
The letter adversely criticized the Comrades because upon the death of LOUIS PASTERNAK, no public mention of his death was made.

"On September 22, our beloved Comrade Louis Pasternak died and not one word of public sympathy expressed by the Comrades he left behind.

Party who operated our Camp Unity for so many years and therefore, a force in our financial struggle. How soon we are forgotten.

"'Can honor's voice provoke the silent dust,

Or flattery soothe the dull cold ear of death ...?

"No! But his memory and what he did in his life should be honored, if only by a small memorial in The Worker!

"I am ashamed of being associated with you.

."Sophie"
