Source stated that the Original Amateur Hour program on Sunday, December 1, 1957, presented a program of Yugoslav amateurs which had originally been scheduled for November 24, 1957. Source stated that the announcer of this program, Ted Mack, stated that the United States Department of State not only approved but urged him to bring about this program and other programs pertaining to the peoples of Eastern Europe. Source stated that Mr. Mack also made it known that this program regarding the Yugoslav amateurs was subsequently broadcasted by the Voice of America.

Source stated that during this program a telegram from Mr. Charles E. Wilson, head of the People to People Foundation, was read and it stated that the program conforms with President Eisenhower's ideas regarding the People to People Foundation. Source stated that the Yugoslav amateurs were rated from good to very good.
