[REDACTED] New York City, made available a copy of 21 page statement, apparently prepared by PAUL CROUCH for submission to the Senate Sub-Committee on Internal Security. [REDACTED] advised that the statement contained much information that was new to him, particularly that which refers to the apparent Communist Party and espionage associations of Dr. J. ROBERT OPPENHEIMER as described by CROUCH. [REDACTED] stated that he was making the statement available to the Bureau for photostating, on an strictly confidential basis as he feels it may possibly contain information of interest to the Bureau which may not previously have come to the Bureau's attention. [REDACTED]

stated that [REDACTED] would very likely sometime make further utilize for publication purposes those portions of CROUCH'S statement which could be safely published without Hearst Publications becoming involved in libel suits.

The statement, which is self-explanatory, has been photostated and the original copy returned to [REDACTED]. Two photostatic copies are enclosed for the Bureau for information purposes. One copy is enclosed for Miami, which office has had contact with CROUCH on an informant basis in the past.

One copy is also enclosed to San Francisco for information. The copy is being placed in the CINRAD file at the New York Office.

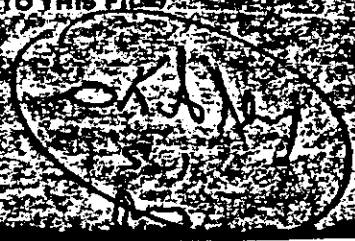

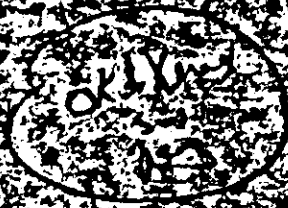
