Reference is made to your communication dated  
January 29, 1954, your references WONEPian, 146-1-11-459  
and 146-200-10.

Further reference is made to our oral acknowl-  
edgment to Mr. William E. Foley of the Criminal Division on  
February 2, 1954, at which time Mr. Foley informed that it  
was not the intention of the Criminal Division to ask for  
a summary of all information concerning the persons referred  
to in referenced letter of January 29, 1954, but that a  
summary of subversive derogatory information bearing on  
the association between Oppenheimer and Condon was  
sufficient.

In this connection, no additional information  
is available at the present time which would establish  
the identities of Martin and Issy. Your suggestion  
that they may be Martin Agrosky and Isidor (Isadore)  
F. Stone appears to be a good possibility. It is also  
possible that Martin and Issy may be Martin David Kamen  
and I. I. Rabi who are known acquaintances of both  
Condon and Oppenheimer. An investigation is being  
initiated in an attempt to determine the true identities  
of Martin and Issy.

Isidor F. Stone is the subject of a pending investigation. Information concerning him has been periodically furnished to the Records Administration Branch in the case entitled, "Isidor Feinstein Stone, was., [REDACTED] b7c

Martin David Kamen is the subject of a pending investigation. Information concerning him has been periodically furnished to the Records Administration Branch in the case entitled, "Martin David Kamen, with alias, [REDACTED] b7c

Our files are presently being reviewed on Martin Agronsky and any pertinent data that is located will be furnished to you.

With respect to the relationship between J. Robert Oppenheimer and Bernard and Hannah Peters, you are advised that prior investigation has reflected that Bernard Peters was formerly one of Oppenheimer's students. It is known that the Oppenheimers and the Peterses were close associates. Our files reflect that a reliable confidential informant reported that on July 16, 1940, at a party held at the home of Oppenheimer he, Oppenheimer, met Mrs. Peters, an M.P. whose husband was a graduate student at the University of California. Mrs. Peters, mentioned above, may be identical with Hannah Peters. (100-17828-10)

Examples of the association between the Oppenheimers and the Peterses appear in our summary memorandum on Oppenheimer dated June 25, 1953. Information appears on page 14 of the memorandum to the effect that Bernard Peters contacted Oppenheimer in 1946 concerning Bernard's acceptance of a position at the University of Rochester. On page 16, information appears which reflects that in 1949 Oppenheimer attempted to get in touch with the Peterses and that Bernard Peters contemplated traveling to Berkeley, California, to see Oppenheimer.

You also asked, "Is Virginia the wife of Clifford Durr and does the Bureau have any information which indicates that Virginia did not share Clifford Durr's pro-Communist leanings?" Our files reflect that Virginia Foster Durr is the wife of Clifford Durr. Our files reflect that she has been affiliated with a number of Communist dominated organizations and she has associated with a number of Communist Party members. A copy

of a summary report by Special Agent Richard Joseph Linehan dated August 26, 1952, at Mobile, Alabama, entitled, "Virginia Foster Durr, aka Mrs. Clifford Durr, Security Matter - C" is attached for your information.

As to your suggestion that J. Robert Oppenheimer is losing Communist Party discipline and Condon is concerned over the matter, it should be noted that Oppenheimer's testimony before an executive session of the House Committee on Un-American Activities on June 7, 1949, to the effect that Bernard Peters had been at one time a member of the Communist Party of Germany, appears to have been correct. Our subsequent investigation of Bernard Peters developed witnesses who testified to the effect that Peters was a Communist Party member in Germany before the Federal Grand Jury that indicted Peters in February, 1953. Considerable publicity was afforded the testimony of Oppenheimer on June 7, 1949. On July 8, 1949, the "Rochester Times-Union" published a letter from Oppenheimer stating that Peters now informed that he, Oppenheimer, was in error by stating that Peters related to him that he had been a Communist Party member in Germany.

With respect to Porter, it is known that Condon's attorney was at one time Paul Porter of the firm, Arnold, Fortas and Porter. We have no identifiable data concerning Bun, Weisenbach or Nick. Investigation is being instituted in an effort to ascertain additional identifying data concerning Porter, Bun, Weisenbach and Nick.

With respect to the authenticity of the "Condon letters," you are advised that during the investigation of the case entitled, "Joseph Woodrow Weisberg, Internal Security - R, Perjury," Assistant United States Attorney William Hitz in Washington, D.C., advised an agent of our Washington field office in October, 1952, that Paul Crouch informed an unnamed representative of the Department of Justice that the McCarran Committee was in possession of a letter written by Condon to Oppenheimer in which Condon requested Oppenheimer to use his influence to obtain a visa for an unnamed individual who desired to enter the United States. A representative of the McCarran Committee furnished us with Photostats of available documents on October 30, 1952, and stated that originals of the documents were in possession of the House Committee on Un-American Activities. The Photostats, seven in number, did not include any similar to the one described above by Paul Crouch, but three of the seven are identical with the three Photostats among the "Condon letters" referred to in referenced letter from you dated January 29, 1954. Photostats of all seven

documents were furnished to Assistant Attorney General Charles B. Murray by letter dated November 6, 1952, entitled, "Joseph Woodrow Feinberg, Internal Security - R, Perjury." The seven documents were also exhibited to U.S. Attorney Hitz on November 12, 1952, during the Feinberg investigation and Hitz stated he would discuss their value with Justice Department Attorney J. Frank Cunningham. (100-333474-753, 743, 749, 754)

Inasmuch as it was once contemplated that Oppenheimer would be called as a witness during the trial of Feinberg, you may desire to confer with Mr. Hitz or Mr. Cunningham in this regard.

The McCarran Committee representative who furnished us with photostats of the seven documents informed that the McCarthy Committee received a telephone call during the summer of 1952 from the owner of an electrical shop (not further identified) who claimed he had information concerning Condon. Accordingly, representatives of both the McCarran and McCarthy Committees contacted the owner of the electrical shop and obtained the seven documents from him. The shop owner explained that the seven documents originally came from Landon Jennings, then an employee of the Fire Marshal's office at the Bureau of Standards. Following Condon's resignation at the Bureau of Standards, Jennings inspected the Condon house and found the documents in the attic. Jennings did not desire to testify concerning the documents as he feared retaliation and he had only a couple of years until retirement. The McCarran Committee requested that he be contacted in the event the documents were used in any proceeding or in the event Jennings is subpoenaed. We assured the Committee that this would be done. We have not interviewed Landon Jennings concerning this matter. In the event you desire that Jennings be interviewed, we will contact the McCarran Committee and conduct the interview upon the receipt of a request from you. (100-333474-753)

We do not have any information to indicate how the House Committee on Un-American Activities obtained possession of the originals of the documents as alleged but it would appear that at the most the House Committee on Un-American Activities only has Condon's file copies rather than the originals. In all probability the originals would have been sent to the addressees.

You will be informed of pertinent developments in this matter.

ISIDOR ISAAC RABI SUMMARY

N.Y.D.C.

Isidor Isaac Rabi, professor of physics, Columbia University, is Chairman of the General Advisory Committee of the Atomic Energy Commission. Our files reflect the following:

The September, 1947, issue of "Science," publication of the American Association for the Advancement of Science, contained a letter protesting the activities of J. Parnell Thomas of the House Un-American Activities Committee for his attacks on Dr. Edward U. Condon, Director of the Bureau of Standards. The letter was signed by six scientists, including Professor I. I. Rabi, Columbia University.

The January 23, 1949, issue of "The Worker," weekly east coast Communist publication, carried an article attacking Professor Rabi for a statement indicating that Soviet science was supported by the state. The article stated that Rabi had "joined the anti-Soviet chorus." The article also stated that Rabi "feels that pure science can only flourish when divorced from the social and political struggles that exist throughout the world."

During 1951, this Bureau conducted an investigation of one Lew Kowarski who had arrived in the United States from France on December 26, 1950. Kowarski was employed as Scientific Director of the French Atomic Energy Commission. According to reliable information received from a foreign source, Kowarski was at one time a Communist and prior to 1940 was alleged to have worked for the Russian Secret Service. During this inquiry it was determined that on January 9, 1951, Kowarski contacted Professor Rabi. Thereafter, Professor Rabi was interviewed concerning this contact at which time he advised that Kowarski was in the United States to see his daughter and also to attempt to find a position. Professor Rabi stated that he had no personal relations with Kowarski and knew of no derogatory information concerning him.

During 1951 and 1952 a Security-type investigation was conducted by this Bureau relative to one Gilberto Bernardino,

an Italian Professor of nuclear physics. Bernardino had been an instructor at Columbia University. He also had been employed in a consultant capacity by the Navy Department in connection with atomic energy development. Another Government agency advised that information received from a foreign source of unknown reliability indicated that Bernardino was "pro-Communist" and also was an associate of three scientists who were allegedly Communist. Another Government agency which also received information from a foreign source of unknown reliability advised that Bernardino was not considered to be communistically inclined. During this investigation, it was determined that Professor Rabi had talked to an official of the Immigration and Naturalization Service concerning the possibility of permitting an extension of Bernardino's stay in the United States. No other information concerning the relationship between Rabi and Bernardino is contained in our files. During 1953, information was received that Bernardino had returned to Italy. (100-369064-23)

Since 1951, this Bureau has conducted a security-type investigation concerning one William Perl based on information indicating that he was possibly involved in espionage activities. During this investigation, Dr. Vernon W. Hughes, a professor at Columbia University, advised that he and Perl worked on an experiment with Professor Rabi at Columbia University during 1946. The experiment involved the "magnetic moment of the helium atom." According to Dr. Hughes, Perl did the mathematical calculations on this experiment and was in frequent consultation with Professor Rabi. The experiment was purely academic and had nothing to do with Government contracts. During this same inquiry, Dr. Theodore Von Karman, a scientist, advised that Perl was his assistant in 1946 while he was a professor at Columbia University. Von Karman stated that Perl was hired on the recommendation of Dr. Rabi, who was then Director of Columbia University's Institute of Science. Perl was subsequently indicted by a Federal Grand Jury of the Southern District of New York on March 13, 1951, for perjury in connection with his denial under oath that he was acquainted with Julius Rosenberg and three additional individuals involved in espionage activities. Perl was subsequently convicted on two counts of the above indictment and is currently serving a five-year sentence in a Federal institution. No information is contained in the files indicating that Professor Rabi had other than professional contacts with Perl. (65-59312-726-32) (100-401991)

On April 5, 1948, Rabi was contacted during a Loyalty of Government Employees investigation of Edward V. Condon, Director of the Bureau of Standards. At that time he furnished a letter from Professor Harold C. Urey announcing a dinner in honor of Condon on April 12, 1948, in New York City.

On April 29, 1954, Herbert A. Philbrick, who now writes a column entitled "Red Underground" for the "New York Herald Tribune," advised that he had developed certain facts from an unidentified source in Washington, D. C., concerning the Oppenheimer case. Based upon these facts, Philbrick prepared a story which was to appear in his column in the May 1, 1954, issue of the "New York Herald Tribune." Philbrick advised that he received instructions from the Managing Editor of the "New York Herald Tribune" not to use the Oppenheimer article because of the pending nature of the Oppenheimer case. Philbrick advised that in all probability the article would be used sometime in the near future. Philbrick furnished the text of this article which is set forth below:

H bombs? Behind the headlines lies another story. Highly skilled and painstaking counter spy work by a Government security agency has turned up certain indications that the Soviet criminal conspiracy has successfully stolen some of this nation's top secret information which could not be traced directly to the Communist spies already uncovered ... such as the Rosenbergs, Klaus Fuchs, or Harry Gold. Top ranking counter-espionage agents have determined that there was -- and that there may still be -- another leak. The isolation of Oppenheimer from the secret documents was a co-operative attempt by the Atomic Energy Commission to plug that leak. Assuming that Dr. Oppenheimer is completely loyal, we can be sure that the Communists will obtain none of the information which the Atomic scientist carried in his brain. You can't microfilm thoughts. But you can microfilm documents ... and up until last July the scientist had a lot of them in his possession. Could it be that Dr. Oppenheimer, who has admitted affiliation with more Communists than the average person is likely to meet in a lifetime, and who has criticized the 'fear of giving vital information to the enemy' because he thought the Reds 'already had the information' may have been a bit too careless with secret documents in his possession? A 'security risk' does not necessarily have to be 'disloyal'. He may simply be unwise in his actions, associations, or appraisal of Communist imperialism. Or was the leak from a source completely isolated from Oppenheimer? Thanks to the irresponsible release of the Atomic Energy Commission investigation to the press we may never know the answer to this question. The U. S. Government kept the matter in confidence, since last July, and acknowledged the security check on April 13 of this year only after the news appeared in the press. Matters of security, espionage and counterespionage, as we are often reminded by certain liberals, are exclusively a matter for the FBI -- not for public charges and counter-charges or public popularity contests. Certainly a prime rule is that you do not let the Soviet spies know what you know about them or their activities. Whatever mistakes Dr. Oppenheimer has made in the past concerning Communism, it is certain that his first error was a great favor for the Soviet Union. The moment the story was bandied about to his goggle-eyed friends it must have become perfectly obvious to the Red spy bosses that the United States suspected ... and was searching for ... a security leak. It has been charged that the reason Dr. Oppenheimer revealed the matter which the Government had been keeping in confidence was because a member of the United States Senate 'threatened' to divulge the case in a public speech. This, however, does not happen to be true; the scientist had spilled the beans to a large number

of friends, acquaintances, and 'advisors' many weeks before the speaking date was scheduled ... including at least two newspaper reporters. In the conclusion of his recent statement to the Atomic Energy Commission, Dr. Oppenheimer states: 'I have recalled instances where I acted unwisely.' You can say that again, Dr. Copyright 1954 NY Herald Tribune."

New York air-tel 4-29-54 related that Herbert A. Philbrick, former Bureau security informant, advised on 4-29-54 that based upon facts received from an unidentified source in Washington, D. Top ranking counter-espionage agents have determined that there was--and that there may still be--another leak. The isolation of Oppenheimer from the secret documents was a cooperative attempt by the Atomic Energy Commission to plug that leak.....Could it be that Dr. Oppenheimer who has admitted affiliation with more Communists than the average person is likely to meet in a lifetime, and who has criticized the 'fear of giving vital information to the enemy' because he thought the Reds 'already had the information' may have been a bit too careless with secret documents in his possession?..... The moment the story (concerning the Atomic Energy Commission's charges) was bandied about to his gogle-eyed friends it must have become perfectly obvious to the Red spy bosses that the United States suspected...and was searching for...a security leak."

Philbrick indicated that he did not have any additional factual information upon which he based these statements.

Philbrick was also questioned concerning the following statement taken from the text of his proposed newspaper story: "Could it be that Dr. Oppenheimer, who has admitted affiliation with more Communists than the average person is likely to meet in a lifetime, and who has criticized the 'fear of giving vital information to the enemy' because he thought the Reds 'already had the information' may have been a bit careless with secret documents in his possession?" In this connection, Philbrick characterized this statement as being a speculative suggestion on the part of his source. Philbrick advised he had received no information indicating Oppenheimer was careless with secret documents.

With regard to his source, Philbrick related that he had been requested not to reveal the source's identity and he had promised to comply with this request. Philbrick did state that his source is not on the payroll of the Atomic Energy Commission, although, according to Philbrick, the source is "allied" with the Atomic Energy Commission. Philbrick stated that his source is not an employee of an intelligence agency. Philbrick was informed that this Bureau has the primary responsibility for the investigation of any such security leak as suggested in his proposed newspaper story. Philbrick stated that he had no factual basis for the statements in his proposed newspaper story and the statements in his story are based on the speculation of his source. It was Philbrick's assumption that his source had previously furnished all of the information in

question to the Federal Bureau of Investigation and it was Philbrick's further assumption that the Atomic Energy Commission's suspension of Oppenheimer was based upon original information furnished to the Atomic Energy Commission by the Federal Bureau of Investigation. Philbrick advised that any additional information which might come to his attention in this matter would be furnished to this Bureau. Should any additional pertinent information be received you will be advised.



Rerep SA HUGH THOMAS FORSHA, NY, dated 5/14/54, the original and five copies of which are enclosed herewith.

Reference is also directed to the report of SA WILLIAM C. PATTERSON, Los Angeles, dated 3/31/54, in instant case which reflects an interview with DAVID T. GRIGGS who advised he had heard the subject leaked non-classified information concerning H-bomb development to JOE ALSOP, a newspaper columnist. According to this report GRIGGS stated he obtained this information from T. F. WALKOWICZ located at the Rockefeller Brothers Corporation, Rockefeller Building, NYC. WALKOWICZ, a former Air Force Colonel, supposedly obtained the information from CHARLES MURPHY, one of the editors of "Fortune" magazine and author of "The Hidden Struggle for the H-Bomb."

WALKOWICZ, in addition to the information included in the attached report of SA FORSHA, was asked if he could furnish any information or evidence regarding the subject's leaking non-classified information concerning H-bomb development to any newspaper columnist or to any other individual or organization. WALKOWICZ admitted he had certain personal suspicions which were not based on fact and which he consequently did not desire to voice. He said he had noted the remarkable speed with which certain discussions at meetings in which the Air Force had an interest had been "leaked" to members of the press, but he had no substantial facts to contribute upon which to base the positive identification of any individual who had furnished the non-classified information to individuals outside the Air Force.

With regard to WALKOWICZ, the files of the NYO reflect that TEDDY FRANCIS WALKOWICZ is the subject of NY file 40568. According to that file WALKOWICZ was investigated as an [redacted] in 4/50 with regard to a [redacted]

Additionally, the files of the NYO reflect in the case entitled "WILLIAM PERL, aka; Espionage - R, Perjury," NY file 65-15387, Bufile 65-59312, report of SA JOHN P. BUSCHER dated 11/30/50 at Washington, DC, information from [redacted] whose identity was concealed in the report at his request. According to the report [redacted] advised that in the latter part of 1947 [redacted] returned from Europe after having worked with DR. VON KARMAN on the Continent. He recalled that in connection with some work VON KARMAN was doing it was necessary that [redacted] meet WILLIAM PERL in NY to discuss technical matters dealing with aeronautical problems. [redacted] contacted PERL briefly on or about 9/26/47, and may have had dinner with PERL at that time. [redacted] had no information of pertinence to offer with regard to PERL, his work, his associates, or his friends. The file on PERL also contains a letter from the WFO to the Bureau, 2/11/52, reflecting a reinterview with [redacted] stated that in 1947 PERL forwarded pertinent material to [redacted] from DR. VON KARMAN's NY office in connection with a paper [redacted] was preparing. [redacted] disclosed he had never known of PERL's taking any documents home for study nor had PERL ever aroused his suspicions in any manner. b7D
