Manhattan Avenue, Tuckahoe, New York was interviewed by
SA ROBERT L. SCHWARTZ, at which time he stated that the
captioned individuals were unknown to him.

advised that the captioned individuals are unknown to him.

the captioned individuals are unknown to him.

It is to be noted that after repeated efforts
by Agents of this office to contact [REDACTED] with negative
results, his attorney, MR. EMANUEL H. BLOCH, 299 Broadway,
New York, New York, called at the New York Office and
stated that he understood this office was trying to
contact [REDACTED]

MR. BLOCH was advised that this office was
interested in interviewing [REDACTED] concerning two
individuals with whom [REDACTED] may have been associated
in the past. MR. BLOCH stated that he would have [REDACTED]
contacted this office, which he did, but that he
doubted if [REDACTED] would be able to furnish any informa-
tion.

It is also to be noted that MR. BLOCH is the
attorney for MRS. JULIUS ROSENBERG, convicted espionage
agent, who is currently in the death house at Sing Sing
Prison. RUC.
