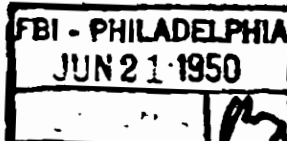

Investigation at Cornell University consisting of a check of the records of the Secretary's Office, the Registrar's Office and the Alumni Office, indicated that SARANT was never a student nor a faculty member at the University. Miss A. A. KING, secretary to the Director, Department of Physics, Cornell University, an established contact of this office, advised that SARANT was employed approximately two years ago as a laborer and draftsman at the Nuclear Laboratory and that this employment was apparently terminated due to the fact that SARANT wanted to become a member of the faculty and was not so qualified.

Mr. C. J. KENERSON, secretary, Ithaca Chamber of Commerce, and Mayor of Cayuga Heights, advised that SARANT is unknown to him and his office.

Miss JANE MCAULIFFE, manager, Ithaca Credit Bureau, furnished SARANT's file which contained the following information. He is listed as a self-employed painter and contractor with address as RD 1, Cayuga Heights Road. He owns real estate in South Lansing, which is just adjoining the Town of Ithaca on the Cayuga Heights Road.

He has an account with the Ithaca Savings Bank and has given R. N. RULSEY AND SONS as a business reference.

He was married to LOUISE JACQUELINE ROSS, daughter of VICTOR K. D. ROSS in July, 1945. He presently has two children. SARANT and his wife formerly lived with the ROSSES at 422 Eddy Street.

Miss MC MULIFFE stated that she does not know SARANT personally and that he is not a customer of the Bureau. Her records failed to reflect the nature or scope of his contracting work. Miss MC MULIFFE advised, however, that she does know VICTOR K. D. ROSS. She stated that he has been practicing law in Ithaca since May 24, 1940, and presently resides with his wife on the West Shore of Cayuga Lake. She stated that prior to assuming his law practice he was a salesman for some wholesale company. In 1945, he was a candidate for County Judge on the American Labor Party ticket.

Confidential Informant T-1, of known reliability, advised that he is personally acquainted with VICTOR K. D. ROSS. He stated that he is not a member of the Tompkins County Bar Association, due to the fact that he is not well liked by many of his colleagues. This informant stated that he considers ROSS as being somewhat of a liberal and added that to his knowledge he has never been suspected of Communist activities. This informant stated that he was introduced to SARANT on one occasion by ROSS and that this is the only time he has ever seen SARANT. He added that SARANT left no impression on him.

This informant further advised that he does not know of SARANT's present occupation. He recalled, however, that ROSS once told him that the best and most economical way to build a new house is to become a contractor yourself and direct the building, thereby gaining contractor's prices and also saving the expense of hiring a contractor. This informant assumed that this is probably what SARANT has done in order to build a new home.

Dr. LYMAN R. FISHER, 210 North Aurora Street, advised that SARANT, assisted by one W. BRUCE DAYTON, has built two modernistic homes on the Cayuga Heights Road, Town of Lansing, beyond the Ithaca town line. He stated that he has never met SARANT, but that he has noticed that the SARANTS and the DAYTONS appear to be very close friends. The DAYTON home was built first and both families resided in this house while the second was under construction.

The above residences were observed by the writer and they are located on the right side of Cayuga Heights Road in the Town of Lansing, approximately  $1\frac{1}{2}$  miles beyond Ithaca City line. They are

ultramodern in construction and neither appears to be completely finished. They are about 50 feet apart, set back about 60 yards from the highway.

[REDACTED] RFD 1, advised that the DAYTONS have lived at this address from nine to ten months and the SARANTS from six to seven months. He also stated that both families appeared to be very close. [REDACTED] stated that SARANT receives an extraordinary amount of mail. b7c

The following information is being set forth concerning WELDON BRUCE DAYTON.

He has been employed as a Research Assistant, Laboratory of Nuclear Studies, Physics Department, Cornell University, since March 1, 1946. He formerly resided at 805 South Plain Street, Ithaca. The files of the Ithaca Credit Bureau reflect he resided at 404 Panoramic Way, Berkeley, California, before moving to Ithaca.

A review of the files of the Albany Office reflects that DAYTON has been a frequent contact of Dr. BERNARD PETERS, PETERS, subject of case entitled "BERNARD PIETROSKI, wa. Dr. BERNARD PETERS - INTERNAL SECURITY - R", Buffalo Origin (Bureau 100-190625), resides at 172 Salina Street, Rochester, New York, and is employed as Assistant Professor of Physics, University of Rochester.

Albany Confidential Informant T-2 of known reliability, has reported that on June 19, 1950, PETERS visited at the home of DAYTON, RFD 1, Cayuga Heights Road, Lansing, New York.

Albany Confidential Informant T-3, of known reliability, advised on April 11, 1950, that he had learned that DAYTON was President of the Central Labor Union and was a delegate from the Cornell University Group of the Teachers Union to the Central Union. He further advised that DAYTON was reportedly a stooge of PHILIP MORRISON, Cornell University nuclear scientist.

The files of the Albany Office contain no information concerning SARANT. However, Confidential Informant T-3 advised the writer on April 11, 1950 that SARANT was Treasurer of the Wallace for President Committee as of May 22, 1948. He resigned on August 4, 1948 and was succeeded by SARA GINSBERG, 129 Blair Street, Ithaca.

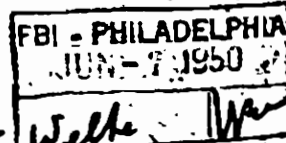

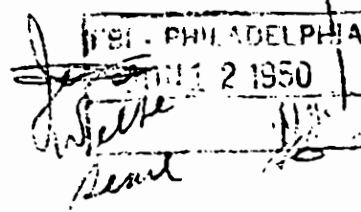
