

SYNOPSIS OF FACTS:

CORNEL and ALICE GRAY, parents of ERNEST PAUL GRAY, advised they had no knowledge of WEIDON BRUCE DAYTON and no knowledge that anyone accompanied their son on his trip to N.Y. from Ithaca to attend 2/2-4/50 meeting of American Physical Society. Mrs. GRAY has letter ERNEST wrote, postmarked 1/30/50 at Ithaca, in which he states he would leave Ithaca "Wednesday" (2/1/50). N.Y. contacts of DAYTON identified. [No indication DAYTON in contact with Mr. and Mrs. MURRAY J. ROSSANT, but these individuals have contacted friends of LOUISE SARANT and her parents Mr. and Mrs. VICTOR K. D. ROSS.

DETAILS

It is recalled that FLOYD ELWYN, JR., Superintendent, 65 Morton Street, New York City, has advised that he saw subject DAYTON and WILLIAM PERL together at 65 Morton Street in the summer of 1949, most probably in July or August.

On January 10, 1951 Miss BETSIE EVANS, Manager of Robinson Air Lines, New York City, advised reporting agent that it was not possible to check reservation records of that air line for the period of June-August, 1949 as those records have been destroyed.

Sunday, January 29, 1950 has been established as the day DAYTON and WILLIAM PERL were allegedly at 65 Morton Street, New York City, in the company of MAXWELL FINESTONE and GARETH (GARY) PICKARD.

ERNEST PAUL GRAY, a former student and research assistant at Cornell University in 1950, has advised that on February 1, 1950 he drove DAYTON from Ithaca to New York City where both were to attend a meeting of the American Physical Society, held Thursday, Friday and Saturday, February 2-4, 1950.

On January 24, 1952 Mr. CORNEL GRAY, father of ERNEST PAUL GRAY, who resides at 89-10 Whitney Avenue, Elmhurst, Long Island, New York, and operates the Margola Novelty Company, 535 8th Avenue, New York City, was interviewed by SA ROBERT F. ROYAL and the writer. Mr. GRAY stated that he had no recollection

of the specific trip his son made to attend the February, 1950 meeting of the American Physical Society, but said that he knew his son attempted to attend every meeting of that Society. Mr. GRAY said that his son had visited his parents quite often while he was at Cornell University, and that he knew his son often gave people rides from Ithaca to New York.

Mr. GRAY said that the name DAYTON seemed familiar to him, however, he could not say why. He advised that he had visited his son at Ithaca and had met several of his son's associates and instructors. Mr. GRAY was shown photographs of DAYTON, FINESTONE, PERL and ALFRED SARANT. He said he did not recognize these individuals and to his knowledge had never heard these names mentioned.

Mr. GRAY stated that his son, ERNEST, wrote to his mother often and usually wrote before each visit. He stated that he would have Mrs. GRAY review any letters she might have from ERNEST for any information which might be of interest in establishing the date and circumstances surrounding his trip to New York in February, 1950.

On January 25, 1952 Mrs. ALICE GRAY, mother of ERNEST PAUL GRAY, 89-10 Whitney Avenue, Elmhurst, Long Island, New York, telephonically advised reporting agent that she had no independent recollection of her son's trip to New York in February, 1950, and that she never heard her son mention subject DAYTON. Mrs. GRAY stated that she had a letter from her son which was undated, but which was in the original envelope, and that this letter was postmarked at Ithaca, New York on January 30, 1950. She said that in this letter ERNEST told her that he was coming to New York on "Wednesday", and that he would not have made the trip in his car except that he wanted to pick up a girlfriend on his way back to Ithaca.

It is noted that January 30, 1950 was a Monday and that the following Wednesday would have been February 1, 1950, the day that ERNEST PAUL GRAY said that he drove DAYTON to New York.

Confidential Informant T-1, of known reliability, advised that correspondence was received by DAYTON'S family at 45 Orchard Street, Jamaica Plain, Massachusetts on November 19, 1951 from Indusco, Inc., 439 4th Avenue, New York City. This correspondence was addressed to CAROL D. DAYTON.

The records of the County Clerk's Office, Supreme Court Building, New York City, reflects that Indusco, Inc., 439 4th Avenue, New York City, also known as the American Committee in Aid of Chinese Industrial Cooperatives, was incorporated on December 13, 1940 to promote cooperative industrial projects in China, and to raise funds for the benefit of Chinese industrial cooperatives, and to aid in the relief and reconstruction of China.

In February, 1950, Confidential Informant T-2, of known reliability, advised that he had been acquainted with the activities of Indusco since its inception, and that since the company was incorporated it had been controlled by Communists, although there have been many non-Communists and anti-Communists, whose names have been used by the organization on its letterhead.

Confidential Informant T-3, of known reliability, a Chinese, in February, 1950 advised that he had been acquainted with the activities of Indusco since its inception. Informant T-3 said that those who know anything about Indusco consider it to be a Communist front dominated by Communists.

On October 30, 1950, Confidential Informant T-4, of known reliability, advised that he learned Indusco does not now help Chinese cooperatives, but is only interested in aiding a school for orphans called the Sandan Bailie School, which is in the North of China. This informant subsequently advised that during the year 1951 he had made numerous visits to Indusco at its office at 439 4th Avenue, and had learned that since January, 1951 there had been little activity by that organization.

Informant T-4 said that Indusco had published a letter in April, 1951 appealing for funds for the Sandan Bailie School, and that during the course of the year had published three issues of "Indusco Bulletin", namely in the winter, spring and summer of 1951. The informant also said that he learned that the United States Government had blocked transmittal of funds by Indusco to the Sandan Bailie School.

Confidential Informant T-5, of known reliability, has advised that the following long distance telephone calls were made from or to subject DAYTON'S residence at 45 Orchard Street, Jamaica Plain, Massachusetts:

Confidential Informant T-6, of known reliability, advised on January 22, 1952 that this phone was listed to Mrs. LOUIS S. WEISS, 215 West 88th Street, New York City, and that it was connected on April 10, 1951.

It is noted that this individual is the widow of LOUIS S. WEISS, attorney; that she and her deceased husband formerly resided at 262 Central Park West, New York City. They have been previously identified by DAYTON as his friends with whom he has often stayed while in New York City.

Confidential Informant T-6, on January 22, 1952 advised that this phone was listed to the residence of Dr. EVA LANDSBERG, 37 West 72nd Street, New York City, and that it was connected on December 20, 1950.

It is noted that DAYTON was subpoenaed to New York for appearance before the Grand Jury of the Southern District of New York during the period June 18-21, 1951.

On June 20, 1951 DAYTON during interview advised that he was staying with Dr. AVA LANDSBERG, 37 West 72nd Street, New York City.

The current Manhattan Telephone Directory reflects that EVA LANDSBERG, MD, has her office at 8 West 58th Street; telephone PL 9-5114, and her residence at 37 West 72nd Street; telephone TR 7-5338. Dr. LANDSBERG also has a listing at 925 West End Avenue; telephone ACademy 2-6024.

The 1950 American Medical Directory, page 1434, indicates that EVA LANDSBERG was born in 1909 and had received her education at the Rega Universita Degli Studi Di Roma, Facolta di Medicina e Chirurgia, receiving her degree in 1936. She was licensed to practice in New York State in 1939, is a member of the American Board of Pediatrics and is a full time specialist in pediatrics. The Directory indicated that she had offices at 925 West End Avenue, New York City and at 125 West Street, New York City.

EVA LANDSBERG was the only doctor E. LANDSBERG listed in New York City.

Confidential Informant T-6 advised on January 22, 1952 that LO 3-8731 was a public coin telephone located at Pennsylvania Station, New York City. It is noted that DAYTON completed his testimony before the Federal Grand Jury, Southern District of New York on June 21, 1951, and he advised agents of the New York Office on that date that he intended to return home that day.

From- Telephone No. VALPORT 614-M, Long Island, New York,  
7/24/51 to- BRUCE DAYTON

Confidential Informant T-6, on January 2, 1952 advised that there was no such telephone exchange in Long Island as Valport,

but there was a telephone BELLPORT 614-M, which was changed on November 25, 1951 to BELLPORT 685-W.

Informant T-6 said that as of July 24, 1951 BELLPORT 614-M was listed to CHARLES P. BAKER, Beaver Dam Road, Brookhaven, Long Island.

It is noted that Brookhaven, Long Island is near the location of the Brookhaven National Laboratories which handle contracts for the Atomic Energy Commission.

Confidential Informant T-7, of known reliability, stated in February, 1951 that one CHARLES P. BAKER was included on a list of employees of the University of California who were at Los Alamos, New Mexico in May, 1945.

On October 15, 1951 Miss MARY McLEOD, who was employed as a departmental secretary for the Physics Department at Cornell University from April 1, 1946 to May 14, 1947, advised SAS RICHARD T. HRADSKY and ROBERT P. ROYAL that CHARLES BAKER, a research assistant at Cornell University, was a consultant of the NEPA Project, and had been formerly connected with the Los Alamos Atomic Energy Project. Miss McLEOD also identified various photographs of subject DAYTON as an individual who was either a graduate student or a graduate assistant in the Physics Department of Cornell during the period she was at that University.

It therefore appears possible that the CHARLES P. BAKER at Brookhaven, Long Island, may be identical with the CHARLES BAKER mentioned above, and that he may be a friend or acquaintance of subject DAYTON.

Confidential Informant T-1 also advised that DAYTON received an air mail letter in care of his Jamaica Plain, Massachusetts residence from Israel on November 13, 1951. The informant stated that this letter had no return address.

It is recalled that Confidential Informant T-8, of known reliability, has advised that a letter addressed to Mrs. VICTOR K. D. ROSS, mother of LOUISE SARANT, addressed to West Shore Road, RD No. 3, Ithaca, New York, and postmarked August 24, 1951, bore the return address of ROSSARANT, Hotel Earle, New York.

Mr. ALFRED LANDI, Manager and Partner, Hotel Earle, 103 Waverly Place, New York City, advised SA ROBERT F. ROYAL and the writer on August 29, 1951 that a Mr. and Mrs. MURRAY J. ROSSANT of Coral Gables, Florida, registered at this hotel on August 17, 1951 and were then residing in room 508. Mr. LANDI advised SA ROYAL on December 5, 1951 that Mr. and Mrs. MURRAY J. ROSSANT had initially registered at the Hotel Earle on August 17, 1951 and departed on September 14, 1951. He said that thereafter they had allegedly travelled to Upstate New York and remained until on or about October 27, 1951. On that day they reregistered at the Hotel Earle and departed again on December 4, 1951, at which time they left a forwarding address of 815 Greenwich Street, New York 14, New York.

Mr. LANDI indicated that neither Mr. or Mrs. ROSSANT were employed to his knowledge during either of their visits.

On December 4, 1951, according to LANDI, a bank statement was received for MURRAY J. ROSSANT from the Manufacturers Trust Company, 378 6th Avenue, New York City, this mail being forwarded to the 815 Greenwich Street address on December 5, 1951.

Mr. LANDI further advised that MURRAY J. ROSSANT has a brother named JAMES ROSSANT, 49 Perkins, Cambridge, Massachusetts, and that this individual was a guest at the Hotel Earle for one night during the Thanksgiving holidays of 1951.

On December 5, 1951 Mr. FRED PARUP, 36 Horatio Street, New York City, Superintendent of the building at 815 Greenwich Street, New York City, advised SA ROYAL that Mr. and Mrs. MURRAY J. ROSSANT were residing in apartment 2-C at 815 Greenwich Street, having moved there on December 4, 1951.

On December 6, 1951, Confidential Informant T-9, of known reliability, advised that MURRAY J. ROSSANT had opened a regular checking account at the Manufacturers Trust Company, 378 6th Avenue, New York City on August 21, 1951; that ROSSANT indicated that he was a free-lance writer, and was residing at the Hotel Earle, New York City.


Informant T-9 stated that ROSSANT had also indicated that he previously had an account at the Manufacturers Trust Company for a number of years at their Broadway and 106th Street, New York City Branch. The informant said that he had learned that ANNE ROSSANT and MURRAY J. ROSSANT had a joint checking account at the Broadway and 106th Street Branch from August 20, 1943 to July 25, 1947.

Informant stated that there was no information at the Manufacturers Trust Company, 378 6th Avenue, New York City, to indicate that ROSSANT was in any way acquainted with, or a contact of subject DAYTON.

The information furnished by Confidential Informant T-9 is not to be made public except after the usual procedure of issuance of a subpoena.

Confidential Informant T-6, who had knowledge of various contacts made by Mr. and Mrs. MURRAY J. ROSSANT when they were residents of the Hotel Earle, New York City, in 1951, advised that there is no indication that ROSSANT or his wife were in contact with subject DAYTON; however, the ROSSANTS had been in contact with friends of LOUISE SAFANT and her parents Mr. and Mrs. VICTOR R. D. ROSS.

It is further noted that the letter DAYTON received from Israel could possibly be from his wife, CAROL DOROTHY DAYTON, and/or from ALFRED SARANT. The latter two left the United States together and their present location is unknown. It is also possible that ALFRED SARANT is in contact with his wife, LOUISE SARANT, through Mr. and Mrs. MURRAY J. ROSSANT, or Mrs. ANIE ROSSANT (MURRAY ROSSANT'S mother), and that contact has been established via the ROSSANTS or directly between subject DAYTON and his wife, CAROL DAYTON.

DAYTON has denied being in New York in the summer of 1949, specifically denying he was at 65 Morton Street in approximately July or August, 1949 as alleged by FLOYD ELWYN, JR., superintendent that address. DAYTON claims he did not meet his mother and mother-in-law in New York when they visited the East Coast in June and July, 1949. His mother-in-law, Mrs. DOROTHY, has advised that she and DAYTON'S mother flew to New York and from there to Ithaca, and she insisted that she did not see BRUCE in New York, and that during her vacation BRUCE and CAROL made no trips to New York.

Mrs. VEDA F. DAYTON, DAYTON'S mother, has advised that when she and Mrs. DOROTHY arrived at the airport in New York, they were met by BRUCE and CAROL, this being in June, 1949.

San Francisco requested to recontact Mrs. VEDA F. DAYTON and possibly Mrs. DOROTHY in an effort to clarify this discrepancy.

Will locate and interview LORRAINE MILLER, a textile designer who has a studio apartment in New York City. This individual, according to DAYTON'S mother, was a former student at Grant Union High School, Del Paso Heights, California, where she is an art teacher.

Will determine whether or not LORRAINE MILLER is acquainted with subject DAYTON and if so will ascertain her knowledge of his activities in New York.

Will interview CHARLES P. BAKER, Beaver Dam Road, Brookhaven, Long Island, New York, telephone BELLPORT 614-M, and ascertain whether or not he is acquainted with subject DAYTON.

If this is the person who has been associated with the Los Alamos Atomic Engineering Project and the NEPA Project at Cornell University, will determine his association and knowledge of any members of the ROSENBERG Espionage Group and determine whether or not any of them, including DAYTON, could have had access to any information in his possession concerning these projects.



WELDON BRUCE DAYTON

Weldon Bruce Dayton was born on February 10, 1918, at St. Helena, California. Dayton and his wife, Betty, presently reside at 12-A, Ramesh Nivas, Bhulabhai Desai Road, Bombay 26, India, and is still employed at the Tata Institute of Fundamental Research, Bombay, India (U)

Weldon Bruce Dayton has reportedly associated with Alfred Sarant, a member of the Julius Rosenberg espionage ring. Sarant resided next door to Dayton in Ithaca, New York, and in August, 1950, following preliminary interviews by Special Agents of the FBI, Sarant fled the United States, taking with him Dayton's wife, Carol. During the period of October, 1943 to September, 1946, Sarant resided in an apartment located at New York City, and upon his departure, sublet this apartment to Joel Barr and William Perl, members of the Rosenberg espionage ring. The apartment was maintained in Sarant's name until the end of January, 1950, and is believed to have been used by Rosenberg and his ring for conspiratorial and photographic purposes. Dayton has been identified by four witnesses as having been in this apartment during January of 1950. Dayton denied this before a Federal Grand Jury in 1951. In 1953, Julius and Ethel Rosenberg were put to death at Sing Sing, New York, in accordance with the sentence received for their espionage activities. (U)

**SYNOPSIS OF FACTS:**

RUTH GREENGLASS advised that sometime during 6/10/50, her husband DAVID GREENGLASS was last contacted by JULIUS ROSENBERG. From information previously developed it would appear that ROSENBERG and MAXWELL FINESTONE contacted ALFRED SARANT in Ithaca, N.Y., on June 9th or June 10, 1950. Miss MARY MC LEOD, former secretary of Dr. HANS A. BETHE, interviewed. She advised that the following individuals had use of the safe in which data was kept in Nuclear Studies School, Cornell University, during the period from 4/1/46 until 5/14/47: Dr. ROBERT F. BACHER, Dr. RICHARD FEYMAN, Dr. ROBERT WILSON, EMILY MORRISON (wife of Dr. PHILLIP MORRISON), JEAN TOWER, a secretary, and herself. Mr. and Mrs. MURRAY J. ROSSANT currently residing 815 Greenwich St., NYC, no indication that the ROSSANTS are in direct contact with WELDON BRUCE DAYTON. VICTOR K. D. ROSS in contact with ALEXIS JAYSON (ELECTRA SARANT JAYSON) on 11/19/51.

DETAILS:

I. INVESTIGATION RE. DATE  
JULIUS ROSENBERG AND MAXWELL  
FINESTONE CONTACTED ALFRED  
SARANT IN ITHACA, NEW YORK

---

Previous investigation has indicated that the most probably dates on which ALFRED SARANT was contacted by JULIUS ROSENBERG and MAXWELL FINESTONE at his Ithaca, New York, residence were the weekends of June 3-4, 1950 and June 10-11, 1950.

DAVID GREENGLASS, United States Penitentiary, Lewisburg, Pennsylvania, convicted former espionage agent who is currently serving a fifteen year sentence in that institution for conspiracy to commit espionage, was interviewed on November 8, 1951, in an effort to ascertain the exact date on which he was last contacted by JULIUS ROSENBERG. GREENGLASS stated that this last contact was definitely not made on or before June 6, 1950 and not on or after June 13, 1950, and that he can definitely state the contact was not made on June 10th or June 11, 1950, because he knows that the contact was not made on a weekend. Accordingly, the contact was made on June 7, 8, 9, or 12, 1950, but GREENGLASS was unable to be more definite.

As to the climatic condition on the day of this contact, GREENGLASS said that he believes it was a fair day, but that he remembers ROSENBERG wore a black raincoat, so it may have been raining earlier in the day, when GREENGLASS was probably still in bed.

GREENGLASS stated that he does not know how long ROSENBERG had been back in New York City from his visit to up-state New York, but that it is his impression that ROSENBERG had returned to the city any time from one to six hours prior to the time of their visit. He cannot recall anything which would indicate that ROSENBERG had been sleeping just prior to their visit.

He said that he does not know how ROSENBERG made this trip to up-state New York, and that nothing was said in this regard. He said that he knows ROSENBERG made almost all of his trips by train, and presumed that ROSENBERG had made that trip by train, but that it may have been made by automobile. GREENGLASS stated that ROSENBERG had always wanted someone available to drive him around in a car and at one time suggested that the Russians make enough money available to GREENGLASS so that the latter could purchase a car and drive ROSENBERG around. Accordingly, GREENGLASS said ROSENBERG may have found someone to drive him around and made this trip to up-state New York by automobile.

GREENGLASS recalls that ROSENBERG said, "I just came back from up-state New York and I'm due to go out west, but I am not going now." GREENGLASS said he formerly testified that ROSENBERG stated he was due to go to Cleveland, Ohio, but that actually he said he was due to go out west and did not mention Cleveland. GREENGLASS said he had been aware that ROSENBERG was planning to go to Cleveland and accordingly, when he testified in court, he became confused and said that at that time ROSENBERG mentioned he was due to go to Cleveland.

GREENGLASS said that at the time of this visit, he was aware that he was being surveilled and accordingly did his best to get rid of ROSENBERG in a hurry. He said that the visit did not last more than about five minutes. He does not know whether this contact was made subsequent to his return from the vicinity of Ellenville, New York, but stated that if the contact was subsequent to June 11, 1950, the only date on which the contact could have been made was June 12, 1950.

He also stated that the contact could not have been made on or after June 13, 1950, inasmuch as on that date GREENGLASS' wife went to the hospital where she was still confined at the time of his arrest on June 15, 1950 and he

recalls that Mrs. GREENGLASS was at home at the time of ROSENBERG'S last visit. He stated that Mrs. GREENGLASS was not in the room at the time of his visit but was in the apartment.

On November 15, 1951, RUTH GREENGLASS, the wife of DAVID GREENGLASS, advised the writer that sometime during June 10, 1950, JULIUS ROSENBERG last visited her husband. She indicated that following his visit she and her husband went for a walk. It should be noted that agents of the New York Office observed DAVID and RUTH GREENGLASS to leave their New York City residence at 11:00 p.m. on June 10, 1951 and thereafter walked to Mrs. PRINTZ's, DAVID GREENGLASS' mother-in-law, who resides at 256 Rivington Street, New York City. At 11:45 p.m. they were observed to leave the Rivington Street address and thereafter walk towards 64 Sheriff Street, New York City, and thereafter enter this address. It is noted that TESSIE GREENGLASS, DAVID GREENGLASS' mother, resides at this address.

It is also noted that DAVID GREENGLASS left his residence at approximately 10:30 a.m. on June 10, 1951 and did not return until 5:15 p.m. that date. DAVID GREENGLASS was not observed to leave his residence between 5:15 p.m. and the 11:00 p.m. departure mentioned previously.

Mr. HERBERT E. COLE, Supervising Observer, United States Weather Bureau, 17 Battery Place, New York City, advised the writer on November 15, 1951, that there was no rain in New York, North Pennsylvania and New Jersey during June 12, 1950. June 13th, 14th, and 15th were also checked for rain for the above mentioned area. It was ascertained that there was no rain in any of the three states on June 13th and there was rain bearing from very light to moderate rain on June 14th and June 15, 1950.

It is noted that JAMES K. MC GUINE of the United States Weather Bureau, had previously advised the writer on

August 28th and 29, 1951, that the weekends of June 3-4, 1950 and June 10-11, 1950 were the most probably dates on which an individual or individuals ROSENBERG and FINESTONE could have made the return trip from Ithaca, New York, to New York City and had a continual rainfall during the entire period. He stated that the most probable period would extend from 9:00 a.m. on June 10, 1950 until 2:00-3:00 a.m. on June 11, 1950. He also indicated that this trip could have taken place during the latter half of June 3, 1950 or in the early morning hours of June 4, 1950.

It is recalled that JULIUS ROSENBERG has advised Confidential Informant T-1, of unknown reliability, that it rained during the entire return trip from Ithaca to New York City.

From the investigation previously conducted and information appearing herein it would appear that ROSENBERG'S and FINESTONE'S trip to Ithaca, New York, originated at New York City during the evening hours on June 9, 1950 (Friday) or during the early morning hours of June 10, 1950. It is 232 miles from New York to Ithaca which is a  $6\frac{1}{2}$  to  $7\frac{1}{2}$  hour trip by automobile. It should be noted that it appears that after ROSENBERG'S and FINESTONE'S contact with ALFRED SARANT that they returned to New York City subsequent to 9:00 a.m. on June 10, 1950, and that ROSENBERG'S last contact with DAVID GREENGLASS took place between 5:15 p.m. and 11:00 p.m. on June 11, 1950.

## II. INTERVIEW WITH MISS MARY MC LEOD

As has been previously reported, Confidential Informant T-1, mentioned previously in this report, has advised that JULIUS ROSENBERG indicated to him that ALFRED SARANT had two contacts which would have supplied him with

information, namely (HANS A.) ~~BETHE~~ and (PHILLIP) MORRISON, both of Cornell University. ROSENBERG has indicated that these two men were physicists by profession.

Miss MARY MC LEOD, 2307 Lyons Avenue, New York 61, New York, was interviewed by SAS RICHARD T. HRADSKY and ROBERT F. ROYAL on October 15, 1951.

Miss MC LEOD advised that she is currently employed as a Secretary, Industrial Engineering Department, Columbia University, New York City. She indicated that she was previously employed by the American Institute of Physics, 57 East 55th Street, New York City.

Miss MC LEOD stated that from April 1, 1946 until May 14, 1947, she was employed as a Departmental Secretary for the Physics Department at Cornell University. During this period she served as a secretary to both Dr. HANS A. BETHE and Dr. ROBERT F. BACHER, who were Directors of the Nuclear Studies School at Cornell University. She indicated that Dr. BACHER left Cornell University in February, 1947 to continue his work with the Atomic Energy Commission on a full time basis and that he is now at the California Institute of Technology.

Miss MC LEOD further advised that there were two safes, one in the office of Dr. BACHER and the other in the office of Dr. BETHE, at Cornell University, which were used to keep classified AEC documents. For clarity these safes will be referred to as the Number One safe, which was maintained in the office of Dr. BACHER, and the Number Two safe, which was later maintained in the office of Dr. BETHE.

Concerning the Number One safe, Miss MC LEOD furnished the following information:

She stated that this was the safe in which the very important AEC documents were maintained, and that there was a stenography notebook maintained in the safe which was used for charge-out purposes. She stated that when she

came to Cornell University Dr. BACHER furnished her with the combination of the safe on a piece of paper and thereafter she committed it to memory and destroyed the piece of paper by burning it. She stated that Dr. BACHER was the only person who knew the combination of the Number One safe at that time and he must have forgotten part of the combination because he relied upon her for the memory of the combination.

Miss MC LEOD stated that she passed this combination on to JEAN TOWER (Mrs. STEPHEN NELSON TOWER) in February, 1947. Miss MC LEOD indicated that JEAN TOWER had become her assistant and she later succeeded her as Departmental Secretary. She explained that she passed this combination in writing to JEAN TOWER and advised her that she should commit the combination to memory and thereafter burn the piece of paper on which the combination had been recorded. She further advised that JEAN TOWER had joined the Departmental Secretarial staff in either September or October, 1946.

Miss MC LEOD stated that upon Dr. BACHER'S departure he furnished the combination to the Number One safe to Dr. ROBERT WILSON, who was Dr. BACHER'S successor as one of the Directors of the Nuclear Studies Laboratory at Cornell University.

Miss MC LEOD further advised that Dr. RICHARD FEYMAN would keep some of his confidential materials in the Number One safe; however, on any occasion which he might desire these materials she would remove them for him and after he had completed the use of the materials she would return them to the safe. She advised that the only other person who would keep anything in the Number One safe was EMILY MORRISON, who is the wife of Dr. PHILLIP MORRISON. She stated that EMILY MORRISON, who is a bacteriologist and a writer by profession, had had the job of historian or some similar titled position at Los Alamos and Miss MC LEOD recalled that during the period she was employed as Departmental Secretary a special courier came from Los Alamos and delivered to EMILY MORRISON a quantity

of classified material which was allegedly to be used as a continuation of the position which EMILY MORRISON had formerly held at Los Alamos. She stated that EMILY MORRISON gave her this package of documents for safekeeping in the Number One safe. She indicated that EMILY MORRISON would from time to time come to her and request these documents and thereafter she would remove them from the Number One safe and EMILY MORRISON would usually take them to the office of her husband, which was approximately 150 feet or so down the hall from Dr. BACHER'S office, where the Number One safe was kept.

Miss MC LEOD stated that EMILY MORRISON would subsequently return the documents to her to be replaced in the safe; however, she stated that there was no accounting of these documents and she never knew the exact number of documents which were maintained in this package.

Concerning the Number Two safe, Miss MC LEOD furnished the following information:

She stated that this safe was obtained during the winter of 1946 to hold classified materials which were sent from Los Alamos to Dr. BETHE. She explained that Dr. BETHE was on a committee which reviewed materials in order to decide whether they should be declassified. She stated that there were considerable classified documents sent to Dr. BETHE by Registered Mail from Los Alamos. She believed that one ROBERT DAVIS was employed at Los Alamos and that he would receive the documents upon declassification, from this committee. She indicated that there was no charge-out record kept in this safe while she was employed as Departmental Secretary.

Concerning the combination for this safe, she stated that upon obtaining the safe, which was Government property as was the Number One safe, Dr. BACHER set the combination and recorded it on a piece of paper for her to commit to memory and thereafter this piece of paper was burned. She stated that she passed this combination on to JEAN TOWER in February, 1947 and she does not recall that anyone else other than Dr. BACHER, JEAN TOWER and herself knew this combination.

Miss MC LEOD furnished the following information pertaining to NEPA:

She stated that Dr. BETHE, Dr. BACHER and CHARLES BAKER, a research assistant at Cornell University, were all consultants to the NEPA Project. She stated that BAKER had formerly been connected with the Los Alamos Atomic Energy Project, as were Drs. BETHE and BACHER. She recalled that all three of these men had on various occasions made separate trips to New York City to see a Mr. LAMBERT(?), who was President of the Fairchild Airplane and Engine Corporation, with offices at Rockefeller Plaza, New York City. She indicated that this individual would on occasions come to Ithaca, New York via his private plane, to consult with Doctors BETHE, BACHER and BAKER. She recalled taking dictation on the early stages of the NEPA Project for Doctors BETHE and BACHER, copies of which were maintained in the Number One safe. She stated that these letters were sent Registered Mail.

Miss MC LEOD stated she could not recall any reports during the period she was employed as Departmental Secretary, and stated that "The NEPA Project from the outset was considered to be something fantastic and was just a matter which you might joke about." She stated she had later learned that the idea of NEPA had considerable merit and it is her understanding that today it is or will be a successful venture.

Miss MC LEOD identified various photographs of Dr. WELDON BRUCE DAYTON as an individual who was either a graduate student or a graduate assistant in the Physics Department during the period she was at Cornell University. She stated she possibly had met CAROL DAYTON at Rockefeller Hall. She indicated that Rockefeller Hall housed the Physics Department and the Laboratory at Cornell University.

Miss MC LEOD stated that DAYTON did not work directly under Doctor BETHE; however, she stated the Graduate School was a well knit, close organization and almost everyone in the Department was known to everybody else. She stated they often attended socials and receptions

at various Faculty members' homes and they had ample opportunity to become known to one another. She stated that DAYTON, to her knowledge, did not have access to either the Number One or Number Two safes aforementioned and she has no knowledge that DAYTON may have had any access to materials which Doctor BETHE maintained.

Concerning WILLIAM PERL, Miss MC LEOD failed to identify various photographs of him which were exhibited to her; however, she stated that she recalled reading about his arrest in the New York newspapers. She stated it was very hazy in her mind; however, she cannot definitely place where, but there was something about PERL or PERLE in Dr. BETHE'S papers. She stated it was possible that Dr. BETHE had corresponded with someone by the name of PERL.

On October 19, 1951 Miss MC LEOD telephonically advised the writer that she was referring to a man by the name of PEIER(S), instead of PERL or PERLE as mentioned above. She stated that Dr. HANS A. BETHE mentioned PEIER(S) in connection with his book entitled "Elementary Nuclear Theory", published by John Wiley, 1947.

Photographs of ALFRED SARANT, LOUISE SARANT, MAXWELL PINESTONE and various other individuals connected with the ROSENBERG espionage group were exhibited to Miss MC LEOD without effecting identifications.

Miss MC LEOD telephonically contacted the New York Office on October 16, 1951, and advised SA ROBERT F. ROYAL that Dr. BETHE may have obtained the combination for the Number Two safe at the time she furnished the combination to JEAN TOWER. She stated that Dr. BETHE had access to this safe inasmuch as it was in his office and he would help himself in obtaining documents from this safe. She also advised that at the time Dr. BACHER furnished her with the combination of the Number One safe he reset the combination, and there is a question in her mind as to whether at the time he physically passed the safe on to Dr. WILSON that he passed on the combination of this safe to Dr. WILSON. She stated Dr. WILSON was reluctant to accept the responsibility of the Number One safe and this accounts for question in her mind as to whether he actually received the combination from Dr. BACHER.

Miss MC LEOD also advised that Dr. BACHER filed the necessary forms for her to obtain clearance to handle the classified documents in the Number One safe at the time of her employment in April, 1946. She stated she does not know whether she ever received any clearance inasmuch as there was no apparent investigation conducted pertaining to her clearance. In this connection she also advised that she had no knowledge of whether JEAN TOWER had clearance to handle classified documents.

The indices of the New York Office fail to reflect any references believed to be identical with Miss MC LEOD.

III. ADDITIONAL INVESTIGATION  
TO LOCATE ALFRED SARANT

Confidential Informant T-2, of known reliability, has advised that BRUCE DAYTON (Dr. WELDON BURCE DAYTON) received an air mail letter in care of his Jamaica Plain, Massachusetts, residence from Israel on November 13, 1951. This informant stated that this air mail letter had no return address.

It is noted that the letter DAYTON received from Israel could possibly be from either CAROL DOROTHY DAYTON and/or from ALFRED SARANT. The latter two left the United States together and their present location is unknown. It is also possible that ALFRED SARANT is in contact with his wife, LOUISE SARANT, through Mr. and Mrs. MURRAY ROSSANT, or Mrs. ANNE ROSSANT (MURRAY ROSSANT'S mother) and that contact has been established via the ROSSANTS or directly between WELDON BURCE DAYTON and his wife CAROL DAYTON.

It is recalled that Confidential Informant T-4, of known reliability, has advised that a letter addressed to Mrs. VICTOR K. D. ROSS, in care of West Shore Road, RD #3, Ithaca, New York, postmarked August 24, 1951, at New York City, bore the return address of ROSSANT, Hotel Earle, New York. Mr. ALFRED LANDI, manager and Partner, Hotel Earle, 103 Waverly Place, New York City, advised on August 29, 1951, that a Mr. and Mrs. MURRAY J. ROSSANT of Coral Gables, Florida, registered at this hotel on August 17, 1951, and were then residing in room 508.

Mr. ALFRED LANDI, Partner, Hotel Earle, 103 Waverly Place, New York City, advised the writer on December 5, 1951, that Mr. and Mrs. MURRAY J. ROSSANT of Coral Gables, Florida, initially registered at this hotel on August 17, 1951, and departed on September 14, 1951. Thereafter, they allegedly travelled upstate New York and remained until on or about October 27, 1951. On October 27, 1951 they, the ROSSANTS, re-registered at the hotel Earle and departed on December 4, 1951. They left a forwarding address of 815 Greenwich Street, New York 14, New York.

Mr. LANDI indicated that neither Mr. nor Mrs. ROSSANT were employed, to his knowledge, during either of their visits. On December 4, 1951, according to LANDI, mail was received for MURRAY J. ROSSANT from the Manufacturers Trust Company, 376 Sixth Avenue, New York City. This mail (bank statement) was forwarded to the 815 Greenwich Street address on December 5, 1951.

LANDI advised that MURRAY J. ROSSANT has a brother named JAMES ROSSANT, 49 Perkins, Cambridge.

Massachusetts. He was a guest at this hotel for one night during the recent Thanksgiving holidays.

Inquiry at 815 Greenwich Street, New York 14, New York, on December 5, 1951, indicated that Mr. and Mrs. MURRAY J. ROSSANT are currently residing in Apartment 2-C. On December 5, 1951, Mr. FRED PARUP, 36 Horatio Street, New York 14, New York, telephone number CHelsea 3-1455, advised the writer that Mr. and Mrs. MURRAY J. ROSSANT are now residing in Apartment 2-C at 815 Greenwich Street, New York City. PARUP is the superintendent of this building and he indicated that they moved in on December 4, 1951. He stated that DOROTHY TUREK, Apartment 2-D, 815 Greenwich Street, New York City, is the owner and agent for this apartment building. PARUP stated that he would immediately advise the writer if any information is received pertaining to a contemplated departure from the 815 Greenwich Street address by the ROSSANTS.

Mr. LANDI stated that on November 22, 1951, a long distance toll call was made from the ROSSANT'S room, number 508, to Miami 488047. He stated that this was a \$3.00 charge.

Confidential Informant T-5, of known reliability, advised that ALEX JAYSON (Mrs. JOEL JAYSON, sister of ALFRED SARANT), 4 Old Westbury Road, Wegmore Estate, Old Westbury, Long Island, New York, received mail with the return address of VICTOR K. D. ROSS, 114 North Aurora Street, Ithaca, New York, on November 19, 1951.

Confidential Informant T-5, mentioned previously, and T-6, T-7 and T-8, all of known reliability, have advised that no mail was received from either ALFRED or LOUISE SARANT by NONDA GEORGE SARANT, ALFRED'S father, ELECTRA SARANT JAYSON, his sister, or by WILLIAM or GEORGE SARANT, brothers of SARANT during the period covered by this report.





(widow of Otto E.) as residing at 190 Clare Avenue, Hyde Park, Boston, Massachusetts. It is noted that this is the same address as that given by you for Christel Heineman in 1954.



In 1950 during the investigation of Klaus Fuchs, his brother-in-law, Robert Heineman, reluctantly admitted current active membership in the Communist Party in Cambridge, Massachusetts, and that Communist Party meetings had been held in his home. Klaus Fuchs has stated that his sister was not implicated in his espionage operation. He did state, however, that she was evidently an active undercover communist in Germany and may have witnessed his meetings with his contact in Boston and may have deduced that these meetings were a continuation of his underground work in Germany. Both of the Heinemans were cooperative when interviewed by this Bureau in connection with the investigation of Klaus Fuchs.

The Heinemans were estranged for some time



The records of the United States District Court at Boston indicate that Christel Heineman married Albert Holzer October 8, 1954, in Boston and that she was naturalized July 17, 1956, receiving Certificate of Naturalization Number 7620094. Our files do not indicate the date the Heinemans were divorced.

There is attached a copy of the report of Special Agent in Charge  dated January 28, 1947, at Philadelphia concerning Robert Black Heineman which contains information which may be of interest to you in this matter.

1. Reference is made to recent letters to your Bureau from this office on the above named Subjects who were assigned to the Section, Division, Branch, OSS during World War II. This section was headed by Soviet Agent, at that time.

2. Recent research by this office in connection with OSS employment has developed what appears to be a Communist colonization of the Section of OSS as early as March 1942. A March 1942 roster of personnel in the Section lists three persons in that section. including Our security files reflect that in addition to one of the remaining two was a member of the Communist Party in 1943, and that the other was living in home and was described as having aims frequently in accord with the Communist Party.

3. An October 1942 roster of personnel in the Section lists six persons in that section. Our Security files reflect that of the six; one, has been identified as a Soviet Agent; the second, his secretary, has been identified as a 1943 Communist Party member; the third, formerly held an official position in a Communist Youth Organization a Soviet agent; the fourth, ASSISTANT, was living in his home in 1942 and described to have aims frequently in accord with the Communist Party.

Further details on the known Communist affiliations of the above individuals are set forth in the attached memorandum.

4. Because of the high degree of Communist infiltration as early as 1942 in the [redacted] Section, and the appearance that only those who were Communists or sympathetic to Communism were brought into that section, we consider as suspect, from a Communist standpoint, all persons who later came into that section, particularly [redacted] and [redacted]

5. We have noted that Elizabeth Bentley has previously been contacted by your Bureau regarding the activities of [redacted] in Soviet espionage activities during World War II. Should she again be contacted regarding [redacted] by your Bureau at a future date, we would appreciate the names of [redacted] and [redacted] being mentioned to her, as well as the names of the others listed in the attached memorandum who were also in the [redacted] Section, and this office being advised should she express a familiarity with any of them. Attached herewith are photographs, where available, on these individuals.

Dear Sir:

Please be advised that a letter dated 20 August 1952 was received by this Agency from Professor Helen B. Pope, Fort Elfsborg, R. D. No. 3, Salem, New Jersey, an applicant for a position with this Agency. In her letter, Professor Pope volunteered certain security information which is quoted as follows:

"A neighbor here thinks I should submit to you or to the F B I a doubt I feel about a former student of mine in Brooklyn College, from which I retired in 1950 at the age of sixty-five. In the Saturday Evening Post for May 31, 1952, on page 33 is a picture of Anatoli Yakovlev, Russian vice-consul in New York, involved in the Klaus Fuchs case. He looks to me like a former Brooklyn College student, Milton or Miltiades Beckos. I never had Milton as a student in a class, but knew him very well because he was a guiding spirit in our Greek Club, Attican Society, of which I was faculty adviser. He was, I think, the most charming person I ever met, immensely popular with all the professors and young people.

"If A. Yakovlev once posed as the Greek Milton Beckos, our authorities learned of the deception, but there is one interesting feature that may have escaped their notice. Milton Beckos pretended to be totally blind. Yet after a bicycle excursion of the Attican Society, in which I did not join, one of the girls told me she was sure he was not blind. Secondly, when he and I were once trying to cross Flatbush Ave. and Nostrand at the Junction, he suddenly seized my arm and with much zig-zagging pulled me to the other side. I felt that he could not be blind.

"There were a good many blind students - and of course are - at Brooklyn College. Two girls in my classes were fanatically interested in politics, but I thought on the fascist side.

"I thought of Milton again recently while reading Elizabeth Bentley's Out of Bondage, page 151, about Helen, wife of Nathan Gregory Silvermaster; her first husband was a White Russian Volkov, by whom she had one child Anatole. On page 152 she is described as a 'slight, wiry woman'. In Brooklyn I met Milton's mother, tall and stately and more dominating than most Greek women. Her daughter (Penelope?) was very beautiful, worked in a night-club, then married a Jew, connected with the radio (I think writing scripts) and accompanied him to California. Milton later followed. If Milton is Yakovlev, then I imagine he boarded with Greeks to get a Greek background.

"If Milton is not Yakovlev, I hope I have not injured him. We all respected and loved him."

This agency learned in January 1964 that Mr. and Mrs. DAYTON were planning to return to the United States in August 1964 for the first time in five years. Their son, Eric, was due to return to the U.S. on or about 30 January 1964 to prepare for his entrance into college next fall.

2. The memorandum dated 18 May 1964 passed on a report concerning DAYTON's employment and address in Bombay and requested confirmation. As of January 1964 DAYTON's employer was as stated in the attachment to that memo. His address is also correct according to information received in late 1963. We have had no indication of change of employment or address.

SUBJECT: Weldon Bruce DAYTON

1. Weldon Bruce Dayton was born in Saint Helena, California, on 10 February 1918. Dayton attended the University of California, Berkley, California; and received his M.A., Phd. at Cornell University, Ithaca, New York. His chosen field was physics, and later nuclear physics, during his graduate work.
2. Dayton was known to associate with American Communist party members during his tenure at Cornell University. He was never proved to be an actual party member, but was thought to have "leftist" sympathies.
3. During Dayton's association with Cornell University as a Research Assistant in the Laboratory of Nuclear Studies, a close friend, Alfred Sarant and his family came to live with the Dayton family for nearly one year. (7-48/2-49). N.Y. Sarant was later a suspect in the Rosenberg Espionage Case. Dayton also associated with known American Communists during his teaching tenure in the Laboratory of Nuclear Science at the Massachusetts Institute of Technology, Cambridge, Mass.
4. In August, 1950, Dayton's wife accompanied Sarant from Ithaca, N.Y. to Mexico City, where he fled to avoid being questioned about his connection with the Rosenberg case. Mrs. Dayton acquired Mexican tourist cards for their trip using the names, "Mr. Bruce Dayton and Mrs. Carol D. Dayton". Both Sarant and Mrs. Dayton have subsequently disappeared in Mexico. N.Y. Dayton was known to have visited Mrs. Sarant and stayed with her for a period of time after his wife's disappearance.
5. Dayton accepted a professorship with the Santa Ana Junior College, at Santa Ana, California, and was gainfully employed there as of July 1957. During the period of 1954-58, Dayton tried to get a passport to take a position at the Tata Institute of Fundamental Research, in Bombay, India. This request was refused by the Department of State until the Supreme Court decision on June 16, 1958 that passports can't be denied on the basis of an applicant's beliefs or associations. It is thought that Dayton will proceed to take the Tata Institute position.

S. from 10-21-64 to 3-21-65, subject was in frequent contact with Lerner, took her numerous places and visited her at the home of Rebecca Lerner, Security Index subject. Sue Mehlan has been married twice and has two sons, an artist (believed to reside in the New York City area) and an individual who is employed in Washington, not further clarified.

After Golda Lerner returned to the USSR, she relayed numerous messages to Mehlan through her sister, Rebecca Lerner. During May, 1965, Rebecca Lerner called subject and had an argument with her. At that time, Mehlan was planning to take a trip to Spain. It was obvious that Rebecca Lerner had attempted to persuade Mehlan to visit the U. S. instead.

During September, 1966, Rebecca Lerner criticized Golda Lerner for requesting Rose S. to contact Sue (believed to be subject), stating that Sue would not like to have Rose S. in contact with her and that Golda Lerner knew why. Rebecca stated that she had always delivered Golda Lerner's letters to Sue and called Sue whenever Golda had requested her to do so.

Additional information received from the source has revealed that the above-mentioned Rose S. is Rose Sobell, mother of Morton Sobell and a cousin of the Lerner family, who visited Golda Lerner in Moscow.

According to a "Weekly Intelligence Report" dated 7-15-32 from the Seattle Office, Morris Pasternak, Jeanne Lerner, Sue Mehlan and S. Max Kitzes (all young people from New York) had recently arrived in Seattle after a cross-country hike. They had started from New York City during September, 1931, hiked to Chicago where they stayed for seven months and left Chicago on 5-2-32. They then visited Terre Haute, St. Louis, Kansas City, Leavenworth, Colorado Springs, Denver, Yellowstone Park, Butte and Seattle. Kitzes had organized the Young Workers League in Chicago and the four New Yorkers had organized branches of the League in St. Louis, Kansas City and Denver. On 7-14-32, they continued their hike to San Francisco. No source was given for this information.

She has been mentioned frequently during contacts between Golda Lerner and Rebecca Lerner as "Sue" and "Sue M." and her last name has been mentioned only twice. She is evidently an old friend who was extremely close to Golda Lerner when Golda was in the U.S. She does not maintain direct contact with Golda Lerner. Rebecca Lerner relays all their messages. Rebecca Lerner appears to be jealous of Mehlman who appears to be "well off" financially. She may be identical with one Susann Mehlman, owner of a dress shop, who was in contact with a Soviet agent in 1952. At the time, the contact appeared to pertain to business for the Soviet agent was making several such contacts.
