A request was made of the Department of the Army, Intelligence Division, to check in Germany on the Leics camera No. 255740, which belongs to Michael Sidorovich. The following report has been received with respect to this camera:

Wholesale distribution of R. Leitz photographic and optical equipment is handled in Berlin by the Leitz firm in Tehlendorf (US Sector). It was learned from this firm that until 1945 that organization was housed in Berlin-Nitte (Soviet Sector) at 46 Luisenstraces and the address had been totally destroyed during North Nor II. All records in the possession of the firm were also destroyed at the same time.

There were about 500 retail declers in leitz photographic equipment in Berlin prior to 1945, but their names and addresses are no longer available to the Berlin wholesale house. Each retailer was obliged to keep a register of the owners to whom leica conserva had been sold, and a record of the registration was also supposed to be kept by the leitz people in Metzlar; if successful, as many as possible of these dealers will be contacted for information concerning the camera. Inquiries are being made additionally among prominent contemporary distributors of photographic supplies in Berlin.



William D. Pardridge, Arcadia, California, who is employed as Technical Editor, Aero-Jet Corporation, Azusa, California, advised this Bureau on June 2, 1954, that Dr. harold Clayton Urey, whomhe considers to be a personal friend, has led him to believe, as a result of a conversation in Pasadena, California, that Urey was considering restricting his future scientific endeavor to purely nonmilitary theoretical research.

According to Pardridge, Urey said he would ndt'JUNS - 1954 "knuckle under" to the Government.

Pardridge classified Urey as the "moral leader of . top American scientists." Pardridge said it was his opinion that Urey's example would be followed by all the top scientists in the United States in what Pardridge referred to as a passive strike against the Government. Pardridge added that Urcy's attitude was in his opinion a result of the Government's recent action against J. Robert Oppenheimer and what Urey described as an attempt by the Government to A.T.

NOTE: Pardridge was interviewed based on information furnished on 6-2-54 by former Senator Harry Cain, who is now a member of the Subversive Activities Control Board. Cain said he received a phone call from Pardridge, whom he knew when the latter was Editor of the defunct aviation magazine "Air Affairs." Cain served on the Board of the magazine which was supported by several high Air Force and Navy officers. Cain said that Pardridge had been employed by the Aero-Jet Corporation at Azusa, California, for the past several weeks and that former Under Secretary of the Navy Dan Kimball got him this job.

Cain said that Pardridge related to him that last Saturday Pardridge had uncovered a conspiracy against the security of the nation and asked Cain to send a courier plane to California to pick up the material to be brought directly to Cain. Bureau files reflect the following information concerning Pardridge:

Pardridge wrote to the Director on 6-5-46 calling attention to the creation of his magazine "Air Affairs" and asking the Director to submit a 600-word letter stating an opinion on the impact of aviation upon our social institutions. The Director replied on 6-10-46 advising that it would not be possible to be of assistance in view of the many pending matters

On 10-5-49 Senator Ralph E. Flanders wrote the Director enclosing a copy of the magazine "Air Affairs" and describing himself as Chairman of the Board of the American Society of Air Affairs. Senator Flanders pointed out that a special issue of the magazine would be published devoted to the atom bomb and they wanted the Director to do a chapter on civil liberties in law enforcement. The Director declined by letter dated 10-18-49 on the press of official matters.

On 11-25-50 Pardridge again wrote to the Director asking for an appointment and the Director noted "I don't know him and he'll have to see someone else." A letter was written to Pardridge dated 12-1-50 inviting Pardridge to come in and talk to one of the Director's assistants. (100-143994-3)

A report from Military Intelligence dated 4-1-43 reflects that , a private attached to an Army technical school squadron, had been investigated by the Army following a report regarding the possible engagement of girl of pro-Nazi sympath es. The summary of the report reflected that character was doubtful, his loyalty. was doubted and-his personality certainly was described in خ critical terms. He was catalogued as being indiscreet, too talkative, failed to get along with other employees, not 🧓 dependable, attempts always to seek special favors and possesses generally a personality which is often disliked . No information, however, was developed which would indicate his disloyalty to the United States. The report reflected that: had studied at the University of Chicago where he was working toward his Ph. D. and that he had served as any he Assistant Air Force Analyst in 1941 and resigned to accept as job with the Board of Economic Warfare. He had part time employment in 1940 with the Chicago Tribune and also in 1940 with the Chicago Times." (100-143994-1, 2)

On February 2, 1951, Pardridge called the Bureau desiring to see the Director. In the Director's absence, arrangements were made to have Pardridge call at the Bureau to be interviewed by a member of Mr. Nichols' office. Pardridge said his main purpose for contacting the Director was to see if the Bureau could quickly "clear" him since he had the possibility of a job with the Army Air Force. He was advised that the FBI does not "clear" anyone and our responsibilities were carefully explained to him.

Attached for your information are photostatic copies of the testimony given by the subjects before the Ohio State Senate Judiciary Committee on May 25, 1949, regarding the Bartunek-Seibert Bill then being considered by that Cormittee.

This Bill, which did not pass during the current session of the State Legislature, called for loyalty oaths from public employees in the State of Ohio and teachers connected with public schools. In its original form it also called for the registration with the Secretary of the State of Chio of Communist Party members and front groups, which, in effect, would have outlawed the Communist Party in Ohio.

You will note that O. JOHN ROGGE spoke as a representative of the Frogressive Party of America and that ARNOLD SALUEL JOHNSON spoke as the National Ingislative Secretary of the Communist Party - USA.

There are also attached two photographs of O. JOHN ROGGE taken during his testimony and three photographs of ARNOLO SAMUEL JCHNSON taken while he was testifying.

The testimony attached was from the official transcript of the Olio Judiciary Committee and it was furnished together with the photographs by me 16, Counter Intelligence Corps. 109th Detachment, Columbus, Chio, on June 16, 1949.

DETATLS:

I. CURRENT ACTIVITIES

A. Employments

T-1, of known reliability, advised on February 2, 1954 that MAXWELL FINESTONE was then employed as an outside salesman for the Dictograph Company, 11 West 42nd Street, New York City. The informant edvised that FINESTONE was selling fire alarm systems for the Dictograph Company.

On February 22, 1954 the informant learned that FINESTONE was not happy with his present job with the Dictograph Company and desired to obtain other employment. The informant learned that one of the jobs in which he was interested was a position as sales manager with the Cities Service Oil Company of New York City.

T-2, of known reliability, advised on April 16, 1954 that FINESTONE resigned from his selling position with the Dictograph Company and is again employed as a free lance market research interviewer for various New York City advertising and research companies. The informant stated that approximately one week ago FINESTONE was employed on a research job for Benton and Bowles, an advertising concern with offices at 1444 Madison Avenue, New York 22, New York.

B. Residences

T-3, of known reliability, advised on February 8, 1954 that FINESTONE is residing at 33-66 Decatur Avenue, Pronx 67, New York with his wife ANNETTENCHAIT SENESTONE. The informant advised that a daughter was born to the FINESTONES January 24, 1954 and she has been named LAURA.

II. INTERVIEW WITH T-4

T-4, of known reliability, advised on March 29, 1954 that he had mot MARVELL FINESTONE while he was residing with FDWARD JAMES WEINSTEIN at 418 East Ninth Street, New York City, during 1950. T-4 further stated that he had visited the apartment of WEINSTEIN and FINESTONE at the Apartment of WEINSTEIN at the Apartment

of 1950. This contact probably took place during the evening hours and the informant met DANIELLETELEN and two girls, who also lived in the apartment building at 418 East 9th Street, at the WEINSTEIN-FINISTONE apartment. The informant believes that MARIEN was dating one of the two girls.

T-4 states that he attended one or two parties at the WEINSTEIN-FINESTONE apartment in the latter part of the summer of 1950. These parties were of a social nature and there were other friends of WEINSTEIN and FINESTONE also in attendance. The informant was unable to furnish the names of any of these individuals. These individuals were, for the most part, introduced as friends of either WEINSTEIN or FINESTONE.

T-4 recalled that WEINSTETN belonged to the Tompkins Souare Young Progressives of America Club and on one occasion he attended a dance sponsored by this club. WEINSTEIN was Organizational Secretary of this Young Progressives of America Club or held some similar post, according to T-4. The informant explained the Young Progressives of America Club rented a hall in the Tompkins Scuere area which was used as a meeting place and for dances and other social functions.

Concerning FIMESTONE, T-4 advised that he knew his parents HUGH and ANNA SHAFFIN, who lived on a small farm out from Ithaca, New York. The informant believes that the CHAFFINS were members of an American Labor Party movie group in Ithaca, New York. This American Labor Party movie group would obtain old movies and exhibit them for the benefit of their membership. The CHAFFINS also made available their home on various occasions for the purpose of meetings of the Cornell Labor Youth League during the 1950-1951 period. The CHAFFINS, according to T-4; were members of the American Labor Party in Ithaca, New York.

T-4 advised that he had heard through hearsay information that FINESTONE was at one time leader of the Communist Party Student Club at Cornell University. This leadership of that Communist Party student group on the part of FINESTONE would have taken place prior to the 1950-1951 period.

T-5, of known reliability, advised on January 7 and 8, 1954 that JOHN MAROUSEE was a member of the [Communist Party from

the similar of 1948 until 1951.

-Concorning DANIEL MARIEN, T-5 advised on January 7 and 8, 1954 that be also believed MARIEN to be a member of the Communict Party during MARIEN's matriculation at Cornell University during the late 1940's and early 1950's. MARIEN, according to the informant, was believed to have been a member of the Student Branch of the Communicat Party at Cornell University.

T-5 further advised on Jenuary 7 and 8, 1954 that HUGH and ANNA CHAFFIN, parents of the subject, were members of the Formuli at Farty in Ithaca, New York, during the 1948-1951 period.

The Communist Party and the Labor Youth League have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The "Guide to Subversive Organizations and Publications' dated May 14, 1951, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the American Labor Party:

- "1. For years, the Communists have put forth the greatest efforts to capture the entire American Labor Party throughout New York "tate. They assecteded in capturing the Manhattan and Brooklyn sections of the American Labor Party but outside of New York City they have been unable to win control. (Special Committee on Un-American Activities, Report, March 29, 1944, page 78).
- "2. Among forganizations that are victims of Communist domination." (California Committee on Un-American Activities, Report, 1948, pages 40 and 41.)"

T-15, of known reliability, advised that while the Young Progressives of America is not a Communist dominated

organization, it received support of the Communist Party and consists of both Communist and non-Communist youth.

HERPERT ROMERSTEIN, a self-admitted former Young Progressives of America member, in testimony before a subcommittee of the Committee of the Judiciary United States Senate on April 12, 1951 and June 12, 1951, stated that the Young Progressives of America was set up on the basis of the needs of the Communist Party. Young Progressives of America members were active within the organization as Communists, and the organization was developed along Communist Party lines. He added that Young Progressives of America leadership was composed of Communist Party members.

III. INFORMATION REGARDING AUNETTE CHAIT FINESTONE'S COMMUNIST FARTY ACTIVITIES

T-6, of known reliability, advised on October 10, 1953 that ANNETTE CHAIT FINESTONE was believed to be a member of a Communist Party cell active in New York City during February, March and April of 1953. This informant advised that the records concerning this Communist Party cell were in the possession of ANNETTE CHAIT FINESTONE during the Call of 1953 and she was believed to be most probably the coordinator of the activities for this Communist Party group, which included a canvass of the Chelsea and Lower West Side section of New York City for "Daily Worker" and "Worker" subscriptions during the months of February, March and April, 1953.

The informant stated that the "Daily Worker" and Sunday "Worker" renewal cards were in the possession of ANNETTE CHAIT FINESTONE during the fall of 1953.

It is noted that the "Worker" is the Sunday edition of the "Daily Worker", an east coast Communist newspaper.

Further, T-6 stated that ANNUTTE CHAIT MINESTONE and her husband, MAXUELL FINESTONE, maintained a considerable quantity of Communist Party literature, which included pamphlets, books and other materials. The literature pertaining to the Jefferson School of Social Science was also maintained by

the FINESTONES at their residence at 106 Bedford Street, New York, New York.

The Jefferson School of Social Science has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

IV. INVESTIGATION REGARDING FINESTONE'S CONTACTS

A. Individuals

1. ALPERN, 75 West 190th Street, New York City

T-7, of known reliability, advised on March 16, 1954 that MAXWELL or ANNETTE CHAIT FINESTONE had received correspondence from the above-captioned individual.

T-6, previously mentioned, advised on October 10, 1953 that the name of AL LEERN, Telephone LU 3-0013 appeared in ANNETTE CHAIT FINESTONE'S telephone-address book.

The current Menhattan Address Tolephone Directory lists ADERT ALTERN, 75 West 190th Street, as subscriber to telephone NE 3-2994.

The indices of the New York Office failed to reflect any derogatory information concerning ALPERT ALPERN.

2. JACK BERKOWITZ, 15 Park Row, New York 38, New York

T-7, previously mentioned, advised on January 28, and March 16, 1954 that NAXWELL and/or ANNETTE CHAIT FINESTONE had received correspondence from the above-captioned individual.

T-6, mentioned previously, advised on October 10, 1953 that the name of JACK BERKOWITZ, 15 Park Row, New York 17, New York, New York Telephone WO 4-7135, appeared as an entry in ANNETTE CHAIT FINESTONE's telephone-address book. This informant stated that after this entry there appeared a

notation "fire insurance."

The indices of the New York Office reflect no derogatory information concerning JACK BERKOWITZ.

3. CHAIT, Accord, New York

T-7 advised on November 24, 1953 and again on March 1954 that MACUELL and/or ANNETTE CHAIT FINISTONE had received correspondence from the above-captioned individual.

It is recalled that Accord, Now_York, is the address of ALEXANDER and SARANDSHAIT, parents of ANNETTE CHAIT FINESTONE.

4. A. CHAFFIN, R.D. #h, Ithaca, New York

T-7 advised on January 5, 1954 that correspondence had been received from the above-captioned individual by MAX and/or ANNETTE CHITTINESTONE.

It will be recalled that ANNA CHAFTIN is the mother of the subject and currently resides outside of Ithaca, New York, on kD #4.

5. FOREST L. (DOSS, 1071) Turnbow Drive, Sun Island, California

T-7 advised on March 16, 1954 that MAXWELL and/or ANNETTE CH'IT WINESTONE received correspondence from the above-captioned individual.

T-6, mentioned previously, advised on October 10, 1953 that the entry "Fornest and Betty ss. (Jill and Sherry) 10714 Turnbow Drive, Sunland, California", appeared in the telephone-address book of ANNETTE CHAIT FINESTONE.

The United States Postal Guide Thils to list a Sun Island, California, however, it does list the town of Sunland, California, as a town located in Los Angeles County.

The indices of the New York Office fail to reflect any reference to FORREST or BETTY DOSS or JILL and SHERRY.

6. FEIDENS, 1007g 30th Street, N.E., Cedar Rapids, Iowa

T-7 advised on January 19, 1954 that correspondence was received by MAX and/or ANNETTE CHAIT FINESTONE from the above-captioned individuals.

It will be recalled that friends of MAX FINESTONE, BARBARA and BARRY TEIDEN, who attended Cornell University with the subject, reside at the above address.

7. ERNEST COLDBLUM,
Room 900,
198 Broadway,
Now York 38, New York

T-7 advised on January 19, 1954 that MAX and/or ANNETTE CHAIT FINESTONE received correspondence from the above individual.

On April 15, 1954 the writer ascertained that PRNEST GOLDBLUM is an insurance agent who has offices in Room 900, 198 Froadway, New York 38, New York. Mr. GOLDBLUM doals principally in fire insurance.

The indices of the New York Office fail to reflect any reference to FRNEST GOLDBLUM.

8. GOLDSMITH, L Castle Drive, Potsdam, New York

T-7 advised on January 28, 1954 and March 16, 1954 that MAXWELL and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

T-6 advised on October 10, 1953 that the above-captioned name and address appeared in 'NHETTE CHAIT FINESTONE's telephone-address book.

It is recalled that ANNETE CHAIT FINESTONE's sister

DOBOTHY is married to BENEDICT GOLDSMITH and that they reside at the Castle Drive, Potsdam, New York. He is employed as an instructor at the New York State Teachers College in Potsdam, New York.

9. G. GREENBERG, 2006 18th Street, Astoria 5. New York

T-7 advised on March 16, 1954 that MAXWELL FINESTONE and/or INNETTE CHIIT FINESTONE received correspondence from the above-captioned individual.

The current rugens Telephone Address Directory lists GERTRUDE GREENBERG at 2006 18th Street as subscriber to telephone RA 6-4019.

On March 24, 1954 an attempt was made to interview GERTRUDE GREENBERG, 2006 18th Street, Astoria, Long Island, New York, by SAS DONALD V. WARTER and PAUL R. BJORKLUND. GERTRUDE GREENBERG stated that she had "nothing to say." When further efforts were made to question her concerning her Communist Party activities she reiterated that she had nothing to discuss.

T-8, of known reliability, advised that it had received information from an informant of unknown reliability, but who was closely accusinted with to the effect that the former was an avowed Communist around 1935. The source stated that she believed in all of the Communist Party teachings, doctrines and beliefs and that she went to every Communist meeting, rally or parade. T-8's informant also indicated that in 1941 it was the opinion of the informant that the subject had possibly been elevated to an important position in the Communist Party in 1940; had been a ducs-paying member of the Communist Farty; and was at that time a member in good standing.

The source further stated that married a non-Communist named in 1935 and was divorced by him around 1939 because of her conduct with another Communist Perty member named had served in the overseas bettalion of the Abraham

Due to the absence of proof of actual participation in this distribution, her suspension was withheld. At that time Miss DANIELS stated that should not be placed in any position of trust or authority since she was very immature and easily influenced.

10. PETE HARMON, Hotel Albert, 65 University Place, New York City



T.7 advised on March 16, 1954 that MAX TINESTONE and/or ANNETTE CHAIT TINESTONE received correspondence from



the above-captioned individual.

An individual by the name of ALPION AUGUSTUS FIRTUILL of 43-38 47th Street, Long Island City, New York, who is identical with the above individual, an Aidd for a position as rest inspector to the Office for Emergency Management on August 28, 1942. The application form indicated that he was born on Docember 19, 1907 or December 14, 1907 at Cardner, Worcester, Massachusetts.

Ho indicated that he had a relative in Government service, his wife, HALO CHADVICH HARTMELL, who was employed as the senior employment counseller with the United States Employment Service.

He indicated that he had been an assistant professor with the Overseas Educational Institute, New York City, and at Grenoble, France, from September, 1932 to July 1, 1933; GWS Teacher's College at Columbia University as a research worker from November, 1933 to May, 1934. He was a technical supervisor for F.E.R.A., Foran School for Merkers at 302 East 35th Street, New York City, from May, 1934 until January, 1935. He was also an executive secretary of the Inter-Professional Association, Room 700, 130 East 22nd Street, New York City, from January, 1935 to April, 1937.

T-9, of unknown rollability, advised that HARTWELL was employed by the Works Progress Administration in a project at Columbia University from 1933 to 1934. The informant advised that "he shirked his work continuously and was very lazy." He was conceited and overboaring and was a member of the Communist Party.

The informant advised that HARTWELL attempted to convert many of the employees at Teacher's College, Columbia University, by distributing various Communist pamphlets and other literature among them and consistently "preached Communist doctrines." HARTWELL continuously voiced his belief in

NY 65-15735 .

Communism to the informant, and made every effort to convert the informant to the cause.

HARTWELL met his wife, HALO CHADUICH, at Columbia - University, -where-she-was-known to-be-a-member-of-the----- Communist Party.

According to the informant, HARTVELL refused a position as instructor in a high school because it would interfere with his communist activities.

The records of the Board of Elections were reviewed by SA ROBERT F. McGUINNESS on August 27, 1943 and reflected that HARTWELL and his wife, HALO, registered as members of the American Labor Party for the years 1941, 1942 and 1943.

12. ARTHUR GARFIELD MAYS, Cornish Arms Hotel, 23rd Street and 8th Avenue, New York, New York

T-7 advised on March,16, 1954 that MAX FINESTONE and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

It is noted that this article appeared in the "New York Post", March 14, 1954 issue, captioned "ARTHUR HAYS Will Address Chelsea ADA Branch." The article states that "ARTHUR GARFIELD HAYS, General Counsel of the American Civil Liberties Union, will address a meeting of Chelsea Branch, Americans for Democratic Action, at 8:30 PM, next Wednesday in the Cornish Arms Hotel on West 23rd Street.

"HAYS will discuss the question Would you Testify If You Wore Called Before a Congressional Committee?" He will discuss practices of various Congressional investigating groups including the Mc CARTHY Sub-Committee."

Mr. CHARLES B. WINN, Banquet Manager, Cornish Arms Hotel, 311 West 23rd Street. New York City, advised the writer on May 11, 1954 that ABTHUR GARFIELD HAYS is not a resident of this hotel. He believes that HAYS recently spoke before a meeting of the Chelsea Americans for Democratic Action Branch. Mr. WINN stated that this group usually meets at the hotel once each month. The hotel rents this ADA branch a neeting room, at which time coffee is served by the hotel.

The current Manhattan Telephone Directory lists ARTHUR GARFIELD HAYS as a lawyer with offices at 120 Broadway, Telephone DI 9-4141 and residence at 24 East 10th Street, telephone GR 3-8038.

On May 23, 1953, Mr. LISTON OAKS, Labor Editor, Voice of America, International Broadcasting Service, Department of State, 1775 Broadway, New York City, advised that ARTHUR GARFIELD HAYS is among the minority in the American Civil Liberties Union (ACLU). HAYS, in discussions within the ACLU, was Anti-Smith Act and against the outlawing of the Communist Party.

Mr. OAKS is an admitted former Communist Party member, 1927-1936, and was Editor of "Soviet Russia Today", from approximately 1929 until 1932.

"Soviet Russia Today" is cited as a "Communistfront publication".

(Congressional Committee on Un-American Activities House Report No. 1953, on the Congress of American Women, April 26, 1950 (originally released October 23, 1949), p.108.)

T-16, another government agency, advised on October 2, 1953 that it had been reliably reported that the Communists have infiltrated several local chapters of the Americans for Democratic Action, although the National Organization is anti-Communist.

On June 23, 1950, LOUIS F. BUDENZ, formerly managing editor of the "Daily Worker", an cast coast Communist newspaper, and a Communist Party functionary until he broke with the Party in October, 1945, advised SA WILLIAM J. MC CARTHY, JR. that the wife of ARTHUR GARFIELD HAYS, noted civil liberties lawyer, ALAINE DAVIS HAYS, was a concealed Communist when he knew. BUDENZ stated that he had met Mrs. HAYS several times in small Communist conferences in connection with the League of Women Shoppers and again in connection with the movement for the American Peace Mobilization. These took place in New York in the late 1930's and early 1940's. BUDENZ advised also that from that time on he was advised, up until 1945, by EUGENE DENNIS, JACK STACHEL and other members of the Communist Party Politburo that Mrs. HAYS continued to be an adherent of the Communist Party.

The "League of Women Shoppers" was cited as
"An organization which this committee found to be a
Communist controlled front by the indisputable documentary
evidence obtained from the files of the Communist Party
in Philadelphia. The original Executive Secretary of the
League was HELEN KAY, a Communist Party member."

(Special Committee on Un-American Activities,
Report, March 29, 1944, pp. 121 and 181.)

The "American Peace Mobilization" has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

T-7 advised on January 22, 1954 that MAX FINESTONE

The indices of the New York Office fail to reflect any reference believed identical with D.H. LEVINE.

T-10, of known reliability, advised on October 30, 1953 that GEORGE M. and JANETYLIBIN, of 1140 Columbus Avenue, Boston, Massachusetts, relatives of MAXWELL FINESTONE, visited with the FINESTONES at their 106 Bedford Street, New York 14, New York, address.

Mr. JOHN R. SHAW, Assistant Manager of the Hotel Statler, New York City, advised the writer on December 14, 1953 that Mr. and Mrs. GEORGE LIBIN, 1140 Columbus Avenue, Boston, Massachusetts, were guests of their hotel from October 30, 1953 until the early morning of November 3, 1953.

T-7 advised on March 15, 1954 that MAXWELL FINESTONE and/or ANNETTE CHAIT FINESTONE received correspondence from the above.

The current Manhattan Address Telephone Directory was reviewed on April 15, 1954 in an attempt to identify this correspondent.

Inculry at the 545 Fifth Avenue address on the same date was conducted by the writer. It was noted that this is

a large business building with many tenants. Neither the review of the current Hanhattan iddress Telephone Directory, nor induity at the 545 Fifth Avenue address revealed any individual or concern at this location with the initials of J.M.

16. J. McGUFFIN, 67 West 11th Street, New York 7, New York

T-7 advised on January 9, 1954 that MAX FINESTONE or ANNETTE CHAIT FINESTONE had received a Christmas card from the above-cartioned individual.

T-6 advised on October 10, 1953 that the entry "JANIE MCGUEFIN, PL 3-9560, 67 West 11th Street, WA 9-1212, BEA', 129 East 52nd, office PL 8-0522" appeared in ANNETTE CHAIT FINESTONE's address-telephone book.

The current Manhattan Tolephone Address Directory lists JANIE McGUFFIN, 67 West 11th Street, as subscriber to telephone number WA 9-1211 and the American Association of Group Workers, 129 East 52nd Street, as subscriber to PL 3-9560.

On July 8, 1953 JAMP McGUTTIN, nec JANIE MARGARET EOYLE, was interviewed by SAS ALEX NOER M. GANCKY and CHEISTOPHER J. PAPPI ANOU, at which time she refused to discuss any of her activities in connection with the Communist Party or the identity or activities of any other individuals who may have been similarly engaged.

On April 10, 1951/ROBERT PAUL MG GUFFIN, Jr. was interviewed by SA GFORGE M. CIBSON at the California Institution for Men. Chino, California, at which time he furnished the following information:

MC GUFFIN advised that upon parole he could be reached through his brother, Lioutenant JAMES P. MC CUFFIN, United States Air Force, 5315 Williamsburg Court, Kansas City, Missouri. MC GUFFIN advised that his former wife, JANIE, nee JANIE M/RGARFT BOYLE, was born August 29, 1915 at Taylor, Texas, and was roised in Houston, Texas. She

completed high school in Houston and finished about a year at Massey Eusiness College, Houston. MC CUFFEN married JANIE May 21, 1937-at-Houston, Texas, (marriage-license--- issued in Richmond County, Texas). Mrs. MC CUFFEN obtained an Interloputory Decree of Divorce in New York City about August, 1947.

MC GUFFIN advised that in 1945 he and his wife were residing at 102 West 98th Street, New York City, however, they wanted to move to Greenwich Village and while looking for an apartment Janie met one RERTHALMEGOWAN. This was in the latter part of 1945 or the early part of 1946.
BERTHA MC GOWAN located an apartment for the MC CUFFINS at 78 Perry Street which is located in the Greenwich Village section of New York City. MC GUFFIN stated that he subscruently learned that BERTHA MC GOWAN was secretary to an official of the Vest Post Maritime Union whose office was in Cooper Union, Cooper Scuare, New York City. MC GUFFIN stated he became well accuainted with BERTHA and her husband, whose first name he believed to be JIM, and associated with them from 1946 to January, 1948.

MC GUFFIN stated that both EERTHA MC GOMAN and her husband were active Communist Party members and that they attempted to recruit him into the Communist Party. At that time MC GUFFIN was working for the Dutch Government, holding the position of Assistant Comptroller to the Economic, Financial and Shipping Mission of the Royal Netherlands Government, 615 Broadway, New York City.

MC GUFFIN stated JANIE was a typical Texas girl and had never known anything about Communism. However, after moving to 78 Perry Street they began attending social functions with BERTHA MC GOWAN and her friends. After several months MC GUFFIN realized he was in a group of Communists and wented to stop this association. However, JANIE refused as she had become interested in Communism.

At this time MC GUFFIN tried to get JANIE to accompany him on a visit to opringfield, Missouri, but she rotused so he separated from her and went to Springfield from May until August, 1946. After his return, in about September or October, 1946, JANIE showed him her Communist Party membership card. MC GUFFIN recalled that the card

was in the name of JANTE MC GUEFIN. He believed that it had a group number such as 249 or 259 or some similar such number and the address on it was Waverly Place, Forest Street, or in the vicinity,

MC GUFFIN stated that after he returned to New York in August, 1946, he and his wife moved to 105 Thompson Street, New York City. At this time MC GUFFIN obtained a job with the Amalgameted Insurance Fund, while JANIE continued her Communist Party activities such as attending Communist Party meetings, functions, etcetera.

MC GUFFIN stated that he believed JANIE was a minor district leader of the Communist Party. She attended numerous sponsored Communist fund-raising affairs known as "Door Parties". Everything cost 1.00, such as admission, drinks, sandwiches, etectera. According to McGUFFIN, JANIE would spend 125.00 to \$150.00 for refreshments for these parties and would contribute this amount. MC GUFFIN stated he attended one of these parties with his wife, which party was held on Waverly Place, next door to the Greenwich Villago Inn.

MC CUFFIN stated that while he was living with JANIE, they operated the Sheridan Clam Bar, 95 Seventh Avenue, South Sheridan Square, New York City. He stated that this was a hangout for Communist Party members who were continually sponging free meals.

MC GUFFIN stated he separated from JANIE in April 1947 because she could not or would not give up Communism. He stated he returned to Missouri and instituted divorce proceedings, although he subsequently permitted JANIE to obtain the divorce. He returned to New York City, where he stayed from October to December, 1947. During this period he stayed with his former wife, however, MC GUFFIN claimed that they did not live as man and wife. MC GUFFIN stated that JANIE was still active with the Communist Party at that time. Since that time, MC GUFFIN has not seen JANIE; however, he did write to her while in jail to inquire about their sen, ROBERT PAUL MC CUFFIN, Jr., born October 17, 1941 in Fort Worth, Texas. MC GUFFIN received three or four

letters from J. MIE which said nothing about their son but harangued him about being in jail and asked why he did not "see the light" and join the Farty. He received his last letter about January, 1950. MC GUFFIN stated that he did not save any of them.

MC GUFFIN further related that while he was still living with JANIE she affiliated herself with the American Association of Group Workers (AAGW) as a secretary and that as far as he knew she still worked for this organization. MC GUFFIN stated that it was his understanding that this is a Communist Party front organization that obtains contacts in professional groups such as doctors, lawyers, teachers, social workers, etectora, however, he did not recall the source of information concerning this opinion.

MC GUFFIN stated that JAMIE had sent their son to the "Little Red School" which he stated was a well-known school in New York City where Communist Party members send their children, and that all of the teachers were Communists. MC GUFFIN stated that their son was then attending the New Jeffersonian School of Social Science, New York City, which, according to MC GUFFIN, was reputed to be a Communist spensored and controlled school. He stated that Leninism, Marxism and anti-capitalism were taught there. MC GUFFIN also advised that JANIE and their son regularly attend Camp Beacon Summer Camp located seventy-five miles up the Hudson River and operated by Communists.

17. MARI NEXAS, 107 East 48th Street, Now York

T-7 advised on Docember 5, 1953 that MAX FINESTONE and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

Current Manhattan Address Tolophone Directory lists the Cornell Club of New York, Tolophone Number PL 5-7210 and the Cornell University Placement Service, Telephone Number PL 5-5085, as the occupants of 107 East 48th Street, New York.

It is noted that MAX FENDSTONU is a graduate of the New York School of Industrial and Labor Relations, __ Cornell University, and he has, according to information set forth in Section I, Sub-section A, of this report, been interested in obtaining other employment.

The indices of the New York Office fail to reflect any reference to MARIA NEXAS.

T-7 advised on March 16, 1954 that MAX FINESTONE and/or ANNUTE CHAIT FINESTONE received correspondence from the above-captioned individual.

T-6 advised on October 10, 1953 that the entry "RUBIN, FAX and BOB, 324 West 24th Street, LA 4-9290, home CH 3-7373" appeared in ANNETTE CHAIT MINESTONE's telephone-address book.

On May 27, 1949 T-11, of known reliability, advised that FAY RUBIN was known to the informant as a member of the Communist Party. This informant advised on November 26, 1947 that FAY and RCB RUBIN, husband and wife, were members of the Eob Thompson Club of the Chelsea Section, Communist Party, USA. This club was active in New York City.

19. W.C.ABURIN, 832 Octon Avenue, Brooklyn, New York

T-7 advised on November 27, 1953 that MAX FINESTONE and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

The current Brooklyn Address Telephone Directory lists Mrs. FLORENCE RUBIN, 832 Ocean Avenue, as the subscriber to Telephone Number IN 9-1169.

T-6 advised on October 10, 1953 that the entry "CPARLEY" and FLORENCE RUBIN, waiters, St 6-2341", appeared in ANNETTE

CHIT FINESTONE's telephone-address book.

CHARGE RUPIN, who was employed at the Compus Host Lunchconette, 30 Wost 4th Street, New York City, and who resided at 832 Ocean Avenue, Brooklyn, New York, was interviewed by SAS JAMES J. JOHNSON and SIDNEY E. HOWE on January 20, 1954. After admitting his identity he made the following comment regarding Communism:

"Mc, a Commie! I wouldn't spit on a ______

Despite repeated attempts to engage him in further conversation, RUEIN refused to make any further statement and the interview was terminated.

T-12, of known reliability, advised on December 19, 1952 that FLORENCE and CHARLES RUBIN were members of the Communist Party and had transferred from New York to California in early 1951. The informant stated that FLORENCE and CHARLES RUBIN had been assigned to do some Communist Party work in California but he did not know the exact nature of this activity.

FINESTONE and they have over the past several years worked on many market research projects together.

T-13, of known reliability, advised concerning the Morning Freiheit Association on November 15, 1949, that this association was the "central organ of Jewish Communist activity in the United States." It is also noted that T-13 advised on December 11, 1946 that the Administrative Committee of the association was also the National Jewish Committee of the Communist Party, USA.

"Jewish Life", in its issue of April, 1952, Page 22, Columns 1 and 2, in an article entitled "30th Birthday Greetings to the 'Morning Freiheit'", said, "We of Jewish Life owe a special debt to the 'Morning Freiheit' for we are its English speaking off-spring."

The "Daily Worker", an east coast Communist newspaper, in the issue of December 9, 1946, Page 7, Column 1, in an editorial referred to the "Morning Freiheit" as the Jewish language Communist newspaper.







These parties were of a social nature and there were other friends of WEINSTEIN and FINESTONE also in attendance. The informant was unable to furnish the names of any of these individuals. These individuals were, for the most part, introduced as friends of either WEINSTEIN or FINESTONE.

T-4 recalled that WEINSTEIN belonged to the Tompkins Source Young Progressives of America Club and on one occasion he attended a dance sponsored by this club. WEINSTEIN was Organizational Secretary of this Young Progressives of America Club or held some similar post, according to T-4. The informant explained the Young Progressives of America Club rented a hall in the Tompkins Square area which was used as a meeting place and for dances and other social functions.

Concerning FINESTONE, T-h advised that he knew his parents HUGH and ANNA CHAFFIN, who lived on a small farm out from Ithaca, New York. The informant believes that the CHAFFINS were members of an American Labor Party movie group in Ithaca, New York. This American Labor Party movie group would obtain old movies and exhibit them for the bonofit of their membership. The CHAFFINS also made available their home on various occasions for the purpose of meetings of the Cornell Labor Youth League during the 1950-1951 period. The CHAFFINS, according to T-4, were members of the American Labor Party in Ithaca, New York.

T-4 advised that he had heard through heersay information that FINESTONE was at one time leader of the Communist Party Student Club at Cornell University. This leadership of that Communist Party student group on the part of FINESTONE would have taken place prior to the 1950-1951 period.

T-5, of known reliability, advised on January 7 and 8, 1954 that JOHN MAROUSEE was a member of the Communist Party from

the-summer-of-1948 until 1951._

Concerning DANIEL MARIEN, T-5 advised on January 7 and 8, 1954 that he also believed MARIEN to be a member of the Communist Party during MARIEN's matriculation at Cornell University during the late 1940's and early 1950's. MARIEN, according to the informant, was believed to have been a member of the Student Branch of the Communist Party at Cornell University.

T-5 further advised on January 7 and 8, 1954 that HUGH and ANNA CHAFFIN, parents of the subject, were members of the Communist Farty in Ithaca, New York, during the 1948-1951 period.

The Communist Party and the Labor Youth League have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The "Guide to Subversive Organizations and Publications' dated May 14, 1951, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the American Labor Party:

- "1. For years, the Communists have put forth the greatest efforts to capture the entire American Labor Party throughout New York State. They succeeded in capturing the Manhattan and Brooklyn sections of the American Labor Party but outside of New York City they have been unable to win control. (Special Committee on Un-American Activities, Report, March 29, 1944, page 78).
- *2. Among 'organizations that are victims of Communist domination. (California Committee on Un-American Activities, Report, 1948, pages 40 and 41.)

T-15, of known reliability, advised that while the Young Progressives of America is not a Communist dominated

organization, it received support of the Communist Party and consists of both Communist and non-Communist youth.

HEREERT ROMERSTEIN, a self-admitted former Young Progressives of America member, in testimony before a subcommittee of the Committee of the Judiciary United States Senate on April 12, 1951 and June 12, 1951, stated that the Young Progressives of America was set up on the basis of the needs of the Communist Party. Young Progressives of America members were active within the organization as Communists, and the organization was developed along Communist Party lines. He added that Young Progressives of America leadership was composed of Communist Party members.

III. INFORMATION REGARDING ANNETTE CHAIT FINESTONE'S COMMUNIST PARTY ACTIVITIES

T-6, of known reliability, advised on October 10, 1953 that ANNETTE CHAIT FINESTONE was believed to be a member of a Communist Party cell active in New York City during February, March and April of 1953. This informant advised that the records concerning this Communist Party cell were in the possession of ANNETTE CHAIT FINESTONE during the fall of 1953 and she was believed to be most probably the coordinator of the activities for this Communist Party group, which included a cenvass of the Chelsea and Lower West Side section of New York City for "Daily Worker" and "Worker" subscriptions during the months of February, March and April, 1953.

The informant stated that the "Deily Worker" and Sunday "Worker" renewal cards were in the possession of ANNETTE CHIT FINESTONE during the fall of 1953.

It is noted that the "Worker" is the Sunday edition of the "Daily Worker", an east coast Communist newspaper.

Further, T-6 stated that ANNETTE CHAIT FINESTONE and her husband, MAXVELL FINESTONE, maintained a considerable ouantity of Communist Party literature, which included pamphlets, books and other materials. The literature pertaining to the Jefferson School of Social Science was also maintained by

the FINESTONES at their residence at 106 Bedford Street, New York, New York.

The Jefferson School of Social Science has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

T-7, of known reliability, advised on March 16, 1954 that MAXWELL or ANNETTE CHAIT FINESTONE had received correspondence from the above-captioned individual.

T-6, previously mentioned, advised on October 10, 1953 that the name of AL ALPERN, Telephono LU 3-0013 appeared in ANNETTE CHAIT FINESTONE'S telephone-address book,

The current Menhattan Address Tolephone Directory lists ALBERT ALPERN, 75 West 190th Street, as subscriber to telephone WE 3-2994.

The indices of the New York Office failed to reflect any derogatory information concerning ALBERT ALPERN.

2. JACK BERKOWITZ, 15 Park Row, New York 38, New York

T-7, previously mentioned, advised on January 28, and March 16, 1954 that MAXWELL and/or ANNETTE CHAIT FINESTONE had received correspondence from the above-captioned individual.

T-6, mentioned previously, advised on October 10, 1953 that the name of JACK BERKOWITZ, 15 Park Row, New York 17, New York, New York Telephone WO 4-7135, appeared as an entry in ANNETTE CHAIT FINESTONE's telephone-address book. This informant stated that after this entry there appeared a

notation fire insurance."

The indices of the New York Office reflect no derogatory information conserning JACK BERKOWITZ.

3. CHAIT, Accord, New York

T-7 advised on November 24, 1953 and again on March 16, 1954 that MARVELL and/or ANNETTE CHAIT FINISTONE had received correspondence from the above-captioned individual.

It is recalled that Accord, New York, is the address of ALEXANDER and SARAH CHAIT, parents of ANNETTE CHAIT FINESTONE.

4. A. CHAFFIN, R.D. #4, Ithaca, New York

T-7 advised on January 5, 1954 that correspondence had been received from the above-captioned individual by MAX and/or ANNETTE CH.IT FINESTONE.

It will be recalled that ANNA CHAFFIN is the mother of the subject and currently resides outside of Ithaca, New York, on RD #4.

5. FOREST L. DOSS, 10714 Turnbow Drive, Sun Island, California

T-7 advised on March 16, 1954 that MAXWELL and/or ANNETTE CH'IT FINESTONE received correspondence from the above-captioned individual.

T-6, mentioned previously, advised on October 10, 1953 that the entry "Forrest and Betty Doss (Jill and Sherry) 10714 Turnbow Drive, Sunland, California", appeared in the telephone-address book of ANNETTE CHAIT FINESTONE.

The United States Postal Guide fails to list a Sun Island, California, however, it does list the town of Sunland, California, as a town located in Los Angeles County.

T-7 advised on January 19, 1954 that MAX and/or ANNETTE CHAIT FINESTONE received correspondence from the above individual.

On April 15, 1954 the writer ascertained that ERNEST GOLDBLUM is an insurance agent who has offices in Room 900, 198 Proadway, New York 38, New York. Mr. GOLDBLUM deals principally in fire insurance.

The indices of the New York Office fail to reflect any reference to ERNEST GOLDBLUM.

6. GOLDSMITH, 4 Castle Drive, Potsdam, New York

T-7 advised on January 28, 1954 and March 16, 1954 that MAXWELL and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

T-6 advised on October 10, 1953 that the above-captioned name and address appeared in NNETTE CHAIT FINESTONE's telephone-address book.

It is recalled that ANNETE CHAIT FINESTONE's sister

T-7 advised on March 16, 1954 that MAXWELL FINESTONE and/or ANNETTE CHIT FINESTONE received correspondence from the above-captioned individual.

The current Queens Telephone Address Directory lists GERTRUDE GREENEERS at 2006 18th Street as subscriber to telephone RA 6-4019.

On March 24, 1954 an attempt was made to interview GERTRUDE GREENBERG, 2006 18th Street, Astoria, Long Island, New York, by SAS DONALD V. WARNER and PAUL R. BJORKLUND. GERTRUDE GREENEERG stated that she had "nothing to say." When further efforts were made to question her concerning her Communist Party activities she reiterated that she had nothing to discuss.

T-8, of known reliability, advised that it had received information from an informant of unknown reliability, but who was closely accusinted with to the effect that the former was an avowed Communist around 1935. The source stated that she believed in all of the Communist Party teachings, doctrines and beliefs and that she want to every Communist meeting, rally or parade. T-8's informant also indicated that in 1941 it was the opinion of the informant that the subject had possibly been elevated to an important position in the Communist Party in 1940; had been a ducs-paying member of the Communist Party; and was at that time a member in good standing.

Due to the absence of proof of the Sactual participation in this distribution, her suspension was withheld. At that time Miss DANIELS stated that should not be placed in any position of trust or authority since she was very immature and easily influenced.

T-7 advised on March 16, 1954 that MAX FINESTONE and/or NNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

The informant further advised that the FINESTONES had also received correspondence from an unnamed individual using the Hotel Albert address.

On April 12, 1954 incuiry was made at the Hotel Albert by the writer in an attempt to further identify PETE HARMON. PETE HARMON was unknown at the hotel and is not currently registered as a guest.

The current Cueens Address Telephone Directory lists one A.A. HARTWELL at 43-38 47th Street, as the subscriber to telephone RA 9-8891.

An individual by the name of ALBION AUGUSTUS
HIRTHELL of 43-38 47th Street, Long Island City, New York, who
is identical with the above individual, applied for a position
as rent inspector to the Office for Emergency Management on
August 28, 1942. The application form indicated that he was
born on December 19, 1907 or December 14, 1907 at Gardner,
Worcester, Massachusetts.

He indicated that he had a relative in Government service, his wife, HALO CHADVICH HART ELL, who was employed as the senior employment counsellor with the United States Employment Service.

He indicated that he had been an assistant professor with the Overseas Educational Institute, New York City, and at Grenoble, France, from September, 1932 to July 1, 1933; GWS Teacher's College at Columbia University as a research worker from November, 1933 to May, 1934. He was a technical supervisor for F.E.R.A., Feran School for Workers at 302 East 35th Street, New York City, from May, 1934 until January, 1935. He was also an executive secretary of the Interprofessional Association, Room 700, 130 East 22nd Street, New York City, from January, 1935 to April, 1937.

T-9, of unknown reliability, advised that HARTWELL was employed by the Works Progress Administration in a project at Columbia University from 1933 to 1934. The informant advised that "he shirked his work continuously and was very lazy." He was conceited and overbearing and was a member of the Communist Party.

The informant advised that HARTWELL attempted to convert many of the employees at Teacher's College, Columbia University, by distributing various Communist pamphlets and other literature among them and consistently "preached Communist doctrines." HARTWELL continuously voiced his belief in

Communism to the informant, and made every effort to convert the informant to the cause.

HARTWELL met his wife, HALO CHADWICH, at-Columbia University, where she was known to be a member of the Communist Party.

According to the informant, HARTWELL refused a position as instructor in a high school because it would interfere with his Communist activities.

The records of the Board of Elections were reviewed by SA ROBERT F. McGUINNESS on August 27, 1943 and reflected that HARTWELL and his wife, HALO, registered as members of the American Labor Party for the years 1941, 1942 and 1943.

12. ARTHUR GARFIELD HAYS, Cornish Arms Hotel, 23rd Street and 8th Avenue, New York, New York

T-7 advised on March 16, 1954 that MAX FINESTONE and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

It is noted that this article appeared in the "New York Post", March 14, 1954 issue, captioned "ARTHUR HAYS Will Address Chelsea ADA Branch." The article states that "ARTHUR GARFIELD HAYS, General Counsel of the American Civil Liberties Union, will address a meeting of Chelsea Branch, Americans for Democratic Action, at 8:30 PM, next Wednesday in the Cornish Arms Hotel on West 23rd Street.

*HAYS will discuss the question Would you Testify If You Were Called Before a Congressional Committee?! He will discuss practices of various Congressional investigating groups including the Mc CARTHY Sub-Committee."

Mr. CHARLES B. WINN, Banquet Manager, Cornish Arms Hotel, 311 West 23rd Street, New York City, advised the writer on May 11, 1954 that ARTHUR GARFIELD HAYS is not a resident of this hotel. He believes that HAYS recently spoke before a meeting of the Chelsea Americans for Democratic Action Branch. Mr. WINN stated that this group usually meets at the hotel once each month. The hotel rents this ADA branch a meeting room, at which time coffee is served by the hotel.

The current Manhattan Telephone Directory lists ARTHUR GARFIELD HAYS as a lawyer with offices at 120 Broadway, Telephone DI 9-4141 and residence at 24 East 10th Street, telephone GR 3-8038.

On May 23, 1953, Mr. LISTON OAKS, Iabor Editor, Voice of America, International Broadcasting Service, Department of State, 1775 Broadway, New York City, advised that ARTHUR GARFIELD HAYS is among the minority in the American Civil Liberties Union (ACLU). HAYS, in discussions within the ACLU, was Anti-Smith Act and against the outlawing of the Communist Party.

Mr. OAKS is an admitted former Communist Party member, 1927-1936, and was Editor of "Soviet Russia Today", from approximately 1929 until 1932.

"Soviet Russia Today" is cited as a "Communistfront publication".

(Congressional Committee on Un-American Activities, House Report No. 1953, on the Congress of American Women, April 26, 1950 (originally released October 23, 1949), p.108.)

T-16, another government agency, advised on October 2, 1953 that it had been reliably reported that the Communists have infiltrated several local chapters of the Americans for Democratic Action, although the National Organization is anti-Communist.

On June 23, 1950, LOUIS F. BUDENZ, formerly managing editor of the "Daily Worker", an east coast Communist newspaper, and a Communist Party functionary until he broke with the Party in October, 1945, advised SA WILLIAM J. MC CARTHY, JR. that the wife of ARTHUR GARFIELD HAYS, noted civil liberties lawyer, ALAINE DAVIS HAYS, was a concealed Communist whom he knew. BUDENZ stated that he had met Mrs. HAYS several times in small Communist conferences in connection with the League of Women Shoppers and again in connection with the movement for the American Peace Mobilization. These took place in New York in the late 1930's and early 1940's. BUDENZ advised also that from that time on he was advised, up until 1945, by EUGENE DENNIS, JACK STACHEL and other nembers of the Communist Party Politburo that Mrs. HAYS continued to be an adherent of the Communist Party.

The "League of Women Shoppers" was cited as
"An organization which this committee found to be a
Communist controlled front by the indisputable documentary
evidence obtained from the files of the Communist Party
in Philadelphia. The original Executive Secretary of the
League was HELEN KAY, a Communist Party member."

(Special Committee on Un-American Activities,

T-7 advised on January 22, 1954 that MAX FINESTONE

and/or ANNETTE CHAIT FINESTONE received correspondence from the above-captioned individual.

The current Manhattan Address Telephone Directory has a listing for Mrs. EVE LEVINE at 239 East 19th Street, Telephone GR 3-5754.

The indices of the New York Office fail to reflect any reference believed identical with D.H. LEVINE.

T-10, of known reliability, advised on October 30, 1953 that GEORGE M. and JANFT LIBIN, of 1140 Columbus Avenue, Boston, Massachusetts, relatives of MAXWELL FINESTONE, visited with the FINESTONES at their 106 Bedford Street, New York 14, New York, address.



T-7 advised on January 9, 1951, that MAX FINESTONE or ANNETTE CHAIT FINESTONE had received a Christmas card from the above-captioned individual.

T-6 advised on October 10, 1953 that the entry "JANIE McGUFFIN, PL 3-9560, 67 West 11th Street, WA 9-1212, BEA', 129 East 52nd, office PL 8-0522" appeared in ANNETTE CHAIT FINESTONE's address-telephone book.

The current Manhattan Telephone Address Directory lists JANIE McGUFFIN, 67 West 11th Street, as subscriber to telephone number WA 9-1211 and the American Association of Group Workers, 129 East 52nd Street, as subscriber to PL 3-9560.

On July 8, 1953 J'NIE McGUFFIN, nee JANIE MARGARET BOYLE, was interviewed by SAS ALEXANDER M. GANSKY and CHRISTOPHER J. PAPPIANOU, at which time she refused to discuss any of her activities in connection with the Communist Party or the identity or activities of any other individuals who may have been similarly engaged.

On April 10, 1951 ROBERT PAUL MC GUFFIN, Jr. was interviewed by SA GEORGE M. GIBSON at the California Institution for Men. Chino. California, at which time he furnished the following information:

MC GUFFIN advised that upon parole he could be reached through his brother, Lieutenant JAMES P. MC GUFFIN, United States Air Force, 5315 Williamsburg Court, Kansas City, Missouri. MC GUFFIN advised that his former wife, JANIE, nee JANIE MARGARET BOYLE, was born August 29, 1915 at Taylor, Texas, and was raised in Houston, Texas. She

completed high school in Houston and finished about a year at Masscy Business College, Houston. MC GUFFIN married JANIE May 21, 1937 at Houston, Texas, (marriage license issued in Richmond County, Texas). Mrs. MC GUFFIN obtained an Interlocutory Decree of Divorce in New York City about August, 1947.

MC GUFFIN advised that in 1945 he and his wife were residing at 102 West 98th Street, New York City, however, they wanted to move to Greenwich Village and while looking for an apartment JANIE met one BERTHA McGOWAN. This was in the latter part of 1945 or the early part of 1946, BERTHA MC GOWAN located an apartment for the MC GUFFINS at 78 Perry Street which is located in the Greenwich Village section of New York City. MC GUFFIN stated that he subsequently learned that BERTHA MC GOWAN was secretary to an official of the West Post Maritime Union whose office was in Cooper Union, Cooper Scuare, New York City. MC GUFFIN stated he became well accuainted with BERTHA and her husband, whose first name he believed to be JIM, and associated with them from 1946 to January, 1948.

MC GUFFIN stated that both BERTHA MC GOWAN and her husband were active Communist Party members and that they attempted to recruit him into the Communist Party. At that time MC GUFFIN was working for the Dutch Government, holding the position of Assistant Comptroller to the Economic, Financial and Shipping Mission of the Royal Notherlands Government, 615 Broadway, New York City.

MC GUFFIN stated JANIE was a typical Texas firl and had never known anything about Communism. However, after moving to 78 Perry Street they began attending social functions with BERTHA MC GOWAN and her friends. After several months MC GUFFIN realized he was in a group of Communists and wented to stop this association. However, JANIE refused as she had become interested in Communism.

At this time MC GUFFIN tried to get JANIE to eccompany him on a visit to pringfield, Missouri, but she refused so he separated from her and went to Springfield from May until August, 1946. After his return, in about September or October, 1946, JANIE showed him her Communist Party membership card. MC GUFFIN recalled that the card

was in the name of JANTE MC GUFFIN. He believed that it had a group number such as 249 or 259 or some similar such number and the address on it was Waverly Place, Forest Street, or in the vicinity.

MC GUFFIN stated that after he returned to New York in August, 1946, he and his wife moved to 105 Thompson Street, New York City. At this time MC GUFFIN obtained a job with the Amalgameted Insurance Fund, while JANIE continued her Communist Party activities such as attending Communist Party meetings, functions, etcetera.

MC GUFFIN stated that he believed JANIE was a minor district leader of the Communist Party. She attended numerous sponsored Communist fund-raising affairs known as "Door Parties". Everything cost 1.00, such as admission, drinks, sandwiches, etcetora. According to McGUFFIN, JANIE would spend 125.00 to 150.00 for refreshments for these parties and would contribute this amount. MC GUFFIN stated he attended one of these parties with his wife, which party was held on Waverly Place, next door to the Greenwich Villago Inn.

MC CUFFIN stated that while he was living with JiNIE, they operated the Sheridan Clam Bar, 95 Seventh Avenue, South Sheridan Square, New York City. He stated that this was a hangout for Communist Party members who were continually sponging free meals.

MC GUFFIN stated he separated from JANIE in April 1947 because she could not or would not give up Communism. He stated he returned to Missouri and instituted divorce proceedings, although he subsequently permitted JANIE to obtain the divorce. He returned to New York City, where he stayed from October to December, 1947. During this period he stayed with his former wife, however, MC GUFFIN claimed that they did not live as man and wife. MC GUFFIN stated that JANIE was still active with the Communist Party at that time. Since that time, MC GUFFIN has not seen JANIE; however, he did write to her while in jeil to inquire about their son, ROBERT PAUL MC GUFFIN, Jr., born October 17, 1941 in Fort Worth, Texas. MC GUFFIN received three or four

He stated that Leninism, Marxism and anti-capitalism were taught there, MC GUFFIN also advised that JANIE and their son regularly attend Camp Beacon Summer Camp located seventy-five miles up the Hudson River and operated by Communists.
