"The publicity that has been thrust upon them once more came from the action of the Department of Welfare.

"There is general acknowledgement that the children have been physically well taken care of; progressed well in school and in their social relationships, and were in a comfortable warm home.

"They have not been exploited by their guardians or the Committee. Every effort was made to protect the children's privacy and the children themselves were not involved in any fund raising. The children's pictures were publicly on the jacket of the book containing their parents' last letters. It was their parents' wish that this be done. MICHAEL ROSENBERG appealed in the last hours of his parents' lives to the White House for mercy for his parents. It was generally recognized that a ten year old had a right to do something on behalf of those he loved, and competent authorities agreed.

"The State Supreme Court ordered the children returned to the temporary custody of their grandmother, SOPHIE ROSENBERG, pending further hearings. The soundness of the family relationship is the basis of social work and child care planning. Mrs. SOPHIE ROSENBERG is their closest kin; she should not be denied her grandchildren.

"On April 5th Judge COLLINS will conduct hearings on guardianship. We are sure that many will want to write expressing their belief that the best interests of the children require that this be taken out of the courts and that Mrs. SOPHIE ROSENBERG's rights as grandmother be respected. "Dear Friend:

"The shameful attack against MICHAEL and ROBBIE ROSENBERG is part of the special 'Rosenberg Justice' that is being foisted upon our country. It is not enough that a mother and father were executed despite world-wide protests and dissents of three Supreme Court Justices. It is not enough that scientist MORTON SOBELL was sentenced to 30 years in Alcatraz on the word of an admitted perjurer, or that little MICHAEL and ROBBIE were hounded from their New Jersey school. Now, just when the children had found a happy home, a brazen attempt is made to continue the case against their executed parents by persecuting two innocent children."

"Publicly the attempt to tear the children from their grandmother and foster parents is being carried out by the New York City Welfare Department. But the filing of papers in Surrogate's Court by the Greenglass family through Mrs. TESSIE GREENGLASS, mother of DAVID GREENGLASS and ETHEL ROSENBERG, raises questions of what role the U.S. Attorney General's office is playing in this case."

"Mrs. GREENGLASS while not asking custody of the children, filed papers through the O. John Rogge law firm asking that the children be raised in a proper Jewish home. Such is the hypocritical request of the woman who committed Michael and Robbie to a public institution when their parents were in prison, and who since that time has never so much as visited them, sent them gifts, or shown any interest whatsoever in their well being."

"The danger of the Rosenberg children being taken from the custody of Mrs. ROSENBERG is great. The status of court action is as follows: Judge WILLIAM T. COLLINS of Surrogate's Court has arranged with the Children's Court to defer action and permit

"the Surrogate's Court to move on the appointment of a guardian and to attempt to seize control of the trust fund. The Welfare Department is pressing for the appointment of a guardian outside of the family. On March 18th the court will consider the Welfare Department's bid to move in on the trust fund which EMANUEL BLOCH raised for the children and which is under adequate and responsible protection now. On April 5th Judge COLLINS will conduct hearings on guardianship.

"This gives only a few precious weeks for nationwide public opinion to be expressed against the unprecedented effort to take the children away from their blood relatives and place them with strangers. In every community there are civic leaders, ministers, rabbis, trade unionists who will speak out if the facts are brought to them.

"The New York Times reports that Surrogate Judge COLLINS has asked the persons interested in the guardianship of the children write to him. We are sure that many will want to write expressing their belief that the best interests of the children require that this be taken out of the courts and that Mrs. SOPHIE ROSENBERG's rights as grandmother be respected. Letters should be sent to Hon. WILLIAM T. COLLINS, Surrogate Court, 31 Chambers Street, New York City. Communications should also be sent to Mayor ROBERT WAGNER, City Hall, New York City, insisting that the welfare Department cease its harrassment of the children.

"It will be to America's lasting shame if MICHAEL and ROBBIE ROSENBERG are not permitted to grow up free from public limelight, safe in the warmth of those who love them.

"ROBERT and MICHAEL were happy in their privacy before this latest outrageous invasion of their rights by a city agency. We must help them to restore this. The justice that was denied their parents must not be denied their Children!



Informant stated that the highlight of the above-mentioned affair was a speech by MARY SUE BELL, wife of MARION BELL, in which she described the work going on all over the country in her husband's behalf. The informant added that BOB AND TINTENSTRAKE and IRVING FISHBERG acted as masters of ceremony at the above-mentioned affair. Informant stated that part of the entertainment consisted of singing a number of songs, one of which was identified as "The Dedication of the Sabbath".

Informants T-13 and T-21:

Informants both advised on December 11, 1953 that they had observed a leaflet which in substance read as follows:

Arrange your baby sitting problem now, you are invited to a New Years Eve party, 10:00 p.m., to 1? on December 31, 1953. Northwest section - 4230 Chesapeake Street, N. W. Southeast section - Trenton Terrace (exact location later). For reservations or information call LENIE TELEBAK\* sponsored by the Rosenberg - Schell Committee of Washington, D. C.

Informant T-18:

On October 25, 1954, informant made available an invitation to a Mexican dinner to be held at 3431 10th Place, S. E., which dinner was to be sponsored by the NSCWDC.

Informant T-14:

On June 16, 1953, informant advised that a clemency rally was held in Washington, D. C. on June 14, 1953 which was sponsored by the National Committee to Secure Justice in

the Rosenberg Case. Informant advised that this rally was attended by some six-thousand delegates and that some of these delegates remained in Washington to participate in a twenty-four hour vigil awaiting the final word in the Supreme Court in connection with the ROSENBERG case.

The "Daily Worker", an East Coast daily Communist publication, in its edition of June 8, 1954, page 1, column 1, contained the following article:

"Reject New SOBELL Plea; Washington, June 7 -- The Supreme Court today rejected another appeal by MORTON SOBELL, framed up together with ETHEL and JULIUS ROSENBERG.

"SOBELL was sentenced to 30 years in prison although he was not even charged with committing any act of espionage but of 'conspiracy.' He is in Alcatraz Federal Prison.

"SOBELL's appeal showed there was no evidence to link him with any conspiracy and that even the dates the government charged 'conspiracy' were later than the dates of the alleged ROSENBERG 'espionage'."

**Informant T-27:**

On December 30, 1953, informant made available the following paper describing the organization of the National Committee to Secure Justice in the Rosenberg Case. Informant stated that it was his opinion that this paper had been in the possession of SYLVIA BERNSTEIN\*\*:

**"SUBJECT - NATIONAL ORGANIZATION"**

**"I: Structure"**

"1. The National Conference of Rosenberg-Sobell Committees establishes a National Organization to implement its program.

- "2. The name of the National Organization shall be 'National Organization of Rosenberg-Sobell Committees'.
- "3. The policy making body of the Organization shall be a National Committee of 49 members, 15 members residing in the Western region (to Colorado, inclusive), 15 members residing in the Mid-Western region (to Ohio, inclusive), and 15 members residing in the East. Election to the National Committee shall be in accordance with Paragraph 5 of the Representation and Voting Plan of the National Conference. Subsequent vacancies in the National Committee shall be filled by procedures worked out by the National Committee. The officers of the Organization shall be: a) 3 National Co-Chairmen, 1 from each region. They shall be elected in accordance with Paragraph 4 of the Representation and Voting Plan of the National Conference. Vacancies shall be filled by procedures worked out by the National Committee. The Co-Chairmen are automatically members of the National Committee. b) a National Director, elected in the same manner as the Co-Chairmen. The National Director is automatically elected to the National Committee.
- "4. Special Committees - The National Committee shall elect or appoint special Committees to further the aims of the Organization (legal, finance, research, other).
- "5. Rosenberg-Sobell Committees on community, city, state, professional, trade or regional levels will elect their own chairmen and officers.
- "6.

"Note: Nominees for any elective post at the Conference do not have to be present to be elected, but their consent to be nominated must be shown in writing or by another reasonable means.

## II: Method of Operation

- "1) All future policy matters are to be determined by the National Committee. Such decisions can be made by:
  - "a) a meeting of the National Committee, at which there are present at least five

\*members from each region, at a time and place set by the National Co-Chairmen. A majority vote of the members of each region shall be required for passage of motions. or

"b) a mail referendum, supervised by the National Co-Chairmen, of the entire National Committee, with a majority vote of the members of each region required for passage of a motion.

"2) In the intervals between National Committee meetings and referenda, the National Co-Chairmen and the National Director shall guide the organization, and shall set up methods of consultation and decision convenient to them.

"3) In the intervals between meetings and referenda of the above two bodies, the organization shall be guided by the fifteen National Committee members residing in the region in which the National Office is located. These fifteen members may elect a sub-committee to work with the National Director.

"4) Initiative in policy making can come from any of the above Committees or National Officers, and from any affiliated Committee on a community, city, state, professional, trade, or regional level. Such proposals shall be directed in writing to the National Committee, who will process such proposals according to such procedures as they deem workable.

"5) Duly arrived at policy decisions shall be for the guidance of all affiliated committees.

"6) A National Office shall be maintained to expedite the work of the organization.

"It is recommended that at this time the National Office be maintained in New York City to insure continuity in the work presently under way, to expedite legal conferences, and to give the National Committee an opportunity to make a change, if they desire to, under conditions which insure the smoothest possible transition."

### "ASK SENATE PROBE BROWNEll ACTIONS IN ROSENBERG CASE

"WASHINGTON, Dec. 8. -- A brief was filed at the weekend with the Senate Judiciary Committee requesting the committee to investigate the conduct of the U.S. Attorney General's office in the case of ETHEL and JULIUS ROSENBERG and MORTON SOBELL.

"A 35-page brief with documented charges against the Attorney General's office was presented to Sen. WILLIAM LANGER, chairman of the Judiciary Committee, by the National Committee to Secure Justice for MORTON SOBELL in the Rosenberg Case.

"The request for the investigation was presented by JOSEPH BRAININ of New York, who is co-chairman of the Committee with DANIEL G. MARSHALL, Los Angeles attorney.

"BRAININ after seeing LANGER, said the Senator had indicated his awareness of the gravity of the charges and had authorized him to state that the Senator said:

"I have received your petition and shall present your request to the full Senate Judiciary Committee at the earliest possible moment, probably in January. I shall not allow it to gather dust. I will insist on a "yes" or "no" answer."

"Seven charges were listed in the Bill of Particulars included in the brief. They were:

"1. The Attorney General's office knowingly used and encouraged perjured testimony against the ROSENBERGs and against MORTON SOBELL.

"2. The Attorney General's office promised rewards, and in fact did give such rewards, to several chief witnesses in the Rosenberg-Sobell case.

"3. The Attorney General's office deliberately engaged in an unlawful campaign of misrepresentation of facts through press releases prior to the trial and thus falsified essential aspects of the case influencing public opinion to prejudge the defendants.

"4. The Attorney General's office attempted and still attempts to keep from the courts documents that reveal the perjuries and the role the Attorney General's office played in obtaining these perjuries.

"5. The Attorney General's office engaged in the use of mental torture against the HOSENBERGS, and mental torture as well as physical violence against MORTON SOBELL.

"6. The Attorney General's office, by deception and misrepresentation, interfered with the courts' handling of the case.

"7. The Attorney General's office, by withholding information, by deception, and by outright falsehoods, misled two Presidents of the United States, who had before them appeals for clemency."

Informant in October, 1953 advised that the National Conference of subject organization was held on October 10-11, 1953 at 410 South Michigan Avenue, room 602, Chicago, Illinois, and that SYLVIA BERNSTEIN\*\* Washington, D. C., attended this conference.

Informant advised that at the October 11, 1953 session of this conference, SYLVIA BERNSTEIN\*\* was elected to the National Executive Committee to Secure Justice in the Rosenberg-Sobell Case.

On September 21, 1954, informant made available two letters on stationery with the letterhead "Committee to Secure Justice for MORTON SOBELL in the Rosenberg Case, 1050 Sixth Avenue, New York 18, New York." Informant advised that one of these letters, dated August 27, 1954, was submitted to SYLVIA BENSTEIN\*\* from TED JACOBS, of the national headquarters of subject organization, as follows:

"Dear Sylvia,

"Hope you had a nice vacation. This is just a reminder about the Eastern Seaboard meeting Sept. 11, 2 p.m. at the national office. Please advise us whether you will want sleeping accommodations. I thought I'd better send the reminder now, since I'm leaving this weekend on a vacation for one week.

"There's good news from California this morning. Love met yesterday with Mort in prison and I understand there is agreement on taking certain legal steps concerning the Alcatraz situation, but I haven't the details yet. There should be a statement from Love at any time on his entry into the case.

"I haven't heard from you yet on the draft pamphlet, and am anxious for your comments.

"Also, on the question of funds, which I discussed with Ethel and the others at our meeting, money is needed very urgently here, and it would be a tremendous help if you could, at the very latest, bring in a sizable portion of the money we talked about to the Sept. 11 meeting, although anything you can send before then will be a godsend.

"Looking forward to seeing you and others from Washington."

The other letter, made available by T-27 on September 21, 1954, has been previously set forth in this report.

Informant on October 5, 1954, made available a letter addressed to Mrs. SYLVIA BENSTEIN\*\*, 4230 Chesapeake Street, N.W., which letter was dated July 21, 1954, from TED JACOBS of the national headquarters of subject organization. This letter, on stationery with letterhead "Committee to Secure Justice for MORTON SOBELL in the Rosenberg Case, 1050 Sixth Avenue, New York 18, New York," is as follows:

\*Dear Sylvia,

"We have been discussing ways of getting a much fuller discussion on national policy and program on a periodic basis. We hope to accomplish this by more frequent Eastern Seaboard National Committee meetings.

"We are setting aside Saturday, Sept. 11, at 2 p.m., at the National Office for such a meeting. This is the earliest date we can select to allow for vacationing.

"If there is some reason that you, or someone from the Washington committee, cannot make it on that date, please let me know and we'll do some arranging. It goes without saying, that the presence of Washington is vital.

"Meanwhile, I hope to get to see you in Washington during the coming weeks to see how things are going and give whatever help I can. We will have some very important developments in the near future, and we believe when a public announcement is made, work will be given a shot in the arm. I'm referring to the pending official entry of Steve Love as attorney in the Sobell case. Meanwhile, we are working on obtaining statements from leading figures on the question of Alcatraz, statements which we'll be able to use in going to other people to get them to join in a demand for Sobell's removal.

"Please let me know about the meeting as soon as possible. By way of explanation, we have done some reorganizing here. Norma is occupying herself mainly with New York activity, and I'm concerning myself with the national program.

"In a few days, you'll receive a copy of the national budget being drawn up for the months of August, Sept., and October.

"Best regards to everyone from all here."

Informant on January 12, 1955, made available information revealing that SYLVIA BERNSTEIN\*\*, 4230 Chesapeake Street, N.W., had received three communications from Room 2, 1050 Sixth Avenue, New York 18, New York, which communications were postmarked October 20, 1954; November 29, 1954, and December 30, 1954, at New York.

CHICAGO, Feb. 11—Distinguished persons from many countries in science,  
education, labor, law, religion and the arts—including Robert M. Hutchins,  
American educator, and Arnold Toynbee, British historian—are among those  
who have signed scrolls of tribute to Dr. Harold C. Urey, Nobel Prize  
winner, for his achievements as a scientist and contributions as a citizen.

A bound volume of individual scrolls will be presented to Dr. Urey  
at a testimonial dinner in his honor on Saturday, Feb. 12th, 7 p.m. at  
the Hotel Hamilton. The dinner, which is expected to be attended by more  
than 400 persons, is under the auspices of the Chicago Sobell Committee.  
After the presentation of the scrolls, Dr. Urey will address the gathering.  
Guest speakers will be Carey McWilliams, author and editor, and Prof. Harry  
Kalven of the University of Chicago. Stephen Love, Chicago attorney, will  
be dinner chairman.

TEXT OF ADDRESS BY DR. HAROLD C. UREY, PREPARED FOR DELIVERY ON  
FEBRUARY 12, 1955  
AT THE DR. UREY TESTIMONIAL DINNER, HOTEL HAMILTON, CHICAGO, ILL.

Naturally I am pleased that so very many good people have been fit to honor me this evening. Also, I am pleased that Mrs. Sobell should present this scroll to me and thank her for her very kind words. But in a certain way the honor is of minor importance to me, certainly very minor as compared to other things associated with the activities of this evening.

As I am sure you all know, this occasion was organized from the beginning by people who believe, with me, that the Rosenberg - Sobell trial was not in the best tradition of American justice. I hope my friends who signed this scroll understood this.

I have not been personally acquainted with either the Rosenbergs or the Sobells. I am not unmindful of the terrible tragedies that have come to their lives and am very sorry about these matters, but my concern with this trial has stemmed more from a belief that the integrity of Justice, as it is administered in the U.S., is at stake. If proper trials cannot be secured for unpopular people -- and it is evident from the publicity of this trial that all those charged with crimes were unpopular -- then it will become impossible to secure justice for other somewhat less unpopular people and so on until no justice is possible at all.

The power of our government is very great and it can afford to be just because of that great power. But there is an illness in this country since the war from which we will surely recover in time. This illness arises from a sense of insecurity and this sense of insecurity is due to the loss of our natural security barriers, namely: the Atlantic and Pacific Oceans. Our danger from foreign foes is now greater than it has ever been before in our history. This danger comes from the long range effectiveness of the aeroplane, as a carrier of powerful military weapons and to the existence in the world of a powerful revolutionary country, whose rulers do not accept the fundamental concepts of our way of life. There is a life and death struggle going on between these ways of life and I am convinced that each group is really determined to eventually destroy the other. I am in favor, as we all are, of the preservation of our way of life and I am sure that we will win in the long run and hope that the war stays cold.

This concern with our basic security as a country has led many people, often in high places, to look for a scape goat, that is, an easy way to solve our difficulties. That scape goat has been spies, espionage agents, subversives in government. I do not condone such agents, but if all communists and all communist sympathizers should quietly die, the fundamental insecurity of this country would be the same as it is now. This very well justified concern for our security in a modern, dangerous world has led us to do things which will undermine our way of life, our form of government; our freedoms. This is my primary concern in this matter. I welcome this dinner and this scroll as a means of fighting one angle of hysteria, one bad case of injustice, as I view it.

There are many things of this kind, such as: the Oppenheimer hearings, Condon's clearance problems, the Lattimer case, passport problems, visa problems, etc. If I do not do anything about some of these things it is because of lack of energy to do so or because many other people have protested them. Perhaps the most disturbing feature of many of these procedures is the increased use of the professional informer by the Department of Justice and Congressional Committees. Recently one of these informers, Mr. Mattusow, has stated that he has given false testimony and has accused Mr. Roy M. Cohen of complicity, which Mr. Cohen has denied. This specific accusation reminds one that Mr. Cohen was assistant prosecuting attorney in the Rosenberg - Sobell case. However, I warn you all that, in my opinion, communists, reformed communists and reformed reformed communists are not particularly reliable. I do not believe that they are reliable when they accuse Mr. Cohen nor when they accuse Mr. Lattimore nor when they accuse

Mr. Sobell. Yet I am of the opinion, after study of the record, that Mr. Cohen's side of this story is incorrect and that Mr. Sobell was not properly tried and that the verdict and sentence were not justified.

One cannot separate the discussion of Mr. Sobell from a consideration of the Rosenberg case. In fact, one finds it difficult to understand what the evidence was against Mr. Sobell -- for it was certainly far less important than that against the Rosenbergs. In fact, the great concern about the latter generally obscured the interests of Sobell. I wish to give you a brief outline of the case for I'm sure many of you are not acquainted with the case and its general structure. Being a scientist, I have made a diagram of the case which enables me to understand the relationships.

The alleged conspiracy is represented by the diagram (Fig. 1). In this diagram an arrow pointing from individual A to individual B means that A testified that he had contact on espionage matters with B. No such arrow means that the individual denies such contact or there is no testimony. A broken line means assumed contact but no evidence or only indirect evidence. Gold admitted that he gave information to Yakovlev, but Yakovlev escaped from the U.S. and was not apprehended. Gold and Fuchs both admit contact. The Greenglasses admit that they gave information to Gold and that they received \$500 from Gold which he said he received from Yakovlev. The money was accounted for in the Greenglass' bank account. They agreed that they matched the pieces of the gelatin box top. Gold said he received his half from Yakovlev. The Greenglass portion was in Mrs. Greenglass' hand bag. They say that they received this from Rosenberg and that the division of the gelatin box top occurred in the Rosenberg apartment. The guilt of the Greenglasses and Gold was agreed to by all three. The Rosenbergs denied dividing the gelatin box lid or giving it to the Greenglasses.

The Greenglasses say that they gave information to the Rosenbergs and that they were recruited into espionage by the Rosenbergs. The Rosenbergs denied this, and denied that they had anything to do with espionage of any kind. They maintained that their contacts were the normal relations of in-laws. (Mrs. Rosenberg was David Greenglass' sister.) Elitcher and Sobell were college acquaintances of Rosenberg. Elitcher testified that he and Rosenberg discussed espionage several times, although he maintained that he and Rosenberg never gave each other any secret information. Elitcher had been a communist; he had sworn in connection with his employment on war work that he was not, and thus had committed perjury. He testified that this was so and that he hoped for clemency as he testified against Rosenberg. He has not been indicted. Elitcher testified that he drove from Washington to the home of Sobell in 1948 and that he thought he was being followed by F.B.I. agents. He says that when he reached Sobell's home, Sobell was much disturbed by his arrival with F.B.I. agents on his trail, and that thereupon the two took a can, presumably containing photographic film, to the neighborhood of Rosenberg's home. Elitcher said that he waited in the car while Sobell delivered it. This is the only evidence of an overt act on the part of Sobell introduced at the trial. Sobell did not take the stand in his own defense. Hence a broken line in the diagram.

The Rosenbergs denied all espionage contacts with Elitcher and Sobell.

No evidence was introduced to prove contact between Yakovlev and the Rosenbergs. Gold's testimony established no contact between him and the Rosenbergs. Greenglass testified that Rosenberg tried to get him to go to college to study atomic physics in order to be more valuable as an espionage agent, and the Government inferred that Julius Rosenberg was the center of an important spy ring. No evidence, beyond that mentioned above, was introduced in support of this.

The Rosenbergs denied all accusations but refused to answer questions relative to membership in the Communist Party. They did admit to a very leftist political point of view. They never, at any time, admitted any traitorous act. Many people with whom I have discussed this case do not know this, and I, therefore, emphasize it. Had they made any such admission, I would have never spoken one word in regard to the case.

In general, it is easy to deny accusations, but it is difficult to make false accusations without inconsistencies appearing in the testimony, and for this reason it is important to consider the details of the testimony against the Rosenbergs in order to judge its

reliability, and it is important to consider motives and opportunity for wrongly accusing the Rosenbergs. Also, if one assumes that the evidence against the Rosenbergs was perjured, it is necessary to be able to account for the essential facts by some other set of contacts. I believe that the essential evidence for the conviction of the Rosenbergs was that given by David and Ruth Greenglass, that their testimony contains unbelievable statements, that the plausibilities of certain details of their testimony can be explained, that they had powerful motives for involving the Rosenbergs unjustly, and, finally, that all the facts of the atomic espionage can be accounted for without the involvement of the Rosenbergs at all.

Elitcher testified to several conversations with Sobell in which espionage was discussed, but that no information ever passed between them. Do espionage agents constantly discuss their activities with old college friends without getting any information? This seems most improbable. The tale that Elitcher, who had never engaged in espionage, told of accompanying Sobell on an espionage errand when he believed F.B.I. agents were following him seems to me to be completely fantastic. Why choose to do this right under the eyes of the F.B.I.?

The bitterness that the case has aroused and the sentence imposed on the Rosenbergs and on Sobell was justified by Judge Kaufman on the basis of atomic espionage and yet no evidence was given connecting Sobell with this activity at all. In fact, no evidence was given except that relating to the transfer of a can containing 35 mm. film, and that by a confessed perjurer hoping for leniency.

Sobell was convicted and sentenced on the basis that he was part of a conspiracy and hence was guilty of many things which he personally did not do. Judge Jerome Frank stated that he should have been tried on a separate conspiracy. Judge Kaufman stated to the jury that they could not find Sobell guilty unless they believed Elitcher. I find Elitcher's testimony very doubtful -- in fact, I find it most unconvincing. We should note that no court passed on the credibility of the testimony of any witness, due to the fact that higher Federal Courts do not review this question. The Supreme Court of the U.S. has refused to accept jurisdiction and this does not constitute a review of the case.

However, to return to the general case, we need to recognize that some espionage was performed. Fig. 2 shows an alternative diagram of the case. This differs from the first case only in the shifting of the arrow from the Greenglasses to the Rosenbergs to an arrow from the Greenglasses to Yakovlev. A contact to another agent of the U.S.S.R. would serve as well.

If the Greenglasses had direct contact with Yakovlev or other Russian agents all the requirements of the other testimony are met. A gelatin box lid was divided. Gold presented one half at Albuquerque which he said he got from Yakovlev. The Greenglasses had the other half which they said they received from Rosenberg. On this basis Rosenberg gave the other half to Yakovlev and he in turn gave it to Gold. But, suppose Yakovlev divided the lid and gave one half to Gold and the other to Greenglass or to Mrs. Greenglass. In this case Rosenberg was unnecessary. Also, the Greenglasses can tell a very realistic tale of the division by substituting the Rosenbergs for Yakovlev. In fact, the inclusion of the Rosenbergs in the conspiracy makes no sense at all. They are unnecessary unless Julius was, indeed, the head of a big espionage ring, and the proof of the existence of that ring is non-existent up to the present time. If only the Rosenbergs had confessed! But we are reasoning in circles. The Rosenbergs were unnecessary to the plot and would have been only another point where the entire espionage effort could have been discovered.

If Yakovlev, or another Russian, could contact the Rosenbergs, why could he not contact the Greenglasses, and then why pass \$500 through the Rosenbergs' hands instead of giving it to the Greenglasses directly? Would you confess to being the head of a non-existent spy ring and let your children live under that stigma, or would you go to the electric chair maintaining your innocence? The letters of the Rosenbergs written to each other in Sing Sing prison give their answer to exactly this question.

Note where this diagram leaves the Rosenbergs and Sobell. Both are completely out of the atomic espionage ring and now we ask what did they do? Even the confessed perjurer's testimony, except for the one overt act, only states that they talked espionage without ever

doing any. Well, one should not talk espionage and if they had been given five years at Lewisburg, we might think justice had been done -- that is, if you believe the testimony. I do not believe the testimony.

On such a basis, two people have been executed and one is in prison for 30 years on Alcatraz. And where are the surely guilty ones? One, David Greenglass, is in Lewisburg for 15 years. Two others, Ruth Greenglass and Max Elitcher, have never been indicted and tried.

Would it not be a wonderful trick for the communists if they could get innocent people sent to the electric chair and imprisoned for 30 years and get guilty ones set free or given moderate sentences? This is exactly what I think has occurred. This is one point to which the current hysteria has carried us.

#### MOTIVES

Elitcher had committed perjury and at the time of his testimony had not been indicted, tried and sentenced. He has not been so indicted or tried since. Had he been sentenced, no matter to what term, at the time of his testimony he would still have been anything but a reliable witness. I do not trust communists nor ex-communists nor perjurers, and I am sure that this view is shared by many others. But when pressure is put on such people, I trust them to do whatever they think necessary to get themselves out of their difficulties, especially when wives and children are involved. Surely Elitcher was tempted to give the testimony that the government wished to have.

The Greenglasses have admitted to a crime for which the maximum penalty is death. It is a custom in the United States to give consideration in sentencing a criminal to the degree of co-operation which he has given to the law enforcement authorities during the preparation and prosecution of the case. I suppose that criminals are advised of this situation by their attorneys or in other ways. At the time of the trial, David Greenglass had been indicted and was on trial but had not been sentenced, and the sentence could have been death. Ruth Greenglass has never been indicted and she was not a defendant in the trial. David Greenglass was given a 15 year prison sentence. It seems to me that the hope of lenient treatment must have constituted a motive for cooperation with the prosecution.

But "cooperation" is not synonymous with perjury and accusation against innocent people. Or is it? Does it not depend on what the facts are? If the Greenglasses' contact was Yakovlev and not the Rosenbergs (see Fig. 2), the revelation of this fact would have given the government nothing since Yakovlev was in Russia. What takes place in a criminal's mind when he is trapped and the electric chair appears in his dreams? I do not know, but it seems likely to me that both the Greenglasses would have confidently expected 30 year prison terms if they had admitted that their contact was with Yakovlev or some other agent of the U.S.S.R.

People ask why the prosecuting attorney and the F.B.I. and the judge should wish to see two insignificant people put to death unjustly. After considerable conversation with lawyers on this subject, including one who worked on the government side of the case, I conclude that lawyers are more interested in the law than in justice. Mostly they are interested in whether all the legal machinery functions according to all the rules, and are not in the least interested in the argument presented in this paper. There are exceptions, of course, as for example Professor Stephen Love and Professor Sharp, who helped the defense during the last weeks of the case without remuneration once he believed that a serious miscarriage of justice had occurred. However, it is my belief that the prosecution believed the Rosenbergs guilty. Once having believed the Greenglass account and having based the prosecution on this it would be difficult to adopt another point of view later. In fact, people do not allow themselves to be convinced that they have made such a horrible mistake as I believe has occurred. Once the government adopted this theory of the case, all concerned with it were trapped and were forced to continue to believe it.

#### CONCLUSION

I cannot review in a talk of this kind all the details of this case. This is better done by lawyers anyway. I commend to you Professor Love's statement on the case and Professor Sharp's book on the subject. But also a word in my own defense in preparing to say anything about the case. We have public trials in this country. The purpose of this surely is not to provide a Brown holiday, a substitute for a real trial, but this is done so that each of us can

Judge the conduct of the trial. This means that you and I have the right to criticize the court, the jury, the prosecution, the defense, everything about it. In criticizing this case, I am exercising certain rights that were mine at birth and I wish to keep them until death. We all of us have the right to form an opinion in regard to these matters and mine is adverse in regard to this case.

I also wish to make a statement in regard to a remark that has come to me from a number of scientists. They say essentially, "Well, if you only knew what I know," or rather mostly, "If you only knew what someone I know knows about the case!" The inference always is that much secret information exists that proves everything but for security reasons, it cannot be made public. My answer to that is that I do not believe this inference and I do not believe people should be executed and imprisoned on secret evidence. I have discussed this question with a man, who saw some of the secret data at least. He says that Greenless' paper looked to be genuine and that it contained valuable information. I have accepted this in fact, but does a paper tell you to whom the paper was given? My reply to these insinuations has been just as I have said above. There has been no answer to them. Before I accept these statements they must be told publicly so that we all can judge them.

I have been interested in this case and shall be interested in other similar cases because of my concern for the integrity of justice in this country. It is better to review a case in which we believe injustice has been done than to wait for the next one, when further injustice may occur. Will you not all try to do something about this series of doubtful trials or quasi judicial procedures that threaten our security as individuals living in a great free country?

I thank you all again for this dinner and scroll.




"This was a social and everyone sat in groups and talked. The main topic was the yellow pamphlets passed out in the schools recently ESCAPE FROM THE H\*BOMB - this according to the majority of Communist opinion is a lot of nonsense—an attempt to cause hysteria.

"When the affair was about over Clara Mae Perkins gave a speech about the injustice and frame-up of Morton Sobell. She said that Helen Sobell had gone to California with one of her children and the child was not permitted to see his father. She called Bennett Director of Prisons, in Washington and he told her to stop bothering him and he supposedly told her that all of this agitation was causing too much trouble. And, according to the story she is not prohibited from visiting her husband. This, of course, proves that the public has become alerted in the case of Sobell and the Government is worried about the publicity.

"Clara Mae then stated that the whole stool-pidgeon frame up is becoming very plan to the people since Matusow has admitted lying. She noted that Roy Cohn who helped convict the Rosenbergs is the one mentioned by Matosow as helping him frame the lies. She then stated that if one paid informer is a liar it is logical to assume that others were too and the whole affair of Communists trials and the Rosenbergs is a frame-up.

"Charlie Cox asked just why the movement to get Sobell out of Alactraz. The answer was a very sob-story one-He cannot see his wife except thru a thick glass; he must talk to her thru a telephone; his children cannot see him. Haven Perkins added his opinion; Morton Sobell is a scholar and is placed in a prison where there is the lowest and most vicious criminals. He belongs in a better prison. Clara Mae then told how the FBI have visited Mr. Sobell four times lately in an

attempt to make him confess. - The FBI want to ease their mind about the elocution of the Rosenbergs and if Sobell would confess this would clear the record.

"Brockman Schumacher took the floor. He gave a short talk against the laws that are causing this injustice—the Taft-Hartley, the McCarran Walter Act, the Smith Act. He mentioned that the Manewitzes are victims of the McCarran Act. He then asked all to sign a petition that he had. It was a four page letter (printed) that a group sent to Attorney General Brownell, asking that the use of paid informers be discontinued. The name of the outfit is INITIATORS TO SECURE JUSTICE or to fight injustice. Brockman Schumacher said that the organization has a number of names.

"Clara Mae Perkins remarked that now that the Post Dispatch has come out against the stool pigeon maybe something will be done about it. Brockman said that there would be no convictions without the array of stool pigeons used by the FBI.

"Clara Mae then touched briefly on the Claude Lightfoot case—the first of its kind under the Smith Act. John Abt was the attorney for the defendant. He has reported that many lawyers who were watching the trial shook his hand and told him what a dirty frame-up the whole case is. This shows how public opinion is changing in these frame-up trials that convict people for thinking.

According to the informant, the individuals formerly associated with the Committee in Miami are afraid to attend any meeting because of the current investigation being conducted in Miami by State's Attorney GEORGE BRAUTIGAM.

The State's Attorney in Miami and the Dade County Grand Jury are investigating Communist activities in the Miami area. To date some 180 persons have been subpoenaed to testify regarding Communist activities.

As a result of this local investigation some individuals have fled from Florida and now reside in other states. Some 8 former members of the Miami Chapter of the ROSENBERG COMMITTEE have fled and have been found to reside in far distant states.

On February 18, 1955, T-1 stated he believes subject organization is now a dead issue in Miami. He said he has received no literature concerning this organization since April, 1954, and there has been no meeting since August, 1954.

FRANTJIS, did not come within the provisions of the Solicitations for Charity Act; the appeal from the conviction and sentence in the Magistrate's Court was sustained; the conviction was reversed and the defendant was discharged. The Newsletter states that this is a very important victory, and "so it is with the SOBELL case. We can transfer MORTON SOBELL from Alcatraz. We can secure a fair trial for him. We can win justice. But to win, we must do more than we are doing now. We must give not only our moral support, but financial support as well."

This Newsletter states that the HAROLD C. UREY Testimonial Dinner scheduled for 2/12/55 in Chicago praised Dr. UREY for his concern in the MORTON SOBELL case. It states that distinguished men who are joining to pay tribute are scientist Dr. PERCY JULIAN, CAREY McWILLIAMS, Editor of the Nation, STEPHEN LOVE, and others.

Dear Friends:

On Wednesday, May 11th, John Wexley, author of The Judgment of Ethel and Julius Rosenberg, will begin a tour of the country at your behest. His tour is of immense importance to us, for not only does it create new possibilities for publicizing and distributing his magnificent analysis of the case, it affords every group and committee an opportunity to draw new people around it.

Pre-publication copies of this book will be available to you, as well as a promotional piece on the book that we are now preparing. In addition, we plan to have a representative of the National Office visit your city several weeks before Mr. Wexley's arrival, to help in planning your activities during this period.

Meanwhile, I wish to propose the following steps:

1) The date or dates on which Mr. Wexley will be in your city is on the enclosed tour schedule. You can see that it is a tight schedule, made so by the necessity for covering many cities within a relatively short space of time. If for any reason it is utterly impossible or undesirable to have Mr. Wexley on the dates specified, please let us know at once, so that an attempt to meet your needs may be made, although it will be very difficult to make basic changes. In any case, it is imperative that you confirm the date within a week of receiving this letter.

2) A number of activities involving Mr. Wexley suggest themselves at once. Public meetings take first place in our consideration. These should be built around the activities of the memorial period as well as around Mr. Wexley and the book. Secondly, large private gatherings of 50 or more persons. These may take the form of meetings, receptions, luncheons, or other affairs.

3) Publicity around Wexley's visit to your city should be used to the utmost. Newspaper ads and press releases and ads in other periodicals, Anglo-Jewish papers, campus weeklies, neighborhood papers, church organization bulletins, etc., are obvious first steps.

Letters to newspapers, requests for review of the book, bookstore displays and posters, press conferences, contact with various book discussion groups such as Sunday Men's Clubs and others, notices to libraries, and other means also suggest themselves.

4) In many cities it is possible to arrange that Mr. Wexley speak at special or regular meetings of other groups, such as some of those mentioned before, and ACLU, Friends Service, etc.

- 5) Many cities have "Traveler Program", on radio or TV, in which visitors to those cities are interviewed. It should be possible to arrange for such interviews for Mr. Wexley, as well as possible interviews on local news commentary, or other programs.
- 6) There are very great possibilities on the campuses for book meetings around Mr. Wexley, newspaper interviews, faculty group discussions, etc. In this, as well as the other suggestions, time is important, and it is one of the reasons that we have taken pains to give you adequate advance notice. Incidentally, many colleges have Mr. Wexley's play "The Last Mile" on their required reading list for English and literature courses.
- 7) Copies of Mr. Wexley's book should be presented to your local libraries, college libraries, and other institutions that maintain libraries.
- 8) At the meetings organized by your Committees, and elsewhere when possible, arrangements should be made for some capable person to speak on the meaning of the book and the case, and to urge the audience to purchase the book. Our aim is not simply one book per person, but two or more, so that copies may be sent to all the Congressmen and Senators of your area, as well as to other persons who should read it. In addition, a very great effort should be made to secure advance sales. (At a number of meetings at which Mr. Wexley has already spoken, as much as twice as many books as there were members of the audience were sold.)
- 9) Very shortly we will send you the promotional piece on the book, which will also contain a biographical sketch of Mr. Wexley. This will help in mailings and other activities.
- 10) As you study the tour schedule you will see that this trip, in fares alone, will be quite costly. These expenses can only be justified if the potential of the tour is realized. We are not in a position at this time to provide the money for this tour. We ask, therefore, that every city undertake to share part of the expenses. Check with your airline the cost of transportation between your city and the city from which Mr. Wexley will be arriving. Add to that as much as you can to cover hotel and food costs, and send it to us by May 1st, so that we will be able to expedite the arrangements in a satisfactory manner.
- 11) Please make a hotel reservation for Mr. Wexley for the date of his arrival. Because of the arduous rigors of such a trip, we know you will appreciate the need for restful accommodations, even if they cost a few dollars more than we ordinarily spend.
- 12) The book will sell for approximately \$4.50. The final price will be known within 10 days or so. We are currently negotiating with the publishers for a large discount. This, in turn, depends very much on the number of books we can realistically order. By giving this matter much thought, and my letting us know soon how many copies you wish to order, you will help us considerably. Likewise, if money for a portion of these books is sent to us, we shall be in a better position to satisfy your requirements.

Finally, I want to add that Mr. Wexley has spent three years of intensive work on his book. Those of us who have read it believe that it was time well spent as it is probably up to a standard of make of this long carefully documented and brilliantly written book is major instrument in the campaign "No in freedom or Morton Sobell."

The title of this case has been changed to reflect the new names of the National and Los Angeles Committees: National Committee to Secure Justice for MORTON SOBELL in the ROSENBERG Case; Los Angeles Committee to Secure Justice for MORTON SOBELL.

For purposes of brevity, the Los Angeles Committee to Secure Justice in the ROSENBERG Case will be referred to as LACSJRC, the Los Angeles ROSENBERG-SOBELL Committee will be referred to as the LARSC, the Los Angeles County Communist Party will be referred to as the LACCP, and the Communist Party as the CP.

Unless otherwise indicated, the informants herein designated by "T" symbols have furnished reliable information in the past.

I. ORIGIN, SCOPE, AND ACTIVITIES

ORIGIN

On March 22, 1955, [REDACTED] orally advised that the Los Angeles Committee to Secure Justice for MORTON SOBELL, which was formerly known as the Los Angeles Committee to Secure Justice in the ROSENBERG Case, and was sometimes referred to as the Los Angeles ROSENBERG-SOBELL Committee, adopted the name Los Angeles Committee to Secure Justice for MORTON SOBELL about August, 1954. The avowed purpose of this Committee is to have MORTON SOBELL transferred from Alcatraz Prison, to secure him a new trial, and to eventually secure his complete release.

Both the Los Angeles Committee to Secure Justice in the ROSENBERG Case and the Los Angeles Committee to Secure Justice for MORTON SOBELL were, from their inception, dominated and controlled by the LACCP [REDACTED] b7D

[REDACTED] In March, 1955, critical discussion by CP members was that the Los Angeles Committee to Secure Justice for MORTON SOBELL should be reactivated and revitalized in a more aggressive way than it was in the past and that its activities should be expanded in terms of securing maximum mobilization of forces to secure SOBELL's transfer from Alcatraz Prison and a new trial for him.

There is an active youth committee organized by forces from the Labor Youth League working on the SOBELL issue, which is known as the Youth Committee for MORTON SOBELL or slight variations thereof, and which is sponsored by the Parent Committee.

The Labor Youth League has been designated by the United States Attorney General pursuant to Executive Order No. 10450.

In August, 1954, the informant furnished a four-page mimeographed leaflet captioned, "Excerpts From Statements By Individuals and Organizations Abroad On The Case Of MORTON SOBELL." The pamphlet bears a sub-caption, "Selected From Letters To Mrs. SCBELL."

The Civil Rights Congress has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The Jewish People's Fraternal Order has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

ACTIVITIES

[REDACTED] indicated a "backslide" in interest and support in the Los Angeles, Hollywood and Beverly Hills areas. It was announced that petitions requesting SOBELL's transfer "to a lesser security prison" were to be circulated door to door. [REDACTED]

According to the informant many of those present claimed they had been in areas where doors had been "slammed" in their faces, where they were pushed downstairs, threatened by the police and the

Sheriff's Office. These persons said, however, that they would not give up.

A meeting of the youth group of the LARSC was held at Park Manor, 607 South Western Avenue, on September 16, 1954. DAN MARSHALL chaired this meeting; ERNIE LIEBERMAN furnished the entertainment. The principal speakers were Reverend STEPHEN FRITCHMAN, CHARLOTTA BASS and HELEN SOBELL.

According to the 1948 Report of the Un-American Activities Committee to the Regular 1948 California Legislature, DAN MARSHALL was President of the National Lawyers Guild in 1948. The National Lawyers Guild was described by LOUIS F. BUDENZ, former Editor of the "Daily Worker" as the legal arm of the CP.

According to T-5, ERNIE LIEBERMAN was considered for a confidential assignment by the LACCP in 1953.

Reverend STEPHEN FRITCHMAN was formerly a member of the CP in Boston, Massachusetts, according to LOUIS F. BUDENZ, former Managing Editor of the "Daily Worker," an East Coast Communist newspaper.

CHARLOTTA BASS was often mentioned as a CP member prior to 1945 and possibly attended the 1942 National CP Convention, according to LOUIS F. BUDENZ.

At a meeting of the Los Angeles SOBELL Committee at Park Manor on September 16, 1954, DAN MARSHALL stated, "We shall continue to fight for MORTON SOBELL until we have achieved his transfer from Alcatraz, and then his freedom."

"Assignments have been taken to get out a new fact sheet each week based on different aspects of the case. A piece is being developed on the credibility of ELITCHER's testimony. With the cooperation of

San Francisco we are working on a project in which slides of all material on the case, to be used with a projector and a running commentary will be available very soon to all areas.

"Each area will assume responsibility of weekly mobilizations at concentration points in a given area. Doorbell ringing in residential areas...plant gates...shopping centers...organizations and public affairs.

"Organizations to be contacted to send representatives to the Steering Committee.

"Two months that HELEN will be here must be utilized to the fullest. Every area, responsible persons and contact should make it a point to see that HELEN is booked in their community.

"That finances are our major problems needs no underlining. The National Committee and the Local Committees are badly in need of funds. Legal expenses and literature are a must and are expensive."
