

Re Rome letter dated 3-6-62.

Referenced Rome letter sets forth information concerning a letter forwarded to the American Embassy in Rome by the Unione Donne Italiane, a communist organization petitioning for the release of MORTON SOBELL. Since the date of referenced letter, two additional communications have been received at the Embassy from the Unione Donne Italiane, one addressed to Mrs. JACQUELINE KENNEDY, dated March 10, 1962, and another addressed to Ambassador G. FREDERICK REINHARDT, dated March 10, 1962, both in the same vein and both petitioning for the release of MORTON SOBELL.

The letters are indications of a propaganda campaign put into motion as a result of the visit to Italy by HELEN SOBELL, wife of MORTON SOBELL. Any significant developments in this connection which come to the attention of the Rome office will be reported. No further action is being taken.

Minister Punished For Saying Prayer For
Morton Sobell's Liberation

Bonne, North Carolina. - Minister David Andrews, who, last December, kneeled on the steps of the White House in an appeal to the President for clemency for Morton Sobell, was "freed of his responsibilities" as director of the Wesleyan Foundation in the "Appalachian State Teachers College" last week.

The directors of the "Foundation" voted twelve to one to fire the Minister from his position for praying that the President should pardon Morton Sobell, who was sentenced to 30 years in jail on the basis of false accusations.

The above was translated from the Yiddish and is being submitted for your information.

The taking of minutes at these meetings has been discontinued, and generally speaking, the meetings have turned into social gatherings.

CAROLINE CANAFAX is a member of the White Center Communist Party Club, Seattle, during March, 1952, according to SE T-2 in March, 1962.

II. LOCATION

On October 31, 1961, the Seattle "Post Intelligencer", a Seattle daily newspaper, forwarded a letter dated October 27, 1961, to the Seattle FBI Office. This letter was received by the newspaper from the Seattle Committee to Secure Justice for Morton Sobell and bore the address 317 Second and Cherry Building.

The current Seattle City Directory shows the occupant for 317 Second and Cherry Building as SARAH M. LESSER.

SARAH LESSER represented several of the Pacific Northwest Communist Party leaders, who were tried for violation of the Smith Act in Seattle during 1953.

This source advised that the Seattle Sobell Committee has used the address of 317 Second and Cherry Building for mailing purposes only inasmuch as SARAH LESSER is sympathetic with the aims of this organization. According to the source, the Seattle Committee has no formal address.

"Dear Sir:

"We strongly object to the vicious attack by JACK LOTTO on the Committee to Secure Justice for Morton Sobell and all the others who are concerned with the Sobell case printed in your paper October 16th. Thousands of people, many of them notable ministers, scientists and lawyers, after investigation have publically expressed their belief that the conviction of MORTON SOBELL was a miscarriage of justice.

"Many fair-minded persons have searched the transcript of the trial in vain to find just what defendant SOBELL was accused of doing and what the jury found him guilty of.

"Let's hope as long as there remains a possibility that an innocent man is in prison there is still room for people of conscience who are concerned that justice be done. We and many others are convinced that since SOBELL has already served 11 years of a 30 year sentence that his sentence should be immediately commuted and he be returned to his family. We urge letters to President KENNEDY urging commutation.

COMMITTEE TO SECURE JUSTICE FOR MORTON SOBELL

"Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL,' the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg Case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and 'then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case'..."

("Guide to Subversive Organizations and Publications" dated January 2, 1957, issued by the House Committee on Un-American Activities, page 60.)

In September, 1954, the name "National Committee to Secure Justice for Morton Sobell" appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell," first appeared on literature issued by the Committee.

The 1960-1961 Borough of Manhattan telephone directory lists the Committee to Secure Justice for Morton Sobell as being located at 940 Broadway, New York, New York.

A source advised that the Seattle Sobell Committee was formed during April, 1959, by an organizer of the Sobell Committee from Los Angeles. JODY HEATLIE, a member of the Socialist Workers Party in Seattle, was named Chairman, and CAROLINE CANAFAX was named Secretary.

The Socialist Workers Party and the Communist Party have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

A second source advised that CAROLINE CANAFAX was a member of the Communist Party in April, 1961, in Seattle.

A third source advised that the Seattle Sobell Committee met at Seattle on January 10, 1961.

This same source advised that this Committee's purpose since its inception has been to raise funds and obtain public support for the release of MORTON SOBELL from prison.

APPENDIX

SOCIALIST WORKERS PARTY - SEATTLE BRANCH

In May, 1941, a source advised that during the month of May, 1941 the Seattle Branch of the Socialist Workers Party (SWP) was reorganized and received official recognition as a branch of the Party from the national office of the SWP in New York, New York.

On April 20, 1961, another source advised that the Seattle Branch, SWP, with headquarters at 1412 - 18th Avenue, Seattle, Washington, is a present active affiliate of the National SWP, following the aims and principles of the National SWP. According to the source, membership in the Seattle branch includes RICHARD FRASER, who is a member of the SWP National Committee, and his wife, CLARA FRASER, who is an alternate member of the SWP National Committee.

one of the most careful and thorough reviews in American history; that SOBELL's defense counsel thanked Judge KAUFMAN for fair treatment, etc.

During the course of his interview with HELEN SOBELL, [redacted] asked her if she or her husband were, or are now Communists. She replied "We are not." b7D

He also asked her if there are any Communists working in her group today. She replied that she had no way of knowing, but "I think not." She characterized her supporters as people "who represent the finest traditions in America."

[redacted] pointed out to SOBELL that it has been stressed in both government and nongovernment publications that her husband received an extremely fair trial, and that the defense attorneys for him had commended Judge KAUFMAN at the end of the trial for his fairness. She denied this. b7D

He also questioned her as to whether "your case may be used by the Communists for propaganda purposes." She claimed no knowledge of whether it was or wasn't but claimed her support came from various private interested citizens.

Following the interview with HELEN SOBELL, [redacted] interviewed JEAN FRANTJIS, FRED A BURKE, and AARON LIBSON, in that order. b7D

FRANTJIS said she is active on the Philadelphia Sobell Committee.

He asked her "Are you yourself a Communist." She replied "No, I am not." She denied knowledge of any CP members being associated with the local committee. He asked her also if she had ever been a Communist. She replied "No."

FREDA BURKE told [redacted] she worked with FRANTJIS on the Philadelphia Sobell Committee. b7D

[redacted] asked her the same general questions concerning whether she is or has been a Communist. She became very indignant and refused to answer. He then told her that if she would not answer definitely one way or the other, it implies that she is a Communist, and that the Philadelphia Sobell Committee is supported by Communists.

She said that this was not a relevant question. He pointed out that it was obviously a relevant question, and that her evasive answers made it plain that the picket was Communist backed.

[redacted] commented that it was clear that the pickets had been briefed before they arrived.

Approximately 30 persons participated in the picket line.

Several bystanders whose comments were overheard, characterized the pickets as "a bunch of nuts."

It is felt that direct questions regarding Communist Party affiliations [redacted] had a strong impact. BURKE apparently was extremely upset by these questions. This very well may have the effect of curtailing future picket activities by her and others connected with the Philadelphia Sobell Committee and other CP fronts in this area. b7D

Pertinent data concerning the above will be included in the next report concerning the Philadelphia Sobell Committee.

Only a limited portion of the tape was used by Radio Station WIP on its news broadcast Saturday afternoon, 3/31/62. That portion used was definitely to the disadvantage of the National Committee to Secure Justice For Morton Sobell and the Philadelphia Sobell Committee.

The interviews mentioned above were taped by [redacted] the tape was lent on a temporary basis to this office by [redacted] and the above information was contained on the tape. [redacted] was advised that he will retain the tape.





A mailing was received from the BACSC which contained a letter dated November 11, 1961, on the letterhead of the BACSC, and an announcement of a November 28, 1961, benefit for MORTON SOBELL. The letter, bearing stamped signature of WARREN K. BILLINGS, Chairman, sets out that since the Justice Department has refused executive clemency to MORTON SOBELL, HELEN SOBELL reserves the right to plead her case to the public via legal motions, public meetings and demonstrations. She intends to continue her walks before the White House on every possible occasion. The letter reflects that inasmuch as Sobell Committees all over the United States plan to make similar walks in their cities the BACSC plans their walk for November 25, 1961, from 1:00 P.M. to 3:00 P.M., outside of the Federal Building Main Post Office, San Francisco. The letter concludes by asking for a monetary contribution to the BACSC in the event the recipient is unable to join in the walk.

The announcement for the Sobell benefit reflects that on November 28, 1961, DONALD PIPPIN will present a piano concert of classical music at the Old Spaghetti Factory Cafe, San Francisco, with admission \$1.50 per person.

The March 29, 1962, issue of the "Golden Gater", a student newspaper at San Francisco State College, San Francisco, contains an article concerning an interview with HELEN SOBELL at the "Golden Gater" Office on March 22, 1962. Mrs. SOBELL who is described as a former physicist and credentialed teacher, described her efforts over the past ten years to free her husband and stated that he was tried only because he refused to testify against the ROSENBERGS. She stated that the CSJMS has a three point plan to free her husband:

1. Petition for Executive Clemency.
2. Two legal motions, which, if accepted, will result in a new trial or freedom.
3. Requesting parole when he is eligible on July 27, 1962.

JULIUS and ETHEL ROSENBERG were convicted in the United States District Court, Southern District of New York, on March 29, 1951, of conspiracy to commit espionage on behalf of the Soviet Union. The ROSENBERGS were sentenced to death on April 5, 1951, and legally executed at Sing Sing Prison, Ossining, New York, on June 19, 1953.

Page 3, Column 1, of the February 10, 1962, issue of the "PW" newspaper, contains an article entitled "Pickets planned by Sobell Group." This article reflects that the Bay Area Sobell Committee will announce further details at a later time concerning a demonstration on behalf of MORTON SOBELL when President JOHN F. KENNEDY speaks at the University of California, Berkeley, (UC), on March 23, 1962.

The March 21, 1962 issue of the "San Francisco News-Call Bulletin", a daily San Francisco newspaper, contains an article entitled "Picket Groups Organize at UC for JFK Visit." This article reflects that HELEN SOBELL and a group of followers will picket and urge freedom for MORTON SOBELL during President KENNEDY's visit to UC on March 23, 1962.



This article reflects that HELEN SOBEL will address a campus audience on March 21, 1962 at Dwinelle Hall, UC, concerning her husband's case and will picket President KENNEDY on March 23, 1962, when he appears at UC. Most of the article sets out information furnished by EUGENE EAGAL concerning the injustice of the SOBEL case.

The March 23, 1962 issue of "The Daily Californian" contains an article entitled "HELEN SOBELL to picket today in Attempt to Free Husband." The article reflects that HELEN SOBELL and about 20 supporters will picket March 23, 1962, in front of the International House in an attempt to have President KENNEDY commute her husband's sentence. She reportedly stated to a campus audience on March 21, 1962, that her husband is completely innocent and was convicted only upon the testimony of a confessed perjurer, MAX ELITCHER, who was never sentenced. She told of her recent trip to Europe and how she has the support of England's Lord CHORELY, thirty members of Parliament and a number of schools and organizations in Europe. She concluded by stating that she didn't think the ROSENBERGS were guilty either.

On March 23, 1962, Special Agents of the FBI observed a group of individuals, led by HELEN SOBELL and WARREN BILLINGS, picketing in front of the International House, 2299 Piedmont Avenue, Berkeley. The group, which varied in size from eleven to twenty-nine, picketed and passed our literature to passers-by enroute to hear President KENNEDY speak at the nearby UC stadium. The literature was the January 1962 issue of the Sobell newspaper, "Give a Day of Your Life", and a reproduction of an editorial entitled "The Sobell Case", which appeared in the December 15, 1961, issue of the "Columbia Daily Spectator", a student newspaper at Columbia University, New York City, New York. The group carried picket signs supporting clemency or pardon for MORTON SOBELL and picketed from 11:30 A.M. to 2:05 P.M., and from 2:50 P.M. until 3:20 P.M.

On November 25, 1959, a second source advised that the BACSC, also referred to as the Northern California Council of Sobell Committees, is one and the same, and their headquarters is located at 345 Franklin Street, San Francisco, California, and is continuing to function and plan future Sobell affairs.

On December 18, 1959, a third source advised that MARY KRVAR, a member of the Warehouse Club, Communist Party (CP), East Bay Region, Oakland, California, and the paid organizer for the BACSC, has stated that the CP is interested in controlling the BACSC so that the BACSC will continue to follow the line of the National Sobell Committee in attempting to obtain the freedom of NORTON SOBELL.

On May 2, 1961, the second source advised that the BACSC was still active and planning future Sobell activities.

The CP, USA, has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg - Sobell Committee at a conference in Chicago in October, 1953, and 'then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case'...."

On February 27, 1962, AL T-3 made available the January, 1962, issue of a newspaper published by the Committee to Secure Justice for Morton Sobell captioned "Give a Day of Your Life." On page four of this paper there appears a block captioned "Help the Sobell Committee Tour Your Home City" and thereafter are listed nine separate committees of this organization throughout the United States. It is noted that Committee #5, is captioned "Syracuse Sobell Committee, 1009 Cumberland Avenue, Syracuse, N.Y."

On April 2, 1962, AL T-3 advised that 1009 Cumberland Ave., is the residence of LILLIAN REINER.

In December, 1961, the Internal Security Division of the Department of Justice made available 18 petitions circulated throughout the States of New York and Vermont by the CGJMS. These petitions were addressed to the President of the United States on behalf of MORTON SOBELL and directed to the President by residents of these States. These petitions requested the President to initiate action on behalf of MORTON SOBELL and cause this case to be reopened stating that the sentence imposed upon SOBELL was excessive and he should be granted executive clemency.

Another source on August 29, 1961, furnished a mimeographed letter headed the Syracuse Sobell Committee dated June, 1961, signed LILLIAN E. REISER, Chairman.

Another Confidential Source advised that as of March 11, 1961, LILLIAN REISER was not known as a Communist Party member, but as Chairman of the American Labor Party at Syracuse, New York worked closely with Communist Party members.

"Communist dissimulation extends into the field of political parties forming political front organizations such as the *** American Labor Party. The last paragraph of page 6 contains information identified as being furnished by PH T-22. This information relates to a picket line conducted by the Philadelphia Sobell Committee (PSC) on 3-31-62 (synopsis indicates the picketing activities took place 3-31-62). The date PH T-22 furnished this information, according to the above-referred-to paragraph, is obviously a typographical error inasmuch as it is listed as 8-31-62. The details of the report do not contain the date of the picketing activities.

In reviewing this paragraph, which also includes information concerning a fisur conducted by a Special Agent of the FBI and the remarks of one [REDACTED] it is impossible to tell whether all the information in the paragraph was furnished by PH T-22 or some of it furnished by [REDACTED] (it is obvious the information attributed to the fisur could not have been furnished by PH T-22). Additionally, it is not clear as to the significance of the comments of [REDACTED] have a Communist Party (CP) background or basis for being a reliable judge so that information he furnished would be of significance in this report? Also, the significance of the remarks made by bystanders as reported by the Special Agent conducting the fisur is vague. The purpose of this report is to show the subversive background of captioned organization, and unless sources used are credible witnesses and are in a position to furnish information bearing upon this subject, such information should be omitted from the report.

On pages 5 and 6 reference is made to Dr. Annette Rubinstein and Dr. Willard Uphaus as speakers at functions sponsored by the PSC. Dr. Rubinstein is on the Security

Index of the New York Office and Dr. Uphaus is on the Security Index of the New Haven Office. Both of these individuals are well-known "apologists" at CP front functions. Philadelphia should have obtained from the office of origin covering the residence of each of these individuals an appropriate subversive characterization to include in this report. It is noted no subversive information is included concerning Dr. Rubinstein, and the major portion of the information characterizing Dr. Uphaus is self-serving, i.e. descriptive information furnished by Dr. Uphaus himself.

The synopsis indicates the return mailing address of the ISC is P. O. Box 908. On page 2 the address is listed as P. O. Box 905.

In various places in the report the date information was furnished by a source and/or the date of the activity have been omitted. Examples can be found on page 5, fourth paragraph; page 4, under the heading "General Activities," first paragraph; page 5, sixth paragraph; and page 6, first paragraph.

On page 7 reference is made to [redacted] and [redacted]. Cover page C indicates PH T-10, PH T-11, and PH T-12 were used to characterize [redacted]. These characterizations do not appear in the report, and the details of the report do not refer to these sources. b7D

The appendix section of the report contains characterizations of the Committee to Secure Justice for Morton Sobell, ISC, Delaware Valley Committee for Democratic Rights, Philadelphia Social Science Forum Committee, Emergency Civil Liberties Committee and the Citizens Committee for Constitutional Liberties. The sources used to characterize these organizations have not been identified in the cover pages of the report with the exception of the Citizens Committee for Constitutional Liberties. In this latter case, however, the sources used in the characterization have been identified twice; as PH T-13, PH T-14 and PH T-15; and at the bottom of cover page B² under the heading "Appendix Informants." I called you because Morton Sobell will be eligible for parole on July 27th by the Department of Justice calculation. Actually, he had served one third of the 30 year sentence by April 1961. There was a period pending appeal when he was asked to stay near his attorneys in order to prepare the appeal and that time served was not credited. The final period will be July 27th. This May 23rd the Parole Board is meeting to consider his case. By their own standards he really has been... he is a person who could be readmitted to society. While in prison he has been working on his after work hours on an electronics project for the blind which would be the substitute for braille. After the first satellite was launched, he wrote an article called "Why The Satellites Stay Up," which article was published in the prison magazine. 

An Appeal to Free Sobell

To the United States Mission to
the United Nations

This petition was presented April 7 to Adlai Stevenson, head of the U.S. delegation to the United Nations, by Mrs. Morton Sobell and her son, Mark. Mrs. Sobell recently returned from a trip to Europe to explain the Sobell case. She enlisted the support of many public personalities such as Bertrand Russell and Arnold Wesker in England, as well as others mentioned in the appeal. These and other materials referred to below may be obtained from the Sobell Committee, 940 Broadway, N. Y. Morton Sobell becomes eligible for parole at the end of July, 1962. It is hoped the White House will be persuaded by aroused public opinion to grant this parole after 12 years of incarceration for Morton Sobell.

THE attached copies of appeals by 30 Members of Parliament in England, by the internationally known British attorney Gerald Gardiner, and by Queen Elizabeth, the Queen Mother of Belgium, are indicative of the concern which the case of Morton Sobell has evoked, not only in our own country but in nations of the world.

Many organizations overseas concerned with civil liberties and human rights, have previously appealed to the White House. Such eminent persons as Lord Bertrand Russell of England, Dr. Martin Buber of Israel, Jean-Paul Sartre of France, and cellist Pablo Casals are among those on record as urging Morton Sobell's release. There is a long and honored list of persons and organizations in our own country who have made appeals for an end to Sobell's incarceration, now in the 12th year. Enclosed is a copy of a newspaper summarizing these appeals.

The first reason Morton Sobell should have long since been freed is that his imprisonment is morally wrong. The trial was held at a time of deep hysteria, the testimony against him rested on a single witness who was an admitted perjurer, the testimony was so flimsy that even if believed it never accused Sobell of giving or receiving any classified material, and the 30-year sentence was completely out of line with the evidence presented.

Morton Sobell has steadfastly maintained his innocence throughout his imprisonment. Many who have studied the case believe this to be the truth.

Others, including legal scholars, believe the trial was unfair. When there is an avalanche of public criticism from authoritative individuals and organizations concerning the trial and conviction of a man, and especially where such a man has already served nearly 12 years of imprisonment, it becomes sheer vindictiveness to con-

time to keep him from his family.

As the *National Jewish Post and Opinion* stated in an editorial of Dec. 22, 1961, "Enough qualified American and world leaders have expressed doubt about the testimony surrounding his conviction to warrant even those who are not aware of the intimate details of the case to take the position that he has paid his debt to society and should be freed by executive action."

This becomes a particular concern not only for the Justice Department and the White House staff of President Kennedy, but to all whose daily work it is to project the image of our nation before world public opinion. The price our country continues to pay by keeping Morton Sobell in prison is not only the evil that results internally

from perpetuating an injustice; it is also the lack of respect that occurs abroad when others can look at us and observe that we are still compounding abuses that occurred during the McCarthy era instead of forthrightly seeing to it that injustices of that harmful period are rectified.

That is why we believe it is important for the United States Mission to the United Nations to at once consider this case, study the appeals of those speaking in Morton Sobell's behalf, and recommend to President Kennedy that in the interests of our country, speedy action be taken to restore Morton Sobell to his family. We thank you for giving this your attention and await your decision.



The "Militant", an SWP weekly newspaper, in the issue dated January 20, 1962, reflected that WENDELL PHILLIPS, welding instructor and SWP member, was officially suspended January 15, 1962, by the Fullerton (California) Junior College Board of Trustees. 



"On May 25, 1962, a group of Communists met at the residence of NORMAN BERMAN, 3641 Pennington, Shaker Heights, Ohio, to hear YURI SUHL of New York speak on behalf of MORTON SOBELL.

"JEAN ROBBINS opened the meeting, explaining how nice it was of YURI SUHL to drop his work and travel on behalf of MORTON SOBELL. She mentioned some of SUHL's books. She introduced SUHL, who she stated would bring them up to date on the MORTON SOBELL case.

"YURI SUHL reviewed the history of the case of JULIUS and ETHEL ROSENBERG. He stated it had never been proven that MORTON SOBELL had committed espionage; that SOBELL had been kidnapped in Mexico and returned to the U. S.; that MORTON SOBELL had been asked to testify against the ROSENBERGs but had refused. SUHL quoted statements of judges and ministers which were favorable to MORTON SOBELL. He explained that MORTON SOBELL had recently appeared before the Parole Board, and that it appeared that conditions were favorable for his parole. He stated that HELEN SOBELL is losing her courage and is looking old, and urged that they write to her, and that he was afraid that if MORTON SOBELL were not paroled she would break up completely.

"YURI SUHL stated that HELEN SOBELL had given her approval to the making of a motion picture of the life of MORTON SOBELL, which is to be made in the U. S. He indicated that this information was confidential, and that if the FBI knew about it, they would try to 'shake down the producer'.

"Every one present signed cards, addressed to the President of the U. S. urging that MORTON SOBELL be freed either by parole or by executive clemency. Additional cards were also distributed to those present which they were to have their friends sign and mail.

"YURI SUHL solicited contributions to help pay for the legal fees in regard to MORTON SOBELL, and everyone contributed.

"JEAN ROBBINS mentioned that the brother-in-law of Rabbi HOROWITZ is going to GEORGIA and would see MORTON SOBELL. The group also discussed getting in touch with certain ministers who might be helpful in the campaign to free SOBELL.



Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL, the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case.....







The ROSENBERGs were sentenced to death on April 5, 1951, and MORTON SOBELL was sentenced to 30 years imprisonment on the same date. JULIUS and ETHEL ROSENBERG were legally executed at Sing Sing Prison, Ossining, New York, on June 19, 1953. MORTON SOBELL is currently serving his sentence at the United States Penitentiary, Atlanta, Georgia.



For the purpose of brevity, the Los Angeles Sobell Committee will be hereinafter referred to as the LASC, the Committee to Secure Justice for Morton Sobell as the CSJMS, and the Southern California District Communist Party as the SCDCP.

All the meetings and activities reported herein were held in Los Angeles, California, unless otherwise indicated.

As of July 13, 1952, the LASC was composed of the Los Angeles Area Chapter, also known as the Metro Chapter; the Long Beach-San Pedro Chapter; West Los Angeles Chapter; and the Valley Chapter. Informant stated the Los Angeles Area Chapter was the only regularly active chapter.

II. CHARACTERIZATION

The LASC (see appendix) is the Los Angeles, California, affiliate of the CSJMS (see appendix).

JULIUS and ETHEL ROSENBERG and MORTON SOBELL were convicted in United States District Court, Southern District of New York, on March 29, 1951, on a charge of conspiracy to commit espionage on behalf of the Soviet Union. The ROSENBERGS were sentenced to death on April 5, 1951, and MORTON SOBELL was sentenced to thirty years imprisonment on the same date. JULIUS and ETHEL ROSENBERG were legally executed at Sing Sing Prison, Ossining, New York, on June 19, 1953; and MORTON SOBELL is currently serving his sentence at the United States Penitentiary, Atlanta.

Between February and June, 1952, the aim and objective of the LASC was to obtain the release of MORTON SOBELL from prison to picketing the White House, Washington, D. C., and by attempting

X. MC GOEY reserved decision."

Appearing in the PW (above) of March 24, 1962, page 3, was an article captioned "Freedom Walk Monday for MORTON SOBELL". The article reported a "walk for freedom" would take place on Monday, March 23, 1962, from 11:00 AM to 2:00 PM in front of the Federal Building in Los Angeles, California.

Appearing in the Los Angeles Herald-Examiner of March 27, 1962, was an article headed "Wife, Mother Picket to Free MORTON SOBELL", which read in part that "The wife and mother of jailed Soviet agent MORTON SOBELL led pickets demonstrating for his release The demonstration, in front of the Federal Building, was sponsored by the Los Angeles Sobell Committee."

Appearing in the Los Angeles Times of March 27, 1962, was an article headed "SOBELL's Wife, Mother Head Pickets Here", which read in part, "His wife and his mother headed pickets parading before the Federal Building here Monday urging the release of MORTON SOBELL, convicted in 1951 of espionage and sentenced to 30 years in prison SOBELL, convicted with JULIUS and ETHEL ROSENBERG, who were executed, has protested his innocence. He will be eligible for parole consideration in July." This article was headed by a photograph of HELEN and ROSE SOBELL bearing picket signs regarding SOBELL.

Appearing in the Citizen-News of Hollywood, California, dated April 6, 1962, was an article headed "SOBELL Plea Turned Down", which reported in part that "A Federal Court has turned down a plea by convicted spy MORTON SOBELL for a new trial. Federal Court Judge JOHN F. X. MC GOEY yesterday denied SOBELL's petition and simultaneously turned down a motion for a reduction of his 30-year sentence."

1APPENDIXCITIZENS COMMITTEE TO PRESERVE AMERICAN FREEDOMS

The "Guide to Subversive Organizations", revised, December 1, 1961, pp. 43-44, describes this committee as follows:

"The Citizens Committee to Preserve American Freedoms * * * specializes in propaganda aimed at abolishing the Committee on Un-American Activities and discrediting the Federal Bureau of Investigation. Created in Los Angeles in 1952, the front organization is run by FRANK WILKINSON, an identified Communist who recently resumed the full-time, paid post of executive secretary after approximately a year's leave of absence to assist in a similar campaign by another front in New York City, the Emergency Civil Liberties Committee.

"When the Committee on Un-American Activities held hearings in Los Angeles, September 2-5, 1958, to inquire into the nature of the Party's recent reorganization in California, the Citizens Committee to Preserve American Freedoms sponsored a series of public meetings to protest the hearings and the very existence of the Committee. Communists subpoenaed as witnesses were guests of honor.

"At this time, leaders of the party's Southern California District, were mobilizing Communists in the area for participation in an intensified campaign to abolish this committee of Congress. How the Citizens Committee to Preserve American Freedoms served the party in this effort was revealed by (Communist Party) District Chairman DOROTHY HEALEY in a report to the party's Southern California District Council on September 21, 1958. Mrs. HEALEY declared that the party preferred public protest meetings to be held by the Citizens Committee to Preserve American Freedoms rather than under party auspices because Communists could attend without danger of being exposed as members of the party. She also noted that Communists scheduled as congressional committee witnesses could not appear beforehand at openly Communist rallies without creating the impression that the party was conspiring with witnesses to withhold information from the committee."

A source advised on April 25, 1962, that the Los Angeles Sobell Committee is the Los Angeles, California, affiliate of captioned organization.

"Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL, the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case'....."

("Guide to Subversive Organizations and Publications" dated December 1, 1961, issued by the House Committee on Un-American Activities, page 116.)

In September, 1954, the name 'National Committee to Secure Justice for Morton Sobell' appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell," first appeared on literature issued by the Committee.

The 1960-61 Borough of Manhattan telephone directory lists the "Committee to Secure Justice for Morton Sobell" as being located at 940 Broadway, New York, New York.

CONSTITUTIONAL LIBERTIES INFORMATION CENTER (CLIC)

A source advised on April 25, 1962, that Constitutional Liberties Information Center (CLIC) was formed in July, 1961, in Los Angeles, California, as a Communist Party (CP) defense committee to combat the U. S. Supreme Court decisions of June 5, 1961, upholding the Internal Security Act of 1950 and the membership provisions of the Smith Act.

Officers

of CLIC include REUBEN W. BOROUGH, Chairman, and HUGH DE LACY, Vice Chairman. CLIC activity currently devoted to furnishing speakers to interested groups, arranged and sponsored so far only by CP units, and to distribution of literature including reprints of the dissenting opinions of U. S. Supreme Court Chief Justice EARL WARREN and Justice HUGO L. BLACK. b7D

Another source advised on August 8, 1961 that REUBEN W. BOROUGH and HUGH DE LACY are current members of the Professional-Cultural Section, SCDPC.

APPENDIXEMMA LAZARUS FEDERATION OF JEWISH WOMEN'S CLUBS

"The Jewish Fraternalist" dated October, 1947, self identified as the official publication of the Jewish People's Fraternal Order (JPFO) of the International Workers Order (IWO), on page 6, contained an article which reflected that the Emma Lazarus Division (ELD) of the JPFO was to hold its first national convention in New York City on November 15 and 16, 1947, after having been first established at a National Women's Conference called three years previously by the JPFO.

The "Morning Freiheit" on January 25, 1951, contained a report on the National Convention of the ELD of the JPFO which took place in New York City on January 20 and 21, 1951. At this convention it was noted that the ELD changed its name to Emma Lazarus Federation of Jewish Women's Clubs (ELF) and adopted a new constitution.

On May 11, 1961, a source advised that the ELF is one of several mass organizations comprising the Jewish Cultural progressive movement. JUNE GORDON, ELF Executive Director, who is a member of the New York State Communist Party (CP) Board and Committee, is the leading force in the organization, whose leadership is largely made up of Communists.

The source stated that the ELF claims to be for peace and interested in protecting the rights of the foreign born. It is against the BEN GURION Government of Israel, bomb testing, anti-Semitism, Negro discrimination, and the rearmament of West Germany.

The source related that the ELF renders support to and receives support from the "Morning Freiheit" and any other Jewish progressive organizations.

The source also stated that the ELF is recognized by the CP, USA as an important progressive national organization of women.

The IWC, JPFO and CP, USA have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

The "Guide to Subversive Organizations and Publications", revised December 1, 1961, contains the following concerning the "Morning Freiheit":

- "1. The Communist International 'subsidized * * * the founding of the CPUSA's newspaper, Freiheit.' (Subversive Activities Control Board, Docket No. 51-101, Modified Report with respect to the Communist Party of the United States of America, December 18, 1956, p. 159.)
- "2. A 'Communist Yiddish daily'. (Attorney General FRANCIS BIDDLE, Congressional Record, September 24, 1942, p. 7686.)
- "3. 'The Freiheit has been one of the rankest organs of Communist propaganda in this country for almost a quarter of a century' (Special Committee on Un-American Activities, House Report 1311 on the CIO Political Action Committee, March 29, 1944, p. 75.)"

A source advised on April 27, 1962, that the Emma Lazarus Jewish Women's Clubs of Los Angeles are affiliated with the Emma Lazarus Federation of Jewish Women's Club, having national headquarters in New York, New York, which, until the early part of 1951, were known as the Emma Lazarus Division, Jewish People's Fraternal Order. According to the informant, the Emma Lazarus Jewish Women's Clubs, Los Angeles, in about 1952 and early 1953 were also known as the Emma Lazarus Council of Jewish Women.

APPENDIXLOS ANGELES COMMITTEE FOR PROTECTION OF FOREIGN BORN

The "Guide to Subversive Organizations", revised, December 1, 1961, pp. 103-104, describes this committee as follows:

"A 'branch' of the American Committee for Protection of Foreign Born found to be under the 'actual management, direction, and supervision' of Communist Party members. The Los Angeles Committee was reorganized in October, 1950, and reported that it 'shall be affiliated to the national organization known as the American Committee for Protection of Foreign Born * * *'. The American Committee and the 'various area or local committees * * * constitute * * * one organization within the meaning of the * * * statute (Internal Security Act)' under which the Subversive Activities Control Board found the American Committee for Protection of Foreign Born to be a 'Communist front organization' and ordered it to register as such with the Attorney General".

(Subversive Activities Control Board, Docket No. 109-53, Report and Order with respect to the American Committee for Protection of Foreign Born, June 27, 1960, pp. 41, 8, 12, and 51.)

"Cited as a 'regional' organization of the American Committee for Protection of Foreign Born and one of its 'most complex affiliates.' The Committee on Un-American Activities found that in early publications, the local affiliates frankly identified themselves as chapters of the American Committee for Protection of Foreign Born; their representation of themselves as independent groups came only after enactment of the Internal Security Act which would have required them, as affiliates, to register as Communist-front organizations."

"Control of the local organizations * * * was made possible primarily by virtue of the fact that the leaders of the local groups were Communist Party members and therefore subject to the discipline of the party. * * * The local affiliates * * * were actually little more than administrative staffs, whose purpose it was to implement the program of the Communist Party in their respective areas."

LOS ANGELES COMMITTEE FOR PROTECTION OF FOREIGN BORN

"The 'Lamp' of January, 1950, reported that the Los Angeles Committee for Protection of Foreign Born had been established on November 29, 1949. Publicly identified Communist ROSE CHERNIN served as 'the operating head' since the time of its organization."

(Committee on Un-American Activities, House Report 1182 on Communist Political Subversion, August 16, 1957, pp. 86, 87, 55, 33, 54, 58, and 59; also cited in Annual Report for 1956, House Report #53, Feb. 11, 1957, p. 5.)

"NATIONAL GUARDIAN"

The "Guide to Subversive Organizations", revised, December 1, 1961, p. 193, describes the "National Guardian" as follows:

"Established by the American Labor Party in 1947, as a 'progressive' weekly. * * * Although it denies having any affiliation with the Communist Party, it has manifested itself from the beginning as a virtual official propaganda arm of Soviet Russia."

The Special Committee on Un-American Activities, House Report 1311, on the CIP Political Action Committee, March 29, 1944, page 78, describes the American Labor Party as follows:

"For years, the Communists have put forth the greatest efforts to capture the entire American Labor Party throughout New York State. They succeeded in capturing the Manhattan and Brooklyn Sections of the American Labor Party but outside of New York City, they have been unable to win control."



COMMITTEE TO SECURE JUSTICE FOR MORTON SOBELL

A source advised on April 25, 1962, that the Los Angeles Sobell Committee is the Los Angeles, California, affiliate of captioned organization.

Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL, the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg case'.....

(“Guide to Subversive Organizations and Publications” dated December 1, 1961, issued by the House Committee on Un-American Activities, page 116.)

In September, 1954, the name 'National Committee to Secure Justice for Morton Sobell' appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell," first appeared on literature issued by the Committee.

The 1960-61 Borough of Manhattan telephone directory lists the "Committee to Secure Justice for Morton Sobell" as being located at 940 Broadway, New York, New York.
