Letters from persons of other countries were also cited in this advertisement and a request was made to write or wire President TRUMAN and to send money to the Emergency Committee of the Arts and Professions to Secure Clemency for the Rosenbergs, 108 West 14th Street, Mew York 36, New York. This article stated that the advertisement was pair for by popular subscription and published by the Emergency Committee of the Arts and Professions to Secure Clemency for the Rosenbergs, Dr. CLEMENS J. FRANCE, Chairman, and BERNARD GERSTEN, Secretary-Treasurer.

It stated that the Board of Aldermen in St. Louis were requested to pass a resolution asking President TRUMAN to grant executive clemency to ETHEL and JULIUS ROSENBERG. The request was made by HAVEN P. PERKINS, Chairman of the SLCSJRC, 3715 LaSalle Street, St. Louis, Missouri.

# A. 3. Mational Offices, Both Past and Present

DAVID ALMAN, described by the informant as Executive Secretary of the National Committee SJRC, spoke at a meeting of the St. Louis Committee SJRC on April 17, 1952 at Italian Fraternal Hall, 626 N. Vandeventer, and during his talk stated that he and five other friends of the ROSENBERGS had originated the National Committee which had met with great success in the United States and abroad as well. He also stated that funds were being collected to enable the case to be carried to the Supreme Court. ALMAN pointed out that the ROSENBERG mass meetings being held everywhere, along with petitions being sent to the Supreme Court, would sway the judges.

No appropriate quotation from the "CP Line" file could be found to compare these two features of the St. Louis ROSENBERG Committee campaign.

testimony of David Greenglass, a confessed spy. Now an FBI agent has bestified under oath that some of the evidence was perjured."

"Already there are grave doubts about the fairness of the Rosenberg trial. An FBI Agent has testified under oath that the government knowingly used perjured testimony. Shall we wake up to find the Rosenbergs are innocent - but too late. It would be better to let them live at prison so that if they are not guilty they will have a chance to prove it."

It is to be noted that portions of pamphlets and publications issued by the NCSJRC in New York evidencing adherence to the CP line are not being herein set out inasmuch as instant publications have already been documented and it is presumed that the New York Office already has copies of same.

St. Louis Security Informants have advised the SICSJRC has emphasized the racial discrimination aspect of the case against the ROSENBERGS and it is the principle contention of this group that the death sentence for the ROSENBERGS is too severe. No appropriate quotation from the "CP Line" file could be found to compare these two features of the St. Louis ROSENBERG Committee campaign.

A meeting of the Ohio Committee for Clemency for the Rosenbergs was held at the home of MARY and JEROME LAND, Cleveland Heights, Chio, on December 14, 1952. Approximately fifty persons were present for the meeting.

This source advised that the committee expected 200 persons to go from Cleveland to Washington on January 4-6, 1953, to participate in the protest march on behalf of the ROSENBERGS.



An article appeared in the "Cleveland News", daily Cleveland newspaper, issue of December 22, 1952, concerning the ROSENBERGS which appeared on page one under the headline, "Plot Uncovered Here to Save Atom Traitors." The article was written by JACK KENNON, "News" political editor. The article stated that an attempt by Communist sympathizers to block the January 12, 1953, execution of atomic secret traitors, ETHEL and JULIUS ROSENBERG, was uncovered in Cleveland on that date by the "News."

Witness:

According to the article, clergymen of all faiths in greater Cleveland were being asked by letter to urge President TRUMAN to commute the death sentence of the ROSENBERGS. The clergymen had received a letter from what purports to be the "Ohio Committee for Clemency for the Rosenbergs." The article stated that identity of the membership of this committee was carefully hidden and the only address is Post Office Box 41, Cleveland, which was located in South Euclid, Ohio.

According to the article the literature requested that contributions be made payable to the Chio Committee for Clemency for the Rosenbergs.

Another article appeared in the "Cleveland News" issue of December 23, 1952, written by ROBERT L. KEHOE, under the headline, "Signers of Rosenberg Petition linked to Reds by Police." The article is quoted as follows:

\*Principal Cleveland supporters of a clemency plea for Ethel and Julius Rosenberg, due for execution on Jan. 12 as atomic secret traitors, are persons frequently linked to the Communist Party and its front organizations, Cleveland police records disclosed today.

These records show that members of the Rosenbergs!

defense committee have held three meetings here in the past six
weeks, but were denied use of Public Hall and a downtown radio
studio for a general mass meeting.

The first of these meetings was under the joint sponsorship of the Cleveland Council of Arts, Sciences and Professions, a government-labeled Communist-front organization, and the Ohio Committee to Secure Justice for the Rosenbergs.

"It was held at the Sterling Hotel, E. 30th St. and Prospect Ave., on Nov. 8 and was attended by about 50 people.

Among those present were Jean Krchmarek, former wife of the Communist leader now under federal indictment; Frieda Katz, listed in the party's Daily Worker as the 'Communists' women's leader,' and her husband, David; George Tomsik, frequent advertiser in the Daily Worker; and Fred Haug, a former union official identified at congresional hearings as a member of the party.

Progressive Party and other front groups; Robert Decker, recently identified as organizer of the party's youth group here; Eugene Duchan, Frieda Kreitner, Norma Shedroff, Jerome and Mary Land; Sallie Marilles, James Schmidt, Libby Gieser, Florence Romig, Caroline Ovchar, Marin Alexandru, and Harry Becker.

"The second meeting, sponsored by the Ohio Committee for Clemency for the Rosenbergs, was held in Parlor F of Hotel Hollenden on Nov. 18, police records disclose.

"In attendance at this meeting were Allen Greenfield, son of E. C. Greenfield, a former CIO official who was a candidate for governor on the Communist Party's ticket this year;

"Don Rothenberg, leader of front organizations listed by the government as Communist fronts; Sam Handelman, an attorney who has represented leftist sympathizers in court hearings and deportation cases, and Mary Land, daughter-in-law of Mrs. Yetta Land, associate counsel for the top Communist leaders now in prison.

# "Third Meeting in Heights

"The last meeting, observed by Cleveland Heights police on Dec. 16 was held in the home of Milton Tenenbaum at 3085 Lincoln Blvd., in that suburb, and was attended by a handful of people

It was arranged, police officials learned, after several efforts were made by Mrs. Margery Posner, 1692 Crest Rd., Cleveland Heights, to rent Public Hall or a downtown radio studio, for a mass protest meeting.

"It was Mrs. Posner who rented a Box ill in the South Euclid post office for receipt of contributions to a Rosenberg defense fund. The box number and solicitation of funds was disclosed by The News after letters appealing for support of the Rosenbergs were sent to clergymen throughout the city.

"Mrs. Posner refused to identify other members of the committee but denied that it was a 'Communist front.' Asked how she would account for the fact that a large number of them have b een linked to front activities here, she replied:

"I can't answer that because I'm not at liberty to disclose names. I know that I'm not a Communist and neither are a number of other members.

"Mrs. Milton Tenenbaum, who identified herself as a member of the committee but then declined to answer questions, said she was 'moved by the apparent injustice in this case.' She also admitted serving as a reference for Mrs. Posner in obtaining the postal box number.

# VIII. MEETINGS AND ACTIVITIES OF THE CONMITTEE


