

NOTE: On 6-13-53, prior to the execution of the Rosenbergs, the associate warden of the Lewisburg Penitentiary refused to allow a New York agent to interview David Greenglass without permission from the Director of Prisons, James Bennett. On 6-15-53, the Philadelphia Office was instructed that agents were not to see Greenglass and were not to have any contact with the warden of the Penitentiary. On 6-23-53, Philadelphia was advised that agents could cover routine leads at Lewisburg, but that until specifically advised, no contact should be made with David Greenglass. The Rosenbergs were executed on 6-14-53, and on 7-1-53, we granted authority to Philadelphia to contact Greenglass in a routine case. The interview desired of Greenglass in instant case is of a routine nature and it is considered that no reason exists for not interviewing him.

3. BLACK recalled that his superior had dark brown hair that was straight and thinning on top. He further advised that his superior "JOHN" did not give the appearance of a Russian, but rather a Sicilian and reminded him of a "Hollywood type gangster" in that he was short, soft spoken, slightly built, dark complected, but a "hard-looking person." He could not recall a small oval shaped mole on either of the cheeks of his superior.

4. BLACK advised that he is convinced from conversations he had with his superior "JOHN" that he did not have a technical education.

5. BLACK advised that judging from conversations with his superior "JOHN," he would say that he had no interest in poetry.

In conclusion, Mr. BLACK stated he did not know of anyone who might be identical to [REDACTED] *b7d*

A description of [REDACTED] was furnished to HARRY GOLD, Inmate, U. S. Penitentiary, Lewisburg, Pa., and he advised that he could not recall meeting anyone answering this description and stated he had no idea as to the identity of this person. He stated he only had one superior by the name of "JOHN" and this was ANATOLI YAKOLEV, former Russian Vice Consul in New York City. *b7d*

Street, advised that they could not locate a record of any Soviet Nationals who attended Massachusetts Institute of Technology (MIT) between 1930 and 1942.

Mr. ROGER F. EVANS, Assistant Director for the Social Sciences, Rockefeller Foundation, 49 West 49th Street, and Mr. H.M. MILLER, Jr., Associate Director, Division of Natural Sciences and Agriculture, Rockefeller Foundation, 49 West 49th Street, were contacted in an effort to identify additional Soviet National who attended MIT between 1930 and 1942 with negative results.

Mr. HARRY SEIBERT, Office Manager of the law firm Simpson, Thacher and Bartlett, 120 Broadway, advised that they formerly represented Amtorg Trading Corporation, but their relationship with Amtorg terminated in 1933. Mr. SEIBERT advised that he located a file which contained a cable dated June 25, 1931 from their law firm to the United States Consul in Berlin requesting visas for PETER ELYSSWICH BOLSHAKOFF, born Samara, Bokuruslan, January 22, 1899 and ILIA PETER STOERBAKOFF, born Kazan, July 20, 1903.

It was pointed out that these visas were for a temporary visit of the aforementioned two individuals to the United States as students to attend MIT for the summer session of 1931. The communication noted that BOLSHAKOFF and STOERBAKOFF would be associated with the Amtorg Trading Corporation.

Mr. SEIBERT also located their letter dated July 1, 1931 requesting the Visa Section of the State Department to issue visas to Soviet students destined to various technical universities in this country. This information has been previously reported.

No record of ILIA PETER STOERBAKOFF was located in the New York indices.

The following information is from a report of S.A.'S H. HEYWOOD, dated November 26, 1941 at Boston, Massachusetts, entitled "AMTORG TRADING CORPORATION, SPIONAGE - R":

SA HEWOOD was advised at the Institute that in the school year 1931-1932 approximately 40 students from Russia had entered schools in the United States and that they had been attending schools in Germany but that conditions there were unsatisfactory and that the students had been sent to the United States. A search of the directory of students at MIT for the year 1931-1932 revealed that the following students had attended the Institute at some time during the school year 1931-1932, and in this connection it will be noted that some of these students are mentioned in the records of the alumni office, for in the event that a student had ever attended the Institute for more than a year his name would be on record in the alumni office; however, if he attended only a part of a year, there is no record of him. GILLILAND has been recently interviewed by Special Agents FRANK T. WILLETT and WILLIAM J. McGPATRICK, JR., of the Boston Office, on separate occasions in connection with applicant type interviews. During these interviews GILLILAND did not appear to have the mannerism of squeezing his lips together [REDACTED] had. b7d

It has been noted that there is an interesting similarity between the description and background of AMADEO SABATINI, deceased former espionage agent [REDACTED] and Unsub JOHN.

SABATINI was born in Italy in 1909, was brought to the US as a minor, and during the 1930's he was in France and Spain. He returned to the US in November, 1938, and from 1939 to 1943 he worked under JOSEPH KATZ in NYC. In January, 1943 to January, 1944 he worked under GRIGORI KRIVITSKY, USSR Vice Consul in San Francisco. While SABATINI and IRVING GEORGE SCHUMAN were engaged in surveilling WALTER KRIVITSKY in NYC in 1939 under the direction of JOSEPH KATZ, they were given about \$400 in cash with which to purchase peanut vending machines, and for a few months they operated a small vending machine business together. These machines were placed in various candy stores, pool rooms and bowling alleys, and they discontinued the vending machine business a short time after they were taken off the KRIVITSKY surveillance.

In 1944 SABATINI was described as: height, 5'4 $\frac{1}{2}$ "; weight, 170; hair, brown; eyes, brown; foundry worker; slight Italian accent; poor education. It has been stated that he appeared taller than his actual height due to his build.

The above information concerning SABATINI compares with Unsub JOHN in this respect: According to BLACK, JOHN was his superior for a short period in 1939 or 1940 and was chiefly interested in Trotskyite activities. JOHN had a hard-looking face, generally associated with that of a gangster. (This compares with SABATINI's photo.) JOHN displayed an interest in shooting galleries, pinball machines, and amusement centers. He appeared to have some education. He could be any nationality although he was possibly Sicilian. He spoke with a slight accent. He never made any mention of having a family in the US. When he severed contact with BLACK, he indicated he was leaving the East, and left the impression he was going to the West Coast to work.
