For your assistance in considering the possibility of instituting prosecutive action against Thomas L. Black, Abraham Brothman, Harry Gold, and others, charging them in a general conspiracy to violate the Federal Espionage Statute, I am setting forth hereinafter certain facts which I feel merit serious consideration with respect to this matter. It is noted that you have previously been furnished with memoranda setting forth in detail information concerning the above individuals.

For your information, the investigation has definitely shown that during the period from 1934 to 1945, there existed in this country a Soviet espionage network, wherein certain individuals, such as Gaik B. Ovakhimian, Jacob Golos, Semen Markovich Semenov, Anatoli A. Yakovlev, and others, obtained information pertaining to national defense and industrial matters from American contacts, which information they thereafter transmitted through channels to the Soviet Union. It can be definitely shown that a portion of this information was of a classified and restricted nature and was obtained during the wartime period. The prosecution for such acts would not be barred by the Statute of Limitations. Testimony concerning the operation of this Soviet espionage network can be obtained through Elizabeth Terrill Bentley, Ferdinand P. Heller and Alfred Dean Slack. It also can be established through the testimony of or signed statements executed by Harry Gold and Thomas L. Black.

In connection with the conspiracy involving Black, Brothman and Gold, it is believed that evidence can be produced with respect to the following phases and overt acts:

- (1) The testimony of or the signed statements executed by Black and Gold would establish that Thomas L. Black, in the latter part of 1935 in New York City, introduced Gold to Paul Smith, a Soviet agent, and that thereafter both Black and Gold furnished information to Smith for transmittal to the Soviet Union.
- (2) The testimony of or the signed statement executed by Harry Gold would establish that Brothman was brought into the conspiracy in September, 1941, when Brothman, who was previously furnishing information to Jacob Golos and Elizabeth Terrill Bentley for transmission to the Soviet Union, was turned over to Gold as his future contact for such activity.

Further, that Gold's instructions to handle Brothman's information were received by him through his contact, Semenov. Brothman, however, received instructions to meet his new contact through Bentley, who was acting under the directions of Golos. In addition to Gold's testimony along this line, Brothman, in his oral statement, as well as his testimony before the Federal Grand Jury on July 22, 1947, corroborated the information to the effect that arrangements for his meeting with Gold were made through Bentley and Golos.

(3) The testimony of or signed statements executed by Gold and Black would establish that in 1942 Black arranged for the services of one Joan Niemasek, nee Sawyrucka, to serve as a stenographer for Gold to assist in the transcribing of information furnished by Brothman to Gold. She would further be in a position to testify that thereafter she accompanied Gold on six occasions to an office where Gold and Brothman dictated to her and furnished her with longhand notes on certain material which she thereafter transcribed and turned over to Gold.

(4) Testimony could be furnished by representatives of the FBI to the effect that at the time of the arrest of Harry Gold, and subsequent thereto, under a voluntary consent to search executed by Gold, there were located at Gold's residence in Philadelphia certain longhand reports and blueprints pertaining to a magnesium powder plant, magnesium powder, the "Buna-S" process, and "aerosol," all of which Gold identified as having been obtained from Brothman for transmission to the Soviet Union.

(5) Through the testimony or signed statement of Harry Gold, it could be shown that during the latter part of 1942 or early 1943, Brothman met and had a conversation with Semenov at the Hotel Lincoln in New York City, at which time Semenov praised Brothman for his wonderful work in behalf of the Soviet Union and indicated to him the value of the "Buna-S" information which was previously furnished to the Soviets by Brothman. The testimony of Black or the signed statement executed by him would establish the fact that in early 1936, Black was turned over by his previous Soviet contact, Paul Petersen, to one "George," whom he identified as "Semenov."

(6) The testimony of or signed statement executed by Harry Gold would establish that as part of his activity in behalf of the network he obtained information concerning atomic energy from Emil Julius Klaus Fuchs and David Greenglass, which information was transmitted by him to the Soviet Union.

(7) Through the testimony of Gold or his signed statement, it could be established that on an occasion in 1946, he informed Brothman of the fact that he had obtained atomic energy information for the Soviets from Emil Julius Klaus Fuchs.

(8) By the admission of Black as appearing in his signed statement, it could be established that Black was informed by Gold to the effect that he (Gold) was the American contact of Emil Julius Klaus Fuchs, and that he had furnished information concerning the atomic bomb to the Soviet Union. According to this statement, Gold told Black of his connection with Fuchs shortly after the arrest of Fuchs in England.

(9) Through the testimony of David Greenglass, Alfred Dean Slack and Ferdinand Heller, additional evidence as to Gold's espionage activities in behalf of the Soviets could be established.

It is suggested for your consideration that in the event an indictment is returned against Black, Brothman and Gold in connection with this matter, such individuals as Greenglass, Slack and Heller, although named as co-conspirators, but not charged in the indictment, may be used as witnesses in establishing certain of the necessary facts as to the existence of and overt acts committed in pursuance of the conspiracy.

CHARLES M. FREEFIELD, 1911 Coral Gate Drive, Miami, Florida, advised that he became acquainted with THOMAS L. BLACK through mutual friends in Newark, New Jersey, during the latter part of 1937 or early 1938. FREEFIELD stated that he was interested in social reform and was associated with many members of the Socialist Workers Party, although FREEFIELD stated that he is not now and never was a member of the SWP.

FREEFIELD advised that he was not intimately acquainted with BLACK prior to March of 1938. BLACK at that time was injured in an explosion at the National Oil Products Company, where BLACK was employed. While BLACK was hospitalized following this explosion, FREEFIELD called

upon him at the hospital. After the first visit, BLACK requested FREEFIELD to return and visit him on other occasions. FREEFIELD stated that at BLACK's invitation he returned almost daily to visit with BLACK while BLACK was in the hospital. FREEFIELD stated it appeared BLACK wanted someone to be with him as much as possible.

Upon the release of BLACK from the hospital, FREEFIELD stated that BLACK requested FREEFIELD to move into BLACK's apartment and live with him. FREEFIELD advised that he did so.

FREEFIELD stated that, after he had moved in with BLACK, BLACK told him that he had requested him to move in with him inasmuch as he, BLACK, was afraid and needed protection. FREEFIELD stated that BLACK then related that BLACK had been a member of the Communist Party from 1931 until about 1935. BLACK advised FREEFIELD that about 1931, while BLACK was employed at the American Cyanamid Company as a Chemist, BLACK was approached by Soviet Espionage Agents to secure information regarding industrial processes from the files of the American Cyanamid Company and turn this information over to another Soviet Agent. BLACK told FREEFIELD he was also to review scientific journals and clip pertinent articles for his Soviet superior. BLACK stated that he did this and continued to do so when he left the American Cyanamid Company and secured employment at the National Oil Products Company.

BLACK advised FREEFIELD that he continued to act as a Soviet Espionage Agent until some time in 1935 when he broke with the Communist Party over its "Stalinist" views and activities. BLACK advised FREEFIELD that, when he broke with the Communist Party, he became a member of the Socialist Workers Party. BLACK further stated to FREEFIELD that his former associates in the Soviet espionage ring continued to contact him and threaten him with bodily harm or to expose his previous activities if he did not continue to secure and transmit to them the industrial information.

BLACK told FREEFIELD that some of the persons contacting him were from the Russian Consulate in New York City and that some of the others were obviously Americans. BLACK stated that he was acquainted with some of the persons and some he had never seen before until they came to threaten him and pressure him.

FREEFIELD stated that BLACK told him the pressure and threats became particularly acute while BLACK was in the hospital, and that

BLACK was visited there on numerous occasions by Soviet Agents. FREEFIELD stated that it was because of these threats that BLACK asked him to move in with him.

FREEFIELD stated that all of the foregoing information was purely hearsay and had been related to him by BLACK. FREEFIELD stated that, however, on one occasion he particularly remembers, shortly after he moved in with BLACK, a man hung around the courtyard of their apartment almost continually for about three days, apparently awaiting an opportunity to see BLACK alone. FREEFIELD stated that he was informed by BLACK that the man was one of the Soviet Agents and, accordingly, both BLACK and FREEFIELD remained together in the apartment all during this time.

FREEFIELD stated that BLACK discussed this situation with the officials of the Socialist Workers Party in an effort to reach a solution, and the S/WP officers suggested that BLACK go to Mexico and discuss the affair with TROTSKY.

FREEFIELD stated that he and BLACK discussed the advisability of buying a gun for protection and also the action that each would take in the event an attempt was made on the life of BLACK. FREEFIELD stated that BLACK also contemplated suicide as a means of escape from his predicament.

FREEFIELD stated that BLACK deliberately refrained from telling him the names and identities of other members of the Soviet spy ring and the Soviet Agents who were threatening BLACK, inasmuch as BLACK did not want any harm to come to FREEFIELD. FREEFIELD stated that, at BLACK's suggestion, FREEFIELD finally moved out of the apartment and severed all connection with BLACK.

FREEFIELD stated that after FREEFIELD went into the Army he wrote to BLACK, and BLACK replied that FREEFIELD should not keep in contact with him because BLACK feared that FREEFIELD would become involved in the situation and bodily harm would befall FREEFIELD.

FREEFIELD stated that BLACK is not the type who has an overactive imagination or is panicky, and FREEFIELD stated that he believes that the story related above is absolutely true. FREEFIELD stated that BLACK's father was from an old highly-regarded Philadelphia

THOMAS L. BLACK, WAS, ESPIONAGE DASH R. DURING COURSE OF INTERVIEW WITH SUBJECT JULY FOURTEEN LAST, HE SUGGESTED THAT CHARLES M. FREEFIELD AND JACK FASS BE INTERVIEWED IN ORDER TO VERIFY CERTAIN PORTIONS OF HIS STORY. BLACK CLAIMS HE TOLD BOTH OF THESE INDIVIDUALS THAT HE WAS A SOVIET AGENT AND THAT BOTH OF THESE INDIVIDUALS COULD VERIFY THIS IF INTERVIEWED. BOTH CAN BE TOLD THAT THEY ARE BEING INTERVIEWED AT THE DIRECTION OF THE SUBJECT AND IN ORDER TO VERIFY SUBJECT-S STORY. SHORTLY AFTER BLACK-S RELEASE FROM THE HOSPITAL IN THIRTYEIGHT, WHEN HE WAS LIVING WITH CHARLES M. FREEFIELD, HE TOLD FREEFIELD THAT HE WAS A SOVIET AGENT. AT THIS TIME BOTH BLACK AND FREEFIELD WERE MEMBERS OF THE SWP. THE PURPOSE OF TELLING FREEFIELD THAT HE WAS A SOVIET AGENT WAS DUE TO THE FACT THAT BLACK WAS BEING PRESSURED BY HIS SOVIET SUPERIOR TO GO TO MEXICO TO JOIN THE HOUSEHOLD OF TROTSKY. BLACK FELT THAT IN THE EVENT THE SOVIETS CARRIED OUT ANY OF THEIR THREATS AGAINST HIS PERSON AND THAT SHOULD HE DISAPPEAR SOMEONE WOULD KNOW OF THIS AND WOULD BE ABLE TO DIRECT THE AUTHORITIES ALONG THE PROPER CHANNELS. FOR THAT REASON BLACK STATES HE TOLD FREEFIELD THAT HE WAS A SOVIET AGENT. BLACK ALSO STATED THAT FREEFIELD KNOW THAT AT THAT TIME HE WAS CONTEMPLATING SUICIDE AS A MEANS OF ESCAPE. HE STATED REASON FOR REQUEST WAS HE DESIRED CONTENTS, SPECIFICALLY HIS CP, SP, AND SWP MEMBERSHIP BOOKS, OF GREEN, LETTER SIZE, STRONGBOX BROUGHT TO PHILA. FOR HIS USE IN ESTABLISHING DATES AND REFRESHING MEMORY IN FUTURE INTERVIEW. STATED HE DESIRED TO BE INTERVIEWED FURTHER AND WISHED TO MAKE CORRECTIONS AND ADDITIONS TO PREVIOUS STATEMENTS, ALSO TO MAKE STATEMENTS REGARDING THINGS NOT PREVIOUSLY MENTIONED THAT HAD COME TO MIND SINCE LAST INTERVIEW. HE ALSO REQUESTED, REPEATING SEVERAL TIMES, THAT HE NOT BE PICKED UP FOR INTERVIEW MONDAY MORNING UPON HIS RETURN TO PHILA., STATING THAT HE WISHED TO COME TO OFFICE AT HIS CONVIENCE DURING EARLY PART OF WEEK IN THAT HE HAD OBLIGATIONS TO HIS JOB AND THAT HE WANTED TO BE RESTED SO THAT HE COULD THINK CLEARLY IN INTEREST OF TRUTH AND BE ABLE TO ORGANIZE THOUGHTS. SEEMED VERY NERVOUS DURING CONVERSATION, TALKING RAPIDLY, AND CLOSED CONVERSATION ABRUPTLY WHEN OPERATOR ASKED FOR ADDITIONAL COIN. PHILA. ADVISED OF INSTANT CALL BY TELEPHONE.
