Letters Containing Unknown Powder  
Victim - News Corporation

Synopsis: To request the opening of a case to document the investigation of a series of five letters containing an unknown powder substance mailed to the News Corporation at 1211 Ave of the Americas New York, NY.

Details: On 12-02-2008, SA [Redacted] was contacted by the [Redacted] call center and advised that two NYPD Emergency Service Unit Officers(ESU) were approached on the street in front of the News Corporation building located at 1211 Avenue of the Americas in NYC and advised by News Corporation Security personnel that a mailroom employee had stated he had received an envelope in the mail room addressed to Rush Limbaugh that was leaking a white powder substance. Investigators from [Redacted] SA [Redacted] USPS Insp. [Redacted] NYPD Sgt [Redacted] and DEP PD Det. [Redacted] responded to the News Corporation building's receiving area three levels below ground/street level. Upon arrival NYPD ESU and New York City Department of Environmental Protection (NYCDEP) personnel were on scene. The mail room clerk is an employee of the Dynamex company contracted to handle mail and deliveries for News Corporation. The clerk, [Redacted] (DOB [Redacted] of [Redacted] [Redacted] stated he saw a white powder type substance leaking out of an envelope addressed to Rush Limbaugh at approximately 0925

There was also one Holiday Greeting Card that was addressed to Fox News and the inside was blank.

The envelopes were postmarked November 28, 2008 and hand written in all capital letters. The Rush Limbaugh letter was the first letter to be noticed with a powder substance in it. NYC DEP conducted preliminary field screening on site which indicated that the powder had properties that were not hazardous to mail room staff at the News Corporation. NYPD ESU packaged the envelopes and letters for transport to the New York City Department of Health and Mental Hygiene Public Health Lab for testing. Due to the nature and number of mailings, and based on the information contained in this communication, it is requested that a case be opened and assigned to Detective [redacted] and co-case agent SA [redacted]

I called the 800 number shown and was told there are three "membership kits" available for those who want to join the "Draft Committee", the "best" being priced at \$29.95. If I bought it, I would be a member of the Draft Committee and it would then be considered a political contribution and the kit would be considered gratis. The 800 operator said they had been hired to take these phone calls and that the 800 organization was located in Utah.

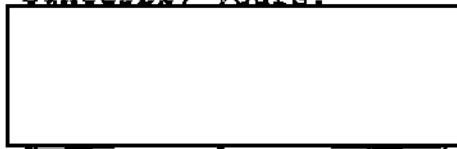
I asked where to send a check and was told that only credit card purchases would be considered. I asked if the Committee had any structured organization in either Maryland or Virginia and was told, after some delay, that there was no organization -- that this was just the effort of the two men named in the fax to "raise money for Rush Limbaugh."

I said the whole thing didn't quite smell right and the 800 operator immediately hung up on me.

You good people no doubt have many other matters to attend to in these troubled times but on the possibility that there are spare moments even for the Bureau I hope you can look into this. After all, 700,000 times \$29.95 is over \$20 million - and Limbaugh has over 5 million listeners daily.

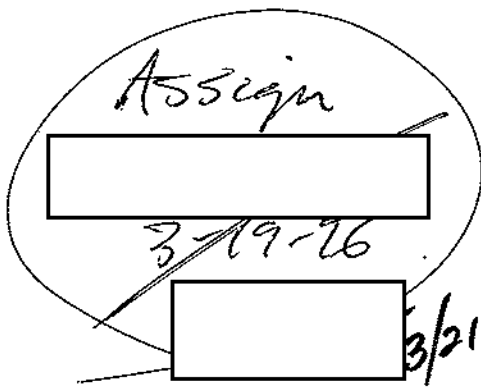

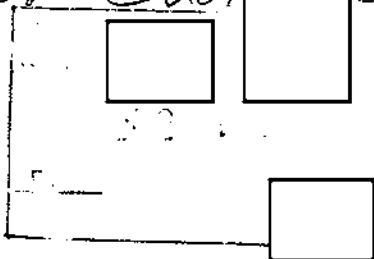

WASHINGTON -- What if they had a Rush room and nobody came?

Something like that happened Friday as two young South Carolina businessmen rented a room at the National Press Club to announce the formation of the National Committee to Draft Rush Limbaugh for President.

Only one reporter showed up.

Rush-for-president enthusiasts, Matt Robinson and Andy Dyer weren't inclined to blame the bias of what Rush might call the Eastern news media elite so much as the legal strictures that surround a presidential draft.

Wanting to scrupulously comply with the legal requirement that a potential candidate have no knowledge of, and no involvement in, a presidential draft campaign, Robinson and Dyer waited until the last minute to publicize their press conference.

It was not until just a few hours before the press conference that they slipped fliers under the doors of National Press Building offices and sent notices out to other news outlets -- including Limbaugh himself, who, Dyer said, "should be receiving his FedExed packet even as we speak."

All told, the two Generation X entrepreneurs -- Dyer, 25, sells corporate aircraft; Robinson, 31, distributes candy -- said they contacted 4,000 media outlets.

For the lone reporter who responded, they demonstrated the Internet home page they've established for the Draft Rush campaign (address: <http://www.dittohq.com>) and showed off their campaign buttons. These feature a logo of the White House with the caption "Ditto.HeadQuarters 1996-2004 A.D."

Dyer and Robinson, both of whom wore official Rush Limbaugh ties for the occasion, insisted they won't need much publicity to energize the conservative talk radio host's legion of fans.

"His radio audience is 20 million," said Dyer. "if even 5 percent respond, that's 1 million petitions."

Dyer and Robinson hope to round up at least 700,000 petitions in favor of a Limbaugh presidential candidacy -- the number they think they'll need to qualify

Time. Most family reunions don't invite reporters, but the GOPAC family - "and we are a family," insisted Palm Beach socialite and GOPAC chief Gay Gaines - invited even the most satanic members of the cultish liberal press to its \$ 125-per person "family" dinner on November 12, presided over by Newt Gingrich and Rush Limbaugh.

The evening was so laden with emotional kitsch I half-expected Michael Lerner to lead Gingrich's "large extended wealthy, white family" in a workshop on surplus powerfulness. In a long, rambling introduction to a long, rambling speech by Limbaugh, the House Speaker publicly admitted, for the first time, that Republicans "cried with each other" over President Clinton's "heart-rending" decision to side with evil against good and thereby shut down the government for what ended up being six days. This decision "troubles my heart," admitted Gingrich, thereby ending liberal media speculation that he was sent here by space aliens on a bet that Americans will take anyone seriously, just so long as he promises to cut taxes and throw the lazy coloreds off welfare.

Guest of honor Limbaugh, who stands astride the entire society ... the man who is creating the twenty-first century," sauntered up to the stage to wild applause around 10 o'clock and then commenced, without notes, to feed blood-red meat to an already well-fed crowd for longer than I could stay awake. Joining him on stage, staring silently and adoringly but without a Linda McCartney-style tambourine, was his third wife, Marta. "This is my team," Limbaugh declared. "I am kept on the right path by all of you," he told the cheering crowd.

Rush is not stupid, but he is remarkably full of crap. Thanks to my comrade Audrey in Berkeley, I get the full transcript of his radio show by e-mail each morning (Tomseaverfaolcom). There is a clear method to Limbaugh's madness. He has one important insight: that the mainstream press is ideologically, emotionally and intellectually indistinguishable from the centrist governing elite. "The media, after all, lives in a world of its own, talking only to themselves, concerned about things that the rest of America isn't. And they have their own candidates. So perhaps the press should just form their own party, and staff it with guys like Sam Nunn, Bill Bradley and Colin Powell," he explains,

in words that would fit quite nicely into these pages. "Clinton will cave, but it won't be reported as a defeat for him. . . . He's thus laying the groundwork so that after he signs the bill he can claim he got the extremism' out of it and stood his ground. In reality, Clinton will have signed pretty much what the Republicans wanted, but he'll still insist he has saved the country and our children's future."

Where Rush goes off purposefully half-cocked is in casting the mainstream consensus as "liberal" thereby kicking the fifty-yard line of political discourse deep into a Dole-fully right-wing region and providing both the far right and the simply unhappy with a common enemy. This is a time-honored tactic on the right, and no less an authority than William Kristol has admitted that it was just a feint to cover the conservatives' lack of ideas. But like Ronald Reagan, it is an obvious ruse whose utility appears no less effective for having been revealed" such. No one brings more gusto to it than Limbaugh. Rush As conservative New Republic editor Andrew Sullivan a "liberal" for the purpose of attacking the President's (singularly) brave defense of affirmative action, which Sullivan opposes. He labels Rupert Murdoch's drooling, rabid poodle of a newspaper, the New York Post, "moderate" and George Bush's politically simpatico tennis partner Brit Hume a "half-liberal." Reaganite neocon Michael Barone is a co-conspirator in the "liberal media." So, of course, is The New York Times, the paper for whom Limbaugh has recently appeared as multimedia pitchman.

Limbaugh lately demonstrated what can only be called an obsession with the newspaper of record when it ran a joint Times/CBS poll noting that Americans prefer a fully funded Medicare program to a balanced budget. The poll, said Limbaugh, was "outrageous . . . embarrassing . . . purposely distorted the truth . . . misrepresented the facts and is part of a very willing attempt to sway public opinion" by "institutions that were once leaders in journalism but which now have fallen into the morass of being the fawning lapdogs of the Democratic Party."

Because the poll undercuts the entire Republican strategy, Limbaugh came back to it day after day. "The American people should be happy and applauding the Republicans for what has happened," he insisted. They aren't because "irresponsible liberals and irresponsible journalists are doing their best to scare and frighten Americans with misinformation and outright lies." He compared the question, rather revealingly Freud might say, to a hypothetical poll that asked whether people would prefer to (1) cure obesity or (2) balance the budget. The obesity cure would win hands down:" he noted with apparent relevance. In fact, The Washington Post reported a meeting back in March in Speaker Gingrich's office in which, as one participant reported, according to the Post's paraphrase, "Everyone understood the perilous circumstances. The G.O.P. had decided to squeeze \$ 270 billion from Medicare to fulfill its promise of a tax cut and balanced budget in seven years, a pledge to which Gingrich had bound his colleagues in February. The odds appeared unfavorable. . . . When a few days later, the Medicare board of directors issued a report noting that its hospital trust fund faced bankruptcy by 2002, Republican Chair Haley Barbour took one look at it and declared, 'This is manna from heaven.'"

Ridiculous, huh?

"They have the elite media; we have Rush," explained Gingrich from the podium. No wonder conservatives are so smart.

Rush claimed, until recently, that "the Sullivan Group in Sacramento" had "documented him to be almost always right, 97.4 percent of the time," in their "official opinion audit." Tom Frangicetto set out to find out just what the hell "the Sullivan Group in Sacramento" was. Since they were not listed, however, he gave up until Rush mentioned Tom Sullivan, his personal accountant, on the air. Frangicetto couldn't reach him, but did describe his troubles in a USA Today column, which Limbaugh later lampooned. (Those obsessed with the Rushin' threat should call Tom Frangicetto at 610-861-5540 to subscribe to his Limbaugh newsletter.) I managed to reach Mr. Sullivan at Everen Securities, formerly Kemper Securities, in Sacramento, by telephone. He confirmed that he was the same Mr. Sullivan who had conducted the audit but declined to make it available. When I asked for information about the Sullivan Group, or any other "opinion audits" they had conducted, responded, "Tell you what, Eric, I am not interested in talking about this with you."

Recently, two South Carolina dittoheads rented out a room of the National Press Club to announce the formation of the National Committee to Draft Rush Limbaugh for President, promising to collect 700,000 signatures. Could a clueless, dissembling right-wing radio announcer who doesn't understand the first thing about the travails of poor and working-class Americans ever be elected President in this country?

Be afraid. Be very afraid.

On February 2, 1995, JAMES J. MAHER, 1402 Christine, Peoria, Illinois 61614, telephone (309) 688-6814, was contacted at his residence. After being made aware of the identities of the interviewing Agents and the nature of the inquiry, MAHER thereafter provided the following information:

MAHER advised that he had a series of telephone conversations with a [redacted] named [redacted] MAHER could not recall specifically the dates on which he spoke with [redacted] but agreed that it was probably sometime in mid-January, 1995. MAHER denied saying that he was going to shoot [redacted] or radio commentator RUSH LIMBAUGH.

MAHER advised that he was smarter than that and more intelligent than that. He advised that he did tell [redacted] that he was a liberal and that he considered communists his enemies and that he had been trained by the UNITED STATES ARMY to kill communists. In MAHER's opinion, he did not know which was worse, extreme right-wing conservatives or extreme left-wing conservatives. In his view, they were about the same.

MAHER advised that it was never his intention to threaten [redacted] or anyone else, and that he would never consider doing physical harm to anyone. MAHER denied owning any type of a weapon or firearm and felt that all weapons and handguns in particular should be banned. MAHER denied experiencing any type of mental health problems, advised he was not under a doctor's care for any type of mental health disorder and expressed the sentiment that he was well educated and possessed a high IQ.
