For the information of Minneapolis, Scotts Bluff County Attorney [redacted] Gering, Nebraska, on 3-22-73, advised SA ROBERT D. KINSEY that on that date Scotts Bluff Associate County Judge JOAN DEE FISHER signed an order that MEANS was to appear in Scotts Bluff County Court on 4-9-73. [redacted] stated FISHER's order further specified that MEANS was to report by 9:00 a.m. on a felony complaint. FISHER also ordered that a copy of her order of 3-22-73 be served personally on MEANS.

The Grand Jury Charges:

COUNT I

On or about February 27, 1973, at Wounded Knee, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly and unlawfully break and enter into the Wounded Knee Trading Post, a building where property was kept, with intent to commit a larceny, in violation of 18 U.S.C. §1153 and S.D.C.L. §22-32-9.

COUNT II

On or about February 27, 1973, at Wounded Knee, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, Russell Means, an Indian, did wilfully, knowingly and unlawfully take and carry away, with intent to steal and purloin, firearms, ammunition, food and other items, the personal property of another, to-wit: the Wounded Knee Trading Post, of a value of more than \$100, in violation of 18 U.S.C. §1153 and §661.

COUNT III

On or about the 8th day of March, 1973, near Wounded Knee, in the District of South Dakota, Russell Means , wilfully, knowingly and unlawfully and by means and use of a dangerous weapon, that is a gun, did forcibly assault Joanne Pierce, a special agent of the Federal Bureau of Investigation of the Department of Justice, while the said officer was engaged in the performance of her official duties, in violation of 18 U.S.C. §111 and §1114.

COUNT IV

On or about the 28th day of February, 1973, at Wounded Knee in the District of South Dakota, Russell Means , did wilfully, knowingly and unlawfully commit an act to obstruct, impede and interfere with U. S. Marshals and agents of the Federal Bureau of Investigation who were then engaged in the lawful performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder obstructed, delayed and adversely affected commerce and the conduct of a federally protected function, in that said defendant did prepare and locate trenches and bunkers at Wounded Knee, which were manned by persons armed with guns, in violation of 18 U.S.C. §231(a) (3)

COUNT V

On or about the 28th day of February, 1973, in the District of South Dakota, **Russell Means** , did wilfully, knowingly and unlawfully commit an act to obstruct, impede and interfere with U. S. Marshals and agents of the Federal Bureau of Investigation, who were then engaged in the lawful performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder obstructed, delayed and adversely affected commerce and the conduct of a federally protected function, in that said defendant did block a road leading into the community of Wounded Knee by placing vehicles across said road to form a roadblock, and did station persons armed with guns at said roadblocks, in violation of 18 U.S.C. §231(a)(3).

COUNT VI

On or about the 28th day of February, 1973, at Wounded Knee, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States, in the District of South Dakota, **Russell Means** , an Indian, did wilfully, knowingly, unlawfully and maliciously, set fire to and burn motor vehicles belonging to the Wounded Knee Trading Post, in violation of 18 U.S.C. §1153 and 18 U.S.C. §81.

COUNT VII

That on or about the 6th day of March, 1973, in the District of South Dakota, **Russell Means** did wilfully, knowingly and unlawfully possess firearms, that is destructive devices commonly known as Molotov Cocktails, which devices had not been registered under the National Firearms Registration and Transfer Record as required by Chapter 53, Title 26, United States Code; in violation of §5861(d) and §5871, United States Code.

COUNT VIII

On or about the 28th day of February, 1973, in Indian country, within the Pine Ridge Indian Reservation, a reservation under the jurisdiction of the United States in the District of South Dakota, **Russell Means**, an Indian, did wilfully, knowingly and unlawfully take and carry away with intent to steal and purloin, a 1970 Dodge automobile, South Dakota license No. 65-1886, the property of another, to-wit: Cleve Gildersleeve, of a value of more than \$100, in violation of 18 U.S.C. §1153 and §661.

COUNT IX

1. Beginning on or about February 28, 1973, and continuing up to the date of the return of this indictment in the State and District of South Dakota and elsewhere, Russell Means, an Indian, and defendant herein, wilfully, knowingly and unlawfully did combine, conspire, confederate and agree with Dennis Banks, Clyde Bellecourt, Pedro Bissonette and Carter Camp, Indians, being coconspirators not named as defendants herein, and with other persons unknown to the Grand Jury, to commit offenses against the United States, that is:

a. To break and enter themselves, and in the company of other Indians, the Wounded Knee Trading Post, a building where property is kept, with intent to steal and purloin the property of another, that is property owned by the Wounded Knee Trading Post located within the Pine Ridge Indian Reservation within Indian country; in violation of 18 U.S.C. §1153 and S.D.C.L. §22-32-9;

b. To take and carry away themselves, and in the company of other Indians, with intent to steal and purloin, guns, ammunition, foodstuffs and other things to the Grand Jury unknown, personal property of another of a value in excess of \$100, that is to say, property owned by the Wounded Knee Trading Post located within the Pine Ridge Indian Reservation and within Indian country, in violation of 18 U.S.C. §1153 and §661.

c. To take and carry away themselves, and in the company of other Indians, with intent to steal and purloin, automobiles and personal property of another of a value in excess of \$100, that is to say, property owned by Indian and non-Indian residents of Wounded Knee located within the Pine Ridge Indian Reservation and within Indian country; in violation of 18 U.S.C. §1153.

d. To commit and attempt to commit acts to obstruct, impede and interfere with firemen, United States Marshals, Special Agents of the Federal Bureau of Investigation and Bureau of Indian Affairs policemen then lawfully engaged in the performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder delayed, obstructed and adversely affected the conduct and performance of federally protected functions and the movement of articles and commodities in commerce; in violation of 18 U.S.C. §231(a)(3);

e. To wilfully and by means and use of dangerous weapons, that is rifles, shotguns and handguns, forcibly assault, resist, oppose, intimidate and interfere with agents of the Federal Bureau of Investigation and United States Marshals engaged in the lawful performance of their official duties; in violation of 18 U.S.C. §111 and §1114;

2. It was a part of the conspiracy that the defendant and his coconspirators, in order to attract public attention to claimed grievances and demands and to seek to obtain concessions from the United States and officers and employees thereof with respect to said grievances and demands, would forcibly take possession of and occupy the Wounded Knee Trading Post in Wounded Knee, South Dakota.

3. It was a further part of said conspiracy that the defendant and his coconspirators would unlawfully obtain and cause to be obtained, firearms, ammunition, foodstuffs, automobiles and other things to the Grand Jury unknown, for use in forcibly preventing agents of the Federal Bureau of Investigation, United States Marshals and other law enforcement officers from freely entering the town of Wounded Knee to carry out their official law enforcement duties and functions.

4. It was a part of said conspiracy that the defendant and his coconspirators would seize and cause to be seized the Sacred Heart Catholic Church in Wounded Knee, South Dakota, to be used for eating and sleeping during the occupation of Wounded Knee, South Dakota.

5. It was a further part of the said conspiracy that the defendant and his coconspirators would seize and cause to be seized homes and house-trailers in the town of Wounded Knee to be used for shelter and eating and for organizing security patrols during the occupation of Wounded Knee, South Dakota.

6. It was a further part of said conspiracy that the defendant and his coconspirators would select and cause to be selected, persons designated as "guards" and did cause such persons to patrol the area surrounding Wounded Knee, South Dakota, for the purpose of resisting and obstructing law enforcement

officers from gaining access to Wounded Knee, South Dakota.

7. It was a further part of said conspiracy that the defendant and his coconspirators did place and cause to be placed, automobiles on the roads leading to and from Wounded Knee, South Dakota, for the purpose of obstructing and impeding law enforcement officers in the performance of their official duties.

8. It was a further part of said conspiracy that the defendant and his coconspirators did dig and cause to be dug trenches and bunkers which could be used for the purpose of directing gun fire at law enforcement officers lawfully engaged in the performance of their official duties.

OVERT ACTS

At the times hereinafter, the defendant and/or his coconspirators committed the following overt acts in furtherance of the conspiracy and to effect the objects thereof:

1. On or about the 27th day of February, 1973, in the State and District of South Dakota, Russell Means drove in a caravan of motor vehicles from Calico, South Dakota, to Wounded Knee, South Dakota.

2. On or about the 27th day of February, 1973, in the State and District of South Dakota, Pedro Bissonette drove in a caravan of motor vehicles from Calico, South Dakota, to Wounded Knee, South Dakota.

3. On or about the 27th day of February, 1973, in the State and District of South Dakota, Russell Means and Pedro Bissonette, and others whose names to the Grand Jury are unknown, prepared a list of demands of the coconspirators to be delivered to officers and employees of the United States.

4. On or about the 28th day of February, 1973, in the State and District of South Dakota, Pedro Bissonette met with Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation.

5. On or about the 28th day of February, 1973, in the State and District of South Dakota, Carter Camp met with Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation.

6. On or about the 28th day of February, 1973, in the State and District of South Dakota, Russell Means delivered to Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation, a list of persons being held by defendant and his coconspirators.

7. On or about the 1st day of March, 1973, in the State and District of South Dakota, Russell Means had a conversation with Joseph H. Trimbach, Special Agent in Charge, Federal Bureau of Investigation.

8. On or about the 28th day of February, 1973, Russell Means, Carter Camp, Clyde Bellecourt, Dennis Banks and Pedro Bissonette constructed and caused to be constructed trenches in and around Wounded Knee, South Dakota.

9. On or about the 28th day of February, 1973, Russell Means, Carter Camp, Clyde Bellecourt, Dennis Banks and Pedro Bissonette, seized and caused to be seized the Sacred Heart Catholic Church in Wounded Knee, South Dakota.

10. On or about the 28th day of February, 1973, Russell Means, Carter Camp, Clyde Bellecourt, Dennis Banks and Pedro Bissonette, broke and entered and caused to be broken and entered, the Wounded Knee Trading Post in Wounded Knee, South Dakota.

SUBJECTS ARE BELIEVED TO HAVE DEPARTED WOUNDED KNEE 3-26-73, IN POSSESSION OF APPROXIMATELY \$6,000 OBTAINED EARLIER IN A POST OFFICE BURGLARY. IN VIEW OF THE INFORMATION THAT SUBJECTS ARE BELIEVED TO BE HEADING FOR CUBA, ALTHOUGH THERE IS NO INFORMATION AVAILABLE INDICATING THEY PLAN TO HIJACK AN AIRCRAFT, THIS IS A DISTINCT POSSIBILITY. the contact was to ascertain what he should do about his

tion like dirt. He himself protested against arrest of
Indians for public drunkenness since there was some conflict
between tribal laws and state laws. This resentment result-

session of the reservation jail and releasing the prisoners.
He advised that two hours after the take over was affected,
RON PETIT, a leader of the American Indian Movement (AIM),

arrived at the scene with [redacted] (ph) of the U.S. Department of Justice. He advised that prior to the take over this action had been discussed with PETIT, DENNIS BANKS (a Chippewa), RUSSELL MEANS (a Sioux) and CLYDE BELLCOURT (an Oglala Sioux), all leaders of AIM. Before the arrival of PETIT the take over was without violence and a mere protest over conditions at Ft. Totten but PETIT, on getting into the jail, said "make it a take over, lock the windows and chain the doors" and this helped make the confrontation one with violence ensuing. He advised that PETIT knew of the original reason and aim for the take over, but ignored these basic demands and started to speak about money from the U.S. Government. The protest finally ended and PETIT left the reservation.

He went on to state that after the Ft. Totten incident, he went to Cass Lake, Minnesota where there was a major confrontation with authorities and Indians. He stated there were about 1500 Indian men at that location and most were armed with automatic rifles; shotguns and two had some type of machine guns, most of which weapons were furnished by the leaders of AIM. He pointed out that, to the best of his knowledge, the armament used in AIM demonstrations is carried in a maroon colored four-door 1962 Buick, which bears an unknown Minnesota license. The car is reported to be out of Minneapolis, Minnesota, where AIM headquarters is located and he did not know the registered owner. He also stated that anyone in the AIM movement drives the car and he is sure it is always loaded with arms of all types.

[redacted] pointed out that he first met BANKS, MEANS, BELLCOURT and PETIT when he went to Washington, D.C. to call to the attention of the Bureau of Indian Affairs (BIA) documentation that [redacted] was defrauding the U.S. Government. He stated that he was only laughed at when the documents were reviewed at BIA. At this point the four AIM leaders pointed out to him that if change was needed it should be taken care of by a take over of the Ft. Totten Jail and this implanted the seed of that operation in his mind.

At this time, PETIT swore him into AIM and he received his membership card from BANKS, and was advised that he was being made a National Director of AIM. He stated that

he still has one close connection in the AIM headquarters in Minneapolis and furnished to the interviewing agent the card given to him by BANKS. He stated that he can learn about all the plans of AIM and BANKS and his associates through contact with his friend, whose name he did not wish to reveal, at AIM headquarters.

He pointed out that due to his close association with BANKS and the other AIM leaders, he knew about the Wounded Knee take over about three weeks prior to it actually taking place.

[redacted] advised that AIM has a ten-man task force, each of which is paid \$1,000. per month. These ten are all people with criminal records who have served time in various penal institutions and they were the first ten men into the BIA in Washington, D.C. when that location was sacked. They are all from Milwaukee, Wisconsin, and while he met all ten at Cass Lake, he can not recall their names and probably would not recognize them again if he met them. He stated that when he first made contact with BANKS he wanted him to join the Task Force and said "all you have to do for \$1,000. per month is sit and wait until we need you and then you move fast." However he declined to participate in the task force even though he was involved in Ft. Totten, Cass Lake and at the take over of a Federal military building at Minneapolis.

He advised that his U.S. Probation Officer [redacted] in North Dakota had given him permission to come to Western Washington. SA MANNING notified [redacted] U.S. Probation Officer, Tacoma, Washington that [redacted] was in contact with FBI and [redacted] asked that [redacted] advise him by letter of his address in Washington. [redacted] was to notify [redacted]

[redacted] said he was completely disillusioned with the leaders of AIM who were interested only in their own personal gain and not in the welfare of Indians. He pointed out that the financing of AIM is achieved by contributions from all sorts of people and church groups which send large numbers of checks to AIM in Minneapolis. He also pointed out that the documents which prove that [redacted] has defrauded the United States over a number of years of a large sum of money are in the possession of his, [redacted] on the Ft. Totten reservation. He also pointed out that when BANKS was

at Ft. Totten, he was seeking money and he observed [redacted] give BANKS \$500. to leave the reservation. He also pointed out that due to his efforts to unseat [redacted] he is no longer tribal chairman at Ft. Totten.

At this point, [redacted] advised that while he was at Cass Lake, in the company of BANKS, he heard BANKS on the telephone ask the operator for the number of the FBI in Washington, D.C. When this number was given BANKS he then placed a call to someone, allegedly at FBIHQ (this person's name was heard but not remembered) and when the conversation was finished BANKS told him and others "no problem at Cass Lake for the FBI will not be here." He also stated that, to the best of his knowledge, he and ten other Indians were secretly indicted by a Federal Grand Jury at Fargo, No. Dakota, for their Ft. Totten activities but on the day he was arrested BANKS called him that morning and told him to get the others together for they would be arrested about 11:00 AM and almost on the hour, the FBI arrested him with the ten other co-conspirators. [redacted] stated he feels that BANKS has connections in high places which get information to him.

[redacted] continued that a number of Indians (AIM members and non-members) have become disillusioned with the AIM leaders and he feels they have alienated a number of people and actually have no other place where they can cause any type of problem. He said that one person he knows who will some day take action against all or some of the AIM leaders is an Indian in Milwaukee named [redacted] at times becomes violent and irresponsible.

[redacted] stated that if his furnishing information to the FBI should become known he would not live long and requested that his identity be protected completely with no information revealed which could compromise him.

He pointed out that there is an AIM chapter in practically every Indian tribe, with each having its own president and recruiting is continuing. He stated he was the president of the chapter at Ft. Totten but that group has now pulled away from AIM in view of the activities of the leaders of AIM. However, while he is no longer an active AIM member, he still has close connections on the administrative level and is sure he can secure any information available

on the future objectives and plans of the movement and can get back into the movement on an active basis since the leaders have come to accept and trust him.

[redacted] advised he will contact his source at AIM headquarters on 3-30-73 and arrangements were made to meet with him on 3-31-73. He further advised that any information he receives will be furnished to the FBI immediately. [redacted]

[redacted] South Dakota, was interviewed and advised of the identity of the interviewing agent and as to the nature of the interview.

[redacted] was furnished an Interrogation; Advice of Rights Form, which he read and was read orally to him by the interviewing agent. [redacted] advised that he understood his rights and executed the form by signing it.

[redacted] advised that he has resided at [redacted] since 1929, and he is totally familiar with the surrounding area.

[redacted] indicated that there are approximately 200-300 individuals participating in the take over of Wounded Knee, the majority of people being Indians. He stated that the majority of the Indians have weapons, mostly being shotguns and rifles of unknown caliber. [redacted] indicated many of the resident people in Wounded Knee are not participating with the American Indian Movement (AIM) member and their followers in the take over of the town. He further advised that he does not know any of the individuals by name who are participating, other than RUSSELL MEANS and DENNIS DANKS.

[redacted] stated that he is not allowed to enter Wounded Knee and resides in the house located between road blocks of the Indians and Federal Agents. Therefore, he is not familiar with much of the fortification inside the town.

[redacted] drew a map of the surrounding area, indicating location of road blocks by the Indians and additional information concerning bunkers and two buildings located in the town, which appear to be AIM Headquarters. These buildings are the Catholic Church which is currently completely surrounded by bunkers and the trading post directly across the street, which appears to be the meeting hall. [redacted] also indicated that the Indian families living outside the town and currently having problems of obtaining food since they are not allowed to enter Wounded Knee due to the fact that the AIM members issue passes to enter the town. Because of this, many families are leaving the Wounded Knee area in order to obtain groceries, and when a family moves from its home, the home is taken by AIM followers.

He also said that [redacted] (phonetic), Indian, is head of maintenance at Wounded Knee. The Indian who was head of the Frank's Landing Protest outside of Olympia, Washington, is at Wounded Knee with about ten men, however, they are not happy and may leave. These individuals have engaged in other protests, but to his knowledge, have never carried guns.

He said dynamite is stored at the rear of the museum and ammunition and guns are stored there also. More dynamite

is stored in the largest of three houses behind the Teepee Church. He heard that Negroes are coming in from San Francisco. He said alot of the security people sleep in the loft of the big church. He said a man from San Jose, California, who is a reporter for the Indian Police Magazine has been going around taking a lot of interviews, and that tape may contain very valuable information.

He said the main headquarters for the inner core is a house across the street from the trading post. He described the house as being small, white, with a fence around it. He said the bunkers communicate with the museum, which also serves as a security building by walkie-talkie.

He said last night three individuals were brought into the jail. One of these individuals considers himself a medicine man, and is from Oklahoma. The medicine man told him that a Russian reporter was in Wounded Knee and intends to go back to Moscow shortly. The medicine man told him also that a number of the Bureau of Indian Affairs (BIA) police will defect to Wounded Knee shortly.

He said a lot of the Indians who are at Wounded Knee have come in from different parts of the Country and tend to stick together in small groups. He heard shortly before he walked out that the leadership intended to split these groups up.

[redacted] Montana, was interviewed at roadblock one as he exited Wounded Knee.

[redacted] advised he came to Wounded Knee on March 8, 1973, from Missoula, Montana, via Frontier Airlines. He wanted to assist relatives in leaving Wounded Knee.

[redacted] entered Wounded Knee at approximately 2:30 PM to 3:00 PM. He said he was stopped at the AIM roadblock by two male Indians. He said these persons never mentioned their names. Both of these guards were armed--one had a .308 caliber rifle with a four power scope, and the other had a .22 caliber rifle. [redacted] said he could not further describe these persons except that they were young, perhaps 17 to 20 years old. [redacted] said he might possibly be able to identify them if he were to see their photographs.

[redacted] also advised he saw a male Indian driving a Volkswagen bus with straw stuck on it for camouflage. This person, according to [redacted] was carrying an old musket.

[redacted] stated that after being stopped at the AIM roadblock, he was told he had to wait to get clearance from RUSSELL HEANS before entering Wounded Knee. Shortly thereafter, [redacted] said he was directed to the front of the store. At the store, [redacted] stated he saw two female Indians and three male Indians. One of the female Indians had a walkie-talkie and was called SARAH by the others.

[redacted] advised he loaded the truck which he drove into Wounded Knee and left the town.

[redacted] was shown a display of photographs of persons arrested at Custer, South Dakota, during disturbances in that town. [redacted] said he believed he saw [redacted] sitting near the store, however, he said he could not be sure.

[redacted] advised he thinks he could identify the people who stopped him as he entered Wounded Knee, South Dakota.

On March 7, 1973, a call came for several ministers to go to Wounded Knee, South Dakota, for the purpose of removing sick people and children from the community.

According to [redacted] 3 or 4 P.M., March 7, 1973, [redacted] who is associated with the Pine Ridge Episcopal Church, and [redacted] drove to Wounded Knee in two cars.

Upon arriving at Wounded Knee, [redacted] parked at the Trading Post where a number of sick persons were picked up. The group then went to the Wounded Knee housing addition where more persons were picked up.

A U-Haul Van, orange and cream in color, which was covered with mud, driven by members of the American Indian Movement (AIM), led the group to a point about 200 yards north of where a roadblock was located on the road between Wounded Knee and Highway 19. The U-Haul Van was then turned around and parked. [redacted] group continued on through the roadblock.

While [redacted] was parked at the Trading Post, RUSSELL MEANS entered the van and pulled several of the young girls "chickens".

[redacted] observed 20 or 25 persons carrying rifles and/or hand guns.

[redacted] could not identify any of the persons other than RUSSELL MEANS.

[redacted] Kansas, was contacted by Special Agent [redacted] at the Pine Ridge Police Department. She was advised of the identity of Special Agent [redacted] and informed that he desired to interview her regarding the takeover of Wounded Knee by the American Indian Movement (AIM) on Tuesday, February 27, 1973, and what had transpired since that date. At this point she was orally advised of her constitutional rights by Special Agent [redacted]. She was then furnished an "Interrogation; Advice of Rights" form which she read and stated she understood. She said she was willing to be interviewed and signed the "Waiver of Rights" portion of the above-named form. [redacted] thereafter advised as follows:

She is originally from Pine Ridge and is an enrolled member of the Oglala Sioux Tribe, Pine Ridge Indian Reservation, Pine Ridge, South Dakota. She returned to Pine Ridge on February 15, 1973, to visit her [redacted] at Pine Ridge. On February 27, 1973, she [redacted] called with [redacted] [redacted] believed to be an AIM member, and several others whose names she does not recall at this time, to allegedly attend a meeting at Wounded Knee. She recalled this meeting was to be presided over by DENNIS BANKS and RUSSELL MEANS. She emphatically denied being a member, sympathizer, or supporter of the AIM movement and stated her only reason for attending the meeting was strictly out of curiosity. She advised there was a large group of Indians in cars that were to drive to Wounded Knee to attend this meeting.

Instead of going to Wounded Knee, they wound up in Wounded Knee and for what reason, she does not know. She said that after arriving in Wounded Knee on Tuesday, February 27, 1973, a number of members in the group broke into the Trading Post at Wounded Knee and eventually the town was taken over by the group, which was led by DENNIS BANKS and RUSSELL MEANS.

At this point, [redacted] identified the leaders of the AIM group at Wounded Knee as DENNIS BANKS, RUSSELL MEANS, CARTER CAMP, and first name unknown CROW DOG. She said that CROW DOG is supposed to be a medicine man.

She wanted to leave Wounded Knee from the beginning of the takeover, as did several other persons from the Pine Ridge area. She stated, however, that after the arrest of a large number of the Indians in connection with the break-in of the Wounded Knee Trading Post, they were afraid they would be arrested when they came out of Wounded Knee. They were also afraid to leave as the members of AIM were around with rifles and pistols, and they thought they might be shot if they tried to leave.

[redacted] remained in Wounded Knee until her fiancée, [redacted] came in and got her out on the afternoon of March 7, 1973.

During the time she was in Wounded Knee, she helped cook at the church for the group, which varied in number from 200 to possibly 400 persons. She said that several other girls and women helped with the cooking and the women and children stayed in the church at night.

In addition to persons already named as being associated with the AIM movement, [redacted] identified several persons by name as being members, sympathizers, or supporters of AIM, who are presently in Wounded Knee. These persons are from the Pine Ridge area and are as follows:

She advised that one male Indian known only to her as "ANGEL" was a real crazy, nutty character. She said he was armed with a rifle and was driving the 1959 red and white Chevrolet when it was firing at the positions occupied by the Federal troops. She said "ANGEL" tried to act brave, however, she and others felt that he was not being brave, but just acting crazy.

[redacted] advised she would estimate that there are currently 300 people at Wounded Knee who are AIM members, sympathizers, or supporters. She advised that many of them are "outsiders" and she does not know the names of these people.

She said that as far as weapons are concerned, she observed many persons with rifles and stated that DENNIS BANKS and [redacted] last name unknown, a male Mexican, carried pistols. She advised that [redacted] also carried a rifle, but she does not recall seeing BANKS carry a rifle. She estimated that 75 to 100 persons at Wounded Knee are armed with rifles and possibly shotguns.

[redacted] stated that the more militant of the members are broken down into squads, varying in strength from five to twelve members. She advised each squad has a squad leader and the squads are assigned duties, as occupying the bunkers on a shift basis. She advised that one of the demands being made by the AIM group is that they be allowed to take over the operation and control of the Bureau of Indian Affairs (BIA) at the Pine Ridge Indian Reservation. She advised they have also asked for the ouster of the Tribal President, RICHARD WILSON. [redacted] is of the opinion that if the Government sends personnel into Wounded Knee to arrest members of AIM, that the AIM group will stand and fight. She said they will not throw down their arms until their demands are met.

[redacted] RUSSELL MEANS, advised that RUSSELL MEANS is very interested in the present state of the petition that was delivered to STAN LYMAN, Superintendent of the Bureau of Indian Affairs, Pine Ridge, calling for the suspension of the present constitution and existing government. It is her understanding that if this petition is accepted as legal, RUSSELL MEANS will lay down his arms and surrender to Federal Agents.

[redacted] stated that RICHARD WILSON is planning to take to court undercharges of fraud those individuals who presented the petition to LYMAN. Those individuals are herself, [redacted] She said it is her understanding that WILSON has until April 2, 1973, fifteen days after the petition was presented to contest the petition. She understands that RUSSELL MEANS intends to hold out until that day believing that this petition will solve their grievances against the local government. She also said that she understands that by April 2, 1973, the petition will go into effect.

She said that RUSSELL MEANS told her that the real enemy here is not the Federal Agents but RICHARD WILSON and his men. She said if the people of Wounded Knee lay down their arms they fear reprisals on the part of WILSON and his men. She said she heard that WILSON has put a \$500.00 bounty on RUSSELL MEANS's braids.

[redacted] said that beginning on Sunday March 25, 1973, through Wednesday March 28, 1973, her group called Better Government intends to hold a series of meetings in order to explain to the people the provisions of the petition and to enlist their support behind the petition. These meetings will be held at the following times at the following places:

Sunday March 25, 1973, at 10:00 a.m., a meeting at Calico Hall for the people of Pine Ridge, Oglaala, Calico and SA.

ON 4/9/73, A SOURCE WHO HAS PROVIDED RELIABLE INFORMATION IN THE PAST ADVISED A GROUP CALLED THE D.C. WOUNDED KNEE DEFENSE COMMITTEE HELD A MEETING AT ST. STEPHEN AND THE INCARNATION CHURCH, 16TH AND NEWTON STREETS, N.W., WASHINGTON, D.C. (WDC).

SOURCE ADVISED THE MEETING WAS ATTENDED BY ABOUT 100 PERSONS, OF WHICH APPROXIMATELY 10 WERE INDIANS, APPROXIMATELY 10 BLACKS AND THE REMAINDER WHITE. THE MEETING STARTED AT 2:30 P.M. AND LASTED UNTIL ABOUT 4:45.

WHO CLAIMS AFFILIATION WITH THE NATIONAL OFFICE OF THE AMERICAN INDIAN MOVEMENT (AIM) AND A [REDACTED] OF THE VALLEY GREEN DEFENSE COMMITTEE (VGDC). THE VGDC IS A LOCAL CIVIC ORGANIZATION PRIMARILY CONCERNED WITH THE WELFARE OF RESIDENTS IN THE VALLEY GREEN SECTION OF WDC.

MAIN SPEAKERS WERE RUSSELL MEANS, A NATIONAL AIM LEADER; AN INDIVIDUAL WHO WAS IDENTIFIED AS AN INDIAN SPIRITUAL LEADER; AND AN UNIDENTIFIED FEMALE, WHO WAS DESCRIBED AS THE SECRETARY OF AIM.

SOURCE ADVISED MEANS WAS THE MAIN SPEAKER AND SPOKE IN GENERAL OF THE SEIGE OF WOUNDED KNEE. MEANS REPORTEDLY STATED AIM WAS NOT HONORING THE AGREEMENT SIGNED ON 4/5/73, BETWEEN THE DISSIDENT INDIANS AND THE UNITED STATES GOVERNMENT BECAUSE THE GOVERNMENT HAS SINCE INTERPRETED SOME OF THE POINTS IN THE TREATY DIFFERENTLY FROM THE INDIANS. MEANS ALSO WAS VERY CRITICAL OF THE PRESS CLAIMING THEY DID NOT GIVE THE PEOPLE AN ACCURATE ACCOUNT OF THE HAPPENINGS AT WOUNDED KNEE. MEANS ALSO CLAIMED THAT A UNITED STATES MARSHAL, NOT AN INDIAN, SHOT THE FEDERAL BUREAU OF INVESTIGATION AGENT AT WOUNDED KNEE AND THAT THE UNITED STATES MARSHAL, WHO WAS SHOT, WAS DONE SO BY A NON-INDIAN. MEANS STATED HE PLANS TO RETURN TO WOUNDED KNEE ON 4/10/73.

SOURCE ADVISED A COLLECTION WAS TAKEN, SUPPOSEDLY TO HELP SUPPLY FOOD AND MEDICAL SUPPLIES FOR THOSE AT WOUNDED KNEE. THE AMOUNT OF MONEY COLLECTED WAS NOT DETERMINED. THE MEETING ENDED WITHOUT INCIDENT.

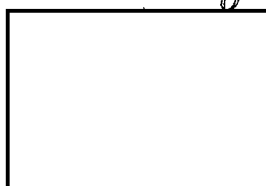

SOURCE ADVISED THAT HE HAS DETERMINED NO INFORMATION THAT ANY SORT OF AIM ACTIVITY IS SCHEDULED IN WDC, OTHER THAN THE ABOVE, WITH RESPECT TO AIM'S QUOTE RETURN TO BUREAU OF INDIAN AFFAIRS (BIA) BUILDING DURING THE CHERRY BLOSSOM FESTIVAL UNQUOTE. THE FESTIVAL IS SCHEDULED FOR WEEK END OF 4/7 AND 4/8/73.

ROUBIDEAUX DID ADVISE SOURCE THAT MEANS AND POSSIBLY BANKS WILL APPEAR BEFORE QUOTE INTERIOR AND INSULAR AFFAIRS UNQUOTE CONGRESSIONAL HEARING; HOWEVER, ONLY MEANS IS OUT ON BOND AT THIS TIME. NO DATE WAS-SPECIFIED, BUT INDICATED TO BE PROBABLY EARLY NEXT WEEK. ROUBIDEAUX STATED THAT MEANS AND BANKS AND BEEN INVITED TO APPEAR BEFORE THESE HEARINGS.

[redacted] Montana was stopped at a road block as she was leaving Wounded Knee, South Dakota. She was advised of the identity of the interviewing Agent, the purpose of the interview and was provided with a copy of an advice of rights form which she executed by signing.

[redacted] advised that she and [redacted] traveled to Billings, Montana on or about March 3, 1973, and to Pine Ridge, South Dakota, around March 6, 1973. They stayed with Mrs. [redacted] at Pine Ridge for a few days and later when the road blocks to Wounded Knee were lifted around March 8, 1973, Mrs. [redacted] and she went to Wounded Knee.

[redacted] stated she stayed at a residence in Wounded Knee abandoned by its owners with four Oglala Indian males. [redacted] claimed she did not know their names nor the names of any other Indians at Wounded Knee.

[redacted] further claimed she did not associate with the American Indian Movement (AIM) Indians or attend their meetings but knows RUSSELL MEANS by sight. [redacted] stated she saw Indians with weapons and was frightened during the shooting, and wanted to come out of Wounded Knee sometime ago but was afraid of being arrested.

[redacted] provided no information regarding AIM's intentions, identity of AIM members or their fire power potential.

On March 24, 1973, [redacted] date of birth [redacted], was interviewed at Roadblock (RD) 1, which is outside of Wounded Knee, South Dakota, by Special Agent [redacted]

Prior to the interview, Special Agent [redacted] identified himself as a Special Agent of the Federal Bureau of Investigation by display of credentials and also advised [redacted] of certain rights as outlined in form FD-395, Interrogation; Advice of Rights. [redacted] advised she would not sign the waiver of rights on that form; however, she was willing to answer questions.

[redacted] stated she is a resident of [redacted] South Dakota, and is an Oglala Sioux Indian. She advised she went into Wounded Knee on or about March 12, 1973, when the Federal Roadblocks had been lifted. She advised she had gone in just to see what was going on, and while she was in there the Roadblocks were closed again and she was afraid to come out for fear she might be arrested.

[redacted] stated she stayed in an empty house in the Wounded Knee Housing Project and was given food by someone who she did not know and does not know if he is associated with the American Indian Movement (AIM) or not. [redacted] advised she did not work for AIM while in Wounded Knee, but was sick in bed the entire two weeks she was there and saw no one with guns and could not identify anyone who was in Wounded Knee at that time. [redacted] advised she did not attend any meetings, she did not see RUSSELL MEANS, CARTER CAMP, PEDRO BISSCHETTE, or any AIM leaders. She stated the only reason she had left Wounded Knee was so that she could go to the hospital, and further advised she would rather take her chances in Wounded Knee than with DICK WILSON, the Tribal Chairman.

At this time [redacted] advised she had no further statement to make and the interview was terminated.

[redacted] commonly known as [redacted] advised that they would like to be jointly interviewed and then furnished the following information:

They represent radio station KWYR and the Winner Advocate newspaper, Winner, South Dakota. At approximately 11:00 A. M. on March 24, 1973, they were issued press passes at Command Post for entrance into Wounded Knee. They arrived at an American Indian Movement (AIM) roadblock manned by one Indian male approximately 20 years of age carrying a rifle, caliber unknown. They described the roadblock as consisting of two burned pickup trucks and trench or block emplacement consisting of what appeared to be sand bags and cinder blocks. The location of the AIM blockade was approximately three quarters of a mile from the blockade manned by federal Agents.

The Indian male manning the blockade asked to see press credentials which he was shown. He advised [redacted] and [redacted] that they should proceed to security where they would receive further instructions. They then drove to an area described as directly in front of the trading post, parking their car directly in front of and across the street from the trading post. While removing their equipment from the car and during the period of time they were outside the trading post they observed approximately 20 to 25 persons on the street stating most were in their early 20's. They indicated that in this group approximately six to eight carried rifles which appeared to be either 30.30's or 30.06's.

They entered unescorted the trading post where after several minutes they asked a white female, not further described, how to find security, receiving no answer. While in the trading post they observed approximately 40 individuals mostly in their late teens and mid to late 20's gathered in a corner where most of the occupants were viewing a television screen which was showing tracer fire and what [redacted] described as possible flares. They stated there was not much conversation but what appeared to be laughter and joking concerning what they were viewing. They indicated in this

group was RUSSELL MEANS; however, they were unable to identify any other individual in the room.

While in the trading post they stated that they noticed approximately six Indians with rifles. After wandering around in the trading post which they described as being very unorganized and disoriented they were approached by an unidentified individual who asked them what they were doing. They advised this unidentified individual they were looking for security and were taken next door to what used to be the Wounded Knee Museum.

As they were leaving the trading post going to the museum they noticed an Indian male draining the gas from their car. They stated that they yelled at the Indian to leave enough gas in the car for them to get out which he indicated he would.

After entering the museum they observed approximately eight people consisting of Indians, Chicanos, and one white male. They stated all people in the museum were armed with rifles which appeared to them to be hunting weapons but were unable to furnish the caliber but did state none of the weapons seen were of an automatic nature. They stated that while in the museum they were asked for identification and searched.

They indicated that while in the museum a male Chicano appeared to be the spokesman. They identified this individual as a Mexican in his mid 20's, approximately 5' 10" in height, heavyset weighing approximately 180 pounds, with kinky hair, wearing an Army field jacket, Army pants, with a Mexican flag sewn to the sleeve. They stated that the Chicano indicated that they would not be allowed to remain in Wounded Knee because they represented the local news media and the only people they were interested in talking to were those individuals representing the national news media. They both indicated there seemed to be some confusion as to whether they should order them out of town right away prior to talking to an individual they called THOMAS, making the statement that they must remember that the Oglalas also had a security force.

While inside the museum they observed what appeared to be a two-way radio, overhearing a transmission indicating

the person transmitting was transmitting from Pine Ridge, South Dakota. This individual transmitting was admonished by one of the individuals in the museum not to use the terminology Pine Ridge over the air.

They indicated after a short time the one Chicano and two Indians met for a short pow wow and then escorted them back to the trading post where they met the individual named THOMAS. They indicated that the Chicano and two Indians left them unattended while they had a pow wow. Shortly after this meeting THOMAS, the Chicano, and the two Indians left the building leaving both [redacted] standing inside. Both [redacted] then walked outside asking THOMAS whether or not they would be allowed to stay in Wounded Knee and were told they could not. They were then ordered into their car, told they had two minutes to leave Wounded Knee and were escorted by a blue panel truck containing the two Chicanos and two Indians to the AIM roadblock. Mr. [redacted] indicated that he took a photograph of the blockade from the car with his camera and that they were immediately stopped by the blue panel truck where they were approached by the Chicano whom he had met at security headquarters and all film in the camera was confiscated. They both indicated that during the time they were in Wounded Knee they were treated congenially and were not physically abused.

While in Wounded Knee they indicated that in the downtown area they observed approximately eight to fifteen cars in the area of the trading post and the museum. They stated that in the area of the church there was no activity but did observe a red pickup truck that may have been inoperative and a blue Ford sedan. They further advised that the three houses and trailer in the vicinity of the trading post and museum did not reveal any activity. They did notice around the church what appeared to be three trenches or dugouts on the outside. They indicated the whole time in Wounded Knee they had observed between 75 to 80 individuals with approximately 25 weapons.

They described the inside of the trading post as being partitioned off with what appeared to be offices located to the left of the main entrance with all the people therein contained in the area to the right of the main entrance which they stated was approximately forty feet by forty feet. They could not remember the number of windows; however, did state that the windows were not barricaded. It was their observation

while in the trading post that the people therein were bored and reading comic books and seemed very unconcerned about the whole matter.

They described the inside of the museum which was designated as headquarters for security as being a room approximately twenty-five feet by forty feet containing two desks and a bar containing a mimeograph machine which was being operated by a whitehappy-type male. They again reiterated that all individuals consisting of approximately eight persons were armed, some having ammunition clips which he stated in total would amount to approximately fifty rounds. They stated that these windows also were not barricaded in this building.

It was their observation that the people in the village were only concerned with national news coverage, were very unorganized, and not well supplied, and in a mass state of confusion.

They did not observe in any quantities any medical supplies or food.

Asked of the ages of the people observed, they both stated that they could not recall seeing any small children, did see one elderly man in the trading post, the rest being in their late teens or mid 20's. They did not observe any Negroes nor many females.

They described the individual introduced as THOMAS as an Indian male in his late 20's, approximately 5' 6", weighing 135 to 140 pounds, long hair, black jacket, levis, clean smooth face, very congenial.

They were shown a group of photographs and identified the following individuals as those possibly seen while they were in Wounded Knee.

ETHEL MERRIVAL, date of birth May 7, 1906, Pine Ridge, South Dakota, telephone number 867-5365, telephonically contacted Special Agent [redacted] at the Bureau of Indian Affairs Office, Pine Ridge, and furnished the following information in a somewhat disjointed conversation. ETHEL appeared to be under the influence of alcohol but was able to furnish the following pertinent information:

ETHEL MERRIVAL called initially to inquire whether or not DICK WILSON had formed a committee of 20 Indians to repulse the AIM members gathered at Rosebud. She stated she also called because she was concerned about the drunken Indians with rifles.

ETHEL stated she was in Wounded Knee last Sunday for only a couple of hours. She stated that while in Wounded Knee, she saw RUSSELL MEANS, PEDRO BISSONETTE, and DENNIS BANKS. She advised she did not see any weapons on the above mentioned individuals. She stated BISSONETTE is her cousin and RUSSELL MEANS in a distant relative to her. ETHEL stated she saw only one Indian carrying a weapon but did not know his name.

ETHEL MERRIVAL was asked by Agent [redacted] if she knew who shot Special Agent CURTIS FITZGERALD. She advised she did not and did not think she could find out from her friends. She stated she knew it was against the law to hold back information, but again stated she did not know who shot Agent FITZGERALD and was doubtful if she could find out.

[redacted] South Dakota, was interviewed regarding her knowledge of the Indian situation at Wounded Knee. She was advised of the identity of the interviewing Agents and their purpose. She was advised of her rights per Miranda which she stated she understood but refused to sign the waiver of rights form.

[redacted] stated that she went into the Reservation on March 12, 1973, with her mother by way of Denby Road while the road blocks were down. She stated that shortly after she went into the Reservation she saw the road blocks being put back up.

[redacted] stated that she and her mother stayed with [redacted] who lives on the outside of the village.

She said that the reason she and her mother entered Wounded Knee was to locate her [redacted] who supposedly had gone into Wounded Knee. [redacted] stated they did not find [redacted] in there and when they started to leave they heard they would be arrested or have a choice of returning to Wounded Knee so they decided to stay.

[redacted] stated while she was in Wounded Knee she usually stayed at the home of [redacted] except for attending five to six meetings which were held nightly. She stated she participated in nothing else while in Wounded Knee. She stated that RUSSELL MEANS and DENNIS BANKS did most of the talking at the meetings and the meetings generally encompassed the state of the village as far as food and the welfare of the people in the village. [redacted] stated there was anywhere from 100 to 200 people at these meetings and most were women and children due to the fact the men were out on guard and carrying out other details in the village.

She stated that RUSSELL MEANS had 100 percent support from the people in the village and there was no arguing or bickering between the people concerning whether the situation there was right or wrong. She stated that last night at the meeting they read telegrams which were received from England, Germany, China, Canada, Australia and a number of cities in the United States supporting their movement.

[] stated that she felt what was happening was one way to attract attention of what the Indians wanted which were the things the Government promised in their treaties and never lived up to. She said she did not feel the people in the village would give up.

[] stated there were a number of Chicanos approximately 18, and whites in the village who wanted to come out and start fighting but RUSSELL MEANS told them if they started shooting he would kick them out.

MEANS allows no drugs or drinking in town and stated if he caught anyone using drugs or drinking that he would let him face the whiteman himself.

[] stated that [] in the village called out and arranged clearance for her []

She stated she did not know how many weapons were in the village or what kind they were or where the weapons and ammunition was kept.

[redacted] was advised of the Miranda warning by Special Agent [redacted] [redacted] was interviewed and furnished the following information:

[redacted] stated he was coming out of Wounded Knee because his [redacted] was very ill and he was taking her to the hospital. Also he said they were very low on food.

[redacted] said he was not a supporter of the American Indian Movement (AIM) nor did he know or have any association with BUSSELL MEANS or DENNIS BANKS. [redacted] said he stayed in his house all the time and had no knowledge of any of the activities of the AIM group. [redacted] could provide no information regarding the strength of AIM, weapons, food, or activities.

[redacted] was advised that if he left Wounded Knee, he would not be allowed to return.

The undersigned complainant being duly sworn states:

That on or about February 27, 1973, through March 10, 1973, at or near Wounded Knee, in the District of South Dakota, Dennis Banks, Russell Means, Clyde Bellecourt, Pedro Bissonette and Carter Camp, did willfully commit and attempt to commit an act to obstruct, impede and interfere with federal law enforcement officials engaged in the lawful performance of their official duties incident to and during the commission of a civil disorder at Wounded Knee, S.D., which civil disorder obstructed, delayed and adversely affected commerce and the conduct and performance of federally protected functions including the investigation of federal crime violations, the enforcement of federal criminal statutes and the collection and distribution of the United States Mail, all in violation of 18 U.S.C. Section 231(a)(3).

And the complainant states that this complaint is based on the following:

1. That complainant is a Special Agent for the Federal Bureau of Investigation and participated in the investigation of the circumstances of the violations alleged.
2. That his knowledge of the following is based upon his personal investigation and through information furnished by other agents of the Federal Bureau of Investigation.
3. That a caravan of members of the American Indian Movement gathered at Calico, South Dakota, on February 27, 1973, and traveled to Wounded Knee where approximately 100-150 members of the caravan broke into the Wounded Knee Trading Post and took a large amount of merchandise including firearms and ammunition.
4. That in conjunction with and subsequent to the aforementioned break-in members of the caravan effected a take-over of the community of Wounded Knee and have forcibly prevented federal officers from entering in order to investigate violations of federal law and otherwise enforcing federal laws and such acts continue.
5. That the Wounded Knee Trading Post contains a United States Post Office.

6. That Dennis Banks, Russell Means, Clyde Bellecourt, Pedro Bissonette and Carter Camp are leaders and supporters of the persons occupying the townsite of Wounded Knee, S.D.

7. That during the aforesaid occupation of Wounded Knee, S.D. Dennis Banks, Russell Means, Clyde Bellecourt, Pedro Bissonette and Carter Camp have on various occasions been at Wounded Knee and taken an active part in the occupation including planning and organizing the defense against federal officers and have refused and forcibly prevented federal officers from entering the area.

8. That based on the aforesaid facts and their own admission the purpose of the acts of Dennis Banks, Russell Means, Clyde Bellecourt, Pedro Bissonette and Carter Camp was and is to aid and assist in the occupation of the Wounded Knee townsite.

And the complainant further states that he believes that the following are material witnesses in relation to this charge: Special Agent [redacted] of the F.B.I. of Minneapolis, Minnesota; [redacted] of Wounded Knee, South Dakota.

The undersigned complainant being duly sworn states:

That at and near Wounded Knee, within the Pine Ridge Indian Reservation, in the District of South Dakota, Mary Quintano, James Roberts, William Allen Means and Robert Burnett, Jr., did:

COUNT I

On or about the 27th day of February, 1973 thru the 6th day of March, 1973, said defendants did obstruct, impede and interfere with federal law enforcement officials who were then engaged in the lawful performance of their official duties incident to, and during the commission of a civil disorder at Wounded Knee, South Dakota, which civil disorder obstructed, delayed and adversely affected commerce and the conduct of federally protected functions including the investigation of federal criminal violations, the enforcement of federal criminal statutes and the collection and distribution of the United States Mails, in violation of 18 U.S.C. §231(a)(3).

COUNT II

On or about the 6th day of March, 1973, said defendants wilfully and knowingly possessed destructive devices commonly known as Molotov Cocktails, which devices had not been registered to them in the National Firearms Registration and Transfer Record, as required by Chapter 53, Title 26 United States Code; in violation of Sections 5861(d) and 5871, Title 26, United States Code.

The complainant further states the allegations are based on the following:

- (1) That complainant Donald G. Wiley is a Special Agent for the Federal Bureau of Investigation and that he participated in the investigation of the circumstances of

the alleged violations set forth above.

(2) That complainant was advised by FBI Radio that a break-in occurred at the Wounded Knee Trading Post at Wounded Knee, South Dakota at about 8:15 or 8:30 on the evening of February 27, 1973. That complainant has knowledge through personal investigation and through information furnished by other agents of the Federal Bureau of Investigation that on the evening of February 27, 1973 a number of individuals were apprehended at a road block established at the intersection of U.S. Highway No. 18 and the Wounded Knee Store and that items identifiable as belonging to the Wounded Knee Trading Post were found to be in the possession of said individuals.

(3) That complainant has been advised by other agents of the FBI that a caravan of AIM members had gathered at Calico, South Dakota prior to the break-in and then traveled to the Wounded Knee Trading Post by caravan where approximately 100-150 persons broke and entered into the Wounded Knee Trading Post and took a large amount of merchandise including firearms and ammunition.

(4) That a purpose of the break-in at the Wounded Knee Trading Post was to obtain weapons, ammunition and provisions to implement a seizure of the townsite of Wounded Knee and to prevent any federal law enforcement officials from entering Wounded Knee for the purpose of investigating the burglary and larceny at the Wounded Knee Trading Post and to prevent them from otherwise enforcing the federal laws.

(5) That the townsite of Wounded Knee was seized by force by members of said caravan and those members who wished to leave said townsite were afforded an opportunity to do so during the evening of February 27, 1973.

(6) That since the evening of February 27, 1973, federal officers have been prevented by force of arms from entering the townsite of Wounded Knee and have been fired upon with rifles and otherwise obstructed from enforcing the laws of the United States.

(7) That said defendants are not residents of Wounded Knee, South Dakota and were apprehended while leaving the townsite of Wounded Knee on the morning of March 6, 1973 and at said time said defendants were in a 1970 Dodge automobile registered to Clyde Gildersleeve and said automobile contained four (4) Molotov Cocktails,

several rounds of pistol and rifle ammunition, knives and items identified as belonging to the Wounded Knee Store.

[redacted] South Dakota, was interviewed at the Pine Ridge Jail. Special Agent (SA) [redacted] of the identity of the interviewing Agents and then advised him of his Constitutional rights. [redacted] advised he understood his rights; however, declined to sign the waiver of rights form. He then furnished the following voluntary information:

He first went into Wounded Knee, South Dakota, approximately 15-16 days ago. He went in just after the Roadblocks were lifted because he wanted to see what was going on there. When the Roadblocks were replaced a day or two later, he was trapped inside the village and then was afraid to leave.

While he was there, he noted that there were approximately 200-300 people in the village and of that number many have left. The leaders inside of Wounded Knee, RUSSELL MEANS and DENNIS BANKS, held nightly meetings to speak to the Indians about current negotiations. He further noted that while he was there he saw several white people, many Chicanos, and also several black individuals. To the best of his knowledge, these blacks have now left the village.

He also noted that there were one or two children under the age of five and one old man (first name unknown) BAD COB, who is near 80 years old. He also remembers seeing FRANK FOOLS CROW; however, FOOLS CROW is no longer in Wounded Knee.

While he was there, [redacted] slept at the round church and ate at least one meal a day. This meal normally consisted of beans or macaroni and sometimes they had meat. This meat was taken from the small herd of cattle which is in the village and which has been rounded up from nearby ranches. When he left on March 27, 1973, he believed there were about 22 head of cattle still in the village.

[redacted] advised that he personally did no shooting and did not see any individuals shooting. He did see many males carrying rifles and shotguns and most of these persons were in their late teens and early 20's.

[] had no idea who shot an FBI Agent three weeks ago and he did not hear anyone speaking of it. Further, he had no information regarding the shooting of a U. S. Marshal on March 26th.

He advised that BANKS and MEANS normally slept in a house across the street from the old museum. He did see both BANKS and MEANS in Wounded Knee just prior to his leaving at 9:00 p.m. on March 27th. He had heard rumors that both BANKS and MEANS had slipped out of Wounded Knee; however, could not be positive as he did not speak with them during his stay there. He did recall that he did not see BANKS and MEANS for about a two-day period just prior to his leaving.

He advised that the people there are beginning to run out of food and the little food they have left is being stored in the trading post. An airplane that landed in Wounded Knee on March 27, 1973, brought in some food and more ammunition. However, he did not see any of the individuals on the airplane and only heard about the supplies they brought in through rumors.

[] advised that he decided to leave Wounded Knee as he was becoming disillusioned as are many of the other Indians in Wounded Knee. He slipped out in the dark around 9:00 p.m. on March 27, 1973, and was arrested by the Bureau of Indian Affairs (BIA) Police.

He advised that he belonged to the American Indian Movement (AIM) approximately three years ago in Denver; however, had a split with them because he wanted to change the standard of living for Indians peacefully and not through violence, as has been advocated by current AIM leaders.

While in Wounded Knee, his job was to distribute food. [redacted] further advised that while in Wounded Knee he talked to DENNIS BANKS and RUSSELL MEANS.

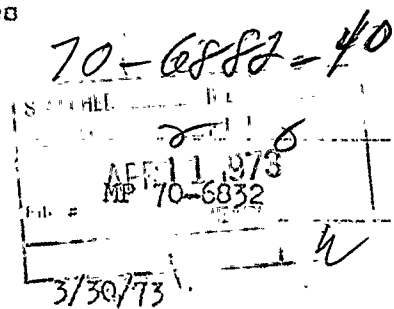

She further stated that she came into Wounded Knee during the time when the Federal road blocks were lifted, and there were two carloads of people who came with her.

She further advised that just the leaders of the American Indian Movement (AIM) are causing problems in the Wounded Knee area; those being RUDOLPH MEANS, DENNIS BANKS, and CARTER CAMP. These individuals have a handful of followers and the majority of the people are discontented in the town.

She advised that all individuals who are followers of AIM are in the security group which comprises approximately 100 Indians, 32 whites, and one black. Of the Indian group, very few are Oglala Sioux, and some of the names she is acquainted with of individuals belonging to the security group are as follows:

ANGEL (LNU), Indian male;
CHARLIE (LNU), Indian male;
MARK (LNU), possibly a police male.

She further stated these individuals in the security group stay only on a first night basis and have meetings practically every night. Other individuals who is familiar with who are in the Wounded Knee area and perform duties for the AIM members and are not in the security group are as follows:

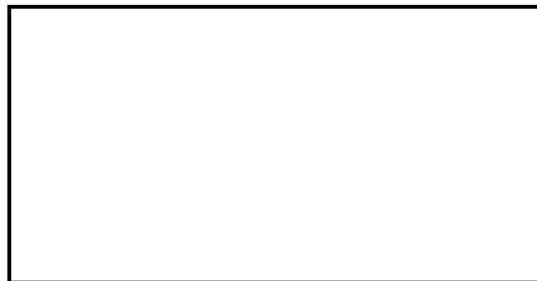



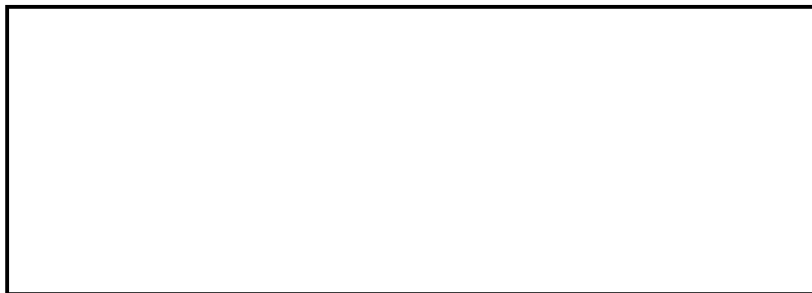
