On December 21, 1973, [redacted] AUSA, Sioux Falls, South Dakota, telephonically advised that he had the following comments concerning the order of proof which related to firefights in which Agents and Marshals were engaged, and Molotov cocktails.

1. In report of SA [redacted] dated May 22, 1973, Pages 81, 82, and 104 refer to Molotov cocktails. On Page 104, eight Special Agents are listed as locating and handling Molotov cocktails in Wounded Knee, South Dakota. AUSA desired that one of the above Special Agents be contacted and it be determined if these Molotov cocktails located were destroyed.

It should also be determined if appropriate gasoline specimens were sent to the FBI Laboratory and if so pertinent transmittal letters and results of Laboratory examinations be furnished to his attention, Sioux Falls USA's Office.

2. AUSA [redacted] stated he was sending to the Minneapolis Office more detailed letter requesting information concerning specific dates during which firefights occurred and the exact type of information he needed for testimony.

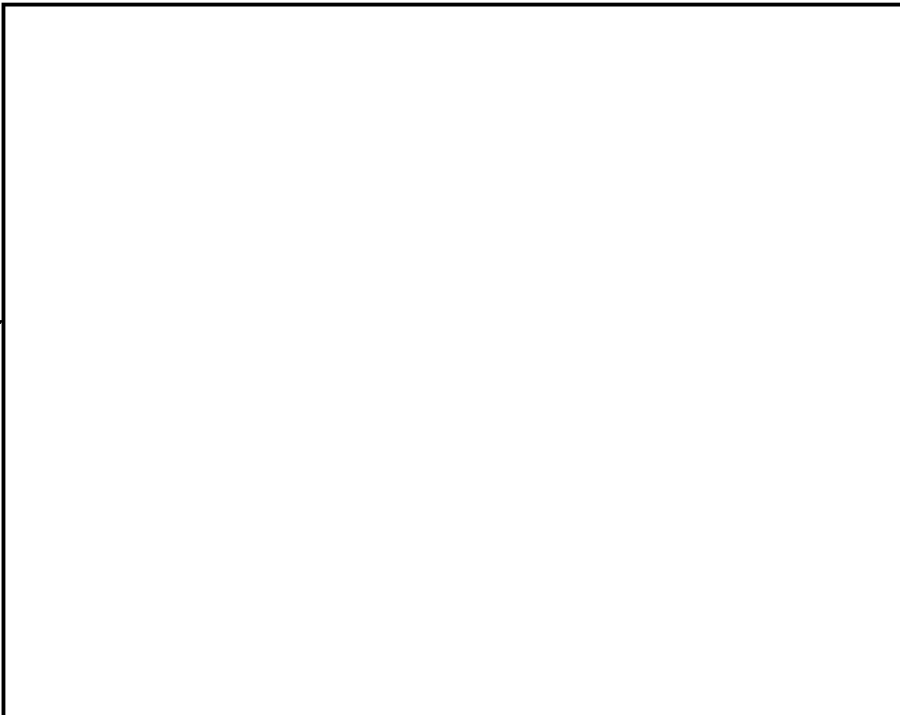

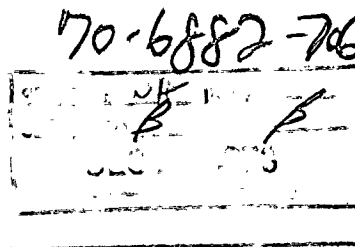

## St. Paul asks \$140,600 for U.S. trials of 6

Associated Press

Mayor Lawrence Cohen of St. Paul seeks \$140,600 in federal funds to help pay expenses resulting from moving to St. Paul the trials of six men charged in connection with the occupation of Wounded Knee, S.D.

The conspiracy trials are scheduled to begin Jan. 8 in U.S. District Court.

Cohen and Donald Lewis, city Human Rights Department director, asked for the funds at a conference with representatives of the U.S. Justice Department, the Minnesota governor's office, the Governor's Crime Commission, police agencies and the American Indian Movement (AIM).

Lewis said the trials could last two to six months and

between 2,000 and 3,000 people could be coming into St. Paul for them.

Lewis, who was named coordinator for the mayor's office to handle plans to house and possibly feed the Indians, said he expects some peaceful demonstrations. To prevent incidents, Lewis recommended that "local uniformed law enforcement should be held at a low profile."

Artley Skenandore, director of the St. Paul AIM chapter, offered volunteers of members, wearing distinguishing jackets, to patrol near the Federal Building to prevent incidents which might reflect on the defendants.

Skenandore also said he believes the city should provide recreation for Indians unable to get into the trial. He said the courtroom seats 150 at most, and many of those places will be taken up by news reporters.

The feature story entitled "The battles of Wounded Knee", which appeared in the Minneapolis Tribune Sunday Picture Magazine, December 30, 1973, very pointedly avoids mentioning the fact that the Oglala Sioux Tribe of Pine Ridge, South Dakota, formally requested assistance by the U. S. Government to counteract militant American Indian Movement (AIM) activities.
