ST. LOUIS (AP) — Grand larceny and burglary convictions of James R. Weddell, arrested after the takeover of the Yankton Sioux Tribe Pork Plant in South Dakota, were affirmed Thursday by a federal appeals court.

Weddell had argued that the crimes were committed in "Indian Country," precluding prosecution, but the 8th U.S. Circuit Court of Appeals noted that the town of Wagner, S.D., is a municipal corporation separate from the Yankton Sioux Tribe.

Weddell was convicted of burglarizing a Coast-to-Coast store in the town of weapons and ammunition, which were later found in the plant where they were arrested.

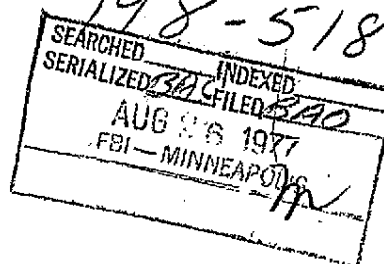

Means Claims He's Still Indigent

Russell Means said Wednesday, May 4, the Minnehaha County Commission won't be able to force him to pay for transcripts of his 1975 trial on rioting charges.

Commission members have voiced feelings that Means is no longer indigent and should be forced to pay for copying 9,000 pages of trial transcript at a cost of about \$13,500.

Means said he would "welcome any investigation by private, local, state or federal agencies upon my status."

In 1973, the Internal Revenue Service contacted his lawyer about his finances, Means said.

"Subsequently, I haven't heard any other inquiries from the Internal Revenue but I can assure any investigative agency and inquisitive person that based upon my educational background, all my financial records are in order by the year."

"And because I have appeared in 11 trials prior to this year since Wounded Knee and in each case was declared indigent by various state and federal judges, I again challenge anyone to investigate my financial status," Means said.

The American Indian Movement member said the move to question his finances was "specifically aimed at myself and the American Indian Movement (and it is) contrary to any common sense approach to improving race relations in this state."

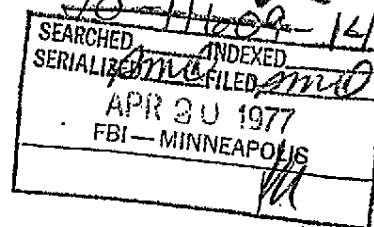

This fugitive investigation stemmed from the takeover of the Yankton Sioux Industries, Yankton Indian Reservation, Wagner, South Dakota, by Indian persons on 5/2/75. [REDACTED] was charged as a result of his participation in the takeover of the Yankton Sioux Industries plant and was apprehended during May, 1976, while in fugitive status. [REDACTED] was incarcerated as a result of this arrest in the [REDACTED] at Sioux Falls, South Dakota, until he escaped and again became a fugitive until apprehended on 1/28/77.

In view of this SA QUIGLEY developed a source who is a close associate of [redacted] convincing this individual to assist the FBI in the location of [redacted]. During the week of 1/24-28/77, SA QUIGLEY worked very closely with the source and these efforts resulted directly in [redacted] arrest without incident on 1/28/77. In addition to convincing the source, SA QUIGLEY coordinated the arrest of [redacted] with local police officers from Charles Mix County Sheriff's Office and officers of the South Dakota Division of Criminal Investigation (DCI). These officers worked long hours throughout this investigation assisting the FBI and their efforts contributed greatly to the success of the investigation.



None of the foregoing individuals were able to furnish information concerning the specific whereabouts of [redacted]

On January 28, 1977, [redacted] was present in a 1976 Dodge Charger bearing South Dakota License [redacted] which at that time was owned and operated by one [redacted] American Indian male, date of birth [redacted] place of birth, Wagner, South Dakota. The vehicle was stopped by a South Dakota Highway Patrolman in the vicinity of Springfield, South Dakota.
