





Russell Means said Wednesday, May 4, the Minnehaha County Commission won't be able to force him to pay for transcripts of his 1975 trial on rioting charges.

Commission members have voiced feelings that Means is no longer indigent and should be forced to pay for copying 9,000 pages of trial transcript at a cost of about \$13,500

Means said he would "welcome" /any, investigation by private, local, state or federal agencies upon my status."

In 1973, the Internal Revenue Service contacted his lawyer about his finances, Means said

"Subsequently, I haven't heard any other inquiries from the Internal Revenue but I can assure any investigative agency and inquisitive person that back upon my educational back ground, all my financial records are in order by the year.

"And because I have appeared in 11 trials prior to this year since. Wounded Knee and in each case was declared indigent by various state and federal judges, I again challenge anyone to investigate my financial status." Means said.

The American Indian Movement member said the move to question his finances was "specifically aimed at myself and the American Indian Movement (and it is) contrary to any common sense approach to improving race relations in this state


