OF [REDACTED] REPRESENTING A GROUP OF INDIANS WHO WERE PLANNING "TAKE OVER" OF SOME FACILITY IN ABERDEEN, SOUTH DAKOTA ON JULY 23, 1987. [REDACTED] ADVISED TAYLOR THAT HE DID NOT PERSONALLY KNOW MEANS AND, THEREFORE, DID NOT KNOW IF THE CALL WAS A JOKE OR NOT, BUT THAT HE WANTED TO NOTIFY LAW ENFORCEMENT SO AS TO CONFIRM THAT HE WAS NOT INVOLVED. TAYLOR OBTAINED ONLY MINIMAL DETAIL AS DESCRIBED ABOVE AND INDICATED TO [REDACTED] THAT HE WAS GOING TO NOTIFY FBI. SUBSEQUENT EFFORTS TO LOCATE [REDACTED] FOR INTERVIEW HAVE MET WITH NEGATIVE RESULTS ALTHOUGH [REDACTED] HAD PREVIOUSLY INDICATED TO TAYLOR THAT HE WOULD REMAIN AT HOME TO FACILITATE CONTACT BY BUAGENTS.

FOR INFORMATION OF MINNEAPOLIS [REDACTED] IS AN AMERICAN INDIAN (PROBABLY COMMANCHE) AND FORMER [REDACTED]

[REDACTED] AT ANADARKO, OKLAHOMA. [REDACTED] WAS DISMISSED AS [REDACTED] APPROXIMATELY FOUR YEARS AGO AND HAS BEEN SUBJECT OF SOME INVESTIGATION BY LOCAL AUTHORITIES IN REGARD TO A MURDER INVOLVING A NON-INDIAN.

VORACITY OF INFORMATION IS UNKNOWN TO OKLAHOMA CITY DIVISION AND SHERIFF TAYLOR ADVISES ON BASES OF HIS CONVERSATION WITH [REDACTED] THAT [REDACTED] IS ALSO UNCERTAIN F THIS IS REAL OR HOAX.

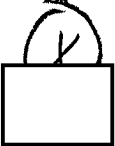

On 7/23/87, SA [redacted] contacted Criminal Investigator (CI) [redacted] BIA, Rosebud, South Dakota. CI [redacted] advised the following information:

On 7/22/87, CI [redacted] was having a general conversation with [redacted] and [redacted] and they mentioned that [redacted] and [redacted] had just returned from New York, New York. The [redacted] stated they heard that [redacted] BILL MEANS, TED MEANS and two other male Indians from Rosebud left last week to go to New York and then were supposed to go to Libya. While in New York, they stayed at a Hilton Hotel and [redacted] and [redacted] got into an argument with the others over money and drinking alcohol. As a result, [redacted] and [redacted] did not go on to Libya, but returned to Rosebud, South Dakota. It is not known if the others went on to Libya.



During the past weekend, 7/18/87 and 7/19/87, RUSSELL MEANS was on the Rosebud Sioux Indian Reservation attempting to locate some people. One of the individuals he was looking for was [redacted]. The [redacted] believed he was looking for these people to take them to Libya with him. RUSSELL MEANS apparently left the reservation on Monday, 7/20/87.

CI [redacted] concluded by stating he would, again, make contact with the [redacted] and attempt to get more specific information.
