Affiant, being first duly sworn on oath, states as follows:

- 1. That affiant is a Police Detective currently assigned to the Milwaukee Police Department Intelligence Fusion Center.
- 2. That affiant has worked full-time as a law enforcement officer for more than 12 years.
- 3. That affiant knows through personal involvement in this investigation, in an official capacity, that on 08/05/2012 at about 10:25AM, a 911 police call for service was generated at The SIKH TEMPLE at 7512 S. Howell Av, in The City of Oak Creek, County of Milwaukee. The call was for shots fired at the location. At about 10:30AM, Lt. Brian MURPHY arrived at the scene. A white male wearing a white T-shirt, with gray writing, with black jeans, and black boots was armed with a handgun. Lt. MURPHY was in full uniform. The suspect pointed and fired the firearm at Lt. MURPHY. Lt. MURPHY was hit at least eight times by gunfire. PO returned fire at the suspect. The suspect was shot once in the head, and expired at the scene. Lt. MURPHY was transported to Froedtert hospital for treatment, Multiple citizens were injured and possibly killed inside the temple, but the total number could not be determined at this time.

4. A red Chevrolet Yukon, WI/399TJA was located in the parking lot at the scene, with the

windows open, keys inside, and no occupants. The plate was run through Wisconsin DOT, revealing a listing to Wade M. PAGE, W/M 11/11/1971, of 3748A E. Holmes Av, in The City of Cudahy, County of Milwaukee.

5. At 2:55PM, Captain Milwaukee Police compared a DOT photo of WADE, to the suspect, and positively identified PAGE as the suspect.

- 6. The affiant knows through the observations of Investigator and Cudahy property records, that the address of 3748A E. Holmes Ave is a two-story, two family residence having a gray and black roof, gray siding with white trim. The common entry door faces South, and the numbers 3748A appear the West of the front door and face South. This residence is in the city of Cudahy and County of Milwaukee.
- 7. That based upon affiant's training and experience, that subjects who possess firearms often possess cartridges, holsters, additional magazines, cleaning supplies, ammunition and/or firearms in their residences.
- 8. That based upon affiant's training and experience, affiant knows that weapons can be secreted in any part of a residence including garages, vehicles and storage areas related to the premises and on persons located in the residence; and that the execution of a search warrant usually results in the seizure of such items associated with firearms as cartridges, holsters, additional magazines, cleaning supplies, ammunition and usually results in the recovery of personal property such as utility bills, canceled mail envelopes, bank statements, keys, photographs, videotapes, and other items or documents which establish the identities of persons in control of the premises and other items.
- 9. That affiant knows that the presence of firearms in the residence presents a significant risk to

- the safety of the officers executing the search warrant, that it is common for more than one firearm to be located in a residence and that the information presented in this affidavit forms the basis to request a no-knock warrant.
- 10. Based on the nature of this crime, affiant believes that premeditation and planning was involved prior to the execution of the multiple shootings. I base this assertion on the fact that the crime occurred at a religious ceremony servicing. Sikh citizens and Wade is a caucasion male who was not a member of the community. I believe it probable that documents and stored electronic devices are likely present at the residence and they would demonstrate surveillance, planning and preparation for the assault as well as information related to associates or co-conspirators. I am therefore seeking permission to seize any documents and electronic storage devices on scene.
- 11. That affiant, based upon affiant's training and experience, seeks permission to search all persons on the premises because: a) the premises in question is a private residence and weapons and other weapon-related contraband may easily be secreted on one's person.
- 12. Affiant states that based on the above stated information that there is probable cause to believe that evidence of the crimes of First Degree Intentional Homicide, Attempt, 940.01, and 939.05 of the Wisconsin Statutes, is now located at the residence described above in paragraph 6, and respectfully request permission to search said residence and persons.

The couple did not see anything suspicious on the day of the incident or in the days leading up to the incident.

The couple first knew it was a serious incident when police in tactical gear ordered them from their home at gun point. The couple said they would not leave without their pets and were allowed to take the pets to the bowling alley across the street.


