Synopsis: To open case in captioned matter and to advise Cyber of a new 288A investigation.

Details: On 8/14/2008, writer received information from the Southern District of New York (SDNY) that the website for a major New York City lawfirm, Sullivan & Cromwell, LLP, was spoofed in a suspected E-Mail phish. The spoofed website was registered and hosted at GoDaddy.com. The Sullivan & Cromwell (S&C) Wikipedia page was altered so the link to the legitimate S&C website redirected to the spoofed address. Two other major New York City lawfirms, Wachtell, Lipton, Rosen & Katz and Greenberg Traurig, LLC, have also been victims. All three lawfirms have major mergers and acquisitions practices involving deals worth large sums of money. S&C believes that someone was trying to intercept the misdirected E-Mails, about the mergers and acquisitions, in an attempt to get insider information on Wall Street activity. The activity occurred in late July, 2008 and the spoofed sites were removed, by GoDaddy.com, around 08/08/2008.
