This file was opened in July, 1986, after Chicago received a request from a private citizen under the Freedom of Information Act for all records Chicago might have concerning Sun Myung Moon and the Unification Church. The requestor was advised by letter dated 8/12/86, that Chicago would neither confirm nor deny the existence of such records without the consent of Moon, as it would be an unwarranted invasion of personal privacy. The requestor appealed the denial to the Department of Justice, and that appeal was denied. The Chicago file was then closed.

Philadelphia file 190-1258 contains a Freedom of Information-Privacy Acts (FOIPA) request from a private citizen seeking any information concerning the Unification Church and/or its founder, Sun Myung Moon. Pursuant to the Privacy Act, the requester was asked to provide a notarized statement from Mr. Moon showing that Mr. Moon authorized the requester to make such a request. The requester failed to provide a notarized authorization from Mr. Moon; therefore no further action was taken to process that portion of his FOIPA request. One main file was located concerning the Unification Church; however, the requester was not willing to pay the fees for processing that file and no documents were released to him. Philadelphia file 190-1258 was then closed.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

Upon a search of the electronic surveillance indices and the indices to the Central Records System of the Buffalo Office, four documents totaling six pages were located regarding the UNIFICATION CHURCH and MOON. They were released to [redacted] with appropriate excisions.

Miscellaneous information was contained in these pages which had been furnished to the Buffalo Division by various complainants in the area. Complaints alleged "brainwashing" and "mind control" by MOON and his organization.

There is no mention of the name [redacted] or INTERNATIONAL RELIEF FRIENDSHIP FOUNDATION, INC.

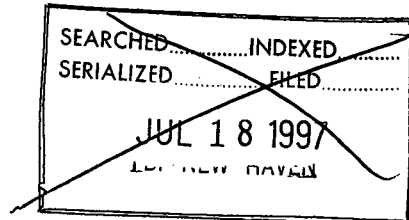

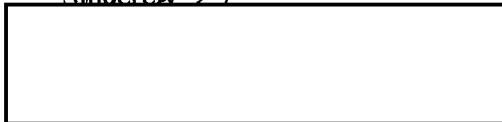

None of the references disclosed any information of criminal nature pertaining to either the captioned persons, Moon, or the Unification Church.
