He recalled that [redacted] was very active in the NAACP, and was also active in the Civil Rights movement.

Chief ADAMS further stated that [redacted] is the patriarch of his family and lives on [redacted] surrounded by his relatives. *M.J.*

Chief ADAMS further stated that it was unlikely that an inquiry could be made [redacted] without [redacted] hearing about it.

A review of Newark file 100-42818, captioned [redacted] SM - C, contains information that [redacted] of the American Friend Service Committee was [redacted] at a symposium captioned, "What Lies Ahead for the Americans Left?", which was held at the New Century Club, located at 124 South 12th Street in Philadelphia, Pa., on Friday, March 15, 1957.

After the meeting of March 15, 1967, [redacted] was reported to have stated that he had nothing to do with getting the program together, that an [redacted] was wanted and he agreed to be just that.

[redacted] was registered in Camden County as of 9/16/53, when his age was listed [redacted]. He has previously lived at [redacted] Pa., and was listed as being native born.

The Camden County Board of Elections in 1957 also contained a card which was postmarked January 26, 1957, which was received from [redacted] advising the Camden County Board of Elections that he lived [redacted] N.J., as of January, 1957.

In May of 1957, a PSI of the Newark Division had attempted to contact [redacted] N.J., [redacted] at the American Friend Service Committee, located at 20 South 12th Street, Philadelphia, Pa. (S) u

For the information of recipient offices the Korean Cultural and Freedom Foundation (KCFF), mentioned in Legat Tokyo enclosure to Bulet 3/3/67, was extensively investigated by WFO during 1964 to 1966 at the request of the Internal Security Division, USDJ. [redacted] advised [redacted] he had terminated his former employment with Republic of Korea (ROK) and had returned to Washington, D.C., to devote full-time to the KCFF. *Ken*

FD 302 dated 3/3/65 in report of SA [redacted] dated 3/22/65 at WFO, WILLIAM A. CURTIN (since deceased) of the KCFF identified [redacted] as [redacted] responsible for bringing "The Little Angels" a Korean song and dance ensemble, to the United States. CURTIN further stated that [redacted] had a deep interest in the "Holy Spirit Association," a Korean spiritualist group in Washington, D.C., (which was not further explained).

FD 302 dated 5/19/65 in report of SA [redacted] dated 5/28/65 at WFO, [redacted] identified Colonel [redacted] at the Embassy of Korea, Washington, D.C., who had called [redacted] identifying himself [redacted] of the KCFF. [redacted] bluntly informed [redacted] that as long as Colonel CURTIN was with KCFF, [redacted] would have nothing to do with KCFF. Additional information
