
On March 16, 1989, SUN MYUNG MOON, was contacted at his residence, 50 East Sunnyside Lane, Irvington, New York. In addition to MOON, also in attendance were MOON's Attorney, from the law firm of LAXALT, WASHINGTON, PERITO AND DUBUC, 1120 Connecticut Avenue Northwest Washington, D. C., telephone who acted as translator for MOON. Additionally, Personal Secretary of MOON,

MOON supplied the following information:

MOON stated that all information shown on his petition for pardon, form OPA-13, was complete and accurate as far as he knew with the following exceptions: It was noted that the actual alien registration number was A20-481-306, and that alien resident status was granted on April 30, 1973 at Washington, D.C. MOON stated while in the United States, he does reside at 50 East Sunnyside Lane, Irvington, New York, and has been there since approximately 1974. This property is owned not by MOON, but rather by the Unification Church of which MOON is the head. Many other functions also take place at the compound in Irvington, New York, and as such, seves as headquarters for the Unification Church as well as the residence for MOON and his family. property listed in Seoul, Korea, is also owned by the Unification Church, and has been owned since 1984. Currently, there is no property owned within the United States by MOON. When asked to explain why MOON is requesting a Presidential Pardon, he stated that there were three basic reasons: Firstly, that his adversaries, most of whom are Communist, were using his conviction of tax evasion as ammunition to try to attempt to sabotage the good works that MOON and his Unification Church are attempting to perform. MOON stated that his Unification Church is attempting to reform through Christianity, many of the problems currently being experienced by younger people, such as drugs, alcoholism, and general lack of respect. Additionally, many of MOONS followers within the United States are currently carrying a heavy burden or stigma related; to MOON's conviction. MOON states that he wants to relieve or alleviate this burden carried around by members of his The pardon is not for himself, but rather for his followers. Currently, many people view his followers as guilty by association, and feels that a pardon would relieve them of such

unfounded guilt. Lastly, many of the followers of the Unification Church are of Asian descent or minority based. As a result of MOON's coviction, many followers have fostered anti-American feelings due to the fact that the United States imprisoned someone who is so "pro-American". MOON feels that this pardon would show the world that the American Government is fair and just and would alleviate some of this anti-American sentiment thoughout the world. MOON believes that the life he has led since his conviction has demonstrated his continued commitment to the Unification Church, the church's own commitment to the betterment of society through a variety of charitable, cultural, and religious organizations and projects, and his respect in performance with the law of the United States. He feels the pardon would not only relieve himself and his family from the heavy burden of the conviction, but relieve the Church members from this burden as well. Currently, MOON derives no income from any outside source other than Unification Church. In his application he had listed as being a Board member with TONG IL ENTERPRISES. It was noted during the interview that TONG IL ENTERPRISES is mainly a Korean firm who produces machine tools and auto parts. In addition to this, TONG IL also was a retailer of pictures and gift items as well as handling some defense equipment in Korea. It was noted that MOON has never had any hands on running or management of the company. He currently holds no title with the company other than honorary title of founder of the company in Korea. Since 1984, the firm has since been sold to a Japanese conglomerate named SEALIO ENTERPRISES and no longer resides or exist at 41 8th Avenue, New York, New York. Again, it was emphasized that MOON never received any financial compensation from TONG IL. Currently, MOON's only source of income is from a trust fund created by the Church to take care of MOON and his family. MOON resides on a church-owned property but does not take a salary from the church for his efforts. This trust fund set up by the Church for MOON and his family is administrated over by a Board and all incomes derived from his trust fund are recorded on Attorney MOON's tax return. stated tha MOON had executed a tax release form and his form was sent to FBI Headquarters in Washington, D.C. Additionally, stated that MOON's accountants would be available to answer questions regarding

It was determined that currently, there were several suits filed against the Unification Church naming Reverend MOON as part of the suit. stated that he currently is obtaining this information and will file an addendum to the original application as soon as this information stated that he would send a copy of this addendum to FBI Headquarters as well as to the New York Office. As previously mentioned, MOON is the head of the Unification Church. This church maintains a core membership of approximately three to four million people throughout the world and maintains a core membership of approximately 10,000 people within the United States. MOON was informed that the FBI is not restricted in its investigation to that information shown on his application form, and as such, is free to follow any leads they see fit. stated that he has absolutely no problem with the FBI investigating any facet of his life and additionally stated that he would always available if any questions or additional information be required. - (5) MOON's honor will be restored and this will be a landmark in the history of the world, as well as enhance people's feelings about what a great country the United States is.
- (6) are suffering, as well as being ridiculed by many people.
- (7) MOON is a "rare living religious leader", who is also involved with numerous cultural organizations. A pardon would be able to enhance MOON's activities with various cultural organizations.

devised that he is very familiar with MOON's conviction.

He feels that MOON was treated unfairly by the DEPARTMENT OF JUSTICE (DOJ), as well as the media. He stated that MOON's case should not have been prosecuted by the DOJ. He stated that the media and the DOJ persecuted MOON, because he supported President NIXON, and asked for the United States to forgive NIXON for his mistakes.

advised that MOON did not personally or intentionally break the law. He indicated that there were poor record keeping and accounting practices which resulted in MOON's conviction.

indicated that the Unification Church could benefit financially from MOON's pardon. He stated that MOON will not personally benefit financially from this pardon, because he only receives enough money from the Unification Church for his family to live on and for his children to receive an education. advised that MOON resides at the Unification Church official mansion, which is located in Irvington, New York advised that the additional money that could be raised, if MOON was pardoned, will not be used for MOON's personal resources, but rather for the growth and work of the Unification Church.
