DETAILS: [Redacted] of the American Conservative Union recently telephonically contacted the Public Affairs Office at FBIHQ and indicated he was calling on behalf of [Redacted] the Unification Church of America (UCA). [Redacted] indicated that [Redacted] would be in Washington, D. C., during the week of January 26-30, 1978, and would like to explain for the record the activities and purpose of the UCA and to enlighten the FBI and provide a clear picture of that church for future reference.
