I watched yesterday's Ford/Kavanaugh hearing. I understand that the committee will not call for an independent investigation by reopening Judge Kavanaugh 's background check, but is there enough credible evidenc now to initiate a new investigation? I am not writing this to be partisan, but because I do not want to see this matter left unresolved. When I was in college, there was a rape, and the school told us that they had investigated, that the girl clearly didn't want it, but that there was no gun or knife, so nothing would be done. I have felt dirty, guilty, somehow complicit in a coverup. I'm not sure

I could have changed anything three facades ago, but I'd like to hold my government to a higher standard. Please, will you tell me if there is a way to open an investigation into serious allegations against a federal judge? Is there anything I can do to set something in motion? Yesterday's testimony was striking. I got the consistent impression that Dr. Ford was trying to answer all questions openly and as completely as possible. Judge Kavanaugh was clear in answering questions about his yearbook and calendar, but grew upset every time he was asked about an investigation. I think I counted eight or nine times when this was brought up. Each time, he got louder, tried to divert the question, or to run out time by reiterating his impressive accomplishments. I got the distinct impression that he does not want any investigation. How different from Dr. Ford practically begging for an investigation. I am not trying to be partisan when I say that the Senate Judiciary Committee is clearly incapable of any impartial investigation. Besides, it would be better for this matter to be followed by people with training and experience to know where to look, how to look, what to ask. During the academic year, I was eyewitness to a shocking ceremony taking place inside the DKE fraternity house that involved a semi-circle of cheering frat brothers watching what was presumably a local prostitute perform a sex act. I first contacted the New York office of the FBI on Saturday, September 29th and was transferred to a national call center where, after waiting on hold for 15 minutes, I onboarded my name, my recollection, the identity of the one frat member seen at the event, my investigative advice, my witnesses' names, and the names of those with whom I shared the information back in the late 80s to what seemed like a low-level input agent. I subsequently called the FBI's New Haven field office on Sunday, September 30th where I was told that there was no need to resubmit my claim if I'd already spoken to the National Call Center. I asked to speak to an agent, but was told that agents weren't in the office since it was a weekend. I followed up again with the FBI's New Haven field office on Monday, October 1st where I was transferred to the National Call Center. After waiting another 15 minutes on hold, the telephone agent acknowledged that my initial claim had been entered into the system and that it had been "submitted out accordingly." I asked if I could be sent an email acknowledging my initial September 29th outreach and was told "no." The telephone agent said that if I had additional information to add to my initial report that I could wait 30 minutes on hold to speak to someone else.
