**Synopsis:** The purpose of this communication is to report the details concerning the captioned case.

**Details:** On 5/23/2007, Detective [REDACTED] U.S. Capitol Police (USCP), [REDACTED] contacted the Asheville RA to report a threat received by a staff member to Senator DEMINT. The staff member, [REDACTED] had received a telephone call in Washington D.C. from a person who identified himself as a constituent of Senator DEMINT. The person was upset with the current immigration legislation pending before congress. During the conversation, the person threatened to travel to D.C. in a pickup truck loaded with dynamite and blow up his two South Carolina senators if the immigration bill passes.

The person refused to identify himself to [REDACTED] but caller ID listed the incoming telephone call as originating from [REDACTED]. Checks with public source records list that telephone number to [REDACTED] Robbinsville, N.C. 28771.

According to Det. [REDACTED] congressional staffs have been receiving thousands of telephone calls from upset and angry constituents over the immigration issue. Standard policy of the U.S. Attorney's Office for the District of Columbia is to decline prosecution on any threat unless the person has taken an overt act in furtherance of the threat. USCP policy regarding this round of threats is to refer the matter to the local police or sheriff's department for action. The USCP requests the local officers contact the angry constituent and ascertain their

potential for actual violence. If there is no apparent attempt to commit an act of violence, then the officers are to admonish them for the threat.

In furtherance of this policy, Det. [ ] contacted the Graham County Sheriff's Department and informed them of this matter. Sheriff RUSSELL MOODY and Captain [ ] contacted [ ] and interviewed him. While [ ] admitted to making a telephone call to the Senator's office, he denied threatening to blow up the two South Carolina senators. MOODY and [ ] admonished [ ] and advised him to refrain from making threatening statements in the future. MOODY and [ ] opined that [ ] has no ability or inclination to carry out any threat against U.S. Congressmen.

Details: In August of 2007 SA [REDACTED] of the Woodward RA attempted to interview [REDACTED] threatened to commit suicide and refused to meet with SA [REDACTED] in person. SA [REDACTED] was able to complete a limited interview via telephone. [REDACTED] never confessed he made threatening phone calls to Congressman Boren's office. Further details are found in serials 28 and 29 of this file.

Since the threatening phone calls of June 2007, [REDACTED] has been in telephonic contact with Congressman Boren's office. [REDACTED] is believed to have left rambling messages on the voice mail system of Congressman Boren's Office. However, these voice mails have not been of a threatening manner. Staffers at Congressman Boren's office have interacted with [REDACTED] telephonically without incident since the June phone calls.

[REDACTED] made a visit to Congressman Boren's Muskogee Office in late 2007. This visit was brief and without incident.

[REDACTED] is a transient individual and his current whereabouts are unknown. It is unlikely he would consent to additional interviews with the FBI given his previous behavior. It is doubtful [REDACTED] can be prosecuted successfully without a confession and a statement of intent regarding his threats.

Details: On 11/4/2007, Detectives from the Lakewood Police Department were contacted by a [REDACTED] a staff member for Congressman Dennis Kucinich. [REDACTED] advised that he arrived at Dennis Kucinich's congressional offices at 14400 Detroit Avenue, Lakewood, Ohio on 11/4/2007 at approximately 2:00 p.m. It was at this time that [REDACTED] found a note taped to the entry door. The note read as follows, "United States Army was here; don't fuck it up"! You ain't J. F. K. Pull it straight. Or shit will happen. 101 Airborne 5th SPC FC Work For Us "Hollywood" (You almost had a hit on you from LCN), "Be good, I'm counting on it!". [REDACTED] advised that the last staff member who left the office would have been at approximately 12:30 hrs on 11/3/2007. [REDACTED] advised that in the past the Congressman has received unusual voice messages, but for the period 11/2/2007 to 11/4/2007 no unusual messages were recorded. [REDACTED] did not touch the message with his hands. He used a plastic bag to cover his hands when he removed the note from the front door. [REDACTED] slid a knife underneath the tape in order to remove the note from the door. A piece of the tape remained on the front door. A piece of tape also came off and remained on the knife.

On 11/5/2007, SA [REDACTED] took custody of five items from the Lakewood Police Department. The items are as follows:

- 1). A black handled knife approximately 12 inch blade with tape on it from note.
- 2). Note with tape and hair on it.

- 3). Envelope that note had been placed in.
- 4). Tape that was on door, razor blade that was used to remove the tape.
- 5). Maxwell professional C-90 cassette tape.

These items were recovered from the Lakewood Police Department and placed into evidence. In addition, Lakewood Police Report 07-009551 was recovered and included in the file.

On 9/6/2007, SA [redacted] conferred with U. S. Secret Service Special Agent [redacted] in connection with this incident. [redacted] advised Congressman Kucinich although he is running for President in 2008 is not currently under Secret Service protect. A copy of the reports will be forwarded to SA [redacted] in the event that Congressman Kucinich obtains Secret Service protection at some point.

**Details:** On 05/11/2007, the Fargo FBI Resident Agency was informed of a telephone threat made to US Senator Byron Dorgan's staff in Fargo, North Dakota.

On 03/21/2007, US Senator Dorgan's staff was contacted by a person identifying himself as [REDACTED] had his wages garnished by the Internal Revenue Service (IRS). [REDACTED] requested the Senator's staff assist him in dealing with the IRS in this matter. The Senator's staff requested a letter from [REDACTED] giving the IRS permission to discuss [REDACTED] case with the Senator's staff. The Senator's staff did not receive any such letter.

On 05/09/2007, a person identifying himself as [REDACTED] telephoned Senator Dorgan's Fargo office. [REDACTED] was upset he had not heard back from the Senator's office. [REDACTED] said he dropped off a letter at US Representative Earl Pomeroy's office. [REDACTED] said he was so "worried about this thing with the IRS that I'm bleeding out my butt hole." The Senator's staff said they would contact Representative Pomeroy's office to see if they had the letter from [REDACTED]

[ ] called the Senator's office back. The Senator's office explained they had not heard back from the Representative's office yet. The Senator's office asked for a copy of the letter. [ ] said he was on the road. [ ] suggested calling his wife, [ ]. The Senator's office contacted [ ] who said she would put another copy in the mail.

At approximately 1:25 p.m. CDT on 05/10/2007, US Senator Dorgan's Field Representative [ ] received a telephone call at the Senator's Fargo office. The caller immediately started talking about [ ] situation with the IRS. The caller was upset the Senator's office still had not received his letter which he had dropped off at Representative Pomeroy's office. The caller referred to his wages being garnished by the IRS. The caller said, "I can't eat, I can't pay bills, I work for nothing, they take it all and Dorgan, Pomeroy, Conrad - they all passed this and let the IRS take the money from me. You tell Dorgan and his buddies Pomeroy and Conrad that I'm gonna start with Dorgan's office and take them all down just like [ ] did." The caller then hung up.

The man claimed that he lost his Veteran's benefits because of  
Senator Harry Reid. He also said that somebody has to do  
something about Senator Reid and said "It'll have to be me."  
[REDACTED] told the man that the Republican Party does not advocate  
violence of any kind and tried to calm the man. The man hung up.

At approximately 4:35 pm, the same man called back and  
asked [REDACTED] if she saw the commercial with Senator Reid on TV.  
[REDACTED] said that she does not watch TV and did not know which  
commercial he was talking about. The man demanded the commercial  
be pulled from being broadcast on TV. He asked what he can do to  
get the commercial taken off TV and [REDACTED] suggested he write a  
letter. The man compared Senator Reid to Adolf Hitler and Pohl  
Pott. The man said "Maybe they'll put my manifesto on TV like  
the Virginia Tech guy." The man hung up the phone again.

[REDACTED] advised that the Washoe County Republican's  
Office, 505 S. Arlington, Suite 106, Reno, Nevada, does not have  
caller identification and does not know who the caller was.  
[REDACTED] said the man did not sound very young or old and

thought he could be anywhere between his early thirties or late fifties in age.

[redacted] of the Reno Police Department notified Senator Harry Reid's Office of the above mentioned threat at approximately 5:00 p.m. on April 24, 2007.

On April 25, 2007, an unknown man called Senator Reid's District of Columbia Office at approximately 2:00 p.m. and said "Fuck you, your traitor son of a bitch. You come to fuckin' Reno and you might be fuckin dead." The man called right back and said "Oh, and by the way, fuck you Reid, you piece of shit."

On April 25, 2007, the Washoe County Republican's Office received a message that stated, "Yeah, my name is [redacted] and my phone number is [redacted] and eh....I think we have to get rid of a traitor by the name Harry Reid and I want to sign a petition or any type of movement that they have to rid of this idiot. Give me a call."

Through telephone records, [redacted] was identified as the caller who left the above captioned message on the Washoe County Republican's phone. The employee who received the threatening telephone call believed that [redacted] was the same person who made the threatening phone call because their voices sounded the same. b6 b7C

The Washoe County Republican's Office AT&T telephone records were subpoenaed. Based upon the subpoenaed information, it was determined that the incoming telephone number that made the threatening phone call was 775-742-0000. Further investigation revealed that 775-742-0000 is not a telephone number, but is most likely a Cingular wireless "trunk" cell phone number. Because the incoming call was not an AT&T number, the telephone company does not record the entire number, only the area code and the prefix, which is a "trunk" number.

Based on this information, [redacted] home telephone number and cellular telephone records were subpoenaed. [redacted] home telephone number is [redacted] From his home telephone number, [redacted] called the Washoe County Republican's office on 04/25/2007. [redacted] did not call the Washoe County Republican's office on 04/24/2007 or 04/25/2007 from his cellular phone.

Further analysis of [redacted] home telephone number revealed that the line had received several telephone calls from 775-742-0000, specifically three times on 04/24/2007 at 7:56 a.m., 3:04 p.m., and 3:06 p.m.

An attempt was made to subpoena Cingular Wireless for a "market search" to search their database for any Cingular Wireless number with prefix 775-742-XXXX that made a call to [redacted] on April 24, 2007. The "market search" records were only available 30 days from when the call was made. Cingular could not provide any additional information that would identify the cellular telephone number because the request for the "market search" was made past the 30 day deadline.

Because [redacted] home telephone number was receiving calls from 775-742-0000 on the day the threatening phone calls were made and the employee of the WCRO recognized [redacted] voice as the person who made the threatening phone calls, [redacted] became a strong suspect.

SA [redacted] attempted to make contact with [redacted] at his residence. [redacted] was not home, and SA [redacted] s card was left for [redacted]. Before SA [redacted] returned to the FBI office, [redacted] had left several agitated messages on SA [redacted] voicemail.

SA [redacted] asked [redacted] to come to the FBI office for an interview and [redacted] advised that he had to consult with an attorney before being interviewed. During a phone conversation with [redacted] admitted that he did not like Harry Reid.

SA [redacted] met with [redacted] and his attorney. [redacted] denied making the threatening phone calls and advised that his brother, [redacted] occasionally breaks into his house and could have made the phone calls.

SA [redacted] requested FIG assistance in an attempt to identify other potential telephone numbers associated with [redacted] specifically a telephone number with area code 775 and prefix 742-XXXX. The FIG was able to identify one telephone number [redacted] belonging to [redacted] is [redacted] ex-wife.

Synopsis: Opening communication with summary of investigation.

Details: On May 7, 2007, the writer was contacted by Special Agent (SA) [redacted] U.S. Capital Police (USCP) regarding a telephonic threat to kill U.S. Congressman Ron Lewis, Second District, Kentucky. Thereafter SA [redacted] provided a facsimile copy of a statement, dated May 3, 2007, setting forth the threat conveyed to [redacted] Communicare, Incorporated (CI), Elizabethtown, Kentucky. In summary the report indicated that, same date, captioned subject, who identified himself to [redacted] and was being treated by Dr. [redacted] Name Unknown (FNU) [redacted] pf Communicare, said he could kill Ron Lewis.

Based upon the above statement, on May 3, 2007, [redacted] was located and arrested by Kentucky State Police (KSP) and charged with Menacing, a Class B Misdemeanor. [redacted] posted \$500 cash bond and was released under conditions set by the district court. Contact with KSP Trooper [redacted] Post 4, determined that [redacted] was cooperative during the arrest and made no overt or veiled threats of any type.

On May 9, 2007, [ ] was contacted at her place of employment, Communicare Incorporated (CI), 1311 North Dixie Avenue, Building C, Elizabethtown, Kentucky, by the writer. After being advised of the official identity of the writer and the nature of the interview

[ ] was asked to observe and review a copy of a written statement dated May 3, 2007, regarding her telephonic conversation with [ ] confirmed that the copy was an accurate depiction of the original she produced. The original is filed in the patient file of [ ]

Thereafter, [ ] provided the following information:
