Synopsis: Opening communication.

Details: On instant date the Hopkinsville RA was contacted by WFO/CR-2/TFO [redacted] of the U.S. Capitol Police (USCP). [redacted] advised the USCP was in receipt of a letter which contained a death threat directed to Congressman Ed Whitfield. According to [redacted] is incarcerated at the Kentucky State Penitentiary awaiting trial on local charges in McCracken County, Kentucky.

[redacted] [redacted] provided an EC containing further details. [redacted] also faxed a copy of the letter to the Hopkinsville RA. This copy will be provided under separate cover.

The hand written letter contains several direct threats to kill Congressman Whitfield. The letter also contains other like threats to [redacted] attorney and the judge presiding in his case.

FBI Hopkinsville contacted Detective [redacted] of the McCracken County Sheriff's Office. Detective [redacted] is investigating [redacted] for the threats made against the judge and others. Detective [redacted] advised [redacted] is incarcerated at the Kentucky State Penitentiary to await trial on the charge of Assaulting a Jail Officer.

He was charged for that offense and taken to the Kentucky State Penitentiary. Detective [redacted] anticipates [redacted] will be returned to a McCracken County court for a preliminary hearing for charges related to the threats against the judge. According to the Detective, [redacted] has confessed to making those threats.

Synopsis: Provision of closing communication.

Details: On January 16, 2009, the Hopkinsville RA was contacted by a U.S. Capitol Police officer assigned to a task force at the FBI's Washington Field Office. The officer advised the Washington office of Congressman Ed Whitfield received a letter containing a threat to kill him. The letter was apparently written by [redacted] an inmate at the Kentucky State Penitentiary. A copy of the letter and envelope was forwarded to the Hopkinsville RA.

The letter and envelope were handwritten with a return address denoted as the Kentucky State Penitentiary. It contained several references to killing the Congressman. [redacted] seemed angered by his treatment in a local jail.

SA [redacted] contacted Detective [redacted] of the McCracken County Sheriff's Office. [redacted] had been arrested by local authorities in McCracken County, Kentucky, for a misdemeanor offense and lodged in the local jail. There he assaulted two guards and was transferred to the Kentucky State Penitentiary. Detective [redacted] had initiated an investigation on [redacted] for sending threatening letters to various members of the McCracken County criminal court system.

[] was interviewed by the Hopkinsville RA on February 10, 2009. He was shown a copy of the letter addressed to Congressman Whitfield and acknowledged writing same. He advised he wanted the Congressman's attention towards his treatment in the local jail. [] declared he did not intend to follow through with the threats contained in the letter. He has been diagnosed and treated for various mental disorders.

[] was sentenced to two years for assaulting the jail guards. He was also indicted for a number of felony offenses related to the letters he mailed threatening local criminal justice employees. The Commonwealth's Attorney for McCracken County anticipated [] would receive another sentence of two to five years.

Congressman Whitfield's office in Hopkinsville was contacted. It advised [] has communicated with the Congressman in the past without threatening him. The office provided copies of correspondence from and to []. The office also provided intra-office communications. These records indicate the Congressman "did not want to press the matter" concerning the threat from [].

This investigation was coordinated with Assistant United States Attorney (AUSA) []. After reviewing the investigation and speaking to the local prosecutor, AUSA [] advised the Hopkinsville RA he was closing his prosecutorial file for this matter. AUSA [] was satisfied with the terms of incarceration, fixed and anticipated, for []. He also believed [] was not an imminent threat to the Congressman and other priority matters needed to be addressed.

[REDACTED] The Congressman's staff notified the U.S. Capitol Police Threat Assessment Section, SA [REDACTED] who then notified the Washington Field Office CR-2/Violent Crimes Task Force.

[REDACTED] listed his name and KSP return address, [REDACTED] on the envelope, along with his inmate number: [REDACTED]

The one-page letter states, in part: "Mr Whitfield, This is inmate [REDACTED] I'm writing you to tell you that I'm going to kill you when I get out of here because wrote you and told you about the court . . . If day try to give me some time for something that I did not do and when I did get out of here I will kill you and that judge and I will kill my attorney . . .".

Details: On February 3, 2009, [REDACTED] was reported to have entered the Nubani Ahmad Law Office in McLean, VA, and after engaging in a brief discourse with [REDACTED] the office's receptionist, [REDACTED] asked if the office practices criminal defense, to which [REDACTED] affirmatively replied. [REDACTED] then stated: "Good, ya'll can represent me, 'cause I'm planning on shooting McCain." [REDACTED] departed the office shortly afterward.

On February 6, 2009, TFO SA [REDACTED] and SA [REDACTED] located [REDACTED] at his residence in Bristow, VA. [REDACTED] denied having making the threat regarding Senator McCain and only professed admiration for him. [REDACTED] was verbally admonished in reference to making threatening comments directed toward Senator McCain.

Since the claim by [REDACTED] of [REDACTED] threatening Senator McCain occurred in person and was not recorded, and [REDACTED] denies making the threat, it is not possible to capture the exact language that was exchanged between [REDACTED] and [REDACTED]. As no evidence exists to support the threat against Senator McCain and no further investigative leads have been developed, no further investigation is deemed necessary. No items of evidence are maintained by the FBI and there are no

The male subject in each message did not provide identifying information. The offices' caller identification systems are not equipped to provide incoming telephone numbers for voice mail messages.

The Grand Rapids office, located at 3280 Beltline Court, Suite 400, Grand Rapids, MI 49525, telephone [REDACTED] received the first voice mail message at approximately 2306 hours. The subject stated: "Hey you fuckin' Stabenow. You'd better quit with your fuckin' ahh, fuckin' ahh, fairness doctrine shit man. We're gonna fuckin' get you man. We're gonna get you with a lot of fuckin' bolt action. Like we did RFK, like we did MLK. You'd better fuckin' stop it man, we know where you are. We'll get you."

The Flint office, located at 432 N. Saginaw Street, Suite 301, Flint, MI 48502, telephone [redacted] received the second voice mail message at approximately 2310 hours. The subject stated: "Hey you fuckin' Stabenow. You better quit with your fuckin', ahh, fairness doctrine shit. You're playin' with the big boys, you fuckin' cunt. You're not protected by anybody we're gonna get you. We're gonna get you with a fuckin' bolt action and a bullet in the head you mother fucker. You better quit you mother fucker. This ain't no fuckin' now shit."

The Marquette office, located at 1901 W. Ridge, Marquette, MI 49855, telephone [redacted] received the third voice mail message approximately 2311 hours. The subject stated: "You fuckin' cunt, you'd better quit with this fuckin' fairness doctrine bullshit you got goin on. You better fuckin' quit 'cause we'll get you mother fucker. Just like we did with RFK, just like we did MLK, we're gonna put a fuckin' bolt action in your fuckin' head. You better quit, you better quit. We've given you a warning. This ain't no fucking now shit ok. This is, this is it."

SA [REDACTED] and Detective [REDACTED] of the Hilliard Police Department interviewed [REDACTED] her husband, [REDACTED] on 9/17/2009 at their residence. Both [REDACTED] were extremely cooperative and denied any involvement in the threatening phone call to Senator Brown's office. SA [REDACTED] was able to verify by checking the toll records of [REDACTED] cell phone that no calls were made from her cell phone to Senator Brown's office. In discussing the above with agents of the FBI Columbus Cybercrime Unit, it appeared as though the cell phone number had been "spoofed" to appear like the call came from [REDACTED].

[REDACTED] is a clerk working in Senator Ben Nelson Lincoln Office. During the conversation, [REDACTED] made threatening comments about both Senator Nelson and Senator Lieberman. [REDACTED] told her that he wanted to talk about the Senator's position on health care. [REDACTED] then voiced his displeasure over Senator Nelson's and Sen Lieberman's stance on health care. He indicated he was for health care reform and thought both of them were being "obstructionist." [REDACTED] then made a threat, stating words to the effect "Whenever I look at Senator Nelson or Senator Lieberman, I imagine a red dot on their

[redacted] said that the call was not recorded and when he called, the caller ID only showed up as Lincoln, NE. [redacted] and her supervisor, [redacted] checked their records and found they had phone calls and letters from [redacted] addressed to Senator Nelson in the past and noted they were all very cordial. [redacted] said she was "disturbed" by the way [redacted] talked about the Senator.

[redacted] was comprehensively interviewed by the writer on 12/23/2009 (see referenced case serial, 89A-OM-53093, Serial 8). The results of that interview were discussed with Nebraska Assistant United States Attorney, [redacted] who encouraged that [redacted] contact [redacted] MD, who had been treating [redacted] for Post Traumatic Stress disorder at the Veteran's Hospital in Lincoln, Nebraska. [redacted] had a session with Dr. [redacted] on 12/23/2009, after which the writer received a call from [redacted] who briefly advised that he spoke with [redacted] about the threatening voice message he left at Senator Nelson's office and determined he was not an immediate threat. The writer arranged to conduct a more in depth interview with [redacted] at a later date. The writer followed by apprising the U.S. Attorney's Office, U.S. Capitol Police, Senator Nelson's office and FBIHQ of the investigative results outlined above.

The writer conducted an in person interview of [redacted] on 01/06/2010 (see referenced case serial, 89A-OM-53093, Serial 9). [redacted] advised that he had a session with [redacted] on 12/23/2009, after [redacted] was initially interviewed by the FBI. After reading the transcript from [redacted] 12/13/2009 interview by the LPD, [redacted] advised that [redacted] had been candid with him about recent events surrounding his call to Sen. NELSON's office. [redacted] did not appear symptomatic (e.g., was not too anxious or distraught) or suicidal when they met and was very remorseful for his actions. [redacted] advised that this is typical of [redacted], advising that [redacted] often knows right away that he has overreacted but at the time he feels compelled to try and save face and justify his position. [redacted] does not consider [redacted] a threat to act out on the veiled threats to Senators NELSON and LIEBERMAN. On 12/23/2009, [redacted] prescribed Celexa for [redacted] 5mg once a day, for PTSD and depression. [redacted] will continue to see [redacted] on a as needed basis. [redacted] has been taught all of the PTSD coping methods and knows what trigger issues in life to avoid.

[redacted] admitted to being a political activist and stated he often sends email messages to other political activists as well as to politicians. Concerning the threatening email message directed toward Senator Blanche Lincoln, [redacted] initially stated he wrote the portion of the email message that was not threatening but later apologized if the message was perceived to have been threatening. [redacted] stated that he specifically tries not to be threatening in his email messages, that he had no intent of threatening anyone nor would he carry out any perceived threats.

[redacted] accepted SA [redacted] admonishment to not send threatening emails to any individual, and acknowledged SA [redacted] advisement that sending such communications to members of Congress is a violation of federal law. [redacted] stated he would be careful in his future email messages to not use words that could be perceived as threatening.

On April 14, 2010, [redacted] Assistant U.S. Attorney, District of Columbia, issued a declination concerning captioned case. No further investigation is deemed necessary, no items of evidence are maintained by the FBI and there are no statistical accomplishments to claim at this time.
