THREATENING PHONE CALL TO U.S. SENATOR BUNNING

On 02/26/2010, at approximately 11:18 a.m., a voice

mail was recorded at Senator JAMES BUNNING's Louisville, Kentucky office from a telephone number captured as transcript of the call is as follows:
"Uh, Senator BUNNING, you mother-fucker, if I lose my unemployment benefits, you know, I'm gonna blow your fucking head off your head. You mother-fucker, and you know what, I'm commin' after your fucking family. If I lose my health insurance, my COBRA and my unemployment, you mother-fucker, because of an asshole basketball game, I'm comin' after you, you mother-fucker. You hear me?"
Following the receipt of this call, the Louisville Division conducted logical investigation concerning this matter. The incoming telephone number of the threatening call was identified as A check through open source databases was conducted and returned no subscriber information but identified the service provider as SBC, an AT&T owned company. An Emergency Request for Assistance for subscriber information was sent via facsimile to AT&T with negative results; the number was not serviced by AT&T. A call to the number revealed a prepaid service to recharge cellular phone minutes, in Spanish, with the location ultimately determined to be in Salt Lake City, Utah.
The main telephone trunk line, which was identified to be the number dialed to reach Senator BUNNING's office, was A Request to AT&T For Customer Communication Records, for the above referenced telephone number, was sent via facsimile for all telephone numbers received from one hour before through one hour after the recorded voice mail threat. Only one telephone number matched the approximate time and length of the threatening telephone call and was identified as Through an open source internet search, the service provider was identified as NEXTEL/SPRINT.

The envelope and letter were typed, possibly on a computer, and no hand writing appears on the envelope or in the letter. The white envelope had a "Liberty Bell" first class stamp on it, and the return address area had the typed phrase:

"The voice of the American People"

The letter was addressed to:

"The Honorable Mr. Minnick 33E. Broadway Ave. Meridian, ID 83642"

The three-page letter is typed in bold font, is not dated, and has no opening nor closing salutation. On page two of the letter are three images of reticles (cross hairs) from a rifle scope. In the opening paragraph, the letter writer claims

The writer of the letter does not mention Rep. Minnick by name, but does mention President Obama, AG Holder, and "Weiner *, Dodd, Pelosi, Lincoln, Frank, Stupak, Reid, Grayson***, Salazar, Titus, Shea-Porter, Himes, Kilroy, Dahlkemper, Clayburn, ... It is unknown why the one asterisk was placed next to the last name "Weiner," and why three asterisks were placed next to the last name "Grayson." The

letter writer alleges that he/she is part of a small group, and that "if you are a supporter of the progressive agenda being pushed by Mr. Obama, and King and Queen Reid and Pelosi," then you risk death. The letter indicates the complaint by the "group" is not with any one particular political party, but any person that supports Health Care, Cap and Trade, the "takeover of our Education system," etc. risks death of himself/herself and their family. Of concern to Rep. Minnick's staff was the phrase: " Vote in favor of progressive liberal programs and DIE in the near future or distant future make no mistake we will come for you, take the wife out to dinner risk getting shot, take the kids to soccer practice risk getting shot...." advised that Rep. Minnick has family members that play soccer, and the above threat about killing family members at "soccer practice" was unnerving.

The letter writer also implied that he/she (or the "group") had a .50 caliber weapon: "Keep up this insanity and we will make an appointment for you to meet Mr. Barrett he can reach out and touch you up close and personal." Agent's note: The Barrett Firearms Company makes and markets numerous .50 caliber rifles that are accurate and lethal to distances over one mile.

Writer provided the original envelope and letter to USSS SA, at his request.
Writer made contact on 3/19/2010 with U.S. Capitol Police Detective Threat Assessment Squad, cell e-mail cap- police.senate.gov. Det. advised that he was not aware of any other letters similar to this threat letter, and he no information that this letter was mass mailed to numerous members of Congress. On 3/22/2010 writer contacted SA WFO, VCMO, cell Writer subsequently forwarded a copy of the letter to SA via e-mail.

Details: On 05/18/2010, Boise RA received the Idaho State Police Forensic Services Fingerprint Analysis Report for the three sheets of white paper and one envelope. These items had been sent to US Representative Walt Minnick, Boise, Idaho on 3/16/2010. Within the typewritten pages, which were mailed through the United States Postal Service (USPS), are threats to various government officials, including President Barack Obama. The results of the attempt to lift latent fingerprints from the paper and envelope in an effort to identify the sender of the letter were negative.
Boise FBI has discussed the matter with US Secret Service Special Agent, Boise, Idaho. SA advised after receiving the negative results from the fingerprint analysis, the US Secret Service had closed their file on this matter.


