On 01/05/2010, a call was made from (800)601-7498 to [REDACTED]. An automated message concerning health care was played. At the end of the call the receiving party was told that they could be connected directly to their Senator if they pressed "1". The party was connected to Senator Feingold's office and the threatening message was left.

Facts of Incident:  
On 01.07/2010, SA [ ] received an email from LPD Inv [ ] attaching two files pertaining to two separate incidents (one a harassing voice-mail message and the other a threatening fax received by Senator Ben Nelson's Lincoln office). The facts of this complaint will pertain to threatening facsimile received.

On 01/06/2010, Sen. Ben Nelson's office contacted and reported to the LPD that on 12/24/2009, at 11:17 a.m., the office received a two page fax from [ ] dated 12/24/2009 10:16:19 am. [ ] listed his email as [ ]@elsiecomm.net and the fax showed it came from [ ]. The content of the fax read "from a voter in Nebraska, as of today, you are dead meat." Sen. Nelson's office indicated they were disturbed by the content of the fax and after checking their records advised that they have had previous correspondence with [ ] in the form of faxes and letters, but none were threatening in nature. The LPD placed a copy of this fax into property as potential evidence. b6 b7C

A copy of the email received from Inv [ ] and copy of the threatening fax received by Sen. Nelson's office is being included as an attachment to this complaint.

On 01/08/2010, SA [ ] telephonically notified SA [ ] U.S. Capitol Police, Threat Assessment Section, 119 D Street NE, Washington, DC 20510, [ ] of said complaint information. SA [ ] was forwarded the email from the LPD, which included attachments pertaining to both threats to Sen. Nelson's office. SA [ ] indicated they would do a threat assessment on this matter and re-contact the FBI with their findings and recommendations.

On 01/08/2010, AUSA [ ] advised that the Nebraska U.S. Attorney's office would like [ ] contacted.

On 01/11/2010, SA [ ] re-contacted the FBI and advised that their threat assessment did not show an immediate credible threat as to this matter (see attached email from SA [ ] dated 01/11/2010). SA [ ] did request that someone contact and interview [ ] and if notify them of the results.

Assessment Findings: On 01/19/2010 [redacted] white male, date of birth [redacted] (73 years old), was contacted at his residence [redacted] by Special Agent [redacted] (FBI-Omaha) and advised of the official identity of the interviewing agent through a display of credentials as well as the purpose of the interview. [redacted] admitted he had sent a fax to Nebraska Senator Ben Nelson on 12/24/2009 which read "From a voter in Nebraska, as of today, you are dead meat." [redacted] then provided the following information:  The fax sent to Senator Nelson was an expression of [redacted] displeasure at Senator Nelson's vote on the health care bill. [redacted] did not mean to imply a physical threat to Nelson, rather he meant Nelson's political career was "dead" as a Nebraska Senator because he wasn't listening to his constituents.	
[redacted] was warned that further incidents of communications involving language which could be taken as threatening would be quickly investigated. [redacted] stated he understood, and although he intended to continue to e-mail the Senator, he would not use language which could be construed as threatening.

[redacted] Staff Assistant, work [redacted] advised writer that Rep. Minnick's office had received a typed threat letter in the mail. [redacted] It is unknown why the one asterisk was placed next to the last name "Weiner," and why three asterisks were placed next to the last name "Grayson." The

letter writer alleges that he/she is part of a small group, and that "if you are a supporter of the progressive agenda being pushed by Mr. Obama, and King and Queen Reid and Pelosi," then you risk death. Minnick's staff was the phrase: "Vote in favor of progressive liberal programs and DIE in the near future or distant future make no mistake we will come for you, take the wife out to dinner risk getting shot, take the kids to soccer practice risk getting shot...." [redacted] advised that Rep. Minnick has family members that play soccer, and the above threat about killing family members at "soccer practice" was unnerving.

The letter writer also implied that he/she (or the "group") had a .50 caliber weapon: "Keep up this insanity and we will make an appointment for you to meet Mr. Barrett he can reach out and touch you up close and personal." Agent's note: The Barrett Firearms Company makes and markets numerous .50 caliber rifles that are accurate and lethal to distances over one mile.

Also of concern to Rep. Minnick's Communication Director, [redacted] was a scheduled protest the following day, Saturday, 3/20/2010, outside City Hall against Rep. Minnick. Ferguson advised that Rep. Minnick consistently stated that he opposed the Health Care Reform Act Bill and was voting "No," but the RNC and others had mistakenly claimed that Rep. Minnick supported the bill. [redacted] was concerned that [redacted] a Nampa, Idaho resident and political blogger/activist, planned to be at the 3/20/2010 protest. [redacted] told the media (Idaho Statesman newspaper) on 3/19/2010 that they (the protesters) intend to be "militant." There is no information to suggest that [redacted] or any area protesters were connected to the mailing of the threat letter.

After being advised of this incident, SA  contacted the FBI OKC office and agents were dispatched to S's residence. Contact was made with S who denied making any threats to kill a VA worker.

Both VA OIG and the Federal Protective Service (FPS) were notified of this incident. FPS obtained a federal "No Trespass" order against S so that if he enters any FPS facility he will be arrested. S's photograph was also disseminated to all FPS facilities.

On 10/07/2010, [REDACTED] was contacted. He admitted he called Sen. McCain's office and was angry when he called. He denied making threatening calls to the Senator said, "Prove it." He said he was just frustrated because McCain had seized his bank accounts. [REDACTED] explained in 1974, he cashed in 400 to 500 pounds of gold in Stevens Point, WI. With that money, he bought some real estate in Hales Corners and Greenfield, WI. He said he was shot in the head and had been in Phrasier Hospital in Wauwatosa, WI. He said in 1982, he was in Operation Desert Shield and had been shot in the head there too. [REDACTED] said he was a tank gunner and an infantry man. He stated he was also a musician and that was how he met and married Brooke Shields. They were married in Las Vegas; however, she was a lying bitch. [REDACTED] said he also knew Alice Cooper and dated Pat Benetar. [REDACTED] stated he was also a cameraman for NBC. He said he had worked for the Greenfield, Wisconsin Police Department, and had worked for the Rusk County Sheriff's Department (RCSD), Ladysmith, Wisconsin. (I was accompanied by the RCSD Chief Deputy and [REDACTED] claim of employment with the RCSD was untrue.) [REDACTED] said he knew Barack Obama when they were growing up in Wisconsin. [REDACTED] also said he owned property near the Flambeau River, next door to Alex Trebek (the game show host). He stated he had been on the Russian Space Station and had been rescued by them. Apparently [REDACTED] was on a flight and the pilot diverted the plane and they wound up in space.

[REDACTED] said he was not threatening Senator McCain. He was just frustrated that McCain had seized his bank accounts. [REDACTED] said his comment about someone moving his hand when he pointed the gun to shoot McCain referred to an incident at a campground near Cornell, WI several years ago. A gun had been glued to [REDACTED] left hand and McCain had started a riot at the campground. During the riot, McCain was shot.

[REDACTED] was asked not to bother the Senator any more.

[REDACTED] was disheveled in appearance and delusional. When surprise at the unbelievable nature some of his comments was demonstrated, he became agitated and angry that he was not being believed.

On October 8, 2010, First Assistant United States Attorney (FAUSA) [REDACTED] United States Attorney's Office, Western District of Wisconsin, Madison, Wisconsin, was contacted and advised of the results of contact with [REDACTED]. FAUSA [REDACTED] stated it appeared this situation was a mental health issue and was not something which should be handled in the criminal justice system. FAUSA [REDACTED] stated he would decline prosecution of this matter due to insufficient evidence of a serious threat, the case lacked prosecutive merit and it was something which would be better handled by local authorities.

A database search was conducted on the telephone number that placed the threatening call to Shuler's office. The search identified the subscriber of cellular telephone number [REDACTED] [REDACTED] as CINGULAR WIRELESS customer [REDACTED] date of birth (DOB) [REDACTED] social security account number (SSAN) [REDACTED] who resides at [REDACTED] Marion, North Carolina.

[REDACTED] was interviewed at his residence by the authoring Agent and TFO [REDACTED] on 10/31/2010, with the assistance of deputies from the McDowell County Sheriff's Office (MCSO). During the interview [REDACTED] advised that he previously owned a cell phone with the number [REDACTED] but that he threw the phone away approximately 6-12 months prior to the interview. He repeatedly insisted that the phone was not given to anyone, but that it had been discarded.

Following the interview [REDACTED] was taken in custody by MCSO deputies for a drug paraphernalia investigation. On Saturday 11/6/2010, A/SSRA [REDACTED] telephonically contacted SA [REDACTED] United States Secret Service and advised him of the email threat.
