2 JOHN: -- reveal himself to all that were
3 there to hear.

4 DAVID: No.

5 JOHN: What?

6 DAVID: No, he didn't.

7 JOHN: Why, why do you say that?

8 DAVID: It says neither his brethren believed
9 on him.

10 JOHN: It doesn't -- I don't say that they
11 believed in him. I said but he was there --

12 DAVID: He gave many infallible proofs --

13 JOHN: To reveal.

14 DAVID: It says though he gave many
15 infallible proofs, yet they believed not on him. He
16 could become convincing.

17 JOHN: That, that doesn't mean he's not
18 giving them the opportunity to listen and the
19 opportunity --

20 DAVID: Exactly. Exactly.

21 JOHN: -- to hear.

22 DAVID: Well, that's what I'm doing.

23 JOHN: And, and you're saying no, he didn't.

24 DAVID: I am saying, clearly, as the record
25 records, this is some homework for you, Matthew, Mark,
Luke, and John. Look and see.

1 JOHN: Uh-huh.

2 DAVID: You've got a good mind. Search the
3 scriptures.

4 (Ringing sound.)

5 DAVID: So, it says here thou hast put
6 gladness in my heart more than a time their corn and
7 wine were increased. I'll both lay me down in peace
8 and sleep, for thou, Lord, only makes me to dwell in
9 safety. So, I'm waiting for this, waiting on my
10 father's next answer.

11 JOHN: Um-hum.

12 DAVID: You know, I'm resting quite well now,
13 okay? Now, let's turn here to Psalms 18 and find out
14 how this is going to work out. Okay? This is what I'm
15 trying to keep from happening to, to you. I mean, I
16 call you brethren, you know. These, these young ATF
17 agents who lost their life out of this, if you play
18 your cards right they'll be back shortly. Promised. I
19 know you can't believe that right now.

20 JOHN: That's like you're, you're coming out
21 immediately. What does shortly mean?

22 DAVID: (Chuckling.) Okay, John.

23 JOHN: Huh? A matter of --

24 DAVID: Don't, don't --

25 JOHN: -- semantics here?

DAVID: -- don't keep poking. Let's learn

1 some stuff. Now, let's hear God. This is God's word.

2 Don't worry about me. I'm just a fool.

3 JOHN: No, you just told me the Lo-- you're
4 the Lord.

5 DAVID: Did I tell you the Lord or did God
6 say no one can reveal the seals but the lamb?

7 JOHN: You told me you are the Lord, did you
8 not?

9 DAVID: I did say that --

10 JOHN: Oh, yes.

11 DAVID: -- hoping you would see that in the
12 Psalms 45 --

13 JOHN: Well, we're up to 18 right now.

14 DAVID: Okay. Now, I love the Lord. Why?
15 He's my what? Strength. The Lord is my rock, my
16 fortress, my deliverer, my God, my strength in whom I
17 will trust, my buckler and the horn of my salvation, my
18 high tower. People keep wondering how I knew you'all
19 guys were coming. Well, I got a high tower, right?

20 JOHN: Um-hum.

21 DAVID: But not the one you think. I will
22 call upon the Lord --

23 JOHN: Well, you have two high towers.

24 DAVID: Well --

25 JOHN: Right?

DAVID: Not the one --

1 JOHN: The physical one and the one that
2 isn't.

3 DAVID: The one who sees all things before
4 they happen.

5 JOHN: The spiritual one.

6 DAVID: Exactly. I will call upon the Lord
7 who is worthy to be praised. So shall I be saved from
8 mine enemies. The sorrows of death can pass me and the
9 floods of ungodly men made me afraid. The sorrows of
10 hell can pass me about and the snares of death
11 prevented me, prevented me from what? Well, what am I
12 trying to do? I'm trying to teach something, aren't I.
13 In my distress I call upon the Lord and cried unto my
14 God. He heard my voice out of his temple. Do you know
15 what that temple is? It's a long ways off but it's
16 very close by. And my ears, his cry came before him
17 even to his ears.

18 JOHN: Back up a little there.

19 DAVID: Go ahead.

20 JOHN: The temple.

21 DAVID: Uh-huh.

22 JOHN: In my distress called upon the Lord
23 and cried unto my God and he heard my voice -- out of
24 his temple?

25 DAVID: Uh-huh. That's where he's at right
now --

1 JOHN: Okay.

2 DAVID: -- sitting on the throne.

3 JOHN: All right.

4 DAVID: Same as in Psalms 2. He that sitteth
5 in heaven shall laugh. I mean, he's laughing right now
6 at ya'll and I'm --

7 JOHN: He's laughing at who?

8 DAVID: He's laughing at ya'll.

9 JOHN: Why do you say that?

10 DAVID: Because --

11 JOHN: We're his children too, aren't we?

12 DAVID: Well, only if you believe his word,
13 for he who is of God heareth God's word. Now --

14 JOHN: Now, do you believe -- do you think
15 and believe me when I tell you I believe in, in the
16 Lord?

17 DAVID: Well, you believe in what you know of
18 the Lord.

19 JOHN: And in salvation?

20 DAVID: But, see, you believe --

21 JOHN: And in the resurrection?

22 DAVID: You -- okay. You believe --

23 JOHN: And in the Ten Commandments?

24 DAVID: Well, what about the other
25 commandments?

JOHN: Do you believe in the Ten

1 | Commandments?

2 | DAVID: Oh, yes, I do. Now, with God --

3 | JOHN: All of them?

4 | DAVID: Yes, I do. When God says thou shalt
5 | not kill, he meant Israel. Of course, the Lord
6 | commanded Israel to destroy the heathen, didn't he?

7 | JOHN: He meant Israel?

8 | DAVID: Didn't he?

9 | JOHN: He, he --

10 | DAVID: Are you telling me that Moses and
11 | Israel did not kill the heathen?

12 | JOHN: Well, sure.

13 | DAVID: Okay. So, exactly, you agree then --

14 | JOHN: Well, when he said thou shalt not
15 | kill, he --

16 | DAVID: He --

17 | JOHN: -- means thou shalt not kill, doesn't
18 | he?

19 | DAVID: He -- well, then why did he command
20 | to offer the sacrifices then? You have to interpret
21 | what God tells you when God tells you as God tells you.

22 | JOHN: Um-hum.

23 | DAVID: Now, God did not talk to you. He
24 | spake to Moses (indiscernible) he spake to Israel.
25 | Now, today --

 JOHN: Well, he speaks to me. When I go to

1 church, he speaks to me a little closer, doesn't he?

2 DAVID: I don't think so.

3 JOHN: What -- how can you say that?

4 DAVID: Well, because you're just -- do you
5 want to learn these Psalms or do you want to scoff?

6 JOHN: Go ahead.

7 DAVID: Okay.

8 JOHN: I'm not scoffing you.

9 DAVID: In my distress I called upon the Lord
10 and cried unto my God. He heard me at -- my voice out
11 of his temple. My cry came before me into his ears.

12 JOHN: Uh-huh.

13 DAVID: Then the, then the earth shook and
14 trembled. You ever heard of the sixth seal? The
15 foundations all through the hills were moved and were
16 shaken because he was wroth. Smoke out of his nostrils
17 and fire out of his mouth devoured. Coals were kindled
18 by it. He bowed the heavens also and came down and
19 darkness was under his feet. He rode upon a cherub.
20 See, the cherubs a masculine angel. Read Ezekiel when
21 you get a chance. And did fly -- he did fly upon the
22 wings of the wind. He made darkness his secret place,
23 his pavilion. Round about him were dark waters and big
24 clouds of the skies. And the brightest as before him
25 as thick clouds passed, hailstones and coals of fire.
The Lord also thundered in the heavens and the highest

1 gave his voice. Hailstones and coals of fire. How did
2 he talk to my enemies? Very physically.

3 JOHN: Um-hum.

4 DAVID: Yeah, he sent out his arrows and
5 scattered them and he shut out lightning that
6 discomfited them. And the channels of the waters were
7 seen and the foundations of the world were discovered
8 it by rebuke at the blast of the breath of my nostrils.
9 He sent me from above. He took me. He drew me out of
10 many waters. He delivered me from my strong enemy and
11 from them which hated me, for they were too many for
12 me. Oh, my. There's too many, huh? They prevented me
13 the day of my calamity. Do you know what a calamity
14 is?

15 JOHN: Sure.

16 DAVID: What we're involved in now, isn't it?

17 JOHN: Yeah, it sure is.

18 DAVID: But the Lord was my stay. That's why
19 in Psalms 2 it says yet have I set my king upon my Holy
20 Hill of Zion. He brought me forth also onto a large
21 place, which is back to the sea of glass. He delivered
22 me because he delighted in me. The Lord rewarded me
23 according to my righteousness, according to the
24 cleanness of my hands hath he recompensed me. I have
25 kept the ways of the Lord and have not wickedly
departed from my God, for all these judgments, all

1 seven seals were before me, and has not put away his
2 statutes from me. I was also right before him and I
3 kept myself from mine inequity. You see, in one of
4 those judgments God requires me to give up something,
5 and I'll explain that later. Therefore, the Lord
6 recompensed me according to my righteousness, according
7 to the cleanness of my hands in his eyesight. Now --

8 JOHN: Yeah.

9 DAVID: -- with the merciful. Thou wilt show
10 thyself merciful. Are you being merciful to me, John?

11 JOHN: I sure am.

12 DAVID: God's going to be merciful with you
13 then.

14 JOHN: Don't you think I am?

15 DAVID: So far. As an upright man thou wilt
16 show thyself --

17 JOHN: Are you going to be merciful to me?

18 DAVID: Well, if you play your cards right
19 I'm --

20 JOHN: Oh, no, no, no. Are you going to be
21 merciful?

22 DAVID: I'm being merciful now and I'll
23 remain to be merciful. But you --

24 JOHN: You know, because, basically, you're
25 saying when, when you're giving your opinion you're
instructing and when I say something to you you accuse

1 me of scoffing, and I'm not doing that.

2 DAVID: No, no.

3 JOHN: Do you think I'm doing that?

4 DAVID: Do you see these words here?

5 JOHN: Huh? Answer me. Do you think I'm
6 scoffing you?

7 DAVID: I know that you're scoffing.

8 JOHN: No. I'm really not. I'm trying to
9 understand what you have to say.

10 DAVID: With the merciful thou wilt show
11 thyself merciful. Be merciful, John. That's what I'm
12 trying to say.

13 JOHN: Well, I think I am.

14 DAVID: With an upright man thou wilt show
15 thyself upright. With the pure thou wilt show thyself
16 pure. And with the forward, those who interrupt and
17 those who aren't learning, listening to learn, thou
18 wilt show thyself forward. For thou wilt save the
19 afflicted people. We're being afflicted right now,
20 John, but thou wilt bring down high looks. Arrogancy
21 seeks to be humbled. Why? For thou wilt light my
22 candle. There are seven candles where I come from and
23 I know clearly what light they shine. The Lord my God
24 will light in my darkness --

25 JOHN: David, do you believe some afflictions
can be brought upon people by their, their own actions,

1 | though?

2 | DAVID: Oh, definitely. I mean, the actions
3 | of Christ got nothing but affliction upon him two
4 | thousand years ago.

5 | JOHN: Sure. Sure.

6 | DAVID: But his actions were justified and
7 | preordained by God.

8 | JOHN: How long did it take people to
9 | understand that?

10 | DAVID: Well, two thousand years they haven't
11 | --

12 | JOHN: Hey --

13 | DAVID: -- understood yet, have they?

14 | JOHN: Many haven't. Many haven't.

15 | DAVID: Some even today don't understand.
16 | For by thee have I run to a truth. Now, this is what's
17 | fixing to happen. And by my God have I leaped over a
18 | wall. For God, his way is perfect. You know those
19 | seven seals?

20 | JOHN: Um-hum.

21 | DAVID: The word of the Lord is tried. You
22 | need to learn those seals, John. He's a buckler to all
23 | those that trust in him, and a buckler is someone that
24 | prepares you for war. For who is God save the Lord and
25 | who is a Rock save our God? It is God that girdeth me
with strength and maketh my way perfect. He maketh my

1 feet like hind's feet. Now, here's the verse we need
2 to look at. He setteth me upon my high places. He
3 teacheth my hands to war so that a bow of steel is
4 broken in my arms. Thou hast given me the shield of
5 thy salvation and thy right hand is holding me up and
6 thy gentleness hath made me great. Thus the Lord has
7 made steps under me that my feet did not slip. I have
8 pursued mine enemies and overtaken them, neither did I
9 turn again till they were consumed. I have wounded
10 them that they were not able to rise. They are fallen
11 under my feet. Well, thou hast girded me with strength
12 unto the battle. Thou subdued under me those that rose
13 up against me. Thou hast also given me the necks of
14 mine enemies that I might destroy them that hate me.
15 They cried, but there was none to save them. Even to
16 the Lord, but he answered them not. Then that I beat
17 them small as the dust before the wind. I did cast
18 them out of the dirt in the street. Thou hast
19 delivered me from the strivings of the people. Thou
20 hast made me the head of the heathen. Sometimes
21 through violence you have to teach people a lesson,
22 John. You know that.

23 JOHN: Are, are you trying to tell me
24 something here, David?

25 DAVID: Is God telling you something through
this prophecy? Do you know who has the key of David?

1 Do you know who has opened the Psalm up to you
2 forewarning you of the events that I am trying to keep
3 you from fulfilling?

4 JOHN: Um-hum.

5 DAVID: People whom I have not known shall
6 serve me. Not everybody knows me. But they're fixing
7 to know me. But I wish we could do it the first way.
8 As soon as they hear of me they shall obey me and --

9 JOHN: Why do you say you wish we could do it
10 the first --

11 DAVID: Well --

12 JOHN: -- way?

13 DAVID: Let me keep explaining.

14 JOHN: What, what makes you think we can't?

15 DAVID: Well, because you'all jumped in on
16 top of me. Let me explain. The stranger shall submit
17 themselves unto me. The stranger shall fade away and
18 be afraid of their close places. The Lord liveth and
19 blessed be my rock. Let the God of my salvation be
20 exalted. It is God that avengeth me and subdueth the
21 people unto me. Save me from mine enemies. Yea, thou
22 liftest me up above those that rise up against me.
23 Thus, deliver me from the violent man. Therefore will
24 I give thanks unto thee, O Lord, among the heathen and
25 sing praises unto thy name. Great deliverance giveth
he unto his king and showeth mercy unto his anointed,

1 to David and to his seed forever more. Now, these
2 events of the sun and the stars being darkened of the
3 sixth seal, we're right now in the fifth seal. In the
4 times that I have -- as it says in the Psalms, my times
5 are in my hand -- I have an allotted amount of time to
6 teach the people who wish to know the seals. And as we
7 turn from the fourth and go into the fifth seal, no
8 longer is the beast assist the opening of the fifth,
9 sixth, and seventh seal. Why?

10 JOHN: No longer is what? I'm sorry.

11 DAVID: Well, you see, when the first four
12 seals are opened in heaven, one of the beasts they come
13 and see. Now, if you understood the mystery of the
14 beasts, then you would understand the story of a great
15 king called Nebekenezzer --

16 JOHN: Um-hum.

17 DAVID: -- and how God has foretold him of
18 the rise and fall of empires, how that in the time of
19 the end these empires be brought unto a judgment.
20 Well, we are fulfilling a prophecy. And the world who
21 knows it not, naturally it's going to scoff. Naturally
22 it's going to make decisions contrary to the will of
23 God. Now, how can they know what they're doing if the
24 words of truth are hid from them? Well, how come they
25 haven't been studying the scriptures? All of this time
has been given. At least the past five hundred years.

1 Especially America. How come men having known that
2 when there's time no longer a mystery of God will be
3 finished. Has God declared to his servants, the
4 prophets? How come your church and your ministries
5 didn't forewarn you of these things? Let's turn to the
6 Book of Nahum now. This is more meaty. But it'll
7 explain something about your little chariots and stuff
8 out here. The prophets are considered mysteries to
9 many because when the prophets wrote of the events,
10 they had to describe things they saw in the future by
11 things that they were familiar with in their day. Do
12 you understand that statement, John?

13 JOHN: Oh, I'm trying to find the Book of
14 Nahum. Hang on.

15 DAVID: Okey-doke.

16 JOHN: Probably going the wrong direction.

17 DAVID: Okay. You keep going to the right
18 towards the end of the book. It's, it's in the
19 prophetic writings. You got Ezekiel, Daniel --

20 JOHN: Gotch ya.

21 DAVID: It's after Daniel.

22 JOHN: Okay. Gotch ya.

23 DAVID: Okay.

24 JOHN: Go ahead. I'm sorry. I didn't -- I
25 was trying to find this and you were saying something.
It's like me trying to chew gum and walk. Give me a

1 break.

2 DAVID: Okay.

3 JOHN: Go ahead. I'm at the Book of Nahum.
4 And you were saying something.

5 DAVID: Okay. I'm trying to find it myself.
6 Anyway, the book starts off with God as jealous, right?

7 JOHN: Yes.

8 DAVID: God is furious. The Lord revengeth,
9 right?

10 JOHN: Um-hum.

11 DAVID: Okay.

12 JOHN: Did you find it?

13 DAVID: Yeah. I've got it.

14 JOHN: Okay.

15 DAVID: Because I usually just -- I just
16 usually quote these books, because I -- my book, my
17 book is not like your books either. So, anyway. This
18 is the vision of Nahum, burden of Nineveh. God is
19 jealous, the Lord revengeth. The Lord revengeth and is
20 furious. Now, why would God be jealous for? Remember,
21 every thought of God harmonizes with every thought of
22 God. Remember in Psalms 45 God said he thought his son
23 was the fairest of men? Remember that?

24 JOHN: Um-hum.

25 DAVID: Maybe some may not think that. But,
anyway, God being jealous, the Lord revengeth, the Lord

1 of vision is furious. The Lord will take vengeance on
2 his adversaries. Remember in Psalms 2 the heathen
3 raged and they go against God's word? And he said to
4 his anointed let's break his bands of son? And they
5 don't want those seals, do they?

6 JOHN: Hmm.

7 DAVID: He reserveth wrath for his enemies.
8 The Lord is slow to anger and great in power, that will
9 not at all acquit the wicked. Okay? The Lord hath his
10 way in the whirlwind. Remember Psalms 18?

11 JOHN: Um-hum.

12 DAVID: And the storm and the clouds are the
13 dust of his feet. Remember Psalms 18? We just read
14 it, didn't we? He rebuketh the sea and maketh it dry
15 and dries up all the rivers. Bashan languisheth and
16 Carmel and the flower of Lebanon languisheth. The
17 mountains quake in him and the hills melt. The earth
18 is burned at his presence. Yea, the world and all they
19 that dwell therein. Who can stand before his
20 indignation? Who can abide of the fierceness of his
21 anger? His fury is poured out like fire and the rocks
22 are thrown down by him. A person you don't want to get
23 on the wrong side of, right?

24 JOHN: Yep.

25 DAVID: But the Lord is good though, John.
Even though he's -- can get angry, he is good. A

1 stronghold in the day of trouble. He knoweth them that
2 trust in him. You know, you trust in the father, don't
3 you? You trust in his word, don't you? You know that
4 the lamb is going to come and reveal the seals, don't
5 you? But with an overrunning flood he will make an
6 utter end of the place thereof. Darkness shall pursue
7 his enemies. Now, what do you imagine against the
8 Lord? He will make an utter end. Affliction shall not
9 rise up a second time. Huh? Second time. Remember
10 two thousand years ago?

11 JOHN: How many times have affliction risen
12 up?

13 DAVID: Now, remember --

14 JOHN: You, you were saying it's only risen
15 one time. You --

16 DAVID: Wait a minute.

17 JOHN: Right?

18 DAVID: Wait a minute. This affliction
19 revolves around with verse 15. Behold up on the
20 mountain the feet of him that bringeth good tidings.
21 Okay? This affliction deals with God being jealous and
22 the Lord revenging. He knows, and the trust in him.
23 This has something to do with God and the seven seals,
24 a message for the latter days. Watch and I'll show
25 you. Now, those whose thoughts, according to Psalms 2,
are contrary to God's thoughts, they imagine an evil

1 | against the Lord. He'll make an utter end. Affliction
2 | shall not rise up again the second time. Two thousand
3 | years ago when Christ came the first time, did they not
4 | imagine evil against the Lord? Did they not choose to
5 | crucify him?

6 | JOHN: Well, we all know what happened.

7 | DAVID: Okay. And affliction did rise up,
8 | didn't it? But we have a promise not the second time.
9 | For while they be thrown together as thorns -- you know
10 | the wicked are a bunch of thorns, right? And while
11 | they are drunken as drunkards, these people are out of
12 | their minds. They shall be devoured as stubble fully
13 | dried. They're going to be burned. There is one come
14 | out of thee -- and as I'm talking to you right now,
15 | this is happening -- that imagineth evil against the
16 | Lord, a wicked counsellor. Thus sayeth the Lord,
17 | though they be quiet and likewise many -- I mean,
18 | outside they're very quiet out here, aren't they? But
19 | there's many of them, isn't there? Yeah, there's a lot
20 | of them. Yet thus shall they be cut down when he shall
21 | pass through. Hey, my father's coming to pay a visit.
22 | I know you don't believe that yet, but let's keep
23 | learning and maybe you might. Though I've afflicted
24 | thee, I will afflict thee no more. Talking about us
25 | right here. For now will I break his yoke from off
thee and I will burst thy bonds asunder. See, y'all

1 | have got this yoke on me right now. You know, you --

2 | JOHN: No, no, no.

3 | DAVID: -- call me --

4 | JOHN: -- no.

5 | DAVID: -- you call me the --

6 | JOHN: That's your interpretation of it.

7 | DAVID: Well, now, exactly. Let me explain
8 | why. Let's finish the book before we make our opinions
9 | out. It says here, this is a conversation between
10 | somebody and somebody. It's a situation of somebody
11 | having a yoke on somebody else and someone says I'm
12 | going to break thy bonds asunder and I'm going to
13 | deliver you. And the Lord hath given a commandment --

14 | JOHN: Wait. Why do you say we have a yoke
15 | on you? Huh?

16 | DAVID: Look, you're being judged by my law
17 | right now and you're not afraid. And you're telling me
18 | to come out and be judged by your law. And I'm trying
19 | to tell you that I would more than love to be judged by
20 | your law.

21 | JOHN: But it's your law, too.

22 | DAVID: No.

23 | JOHN: Yes, it is.

24 | DAVID: See, my law comes from a God above
25 | this world. You don't understand yet, John.

 JOHN: Well, sure I understand. I understand

1 | that we're all going to be judged by our actions.

2 | We're going to be --

3 | DAVID: Exactly. Right now.

4 | JOHN: -- judged by our deeds.

5 | DAVID: Your case -- every thought of your
6 | mind is being judged right now.

7 | JOHN: Well, that's for --

8 | DAVID: In regards --

9 | JOHN: -- everyone.

10 | DAVID: -- in re-- in regards to the way
11 | you're --

12 | JOHN: That's --

13 | DAVID: -- dealing with this truth.

14 | JOHN: That, that -- you're, you're trying to
15 | say, you know, you think that I'm, I'm trying to be
16 | facetious about it or something. I'm not.

17 | DAVID: No, I'm not.

18 | JOHN: I'm, I'm being serious.

19 | DAVID: Okay.

20 | JOHN: I'm trying to be. And we will all be
21 | judged --

22 | DAVID: At the judgment --

23 | JOHN: -- not only by the Lord, right? Will
24 | we? Don't you believe that?

25 | DAVID: How does Christ judge? He reveals
truth. I've come to give you my reward. Do you want

1 | the knowledge that I have ahead of time? You want to
2 | escape -- (Unidentified voices in background not
3 | discernible.) -- from making a wrong step --

4 | JOHN: Sure.

5 | DAVID: -- a wrong decision?

6 | JOHN: Sure.

7 | DAVID: Okay. The Lord hath given a
8 | commandment concerning thee that no more thy name be
9 | sown out of the house of thy gods. I will cut off the
10 | graven image of the molten images. I will make thy
11 | grave for thou are vile. Up on the mountains -- behold
12 | up on the mountains the phoenix hand that bringeth good
13 | tides that publisheth peace. O Judah, keep thy solemn
14 | feast. Perform thy vows, for the wicked shall no more
15 | pass through these, early cut off. He that dasheth in
16 | pieces has come up before thy face. Okay. Here you
17 | guys are. Want to dash us to pieces, right?

18 | JOHN: No. How many times did I tell you
19 | not?

20 | DAVID: Okay. But you already started,
21 | though.

22 | JOHN: But you don't listen to me, do you?

23 | DAVID: You already started. You came in
24 | through the gate just like the prophet says. You came
25 | --

 JOHN: No. What I said --

1 DAVID: -- in through the gate --

2 JOHN: -- is what happened happened and we
3 all regret --

4 DAVID: And you can --

5 JOHN: -- what happened.

6 DAVID: -- feel. Now, watch. This will
7 explain exactly the very moves you made already.

8 JOHN: Let, let me ask you something and then
9 continue, okay?

10 DAVID: Go ahead.

11 JOHN: Let me just ask you something. Are
12 you telling me -- and, and I just want you to clarify
13 it. That's all.

14 DAVID: Go ahead.

15 JOHN: Are you telling me that you are not
16 answerable to the Constitution of the United States and
17 the laws of the lands of the United States?

18 DAVID: I am answerable to the laws as far as
19 you can see, but I'm also --

20 JOHN: No, no. You're not answering the
21 question.

22 DAVID: Yes, I am.

23 JOHN: Are you answerable only to the law of
24 God or are you answerable to the Constitution of the
25 United States?

 DAVID: United States.

1 JOHN: Okay.

2 DAVID: And to God's law.

3 JOHN: But you're not willing to be judged by
4 that law.

5 DAVID: Yes, I am. I told you, I'm ready to
6 come.

7 JOHN: But you said I have this yoke around
8 you.

9 DAVID: Well, what hap--

10 JOHN: And I'm telling you that you can walk
11 out that door any time you want. However, you have
12 told me that you're waiting to hear the word, and I'm
13 not arguing with, with you about that.

14 DAVID: Well, I appreciate that. It shows
15 you're being merciful.

16 JOHN: Well, it shows that I believe you
17 telling me what you believe. I don't necessarily have
18 to believe it, but I believe you believe it.

19 DAVID: Okay. Fine. Well, here's what I
20 believe. He that dasheth in pieces has come up before
21 thy face. Keep the munition. What's munition?

22 JOHN: Well, you and I both know what that
23 is.

24 DAVID: It's weapons, isn't it?

25 JOHN: Sure.

DAVID: Watch the way.

1 JOHN: Where are you? Where are you? What
2 paragraph?

3 DAVID: We're in Chapter 2, verse 1.

4 JOHN: Yeah. I'm in 2.

5 DAVID: Okay. Watch the way. What does that
6 mean? Make thy loins strong. Fortify thy power
7 mightily, for the Lord will turn away the exodus of
8 Jacob, that's exodus of Israel. In other words, God's
9 people in this prophecy don't look so hot, do they?
10 The emptiers have emptied them out and marred their
11 vine branches. The shield of the mighty men is made
12 red. The valiant men are in scarlet. The chariots
13 shall be with flaming torches in the day of his
14 preparation. Huh. The fir tree shall be terribly
15 shaken.

16 JOHN: Um-hum.

17 DAVID: The chariots shall rage in the
18 streets. They shall jostle one against another in the
19 broad waves. They shall seem like torches. They shall
20 run like the lightning. Roooor, Roooor (siren sound)
21 -- is you heard all night long out here. Man, they're
22 fast, you know? They get up and go, don't they?

23 JOHN: Um-hum.

24 DAVID: Now, y'all lost the first round.

25 JOHN: No. We all lost the first round.

DAVID: Well, not really, because --

1 JOHN: Yes, we did.

2 DAVID: Let me explain.

3 JOHN: You don't think so?

4 DAVID: Let me explain. If those young men's
5 soul was not right with God according to the knowledge
6 they had?

7 JOHN: Um-hum.

8 DAVID: They've lost forever. Now, if their
9 soul was right, then they won. That's what I'm saying.
10 But now what happens is, it says, he shall recount his
11 worthies. In other words, they step back and they re-
12 enfortify (sic). Okay?

13 JOHN: Um-hum.

14 DAVID: And that's what y'all have done.
15 You've got a lot more --

16 JOHN: That's what we have done.

17 DAVID: Yeah. If you --

18 JOHN: Not you'all. You have done, we have
19 done.

20 DAVID: No, no, no. We already, we already
21 know how many we got. Y'all went and got
22 reinforcements. They shall stumble on the --

23 JOHN: You're not fortified?

24 DAVID: Huh?

25 JOHN: You're not fortified?

DAVID: We're fortified.

1 JOHN: Sure.

2 DAVID: But, but you went --

3 JOHN: But is it necessary?

4 DAVID: Well, you see, the thing of it is
5 it's only necessary --

6 JOHN: I mean, from what you're reading and
7 from what you're telling me --

8 DAVID: Let's repeat. Okay?

9 JOHN: And, and I'm not going to, I'm not
10 going to argue. Your interpretation is your
11 interpretation. All right?

12 DAVID: Okay.

13 JOHN: But by what you were reading to me in
14 your interpretation --

15 DAVID: Do you believe --

16 JOHN: -- I should go tell, tell all the
17 ministers and all the rabbis and all the others here in
18 Waco that they'd better start fortifying their
19 churches, right?

20 DAVID: That's not who the prophecy is
21 addressed to.

22 JOHN: Huh?

23 DAVID: Remember, who only can reveal the
24 book?

25 JOHN: But the question is are you the Lord?
Are you Christ? Are you Cyrus? Are you David? Are

1 | you the lamb? Who are you?

2 | DAVID: When the prophecy --

3 | JOHN: Right now who are you?

4 | DAVID: I'm one trying to show you the seven
5 | seals. Now, go --

6 | JOHN: But who did you tell me you were?

7 | DAVID: -- go learn what that means.

8 | JOHN: Who did you tell me you were?

9 | DAVID: If God sits on the throne, if he gave
10 | the book to the lamb --

11 | JOHN: Yes.

12 | DAVID: You know who I am. And you know who
13 | I claim that I am.

14 | JOHN: And you claim that you're the Lord.

15 | DAVID: I am Christ.

16 | JOHN: Well, you didn't say that. You said
17 | you claimed to be the Lord.

18 | DAVID: Christ is the same as the Lord. King
19 | of Kings and Lord of Lords. The Prince of the kings of
20 | the earth. Yep. What can I say? Shall I lie? No, I
21 | will not lie. And, as I said before, my father sits on
22 | a throne and he said to wait. And you're being judged,
23 | John.

24 | JOHN: Aren't we all?

25 | DAVID: I've already been judged. I already
got the book. I have already been judged. Did you

1 know that?

2 JOHN: What about those people in there with
3 you? Have they been judged?

4 DAVID: They accept my judgment, because in
5 my judgment I don't condemn any. I give --

6 JOHN: You don't what?

7 DAVID: -- people the truth and the truth
8 will set them free.

9 JOHN: You don't condemn anyone?

10 DAVID: None. The condemnation comes when
11 men reject the truth. You see, God sent not his Son to
12 the world to condemn the world. Never has.

13 JOHN: Well, well, from my questioning you,
14 you're probably in your mind saying now, you know, I'm
15 rejecting the truth.

16 DAVID: I didn't say that, Jim. I'm saying
17 --

18 JOHN: John.

19 DAVID: -- let's reason to-- John -- I'm
20 saying we're reasoning together.

21 JOHN: I hope so.

22 DAVID: Exactly. I mean, you've got to,
23 you've got to fight with us. It, it would be crazy for
24 you to, to just begin starting off this procedure and
25 saying, oh, yeah, man, when the guy really opens it up,
it's like he knows what he's talking about, like he's

1 the Lord.

2 JOHN: But you're --

3 DAVID: Don't be a fool.

4 JOHN: -- you're saying that you're Christ.

5 Did Christ run from his accusers or, or did he have a
6 confrontation with his accusers and was he judged by
7 his accusers?

8 DAVID: He was judged by his accusers.

9 JOHN: But you're not willing to be judged by
10 the law --

11 DAVID: I did --

12 JOHN: -- of the land?

13 DAVID: -- not say that. Stop putting words
14 in my mouth.

15 JOHN: Well, you said you were going to
16 answer to another law.

17 DAVID: I am answering to one and both of the
18 laws. See, for your lack of knowledge of the
19 prophecies, for your lack of knowledge of the truth --

20 JOHN: Yes?

21 DAVID: -- you're making all these statements
22 based upon what you perceive.

23 JOHN: No. It's what you told me.

24 DAVID: Anyway, let's, let's look --

25 JOHN: Go ahead.

DAVID: -- at this.

1 JOHN: You -- I mean, did you tell me or
2 didn't you?

3 DAVID: I told you --

4 JOHN: That you didn't have to answer to the
5 law of the land, that you only --

6 DAVID: I said --

7 JOHN: -- answered to a higher law.

8 DAVID: Okay. For instance, right now --

9 JOHN: Yeah.

10 DAVID: -- here's where we're at. I told you
11 I was going to come out and be judged by your law.
12 That's what I --

13 JOHN: And you said that you were coming out
14 immediately.

15 DAVID: Okay. I said I was coming out
16 immediately.

17 JOHN: Yes.

18 DAVID: And then I said --

19 JOHN: You couldn't.

20 DAVID: -- I couldn't. Now, I also said two
21 thousand years ago I'm coming soon.

22 JOHN: Oh, you did?

23 DAVID: Didn't I? Read the gospels. But my
24 father said no. Now, fear God, don't fear me. And
25 when you learn to fear God and learn that his word is
the truth --

1 JOHN: Uh-huh.

2 DAVID: -- then you can put your trust in me.
3 I will show you the words of God. Don't worry about
4 me.

5 JOHN: David --

6 DAVID: Worry about your --

7 JOHN: Was Christ armed, David?

8 DAVID: With two swords.

9 JOHN: Was Christ armed?

10 DAVID: With two swords.

11 JOHN: What did he do with his two swords?

12 DAVID: He told his brethren --

13 JOHN: Did he hurt anybody with them? Did
14 he --

15 DAVID: Not, not yet.

16 JOHN: -- harm any one with them?

17 DAVID: Not yet.

18 JOHN: But did he?

19 DAVID: He destroyed -- he destroys -- he
20 destroyed (indiscernible) --

21 JOHN: We do -- we know what he did to the
22 money changers and to the others, but did he harm
23 anyone with his two swords?

24 DAVID: Who do you think -- this -- look. Do
25 you want to learn this or not, John?

JOHN: Just trying to see where you're coming

1 from, David. I'm trying.

2 DAVID: Psalms 45 is the first seal. The
3 lamb is going to destroy his enemies. Yes or no?

4 JOHN: Sure.

5 DAVID: All right.

6 JOHN: So, according to Psalm 45, yes.

7 DAVID: According to Psalms 45, the first
8 seal, which must be hereafter. Now, let me tell you
9 something. I came into this world in 1959 butt naked.

10 JOHN: Didn't we all?

11 DAVID: Yes.

12 JOHN: We'll go out that way too.

13 DAVID: I came through your system and I
14 learned your laws and I abided by all of your laws. I
15 kept all of your laws. And in 1985 --

16 JOHN: Wait, wait a minute. You kept all of
17 the laws?

18 DAVID: All of the laws.

19 JOHN: Okay.

20 DAVID: In 1985, when I was in Israel, I
21 received additional laws. Okay? And I'm trying to
22 explain to you in all honesty and in all soberness,
23 it's time to fear God and give glory to him for the
24 hour of his judgment is come. This will bring the fall
25 of confusion. That's what I'm trying to explain to
you. He that dasheth in pieces has come up before thy

1 face. God is speaking to somebody. God says to that
2 somebody keep the munition. Watch the way. Make thy
3 loins strong. Fortify thy power mightily. The Lord
4 had turned away the exodus of Jacob. The people of
5 God in this prophecy are not very -- they don't look
6 very good. As the exodus of Is-- for the, for the
7 emptiers have emptied them out and marred their vine
8 branches. These people look in a bad situation. The
9 shield of the mighty men is made red in this event.
10 The valiant men are in scarlet. The chariots shall be
11 with flaming torches in the day of his preparation.
12 This belligerent power, the one who dashes in pieces,
13 Daniel will tell you who that power is. And it says it
14 is the chariots will have flaming torches on them. Fir
15 trees shall be terribly shaken. These chariots, Nahum
16 says, will rage in the streets. They shall jostle one
17 against another in broad waves. They'll seem like
18 torches. They'll run like the lightnings. They're
19 pretty fast, aren't they?

20 JOHN: Um-hum.

21 DAVID: They're tanks, John. He shall
22 recount his worthies. You know, they come together to
23 get more numbers, to get refortified?

24 JOHN: That's an interpretation that they're
25 tanks, isn't it?

DAVID: He recounts --

1 JOHN: Huh?

2 DAVID: He shall recount, meaning he
3 rennumbers his worthies. They shall stumble in their
4 walk though. By their moving forward, they get in
5 trouble.

6 JOHN: Um-hum.

7 DAVID: They shall make haste to the wall
8 thereof and the defense shall be prepared, and the
9 gates of the rivers shall be opened and the palace
10 shall be dissolved. Now, we're getting to the real
11 weird aspect. And Hazab shall be led away captive.
12 She shall be brought up and her maids shall lead her as
13 with the voice of doves. Hooo, hooo, hooo, hoh.
14 Tabern (phonetic) upon their breasts. But Nineveh is
15 of old, like a pool of water, stagnant. And they shall
16 flee away. Stand, stand, shall they cry, but none
17 shall look back. Someone at that point is told to take
18 ye the spoil of silver. Take the spoil of gold, for
19 there's none end of the store and the glory out of all
20 the pleasant furniture. She's empty, void and waste,
21 the heart melted, the, the knees smite together, and
22 much pain is in all loins and all faces of them shall
23 get a blackness. Where is the dwelling of the lions --
24 these tough guys, huh? The feeding place of the young
25 lions -- they thought their sons were going to rule,
huh? Where is the lion? Even the old lion walked, and

1 the lion's weapon, none made them afraid. Man, they
2 thought they were so powerful, didn't they? The lion
3 did tear in pieces enough for his whelps and strangled
4 for his lioness and filled his holes with prey and his
5 dens with raven. I understand. It's just a job to
6 keep yourself going, right? All these guys out here
7 are just making a living, aren't they? Behold I'm
8 against thee, said the Lord of hosts. And I will burn
9 her chariots in the smoke and the sword shall devour
10 her young lions. And I will cut off thy prey from the
11 earth and the voice of thy messengers shall be no more
12 heard. That's what you're doing. You're giving me a
13 message, right? We've had --

14 JOHN: I think you --

15 DAVID: -- several of them.

16 JOHN: I think you're trying to give me a
17 message, aren't you, David?

18 DAVID: Well, I'm saying y'all keep
19 negotiating with us and stuff. But woe to the bloody
20 city.

21 JOHN: No. I'm trying to reason with you and
22 trying to be rationale with you.

23 DAVID: And I'm not being rationale with you,
24 correct?

25 JOHN: You're really not, are you?

DAVID: You don't believe this prophecy, do

1 | you?

2 | JOHN: I --

3 | DAVID: You don't believe --

4 | JOHN: -- believe that --

5 | DAVID: -- you've got --

6 | JOHN: -- I believe that --

7 | DAVID: -- tanks out there, did you?

8 | JOHN: -- you believe --

9 | DAVID: You don't believe you've got --

10 | JOHN: -- what you're telling me.

11 | DAVID: Why would you have tanks out there?

12 | JOHN: To protect our people from your

13 | weapons.

14 | DAVID: From our weapons?

15 | JOHN: From your weapons. Your admitted

16 | weapons.

17 | DAVID: Huh. Well, you know the weapon I

18 | haven't admitted is the greater and above all the

19 | weapons you could ever know of?

20 | JOHN: You've admitted that one.

21 | DAVID: God.

22 | JOHN: Yeah. Well, didn't you just tell me

23 | you're the Lord?

24 | DAVID: Who is this bloody city in Chapter 3?

25 | JOHN: Babylon.

 DAVID: It's all full of lies and robbery and

1 the prey departeth not. If yours had to go to work in
2 a system like this, the noise of a whip, those rattling
3 wheels, prancing horses, and jumping chariots. Horses
4 lifted up both the bright sword and the glittering
5 spear, and there's no -- there's a multitude of slaying
6 and a great number of carcasses. There's none end of
7 their corpses. They stumble upon their corpses,
8 because of the multitude of the hoard under the well-
9 favored harlot. Who is that harlot? You know.
10 Babylon, the mistress of witchcrafts that sells nations
11 to her whoredom and families to her witchcrafts?
12 Behold, I'm against thee, sayeth the Lord of Hosts.
13 That's the father. And I will discover thy skirts upon
14 thy face and I will show the nations thy nakedness and
15 the kingdoms thy shame. I will cast abominable filth
16 upon thee and make thee vile. I will set thee in the
17 gazing stocks. Well, Revelation 18 says, shall come to
18 pass that all they that look upon thee shall flee from
19 thee and say: Nineveh is laid waste. Who bemoan her?
20 When shall I see comforters for thee? Art thou better
21 than populace No (phonetic)? There's a city No --
22 called No, an ancient city, very populated, that was
23 situated among the rivers that had the waters round
24 about it whose rampart was the sea and her wall was
25 from the sea. No, it was impregnable, very strong
place. Ethiopia and Egypt were their strength and it

1 was infinite. Put and Laban were thy helpers, yet was
2 she carried away. She went into captivity. Her young
3 children also were dashed in pieces at the top of the
4 streets and they cast lots for their honorable men and
5 all their great men were bound in chains. I mean, you
6 know, nations can be overthrown, man. Thou also shall
7 be drunken. You know --

8 JOHN: Are you try-- are you trying to tell
9 me something?

10 DAVID: I'm trying to say that God says to
11 somebody that as ancient empires fell so also whoever
12 this empire is will also be drunken. When you're a
13 drunk you're not in your right mind.

14 JOHN: Well, we, we've seen nations
15 overthrown for years, haven't we?

16 DAVID: Exactly. Thou shall be hid. Thou
17 also shall seek strength because of the enemy.

18 JOHN: Um-hum.

19 DAVID: Just so happens God ends up being
20 their enemy. All thy strongholds --

21 JOHN: Listen. Will God have his way whether
22 or not you're inside that compound or outside of that
23 compound?

24 DAVID: God is going to have his way
25 depending --

 JOHN: Will he?

1 DAVID: -- upon what you do.

2 JOHN: What who does?

3 DAVID: You do.

4 JOHN: Well, we've already told you very
5 clearly that, that the -- these people here have
6 absolutely no intention of coming in that compound.

7 And --

8 DAVID: Well, John --

9 JOHN: -- and --

10 DAVID: -- I wish --

11 JOHN: But the yoke is not our yoke upon you.

12 DAVID: Look. Your law --

13 JOHN: You're free to exit there any time you
14 want to exit there and so are all those people. You've
15 told me they're free to leave, haven't you?

16 DAVID: You know, every weapon that I have
17 here I bought on the yellow sheet.

18 JOHN: Every one.

19 DAVID: Every one.

20 JOHN: And none have been remanufactured in
21 any manner? Is that correct? Or you'd rather not
22 answer that?

23 DAVID: Well, if I answer that --

24 JOHN: And I'm not, and I'm not asking it
25 in --

 DAVID: It don't (not discernible) --

1 JOHN: -- in that vein --

2 DAVID: If I, if I answer that, if I say yes

3 --

4 JOHN: Yes?

5 DAVID: -- then you'll say, uh-huh. If I say
6 no, then you won't believe me.

7 JOHN: Uh-huh.

8 DAVID: See?

9 JOHN: I think I have my answer, don't I?

10 DAVID: Yeah, because we've been hearing all
11 over the news, all over, what we have here.

12 JOHN: Well, do you believe everything you
13 hear on the news?

14 DAVID: Well, it comes from ATF. I'm
15 supposed to, aren't I?

16 JOHN: Do you bel--

17 DAVID: Or am I?

18 JOHN: Do you believe everything you hear on
19 the news?

20 DAVID: Is ATF having different words put to
21 their movements of their mouth?

22 JOHN: Well, I don't know. I haven't been
23 listening to the news, to tell you the --

24 DAVID: Right.

25 JOHN: -- truth.

DAVID: Let's get back to one thing. Whoever

1 this power is, all their strongholds shall be like fig
2 trees with the first ripe figs. They'll be shaken and
3 fall into the mouth of the eater. You know what God
4 says about this thing? He says behold thy people, the
5 (indiscernible) of women. God's calling somebody
6 sissies. Thy gage shall be laid wide open to thine
7 enemies. The fire shall devour thy bars. You know,
8 God's -- is the enemy. Just like Joel 2. It says, you
9 know, in Joel 2 the strongest lord executes his word?
10 Ah, you know in the days of Noah, nobody believed Noah.
11 Come on, John. They had to have the waters come and
12 swept them all away, didn't they? Huh? It's just like
13 here in verse 8 -- in verse 17 it says -- in -- I'm --
14 start with verse 16. Thou has multiplied merchants
15 above the stars in heaven. How many merchants do you
16 have in this nation, huh? How many merchants are in
17 the whole world?

18 JOHN: Well, he also said that the merchants
19 are going to see this fire and, and unless this fire is
20 going to --

21 DAVID: No.

22 JOHN: He did.

23 DAVID: No. What I'm saying is those who
24 have ships.

25 JOHN: Well, you identified the merchants as
being who?

1 DAVID: The great men of the earth.
2 JOHN: Sure. And, and those with --
3 DAVID: You know, that is a fact.
4 JOHN: And those with ships, right?
5 DAVID: So, see it afar off. Exactly. And
6 wail, because no one buys their merchandise anymore.
7 When they pull in the dock --
8 JOHN: We don't have --
9 DAVID: -- the dock's not there.
10 JOHN: -- a whole lot of vessels floating up
11 and down the river in --
12 DAVID: Oh --
13 JOHN: -- in Waco, Texas, do we?
14 DAVID: I know, but this is a national thing.
15 Remember. You know --
16 JOHN: Well, --
17 DAVID: -- heart of Texas. Are you saying
18 that --
19 JOHN: No. Someone's --
20 DAVID: -- Waco, Texas --
21 JOHN: -- trying to make it a national thing,
22 but it is a very local thing.
23 DAVID: Okay. Okay. Well, God'll have to
24 spread it out then. He says thou's merchandi--
25 JOHN: Well, then, God can come out of that
compound and spread it out, can't he?

1 DAVID: Yeah.

2 JOHN: Huh?

3 DAVID: Yes. When he's ready, he can.

4 JOHN: You betcha.

5 DAVID: Anyway, verse 17. Thy crown are as a
6 locust and thy captains as the great grasshoppers.
7 There's a lot of -- there are a lot of -- you got a lot
8 of bosses there, don't you?

9 JOHN: We all do.

10 DAVID: Which camp in the hedges in the cold
11 day. Ooh, it's cold out here, isn't it? Are y'all
12 camping in the hedges? Is that what you're doing --

13 JOHN: I'm camping on a --

14 DAVID: -- camping in the hedges?

15 JOHN: I'm camping on a chair talking --

16 DAVID: You're camping in --

17 JOHN: -- to you, David.

18 DAVID: -- the hedges. But when the sun
19 ariseth, buddy, you're going to flee away. Thy
20 shepherds slumber, O king of Assyria. Thy nobles shall
21 dwell in the dust. You know, it just is true. I guess
22 the word of God is true. Verse 19, there's no healing
23 of thy bruise, is there? The wound is grieving. All
24 that are going to hear, when everything's going to be
25 exposed about you and what you're doing, they're going
to clap the hands over thee, for upon whom if not thy

1 wickedness pass continually.

2 JOHN: David.

3 DAVID: I'm willing to listen --

4 JOHN: Tell me what your --

5 DAVID: -- to you, John.

6 JOHN: -- intention is? Do you want to work
7 with me or don't you?

8 DAVID: Hey. I'm willing to work with you
9 when you begin to realize you need to start fearing
10 God.

11 JOHN: Well, I think we both do. I'm, I'm a
12 God-fearing person.

13 DAVID: You don't even know these prophecies,
14 my friend.

15 JOHN: Do I have to?

16 DAVID: You'd better believe it.

17 JOHN: To be a God-fearing person?

18 DAVID: If you -- exactly. Otherwise, the
19 gods you fear will avail you nothing.

20 JOHN: No, I, I'm --

21 DAVID: There is a God of (indiscernible) --

22 JOHN: -- just may not have as much religious
23 teaching and, and be as learned as far as theology as
24 other people, but --

25 DAVID: This is not --

JOHN: -- that doesn't mean I'm a -- not a

1 God-fearing person.

2 DAVID: -- theology. This is straight
3 testimony.

4 JOHN: Don't be condescending, David.

5 DAVID: Look. You said you wanted to hear
6 and I've let you hear something. If it means nothing
7 to you, I can do nothing. Okay?

8 JOHN: I just wanted an explanation, didn't
9 I? Isn't that what I asked for?

10 DAVID: Did you get it? God (indiscernible)
11 --

12 JOHN: We went a roundabout way. Now, I have
13 to go tell all of the priests and all of the ministers
14 and all of the rabbis that they'd better start arming
15 their fortresses, huh?

16 DAVID: Stop playing child.

17 JOHN: You, you know exactly -- that's your
18 interpretation --

19 DAVID: Stop --

20 JOHN: -- of this.

21 DAVID: -- being foolish.

22 JOHN: You're the one interpreting it that
23 way.

24 DAVID: You'd better come up hither, my
25 friend. You better fear God like Paul, of whom you say
you believe was an apostle. Paul says fear him that

1 speaketh from heaven. The apostles talk about a truth.
2 In the latter days it's going to come and wipe out all
3 nations.

4 JOHN: Um-hum.

5 DAVID: Now, go ahead and laugh at Psalms 45.
6 Go ahead and get on the side of your bed tonight and
7 look at Psalms 45, and go ahead and laugh at that
8 prophecy. And go ahead and laugh because I showed it
9 to you. But the door is now shut. If you have any
10 other questions, I'm sorry.

11 JOHN: What do you mean the door is shut?
12 Huh?

13 DAVID: I already tried --

14 JOHN: You're not going to talk to me
15 anymore?

16 DAVID: I already tried to tell you the key
17 of David opens, but you don't believe Psalms 45. You
18 don't believe the warnings of the ancients. You don't
19 know about the lips of the ancients they cause to
20 speak. Spiritually discerned. I -- you know, what can
21 I say, John?

22 JOHN: David, the -- the truth may be here,
23 David. But if you remain inside there, who's going to
24 open the door?

25 DAVID: The door is already opened.

JOHN: But you just said that the door is

1 | shut.

2 | DAVID: I'm talking about there are things
3 | that you do not know. I've opened up Psalms 45 to you.
4 | Who only can open the first seal, John?

5 | JOHN: Well, we've, we've covered that
6 | ground, haven't we?

7 | DAVID: Who?

8 | JOHN: The Lord's going to open the seals,
9 | right?

10 | DAVID: Who just did? It's a small, minute,
11 | little red light at first. Just a quickening of the
12 | mind, a quickening of the intellect. Hey, Psalms 45,
13 | the first seal. You should have heard all those
14 | preachers and teachings on the radio the other day.
15 | They sure sounded funny.

16 | JOHN: Let me ask you something, David,
17 | changing the subject. Okay? Since -- because I guess
18 | we're pretty satisfied that my answer to why you have
19 | all those weapons has been now put upon me, huh?

20 | DAVID: In the Book of Nahum, as was in other
21 | prophecies.

22 | JOHN: I mean, you're satisfied --

23 | DAVID: My work --

24 | JOHN: You're satisfied that you have
25 | answered my question, ha-- aren't you?

 DAVID: Well, not really. I'd like to answer

1 | it in greater detail. But my means of answering you is
2 | the means that you don't want to hear.

3 | JOHN: Well, I mean, you can tell me that
4 | you're doing it because of the books. Right?

5 | DAVID: But that does not avail you with an
6 | understanding. See, you don't understand, John. Too
7 | many years --

8 | JOHN: Well, I'm trying.

9 | DAVID: Well, let's, let's back up a second
10 | now. Psalms 45 is a prophecy about God talking about
11 | his Son, right? God's heart (indiscernible) a good
12 | matter. He wants to talk about things he's made. Is
13 | he a creator? Is he a maker? Touching the king?

14 | JOHN: Um-hum.

15 | DAVID: Has God elected a king?

16 | JOHN: Um-hum.

17 | DAVID: Is God's tongue the pen of a ready
18 | writer? Has he got -- is God going to write it down?
19 | Did he think his Son is fairer than children of men?
20 | Do you think God loves you more or his Son more?

21 | JOHN: And I'm listening to you, David.

22 | DAVID: God says that grace is poured into
23 | the Son's mouth.

24 | JOHN: Where are you?

25 | DAVID: I'm, I'm just, I'm just -- I'm not,
I'm not looking in the Bible no more. I'm just simply

1 going over Psalms 45.

2 JOHN: Go ahead.

3 DAVID: Well, I'm --

4 (End of Tape #72)

2 DAVID: -- until you know about his book,
3 that he wants to talk about things he's made touching
4 the king, correct?

5 JOHN COX: True.

6 DAVID: He's going to put in the book, isn't
7 he?

8 JOHN COX: Uh-huh.

9 DAVID: His tongue will be the pen of a ready
10 writer. He wants you to know that he thinks his son is
11 fairer than the children of men. You may not think so.
12 Isaiah 53 says there's no beauty when we shall see,
13 that we shall desire Him. He's not the kind of guy you
14 just look at and say, oh, wow, look at Him, He's the
15 Christ. Says that grace is poured into his lips.
16 Instead of hurting anybody, I would rather teach the
17 truth.

18 JOHN COX: You can do that, too, can't you?

19 DAVID: Oh, yes, I would more than do
20 anything and you don't know what I've given up. I
21 should be able to do that.

22 JOHN COX: But you can teach -- you can teach
23 the truth to more people than just those people that
24 are inside that compound, can't you? If you want to.
25 And it's your decision to make.

DAVID: You see, John, --

1 JOHN COX: Am I saying an untruth to you?

2 DAVID: Well, you're, you're, you're not
3 fully understanding what position or time we're in. I
4 explained to you we're in the fifth seal.

5 JOHN COX: Uh-huh.

6 DAVID: And because of your lack of
7 understanding of that seal as well as the second, third
8 and fourth, you don't understand the events as they're
9 now transpiring. You don't understand -- you don't
10 understand that there is a heaven and there is a God
11 and there are people of great authority there. You
12 don't understand that Moses is there and Elijah and
13 Enoch's there. You don't understand these things. And
14 you're of this world, you've never had a chance to go
15 beyond this world.

16 JOHN COX: Well, I am. I can't deny that.

17 DAVID: Okay. So, God has proclaimed ahead
18 of time something that must be done. There must be --

19 JOHN COX: Aren't you, aren't you of this
20 world?

21 DAVID: No, I'm not. Honestly, John, I am
22 not. I was born in this world.

23 JOHN COX: Yes. And you also told me that
24 you have never broken the laws of this country, didn't
25 you?

DAVID: Exactly, until recently.

1 JOHN COX: No. Did you -- you've never
2 broken the laws?

3 DAVID: Go check my record, my past record.

4 JOHN COX: Oh, I'm not checking -- I'm not
5 checking your record.

6 DAVID: I mean in '88, in '88 --

7 JOHN COX: You know, it's, it's like me
8 telling -- it's like me telling my dad I never broke
9 the law and I never drank under age. Did you ever
10 smoke grass?

11 DAVID: Once.

12 JOHN COX: Did you break the law?

13 DAVID: Yeah, I did.

14 JOHN COX: Okay.

15 DAVID: I have to admit I did. But I didn't
16 smoke that much.

17 JOHN COX: Well, you just told me you didn't
18 break the law.

19 DAVID: Well, I guess you got me on that one.
20 You got me on that one.

21 JOHN COX: Well, --

22 DAVID: But, of course, that was put into law
23 --

24 JOHN COX: Don't give me -- don't give me an
25 excuse now.

DAVID: No excuse. Hey, and I didn't like

1 | it, you know what I mean. I was one of these guys that
2 | ran seven miles every day, you know. And a guy that
3 | was physically in condition like me got a better high
4 | off of isometrics and physical fitness. I mean I could
5 | not understand at a very young age why all my friends,
6 | you know, were doing that kind of stuff. And when I
7 | did it, you know, we really didn't know that much about
8 | laws, per se.

9 | JOHN COX: Let me ask you something, David.
10 | Would -- let me -- and it's away from this and I don't
11 | want you to think that I'm, I'm trying to move you away
12 | for a particular reason. But I think I understand how
13 | you responded to my question as to why you have those
14 | weapons there, because that's going to suit your needs,
15 | all right? That's why you have those weapons there.

16 | DAVID: Why did your --

17 | JOHN COX: Let, let me ask you, would you --
18 | do you want to communicate with the media? Do you want
19 | to communicate with them?

20 | DAVID: If they have questions to ask, now's
21 | the best time to ask them. So, you can make your
22 | statements. We --

23 | JOHN COX: No, no, no. Do you want to
24 | communicate with the media?

25 | DAVID: What -- well, that would be fine.
But it would --

1 JOHN COX: You know how you communicated with
2 the media before?

3 DAVID: Yeah, through the telephone lines.

4 JOHN COX: No, through a -- an audio tape.

5 DAVID: Well, you see --

6 JOHN COX: Would you like to do it again?

7 DAVID: That is -- okay, look. The Bible
8 communicates to us through a bunch of words, right?

9 JOHN COX: I'm just asking you a question.
10 I'm looking for a yes or no.

11 DAVID: No, that's not efficient. It does
12 not --

13 JOHN COX: It's what?

14 DAVID: It does not serve the perfect
15 purpose.

16 JOHN COX: I'm asking you if you have a
17 statement that you would like to be heard by the media
18 and by those addressed by the media, would you or
19 wouldn't you? I'm going to give you the opportunity to
20 do it.

21 DAVID: John, there are people that have
22 questions and a statement only --

23 JOHN COX: Uh-huh.

24 DAVID: -- develops another question. One on
25 one communication. It's like I'm talking with you and
I'm saying, John, is Psalms 45 the first seal? And

1 | you're saying, well, you can see that it has -- it
2 | definitely has a basis in the first seal of Revelation.
3 | But what I'm trying to say to you again is I'm saying,
4 | John, don't you fear God? Don't you know what I've
5 | just shown you? Don't you know who I am? And you,
6 | turning away from the Revelation, turning away from God
7 | --

8 | JOHN COX: I tell -- no, I tell you that I
9 | fear God and that I know you know who you say you are
10 | and that, that's fine. But do I have to accept that?

11 | DAVID: Well, it could cost you a great cost
12 | if you don't.

13 | JOHN COX: I believe that you believe who you
14 | are but --

15 | DAVID: Do you believe --

16 | JOHN COX: -- that's not consistent with the
17 | teachings that I have received. So, and --

18 | DAVID: Well, wait a minute.

19 | JOHN COX: -- you're just telling me --

20 | DAVID: And you're saying --

21 | JOHN COX: Pardon me?

22 | DAVID: You're saying that Psalms 45 is not
23 | the first seal?

24 | JOHN COX: I am, I am saying that my
25 | teachings, as well as other people's teachings are --

 DAVID: You talking about the Catholic

1 church?

2 JOHN COX: Oh, sure.

3 DAVID: Well, you know what the papacy --

4 JOHN COX: But I'm not going to argue with
5 you about your, your feelings and your interpretations
6 of what you're saying.

7 DAVID: Well, what is, what is the papacy's
8 interpretation of the first seal? You can't even tell
9 me, can you?

10 JOHN COX: Do you want me to go call Rome and
11 tell him, you know, I, I don't go along with this? I
12 mean you don't give a rat's ass anyhow, do you, what I
13 tell them, do you?

14 DAVID: The Vatican is a very unique place,
15 isn't it?

16 JOHN COX: It is.

17 DAVID: Very powerful place.

18 JOHN COX: But I'm not going to argue about
19 the Methodists, the Baptists, the Lutherans, the
20 Episcopalians.

21 DAVID: Why -- they're sisters, aren't they?

22 JOHN COX: I think we all are.

23 DAVID: Not us.

24 JOHN COX: Why?

25 DAVID: We're not related.

JOHN COX: Why?

1 DAVID: Because our God is a God of truth.
2 And we -- hello?
3 JOHN COX: But my God is not a God of truth?
4 DAVID: No.
5 JOHN COX: We all have the same God, David.
6 DAVID: That's not true.
7 JOHN COX: Yeah, it is.
8 DAVID: (Laughs) Contrary.
9 JOHN COX: Au contraire, wrong. It's all how
10 we interpret it.
11 DAVID: It's all how we believe the testament
12 of God.
13 JOHN COX: Hey, I'm not going to argue that.
14 But there is a God. You know, I'm not some theologian
15 that's going to sit here and try and grasp this. I
16 can't. I really can't. And you know that.
17 DAVID: I'm sorry.
18 JOHN COX: But I asked you -- I asked you
19 whether or not you would like to make a tape and have
20 it given to the media. Would you like to do that?
21 DAVID: Wait one second.
22 (Pause)
23 STEVE: John?
24 JOHN COX: What's up, Steven?
25 STEVE: What's up, John?
 JOHN COX: What's the matter, he couldn't

1 stand it anymore?

2 STEVE: What do you mean?

3 JOHN COX: He gave --

4 STEVE: Hello?

5 JOHN COX: -- up on me.

6 STEVE: Hello?

7 JOHN COX: David gave up on me.

8 STEVE: Okay. Don't move it anymore 'cause

9 it -- okay. Now, what's that?

10 JOHN COX: David gave up on me. How come?

11 STEVE: I don't know.

12 JOHN COX: He's not walking away shaking his

13 head, is he?

14 STEVE: Well, he does have -- about that look

15 on his face.

16 JOHN COX: Very perplexed?

17 STEVE: Not quite, but he is --

18 JOHN COX: He's not mad at me, is he?

19 STEVE: Oh, of course, not.

20 JOHN COX: Oh, I --

21 STEVE: Probably sorry.

22 JOHN COX: Sorry for me?

23 STEVE: For sure.

24 JOHN COX: Well, he's not the first. He's

25 not the first.

STEVE: No.

1 JOHN COX: No, I just asked him, asked him a
2 question, whether or not he would like to make a
3 statement to the media the same way that he made one
4 before, on a tape. And I didn't get an answer.

5 STEVE: Just a minute.

6 STEVE TO DAVID: He said he -- all he did was
7 ask you a question if you wanted to make a statement to
8 the media --

9 STEVE: I'm supposed to tell you you're a
10 snake.

11 JOHN COX: I'm a snake?

12 STEVE: But --

13 JOHN COX: Well, I've been called worse
14 things than that before.

15 STEVE TO DAVID: He said he's been called
16 worse things than that before.

17 STEVE: But he says he still loves you but he
18 says you're a snake.

19 JOHN COX: Oh. What I was going to do is, is
20 give him the opportunity to do it, you know. If he
21 wants to make a statement, fine. We can make some
22 arrangements to do that.

23 STEVE TO DAVID: (Indiscernible) to do it, if
24 you want to make a statement, fine.

25 STEVE: He's more -- he looks kind of worn
out.

1 JOHN COX: Oh, I can't believe that.

2 STEVE TO DAVID: He said he can't believe
3 that.

4 JOHN COX: He was enjoying every moment of
5 it. Hey?

6 STEVE: Yeah?

7 JOHN COX: You tell him I know he enjoyed
8 every moment of it.

9 STEVE TO DAVID: He says, I know you enjoyed
10 every moment of it.

11 JOHN COX: And he's hoping some of it will
12 rub off.

13 STEVE: He says the truth will judge us in
14 the end.

15 JOHN COX: Well, isn't that the -- that's the
16 truth. I can't argue that, can I? It will. Are you
17 interested in making a statement, Steven?

18 STEVE: Well, in -- see, what, what's the
19 context? Making a statement, do you mean to the world,
20 to the public, to --

21 JOHN COX: No, not to me, not, not to me, no.

22 STEVE: I didn't say to you, I said to the
23 world.

24 JOHN COX: Well, sure. I mean --

25 STEVE: Are you talking about by the press,
by the telephone or what are we talking about?

1 JOHN COX: Basically, we're basically -- I
2 don't know if you're interested or you're not. If you
3 are, we can make arrangements for you to make a taped
4 statement and give it -- we'll give it to the media.
5 If, if you're not, just tell me you're not. That's
6 all.

7 STEVE: Okay. Just a minute.

8 STEVE TO DAVID: He's asking me if I'm
9 interested or you're interested in making a statement
10 to the media.

11 STEVE: David says give us a line.

12 JOHN COX: Give you a line?

13 STEVE: Like we had before this all came
14 about. We had three or four telephone -- four
15 telephone lines to the outside.

16 JOHN COX: You're talking on the line.

17 STEVE: Yeah. But we're talking on --

18 JOHN COX: This is, this is the line.

19 STEVE: Uh-huh.

20 JOHN COX: Now, what, what I have asked is if
21 you would like to make a --

22 STEVE: A taped statement --

23 JOHN COX: -- a taped statement to be given
24 to the media. And, and, you know, the last tape
25 statement that was given to the media was not altered,
was not played with, you know. I'm just asking you if

1 you'd like to do it because --

2 STEVE: Okay.

3 JOHN COX: -- there's going --

4 STEVE: Because there's --

5 JOHN COX: I'm not, I'm not looking for 58
6 minutes now.

7 STEVE: Okay. Just a minute.

8 STEVE TO DAVID: He said he just wants to
9 know if you want to do it, if you want to make a
10 statement (Indiscernible) to the media. (Indiscernible)
11 He says I hope it wouldn't be a 58 minute one.

12 (Indiscernible conversation between Steve and David).

13 JOHN COX: Steven? Steven?

14 STEVE: John?

15 JOHN COX: Let, let me --

16 STEVE: He said he'll start working on it.

17 JOHN COX: But let me tell you --

18 STEVE: All right.

19 JOHN COX: -- what, what this will consist
20 of.

21 STEVE: All right.

22 JOHN COX: And then it may be negotiable, all
23 right?

24 STEVE: I'm listening.

25 JOHN COX: But I'm, I'm just throwing it up
for grabs.

1 STEVE: I'm listening.

2 JOHN COX: All right. That David will
3 prepare, or in his absence if you want to prepare and
4 send out a tape for the media, it will be received the
5 same way before.

6 STEVE: Uh-huh.

7 JOHN COX: When the children and the women
8 are sent out, we'll play the tape.

9 STEVE: Okay. Just a minute.

10 JOHN COX: Now, as I said, --

11 STEVE: All right.

12 JOHN COX: -- this is negotiable.

13 STEVE: Okay.

14 JOHN COX: All right. Give me another offer
15 if you don't like that one.

16 STEVE TO DAVID: (Indiscernible) he says you
17 can do as before. Get a tape together. When the women
18 and children are sent out, they will play it. This is
19 negotiable.

20 JOHN COX: Hey, Steven? Steve -- Steven?

21 STEVE: He said, he said, John, he says, I
22 told him he was a snake.

23 JOHN COX: Well, you know why -- you know why
24 I'm saying this? And as I said, I've been called --

25 STEVE: Why are you saying that?

JOHN COX: I've been called worse things than

1 a snake. Haven't we all? And the reason --

2 STEVE: Well, see, Christ was also called a
3 serpent, though. So, --

4 JOHN COX: And the reason I'm willing to play
5 the tape after they're released --

6 STEVE: Uh-huh.

7 JOHN COX: -- is because we played a 58
8 minute tape with an entree to it and nothing happened.
9 And that's, that's why we're looking for some
10 assurances on David's part.

11 STEVE: Just a minute.

12 STEVE TO DAVID: He says, he says we're
13 looking for some assurances this time because the last
14 time we played it first.

15 STEVE: David is not smiling right now. He
16 said his God --

17 JOHN COX: Has he thrown anything at you?

18 STEVE: He is -- I mean I'll tell you what,
19 he's extremely serious right now. He's, he's --

20 JOHN COX: Well, good.

21 STEVE: -- actually staring at me saying, he
22 said my God said wait.

23 JOHN COX: I, I hope he is being serious and
24 staring at you. But what I am saying is -- first of
25 all, I said it was a negotiable thing, didn't I? But I
said that --

1 STEVE: He said he --

2 JOHN COX: -- we --

3 STEVE: John, here's what --

4 JOHN COX: Go ahead.

5 STEVE: -- here's what he said. He said any
6 of these people can leave and go out from here any time
7 they want. But for he, himself, --

8 JOHN COX: Well, well, send me something to
9 prove that. And I want to get things moving again,
10 Steven. You want to get them moving. David wants to
11 get things moving. And we want to see some positive
12 signs.

13 STEVE: What, what do you know -- see, he's
14 actually sent me around the building, asking people on
15 a day-by-day basis, do you want to leave, do you want
16 to leave? That is no joke. Right from this morning
17 on --

18 JOHN COX: Steven --

19 STEVE: -- right from this morning on --

20 JOHN COX: He had a little girl this morning
21 that said that she wanted to leave, and what happens?
22 Somebody pumps something in her ear and says, no.

23 STEVE: Well, that's -- not so, no, no, not
24 so. I was sitting right here the whole time. Her
25 mother said nothing to her.

JOHN COX: Do you think I fell off a turnip

1 truck?

2 STEVE: Listen, that's the --

3 JOHN COX: Huh?

4 STEVE: -- truth. I sat here -- when the
5 first question was asked, do you want to leave, she
6 said, no. The second part of the question --

7 JOHN COX: She said yes first.

8 STEVE: No, she didn't. No, she did not.
9 She didn't.

10 JOHN COX: Come on, Steve.

11 STEVE: No, no. The second part of the
12 question -- now, listen, if you were there, you would
13 have heard this.

14 JOHN COX: Well, I wasn't there.

15 STEVE: Well, I was. I was right here. The
16 second part of the question is, if we get to talk to
17 Gonzales, Robert Gonzales, would you go if that gave us
18 the oppor -- and she said, yes, to that. And I about
19 fell over.

20 JOHN COX: Steve, are you going to tell me
21 that this six year old girl knows Robert Gonzales?

22 STEVE: Listen, listen. I --

23 JOHN COX: What do you think, I fell off the
24 pumpkin truck?

25 STEVE: No, no, no, no, no, no. Now, listen
to this. This is what happened. Whether she

1 understood or not, I don't know. I don't know.

2 JOHN COX: You've got a good idea, huh?

3 STEVE: Well, I would imagine she probably
4 didn't.

5 JOHN COX: Sure.

6 STEVE: But at the same time, her mother made
7 no faces, no one coerced or encouraged either
8 direction. And then her mother -- again, it was asked
9 her mother if she wanted the daughter to go.

10 JOHN COX: Well, who guided the child?

11 STEVE: Well, then the mother did.

12 JOHN COX: Did the child do it of her own
13 free will and volition?

14 STEVE: Well, this -- and the last thing --

15 JOHN COX: No.

16 STEVE: Listen. The last thing that was
17 asked was that -- did the girl want to go or did the
18 mother want her daughter to go. The mother said she
19 did not want her daughter to go unless Robert called
20 David and they had a phone conversation.

21 JOHN COX: Now, who planted that seed in the
22 mother's mind?

23 STEVE: David did.

24 JOHN COX: Well, sure. The mother didn't
25 know Robert Gonzales from the man in the moon.

STEVE: No, she did. She saw him. She --

1 JOHN COX: Well, --

2 STEVE: -- got to meet him.

3 JOHN COX: I know she saw him but she doesn't
4 know the part he played in this thing unless somebody
5 told her, right? So, did the girl have the opportunity
6 to leave? Yes. The girl said she wanted to leave --

7 STEVE: Here's what David --

8 JOHN COX: -- and someone planted a seed and
9 told her not to.

10 JOHN COX: No, no, here's how it works. The
11 woman and her daughter -- number one, the woman did not
12 want to leave but David says, look, if that gives this
13 man an opportunity for me to talk to him, to share some
14 things with him, would you be willing to encourage your
15 daughter to leave? She didn't want to leave her
16 daughter go, in the first place.

17 JOHN COX: How many women have allowed their
18 daughters to leave?

19 STEVE: Oh, quite a few of them.

20 JOHN COX: Sure. And how many should be with
21 their children, raising their children, caring for
22 their children?

23 STEVE: Of course. Of course.

24 JOHN COX: You know it and I know it, right?

25 STEVE: Of course.

JOHN COX: Sure. Sita --

1 STEVE: So --

2 JOHN COX: -- said she wanted to leave. She
3 would like to leave. But she's not leaving, is she?

4 STEVE: It's because of the mother. I can go
5 get the mother right now. You can talk to her again if
6 you want and I'm, -- I'll walk away.

7 JOHN COX: Well, how do I know -- how do I
8 know what you tell the mother and what David tells the
9 mother?

10 STEVE: Believe me, I have no -- when it --
11 look it, these people have come from such a distance, I
12 have no influence on them. Even my own decisions are
13 something that (Indiscernible).

14 JOHN COX: Why don't you let that mother walk
15 down that road and tell somebody down at the end --

16 STEVE: She can.

17 JOHN COX: Tell them --

18 STEVE: She can do that.

19 JOHN COX: -- down at the end of the road
20 that she doesn't wish to leave.

21 STEVE: She can do that.

22 JOHN COX: You know, I asked you yesterday to
23 do me something real simple. Last night when we were
24 talking and remember I read off the list of names to
25 you of some of the concerned people that called about
people --

1 STEVE: And I wrote those down.

2 JOHN COX: Not when I was talking to you, you
3 didn't, right?

4 STEVE: No, no, no, no, not -- I told you
5 that. Don't you remember how late it was?

6 JOHN COX: Sure. And I understand that and I
7 appreciate that. But I asked you that I would like you
8 to do me a favor and you said, uh-huh. And, and you'd
9 get back. And then you and Dick talked this morning, I
10 presume about it, huh?

11 STEVE: That's right.

12 JOHN COX: And I said I would like these
13 people to speak to me or to speak to Dick or to speak
14 to whomever, at your leisure so that I know that person
15 is healthy and safe in there and I can call David
16 Thibodeau's relative and say, yes, Belinda, David's
17 fine. And I can call --

18 STEVE: Well, there's two right here.

19 JOHN COX: -- Margarita Vaega's --

20 STEVE: Would you like to talk with a couple
21 of people here?

22 JOHN COX: I really would. I really would.

23 STEVE: Okay. Well, --

24 JOHN COX: But I thought you were going to
25 make those arrangements.

STEVE: I -- well, look it, here's what I

1 | did. I went and talked -- I took the list down from
2 | Dick.

3 | JOHN COX: Yeah.

4 | STEVE: I can even read the list back to you.
5 | I went around -- I wrote down -- I says, well, who was
6 | it that called? Who were they asking for?

7 | JOHN COX: Uh-huh.

8 | STEVE: The first three names that you gave
9 | which he, again, reiterated to me were people that have
10 | -- I have never heard of them. Nobody here has ever
11 | heard of them. So, --

12 | JOHN COX: Nobody ever heard of David
13 | Thibodeau?

14 | STEVE: Oh, no, of course, David -- let me
15 | grab --

16 | JOHN COX: That's the first name.

17 | STEVE: Let me grab the list again, okay?

18 | JOHN COX: Go ahead.

19 | STEVE: Let me take a look at it here. I
20 | can't even find -- where, where did I go with the
21 | thing? I've got it here. Okay. Let's see what we
22 | have. Now, all these people were told, I went right to
23 | every last one of them and asked them --

24 | JOHN COX: Uh-huh.

25 | STEVE: -- and told them the guy, he'll be
calling. You can get on the phone. You can wait for

1 | his call.

2 | JOHN COX: Uh-huh.

3 | STEVE: Here's the list that was given to me.

4 | JOHN COX: Yeah, go ahead.

5 | STEVE: Okay. I'm looking at it right here.

6 | Let's see. The first three names -- he told me that a
7 | Barbara Reed, a Lee Ann Josephson and a Bill Josephson.

8 | JOHN COX: Uh-huh.

9 | STEVE: And the connecting person was Lynn
10 | Josephson. I said I have never heard -- I asked
11 | everybody here if they've ever heard of any of those
12 | four names. No one ever has.

13 | JOHN COX: No Barbara Reed?

14 | STEVE: No Barbara Reed. I don't know who
15 | she is.

16 | JOHN COX: What about David Thibodeau?

17 | STEVE: Of course, Dave Thibodeau.

18 | JOHN COX: Because Belinda Gainon called
19 | about him. What about Jeff Little?

20 | STEVE: Jeff Little, also. I answered -- in
21 | fact, we went right down the list, Dick and I did, and
22 | I answered every one that was here.

23 | JOHN COX: And Margarita Vaega?

24 | STEVE: Correct.

25 | JOHN COX: Katherine's already outside.

 STEVE: Exactly.

1 JOHN COX: Kathy -- Katherine Matthewson.

2 STEVE: Right.

3 JOHN COX: Sherri Jewell.

4 STEVE: Right. She's here.

5 JOHN COX: Mary Jean Borst?

6 STEVE: Uh-huh.

7 JOHN COX: Gran -- what is it, Graeham or

8 Gran Craddock?

9 STEVE: That's correct.

10 JOHN COX: Douglas Martin?

11 STEVE: That's correct.

12 JOHN COX: Sheila Martin?

13 STEVE: Correct.

14 JOHN COX: Paul Fatta?

15 STEVE: Correct.

16 JOHN COX: And Kol -- what is it, Kolani

17 Fatta?

18 STEVE: Correct.

19 JOHN COX: And all I said was, would you let

20 those people speak to me, say hello, say I'm doing

21 fine?

22 STEVE: And I said, yes. In fact, there's

23 two of them -- well, there's two not in that list right

24 here.

25 JOHN COX: Well, that was 24 hours ago.

STEVE: What am I going to do when we get on

1 | the phone talking for hours like just now and --

2 | JOHN COX: Yeah, but I was, I was getting --

3 | STEVE: Wait, wait.

4 | JOHN COX: -- an education, wasn't I?

5 | STEVE: This is correct. Not only --

6 | (JOHN LAUGHS)

7 | STEVE: -- not only that, not only that, it
8 | was not me that brought up the subject matter of the
9 | last few conversations in the first place. When Dick
10 | talked to me earlier in the day --

11 | JOHN COX: Uh-huh.

12 | STEVE: -- I took it down.

13 | JOHN COX: Yeah.

14 | STEVE: He said he'd get back to me in a few
15 | hours, which -- and it would have been like 4:00.

16 | JOHN COX: Okay.

17 | STEVE: And at that time he never brought up
18 | anything to do with these names even though I had the
19 | people standing right here.

20 | JOHN COX: Well, you could have put them on
21 | the phone, huh?

22 | STEVE: Well, he didn't ask for that. He
23 | started talking about --

24 | JOHN COX: Hey, give him a little guidance.

25 | STEVE: No, he said he had a new proposition
that --

1 JOHN COX: Give him a little guidance
2 sometimes, Steve.

3 STEVE: Hey, come on, John. He gave -- he
4 said he had --

5 JOHN COX: Would, would you, would you let
6 them talk to me?

7 STEVE: He had a new proposition. He said --

8 JOHN COX: Uh-huh.

9 STEVE: -- there was something new that he
10 thought we'd go for, that would be great. And that's
11 when he dropped on me, we'll back off the Bradleys and
12 everybody come out. I said, oh, great, we're, we're
13 out there now.

14 JOHN COX: Yeah, I know about that. But
15 would you let them -- would you let the people talk to
16 me?

17 STEVE: Yeah, they're right here.

18 JOHN COX: And I'm not trying to play a game
19 with you. I really would like --

20 STEVE: Here's, here's Rita. You want to
21 talk to Rita?

22 JOHN COX: Yeah.

23 STEVE: She'd like to talk to you.

24 JOHN COX: Great.

25 STEVE: This is John Cox. F.B.I. agent?

JOHN COX: Yes, sir.

1 STEVE: Okay. And then after that will be
2 Lisa.
3 JOHN COX: Okay.
4 STEVE: Okay, here's Rita.
5 RITA: Hi, John.
6 JOHN COX: Rita?
7 RITA: Yes.
8 JOHN COX: What, what is your last name,
9 Rita?
10 RITA: Riddle.
11 JOHN COX: Rita Riddle?
12 RITA: Uh-huh.
13 JOHN COX: Well, you're not one of the names
14 that, that I have on the list here but do you have a
15 relative outside that you would like us to call and
16 tell them that you're fine?
17 RITA: Sure.
18 JOHN COX: Okay. Who would you like us to
19 call?
20 RITA: You can call -- I mean I, I know they
21 know I'm fine, you know. I mean they know why --
22 JOHN COX: Well, I'm just trying to be
23 reassuring to people, that's all.
24 RITA: Well, that's what I'm saying, you
25 know. They know why I'm here and --
JOHN COX: Okay.

1 RITA: -- you know, they know I'm fine. But,
2 yes, if you want to do that, that's okay, too.

3 JOHN COX: Okay.

4 RITA: It's a North Carolina number. The
5 area code is 704.

6 JOHN COX: Uh-huh.

7 RITA: And the number would be 684 --

8 JOHN COX: Uh-huh.

9 RITA: -- 1639.

10 JOHN COX: Okay.

11 RITA: And the person that you can ask for is
12 my father. His name is James Riddle.

13 JOHN COX: James Riddle. Okay. Well, I
14 appreciate it. I really do.

15 RITA: But I would just like to tell you, you
16 know, you think that he's got a bunch of people here
17 that's not here of our own free will.

18 JOHN COX: No, I don't think that at all. I
19 think everybody's in there because of your -- other
20 than the children maybe that don't have their own free
21 intellect or something, but I think you're all there
22 because you want to be there.

23 RITA: Well, --

24 JOHN COX: What I'm saying is that -- the
25 question is, can anybody leave if they want to leave?

 RITA: Of course. Look, the car

1 (Indiscernible).

2 JOHN COX: Well, we've had, we've had some
3 people tell us that they would like to leave and they
4 haven't left.

5 RITA: You've had people in here tell you
6 that they wanted to leave and haven't left?

7 JOHN COX: We've had children tell us that
8 people would like to leave.

9 RITA: Who, who's that?

10 JOHN COX: Well, I'm not going to put
11 somebody on the spot.

12 RITA: Look, I'm sitting here. I know what
13 goes on in here.

14 JOHN COX: Well, I'm sure you do.

15 RITA: And I'm saying if there's any kids
16 that want to leave here, they're more than welcome to
17 go. Like he said, you know. He's gone around and told
18 everybody if they want to leave --

19 JOHN COX: Well, I'm not, I'm not, I'm not to
20 debate a child. I mean a child's going to do what a
21 parent tells a child to do and I'm not trying to get
22 into any dispute there.

23 RITA: There's nobody here told their kids.
24 The kids want to stay with their parents. The kids
25 that went out didn't want to leave.

JOHN COX: Let, let me ask you something,

1 Rita. You say the kids wanted to stay with their
2 parents?

3 RITA: Yes.

4 JOHN COX: All right. Do parents have an
5 obligation to their children?

6 RITA: Well, you know --

7 JOHN COX: Do they? Yes or no.

8 RITA: Do the parents have an obligation to
9 their children?

10 JOHN COX: Yes or no?

11 RITA: Of course, yeah. They brought them
12 into this world, so, yeah.

13 JOHN COX: Well, then what about the parents
14 of the children that have come out of that compound, do
15 they have an obligation to their well-being, their
16 welfare, and that they be raised properly?

17 RITA: Of course.

18 JOHN COX: Then why aren't they with them?

19 RITA: Because there's seven seals that's in
20 the Bible. If you knew -- if you had to listen long
21 enough --

22 JOHN COX: I've listened for days.

23 RITA: But, look, it takes a long time, you
24 know. We don't learn a scripture here and a scripture
25 there.

JOHN COX: You're not answering my question.

1 RITA: We learn -- we learn that --

2 JOHN COX: Why aren't the parents with the
3 children?

4 RITA: That's exactly what I'm trying to tell
5 you.

6 JOHN COX: Is it because they don't love
7 their children?

8 RITA: Of course not.

9 JOHN COX: Then they should be caring for
10 their children, shouldn't they?

11 RITA: They are caring for them. Because,
12 see, that's what I'm saying.

13 JOHN COX: They are?

14 RITA: Right. Yeah, they are.

15 JOHN COX: How, by prayer?

16 RITA: No. That's what I'm telling you. If
17 you knew, if you had sit and listened long enough, you
18 may -- you know, you said -- you told me that you
19 listened for two days.

20 JOHN COX: Well, I am but I'm -- and I --

21 RITA: Hey, look, I've been here for two
22 years. It takes a long time --

23 JOHN COX: Well, I'm sure it does.

24 RITA: -- to go over the whole book of the
25 Bible and to learn its meaning.

JOHN COX: I'm sure it does and I, I won't

1 | argue that point with you one bit. And we all have our
2 | different interpretations, don't we?

3 | RITA: Right.

4 | JOHN COX: And I'm not going to argue those
5 | either, whether a person's Baptist or Methodist or
6 | Presbyterian or Catholic or Jewish or whatever they
7 | are, you know. We all have free, free interpretation
8 | there, don't we?

9 | RITA: Yeah, but there's only one -- the
10 | Bible says that there's only the Lamb that can reveal
11 | the book.

12 | JOHN COX: Well, I'm not going to try and
13 | change your mind. I'm not going to try and change your
14 | mind, and I wouldn't attempt to do that. I feel that's
15 | your right and your privilege.

16 | RITA: Well, but you're denying the world,
17 | you know. I don't know what you're trying to cover --

18 | JOHN COX: I'm doing what?

19 | RITA: -- up by not letting the press, you
20 | know, by not letting us talk to the press. There's a
21 | lot of people, look --

22 | JOHN COX: Do you -- well, do you want to
23 | talk to the press?

24 | RITA: I have listened to people on the
25 | radio. There were three people in particular that
stated that when they knew when the Federal government

1 pulled the media back --

2 JOHN COX: Uh-huh.

3 RITA: -- that they knew right then that the
4 government had something to hide. You have stated on
5 your press conferences --

6 JOHN COX: Let me, let me tell you exactly
7 why we did it. You want me to tell you why we did it?
8 Do you want me to tell you exactly why we did it?

9 RITA: Go right ahead.

10 JOHN COX: Well, you -- I think you sound
11 exasperated and you're going to be condescending with
12 me. All I want to tell you is why we did it.

13 RITA: Okay. Go right ahead.

14 JOHN COX: We did it because the Federal
15 government is responsible for the safety and welfare of
16 the media, period. And we know the weapons that are
17 inside there, whether you know them or not, we know
18 them and David has admitted them to me, --

19 RITA: (Laughs) So, you --

20 JOHN COX: -- that those weapons could harm
21 the media. And we're responsible for their welfare.
22 However, I have told David that if he would like to
23 speak to the media and I'll tell you, if you want to
24 speak to the media, all you have to do is walk down
25 that path and the media is down there.

RITA: That's ridiculous, you know.

1 JOHN COX: No, it's common sense.

2 RITA: That -- no. That's totally
3 ridiculous.

4 JOHN COX: Why?

5 RITA: Hey, look, we have a telephone.

6 JOHN COX: Do you?

7 RITA: You know --

8 JOHN COX: Well, go ahead and call out there
9 and talk to the media then.

10 RITA: Well, we can't because you messed our
11 lines up.

12 JOHN COX: No, I didn't mess your lines up.

13 RITA: Well, somebody did.

14 JOHN COX: Well, that could have been a
15 vision.

16 RITA: I don't think so. And, you know, you
17 -- I, I figure it this way, you know, I'm with the
18 people on the radio, you know. When they said that you
19 had something to cover up, you know, it's like you been
20 saying that we got ten people in here dead. Well, we
21 don't have --

22 JOHN COX: I won't tell you.

23 RITA: But, look, --

24 JOHN COX: I asked Steve --

25 RITA: -- it has never been straightened out.

JOHN COX: Let me tell you, I asked Steven

1 | last night, last night. And you ask him if I'm lying
2 | to you. I asked him last night when we were discussing
3 | Peter and we were trying to make some arrangements to
4 | remove Peter. I said, Steven, if there are others in
5 | there that are in the same condition of Peter, let me
6 | know and we'll try to make some arrangements. And I
7 | have not heard one word back. So, there is no
8 | allegation --

9 | RITA: Well, I haven't heard it changed
10 | either about ten people being dead in here. So, you
11 | know, I figure, hey, --

12 | JOHN COX: That's the media saying that.

13 | RITA: -- what you going to do --

14 | JOHN COX: That is pure speculation on the
15 | part of the media.

16 | RITA: Okay. Well, where did they get it
17 | from because like I said, we have no connection with
18 | the media.

19 | JOHN COX: I have absolutely no idea. Why
20 | don't -- let somebody ask the media where they got it
21 | from, come out and ask the media.

22 | RITA: We don't need to come out to ask
23 | anybody. Like I said, all we need is a telephone line.

24 | JOHN COX: Well, you're not going to get it.
25 | You know that.

 RITA: Exactly.

1 JOHN COX: Well, come out and ask the media.

2 RITA: So that's what I'm saying, you know.
3 I, I'm not coming out there. I don't want to, you
4 know. I know they're out there.

5 JOHN COX: Well, that's your privilege. That
6 your prerogative. If you don't want to come out, you
7 don't have to. I don't want to be getting into an
8 argument with you, you know? You're, you're probably a
9 good person. If you want to stay in there, you stay in
10 there. All I'm saying is the opportunity is there for
11 you to come out. The opportunity's --

12 RITA: Hey, I'm well aware of that. Look --

13 JOHN COX: The opportunity is there for any
14 parent to come out and be with their child.

15 RITA: (Indiscernible) I can come out anytime
16 I please. Look, I came here at Passover. I left and
17 went back home. Nobody made me stay. I came back at
18 Atonement.

19 JOHN COX: Well, that's good.

20 RITA: I left again. Nobody made me stay.
21 And just like now, nobody's forcing me to be here. I
22 can leave anytime I please, just like anybody else
23 here.

24 JOHN COX: Hey, I'm not going to tell you --

25 RITA: But, you know, look --

JOHN COX: -- I'm not going to tell you that

1 | you're doing anything wrong.

2 | RITA: But look --

3 | JOHN COX: I'm not telling you that you can't
4 | leave.

5 | RITA: You --

6 | JOHN COX: What I'm saying is that a parent -
7 | -

8 | RITA: Right. You said --

9 | JOHN COX: -- has a responsibility to take
10 | for their child.

11 | RITA: That's beside the point.

12 | JOHN COX: Why, why is it? That is the
13 | point.

14 | RITA: The point is, look, we've been sitting
15 | here for almost 8 days now.

16 | JOHN COX: Yeah.

17 | RITA: And it's not going to change because,
18 | yeah, as far as the media, the ball's in your court.

19 | JOHN COX: It's going to change the minute
20 | David hears the word.

21 | RITA: But look, you know --

22 | JOHN COX: Isn't it?

23 | RITA: -- the re -- why are we sitting here?
24 | Why do you think we're sitting here? I mean, you
25 | know, --

 JOHN COX: Ask David.

1 RITA: -- there's a lot of people out here
2 that would like to hear David, that would like to have
3 questions answered, just like you did. But like I
4 said, you know, just because you didn't listen long
5 enough to get the full picture, you know, that's your
6 own fault.

7 JOHN COX: Hey, the only person that's going
8 to tell you why you're sitting there is David because
9 he said he has to hear the word. Isn't that right,
10 Rita?

11 RITA: Do what, now?

12 JOHN COX: The only reason you are in there
13 and you have not left -- because David had agreed that
14 he and everyone in there --

15 RITA: Right. Originally, though, that's not
16 why we're here. At this point, yes.

17 JOHN COX: Everyone were going to leave and
18 David said you would not leave because he received a
19 word telling him to wait. That's the only reason
20 you're still in there.

21 RITA: That's right. That's right.

22 JOHN COX: So, don't give me some cock and
23 bull story about why you can't leave, that we're
24 preventing you from leaving. You can leave anytime you
25 want.

 RITA: That's exactly right.

1 JOHN COX: And that's your privilege. If you
2 don't want to leave, don't leave.

3 RITA: Well, that's what I'm saying, you
4 know.

5 JOHN COX: Well, that's good. The only
6 reason I asked to talk to you is so I could pass on to
7 one of your loved ones that everything's fine, not to
8 get into some debate with you. Do you understand that?

9 RITA: Yeah. Yeah, I sure do.

10 JOHN COX: Why don't you put Steven back on
11 the phone?

12 RITA: Okay.

13 LISA: Hello?

14 JOHN COX: Hey, who's this?

15 LISA: Hi, this is Lisa.

16 JOHN COX: Lisa?

17 LISA: Yeah.

18 JOHN COX: Lisa who?

19 LISA: Lisa Farris.

20 JOHN COX: Lisa Farris?

21 LISA: Yeah.

22 JOHN COX: How do you spell your last name,
23 Lisa?

24 LISA: F-A-R-R-I-S.

25 JOHN COX: F as in Frank?

LISA: Right.

1 JOHN COX: R-R-I-S?

2 LISA: Uh-huh.

3 JOHN COX: Do you have someone out here that
4 you would like us to call and tell them that you're
5 doing fine?

6 LISA: No, I don't have any family out there.
7 All my family is right here.

8 JOHN COX: No mother, father, sister,
9 brother, et cetera?

10 LISA: No, I was abandoned a long time ago.

11 JOHN COX: Okay. Well, that's the reason I
12 was speaking to Steven. We were discussing a lot of
13 other things along the way but I said there were some
14 people who had called, some, some relatives and friends
15 of people who were concerned, that's all. And I gave
16 them those individuals' names and I said, if you get
17 them and put them on, I'd be happy to call a relative
18 and say, hey, I've spoken to your son, your daughter,
19 whomever. And they're fine and they're -- they said to
20 say hello or whatever message they had.

21 LISA: Yeah. Well, I don't know how to get
22 in touch with them anyway even if you did want to talk
23 to them. I don't know where they are.

24 JOHN COX: Okay. Well, that's, that's the
25 only reason that, that I asked Steven to speak to
somebody. You doing okay?

1 LISA: Uh-hum, fine.

2 JOHN COX: Well, that's good. I'm glad to
3 hear it. Is there any message you have for anyone?

4 LISA: Excuse me? Do I have a message for
5 anybody?

6 JOHN COX: Yeah.

7 LISA: I just have a message to everybody,
8 you know.

9 JOHN COX: Sure.

10 LISA: And that is, you know, if they could,
11 get in, you know, get in contact with us, if they could
12 hear what we had to say, I wish, you know, I wish they
13 could but it's --

14 JOHN COX: If they could do what, now?

15 LISA: If they could hear what we had to say
16 and hear our side of the story, I wish they could.

17 JOHN COX: Well, let me tell you the same
18 thing I told Rita, okay?

19 LISA: Okay.

20 JOHN COX: You could walk down that road and
21 tell them anything you want to say and it's your
22 decision to make. It's not my decision, it's your
23 decision. And you've obviously decided to stay in
24 there.

25 LISA: Yeah. We walk out there, you're going
to handcuff us and put us in the, you know, --

1 JOHN COX: Not going to handcuff --

2 LISA: -- solitary confinement and nobody's
3 ever going to be able to talk to us again.

4 JOHN COX: Why do you -- why do you say that?
5 If you have any --

6 LISA: Because --

7 JOHN COX: If you have --

8 LISA: -- you guys shot at us, we shot back
9 at you and now, you know, you got us -- we know how the
10 system works.

11 JOHN COX: Let me, let me tell you something.

12 LISA: You put people away everyday.

13 JOHN COX: Do you know the Federal system?

14 LISA: Yeah, of course, I know the Federal
15 system.

16 JOHN COX: Anybody is presumed innocent until
17 found guilty in a court of law. That's the Federal
18 system for you and for me, okay?

19 LISA: Uh-huh.

20 JOHN COX: If you have done nothing wrong,
21 you're not going to be arrested. We're not going to
22 arrest people who have done nothing wrong, who we have
23 no reason to --

24 LISA: That's not true.

25 JOHN COX: -- to arrest. You think we
arrested the children when they came out?

1 LISA: Of course not. They didn't, they
2 didn't do anything.

3 JOHN COX: Well, --

4 LISA: They're children and they can't --

5 JOHN COX: -- you're not going to be arrested
6 if you didn't do anything either.

7 LISA: I am fighting for what I believe in,
8 and I'm fighting for, for my family and my friends
9 here. That's something.

10 JOHN COX: But then you will be judged in a
11 court of law. But what I'm just saying is, if you want
12 to stay in there, that's your prerogative, you know.

13 LISA: Uh-huh.

14 JOHN COX: That's, that's your business. I'm
15 not trying to force you to come out of there, but the
16 door is open. And as long as you understand that, that
17 you will be -- you will be cared for if you, if you've
18 been injured, your injuries will be treated. And
19 you'll be afforded legal counsel and in this country
20 it's the best judicial system in the world. Whether
21 you like it, whether you don't like it, it's still the
22 best one in the world.

23 LISA: Okay. Well I think I should go.

24 JOHN COX: And it's something we have to live
25 with but I, you know, I didn't -- I just wanted to see
if there was somebody that you wanted to talk to and

1 I'd be happy to pass on a message.

2 LISA: No, that's all right.

3 JOHN COX: And I'm glad to hear that you're
4 doing well.

5 LISA: Thanks.

6 JOHN COX: You're welcome.

7 LISA: Thanks a lot. You want -- Sherrie up?
8 I think she's sleeping. Sherri, you sleeping? Here,
9 here, talk to a friend of mine, Neal. Here, hold on.

10 JOHN COX: I'm sorry.

11 NEAL: Hello, John?

12 JOHN COX: Hey.

13 NEAL: What's up?

14 JOHN COX: Who's this?

15 NEAL: Neal.

16 JOHN COX: Neal?

17 NEAL: Yeah.

18 JOHN COX: What's your last name, Neal?

19 NEAL: Vaega.

20 JOHN COX: Neal --

21 NEAL: Yeah, you have my little kid there.

22 JOHN COX: I, I did what?

23 NEAL: You have a little kid of mine there.

24 JOHN COX: How do you spell your last name?

25 NEAL: V-A-E-G-A.

JOHN COX: V-A-E-G-A?

1 NEAL: Uh-huh.

2 JOHN COX: And what's your youngster's name?

3 NEAL: Joanne.

4 JOHN COX: Okay.

5 NEAL: Yeah.

6 JOHN COX: Well, I'll tell you one thing,

7 Neal -- NEAL: Yeah.

8 JOHN COX: -- she's being cared for well and,

9 and she's probably in pretty good shape. She's -- is

10 she seven years old, seven years old?

11 NEAL: Yeah.

12 JOHN COX: I think I remember her coming out.

13 NEAL: Yeah, yeah.

14 JOHN COX: Does she have -- does she have

15 any, any problems or anything that we should know about

16 as far as taking medication or anything --

17 NEAL: Problems?

18 JOHN COX: I'm sorry?

19 NEAL: No, she's fairly normal.

20 JOHN COX: That's good. That's great because

21 I, I'm concerned about that as are -- you know,

22 everybody out here wants to make sure that we take care

23 of them.

24 NEAL: Listen, John, we brought all those

25 kids up real good.

 JOHN COX: I'm sure you did.

1 NEAL: There's nothing wrong with them.

2 JOHN COX: I don't think there is.

3 NEAL: I don't, I don't really see any reason
4 why they need any psychology or any psychologists.

5 JOHN COX: Oh, they're not.

6 NEAL: Okay. I just want to let you know.

7 JOHN COX: They're just being cared for.
8 They're being fed, they're being clothed, they're being
9 cared for, that's all.

10 NEAL: Yeah. I saw the photos and --

11 JOHN COX: And, and let me tell you, they'd
12 love to be with you.

13 NEAL: Yeah.

14 JOHN COX: Is -- do you have any, anyone out
15 here, Neal, that, that you would care for me to
16 contact, whether it's a mother, father, sister,
17 brother, and tell them that I spoke to you and you're
18 all right?

19 NEAL: Uh --

20 JOHN COX: And the reason -- and the reason I
21 ask that --

22 NEAL: Yeah.

23 JOHN COX: -- it's not a trick. I'm not
24 playing any games. We've had a lot of people call in
25 here and --

NEAL: Okay.

1 JOHN COX: -- who are concerned.

2 NEAL: My relatives are all in New Zealand.

3 JOHN COX: Well, I don't care.

4 NEAL: And, so, --

5 JOHN COX: We'll contact the -- we've had the
6 British Consulate call us.

7 NEAL: Yeah.

8 JOHN COX: So, I'll be happy to contact the
9 New Zealand Consulate.

10 NEAL: Sure, by all means.

11 JOHN COX: You just give me a name and an
12 address.

13 NEAL: I did leave my address and number with
14 Joanne.

15 JOHN COX: Go ahead.

16 NEAL: And she has it.

17 JOHN COX: I'm sorry?

18 NEAL: And she has it.

19 JOHN COX: Joanne?

20 NEAL: Joanne. No, she --

21 JOHN COX: Who is Joanne?

22 NEAL: My little kid brought --

23 JOHN COX: Who is Joanne?

24 NEAL: Joanne?

25 JOHN COX: Oh, one of the other youngsters
that came out?

1 NEAL: No, that's my kid.

2 JOHN COX: I'm --

3 NEAL: The seven year old.

4 JOHN COX: I'm sorry, go ahead. And you gave
5 the address --

6 NEAL: And I gave the address and number on
7 it, on her --

8 JOHN COX: You gave her a little slip of
9 paper?

10 NEAL: Yeah.

11 JOHN COX: Okay.

12 NEAL: Yeah.

13 JOHN COX: Well, I can assure you that -- did
14 it give the name of someone on there to be contacted?

15 NEAL: Yeah, she did. I gave it to her and
16 she had it on her person.

17 JOHN COX: Okay.

18 NEAL: Yeah.

19 JOHN COX: Now, do you understand the same
20 thing that I mentioned to, to Rita and to, to Lisa?

21 NEAL: Uh-huh.

22 JOHN COX: That you are free to leave and I
23 understand you are free to leave.

24 NEAL: Uh-huh.

25 JOHN COX: And that if you care to stay in
there, that's your business. No harm is going to come

1 to you whether you stay -- you care to stay in there or
2 you, or you care to leave. And, and I've impressed
3 that upon David and I've impressed that upon Steven,
4 that, that I'm certainly not here to get into any
5 religious issues with you. And I respect your
6 religious beliefs, you, David, Steven's, Rita's,
7 Lisa's. That's your, that's your prerogative. But as
8 I explained to Lisa and as I explained to Rita, that
9 these children that are out here need their parents.

10 NEAL: Uh-huh.

11 JOHN COX: And they should be together and,
12 and that parents have a certain responsibility to their
13 children for their care and their upbringing and their
14 welfare.

15 NEAL: Uh-huh.

16 JOHN COX: And that if you want to be with
17 them, --

18 NEAL: Uh-huh.

19 JOHN COX: -- you certainly can be. But I'm
20 not trying to exert any pressure upon you and tell you
21 that if you don't, something's going to happen. That's
22 not true. Your children are going to be taken care of
23 us out here because we love them like you love them --

24 NEAL: Okay.

25 JOHN COX: -- you know?

NEAL: Well, maybe you should send them back.

1 JOHN COX: Are you serious?

2 NEAL: Yeah. You're concerned about them
3 being with us and, and they're happy. Maybe you should
4 send them back here. I think this will be the best
5 place for them. I really didn't want to send them.

6 JOHN COX: Let me tell you something.

7 NEAL: Yeah.

8 JOHN COX: There's a reason, Neal, that those
9 children aren't going back in there and, and you know
10 what the reason is and I know what the reason is, is
11 that there's a lot of weapons in that place, there's a
12 lot of ammunition in that place.

13 NEAL: Uh-huh.

14 JOHN COX: And I am not going to put those
15 children in harm's way to allow them to get caught in
16 -- because of some foolish act by whomever, you know,
17 just one person makes some kind of a crazy mistake,
18 those kids can get hurt.

19 NEAL: John, they've lived with these arms.
20 They've lived with these firearms for as long as they
21 been around.

22 JOHN COX: You, you saw what happened last
23 Sunday, didn't you?

24 NEAL: Yeah, and that was the --

25 JOHN COX: It wasn't good, was it?

NEAL: -- fault of the B.A.T.F. It had

1 nothing to do with us.

2 JOHN COX: Hey, I am not here to judge whose
3 fault it is. That's not my job. A court of law will
4 judge whose fault it was. It's not my job. But what I
5 am telling you is those children are not going to get
6 put back in an environment where if anybody makes a
7 mistake, they can be harmed. And I hope you understand
8 that. And I'm not saying whether it's your mistake or
9 David's or Steven's or A.T.F.'s mistake, or the
10 F.B.I.'s mistake. But I think that I owe it, we owe it
11 to those kids --

12 NEAL: Uh-huh.

13 JOHN COX: -- to insure that they don't have
14 to be in that environment. I don't want them harmed,
15 do you?

16 NEAL: No, but --

17 JOHN COX: Sure, you don't.

18 NEAL: -- that environment out there, too, is
19 just as bad, I mean --

20 JOHN COX: Well, you made, you made a
21 decision to send your daughter out, didn't you?

22 NEAL: Huh?

23 JOHN COX: You made a decision to send your
24 child out?

25 NEAL: This is true.

JOHN COX: So, you made that decision of your

1 -- NEAL: You're right.

2 JOHN COX: -- own free will. Nobody forced
3 you to make it, did they?

4 NEAL: Well, --

5 JOHN COX: Huh?

6 NEAL: Huh?

7 JOHN COX: Nobody forced you to make that
8 decision, did they?

9 NEAL: That's true, John, that's true. I
10 sent them out.

11 JOHN COX: So, so, it was a -- it was a
12 willful decision to send your child out?

13 NEAL: Yes.

14 JOHN COX: And, so, you had to have a reason
15 for sending your child out, didn't you?

16 NEAL: This is so that this could come to an
17 end.

18 JOHN COX: That's the bottom line, isn't it?

19 NEAL: Yes.

20 JOHN COX: And that's all I wish for, too,
21 huh?

22 NEAL: But if you're talking about
23 environment --

24 JOHN COX: Do you, you think that your child
25 is in a worse environment now than your child was in
before?

1 NEAL: Oh, Waco, the killings that take place
2 out there is -- I don't see any difference. The same
3 people that attacked this place are the same people
4 already out there.

5 JOHN COX: Your child's being fed three days
6 -- your, your child is being fed three meals a day --

7 NEAL: Yeah.

8 JOHN COX: -- in a nice warm bed in a nice
9 environment.

10 NEAL: I appreciate that.

11 JOHN COX: And, and because we care. And I'm
12 not telling you -- I'm not saying you don't care.

13 NEAL: Uh-huh.

14 JOHN COX: You love your child. You tell me
15 how it's going to be resolved. I wish I had the
16 answer. You tell me you think how this is going to be
17 resolved.

18 NEAL: See, John, we live day-by-day every
19 day and we --

20 JOHN COX: Yeah, but we shouldn't have to,
21 Neal, should we?

22 NEAL: Well, you know, that's just the way
23 the world is.

24 JOHN COX: No, the world doesn't have to be
25 that way. I was living day-by-day in another state a
week ago. But it doesn't have to be that way. And

1 | it's through reasoning and it's through common sense
2 | and it's through communications that this thing is
3 | going to be resolved peacefully and nobody's going to
4 | be harmed. Wouldn't you like to see that happen?

5 | NEAL: Well, let me put it this way, man
6 | doesn't have the answer.

7 | JOHN COX: Oh, I hope he does.

8 | NEAL: He doesn't.

9 | JOHN COX: I hope some sound judgement and
10 | reasoning will prevail.

11 | NEAL: No. We've gone generation after
12 | generation. There's been a screw-up. There's been
13 | snowballing. And it's going to get worse and worse.
14 | We do not have the answer. Yes, the book that we --

15 | JOHN COX: I'm listening.

16 | NEAL: I'm talking about a book.

17 | JOHN COX: I'm listening to you.

18 | NEAL: Yeah, I'm talking about a book --

19 | JOHN COX: Uh-huh.

20 | NEAL: -- that not too many people believe in
21 | yet. They go every Sunday -- they go to church every
22 | Sunday, they go to sabbath every Sunday. And that's
23 | what we do. And then after that, it's back to --

24 | JOHN COX: Who?

25 | NEAL: -- their own normal lives and they do

--

1 JOHN COX: Who?

2 NEAL: People.

3 JOHN COX: Just think of the ones that don't
4 go to church.

5 NEAL: Yeah, oh. They probably have a better
6 chance than those who do go to church.

7 JOHN COX: Well, I hope not. I hope not.

8 NEAL: Well, --

9 JOHN COX: I mean I go to church and, and you
10 go to church, right?

11 NEAL: True.

12 JOHN COX: And even though we may not totally
13 believe the same thing, we do believe that there is
14 somebody stronger than us, don't we?

15 NEAL: True. And we believe that he has the
16 answer.

17 JOHN COX: Well, it may even be a she but
18 there is an answer, isn't there?

19 NEAL: Right, there is an answer.

20 JOHN COX: Sure. And --

21 NEAL: And it's in your fingertips.

22 JOHN COX: And you and I are going to accept
23 that answer some day, aren't we?

24 NEAL: Well, you're going to face it one way
25 or the other, whether we like it or not, whether we're
good or bad.

1 JOHN COX: Well, we are. We are.

2 NEAL: Yes.

3 JOHN COX: And we all have to answer for our
4 actions, don't we?

5 NEAL: I think we are.

6 JOHN COX: You know? But just -- I think, as
7 I told David and I told Steven, you know --

8 NEAL: Uh-huh.

9 JOHN COX: -- the Lord is charitable, too.
10 And, and so is the system. And, and I just want you to
11 understand that your children are going to be cared for
12 and that if you want to insure their safety and their,
13 their upbringing, all you have to do is come out and be
14 with them and nothing's going to happen to you. I'll
15 guarantee you that. But the system will prevail. You
16 know that and I know that. The system will prevail.

17 NEAL: Well, there is a system that was once
18 --

19 JOHN COX: No.

20 NEAL: -- based on God.

21 JOHN COX: It's going to be a system today
22 and it's going to be a system next week and it will
23 prevail.

24 NEAL: Well, I think the, the government and
25 the bureaucracy has gotten a lot bigger than it should
be. It's not as simple as it was. The Constitution

1 | has been stepped on. People --

2 | JOHN COX: Well, it has.

3 | NEAL: -- come on this property and do
4 | whatever they want.

5 | JOHN COX: I can't argue -- I can't argue
6 | that. But people have viol -- you say the Constitution
7 | has been stepped on.

8 | NEAL: Sure, it has.

9 | JOHN COX: That's the law of the land, isn't
10 | it?

11 | NEAL: It's been violated.

12 | JOHN COX: And you have to live by it and I
13 | have to live by it.

14 | NEAL: I wish you'd live by it.

15 | JOHN COX: Huh?

16 | NEAL: I wish people would live by it and --

17 | JOHN COX: Don't we all?

18 | NEAL: Yeah.

19 | JOHN COX: David was telling me that if he
20 | hadn't been in the religious profession, he would have
21 | loved to have been a law enforcement officer.

6 start putting LAW rockets and .50-caliber machine guns
7 in the, in the church? Do you think he needs that?

10 JOHN: That's crazy. And that's all I'm
11 saying. That I hope you understand that the reason I
12 want to talk to you is --

13 NEAL: Uh-huh.

14 JOHN: -- not to try and influence you one
15 way or the other.

16 NEAL: Yeah.

17 JOHN: That if you had a message to relay to
18 someone, I, I sincerely will relay that message. But
19 to -- and, and, believe me, your child is going to be
20 well-cared for, well-cared for. And, and, hopefully,
21 you will have the privilege of caring for your child
22 some day just like your child's being --

23 NEAL: Well --

24 JOHN: -- cared for now.

25 NEAL: Okay.

18 | JOHN: Go ahead.

19 | LISA: Well, you were asking why, you know,

7 | because --

8 | JOHN: We have a responsibility.

9 | LISA: You don't want them injured, right?

10 | JOHN: Absolutely.

11 | LISA: Okay. But the thing is is, you know,

12 | we're not out to hurt anybody.

13 | JOHN: You're not what?

14 | LISA: Yeah, see -- we're not out to hurt

15 | anybody. You guys came on our property. You guys

16 | started -- you know, you brought these two trucks in

17 | with all these people.

18 | JOHN: Whoa, whoa, whoa. Listen. Listen.

19 | The people --

20 | LISA: You, you --

21 | JOHN: -- went -- Li--

22 | LISA: -- totally destroyed our house.

23 | JOHN: Wait, wait. Listen. The people that

24 | went on your property had not only a search warrant

25 | issued by a U. S. District Judge, but they had an

arrest warrant issued by a U. S. District Judge, and

1 that arrest warrant and that search warrant instructs
2 them, orders them, to execute those warrants. Orders
3 them. It doesn't ask them to do it. It doesn't say
4 you can if you want to. A warrant in writing orders
5 you to do something. That's why they were there.

6 LISA: Okay. That's understandable. Okay.

7 JOHN: Now, if --

8 LISA: I understand --

9 JOHN: -- things went wrong --

10 LISA: But why did you need them -- fifteen
11 thousand million people out here for an arrest warrant?

12 JOHN: Why did you need those LAW rockets and
13 those .50-caliber machine guns?

14 LISA: We don't need them.

15 JOHN: Then get rid of them.

16 LISA: We bel--

17 JOHN: Get rid of them. Throw them out the
18 windows.

19 LISA: What, what is wrong, though, with each
20 person having --

21 JOHN: Don't give me a lot --

22 LISA: -- the right to bear arms?

23 JOHN: -- of nonsense about that Lisa. There
24 is no reason in the world somebody needs those kind of
25 weapons. I don't need them. I don't have them at
home. I don't have --

1 LISA: The system you work for does.

2 JOHN: My church --

3 LISA: They got --

4 JOHN: -- doesn't have them.

5 LISA: -- you should see the tanks they've
6 got sitting in our front yard. They're worse than
7 anything.

8 JOHN: They do have them because they know
9 what some of those weapons can do, the destructive
10 power of some of those weapons. And those tanks aren't
11 going to harm anyone.

12 LISA: Anyway, that's besides the issue.
13 That's beside the point.

14 JOHN: But that's what you --

15 LISA: We understand --

16 JOHN: -- were saying.

17 LISA: No. Well, what I'm talking about is
18 why the media couldn't come out here. We're not out to
19 hurt them. (Indiscernible).

20 JOHN: Then come on out and talk to them.
21 You can go out and talk to them. Well, just walk down
22 the road and talk to them, if you want to. Nobody's
23 going to prevent you from doing that. But I, I'm not
24 -- I really sincerely do not want to get on the phone
25 and get in an argument with you.

LISA: Yeah. I don't want to get --

1 JOHN: I'll answer --

2 LISA: -- into an argument.

3 JOHN: -- any question you have, believe me.

4 But -- and, and I'll talk to any relative in your

5 behalf. You know, I'm --

6 LISA: But not --

7 JOHN: -- being very sincere with you about

8 --

9 LISA: Okay.

10 JOHN: -- that.

11 LISA: Okay. Listen, why don't you come out

12 here?

13 JOHN: I'd be delighted to come out there. I

14 really would.

15 LISA: No, really. I'm serious. We'd, we'd

16 love to have you down here.

17 JOHN: Do you think I just fell off the

18 turnip truck?

19 LISA TO UNIDENTIFIED PERSON: He doesn't

20 think -- I don't know.

21 LISA TO JOHN: No.

22 JOHN: Hey.

23 LISA: No, no.

24 JOHN: I'm, I'm being very serious with you.

25 Do you --

LISA: I am, too.

1 JOHN: Do you think it would be in my best
2 interest to go huckle-bucking down that road knowing
3 the weapons that are inside that place?

4 LISA: Hey --

5 JOHN: What assurances am I going to get that
6 nothing's going to happen? If David wants to meet me
7 down at the end of that road, I'll meet him down at the
8 end of the road.

9 LISA: Well, see, that's the thing, though,
10 John. I mean, if that's your reason --

11 JOHN: And I will not harm him.

12 LISA: We have our reasons. You're saying
13 that you won't harm us. How do --

14 JOHN: Well, I wo--

15 LISA: -- we know that? We got -- you got
16 tanks. You've got all kinds of people out there.

17 JOHN: Because you have to believe in the
18 system. That's all I can tell you.

19 LISA: Believe in the system?

20 JOHN: And if you don't want to believe in
21 it, that's your business and -- that's your business.
22 Do you think we're going to harm these children that
23 came out, those ladies that came out?

24 LISA: The people -- the, the children that
25 you took out of their home?

 JOHN: I didn't take anybody out. They were

1 --

2 LISA: You most certainly did. You e-- you
3 practically --

4 JOHN: Whoa, whoa. Wait a minute.

5 LISA: -- insisted that they come out or you
6 weren't going to --

7 JOHN: Those parents allowed their children
8 to leave -- and, hey --

9 LISA: Yeah, but --

10 JOHN: -- Neal just told me --

11 LISA: -- we're afraid you might bomb us up
12 or something with all --

13 JOHN: Neal just told me --

14 LISA: -- the tanks you've got around here.
15 We're doing it for their, their best interests. We
16 don't know what you're going to do to us.

17 JOHN: You don't?

18 LISA: No.

19 JOHN: Well, come out --

20 LISA: You got seven tanks out here. Of
21 course we're going to get these children out for their
22 best interests.

23 JOHN: Well, then let the rest of them out.

24 LISA: That's up to them.

25 JOHN: What do you mean that's up to them?
You just said that we made them come out. We didn't

1 make anybody come out.

2 LISA: Their parents let them out for their
3 best interests.

4 JOHN: Well, then why don't the rest of the
5 parents let their children out for their best
6 interests?

7 LISA: Because that's entirely up to them. I
8 can't forc--

9 JOHN: Huh?

10 LISA: I'm not going to tell them what to do.

11 JOHN: Is it common sense? Since you said
12 that they may be harmed.

13 LISA: That's true.

14 JOHN: Then I guess the, the women and
15 children and all of them should come out, huh? Whose
16 best interests are we looking out for?

17 LISA: I'm looking out for my best interests.

18 JOHN: Well, do you think --

19 LISA: Everybody else is looking after their
20 own best interests.

21 JOHN: What best interests are you looking
22 out for?

23 LISA: Look, I don't trust your system.

24 That's --

25 JOHN: Okay.

 LISA: -- basically where it stands. I don't

1 trust your system. I don't like it. I never have.

2 JOHN: Well --

3 LISA: And I don't --

4 JOHN: -- well, that's all right.

5 LISA: -- like what you've done to me and I
6 don't like what you've done to my friends and my
7 family.

8 JOHN: In what respect?

9 LISA: In what respect?

10 JOHN: Yeah. And I'm not talking about
11 Sunday, all right?

12 LISA: I --

13 JOHN: Sunday happened. Sunday's over with.
14 There's not a darn thing I can do about what happened
15 Sunday. I wish I could. Okay?

16 LISA: Okay. Well, look, everybody that --

17 JOHN: Tell me something else.

18 LISA: That anybody that knows us knows that
19 we have never harmed anybody or never had intentions --

20 JOHN: I'm not going to argue --

21 LISA: -- to harm anybody.

22 JOHN: I'm not going to argue that with you.

23 LISA: We've been out here for years.

24 JOHN: Answer one question.

25 LISA: Okay.

JOHN: Answer me a question.

1 LISA: Okay.

2 JOHN: And I am not accusing you of harming
3 anyone. I'm not accusing David of harming anyone.
4 Steven -- no one.

5 LISA: Okay.

6 JOHN: I think you're peace-loving people,
7 all right?

8 LISA: We are.

9 JOHN: Why do you have LAW rockets,
10 .50-caliber machine guns --

11 LISA: We don't have no LAW rockets.

12 JOHN: I know you do, so don't tell me that.
13 You just don't know what a LAW rocket is, that's all.
14 And why do you have .50-caliber machine guns?

15 LISA: We don't have those either that I know
16 of.

17 JOHN: You've got .50-caliber Barrett
18 (phonetic) rifles.

19 LISA: Never seen one.

20 JOHN: I didn't ask you whether you'd seen
21 one. I'm telling you what's out there and David didn't
22 deny it and Steven didn't deny it, whether you've seen
23 it or not. And there's absolutely no reason to have
24 those kind of munitions.

25 LISA: But I don't think they have them, and
I've been everywhere in this whole house. I've never

1 | seen anything like that.

2 | JOHN: Let's just say that neither David nor
3 | Steven denied it, and I've been talking to them for a
4 | few days. Okay?

5 | LISA: Okay.

6 | JOHN: So, I'm -- and, and I don't have to
7 | argue that with you. If, if you tell me you haven't
8 | seen them, I believe you. Because maybe you haven't.
9 | I'm not going to argue that with you. What I'm saying
10 | is the system we have in this country is the best
11 | system in the world. Whether you like it, whether I
12 | like it, it's still the best one in the world.

13 | LISA: Yeah.

14 | JOHN: It doesn't get any better. You know,
15 | we tell people if you don't like the system, you can go
16 | someplace else. But we are a country of laws, aren't
17 | we?

18 | LISA: Um-hum.

19 | JOHN: And I raise my right, right hand one--

20 | LISA: But I don't think that's true either.
21 | Because if we wanted to move to another country, you
22 | wouldn't let us do that.

23 | JOHN: You could have. You could have done
24 | that a year ago, a week ago, whenever you wanted to.
25 | If you don't like the system in this country, you can
 | go someplace else.

1 LISA: Well, can we go now? Will you let us
2 go now?

3 JOHN: If you come out right now, the only
4 thing I'm telling you that will happen to you is that
5 no harm will come to you. If you have not violated a
6 law, then you will, will not be charged with any
7 violation of the law, will you?

8 LISA: Well, you know what, John?

9 JOHN: What?

10 LISA: I've got to tell you that we really
11 love you guys. We love you.

12 JOHN: Well, good. I love you too.

13 LISA: And --

14 JOHN: I'm being very truthful. I love you.

15 LISA: I know.

16 JOHN: And I hope nothing happens to you.

17 LISA: Yeah, me too.

18 JOHN: Because it won't be because of any
19 action we've done. And, and, and I'm telling you
20 you're dealing with the FBI and you're dealing with the
21 other Federal agencies, and nothing -- no harm is going
22 to come to you because of something we're doing. We
23 are working out on a perimeter and we're out there to
24 protect people. And that's, that's it. Nobody is
25 going to assault that place. You may -- somebody might
tell you something, but it's not going to happen. It

1 | is just not going to happen.

2 | LISA: Okay.

3 | JOHN: I'll sit here and I'll talk to David
4 | for a month, if I have to talk to David for a month, to
5 | ensure that no harm comes to anyone. And I hope you
6 | believe that.

7 | LISA: I, I do.

8 | JOHN: Because I -- and I don't want it to
9 | happen to you, kid.

10 | LISA: Okay.

11 | JOHN: Okay?

12 | LISA: And, listen, what religion are you
13 | anyway -- religion --

14 | JOHN: Why does that enter into it?

15 | LISA: Huh?

16 | JOHN: Why does that enter into it? I'll
17 | tell you if it makes you feel --

18 | LISA: Yeah. I was just wondering if you
19 | guys believe in present truth.

20 | JOHN: I'm Catholic.

21 | LISA: You're Catholic?

22 | JOHN: Yeah.

23 | LISA: Well, do you believe in present truth?

24 | JOHN: Another one of those damn Catholics,
25 | huh?

 LISA: Do you ever believe in present truth?

1 JOHN: What present truth?

2 LISA: Present truth that comes from time to
3 time to different people?

4 JOHN: You, you're going to have to explain
5 it to me.

6 LISA: I have to explain it to you.

7 JOHN: Well, I'm not being, I'm not --

8 LISA: No, no. I know.

9 JOHN: -- being silly. I'm --

10 LISA: Do you know who started the Catholic
11 church?

12 JOHN: The -- yeah, the pope from Jesus
13 Christ.

14 LISA: The pope from Jesus Christ?

15 JOHN: St. Peter was the first pope of the
16 Catholic church.

17 LISA: Okay. Well, listen, this is

18 JOHN: I'm not --

19 LISA: -- this is --

20 JOHN: -- lying to you. What research have
21 you done into the Catholic church?

22 LISA: A lot.

23 JOHN: Were you raised Catholic?

24 LISA: No.

25 JOHN: You don't believe that St. Peter was
the first pope of the Catholic church?

1 LISA: I don't really know.

2 JOHN: Well, you asked me a question, didn't
3 you?

4 LISA: Yeah.

5 JOHN: I gave you an answer.

6 LISA: Okay. Listen, do you -- but do you
7 still believe in, in present truth?

8 JOHN: What -- I'm asking you because I don't
9 know. What do you mean by present truth?

10 LISA: Present tru-- well, this is -- what
11 does that mean? What does it sound like? Present,
12 today, right now, present, right --

13 JOHN: But is this some religious dogma?

14 LISA: No.

15 JOHN: Do I believe in the truth. Is that
16 what you mean?

17 LISA: Yes. Second Peter, 1:12.

18 JOHN: I just asked you if we're talking
19 religious dogma and you said no.

20 LISA: No, it isn't. I'm just telling you --

21 JOHN: Do I believe in the truth. Tell me
22 the truth. Go ahead.

23 LISA: No, no. I'm telling you present
24 truth. There's a lot of truths out there, but what --

25 JOHN: What is the question you want to ask?
I'll, I'll answer any question you've got. What do you

1 want me to answer?

2 LISA: All I want to know --

3 JOHN: Uh-huh.

4 LISA: Well, I want you to look at --

5 JOHN: Yeah.

6 LISA: Okay. Is your believing in a religion
7 that's been around for a lot of th-- a lot of years.

8 JOHN: Yeah.

9 LISA: Okay?

10 JOHN: And I'm not faulting your religion. I
11 am not faulting yours. Do you under -- and I hope you,
12 you understand that I really mean that.

13 LISA: Yes.

14 JOHN: I feel that whether a person is of
15 your faith or whether they're Baptist or whether
16 they're Presbyterian or Methodist or Jewish or whatever
17 they are, that's their business.

18 LISA: Yeah.

19 JOHN: That's their prerogative. And I am
20 not going to try and sway them one bit from their
21 beliefs. And I hope you understand that.

22 LISA: That's, that's good.

23 JOHN: And I don't want you to try and sway
24 me from mine. Because I believe in something else.
25 Now, if I bel-- if -- hey, if I believed in, in, in
your church, that's my business, isn't it?

1 LISA: Um-hum.

2 JOHN: So --

3 LISA: That's true.

4 JOHN: So, you know, I don't, I don't
5 begrudge you or, or try and demean you for your
6 religious beliefs, and I think it's wrong for someone
7 to do that to anyone. You know? And I, and I wish you
8 well. I really do. I hope we meet again.

9 LISA: Okay. Thanks.

10 JOHN: You bet, kid.

11 LISA TO UNIDENTIFIED PERSON: Didn't want to
12 talk about my own --

13 STEVE: Hello?

14 JOHN: Hey. Who am I talking to?

15 STEVE: Back to Steve.

16 JOHN: Hey!

17 STEVE: What's happening?

18 JOHN: Gosh, you probably went and took a
19 break, didn't you?

20 STEVE: Well, now and then and from time to
21 time I, I do get one.

22 (Laughter.)

23 JOHN: I enjoyed talking to those people.

24 STEVE: Are you sure?

25 JOHN: Do you think I'll be able to talk to
any of the people on --

1 STEVE: Positively.

2 JOHN: That's great. That's great. Because

3 I enjoyed talking to them.

4 STEVE: I wasn't kid -- I mean, seriously --

5 JOHN: Let me ask you something. Let me ask

6 --

7 STEVE: Oh, sure.

8 JOHN: -- you something now.

9 STEVE: Sure. Go ahead.

10 JOHN: Are you going to let me hang up the

11 phone and call you back, and will you talk to me?

12 STEVE: Sure.

13 JOHN: The reason I'm saying that is I have

14 to make a trip.

15 STEVE: Gotcha.

16 JOHN: There are certain biological things --

17 STEVE: I gotcha.

18 JOHN: -- callings in life.

19 STEVE: I may not have inspiration, but I

20 have a little insight.

21 JOHN: God bless you.

22 STEVE: Okay. I --

23 JOHN: Now, if I ring you back in about 15,

24 20 minutes --

25 STEVE: I'll be here.

 JOHN: Will you?

1 STEVE: I'll be here.

2 JOHN: Do you think you'll have one or two of
3 those people for me to talk to, just to say howdy?

4 STEVE: It's getting late. I could go try to
5 wake them up. I don't know if they've be very happy.

6 JOHN: You can be persuasive. I know you
7 can, if you want to.

8 STEVE: Well, you know that anybody can go
9 wake someone up. Whether they'll be happy with you is
10 another story. Oh, these two girls that you were
11 talking to, I'll ask them if they'll go to wake
12 somebody up or something.

13 JOHN: And I don't, I don't mean to be mean
14 to them. You know? I just want to -- if they have
15 somebody --

16 STEVE: Well, they know. I mean, they've got
17 to know -- they've been around long enough to know
18 that, you know, you've got certain designs and lack of
19 interest in spiritual things. See, we're different, I
20 guess, aren't we?

21 JOHN: What do you mean --

22 STEVE: We --

23 JOHN: -- I have a lack of interest in
24 spiritual things? You --

25 STEVE: Well, it's, it's --

 JOHN: Don't tell me that now.

1 STEVE: Well, she apparently wasn't through
2 with talking to you. She was kind of --

3 JOHN: Hey.

4 STEVE: -- disappointed when the phone was
5 being handed to me --

6 JOHN: Hey.

7 STEVE: -- from what I could tell. Yes?

8 JOHN: When I come back you tell her to get
9 back on the phone. I'll talk to her. Okay?

10 STEVE: All right.

11 JOHN: I'm serious.

12 STEVE: Okay.

13 JOHN: You, you're going to answer it now,
14 huh?

15 STEVE: I'll be answering it.

16 JOHN: I'm going to let you get some sleep
17 tonight, too.

18 STEVE: Oh, sounds good.

19 JOHN: But you got too much last night.

20 STEVE: Well, let's, let's stay to it a tone
21 now.

22 JOHN: Okay.

23 STEVE: Don't get anymore than me.

24 JOHN: Hey, I'll call you back in 15 minutes.

25 STEVE: Okay. David said he still loves you,
John.

1 JOHN: I love him too.

2 STEVE: All right. And I'll --

3 JOHN: I hope --

4 STEVE: -- pass it on.

5 JOHN: -- to see him --

6 STEVE: Okay.

7 JOHN: --soon. Okay.

8 STEVE: You'll talk to who?

9 JOHN: Okay?

10 STEVE: He'd like to see how Jim's doing also

11 sometime again.

12 JOHN: Who?

13 STEVE: Jim. That ATF agent that started

14 with us.

15 JOHN: I don't --

16 STEVE: He's probably not around anymore or

17 is --

18 JOHN: I think --

19 STEVE: -- he or --

20 JOHN: I think -- I'm trying to think -- he

21 had to go someplace.

22 STEVE: Is he going to --

23 JOHN: I'll find out.

24 STEVE: Thank you.

25 JOHN: I'll find out. And, and when I call

you back, I'll let you know.

1 STEVE: All right.

2 JOHN: But he normally is, is around here
3 from like 6 in the morning to 6 in the evening.

4 STEVE: He is? Okay.

5 JOHN: But I, I got the impression this
6 afternoon that he had to go someplace. Whether it was
7 a trial or something, that he had to --

8 STEVE: Um-hum.

9 JOHN: -- to go someplace. I'll find out.
10 I'll get --

11 STEVE: Okay.

12 JOHN: -- back with you.

13 STEVE: Talk to you in 15.

14 JOHN: Thanks.

15 STEVE: Okay, bye.

16 JOHN: Bye.

17 *****

18 CATHY: Hello?

19 JOHN: Hi. Who's this?

20 CATHY: Cathy.

21 JOHN: Cathy?

22 CATHY: Uh-huh.

23 JOHN: This is John. Is Steve there?

24 CATHY: No, he isn't.

25 JOHN: He isn't?

CATHY: No.

1 JOHN: I'd told him I was going to call him
2 back in 15 minutes. And he's not there. Is David
3 there?

4 CATHY: Who?

5 JOHN: David.

6 CATHY: No.

7 JOHN: Well, where are they? David's
8 supposed to be right next to the telephone.

9 CATHY: Well, I'm -- they -- I don't know who
10 David is.

11 JOHN: You don't know who David is, huh?

12 CATHY: No.

13 JOHN: Okay. I'm sorry to bother you.

14 CATHY: Um-hum.

15 JOHN: Uh-huh.

16 *****

17 LISA: Hello?

18 JOHN: Hello.

19 LISA: Hi. Do you want to talk to Steve?

20 JOHN: Well, who's this?

21 LISA: This is Lisa again.

22 JOHN: No. I want to talk to you. He said
23 that I was too abrupt in --

24 (Clicking sound.)

25 JOHN: Hello?

(Dial tone.)

1
2 LISA: Hello?
3 JOHN: Lisa?
4 LISA: Yeah.
5 JOHN: What did you do to me?
6 LISA: No. I just got disconnected somehow.
7 Somebody must have stepped on the line.
8 JOHN: You threw the phone against the wall,
9 huh?
10 LISA: Yeah, I did.
11 JOHN: I didn't mean to be abrupt with you.
12 Go ahead, if you had someth-- Steve said there was
13 something else that you wanted to say.
14 LISA: Oh, no. That's okay. I realize, you
15 know, you have your beliefs and I have mine and --
16 JOHN: Hey --
17 LISA: -- what's just like -- that's --
18 JOHN: -- it'll all work out. Your beliefs
19 and my beliefs, they'll all work out, huh?
20 LISA: Yeah, because there's a God in heaven,
21 you know.
22 JOHN: You got it. And he loves us all,
23 doesn't he?
24 LISA: Um-hum.
25 JOHN: That's what counts. That's the bottom
line. If, if Steve's there, go ahead and put him on

1 with me.

2 LISA: Okay.

3 JOHN: Thank you.

4 LISA: Sure.

5 STEVE: John.

6 JOHN: Feel much better.

7 STEVE: You do? Good. Good.

8 JOHN: I do. I do.

9 STEVE: Oh. Good. So, it's after the

10 pumpkin hour here.

11 JOHN: It is?

12 STEVE: Yeah.

13 JOHN: Are we going to turn into something?

14 STEVE: Well, I, I'm hoping so.

15 JOHN: Yeah? Well, I do --

16 STEVE: Aren't you worn out after this long

17 day?

18 JOHN: No. No. I enjoyed it. I enjoyed it.

19 I mean, I, I enjoyed talking to David and -- and I

20 enjoyed talking to you.

21 STEVE: Where did you say home was for you?

22 JOHN: Home?

23 STEVE: Yeah.

24 JOHN: Lafayette, Louisiana.

25 STEVE: That's right. Louisiana.

JOHN: Down in the bay-- not Indiana now.

1 STEVE: No, no, no. I got it straight. I
2 got it straight.

3 JOHN: Down in the bayou.

4 STEVE: Yeah. David wanted to know if you
5 eat crawdads.

6 JOHN: You tell David that they are crawfish.

7 STEVE TO DAVID: He says I'm to tell you
8 they're crawfish.

9 DAVID: (Not discernible).

10 JOHN: And I know --

11 STEVE: He says he knows.

12 JOHN: I -- he probably uses them for bait.
13 Where I'm from they --

14 STEVE TO DAVID: He says you use them for
15 bait. Because he wants to know -- he says you probably
16 do it where he's from --

17 STEVE TO JOHN: They what?

18 JOHN: Eat them.

19 STEVE TO DAVID: They eat them.

20 JOHN: That's right.

21 STEVE: Okay.

22 DAVID: (Not discernible).

23 JOHN: So, are we going to get to talk to
24 anybody?

25 STEVE: Well --

 JOHN: I'll talk to David again if he, if he

1 | wants to. I'll talk to him again. You know what I
2 | mentioned to you.

3 | STEVE: John, you know what we're supposed to
4 | do? He asked to --

5 | JOHN: You're supposed to sleep probably.
6 | Yeah.

7 | STEVE: Well, yeah. He wanted us to read
8 | Isaiah 65 and 6 to you because of mentioning how you
9 | eat those crawfish.

10 | JOHN: Never mind. Never mind. I know what
11 | it's going to say.

12 | STEVE: What is it going to say?

13 | JOHN: They're going to poison me.

14 | STEVE: Well, it's close. And no cigars.

15 | JOHN: Hey. I don't smoke those either.

16 | Well, you got --

17 | STEVE: You can smoke a cigar, but don't eat
18 | those things.

19 | JOHN: Now, see? The cigar won't kill me,
20 | huh?

21 | STEVE: No, it won't.

22 | JOHN: No. I'd have a hard time convincing

23 | --

24 | STEVE: Hey --

25 | JOHN: -- somebody of that.

 STEVE: Hey, get this.

1 JOHN: Go ahead.

2 STEVE: It says here for behold the Lord will
3 come with fire and with his chariots like a whirlwind
4 --

5 JOHN: Uh-huh.

6 STEVE: -- to render his anger with fury and
7 his rebuke with flames of fire.

8 JOHN: Uh-huh.

9 STEVE: For by fire and by his sword will the
10 Lord plead with all flesh. And the slaying of the Lord
11 shall be many. They that sanctify themselves and
12 purify themselves in the gardens behind one tree in the
13 midst --

14 JOHN: Uh-huh.

15 STEVE: -- eating swine's flesh and the
16 abomination and the mouse shall be consumed together,
17 sayeth the Lord.

18 JOHN: It didn't say crawfish.

19 STEVE: If you read Deuteronomy, Chapter 14,
20 or Leviticus 11 --

21 JOHN: Uh-huh.

22 STEVE: -- you will see it there. Well --

23 JOHN: Well, will it say crawfish?

24 STEVE: Oh, yeah. Anything that doesn't have
25 fins or scales is bad for the body. See, if you eat a
pig, a pig is a, a --

1 JOHN: Oh, I know. I know.

2 STEVE: -- cesspool. It eats dead, decaying
3 fecal matter.

4 JOHN: Oh, yeah.

5 STEVE: It eats anything. So, God created
6 some animals to actually keep the world clean. They're
7 sort of clean. Other animals have been allowed -- have
8 been added to the diet for man's benefit.

9 JOHN: Well, you don't think crawfish were?

10 STEVE: Oh, definitely not. Definitely not.
11 They eat dead --

12 JOHN: Oysters?

13 STEVE: They eat -- oh, another thing that
14 eats dead, decaying matter down in the ocean is --

15 JOHN: Oysters?

16 STEVE: Oh, yeah. (Not discernible).

17 JOHN: Are you going to tell me --

18 STEVE: Rules that -- in fact --

19 JOHN: What about well, catfish?

20 STEVE: And as far as -- for --

21 JOHN: -- catfish have fins.

22 STEVE: Do they have scales though?

23 JOHN: Su-- catfish?

24 STEVE: Yeah.

25 JOHN: Yeah, they have scales.

STEVE: Are you posit--

1 STEVE TO DAVID: Do catfish have fins and
2 scales?

3 UNIDENTIFIED SPEAKER: No.

4 STEVE: No scales.

5 JOHN: No scales?

6 STEVE: No scales.

7 JOHN: You mean, no catfish?

8 STEVE: They eat bad -- they eat a lot of
9 dead crap on the bottom of the rivers and --

10 JOHN: Steven?

11 STEVE: -- places. Yeah?

12 JOHN: I guess oysters and beer are
13 definitely out, huh?

14 STEVE: Beer is okay. Beer is all right.

15 JOHN: In moderation?

16 STEVE: You got -- now, he said it the same
17 time you did.

18 JOHN: Huh?

19 STEVE: You and Dave said it at the same
20 time.

21 JOHN: We're on the same wavelength then,
22 aren't we.

23 STEVE: I, I'm hoping so.

24 JOHN: Well, that's the -- me, too.

25 STEVE: I'm hoping so.

JOHN: This is going to be depressing, going

1 back --

2 STEVE: He says that -- he says a little wine
3 is good with the Eucharist.

4 JOHN: Well, I, I, I'll go along with that.

5 STEVE TO DAVID: He says he'll go along with
6 that.

7 JOHN: I'll go along with that. Listen.

8 STEVE: Yeah.

9 JOHN: What do you, what do you think about
10 what I mentioned to you before? And I didn't mean it
11 to, to s--

12 STEVE: Well, do you want to talk to a few
13 people here?

14 JOHN: Yeah, or that -- or David.

15 STEVE TO DAVID: He'd like to talk to a few
16 people here or you, if it's possible.

17 DAVID: (Indiscernible).

18 JOHN: Hey, I don't want him to think he's
19 playing second fiddle.

20 STEVE: Yes. He said you -- he said we were
21 studying Habakkuk.

22 JOHN: I don't, I don't want him to think
23 that he's playing second fiddle now.

24 STEVE TO DAVID: He, he says he don't want
25 you to think he's playing second fiddle now.

 DAVID: Well, well, tell him to -- if he

1 | wants to listen, I'll read it. He can listen along.

2 | STEVE: He says now, if you will, he'll read
3 | it, if you want to listen along here.

4 | JOHN: Read what?

5 | STEVE: Habakkuk. It's very short. It's
6 | very short.

7 | JOHN: Some, somebody, you know, picked up
8 | the other phone and was playing some -- they said
9 | something about Saturday Night Live or something else
10 | on there?

11 | STEVE: Is that right?

12 | JOHN: Yeah. I don't know who inside there
13 | was --

14 | STEVE: John, you're all right. Here he is.
15 | Okay?

16 | JOHN: Okay.

17 | STEVE TO DAVID: Here he is.

18 | (Clicking sound.)

19 | JOHN: Don't disconnect --

20 | DAVID: Hello?

21 | JOHN: Hi.

22 | DAVID: Hey, John. Steve says he just don't
23 | know about you.

24 | JOHN: He doesn't?

25 | DAVID: Yeah. He says he likes you, but he
just don't know about you.

1 JOHN: Hey. He'll be able to find out
2 someday, though, huh?

3 DAVID: Yeah. Okey-doke. Aah.

4 JOHN: Are you feeling a little better?

5 DAVID: Are ya'll, are ya'll ready?

6 JOHN: You're feeling better tonight, aren't
7 you?

8 DAVID: Well, I, I feel kind of a lot better,
9 you know. I've, I've, you know, been able to get up a
10 little bit and try to -- it's just this top part of the
11 leg that's been --

12 JOHN: Did, did --

13 DAVID: You know where you --

14 JOHN: Does --

15 DAVID: You know where your -- let me tell
16 you exactly where I got hit, all right?

17 JOHN: Where?

18 DAVID: Okay. You see where your, see where
19 your left leg is? Okay?

20 JOHN: Yeah.

21 DAVID: Do you know where the hip bone is?

22 JOHN: Yes, sir.

23 DAVID: Okay. Now, when you're going towards
24 your belly button?

25 JOHN: Yes, sir.

 DAVID: Come over about four inches.

1 JOHN: Okay.

2 DAVID: I got hit right there in the belly --

3 JOHN: Just the left side where you'd have an
4 acka-- appendectomy scar on the right side. Just about
5 the opposite, huh?

6 DAVID: Right. Okay. So, you four -- about
7 four inches from the belly to the left.

8 JOHN: Okay.

9 DAVID: All right.

10 JOHN: And it went which way?

11 DAVID: And it went in. It went in and hit
12 the hip bone.

13 JOHN: Uh-huh?

14 DAVID: The top of it. Because that thing --
15 you know, I'll tell you.

16 JOHN: Uh-huh.

17 DAVID: And then it came out my back --

18 DAVID TO LISA: How many inches is it from
19 the middle of my hip to the back again, Lisa? About
20 what?

21 LISA: (Not discernible).

22 DAVID: Well, like if, if I'm laying on my
23 back, I'm laying on it. It's just a -- it's, it's a,
24 it's a so-- it's a big caliber. I guess it's about --
25 was a .45-er. I don't know.

DAVID TO UNIDENTIFIED PERSON: What would you

1 | say, about a .45?

2 | JOHN: It should have been something a little
3 | smaller.

4 | DAVID: You think 9-mm?

5 | JOHN: Yeah.

6 | DAVID: Probably a hypersonic then.

7 | JOHN: Something -- I -- well, I don't know,
8 | but that's what the round should have been, probably.

9 | DAVID: Yeah. And -- so, anyway, it went in
10 | there --

11 | JOHN: There's no infection though, huh?

12 | DAVID: No. No.

13 | JOHN: Good.

14 | DAVID: I let it -- you know, like I said, I
15 | bled over three qu-- three pints or so.

16 | JOHN: Yeah.

17 | DAVID: And I learned that from a long time
18 | ago, that any time you start covering them up and all
19 | that they don't bleed clean.

20 | JOHN: Yeah.

21 | DAVID: So, like I said, it -- now, I bled a
22 | couple of blankets and -- because I laid in three
23 | different places on the floor.

24 | JOHN: But it, it hit, hit you in the wrist
25 | also?

 DAVID: Yeah. Well, then, the shell -- a, a

1 round -- second --

2 JOHN: Or, or another round?

3 DAVID: Well, that was a completely different
4 bullet.

5 JOHN: Oh. Oh.

6 DAVID: See, first, at first, I thought I'd
7 been shot twice.

8 JOHN: Uh-huh.

9 DAVID: But, actually, what we figured out
10 what it did was I got shot and -- several rounds were
11 fired at me, because it went, it went in the front, and
12 then went straight out the back. That's what happened.

13 JOHN: Uh-huh. Did you --

14 DAVID: And --

15 JOHN: -- get the use of that suture kit at
16 all?

17 DAVID: Huh?

18 JOHN: Did you --

19 DAVID: No. What, what they're saying is is
20 that it's already swollen up and it, it's already
21 started to heal.

22 JOHN: Uh-huh.

23 DAVID: It's about a -- oh, good over a half-
24 an-inch in gash. If somebody was to take above your
25 wrist there and just make a clean cut like a little
ditch --

1 JOHN: Going up your forearm?

2 DAVID: Going sideways, on the side of it,
3 the side of my thumb.

4 JOHN: Uh-huh.

5 DAVID: Up, up above the thumb. But my whole
6 thumb is totally numb.

7 JOHN: Really?

8 DAVID: So, it's just numb now.

9 JOHN: (Not discernible).

10 DAVID: Yeah. See, what happened was, what
11 happened was I went to, I went to see what was going
12 on. You know, I was just -- I was walking around
13 seeing what was going on. And when I, when I went up
14 one place, then that's when some -- you know, I looked
15 out the window. Some rounds came up and that's, and
16 that's when they hit me there.

17 JOHN: You think you got your hip broken?

18 DAVID: I think it's either chipped or
19 cracked --

20 JOHN: Yeah.

21 DAVID: -- at the very top of it.

22 JOHN: Yeah.

23 DAVID: And, of course, the back hole was a
24 lot bigger than the front hole. It was like I went
25 outside (not discernible) --

JOHN: You don't have any of those girls in

1 | there that, you know, have some medical background that
2 | could really tell you whether you, you broke a bone
3 | there, huh?

4 | DAVID: Oh, we've got two --

5 | JOHN: You think you just chipped --

6 | DAVID: -- we've got two RNs. We've got two
7 | Registered Nurses here.

8 | JOHN: You think it just may have just
9 | chipped it a little bit?

10 | DAVID: I don't know. It's just hard to
11 | tell.

12 | JOHN: Well, when you tried walking?

13 | DAVID: Well, see, the way I have to walk --

14 | JOHN: Could you put any weight on it?

15 | DAVID: Not -- only when it's straight up and
16 | down.

17 | JOHN: Uh-huh.

18 | DAVID: It's all, all from the -- it's from
19 | the hip belt --

20 | DAVID TO UNIDENTIFIED PERSON: I'll be right
21 | with you on a second.

22 | DAVID TO JOHN: From the belt up is just big
23 | swollen.

24 | JOHN: Uh-huh.

25 | DAVID: You know, it's just, it's just real
big swollen.

1 JOHN: Uh-huh.

2 DAVID: So, anyway -- so --

3 JOHN: Well, you sure sounded a lot better
4 tonight than you did, did last night.

5 DAVID: It's, it's hyperkinetics.
6 Hyperkinetics.

7 JOHN: It is?

8 DAVID: Mind power. Mind power.

9 JOHN: The mind over the body, huh?

10 DAVID: Well, yeah. Plus the mind over the
11 -- so, it's when you treat your body descent, you know,
12 you heal faster, too. Or maybe God's just healing me.
13 I know people are scoffing and laughing, but --

14 JOHN: What?

15 DAVID: -- let them get shot like this and
16 see.

17 JOHN: Well, I don't think anybody's laughing
18 about it at all?

19 DAVID: I mean, what -- it's all on the
20 radio. They're going, ah, he wasn't shot or --

21 JOHN: Well --

22 DAVID: -- or emergency (Indiscernible), oh,
23 yeah.

24 JOHN: I'll tell you what --

25 DAVID: We was thinking about, we was
thinking about sending y'all some pictures.

1 JOHN: The media is -- you know, you take the
2 media with a grain of salt. But if you want to send
3 some pictures out -- I'll tell you. Do it.

4 DAVID: I think I might.

5 JOHN: Do it. I mean --

6 DAVID: They were, they were thinking about
7 these holes.

8 JOHN: Hey. Send them out.

9 DAVID: He appears to be on my side.

10 JOHN: I did -- hey. That's, that's carrying
11 it a little far, isn't it?

12 DAVID: Yeah. And it's a bullet hole this
13 time instead of a spear.

14 JOHN: I'm not going --

15 DAVID: Okey-doke.

16 JOHN: I'm not going to give you any, any
17 sponge with --

18 DAVID: Vinegar.

19 JOHN: -- bitter, bitter wine either, am I?

20 DAVID: No. Gall.

21 JOHN: You got it.

22 DAVID: Vinegar.

23 JOHN: The -- no. If, if -- seriously, if
24 you want to, if you want to send out some pictures, I'd
25 be happy to send them -- show them to some medical
people, too. You know what I, what I mentioned a

1 | little earlier?

2 | DAVID: What was we talking about?

3 | JOHN: God, I guess we mentioned a bunch of
4 | things. But what I talked about, if you wanted to send
5 | out a message.

6 | DAVID: Oh, yeah. Well, like I said, it's,
7 | it's kind of a --

8 | JOHN: Get up -- go ahead.

9 | DAVID: It was kind of a -- you know, I don't
10 | want to, I don't want to -- you know, what I gave in
11 | the first message --

12 | JOHN: Yeah.

13 | DAVID: -- was serious enough. I mean,
14 | nobody can deny that Psalms 45 was the first seal. You
15 | know, nobody in their right mind. Hey. Psalms 45.
16 | David, a great king, was inspired of God to write in
17 | behalf of God, and surely God could write himself. God
18 | wrote the law with his own finger. And then God told
19 | Moses to write the laws afterwards. But, you know,
20 | it's kind of like this. We heard ministers the other
21 | day, lots of them, get on the phone and --

22 | JOHN: Yeah.

23 | DAVID: -- well, ah, this and this and ah
24 | some theologians in the apocrypha believe that, ah,
25 | this, that, and that and this, and we believe, and we
 | feel, beh, beh, beh. And I just come straight across

1 the table, going, now, what's this little key of David
2 right here? Let's start with Psalms 45, putting little
3 key in, open the door. Look here at Psalms 45. Say it
4 was Revelations.

5 JOHN: Hey --

6 DAVID: See?

7 JOHN: Let me, let me tell you --

8 DAVID: And people go like wow --

9 JOHN: You --

10 DAVID: -- it's right.

11 JOHN: -- you can respond to that.

12 DAVID: I win. You lose.

13 JOHN: You know, you can respond to that if
14 you --

15 DAVID: The first point's mine, right, John?

16 JOHN: Hey.

17 DAVID: Right?

18 JOHN: Whatever.

19 DAVID: Did I win the first point?

20 JOHN: Well --

21 DAVID: Hey, seven strikes you're out. You
22 know that, don't you?

23 JOHN: Seven strikes you're out?

24 DAVID: Seven strikes, you're out forever.

25 JOHN: Nah.

DAVID: Yep. God's going to whup your

1 behind, going to burn --

2 JOHN: Yeah, but he --

3 DAVID: -- you.

4 JOHN: -- he won't be getting a fresh one,
5 I'll tell you that, to whip on.

6 DAVID: I tell you.

7 JOHN: But if you want to, to respond to what
8 you saw on the news or anything else, I, I --

9 DAVID: Why would you want to do that for me
10 anyway?

11 JOHN: Well, did you understand --

12 DAVID: Because you don't believe --

13 JOHN: Did you understand --

14 DAVID: -- my (not discernible) --

15 JOHN: -- everything I said that --

16 DAVID: You said send some girls out and send
17 some kids out, and we're, we're going to come out.

18 JOHN: I know you are.

19 DAVID: You see, we're just waiting on God
20 because God, when we come out --

21 JOHN: I know you are.

22 DAVID: -- God's going to give you a chance
23 to judge us, and then God is going to show you what
24 he's talking about.

25 JOHN: Well, I hope so.

DAVID: For right now the truth, the seed is

1 spreading. And, you know, people have an opportunity
2 right now to look at the situation, to see how you're
3 working, and they don't know nothing about us.

4 JOHN: No, they don't.

5 DAVID: When, when we come out --

6 JOHN: Other than what you told them on that
7 tape.

8 DAVID: Right. And when we --

9 JOHN: That's the only thing. And, and if --

10 DAVID: Well, that's what -- you know, God's
11 word sounds pretty far (indiscernible) first -- you
12 know, hey, don't -- don't be stupid.

13 JOHN: But you've got a lot of people that
14 are just sitting out there saying, aw, what's this guy
15 talking about. And, and they, and they take it in kind
16 of a frivolous vein when they shouldn't --

17 DAVID: Ooh --

18 JOHN: -- take it in a frivolous vein.

19 DAVID: You know, Psalms -- you know what
20 Psalms 1 says? Blessed is the man that walketh not in
21 the counsel of the ungodly nor sits in the seat of the
22 scorers. Right? Or stands in the way of sinners, but
23 whose delight is in the law of the Lord, and in his law
24 on what he meditates day and night. You know, why the
25 law? It says he shall be as a tree planted by the
waters and his leaf shall not fade. Everything he does

1 | shall prosper. The ungodly are not so, but like a
2 | chaff which the wind blows away. Therefore, the
3 | ungodly will not stand in the judgment nor sinners in
4 | the congregation of the saints. The way of the ungodly
5 | shall perish. Now, it's very ungodly not to pay
6 | attention to scripture. It's very ungodly to mock or
7 | to lightly esteem the fact that Psalms 45 is the first
8 | seal. I cannot help it --

9 | JOHN: You've seen and heard it, though,
10 | haven't you?

11 | DAVID: -- I cannot help it that people
12 | disregard -- why -- why do you think the second seal
13 | says what it says? Huh? Why do you think that you're
14 | fulfilling the very thing God says you're going to
15 | fulfill before he beats your butt? You don't even know
16 | the second seal, do you?

17 | JOHN: No.

18 | DAVID: Okay. Well, I'd like to show you.

19 | JOHN: Go ahead.

20 | DAVID: Okay. We're going to, we're going to
21 | alter our route here for a second. We're going to show
22 | John the second seal. Let's turn to Revelation 6,
23 | verses 3. I appreciate this, John, for my sake --

24 | JOHN: Well, I do too.

25 | DAVID: It's for my sake too, because I
really would like you to -- the light to turn on. I'd

1 | like to see you in the kingdom, you know? So, you
2 | know, it's -- we're all made of flesh and blood and we
3 | all get this one life to learn about good and evil and,
4 | and then, you know, then we've got to stand for a
5 | judgment. If we haven't accepted Christ's
6 | righteousness, the truth of God, then we're going to
7 | lose. Okay. Verse 3. Revelation 6, verse 3.

8 | JOHN: I'm there.

9 | DAVID: And when he had opened the second
10 | seal, I heard the second beast say: Come and see. And
11 | there went out another horse that was red. And power
12 | was given to him and set thereon to take peace from the
13 | earth, and that they should kill one another. And
14 | there was given unto him a great sword. Again, it may
15 | appear to be a subject of violence, just like the first
16 | seal may appear. For, remember, if God makes any
17 | violent threats against us, it's so that we might fear
18 | him so that we might receive his mercy. Correct?

19 | JOHN: Um-hum.

20 | DAVID: Okay. That's what you're doing out
21 | there. You're showing me a show of arms so we might
22 | fear you so we might come out to receive your mercy.
23 | I, I appreciate that. Thank you very much. Now, let's
24 | turn to the --

25 | JOHN: Well, I don't think I'm talking mercy
 | though, huh? Not me or, or we. We're not talking --

1 DAVID: Well --

2 JOHN: -- mercy.

3 DAVID: -- at least, at least the mercy of
4 the judicial system.

5 JOHN: And, and I hope you understand and --
6 that what I tell you is --

7 DAVID: Oh, I realize that. I, I've been
8 hurt before. Don't --

9 JOHN: -- is true.

10 DAVID: -- don't (not discernible).

11 JOHN: You know, that --

12 DAVID: I'm not asking for no, no bequittal
13 or anything like that or amnesty. What I've done, I'm
14 willing -- ready, ready and willing to pay for.

15 JOHN: Well, whatever that may be, huh?

16 DAVID: A lot less than one shall think --

17 JOHN: Well, okay.

18 DAVID: -- that I've done.

19 JOHN: You know, I, I hope it is. And, and

20 --

21 DAVID: That's why I want to talk to Robert.

22 You know --

23 JOHN: You're going to get the opportunity to

24 --

25 DAVID: I did everything in my power to keep
you guys from making that mistake.

1 JOHN: I know. You said that you had a lot
2 of dialogue with Robert about it. And, and I, and I
3 know he's taking --

4 DAVID: He was the one --

5 JOHN: -- this thing very diffic-- it's very
6 difficult for him.

7 DAVID: Well, you tell him I still love him.

8 JOHN: Well, I'm sure he -- that he believes
9 you do. You know, I can't tell him. He's --

10 DAVID: He's going to, he's going to --

11 JOHN: -- he's not around Waco anymore, I'm
12 afraid, but --

13 DAVID: Well, you need to get him back --

14 (clicking sound.)

15 DAVID: Hello? Hello, Robert? Okay. Are
16 you there?

17 JOHN: Hello?

18 DAVID: All right.

19 JOHN: Yeah.

20 DAVID: Now, are we in the book of Zechariah?

21 JOHN: No. We're in the book of Revelation.

22 DAVID: Well, now, let's turn to Zechariah
23 and let's bust this seal.

24 JOHN: Okay. Be patient with me.

25 DAVID: I will.

JOHN: Hang on. Almost there.

1 DAVID: John, I don't mind if you're a --

2 JOHN: We're there.

3 DAVID: -- Catholic. I don't mind if you're
4 a Catholic, John. I just hope you're a --

5 JOHN: Well, I hope not.

6 DAVID: -- a good Catholic.

7 JOHN: I hope not. And I hope I am.

8 DAVID: Now, a good Catholic believes in the
9 Bible, don't they?

10 JOHN: You bet. And the Ten Commandments.

11 DAVID: And the Ten Commandments. Although
12 the sa-- sabbath -- you changed the sabbath a little
13 bit, but, nevertheless, still you've got a sabbath in
14 there somewhere, right?

15 JOHN: I'll, I'll do you a favor. I'll go to
16 church on Saturday. How's that?

17 DAVID: (Laughter.)

18 JOHN: Huh?

19 DAVID: Well, you ought to go to church every
20 day too, just like we do.

21 JOHN: We have an --

22 DAVID: We keep it daily.

23 JOHN: -- evening mass on Saturday. How's
24 that?

25 DAVID: Okay.

JOHN: Maybe we're swaying a little bit, huh?

1 DAVID: Well, like I say, there's a narrow
2 path and a broad path. So, let's see if we can't
3 resolve it.

4 JOHN: Chapter 1.

5 DAVID: Chapter 1. Now, it was in the eighth
6 month of the second year of Darius, which was one of
7 the kings of Middle Persia, came the word of the Lord
8 to Zechariah, the son of Berekiah, the son of Iddo, the
9 Prophet, saying: The Lord has been sore displeased
10 with your fathers. Okay. So, God was angry with the
11 Jews, right?

12 JOHN: Um-hum.

13 DAVID: Therefore, say though unto them:
14 Thus sayeth the Lord of Hosts. Turn ye into me, said
15 the Lord of Hosts, and I will turn into you, sayeth the
16 Lord of Hosts. Kind of a barter there, huh?

17 JOHN: Um-hum.

18 DAVID: How do we turn to God, though? How
19 will they turn? Well, be not as your fathers and to
20 whom the former prophets have cried, saying: Thus
21 sayeth the Lord of Hosts, turn ye now from evil ways
22 and from your doings. But they did not hear nor
23 hearken unto me, sayeth the Lord. So, they wouldn't
24 listen to prophets, would they?

25 JOHN: Um-hum.

 DAVID: No. Your fathers, where are they?

1 Dead. And the prophets, do they live forever? No.

2 JOHN: No.

3 DAVID: But my words and my statutes which I
4 commanded to my servants the prophets, did they not
5 take hold of your father? Isaiah the prophets foretold
6 a battle that overthrow the Jews if they didn't listen.
7 And they were. And after 70 years, all of a sudden
8 they came out of captivity, and now Zechariah is
9 prophesying. And they returned and said, like has the
10 Lord of Hosts ought to do unto us according to our ways
11 and according to our doing, so hath he dealt with us.
12 See, prophecy is important, isn't it?

13 JOHN: Um-hum.

14 DAVID: Upon the four-and-twentieth day of
15 the eleventh month, which is in the month Shebat, in
16 the second year of Darius came the word of the Lord
17 unto Zechariah, the son of Berekiah, the son of Iddo,
18 the prophet, saying: I saw by night and, behold, a man
19 riding upon a red horse. Isn't that complicated? Huh?

20 JOHN: Yeah.

21 DAVID: It's a kid's game, isn't it?

22 JOHN: Sure.

23 DAVID: Who do you think this guy is on the
24 red horse?

25 JOHN: Speckled in white.

DAVID: And he stood among the myrtle trees

1 that were under the bottom. See, in Jerusalem there's
2 a valley called the Kidron.

3 JOHN: Um-hum.

4 DAVID: Okay. It runs right into -- between
5 the Mount of Olives and, and, and the Mount Mariah
6 (phonetic). And behind --

7 JOHN: I only wish I could go over there and
8 see it.

9 DAVID: Oh, any time, you know. Helal's
10 (phonetic) a good airline.

11 JOHN: Well, you --

12 DAVID: And behind him there were red horses.
13 Now, the Hebrew word speckled, the translators in the
14 English, it's pale. Okay? That there's a word
15 translation. Get your dictionaries out and look. In
16 other words, red horses, pale and white. Then said I:
17 O my Lord, what are these? What does this mean? You
18 know, what are these? What are these horses? What do
19 they -- what does it mean? The angel that talked unto
20 me said unto me: I will show thee what these be. And
21 the man that stood among the myrtle trees answered and
22 said: These are they who the Lord has sent to walk to
23 and fro through the earth. Uh-huh. A little
24 spiritualism here. You ever see horses walking to and
25 fro through the earth?

JOHN: Um-hum.

1 DAVID: You ever go around and see all these
2 horses? And they answered the angel of the Lord --
3 now, horses don't talk, do they?

4 JOHN: Not likely.

5 DAVID: These horses do though, don't they?
6 They answered to the angel of the Lord that stood among
7 the myrtle trees and said: we have walked to and fro
8 through the earth and, behold, all the earth sits still
9 and is at rest. Well, remember the Book of Nahum?

10 JOHN: Hmm.

11 DAVID: There's a group that says though that
12 it be likewise quiet and likewise many? See, they're
13 hiding. You know, they're being real quiet. It says
14 they camp out in the hedges, you know, and the bushes
15 and everything, that God's fixing to come and burn them
16 up. Remember?

17 JOHN: Um-hum.

18 DAVID: Because they're fighting against the
19 Lord. They don't know that yet, but they're fighting
20 against the man that brought good tidings. Now, these
21 horses, the way they travel, because everywhere the
22 Bible goes they go. Everywhere there's a scripture,
23 there's a revelation of Jesus Christ, which is a
24 mystery of God God declared aforetime to who? His
25 servants the prophets. Right?

 JOHN: Um-hum.

1 DAVID: Then the angel of the Lord answered
2 and said: O Lord of Hosts, how long will thy not have
3 mercy on Jerusalem and on the citizens of Judah,
4 against which thou has had indignation these three
5 score and ten years? For 70 years God allowed Judea to
6 be led into captivity into Babylon. Well, they still
7 have to go through Middle Persia, Greece, Rome, Europe,
8 and sometime during the times that Europe still stands
9 as a broken nation.

10 JOHN: Okay.

11 DAVID: Then God the Rock will set up a
12 kingdom. And the Lord answered the angel that talked
13 with me with good words and comfortable words, and so
14 the angel communed with me and says: Cry thou: Saying
15 thus the Lord of Hosts, I am jealous for Jerusalem and
16 for Zion with a great jealousy. And I am very sore
17 displeased with the heathen that are at what?

18 JOHN: That are at ease.

19 DAVID: Because they don't care about these
20 horses, do they?

21 JOHN: No. Kind of taking a lackadaisical
22 attitude.

23 DAVID: Right. For I was but a little
24 displeased and they helped ford the what? Of -- so,
25 God's being afflicted, isn't he?

 JOHN: Um-hum.

1 DAVID: Therefore, thus sayeth the Lord, I am
2 returned to Jerusalem's mercies and my house shall be
3 built in it sayeth the Lord of Hosts, and a line shall
4 be stretched forth upon Jerusalem. Cry yet, saying --
5 cry yet, saying: Thus sayeth the Lord of Hosts -- are
6 you there?

7 JOHN: Yeah.

8 DAVID: My cities through prosperity, she
9 have be spread abroad. And the Lord shall yet comfort
10 Zion and shall yet choose Jerusalem. It doesn't say
11 when, though, right?

12 JOHN: No.

13 DAVID: Then lifted up mine eyes and saw and,
14 behold, four horns. Uh-uh.

15 JOHN: Which means?

16 DAVID: Well, let's find out. And I said
17 unto the angel that talked with me: What be these?
18 And he answered me, these are the horns which have
19 scattered Judah, Israel, and Jerusalem. Well, what
20 were the four empires that scattered Judah, Jerusalem,
21 and Israel? Babylon, Middle Persia, Greece, and Rome.
22 Huh. And the Lord showed me four carpenters. You
23 know, carpenters build, right?

24 JOHN: Um-hum.

25 DAVID: Then said I: What come these to do?
And he spake, saying, these are the horns which have

1 scattered Judah, stood nobly, then lift up his head.
2 But these are come to fray them. To scare them. To
3 cast out the horns of the Gentiles, which lifted up
4 their horn over the land of Judah to scatter it. Now,
5 wait a minute. How can it be that Babylon, Middle
6 Persia, Greece, and Rome can come back to Jerusalem one
7 day to try to scare the Jews, and at the same time
8 scatter the Gentiles? Well, it's, it's a situation
9 you'll find in other prophecies that deals with Amon
10 Moab, right? The Arab nations want Jerusalem. Okay?
11 And unless the empires of Babylon, Middle Persia,
12 Greece, and Rome combine together and defend Jerusalem,
13 the Arab nations would overthrow it. Now, this is
14 something very serious. Now, here's the next part of
15 it. I lift up mine eyes again and looked to behold a
16 man with a measuring line in his hand. And said I:
17 Whither goest thou? And he said unto me: To measure
18 Jerusalem, to see what the breadth thereof and what is
19 the height -- length thereof. To see how big it is.
20 Because no doubt he wants to populate it, right?

21 JOHN: Um-hum.

22 DAVID: And behold the angel that talked with
23 me went forth. Another angel went up to meet him and
24 said to them: Run, speak to this young man, saying
25 Jerusalem shall be inhabited as towns without walls for
the multitude of men and cattle therein. Now, we can't
