Well, at the moment, we don't 10 11 think it's necessary. 12 HENRY: Okay. What time exactly did you take 13 the, the blood pressure? JILLIAN: I've only just taken it about 3 14 15 minutes ago. 16 HENRY: Okay. And what is your name? 17 JILLIAN: My name is Jillian Matthew. HENRY: Okay, Jillian. If you would, see 85 18 over 40 is a little bit, you know, is a little bit of a 19 concern. So I would like for you to take it like maybe 20 21 in another half hour or so. 22 JILLIAN: Um-hum. All right. 23 HENRY: Okay? 24 JILLIAN: Yes. 25 HENRY: Okay. May I speak to him? JILLIAN: All right. You -- like to speak to

1 you. 2 DAVID: Yeah. 3 HENRY: You're holding up, huh? 4 DAVID: Yeah. But she said it was a miracle. 5 ~ HENRY: Yeah. Yeah. 6 DAVID: I got to -- like I said, you know, 7 you got a, got a strong will you got a strong will. 8 HENRY: Um-hum. Well, that's real good. 9 We're happy to hear that. I have a bit of a concern. 10 DAVID: Uh-huh. 11 HENRY: Okay? And the concern that I have is, you know, when these children are coming out they 12 are all convinced that they're not going to see their, 13 their mamas again or their daddies. Okay? Now you 14 15 gave me your word --DAVID: Now wait a minute. Now you're making 16 a statement, you're making a statement which is totally 17 contrary to everything those children with reasoning 18 powers have been taught. Scripturally you're denying 19 what they themselves have sit and heard day by day. 20 So I know point blank that, you know, you 21 have not asked them in regards to whether they're going 22 to see their parents again. Because the whole doctrine 23 revolves around, you know, Isaiah 49 where it says I 24 will save thy children referring to the covenants. 25 you know, they, they know all of these or at least are

-

aware in conversational-wise children that age usually 1 2 do not have a conscience to discern or understand, you 3 know, the high points of doctrine or philosophy. 4 But no, the thing of it is that, you know, every one of these mothers tell them well, I'll see you 5 So I don't know why you're saying that, Henry. 6 7 HENRY: Well, I'm not, I'm not questioning, 8 you know, your word. You know, I just --9 DAVID: Well, I mean how -- you know, by, by your statement it implies that you're just making a 10 11 statement. But the question lies is did you really ask 12 them? 13 **HENRY:** Well, see, for example. One of the kids, you know, came out with a note that says that, 14 that his name is Joshua and that he's 7 years old and, 15 you know, it lists all the different people that, you 16 17 know, I guess are relatives of --Relatives. Correct. 18 DAVID: 19 HENRY: Okay. 20 DAVID: And we've, and we asked, we asked Jim originally. We said look, Jim. Because we -- first of 21 22 all, our children don't eat pork. 23 **HENRY:** Okay. 24 DAVID: Okay? Now whether you all uphold that or not we, we cannot really guarantee that. But 25 come to find out instead of calling the -- because I

understand it may take a day or two in some cases. 1 instead of calling the present closest relative, you 2 all, you all have gone ahead and put them down at the 3 social place. 4 ~ HENRY: Um-hum. Um-hum. 5 6 DAVID: You know, and which, you know, like I say that's kind of really neither here nor there at 7 this point in time. You know, I've trusted Jim. 8 would think that he would be smart enough not to 9 consider these children, you know, worthy of a foster 10 home or something like that. Because that would 11 strictly violate the reasons why that, you know, most 12 of these women and stuff would be coming out in the 13 14 first place. 15 HENRY: Okay. 16 I mean they don't want to be judged DAVID: or considered that they're unworthy of motherhood. 17 18 HENRY: Um-hum. 19 Or you know, having their children, DAVID: you know, because of an incident such as we're in at 20 the present time. 21 22 HENRY: Uh-huh. 23 I mean that's another thing of trust DAVID: Because like I say, maybe that's what you're 24 again. going to do. Maybe that's not what you're going to do. 25

You know, we don't know as of yet. Like I say, you

know, in my case I realize that, you know, I'll, I'll never see my children again, you know? Because, you know, I understand through, through many, many 3 observations and through much history research, you 4 know, how the government works and stuff. Like I say, 5 I will dance to the music that I, I have played to. 6 You see what I'm saying? 7 8 **HENRY:** Um-hum. 9 Okay. But the main thing is for me to stand up in front of my Father, my God, and to 10 present a truth that he gave to me. Because there's 11 one reality that's above all realities. And that is 12 when the powers that control the universe, you know, 13 when those other worlds and those other beings out way 14 beyond, when they come and communicate to you, you 15 16 know. 17 HENRY: Um-hum. 18 A lot of people have a very DAVID: Elizabethan ideal of God. You understand? 19 20 HENRY: Um-hum. 21 DAVID: They think God's got a beard and wears a robe and, and not a very smart, you know, it's 22 kind of old, you know, traditional old English or, you 23 know. God is very high-tech. God's got computer 24 systems and technology above and beyond what this 25

world's ever seen.

HENRY: Um-hum. 1 2 I know Harry, you see. DAVID: 3 HENRY: Um-hum. 4 DAVID: In 1985 like I said I had a little 5 visit when I was in Israel. I've always been a sincere 6 guy like Randy will tell you, you know, if you ever 7 interview Randy. He knows I used to always tell him as a kid that, you know, there's got to be a God. And all 8 my life I've, I've had this calling, this, you know, 9 10 these -- anyway. But never mind. 11 But the thing comes down to this. There's a 12 test in latter days. And it's a test of human intelligence. And all that which is human that is not 13 going to use its intelligence. I don't mean in regards 14 15 to bureaucratic law. 16 HENRY: Um-hum. DAVID: You see, remember that two 17 individuals that are into bureaucratic control --18 19 HENRY: Um-hum. 20 DAVID: -- can cause millions of people to go 21 to war. 22 HENRY: Um-hum. DAVID: A hothead like Hussein and a hothead 23 like -- oh, my mind, let's see here. The Cuban guy, 25 Castro.

HENRY: Uh-huh.

DAVID: See just their, their one decision 1 2 can cause many men to go and lose their lives, right? 3 HENRY: Right. DAVID: Well, see you might call that a 4 political thing. 5 6 HENRY: Um-hum. DAVID: But it really it's, it's, politics is 7 8 another form of religion. 9 HENRY: Um-hum. 10 You see. It denies a deity, a DAVID: sovereignty. But still it has its principles --11 12 HENRY: Um-hum. 13 DAVID: -- its philosophies and its -- well, not theology. It's I guess humanology (sic). 14 15 Utopianistic views. 16 HENRY: Um-hum. 17 DAVID: Okay. So the point that we finally come around to is this. If you were in Israel and you 18 was confronted with, you know, something from beyond 19 this world, something that, you know, confronted you 20 and communicated with you and told you what you must do 21 and showed you things such as you have never dreamed. 22 See I used to stutter all my life. I was a stutterer. 23 24 HENRY: Um-hum. 25 I stammer all through school. DAVID: speech problem. You know?

1 HENRY: Uh-huh. 2 But after that event, I never DAVID: 3 stuttered again. 4 HENRY: Uh-huh. 5 - DAVID: But like I say, we have to, we have 6 to realize that, that in today's world with such modern 7 technology everywhere we, we have to look at old truths 8 of the Bible --9 HENRY: Um-hum. 10 DAVID: -- in a modern way. 11 HENRY: Um-hum. 12 DAVID: And the modern way is, is 13 computerized technology. Seven seals, what is it? You 14 know, data program. In other words, what mind of man 15 can be able to categorize all the testaments of the prophets and put it together into seven categories. 16 17 See now that's technology. 18 HENRY: Uh-huh. 19 DAVID: And the thing of it is it's called 20 wisdom. 21 HENRY: Um-hum. 22 DAVID: And scripture teaches us that if we fail to be interested in this riddle, then the worlds 23 that are beyond our world are going to destroy all 24 those whose attitude have shown that they have not 25 chosen to increase and grow in wisdom.

1 HENRY: Um-hum. 2 DAVID: See, the prophecies themselves may be 3 allegorical. 4 HENRY: Um-hum. 5 They may be just little stories. DAVID: 6 nonetheless, it still is a test. 7 HENRY: Um-hum. 8 DAVID: You know, when you're, when you're a little kid and they send you to a psychiatrist don't 9 they put, tell you to put these little blocks in this 10 little block thing there? And you got to shape up, 11 match up the sizes? 12 HENRY: Right. 13 14 DAVID: Okay. Well, the same as this last revelation. We have such pious and powerful men in the 15 16 world. Such power. Look at the Pontiff. 17 HENRY: Um-hum. 18 DAVID: You notice how powerful that 19 religious man is? 20 HENRY: Um-hum. 21 DAVID: I mean no one questions the, the 22 history and origin of the papacy. . 23 HENRY: Um-hum. DAVID: I mean it killed millions. 24 25 Jesuit priesthood for those who went against its infallible laws. The eucharist, the catechism. All

HENRY: Well, one of the things that, that we have a concern about, of course, is the kids. We're hoping and we're, we're certain that we want them to be reunited with their families. We can count on that.

DAVID: Yeah, well, we realize also, and I was discussing it with some of the people here that, that, you know, once we go out there's going to be, you know -- now we realize our butts are in trouble. There is some extensive research that has to be done, you know. Someone is responsible for the deceasement (sic) of law enforcement officers.

HENRY: Um-hum.

DAVID: You know. I'm, I'm hopefully they say on the news that it shows clearly in regards to when the officers first approached it shows, you know, who fired first. Because I was standing right there in the door. And I know, you know, that no fire came from our side first.

1 **HENRY:** Okay. 2 DAVID: You see. But the thing of it is is that my only hope would be for that is that, is that 3 those, those cameras actually were zooming in enough on that front door. 5 6 HENRY: Um-hum. 7 To show just exactly. Of course, DAVID: what I heard one guy comment was is that, you know, 8 9 somebody saw somebody there with a firearm. And so once they saw the firearm that, that's a sign to go 10 11 after it, right? 12 HENRY: Um-hum. 13 Isn't that, isn't that a ATF rule or DAVID: I mean if, if you all walked into a place, and a 14 guy's standing there with a gun, you know, I mean 15 that's, that's what you got to do. You got to draw 16 17 out, right? 18 HENRY: Well --DAVID: 19 So that's probably where our problem 20 came from. 21 HENRY: Um-hum. 22 But you know, I had my head and part DAVID: of my body sticking out that door. I was actually 23 standing in the door there and I, I waved out. And 24 that's probably all on film too. And says, you know, 25

get out of here. There's women and children.

Let's go. 1 talk. Get out. You know so --2 HENRY: Um-hum. 3 DAVID: -- you know I hope they --4 HENRY: Well, one of the things that 5 concerned us was that one of the mothers said to one of 6 the kids I'll see you on the other side. So you know, 7 we were, we just wanted to make sure --8 DAVID: Well, now remember too that, that 9 this was probably stated before we got this previous arrangement going. Like I said before, nobody wants to 10 11 die. 12 Now but here's the thing. We cannot trust 13 you people. Nobody that has really had any experience 14 with the federal government can 100 percent trust the 15 federal government. Because like even with yourself or 16 with Jim, we see that you guys are not the boss. You 17 know, and the thing of it is is that there's just too many voices and too much influence. 18 19 You know, I've -- let me back up and say one 20 I've been very pleased thus far at how, you know, Jim and yourself have, you know, guaranteed that 21 22 they haven't come in and punched us out yet. 23 HENRY: Um-hum. 24 You see. I'm -- I respect that very 25 I, I appreciate that. You know, I thank God for that that, you know, under the circumstances that you

have borne with me. 1 2 HENRY: Um-hum. 3 DAVID: You know. So this gives the 4 confidence, you know. Because this is a great nation, 5 America, and it should be, you know, more considerate 6 and more intelligent in regards to these things. 7 HENRY: Um-hum. 8 DAVID: Okay. So now this gives me more 9 liberty to entrust myself in the hands of this system, 10 you know, for you guys to be able to help drive this situation out of the mud. You know, this is like a 11 four-wheeling truck. And we're all in it and we're 12 stuck. You know, and we all have to drive this thing 13 14 out. 15

It's called 8 "Breaking the Law in the Name of the Law." 9 HENRY: Um-hum. 10 DAVID: I'm sure you've seen that. course, like I say, you know, it's, it's not meant to 11 ultimately degradate you. But it's, it just simply 12 13 shows that people are human, okay? 14 HENRY: Um-hum. 15 On both sides. So anyway. I guess DAVID: I've said enough. And no. You, you tell the children 16 17 that, you know, we've been letting them out little by little to see what you all's reaction was going to be. 18 Because they've been saying on the radio all the time 19 20 that you all are fixing to hit us tonight. You know. 21 HENRY: Well, no, we --22 And Jim's been telling me that's not DAVID: 23 true. 24 **HENRY:** We've never had that plan. You know, 25 we --DAVID: So I've, I've been balancing it out

1 on both sides. 2 HENRY: Okay. 3 Because like I say I have to stand in DAVID: a position to where if you do hit us tonight --4 5 - HENRY: No. 6 DAVID: -- you're going to, you're going to be guilty of killing little children. 7 8 HENRY: Exactly. DAVID: And the thing of it is is that that's 9 10 why in the beginning I made it very plain -- I stood in the door there, you know. And that's not very fun with 11 a bunch of professionals, you know, coming at you. And 12 I tried to tell them, holler best I can let's talk 13 about this. I tried to talk to Robert Gonzales first, 14 15 you know. 16 HENRY: Um-hum. 17 DAVID: And you know. I saw him on news here. But I think it's very cheesy in his behalf, 18 very, very cowardish (sic) to be staying out of the 19 light now. Because he could have -- and you tell him 20 this. He could have stopped all of this. 21 22 HENRY: Um-hum. 23 You know, his conscience is probably DAVID: 24 eating him up. 25 HENRY: Um-hum. DAVID:

So anyway.

1 HENRY: Okay. 2 Okay. I'm sorry. So --DAVID: 3 HENRY: That's okay. I just want -- yeah, I just want to feel real good about this. And I want to 4 feel good that everybody is going to be coming out 5 alive. 6 7 DAVID: Well, that's what we want. 8 HENRY: Okay. Including you. 9 DAVID: Oh, I'm, I'm still here. 10 HENRY: Okay. Nobody's going to commit 11 suicide. 12 DAVID: No. I don't think anyone's going to 13 commit suicide. 14 HENRY: Nobody's going to be coming out with guns so that somebody can shoot at them. 15 16 DAVID: Nobody's going to be coming out playing John Wayne. 17 18 HENRY: Okay. Well --DAVID: I mean have -- I mean are we letting 19 our children out? I mean, you know, are the children 20 gone -- do the children look like they've been abused 21 22 or neglected? 23 HENRY: No. No. 24 DAVID: Okay. So do they act abnormal except the one child because it was born that way. It was --25 HENRY: Um-hum.

1 DAVID: -- a medical misinterpretation. 2 know, the doctor didn't quite diagnose something right --3 4 HENRY: Um-hum. Um-hum. -- and it affected the child. 5 DAVID: 6 are you happy with the children so far? 7 HENRY: Yes. Yes. 8 DAVID: Do they look like they're raised 9 strange, abnormal? 10 HENRY: No. No. They look just fine. just, you know, because of your concern and because 11 12 everybody's concerned that and, and primarily your concern that you not be considered just another cult 13 leader. You know, and because of the sincerity that 14 you've expressed during our negotiations, you know, I 15 believe in, in the things that you've said. I believe 16 that when you've given me your word, you know, you've, 17 you've stuck to your word. And I want to feel good 18 about, about this situation. And I'm holding you to 19 your word. 20 21 DAVID: Well, just like Jim said that. And, and like I say in our past experience together we've 22 23 seen it's been more shadowy on your side than it's been 24 on mine. 25 **HENRY:** I understand. I mean I've kept -- just like the DAVID:

other night Jim told me not to deal with anybody else 2 but him. And we made an --3 HENRY: Um-hum. 4 DAVID: -- an agreement. And then, you know, 5 another guy came along. And, and then all of a sudden 6 da, da, da, da. You know, he -- we, we -- he was very forceful and very strong. And when someone's going to play forceful and strong to me, then I'm going 8 to play forceful and strong back. 9 10 HENRY: That makes sense. 11 DAVID: You see, but if someone's going to sit down and say look, I'm willing to give you, you 12 know, 50 percent of the chips, and I'll take 50 percent 13 of the chips, and we'll play this card game fair. 14 15 HENRY: Um-hum. 16 DAVID: Then you know, when the chips are all on your side then I'll, I'll fold up. You know, it's a 17 18 fair game. 19 HENRY: Okay. DAVID: And that's, that's the way, that's 20 the way I've always been. It's the way I've always 21 taught the doctrine that was given to me. 22 23 HENRY: Okay. 24 And this is the way the truth has to DAVID: 25 be.

HENRY:

Okay. One of the things that I, you

know, that I had a concern about, and you don't have to 2 give me the specifics on this. But you know, when 3 we've talked about the number of children that are within the compound, we've never had a real good idea. And you don't need to tell me that. But I feel --5 6 DAVID: Well, ask the children that are 7 there, you know. Of course, like I say they don't probably know either. But just ask them if there's a 8 lot more children. That's all you have to do. 9 10 HENRY: Yes. But that -- I'm -- that's, 11 that's not the point here. And, and the point is I just want you to feel comfortable, you know. 12 of if I ask you something I'm, you know, I'm asking you 13 man to man. And if you say this or that or the other, 14 that's fine. Or if you say look, I don't want to tell 15 you for this reason that's fine. RADIO (CHARLIE): We've got a minute and 15 seconds by the, our studio clock here. And we'll go by that. So if you can stand by, we'll give you a countdown as we get closer to it. Again, Rick, I want to thank you. I know it's been an incredibly stressful time for you there. And not knowing what was around the corner and having to face up to it in an incredibly professional manner. And I thank you for all your service. And, and you can have a couple of days off when we get out of this so you can catch up on your sleep. Because I plan to do the same. Can we ask one more question?

RADIO (RICK): Sure.

RADIO (CHARLIE): With the agreement that they will peacefully leave the compound, is it your understanding, Rick, that will be after the broadcast or during the broadcast when it begins?

RADIO (RICK): I don't know, Bob. That's between the FBI negotiators and David Koresh. From the listening to the first few seconds of it I get the impression that once the broadcast starts, the peaceful surrender will begin. But that's just based on the words I heard.

1 RADIO (CHARLIE): Okay. 2 RADIO (RICK): Time will tell. It will, we'll have to depend on our reporters, and we'll have 3 to qualify that so that people don't have expectations. That's an assumption on our part. We really don't know. Having not been a party to the negotiations, we cannot give you any certainty to the, the contents of 8 the tape. We need to do a legal ID here, Bob. This is KRLD, Dallas-Fort Worth. It is 1:30. 10 RADIO: The tape you're about to hear was 11 given to KRLD news 42 minutes ago by two FBI agents who came from the command post at the PSPI, the old 12 Connolly (phonetic sp.) Air Force Base (indiscernible). 13 (Radio continues playing, intermittently discernible.) 14 15 RACHEL: Is someone confirming to them that it's after the tape or --16 17 JIM: The, the --RACHEL: Because they think that it's, it's 18 19 going to begin after they start the tape not at the end 20 of the tape. JIM: Well, no, it's after the end. 21 22 worry about that. You and I work that out. 23 RACHEL: Okav. 24 JIM: Yeah. 25 RADIO: -- by the request of the FBI and David Koresh at 1:30.

1 (Following is the tape being played over the radio.) 2 I. David Koresh, agree upon the 3 TAPE: 4 broadcasting of this tape to come out peacefully with 5 all the people immediately. 6 RADIO: Now we will have a few seconds before 7 the beginning of the 58 minute --8 TAPE: March 2nd, 1993. My name is Dave 9 I'm speaking to you from Mt. Carmel Center. 10 The first thing that I would like to 11 introduce in our subject is the reasons for the revelation of Jesus Christ. In the Book of 12 13 Revelations, commentary states that what John has written in scripture is nothing other than the revelation of Jesus Christ which God gave to him to 15 show to his servants things which much shortly come to 16 pass. And he signified it, signified it by his angel 17 into service John. Now --18 JIM: Rachel? 19 TAPE: John (indiscernible) --20 21 Hello? Rachel? JIM: 22 -- the record of God and the word of TAPE: 23 Christ and of all things that he saw. 1 (Start Tape 15) 2 (Following is the tape being played over the 3 radio.) 4 TAPE: If we take a look at the record of 5 John, the Gospel writer John, take chapter 7. We see . 6 in scripture John writes that after certain events, 7 after these things, Jesus walked in Galilee. He would not walk openly, he would not walk in jewry. Would not 8 walk amongst the Jews, because the Jews sought to kill 9 10 him. We might wonder why. Wasn't Christ such a good 11 man? 12 Now the Jews' feast of tabernacles was at 13 hand. 14 His brethren therefore said unto him, Depart hence, and go into Judaea, that they disciples also may 15 16 see the works that thou doest. 17 For there is no man that doeth any thing in secret, and he himself seeketh to be known openly. 18 19 though do these things, shew thyself to the world. For neither did his brethren believe in him. 20 Strange statement, isn't it? It's funny how that when 21 men live and have to deal with realities of life that 22 even a man like Christ could have to meet with unbelief 23

Then Jesus said unto them, My time is not yet come: but your time is always ready. And I'm sure

even from his own brethren.

most fellow Bible students will agree the time referred 2 to is the time of his crucifixion. They wanted to kill 3 him, and he didn't want to show himself openly. 4 Then Jesus said to unto them -- excuse me. 5 Verse 7. The world cannot hate you; but me it hateth, 6 because I testify of it, that the works thereof are evil. 7 8 Go ye up unto this feast: I go not up yet 9 unto this feast; for my time is not yet full come. When he had said these words unto them, he 10 abode still in Galilee. 11 12 But when his brethren were gone up, then went he also up unto the feast, not openly, but as it were 13 in secret. 14 15 You would wonder why a man like Christ would 16 have something to hide. I mean surely the angels would 17 protect him obviously. I personally think a lot of things about this strange character and disposition of 18 character. But we're sure in being Christian that 19 Christ knew what he was doing. (Unidentified voices in 20 21 background not discernible.) Then the Jews sought him at the feast, and 22 said, Where is he? 23 24 RACHEL: Well, can you let them find out if they see the stretcher, if they took the stretcher out? 25 TAPE: And there was much murmuring among the

people concerning him: for some said, He is a good man: others said, Nay,; but he deceiveth the people. 2 3 RACHEL: The truck is here. But we're waiting to see if they let out the stretcher. Are you 4 there? \_\_ 5 6 JIM: Yeah. 7 RACHEL: Okay. 8 TAPE: Howbeit no man spake openly of him for 9 fear of the Jews. 10 JIM: What did you say about the stretcher? TAPE: Now we understand the Jews at that 11 time had their own religious (unidentified male voice 12 in background not discernible) --13 14 JIM: Oh. 15 TAPE: -- political network, didn't they? 16 Okay. Well, we're sending it. JIM: TAPE: And a pretty strongly religious 17 spectrum although they had no actual political power. 18 They were subject to the relevant government and thus 19 to the really traditional rabbinical laws. 20 21 Now about the midst of the feast, Jesus went up into the temple, and taught. 22 And Jews marvelled, saying, How knoweth this 23 24 man letters, having never learned? 25 Now in the days of Israel, most scholars and teachers will agree that the schools of Israel ordained

by the Sanhedrin and also the Pharisees were schools similar to the ones of our own theological schools of today of which a careful student of scripture observes that no where is it written in the gospel that Christ ever attended these schools. But at the age of 12 he did enter into the temple and had a most unique and interesting discussion with the religious leaders of which they were quite amazed at such a young lad's knowledge of scripture.

Now this man was teaching something no doubt, Christ that is, that inspired the people to say, you know, how knoweth this man, you know, letters having never learned. They marvelled.

commit my spirit. Taken from Psalms 31, we begin to see that Christ is well versed at the scripture just like the gospels tell him when (indiscernible.) Always referring I guess to temptation by stating it is written. It is written.

Now what is this spirit of Christ? Well, they pierced his side. Out of his side came blood and water. I get another mystery. This became something to do with eating his body and drinking his blood. Some implements for the church. But what do these things really mean?

Well, after we've read Acts and learned of the power of pentecost, the cloven tongues of fire that came upon the apostles who by mercy through Christ were given another chance to recover from their falling. We learn through Romans that there is a righteousness of God in Christ declare his righteousness. We learn in Corinthians I and II, we learn in Ephesians, Galatians, Philippians. Oh, we have such a wealth of information of such intelligent men who speak sometimes very deep, mystical things about a God who is in the form of humanity who is the Son of God who sits at the right hand of God in the highest court of the universe.

RACHEL: Keep the kids quiet.

TAPE: Who promises that one day he'll come again. Well, the last living apostle (indiscernible)

this great controversy. And I might add those who persecuted Christ who would not hear him no matter what sign was given also persecuted his disciples.

And finally, we end up in the Book of Revelation where John, the last living disciple on the Isle of Patmos being a prisoner for the word of God and for the testimony of Jesus Christ which no doubt are the things Jesus has to say which would probably be quite controversial to the things that the Pharisees and Sanhedrin of the day had to say we're sure. He being on this Isle of Patmos a prisoner on the Lord's day had a vision. And it states in this vision, we should all be familiar with it hopefully or get familiar with it, he has a messenger, the angel of the Lord come to him who identifies himself as the spirit.

And he is told to write the seven churches of Asia of which we can see clearly in the scriptures that they were given specific and direct messages from Christ. And in each one of these messages Christ specifically told the churches what he would have them to do. Now we know that Christ is the only man in scripture who ever kept the law of God perfectly. We know that, because we've heard the writings of the apostles. But sad to say the religious leaders of his days and the majority of the populace of his days didn't think so.

1 It's funny how that is. It's kind of like people always like to build the sepulchers of the dead 2 prophets and garnish their tombs. But yet they hate 3 and kill the living prophets. Only God knows why that 5 is. 6 But nonetheless, the church of Ephesus, Smyrna, Thyatira, Sardis, Philadelphia, Laodicea, the 7 churches that's involved for anyone to read direct 8 counsel is given beginning with it's the age of the 9 church of Ephesus, right. These things (indiscernible) 10 what happens if the best is given. And then the 11 decision is up to those (indiscernible) Christ. Each 12 council (indiscernible) even has ear to hear so if you 13 want to know. But in here with the spirit 14 (indiscernible) the church. 15 Finally, we get to the 40th chapter of 16 17 Revelation. RACHEL: They picked up the stretcher. 18 they're on their way back. 19 20 TAPE: And as soon as scripture becomes (indiscernible). (Tape continues playing.) 21 22 JIM: They picked it up you said? 23 RACHEL: Yeah. 24 JIM: And they're on -- ' RACHEL: Now they're on their way back. 25 JIM: Okay. Okay, good. Can you see them?

--

RACHEL: Yeah.

TAPE: -- which was referring to the last part of third chapter of the message of Laodicea. He says after these things I saw and behold, a door was opened in heaven: and the first voice that spake to me as it were of a trumpet talking with me; which said, Come up hither, and I will show you that which must be hereafter.

Now the question to every true Christian is this. Is John telling us the truth, or is John lying to us? We know he just gave counsel to the seven churches of Asia which were alive and hopefully in good health when he first gave these letters to them. But nonetheless, they being of Asia are know-wise the same people of us today or even of the oncoming years thereafter.

So the events of chapter 4 clearly explained by John that his messenger as sent to him stated that he be taken up hither. Therefore a door opened in heaven the Bible records. And he was to be shown things which must be hereafter sometime after John's day. Now what did he behold in chapter 4 of revelations? He says that he was in the spirit. He immediately was in the spirit. And behold, a throne was set in heaven. And he states that the throne was occupied. Someone sat on the throne. And he that sat

upon the throne was like a jasper, a sardine stone.

I (indiscernible) say the scripture knows all the way through prophecy, all the way through the Bible, as far as back as the days of Genesis even to the prophecy of Deuteronomy 32 where it says God is a rock. He is our rock. And his work is done in truth and in righteousness. All the prophets refer to God as a rock.

Now here we see in Revelation John likewise written it says God has the appearance of a jasper and a sardine stone. (Indiscernible) there was a rainbow round about the throne, in sight like an emerald. He carefully saw that there were living creatures around the throne saying that God is holy, holy, holy which was, is and is to come. God intended all things for which the pleasure they were and are created.

Now this instruction emphasizes that there is a God, a kingdom, a judiciary in the respect that John witnesses that there were 24 elders sitting on 24 thrones seems to imply a judgment. But uniquely enough, in this judgment or in this throne or in this heavenly sanctuary as we see from the rise and fall of the apostles.

Paul only talks about the heavenly sanctuary, the heavenly sign. In this sanctuary, we see a God, a rainbow, a throne, living creatures stating that God is

holy which was, is and come, the past, present and 1 future. And that this God, this creator of all things, is holy and deserves to be worshipped.

We continue on in chapter 5 to see that I beheld, John says, the right (indiscernible) that sat on the throne a book or a scroll sealed with seven seals. Notice it's written on the inside and the backside. Well, the meaning of these things kind of will be speculated until we have solid proof. words, unless we were there ourselves to see it in detail.

But what we are allowed to see in the scripture is John also beholds a might angel in this throne room where all these angels, thousands, ten thousand and thousands are called together. And this mighty angel questions all in heaven. Who is worthy to open this book, and to loose the seven seals thereof. Clearly scripture states no man in heaven, neither on earth, neither under the earth. Of course, buried. In other words, we do have dead in this world, you know? Was worthy to open neither to look thereon. So hey, God says in scripture at least John testifies in scripture that the mystery of God, his book is sealed.

Well, what happens is as we continue on we see in Chapter 5 that John begins to weep until one of
