Now, like I said, who has the key of David? the book of Revelation to the Church of Philadelphia, you know, these things they get holy. He had had the key of David. He had opened that no one can shut. And when I shut, no one can open. Now, that's Christ talking and that's why in the latter days in Psalms 18 when the key begins to open all the Psalms you can hear Christ talk, not just out of his mouth in the flesh, but out of a book declaring the end from the beginning and from ancient times things not yet done saying, "My council which shall stand and I'll perform all my

pleasure, calling a ravenous person the east, the -- in 2 far country." You know, prophecy, what is this stuff, 3 the testimony of Jesus Christ? What is this spirit that forewarns us of soon coming events? The testimony of Jesus Christ is the spirit, a prophecy. Well, 6 didn't Christ say, "Let there be light," and wasn't there light in creation? Didn't Christ say, "Let us make men in our image after our likeness?" The world was made flesh and whatever the word said came to pass, 10 didn't it? 11 HENRY: Um-hum. 12 DAVID KORESH: Now, here we say in Psalms 18, "I will love thee, O Lord, my strength." 13 "The Lord is my rock and my fortress. Hebrew or in the ancient concept when man referred to a 17 horn, referred to his father's ability to procreate, 18 the strength of a man's loins. You know he sits on a 14 15 throne in Heaven, right? 16 HENRY: Um-hum. 17 DAVID KORESH: "My cry came unto him, before 18 him, even into his ears," and with the sixth seal now and suddenly the stars are darkened and the earth 19 shakes and the mountains shake, right? 20 21 HENRY: Um-hum. DAVID KORESH: This is the sixth seal now. 22 *Then the earth shook and trembled; the foundations 23 also of the hills moved and were shaken, because he was 24 25 wroth."

"There went up a smoke out of his nostrils,

and fire out of his mouth devoured: coals were kindled 2 by it." "He bowed the heavens also, and came down: 3 and darkness was under his feet." 4 He rode upon a cherub. See, where I come 5 from there's two kinds of angels, the -- a set of them 6 7 are masculine angles and a set of them are feminine angels. The masculine angels like Ezekiel talks about 8 9 on the judgment throne, they -- they're like soldiers. He did fly. 10 "He did fly upon the wings of the wind. 11 12 made darkness his secret place and his pavilion round about him were dark waters and thick clouds of the 13 It's like lightning, stones and voices. 14 skies." That's where the throne is, you see? 15 HENRY: Um-hum. 16 17 DAVID KORESH: "At the brightness that was before him his thick clouds passed, hail stones and 18 coals of fire." 19 "The Lord also thundered in the heavens, and 20 21 the highest gave his voice; hail stones and coals of 22 fire." So when God speaks to you all in his wrath, you won't understand an audible voice like I'm talking. 23 24 You'll understand the elements of nature fighting against you like you've never seen. 25

"Yea, he sent out his arrows, and scattered

them, " and his arrows aren't really arrows like wooden 2 with a rock tip either. 3 HENRY: Um-hum. 4 DAVID KORESH: "He shot out lightnings, and discomfited them." 5 6 "Then the channels of the water were seen, 7 the foundations of the world were discovered at thy rebuke, O Lord, " same as Isaiah 24. It's -- this stuff 9 is geographically incredible how these things happen. 10 See, Waco has a, has a fault running through it --11 HENRY: Um-hum. DAVID KORESH: -- especially through the old 12 13 place where God originally established His name on the 14 first Davidian movement. Now, Brother Houteff was 15 raised up to begin to, to prepare the way for this truth to be know but, like I say, there's other things 16 involved, too, but anyway, it says here -- anyway, it 17 says they were discovered, "O Lord, at the blast of the 1.8 19 breath of thy nostrils." 20 "He sent from above, he took me, he drew me 21 out of many waters," which is the floods of ungodly 22 men." "He delivered me from my strong enemy, and 23 from them which hated me: for they were too strong for 24

calamity," and this is a calamity like Psalms 89 says, 2 right? HENRY: Um-hum. 3 DAVID KORESH: "But the Lord was my stay." 4 5 "He brought me forth also into a large 6 That's where, you know, the sanctuary is in Heaven, the sea of glass? HENRY: Um-hum. 8 9 DAVID KORESH: Very big place. "He delivered me because he delighted in me." 10 11 "The Lord rewarded me according to my 12 righteousness; according to the cleanness of my hands hath he recompensed me." 13 HENRY: Um-hum. 14 15 DAVID KORESH: I have never taught, ever taught, false doctrine. 16 "For I have kept the ways of the Lord, and 17 have not wickedly departed from my God." And in these 18 seven seals there's some strange things, and without 19 the knowledge of it -- well, like it says in verse 22, 20 21 "For all his judgments were before me, and I did not put away his statutes from me." Now this is different 22 23 than what happened 2,000 years ago. Just as in Psalms 89 or in Psalms 2 or Psalms 40 when he gave me a new 24 25 Psalm, whatever the seals contain is what I am responsible for doing this time, and I always obey my

Father. "I was also upright before him, and I kept myself from mine iniquity," and if I don't do what my 3 Father asks -- asked me to be a sinner as in Psalms 40 4 or Psalms 51 or Psalms 139 and that would be iniquity. 5 6 It says in Psalms 119, the Psalm called the word, it 7 says I've seen end of all perfection, but the commandment is extremely broad. 8 "Therefore hath the Lord recompensed me 9 10 according to my righteousness, according to the 11 cleanness of my hands in his eyesight." Now -- so I'm 12 a sinner, but do you know some people have not used 13 that against me. Just because I might have a little beer every once in awhile which some would consider a 14 sin --15 16 HENRY: Um-hum. 17 DAVID KORESH: -- although Mosaic law says that -- their liquors and strong drinks. 18 HENRY: Um-hum. 19 20 DAVID KORESH: Anyway, that -- we won't get into that too much, but here's the, here's the thing. 21 I need, I need to world's mercy now. Why? Because in 22 23 the judgment that I come from where God wants to do --

this is the deal my Father wants to do for this nation.

This nation has failed the -- of its iniquity and this is what my Father wants to do. If everyone would come

HENRY: Okay.

DAVID KORESH: "The Lord, my God, will lighten my darkness."

In Psalms 75, which says all the horns of the wicked shall be cut 9 off, you know what that is. Henry? 10 HENRY: Tell me. 11 DAVID KORESH: That's their ability to 12 procreate. 13 HENRY: Okay. 14 DAVID KORESH: David of old, you know. 15 There's something about the wicked of the world. know, God gave male and female as a blessing from his 16 17 people, to progenerate his seed. And there's a big 18 controversy now. There's people that are telling me that I don't have a right to be able to procreate my 19 20 image. 21 HENRY: Well --22 DAVID KORESH: But there's a lot of people 23 that tell me that I do. Remember, I go by my God's 24 law. 25 HENRY Um-hum. DAVID KORESH: I don't go by the laws of the

| land when they conflict my Father's laws but, anyway.

"For thou hast girded me with strength unto the battle; thou hast subdued under me those that rose up against me." That's why that tape was played, so people might have a small scratch and might wonder and fear.

HENRY: Well, the --11 12 DAVID KORESH: "As soon as they hear of me, 13 they shall obey me." 14 HENRY: -- the thing is they probably will, but we have to follow through. You made a promise and 15 16 everybody is waiting to see if you're going to follow 17 through. Do you know of anything that could be a 18 human transport system that has a flaming torch on it? 19 Have you ever heard of a tank? 20 HENRY: Okay. 21 DAVID KORESH: Okay. Now look, there's a lot 22 of things that you people don't understand, that you're 23 fulfilling the very word of God right as I speak and it 24 may seem odd and it may seem strange how that -- you 25 know, we're here at this time and yet, you know, by nature you don't believe because you don't know what to

believe. But the thing of it is if you could have known the word of God and what is taking place in this 3 time, if you could have believed that Russia -- and, you know, Russia wouldn't lie. They stated, and this 5 should be something they should have brought back into investigation, that in 1985 they saw seven angels 7 flying towards earth with the wings of the size of 8 jumbo jet. Lord is slow to anger and great in power and will not 6 at all acquit the wicked. No acquittals for the 7 8 wicked. 9 HENRY: Um-hum. 10 DAVID KORESH: "The Lord hath his way in the 11 whirlwind and in the storm and the clouds are the dust 12 of his feet." We just read that in Psalms 18, didn't 13 we? 14 **HENRY:** Right. 15 DAVID KORESH: "He rebuketh the sea and maketh it dry. He drieth up the rivers; Bashan, Carmel 16 17 languisheth the flower of Lebanon languisheth." "The mountains quake at him, and the hills 18 shall melt. The earth is burned at his presence in a 19 the world, and all that dwell therein." 20 "Now, who can stand before his indignation 21 22 Who can abide in the fierceness of his anger? For his 23 fury is poured out like fire and the rocks shall be thrown down by him." 24

I can back mine. 24 HENRY: If you can, then come out now. 25 DAVID KORESH: My words are backed by God. HENRY: Your word was --

1 DAVID KORESH: Your words are backed by man. 2 HENRY: Your word was, you word was --3 DAVID KORESH: Whose words do you think shall 4 win? 5 _ HENRY: Your word was you will come out 6 immediately. 7 DAVID KORESH: That's right. 8 HENRY: Whether you realize it or not, you're 9 losing face. 10 DAVID KORESH: I also said, I also said --11 look. 12 HENRY: We want you to come out so that everything that you said, whether it was immediately or 13 not, is still looked upon as being the truth. 14 15 DAVID KORESH: Yes. 2,000 years, I come quickly, so I will come out immediately.
