God really has 15 given light to those that have, on their own, by their 16 own pride and arrogancy, through a lot of hard work, gained their degrees and so forth. 17 18 JOHN: Yeah. 19 STEVE: You look throughout the Bible, 20 prophets usually were sheep herders, fig pickers, which 21 now we call migrant workers. There were people that 22 were --23 Hadn't heard fig pickers before. JOHN: 24 Yeah. Amos was a fig picker. STEVE: 25 fact --JOHN: You don't want to say that 10 times

real fast, do you? No. In fact, I have heard people say STEVE: 2 pig ficker, you know, get it turned around there. It's 3 I had to laugh, too. I did this week quite humorous. in a lecture. 5 JOHN: You, you mentioned when you first met 6 7 David --STEVE: Yeah. 8 -- it was out in California, though, 9 JOHN: huh? 10 11 STEVE: This is correct. It was actually in -- I was picked up by one of the people out there in 12 Los Angeles, at the airport, taken to one of their 13 homes. And extremely apprehensive, of course, looking 14 around, not knowing what this was all about. And I met 15 him in a home and, I mean, I was shocked. He came over 16 I sat in a chair and he sat down on the floor, 17 looking at me, and he started talking to me about the 18 scripture. And, well, I was half listening because, 19 you know, the first time you meet someone you're 20 usually looking them over and observing and --21 22 JOHN: Well, you said you thought he was a . 23 little strange, huh? 24 STEVE: Well --The first time you met him. 25 JOHN: STEVE: Well, not really strange.

JOHN: Well, the beliefs, the theory, the principles.

STEVE: Well, no, it was actually the, the information was extremely logical. And what was more astounding was how clear it was coming directly from the book that I had read so many times and never understood, other than, you know, once in a while you might come up with a theory or, speculatively speaking, it could be this, maybe that.

JOHN: Yeah.

STEVE: But he was talking with such authority because he was bringing in so many chapters in context without interpretation, just reading them but showing how they connect. Well, definitely, a very clear picture was developing between all the prophets and what they saw. So, see, that's what really caught my attention, even though he was dressed not anything like a, a minister or in a three-piece suit or anything else. In fact, on the contrary, the way he was dressing in those days was always a stumbling block. You wondered well, this guy doesn't seem to be a professional by looks. I mean, you would not expect him to be really anything by the way he was dressing, but it was when he opened his mouth. Where on earth someone as young as himself, where did he get the information? I mean, he did not have enough time in

life at that time to develop and to gain or give that kind of information. There was just no way, especially when once I saw him get on a pulpit and give a group of 100 people a lecture on the Bible.

His hands were greasy from working on a car. He went for five hours, quoting chapter after chapter after chapter, not missing a word. And the astounding thing was not that a person could ever memorize all that, the astounding thing was the clarity and the picture that was drawn from it, the logical progression.

JOHN: Yeah.

STEVE: And this is what, you know, caught a lot of people's attention. So they started -- he's always said ask questions, any questions, any questions. So people asked the questions. The answer is given by having them turn to the pages of their own book. Then they're told to go wrestle with the issues. Like if somebody comes to us, like, for instance, of course, Robert had been coming here, we've had other guests through the years that come here, we'll give them some pretty strong studies and then send them out, tell them to take some time away from us.

Go to the scholars, go to the ministers, go to the lay people, ask them these questions, let them raise questions with yourself. Honestly, this is what

| we've done over and over again.

JOHN: Do you encourage them to talk to basically nondenominational scholars --

STEVE: Oh, yes, either or.

JOHN: -- or any particular ones?

STEVE: Anybody. You know, go, go to atheistic scholars that -- maybe someone that's into anthropology of religion or someone that's really studied and looked at it from many different angles. Go to the rabbis, go to the ministers of different denominations.

JOHN: You weren't just, just talking about any selected verses with selected analyses, though, you were going over an entire --

STEVE: Yeah. We -- well, he opens up -- for instance, you know, you have a prophet like Joel who wrote three chapters in the Old Testament.

JOHN: Uh-huh.

STEVE: Doesn't take long to get through, it's just that the question that puzzles any scholar, any layperson is how does it connect to the other writers of that book, which Christians always tell you that that book is a very consistent book, even though in reality one can show many contradictions. Yeah, and one soul is worth more than any of this, that is to say, the, the 12 13 cycle or the Corvette --You can say that again. 14 JOHN: 15 STEVE: And to show that he doesn't have a 16 love for those things, he doesn't even drive them. Never operated the things. The Corvette --17 18 JOHN: Really? 19 STEVE: Yeah. The Corvette just sits there 20 and --He said he likes his Camaro. 21 JOHN: Yeah. Yeah. But it's something he's worked 22 STEVE: He's, you know, he's mechanically inclined. 23 on. 24 JOHN: Sure. Sure. 25 STEVE: So he put it together himself, worked hard to put it together --

1 JOHN: Yeah. STEVE: -- and, and make it right and -- but 2 on the whole, I mean, you know, he's never been into 3 any of those things. The guy's not into material 5 things. JOHN: Sure. 6 7 STEVE: He has -- he's got -- he has opened 8 up things to us that are so awesome when it comes to 9 astronomy, about the worlds yet that exist, the 10 movement of those worlds, the beings that live and 11 appreciate and habit those spheres. 12 JOHN: Well, you got to give him a lot of credit, huh? 13 14 STEVE: Well --15 For taking that stand, taking that position? It's, it's a very, you know, unselfish 16 17 posture. 18 STEVE: But anyway, you know, I figured that one day it would -- not that it would come like this, 19 20 down to an agency or something like this happening by 21 an agency of the government, but I knew Mark would be 22 relentless when he --.23 JOHN: Hey, what's done is done, huh? 24 STEVE: But --25 JOHN: You can't turn it around. STEVE: No, it's, it's past that stage.

JOHN: But you're just going -- people are 1 going to have to communicate, though. 2 3 STEVE: Well, that's what we're doing. JOHN: And, and just try to, to ease the pain 4 and suffering on both sides, because there was a lot of 5 pain and suffering on both sides. 7 STEVE: Even though you've been a Catholic, 8 and I know that maj -- the majority of all Catholics 9 have little background in the Bible or familiarity with it --10 That's very true. That's very true. 11 JOHN: 12 STEVE: Well, I know that, you know, just 13 because of my mother being a Catholic, because I've 14 studied comparative religion, Catholicism --15 JOHN: Those nuns would just bang your knuckles and drive it home. 16 17 STEVE: Oh, but, yeah, of course. They are 18 very, you know, they've got good morals and so forth, 19 you know. I mean, at least they teach that. There are many good nuns --20 21 JOHN: Yeah. 22 STEVE: -- many good priests --23 JOHN: Just don't get the numbers --24 STEVE: But see the thing that if you had a 25 greater understanding of the Bible, and I, I would not want to do that to you, because, you know, I, like he,

have respect --

JOHN: Sure.

STEVE: -- for freedom -- person's choice is to listen to spiritual or religious things, but the Bible in many numerous chaper -- chapters talk about a man that comes in the final days not able to work miracles, but the only miracle is he opens up the word of God.

JOHN: Um-hum.

STEVE: And it can't be controverted. I could right now rattle off numerous chapters. You could write them down, take them to --

JOHN: Listen, you'll buzz right on by me, wouldn't you.

STEVE: Well, no, no. What would happen is, you could write those down, take them to a scholar or call up a scholar and say, well, who is this person that the prophets speak about in the final days. Is this to be Christ of 2000 years ago, or is it his return, is it someone else? Because this person that the prophets speak about, they speak about him having fins. They speak about him being called a ravenous bird. Well, 2000 years ago the Christ of that period of time was not a ravenous bird.

JOHN: No.

STEVE: In fact, he was moderate in

7. E.:

everything he did. He, in fact, he --

JOHN: Although he was probably considered a rebel of his time by a lot of people.

STEVE: Oh, he was exemplary when it came to a life of perfection.

JOHN: That's right.

STEVE: In fact, he was to hold up a standard of the law that was unequaled by any being that's ever been on this planet.

JOHN: Uh-huh.

STEVE: But what all the prophets talk about is a man that comes in the final days with more sins than the hairs of his head, like in Psalms 40 and in Isaiah 57 it speaks about the man. I mean there's countless, countless chapters, countless chapters. The question is who is this person? Who is it? And that's where it comes -- where the involvement of the seven seals are.

There's where the challenge is. The one that opens up these seals, which is basically all the scripture in its tenor, in its harmonization. But I, I can tell, you know, I don't want to keep you on the phone talking to you about that. But see that's the challenge though, John, and it may be something that, you know, you may not have an interest now. I mean, who knows down the road not far from now, I don't

believe that time is going to go on a lot -- very much 2 longer. There is absolutely no 3 way --5 STEVE: Yeah. 2 JOHN: -- nobody was going to try and offend 6 7 anyone that way. 8 STEVE: And if you want -- hey, if -- John, if you ever want to know why it's that way, we believe 9 that way, just read sometime Isaiah 66, verses 15 10 through 17. It says how God will come with flaming 11 12 chariots to destroy people, because they've eaten 13 swine's flesh and the abomination and the mouse. Now what does that mean? Well, God made a list of animals 14 he did not want man to eat --15 16 JOHN: Yeah. 17 STEVE: -- because they're living sewers. pig will eat its own feces. It'll eat -- it eats dead, 18 decaying things. Now, if a human being thrives on the 19 flesh of that animal, you're going to -- your longevity 20 21 will be shortened seriously. There are certain 22 meats --23 What did it say about shellfish. STEVE: Well, it -- I'll be honest with you, 24 25 shellfish are not allowed either in the Bible. JOHN: No, and, and I realize it.

But fish with scales, trout, mahi 1 2 mahi, tuna, all of those are okay. If they have fins and if they have scales, they are allowed to be eaten, 3 but you and I wouldn't think about sitting down and eating a mouse or a buzzard or a mole, but --5 You'd have to be pretty hungry. 6 JOHN: 7 STEVE: Well, see, those things are in the 8 same category as a pig, though. 9 JOHN: Sure, sure. But, you know, this is what that book 10 says and either -- see, we follow it wholly or not at 11 12 Either it's totally true or it's --JOHN: Well, absolute, right? 13 14 For me, if that book isn't true, 15 well, to me there is no God. I'm going back to Hawaii 16 to live and live my life, as short as it may be, get 17 the most I can, and that'll be it. But I -- see, I'm 18 still leaning on that there is a God. That I'm a 19 complex being and that there's something better. And even though I don't totally agree with it all the time 20 -- I mean, maybe what the -- who this God is, what he 21 22 does, I don't like to see what's happened to humanity at large. 23 24 JOHN: Yeah.

STEVE: Well, I'm hoping that one day God will show a greater wisdom and maybe that this sin,

this world and its problems, it'll never rise up a 1 second time like it says in the Book of Nahum. 2 Well, you hope you, you -- we all hope 3 JOHN: we see these things in our lifetime. Well, we do, we do. But I'm one of 5 STEVE: those people that want to try to do my best to ensure 6 7 that if there's a hereafter, I'm, I'm banking on --8 JOHN: Yeah. I'm putting my cards, I'm putting all 9 STEVE: my money in that corner, because for me this world I 10 see it's short, it can end anytime. It's very 11 uncertain, the world, and, and peoples trying to gain 12 happiness. You get bits and pieces of it, but again 13 it's always eroding. So this is why a wise man is a 14 15 man that tries to grasp and have the priority of the eternal things before him. So, see, that's the way 16 this group is, if that makes sense to you at all. So if you read 9 Acts chapter 3, verse 20 and 21, it says, everything 10 written by the mouth of every holy prophet since the 11 beginning of the world, it says, will come to pass. 12 Otherwise God's a liar and the prophets are -- you 13 can't buy it, they're false. So, see, this is why we 14 take the book wholeheartedly --15 JOHN: Yeah. 16 STEVE: -- and, and in it's totality. 17 JOHN: Well, you know, one of the things is, 18 though, there -- and, and so many different religions 19 interpret things different ways. 20 STEVE: And I'm glad you said that. 21 JOHN: And, and I don't fault any of them 22 unless they were violent, you know, and, and of course 23 in, in my teaching of police officers in some of the 24 courses that I teach them and, and one of the things I 25 talk to them about is Islam. And of course that gets a bad name, right? Because of all the problems in the --

1 STEVE: Well, it didn't start out bad. -- in the Middle East. 2 JOHN: 3 STEVE: Right. JOHN: No. But I'm talking about -- you 4 mention Islam today and all they think about is - E. bombings and they think about --7 STEVE: Well, they're a faction --8 JOHN: -- Beirut and they think about --9 STEVE: Right. JOHN: -- all the negative things, yet 10 11 probably --STEVE: The Shiites --12 13 JOHN: -- 99 percent of all of the people in 14 the world that practice it are very God-fearing good 15 people. 16 STEVE: Exactly. Exactly. You know, and, and it's the ones that 17 18 just have some really bent interpretations of it and, 19 and --STEVE: Well, see, this is where most -- when 20 I deal with ministers of many --21 22 JOHN: Uh-huh. 23 STEVE: -- different -- like I've heard of 24 quite of few of these on the talk shows, how they've - --25 reacted to David's very simple presentation in that 56 minutes. I mean that, that is nothing. That -- when

he -- when I first met him, when he opened up to me in the first two hours six and a half years ago was way beyond that. And right away you get all of this negative reaction by a lot of the scholars. scholars don't know their head from a hole in the ground. They agree with no one but themselves.

This is why in the Book of Isaiah, chapter 41, God calls these men islands. They're, they're on their own. They don't see eye-to-eye with anybody. They're so proud because of all their degrees and what they have found and -- but at the same time, there's -according to the Bible only one truth, one spirit, one body, and so forth. So, when I met David -- I mean, I already understood like in II Peter 1:12 it says, you're to be established in the present truth.

That means in every generation there's a truth that God would have whoever his people are to And further on in that chapter it goes on to say, know this first it says in verse 20, that no, no prophecy of the scripture is of any private interpretation. That's what it says, John. Bible was written by inspired men and women as God willed that they saw certain things in regards to the future. Does that make sense?

STEVE: And it says -- so it goes on without

Who is Michael, the great prince that stands up, and there's going to be a time of trouble like the earth has never seen before since there's been a nation.

And they sit there going ah, well, ah. then I say, let's look a little further over here at

We know what they're going through, being in their shoes. No one ever would have chosen to have such a thing happen to anybody like that.

DICK: Absolutely.

STEVE: Especially such young guys and probably fathers, brothers, or sons. What fathers, I mean, that's the last thing. Never had a choice to do such a thing. So I mean they have to -- if -- words

aren't even enough to --DICK: Sure. 2 STEVE: -- express the condolences and 3 sympathy --DICK: And that's why we have to make sure 5 that it never happens again. 6 STEVE: Well, of course. 7 DICK: And, and we know that you're sincere. 8 STEVE: -- positively. 9 DICK: And, and I hope that -- and I hope you 10 know that we are. It's, it's terribly unfortunate and 11 we've got to go forward from here and ensure that it 12 doesn't happen again. 13 STEVE: But the next time if a question like 14 that is asked I hope, I hope that that's passed on. DICK: Okay. 1 STEVE: Well, of course, it's with the 2 deepest sympathy and regret --3 DICK: Sure. STEVE: -- and we give our sorrow and --5 6 how's David? Well, he's, he's still, you know --7 DICK: I mean, did you guys get a chance to use those sutures? 8 STEVE: I -- in honesty --9 DICK: You don't know? 10 STEVE: -- I've been away most of the evening 11 and when I came back he was -- he had fallen to sleep 12 and I -- when John called, I spoke with John for some 13 14 time. DICK: Okay. 15 16 STEVE: I think it must have been about 17 midnight on. DICK: All right. You don't -- yesterday you 18 19 brought up some procedural matters, when you come out what would be done? Are you clear in your own mind 20 what --21 22 STEVE: No, I'm not. DICK: Okay. Let, let me go through this 23 24 with you. STEVE: All right. 2.5 DICK: And, and I'll bring you up to date a

little bit on that in terms of what happens in a Federal, in a Federal matter. 3 STEVE: Okay. DICK: All right. In this instance, we're going to make, we're going to make some special efforts 5 to ensure that this is handled even -- probably a 7 little differently than it, than it is handled normally 8 to ensure, you know, that you're -- you have the 9 opportunity to speak with people and to make your side known, but also so that you can feel comfortable with 10 the accommodations -- I mean, to -- up to a degree, 11 obviously, in terms of what might be done. 12 13 STEVE: Um-hum. 14 DICK: This is, this is what's done. Once 15 you come out of that, that compound, the buses -- there have been buses that will be arranged and we'll, we'll 16 17 bring you down here to the, to the airport complex. 18 STEVE: All right. A hearing will be scheduled by a 19 magistrate here at the airport. 20 21 STEVE: Um-hum. 22 DICK: At that time, there's an identity -you'll be asked to -- and to determine your identity, 23 24 to, to provide information in terms of identity. A magistrate, then, will de -- will determine the issue 25

of bond or bail. It's not an FBI or ATF responsibility

to do that. It's, it's done by a magistrate, depending on the nature of the charge. And I, I'm telling you with the number of people in there, I, I hope one of the concerns is not that everybody's going to be charged and locked up and have the key thrown away, because it's just absolutely not true.

I know -- it's been my experience, having been a law enforcement officer for a good long time now, that people are concerned and it's difficult for them to confront those issues, because they're, they're scared. Especially if they've never been in that situation before. But in this instance, it's just -it's, it's not something to be fearful of. It's, it's more of a procedural matter.

STEVE: Um-hum.

DICK: And I, I think that the folks inside need to know that. Steve, this, this is not a matter that's going to go away. It's not one of these things with the today, tomorrow, or the next day that the Government's going to fold their tent and leave. So I think you have to, you have to address these kinds of issues --

STEVE: Well, I do realize that. why, you know, I was talking to you about that.

DICK: Well, I, I think -- you need to know --

STEVE: You wanted some ongoing, of course, 1 progression and, and, and things being resolved, so 2 3 we're on this side also trying to, you know, gain the information, helping people decide, make choices, of course, as they do daily. And so, you know, if there's 5 anything else you have or you might want to --6 7 DICK: Well, we just want to make sure, It's been my, it's been my experience that 8 9 people are concerned about what will happen to them and, and they don't know, have not having been --10 11 STEVE: A statement was just made here that you killed an innocent man that did -- well I didn't --12 13 you, of course, I mean generically -- an innocent man that did not know what was going on. I mean I was told 14 it was found in a ravine, his body, and so forth. He's 15 16 been identified, you know. I've, I've told the wife and, of course, she can't even come to the phone to 17 18 speak at the moment, but --DICK: Now, are you, are you speaking to 19 someone else there or are you speaking to me? 20 21 STEVE: Yes. 22 DICK: Okay. 23 STEVE: To you. Actually to you --24 DICK: Okay. STEVE: -- by someone else. DICK: Well, you're talking about Mike

Schroeder then? 2 STEVE: Yes. 3 DICK: Certainly. I'll be happy to talk to that per -- are you talking, are you talking about 4 5 Kathy? 6 STEVE: Right. DICK: Well, I'll be happy to talk to Kathy. 7 8 Put, put her on the --9 STEVE: When she -- no, when she can. DICK: Okay. I thought you meant someone was 10 there asking you and asking you to, to tell me those 11 So Kathy has questions about why it happened 12 things. 13 is what you're saying? 14 STEVE: Well, of course. I mean, that's where it came from. It was passed to me by someone 16 else. 17 DICK: I will be happy to talk directly to 18 Kathy. 19 STEVE: I know. I told her. 20 DICK: Okay. 21 STEVE: -- you know. 22 DICK: Sure. Well, listen. 23 STEVE: Yeah. 24 Steve, you and I both know this is a regrettable incident. The ATF, and one of the 25 questions apparently that David asked last night is why

he was not arrested on the road while he was jogging or why he went to town --3 STEVE: Well, that's it. He did want to know that, because I went with him to town a number of times --5 6 DICK: Sure. 7 STEVE: -- very recently. We went to a 8 number of different places. 9 DICK: Sure. 10 STEVE: He went with a few other people. 11 He's gone other places on his own very close by. 12 DICK: But Dave -- Steve, there's a simple answer for that. We had no -- we, meaning the 13 14 Government, ATF in this instance, had no arrest warrant for David. 15 16 STEVE: Well, what, what happened Sunday 17 though? 18 DICK: That's a search warrant for the 19 premises. Okay? 20 STEVE: But they are -- they have already said on TV and in the news -- I've heard them say also 21 22 -- I believe it came from Jim, that they did have a warrant for his arrest also. 23 24 DICK: That's true, but I mean in addition to 25 the search warrant --STEVE: Okay.

DICK: -- but, but you can't arrest him 1 outside and then expect to execute the search warrant there. What, what do you --3 That doesn't make sense. Of course STEVE: 4 5 you could. DICK: Well, what I'm saying. If you were 6 arrested outside, they would still have to -- had to go 7 to the house to execute the search warrant. STEVE: Really, but it would have been a lot 9 safer for everybody involved wouldn't have it? 10 DICK: Well, hindsight, perhaps it would have 11 12 been. STEVE: Hindsight? 13 DICK: Perhaps it would have been. 14 STEVE: How many people, how many people have 15 dealt with David through the years, the weeks, the 16 months? Has seen his demeanor, how he is with people. 17 Do you know that if you ever sat down with him and you 18 had a sincere desire to know what that Bible is about, 19 he would sit with you --20 DICK: For hours! 21 STEVE: Five hours, ten --22 DICK: 23 Sure. STEVE: -- a day, two days. 24 DICK: Okay. Let me put it --25 STEVE: Time -- let me just say something.

Time is short. His whole life, you'll be able to see it in him, is devoted to allowing people to have an opportunity to live forever. That's what he's all about.

DICK: And I understand that and I can, and I can appreciate that.

STEVE: I've never met another person that is

-- that makes money off of religion, makes money off of
God, whatever he is, a priest, a minister. This man
does not do that. And he's concerned about the world
whole, whole wide --

DICK: Sure.

STEVE: -- because the guy knows the book backwards and forwards. He knows what God is going to do.

DICK: There's no one going to question that, but you have to understand. The Government collects information in terms of law -- breaking of laws, okay?

STEVE: This, this sounds so -- doesn't it, Dick, sound to you more though that it was the ATF's whole -- well, not only choice as to what took place, how they went about it, but they ended up -- even though they had signs that showed -- and they should have known clearly from Robert -- I mean, I'm amazed that they went on with what they did after what David said to Robert.

DICK: Um-hum.

STEVE: Especially with all the women and children everywhere. That's why, when they came to the door already I'm packing and David, David should have been dead standing at the door. There's something I wanted to tell you people, but I guess -- I'm not, I'm not going to say anything just yet, but and having the opportunity to speak, you will find out for a fact what happened.

DICK: Well, that's exactly --

STEVE: Not may, not maybe.

DICK: Absolutely.

charges, there's going to, there's going to have to be somebody charged on that side, because I'm telling you. From what it all appears, from all the testimony and all that was seen and observed here, and if there really was TV coverage or any kind of video tape coverage, it'll fit totally and perfectly with what was seen and the testimony given here.

DICK: That's fine. And that's all we've asked you repeatedly over these last six, seven days here is that we want you to make that known. We want to understand what happened from inside. I was not here. I'm not in the position to say what happened. You are. ATF is. ATF, I guarantee you, will be able

to tell their side of it, just as you need to tell 2 yours.

I can -- Dick, I can understand, I STEVE: can understand why Americans would be totally terrified of what happened. To think that could happen to anybody in this country. I mean, it's one thing to have, you know, an agent or two or three --

DICK: Um-hum.

STEVE: -- a sheriff or somebody from the department that -- David's used to -- he, he's loves a thorn. He has given the time to any one of those guys. He's never threatened any of them. On the contrary, he's been so cordial and open to these guys. They could have come to that door and knocked at it, come in with a warrant in their hand. He would have gone with them. He'd have invited them in, sat down -- I mean, he's always been that way. You can look at his -- talk to the people who have known him from all over, out in California, here, wherever. He's always offering people something. He's always giving. He's always giving people money, food, whatever opportunity --

DICK: Steve, I -- my understanding is that that is correct. But, how do we go on from Sunday?

No, we still are going on, but, you STEVE: know, and, and saying this to see what your response is to that, maybe it'll help those that are, are listening

Absolutely no one. 8 Including the people inside, the people outside. 10 However, how do we move to get -- making sure that this does not happen again. The way we do it, the way we do 11 it, Steve --12 13 STEVE: Okay. DICK: -- is to ensure that all parties that 14 were involved in this are talked to, they're 15 interviewed, and that all the information is collected 16 and is, is used in a, in a useful way. That is --17 STEVE: No, I understand that. 18 DICK: But, but, but I know. You and I both 19 understand that. David understands it, but how do we 20 go about doing it? 21 STEVE: Dick, can I ask you a question? 22 23 DICK: Surely. STEVE: Were the FBI notified right away when 24 they came to the door before? Were they not involved 2.5 at that point?

DICK: 1 No. STEVE: We've heard conflicting --2 3 DICK: No, no. The FBI was not involved at See, that's -- ATF and the FBI are, are not even 5 in the same department. 6 STEVE: No, I, I understand that. 7 DICK: And we had no input into that. They work violations of Federal law that, that, that are --8 9 that they have jurisdiction over and we do the same. 10 So, no. 11 STEVE: Well --12 DICK: We were not part of that. 13 STEVE: I know that this Mark Bro (phonetic 14 sp.) from the beginning has contacted just about every 15 major agency. In fact, even the sheriff's department. 16 I went down there, I believe it was this last summer 17 sometime. Or maybe a little bit earlier than that, 18 another man and myself, and we talked with the 19 sheriff's department and they told us. They said that 20 Ma -- a Mark Bro from Australia was constantly 21 harassing them in regards to getting some kind of charges on us or, or coming after us or -- the guy was 22 23 relentless. They told us that the guy was always 24 calling --25 DICK: He may well have been, Steve.

you know, there were a lot of people calling and part

of the information, I'm sure, was in error. It's much like now. You cannot believe the input we're getting 2 from former members inside, from people that think they 3 know what you're about, and those kinds of things. That's what life is. I mean --5 STEVE: Oh, no. I, I understand and one would 6 7 expect that, of course. DICK: Sure. And part of it's going to be 8 probably accurate, some of it's going to be partially 9 accurate, and other parts --10 STEVE: Surely. 11 DICK: -- are going to be totally inaccurate. 12 You can only sort out the best you can the information 13 that you receive and, and that's what, what ATF was 14 supposed to have done and made every effort to do it. 15 But, you know, there's nothing certain in life and 16 while we all try to do the best job we can, some 17 mistakes are made at some point in time and 18 unfortunately --19 STEVE: Oh, I mean, but something so big as 20 that --21 DICK: Absolutely. This was a horrible -- as 22 horrendous as anything I've ever seen in, in the years 2.3 that I've been in law enforcement. And it's -- you 24 know, Jim is, is an ATF agent that was here and you

think that he feels any less worse than you do?

STEVE: Well, you know that's not so, but of course there's that mentality and it does make a person stop and wonder, but who's watching the watchdog, about big brother? If that is not in the -- one of the worst examples that I've ever seen or heard about --

DICK: Absolutely.

STEVE: -- and that there's -- there are people, you know, and there are small, little newspapers and large papers and there are concerned, very intelligent people across America that have been watching this Government grow. I'm not talking about the people, I'm talking about when this country was founded, the militia was the people.

And nowadays what do we have? We've got a standing army controlled by the Government, not by the people. And when these guys are sent off to war or whatever, it's not by the people again. It's about people that are in office. Your agencies, like the FBI and like INS, IRS, we -- people don't even have direct access to when it comes to voting. You know that. I mean, they've become so powerful, who do they answer to? Can you tell me that? Who do they answer to?

DICK: I'm not -- Steve, I don't disagree

with you at all. I think we all see Government excesses. Absolutely true.

STEVE: I mean, though, but --

DICK: Absolutely true. 1 STEVE: -- but these agencies really are on 2 3 the outside of the Constitution. There -- and there's no way we -- they can be controlled by the people. This is to be a country for and by and all the rest of 5 7. E.i. the people --6 7 DICK: Sure. Absolutely. 8 STEVE: -- but it's not, it's not that way anymore. What, what's this Federal Reserve System. 9 Nothing to do with the Federal anything. Private 10 bankers coining our money, even though in the 11 Constitution, even though the statements made by 12 13 Lincoln, Jefferson, all of these guys, Jackson, all these past presidents. The warnings they gave. This 14 15 Mayer Amschel Rothschild that made a statement 200 and some years ago in, in Europe, allow me to coin a 16 17 nation's money and I don't care who runs it, I don't 18 care who's president. Quite a strong statement. Who's 19 coining our money, Dick? 20 DICK: Steve --21 STEVE: Do you, do you know who is? Do you 22 know anything about the Federal Reserve System? 23 DICK: I -- those things you just 24 mentioned --25 STEVE: Why, why they take the -- what?

DICK:

-- are true. Those things you just

mentioned are absolutely true. 2 STEVE: Why did they take the gold backing away from the American money? They used to be called 3 Silver Certificates --5 DICK: Um-hum. STEVE: -- and all the rest. Now they're 6 7 Federal Reserve Notes. A note is for something of valuable. 8 DICK: Steve. 10 STEVE: Take the piece of paper and you're to 11 get something in return. What do you get? Another piece of paper these days. They don't even have an 12 13 answer for that. 14 DICK: I -- Steve, I, I understand your 15 concern and I share many of those concerns, as do other 16 17 STEVE: Why aren't you speaking out for your country then, for the freedoms that you -- do you hold 18 19 these freedoms dear yourself? 20 DICK: I, I do. I do. And I'm doing -- what I do for a living I hope it contributes to, in some 21 small way, to those same issues. Not specifically 22 about the bank. 23 24 STEVE: What is the -- agency you all answer to, because I'm curious. I'd like to know some of 25 these things.

1 DICK: Well --2 STEVE: And, and those people that work for it, what do they think? 3 DICK: Well, listen. Many of us are dissatisfied with, with many aspects of our particular 5 jobs. Whether we're employed by the Government, without -- outside the Government, by major 7 corporations, by, you know, by the farmer down the 8 road. I, I would guess all of us have some opposition to those kinds of things, but you know, very few of us are ever put in a position during our lifetime that we 11 can, that we have a forum to make those thoughts known 12 to others. You have that forum. You have that 13 opportunity and you have that responsibility now. 14 15 STEVE: What are you saying that I have that? 16 DICK: You have the ability to do that. 17 You know as well as I the moment I walk out that's all it. There's no more voice -- not 18 19 now. 20 That's it. That's, that's your, that's your, that's your belief? That you have no 21 voice when you leave that compound? Is that what 22 you're saying? 23 24 I have watched every -- whatever happened. I never heard -- I would like to have heard 25 this Weaver, what happened to him and his voice. I'd

like to have really heard both -- I mean, I would listen to both sides of it. I'd definitely like to 2 3 hear that man speak for himself. DICK: He will be speaking for himself. STEVE: America -- well, who's -- who's heard 5 about that guy? If that was -- if there was a 6 newsworthy item to take place, an event, how come 7 8 American -- American's have not had or heard anything about this case? 9 10 DICK: Well, Wea -- Weaver is going to be --11 STEVE: What, what's with this press of ours. the Associated Press and all the rest. Are they so 12 controlled that nothing can ever get out other than --13 I mean, what you hear in one newspaper across America 14 15 is what you hear in all of them these days. It didn't used to be that way, did it? 16 17 Steve, let, let me address the issue 18 with Weaver. Okay? 19 STEVE: Okay. Please do. 20 That seem -- I know you've brought 21 that up a couple of occasions. 22 STEVE: Definitely have. 23 DICK: Okay. Weaver, like others, are 24 represented by attorneys. Okay? He will have, and 25 there is an opportune time and an appropriate time, for him to respond to those issues. The, the system in

this country, while there are certainly some 1 2 shortcomings with the legal system in this country, I 3 think we all agree it's the best one in the world. picks his time to make these -- his concerns known. 5 And much like you, he's, he's another that, that was fed up with the system, this system of 6 7 Government, and chose to live another life and 8 unfortunately people were injured. But he had the courage and the fortitude to come out and say, listen. 10 I want this known --11 STEVE: I want to -- I'm talking about 12 hearing the man, what he's got to say about what 13 happened. 14 DICK: He -- he's picking his time, Steve. 15 I don't -- I have a hard time 16 believing that, because of what I've heard by others 17 that do know him, the little bit of coverage that came out by small groups of people in, in other papers. 18 19 DICK: Um-hum. 20 I haven't heard even what's happened STEVE: to the case. There's no question the man would want to 21 22 speak in regards to what happened to his wife and all 23 the rest. DICK: Well, well, sure. 24 Listen. Let me, 25 let me draw you an analogy here. In Waco, Texas, every

newspaper, every TV station, every media source here is

riveted on this --STEVE: I don't -- you know what? 2 DICK: Okay? 3 I don't, I don't doubt that, but --STEVE: 5 DICK: No, okay. STEVE: -- there's one, there's one problem. Your people have moved them back further and further and further, to the place where if we even did come out 8 we would be going right by them. So what if they're 9 10 there. They won't have any opportunity to talk with us. They haven't had now. You took care of that way 11 back in the beginning. 12 DICK: Steve, that's completely untrue. 13 STEVE: I, I want -- I really did want to 14 15 talk issues to this country that's been so great. 16 DICK: You'll have the opportunity to. STEVE: And if someone came to the door, I 5 mean, what --You've -- let's -- let me stop you 7 DICK: here for a second and address that issue. 8 STEVE: You ought to see his --9 DICK: Okay? 10 11 STEVE: But hey, Dick, you ought to see his bedroom, how it was shot up by choppers and it was 12 13 seen. They were seen coming and when they came, what Three of them. Is that they way you serve a they did. 15 warrant? You tell me. DICK: Absolutely not. Absolutely not. 16 17 STEVE: And, and I want the press to know I haven't heard anything on TV about three 18 choppers, how they came guns ablazing. You, you want 19 20 us to walk out of here? You got to start doing 21 something, giving us connection to the press. DICK: I was not there, okay? 22 23 STEVE: -- I was. -:-24 DICK: You -- only you were there. Okay? You will have access -- I'm telling you people are 25 going to write books about this, there are going to be

movies about it, there are going to be Congressional inquiries about it, the press from all over the world 2 is here. They're just waiting to get an opportunity to talk with you folks. 5 I'm sure they are. But, of course, 6 you cut them off. I've never -- where in the 7 Constitution do you have the right to do something like that? 8 9 DICK: We are charged to protect the lives of 10 the agents that are here --11 STEVE: Listen --12 DICK: -- the lives of the people inside, and 13 the newspaper people and everybody else. 14 Don't, don't insult my integrity. STEVE: 15 They're sitting out there in an armor-clad Bradley. 16 DICK: Absolutely. 17 STEVE: They, they can move around. They've 18 got so much --19 DICK: Sure they can. 20 STEVE: -- and you can bring the whole United States Army here if you want, whatever. The bottom 21 line is we were peaceable before, we have been since. 22 23 The greatest thing we showed you right from when the 24 incident happened was how we allowed immediately others 25 to come onto the property and take these wounded off and, and the bodies of those that passed away. We were

-- in fact, I was the guy on the telephone working with you guys right from the beginning. 2 DICK: As was Jim. 3 STEVE: Trying to get them --(Pause.) 5 DICK: You still there? 6 7 STEVE: Yeah. I'm listening to them. David says you're just damn, belligerent bullies. 8 DICK: Well --9 STEVE: With a double tongue and this is what 10 you guys have shown from the beginning. 11 DICK: Well, I -- that's not true and I hope 12 that --13 STEVE: No, it is true. It is true, because 14 of the very statements that Jim made and promised us, 15 16 what has taken place since then, the cutting off to the 17 press, even though we were opening our -- why are we so -- why do we appear to be so weird, the rumors. He was 18 explaining to the press our, our stance and belief in 19 God and, and the power that be that we all will have to 20 21 come before. DICK: Well --22 STEVE: Wait. Now, he's talking -- I'll pass 23 24 it on to you, Dick. Just hang on. 25 (Pause.)

STEVE: You, you've cut us off in our

communications and now we can't answer in our behalf,

whereas you can give all the rhetoric, all the 2

information in the manner you want and it's been com --3

totally -- so frequently incorrect as you know it, like

yesterday. 5

DICK: Well, listen --

STEVE: Wait, wait. First you come on and the ATF agent says that there was a shootout between this group and the sheriff's department. That's correct -- then he says in '88 -- then he -- then when he goes to correct it, it's still wrong because he gives the wrong year -- I mean, this is -- it constantly is that way. I watched yesterday, even though Rick who is your representative to the press did a better job than most --

> DICK: Um-hum.

STEVE: -- the facts still were not totally correct. And it is not hard to get them correct. I'll give you and point you to the places where you can get the information right before it's given, but it does not happen that way. So while we sit here and we watch all of this, it's so unnecessary that you're so inept as a department to do something like that.

Especially in regards to making that statement about this group being in battle with the sheriff's department in '87. I mean, come on.

There can't be a secondary crime when a 13 14 crime was committed, number one, by the Government and their procedure, what they chose to do, and they did 15 not do as the Constitution allows. Especially when the 16 warrant and how the warrant is to be given. 17 DICK: Do you think I support what was done? 18 STEVE: I haven't said that. 19 20 DICK: Ask David that. 21 STEVE: Yes. 22 DICK: Put David on the phone and let me talk directly to him. I don't support that and I don't know 23 anybody that does. 24 25 STEVE: I -- he claims he does not support that and he doesn't know anyone that does.

1 (Pause.) STEVE: David says, what a liar. 2 DICK: Well, I have not --3 STEVE: He says take the time to read Psalms 4 5 149, Dick. DICK: Listen. Let me tell you something, 6 7 Steve. STEVE: He cares for you as a person --8 Steve, I understand that and I'll be 9 happy, at the appropriate time, and I'm going to look 10 at Psalms and I'm going to look at some of these other 11 12 passages he mentioned. However, right now, at this moment, at this time --13 STEVE: You don't realize --14 DICK: -- we have to -- all this impasse. 15 16 STEVE: You don't realize. If you opened 17 your Bible to Psalms 68 it talks about God having 20,000 chariots. 18 19 DICK: Um-hum. 20 STEVE: Understand. All these prophets taught in the last conflict between a little group of people and it doesn't have to be us. I'm no person 22 23 that's running around with some banner saying hey, it's me, it's me. 24 25 DICK: Um-hum. But the Bible is clear. If you, if STEVE:

you took the time, I'll show you or he will, that there are chapters after chapters showing that when this conflict winds down, there are other worlds, there's other peoples that God has created --

DICK: Well, let's wind this conflict down.

STEVE: -- that -- listen, listen, listen to this now. Whether you believe it or not, they're going to come down in what is called a Murkeva (phonetic sp.). It's a Hebrew word. It's in the Bible. It's a chariot so large that all of mankind, from the beginning of Adam and Eve, they're so huge, would fit into one. So these worlds, a number of these worlds, are going to empty out. They're going to get into these vehicles. This is why it says God has 20,000 chariots. Then it goes on to tell about his angels, the power --

DICK: Um-hum.

STEVE: -- that he has to destroy.

DICK: Okay.

STEVE: So it says that they're coming to this world to watch this last great conflict. So right now, our interest, our concern is for your life, for your safety. See, we look out here at these little Bradleys and so forth and all the rest. My concern is not mankind other than for your salvation. It's not that we have a fear for man. We do fear this God.

This is why people have not left here. It's not that he has some kind of great power over these minds. You — and if fact — in fact, in coming out and sitting down with any kind of an interrogator, a psycho — psychologist, psychiatrist, you'll find that these people are the most logical, common sense — this is what we're talking about. This is what the Bible is.

DICK: I don't doubt that at all.

STEVE: But the, the -- that person that created you and me, that being that created you and I, the one that's beyond us, is angry. All the prophets show in the last days, you've been doing your own thing all your life, I've been doing my own thing all my life.

DICK: All right.

STEVE: There comes a day when we all have to give an account. God wants us to slow down and take a look at what he's offering. Otherwise, now, now -- real careful here, as in the days of Noah. Noah preached for 120 years, people didn't take him serious. The same is happening today. There's one last time, there's going to be an ark of safety, one last time. And where's that ark of safety going to be? You see, that's what we're trying to share with you. People scoffed at Noah. They were living in this life. They had their system. They believed in their god. They

had something to say about God. The day came where the 2 safety was to get into the Ark. That was salvation. Everybody went swimming except for the eight. So 3 that's what our concern is for you and for these agencies and for others --5 DICK: Okay. 6 7 STEVE: -- but we can't make that known to 8 anybody and if you think we --DICK: You can -- listen, listen, Steve. 9 STEVE: Listen to me. 10 11 DICK: You can in your own mind. I mean, you 12 can but you have to accept it -- listen. I didn't mean 13 to interrupt. I apologize for that, but one of the 14 Bradleys apparently has some, some repair problems that are going to have to be fixed, so there might be -- you 15 might see some smoke coming from one of them. So I 16 17 just want you to be alert to that and --18 STEVE: I -- should I tell you what I think 19 is happening there? 20 DICK: Okay, sure. 21 That I might see some smoke coming 22 from one of those Bradleys. They're going to probably 23 try out the system they have there --24 DICK: The system. 25 STEVE: -- that creates -- I, I'm aware. See, we even have books on things like that.

DICK: Okay. What system are you talking --1 I'm not familiar with the Bradley. 2 I don't have the, I don't have the STEVE: 3 book in front of me, but if I, I went and got it here now --5 - E. DICK: Well, I'm telling you that there is 6 not going to be anything done except they're doing the 7 repair. Now, you'll find that to be true as soon as it's done, but I -- accept that from me. 9 STEVE: Well, what kind of a, what kind of a 10 repair? Are you talking about an engine repair? 11 I assume if there's going to be smoke 12 DICK: that it must be an engine --13 STEVE: Well, see, these Bradleys are made 14 and have a device where they create smoke, create --15 DICK: No, no. We're not talking about 16 laying a field of fog down or anything of that nature. 17 18 STEVE: Okay. DICK: I mean --19 STEVE: Well, they do have that capability, 20 21 of course. DICK: Well, certainly they do. In, in a war 22 This is not a war zone. 23 zone. STEVE: What Bradley is it? Where's it 24 25 located? DICK: I don't -- which Bradley is it?

1 UNIDENTIFIED MALE SPEAKER #1: -- it's the one back by the water tower. 2 3 DICK: There's one up by the, the tower up there, the water tower that they're going to fix. 5 STEVE: One by the water tower? What, 3-22 6 where's --7 It's going to be done there. They're 8 going to do it there. Double E Road is where they're going to do the repair work. 10 STEVE: On Double E Road. 11 DICK: Yeah. Near -- on Double E Road 12 they're going to do it --13 STEVE: I see it over there. 14 DICK: Again, it's an inconsequential thing, 15 but we want to tell you about it --16 STEVE: I see. Okay. 17 DICK: -- so you won't be concerned. STEVE: Okay. Is that John what you were 18 19 speaking with? 20 DICK: No, one of the other fellows over 21 there. No, John's gone. 22 STEVE: All right. 23 DICK: You know, he was there during the 24 evening and he's gone. 25 STEVE: Right. DICK: He'll be, he'll be back with you

tonight. STEVE: No, it's not that I'm requesting him. 2 DICK: No. I understand. 3 4 STEVE: I just thought, I thought I heard a familiar voice. 5 6 DICK: No, it was not John. 7 STEVE: Okay. 8 DICK: One of the guys just yelled in at me. 9 Steve. 10 STEVE: Yes. 11 DICK: I, you know, unfortunately you've --12 you think that I'm just telling you these things. 1 DICK: Okay.

STEVE: One of the biggest things of all things is that you cut us off. You cut our telephones off from talking to who we will.

DICK: We, we, we do this in every --

after you came here, and when I say you I'm talking about that agency which came to take the lives of people indiscriminately. They didn't even -- were not concerned about women and children, even though Wayne and I were screaming on the phone to the 911 number. David's at the front door saying back off, we'll communicate. He said there are women -- I heard him before there was any gunfire, I heard him call that out.

DICK: Then tell that to the world.

STEVE: And they, and they were shooting through the walls. How can -- you're telling me that -- I don't -- that's what we want to do is tell it to the world. Put -- leave our phones -- put them as they were, as is given in the Constitution the freedoms that we should have to be able to speak. And if you want to refute that --

DICK: You will have those services restored eventually.

STEVE: If you want to get your people to

I remember he used 13 the word perimeter --14 DICK: Um-hum. 15 STEVE: That these Bradleys, would be three of them, would come up to the very edge of the 16 perimeter, to the property, but would not come onto the 17 property. And no one would come on to the property and 18 19 we agreed. 20 DICK: Steve --21 STEVE: And he even said that there would be maneuvers at times. We agreed to that. That's fine. 22 23 DICK: Let me, let me give you an analogy 24 here, okay? 25 But listen. But, Dick, though. me though now. Hear me.

DICK: I'm hearing you. 1 STEVE: That's the statement now --2 DICK: I understand. 3 STEVE: -- and, and that has not happened. These guys had the audacity to get out there, like yesterday to move our motorcycles out of that protective shelter in the back there. 7 8 DICK: Okay.
