But I'm, I'm strongly convicted in 8 what I've read and studied and what I've seen and I think there's going to be a final judgment that's 10 contrary to what you and I and all of us think. 11 RICK: Well, I kind of understand what you're 12 saying and that way, but if you'll tell me right now 13 that you would like to talk to your attorney --14 STEVE: Okay. 15 RICK: -- for sure, then I -- with a 16 commitment like that from you then maybe, maybe we can 17 work it out and, and make those arrangements for you. 18 What do you think. 19 STEVE: Well, I don't know. What kind of 20 thing are you thinking about? Are you talking about 21 over the telephone? Are you talking about --22 RICK: Well, if that's what we can arrange, 23 yeah. If you, you'll just tell me that's the way you 24 want to do it and give me a commitment there, then, 25 then I can go from that --

Let me, let me have a good night's 1 rest and give it some thought and tomorrow, you know, 2 that amongst a few other issues that I'm speaking with 3 John-5, as he terms himself. I guess John O'Neil, he 4 called himself? 5 RICK: Yeah. Yeah, that's correct. 6 John O'Neil, okay, and --7 RICK: He's a dynamic kind of guy, isn't he? 8 STEVE: Well, a lot of you guys are. You 9 wouldn't be in the position you are. I mean, dealing 10 with people, weird cases like this. Like yourself, I 11 mean, through my life I've dealt with thousands of 12 people from all walks of life and I'm interested in 13 humanity myself and also advancing, you know, people 14 doing better and helping them, of course, and I never 15 thought I'd be on this side of the picture, but here I 16 am. 17 RICK: Well, like I said, you know, if you'll 18 think about, think about it with your attorney. Of 19 course, we'd, we'd try to -- if we were going to 20 arrange something, we'd definitely -- I'm sure the 21 attorney would want us to arrange it where it was just 22 you and he talking --23 STEVE: Okay. 24 -- and not anybody listening in on it, 25

BO --

STEVE: Well --1 2 I kind of know how attorneys are, you I deal with them fairly frequently. 3 know. STEVE: Well, it wouldn't matter to me if 4 anybody was listening or not because the truth is the 5 truth and --6 7 RICK: Well, but I know that that's kind of a 8 private thing and we wouldn't want your attorney to feel restricted by someone listening in. 9 10 STEVE: Well, I, I tell you the honest truth. 11 I don't -- I guess America's changed so much -- well, I haven't been apparently up to date as to the things 12 going on. I mean I've never been certain how it works 13 14 with bugs and things of that nature, so I know you guys can gain information from many different types of 15 sources and avenues and, and apparently it can be used 16 in courts and from what I'm understanding now --17 RICK: Well, you know, I know --18 Like Kathy. I, I, I would guess from 19 STEVE: what -- just from common sense, it would seem like 20 Kathy Schroeder has a conspiracy charge against her 21 because of information being gained that way I would --22 it would seem. I don't know. 23 24 RICK: Well, let me tell you something. I, I'm on a local level and I'll be honest with you, 25 I've seen some stuff on the local level that I've not

been real excited with, but I can tell you right now that I've never seen anything on the federal level in 2 3 the court system --STEVE: Hey, somebody must have dragged some 4 kind of a factory in here or something, because they're 5 pounding on something out here. I don't know what. 6 was listening to some seagulls here a moment ago. 7 RICK: Yeah. 8 I thought I was back in Hawaii. 9 STEVE: RICK: Well, that -- as I was saying, I've 10 never seen anything on the federal judicial level where 11 I wasn't proud of the way the system worked, you know. 12 STEVE: That's good to hear. 13 It's really good, you know, like I RICK: 14 I'm, I'm on a local level and I've seen some 15 things that I've been disenchanted with, but not, not 16 from what I've seen on the federal level at all. 17 STEVE: 18 Okay. RICK: -- and I've listened to a lot of the 7 different people in there so I've kind of got a feel 8 for their emotions and how they're feeling and they're, 9 they're fears and that sort of stuff and, and to be 10 honest with you, I understand fully well how they're, 11 they're really concerned about the deal with Kathy, but 12 you know, as with anything else, it sounds a lot worse 13 than it is and right now, really all it is is an 14 allegation and it's just like a lot of other things. 15 Once it goes to court, the facts are 16 presented and everything comes out, then, then the 17 truth will be, will be brought to light and things will 18 be decided from there. And, and I know that it's easy, 19 20 again --STEVE: Well, hopefully that's going to work. 21 RICK: Yeah, I know you know -- it's like you 22 said, it's easy for me to say that from out here, but, 23 but help me in ensuring my feelings that way, help me 24 by doing that with the people in there. Explain to 25 them that this thing is not as big as it seems like and that that's what the, the United States is all about
and if we didn't have one of the best judicial systems
in the world, we wouldn't be as strong a country as we
are. It's a fair system. I, I've seen it work from
the standpoint -- like I said, I got some relatives
that had some problems and I've seen it work from their
standpoint.

STEVE: I hope they never had any problems

And I want you to know that Mandy and your friends from the band send their best wishes to you. I want to share something with you now from the heart, Dave.

You need to know that your past concerns about my inability to control my emotions will require a vast reevaluation from you now. Every moment here in Waco is haunted with sadness and fear, but I will not be broken, nor will I leave, but rather I will remain right here in safe and bonded love, undaunted by anyone, federal agencies or Davidians alike, by the solid belief that you will survive this trial.

I don't understand why this has carried on so long and I know that you understand why I don't understand. But you know that I'm here and you know that the pain and waiting -- of waiting and worrying about your life is unbearable. Your spiritual beliefs are not being challenged, but your ability at this moment to act and speak like a human being are in question.

I can't begin to understand the depth of your

belief and your conviction. I could respect it if I honestly thought that you were helping the people around you, rather than hurting them. Not long ago you shared with me your vision to take your music out into the world and to be able to do something to help heal the pain and suffering that we're all having to experience in our lives. And I want you to know, Dave, that I don't believe for a moment that you have lost touch with that very honorable vision.

ì

I, of course, look at this entire situation from a very deep place of guilt on my own part. This situation has broken my heart, Dave. If a child ever decided to lash out at a parent or person for the sin of human imperfection you have proved yourself to be a master. Punishment is really humiliating for all of us, but I ask you to please come and talk with me and I hope to God that my punishment from you, and it's only from you, Dave, is not to have to live on wondering why you lost touch with your own mission in life.

And I believe, as I always have, that your mission of music is essential and I believe that you will have every opportunity to put that vision into realization. So come talk to me. Just talk to me. I love you.

Dave, I want you to try to answer a question for me. And this question has just hit me like, like

a, like a boulder. Why is it that so many people are 2 so anxious in anticipating the end of the world? Why 3 is there this lust? Every century, every generation, every decade, for the world to explode and end in this 5 apocalyptic prophecy? When it is so much more passionate and enthralling to be part of the effort to 6 7 make the world live, to make it healthier, so that we 8 can go on and on and carry on the generations and live. Dave, I don't understand. I want you to 9 10 answer this question for me. I need to know at this 11 moment in time that you, Davey, that you can answer that question for me. Please try. I'm waiting to hear 12 13 from you. Take care, my dear. Love, Mom. (End of taped message.) 14 15 JOHN-4: Hey, Dave? 16 DAVID THIBODEAU: Yeah, how you doing. JOHN-4: How you doing. You know, they're going out, 23 they're leaving, people -- more people are getting ready and then all of a sudden all this extra pressure 25 is put on us real quick and then the tanks start coming

over and doing things and we can't figure this out, because this is the day after seven people walk out and 2 3 more people were planning. That's why I'm on the phone right now, 4 David. 5 DAVID THIBODEAU: I mean people were outside 6 checking -- and the people were outside checking this 7 out --8 David. 9 JIM: DAVID THIBODEAU: -- you know, and all these 10 things were happening all of a sudden and pressure 11 being put on us and all of a sudden, you know, 12 everyone's like, hey, man, these guys are playing some 13 weird game. And everyone just checked out and said I'm 14 15 not going out there. JIM: Okay, Dave, like I said. I'm in here, 16 I'm new, I'm starting to participate now. What we're 17 going to do is work through that and get, get by the --18 all that, so let's try this situation again. You know, come out, you know, and, and about at least ten people 20 21 can come out. You know, that will give us some sign or give the commander some sign that you're making the 22 good faith effort to get this thing resolved, and 23 that's what I'm in here to do. And I'm really here to 24

kind of ensure that this stuff does take place.

about -- I had a friend of mine take down the last 10 minutes in notes, but I didn't realize what the time was so I missed the first 20 minutes, but I definitely 3 wanted to hear what was said. JIM: Okay. Okay. How's the situation with 5 6 this video of the children going at this time? 7 STEVE: Well, what I'm trying to do is get them all ready. Still I'm having troubles with this 8 camera, but I'm still trying to get the thing working 9 10 with the battery pack that they sent in and I think I can get it working, but I still am having little 11 problems with it. I don't know what it is, but I'm 12 getting most of the children together now to try to 13 find a place where there's enough light. It's kind of 14 a dark day and, you know, I was hoping for a lot more 15 16 light than what there is. JIM: Was David present at the time that the 17 news conference was being broadcast? 18 19 STEVE: No, he was -- he didn't get to hear 20 any of it. 21 JIM: He didn't hear any of it? 22 STEVE: No. In other words, the information that 23 JIM: he'd be getting from that broadcast would be second-24 25 hand?

STEVE: Right.

JIM: Oh.

STEVE: Do you have any, any information you could share, because actually -- you know, there's usually someone that's listening but today I don't know what happened. I wasn't -- looked at my watch and I says, has somebody got this down, because I looked to see. There was like ten minutes to 11:00 and I went looking around, you know, and so I grabbed my radio, handed it to a friend of mine, said take some notes, because I still had to try to get this camera working and going here.

JIM: Steven, what I've -- from what I understand of this situation, it was the same drill as, as the days previous to this. One of the things that we'd like to discuss with you is our lack of contact with David.

STEVE: All right.

observed as outside observers is that there may be some pressure bring -- brought to bear on the commanders here because evidently some of the upper folks are somewhat concerned that because of David's lack of participation in these negotiations, that there may be the same situation developing as it was down in Guyana with Mr. Jim Jones. There seems to be some parallels being drawn by some folks and there is a great deal of

pressure being brought down on these commanders to 2 resolve the situation. 3 STEVE: What, what are you saying when you're 4 talking about a comparison to Jim Jones? 5 Evidently they're referring to the 6 suicide situation. And one way that we could resolve 7 this is actually being able to speak with David on the 8 telephone to help, you know, get rid of some of these 9 -- hold on just a minute -- some of the concerns that some of the folks are having about this. 11 STEVE: Well, this is -- honestly, Jim, this 12 is news to me about any concern about suicide or anything like that because --13 14 JIM: Well, it's, it's --15 -- it's nothing that's ever been --16 Steven, that's one reason that I'm on the phone right now. Like I said, I'm here --18 STEVE: Yeah. 19 JIM: -- as an outside observer and --20 STEVE: I see. 21 -- and I -- we can see that there is --22 STEVE: Now, Jim, these are people that --23 JIM: -- being some parallels drawn. 24 These are people that have a super 25 love for life, have a respect for life, humanity -- in fact, I did get to talk with David this morning and he

was saying -- he was talking about the very thing of 2 only we had an understanding with people. If they 3 could only see what we've always pursued, and that's dissemination of information for their own welfare, 5 their own good, based upon something that everybody 6 says they believe in -- God. But ultimately there's 7 going to be a test like in the days of Elijah where there's information given out, it's either true or 8 false. If it's false, all that anyone's lost is a 9 little bit of their time. 10 11 JIM: Steven. 12 STEVE: Yes. One of -- you know, as I said before, 13 JIM: there is some genuine concern being expressed to these 14 commanders that the situation may develop. Some people 15 are feeling that David may be cracking under some 16 17 pressure. Oh, not in the least. 18 STEVE: 19 JIM: Psychologically. And that --20 STEVE: Not, not even in the least. 21 -- we need to or there needs to be some sort of action taken to avoid the situation. 22 23 STEVE: What, what do you mean? Make yourself plain on that. 25 JIM: Let's, let's try to resolve this thing.

Let's -- they're wanting people to be released.

STEVE: Well, I realize that, Jim, but you see we believe in God first. I mean that seems to be the whole wrench in the system and we see very clearly what has become of this government. We've seen what has become of the judicial system. I hear the statements made by David Troy like I did yesterday. I would have liked to have heard what he said today. I'm sure he spewed out more lies. If the man could read Psalms 36 and 52 he might see something about himself there.

JIM: Well, like I said, some of the dynamics of this situation are somewhat similar to the -- that situation that took place in Guyana.

STEVE: It bothers -- it -- bothers me when a man of his position and having the access that he has can say such things without even -- if -- unless the man was here when it happened and was an eyewitness and observed, I don't see how the man has a right to really say anything. I was the one that had to duck and almost lost my life and I, and I had no weapons. I've never been into them. I'm talking in a room to someone and, I mean, I -- it wasn't a happy thing at all. They asked me last night if certain individuals were, were dead finally. You know, we've been hesitant to say a few things for reasons they should be able to figure out. But they killed a number of innocent people

laying on their beds. Seriously. When, when I heard 2 this --3 How many innocent people are you JIM: 4 talking about, Steven? 5 STEVE: Well, they, they gave a list to me 6 and I didn't really respond, because if -- it doesn't 7 seem like it's time yet. I need to get the okay from those people that are related or those that, you know, 8 9 I'm trying to respect their wishes. 10 I'm not really looking for any names right now, but a number would help me resolve some --11 STEVE: Well, we'll -- Jim, we'll give you 12 I need to talk to a few people here yet today, 13 14 which I haven't had opportunity to do yet and I, I did tell a person last night, I believe his name was Rick, 15 that I would try to get back to them and give them some 16 more, information. 17 That's fine, but when would this be? 18 19 STEVE: A little bit later. I still haven't 20 had opportunity still. I wanted to talk with a couple 21 of these people here that actually were to some degree aware of what was happening, which I wasn't so --22 23 Steven, one thing that I would really like to do to help dispel some of the fears that the 24 25 command staff's having in reference to this situation

is I, I really do need to speak with David and, you

know, and converse with him over this situation. 2 STEVE: Are you going to be at the normal 3 number that I dial? JIM: Yes, I will be. 4 STEVE: How long will you be there, because 5 I'm -- I will try to do that. 6 JIM: Probably till about 6:00, 6:30. 7 STEVE: Okay. Well, I'll do all I can. 8 If you can get back with me in 9 approximately an hour so that we can get this going. 10 I will try to. I really will. 11 STEVE: JIM: Do that. 12 Is there anything else you'd like to 13 bring up or -- did you get to hear the press conference 14 then? 15 JIM: Not really. 16 STEVE: Okay. 17 JIM: What -- this video that you're going to 18 do, do you think you can have that prepared in that --19 within this next hour? 20 STEVE: Well, I'm trying to -- that's what 21 I'm trying to do right now is get it all together and I 22 was having difficulty with the camera. I still don't 23 have it totally taken care of. I'm trying to get this 24 pack working. I don't know if it's the pack or it's 25 the camera or what. Someone dropped it and I'm a

little concerned, so I still think I can get it going, but so far I haven't been able to. 2 JIM: Steven, I saw the format that you used 3 in the last video tape that you sent out of your house 4 there. 5 Right. STEVE: 6 JIM: What I'd like to see is probably the 7 same format used, as far as being able to put this 8 thing together with David and the children. You seem 9 to be a rather good cameraman. You're able to keep 10 everything together. 11 STEVE: Well, I'm less than an amateur, 12 13 but --JIM: Hey, you've done well, but the same 14 format would, would be most appropriate. That way I 15 could dispel their fears --16 STEVE: Well, see, what I did before and 17 where I did it before is not able -- I'm not able now 18 because of the lack of electricity. 19 JIM: Uh-huh. 20 STEVE: So I have to try to find a spot 21 somewhere where there's enough light coming through one 22 23 of the windows. I understand that. JIM: 24 STEVE: Yeah, and that's where the difficulty 25 lies.

JIM: What do you have? A two-lux camera? 1 2 STEVE: Pardon? JIM: What lux camera do you have? 3 4 STEVE: Well, it's a, it's a Canon A-1. a high 8 is what it is. 5 Is it a low-light camera? Is it a one-6 7 lux camera? What do you have there, Steven? 8 STEVE: I am not certain about, you know, what -- when it comes to light or the sensitivity of 9 10 it. All right. Well, I'll tell you what. 11 You put that together, you get your information 12 together on the video, and like I said, the same format 13 14 would be appreciated so that we could observe the thing here and I could also get that information back to the 15 commanders on that and I really do need to speak with 16 David and to dispel anything, you know, any fears that 17 may be developing. The commanders would like us to 18 talk at a face-to-face meeting and -- so if you can 19 20 call me back in an hour and let's get things put 21 together. STEVE: Are you talking about yourself and 22 23 me? You bet. Well, either one of the 24 JIM: negotiators here, you, and David and one of the reasons 25 that we would like you and David out there is so that

you and some of the negotiators on this team can work 1 2 out some of the problems that we're having here and 3 help resolve some of these issues that you have in this face-to-face meeting. Then, you know, the phone keeps ringing so I've got to put everything down. I come back here and now an ultimatum is given for a specific time period, minutes away. Not an hour.

GEORGE: Steve, I, I -- you're not in an easy position, but you're --

STEVE: Never have been, have I?

1 GEORGE: -- you're the, you're the, you're the link. You're the link. You've got a lot of 2 3 responsibility. 4 STEVE: It's called pressure to the place of 5 having headaches from it. 6 I understand, but, but GEORGE: Sure. Sure. 7 there's no, there's no other way -- it's the only game 8 here. It's the only game in town. You've got to keep, 9 you got to keep doing it. 10 STEVE: Well, I have been. I haven't shirked 11 from it. The only thing is, I've asked these guys, 12 like when they've got me up till, you know talking like 13 last night, three hours, two in the morning whatever, 14 you know, finally one needs to get some rest -- I did 15 get at least four hours of sleep last night. That's 16 the most I've had in quite a while. 17 GEORGE: Well, David needs to take some of 18 the responsibility from you then. 19 STEVE: Well, he does -- I'll tell you the 20 truth. He wants to. He wants to. I was talking to 21 him, he's very aggravated about his physical condition. 22 He's annoyed by it, because he's not used to -- all his life, basically, he's been in pretty good condition, 23 and he's not a happy camper right now because of the 24 wound and, and his body the way it's responding to it. 25 He's not a -- like I told these guys, he's never --

1 | he's not a person that's had headaches. He's never really had, you know, the -- a lot of little problems like a lot of people might have, so for him it's a new experience. GEORGE: Well, how about have him come into the phone then. That's -- that shouldn't be a problem. STEVE: Well, that's what I was going --(End of Tape #179)

So, you know, it's a foolish thing to even bring 7 up really unless, you know, they really have some plans that they want to do something. Well, who am I to stop them in the first place. GEORGE: Well, except that's not going to 15 make anything better. 16 17 DAVID: I'm sorry. What? I didn't 18 understand what you were --19 GEORGE: I, I don't think -- I think kind of 20 trying to resolve the way you feel and, and getting some help for, or whatever is the better way to, to 21 22 think about this rather than, than kind of drifting off 23 into sleep. It's not -- things aren't going to get 24 better if you do that, David. 25 DAVID: Oh, I know it.

GEORGE: We got to, we got to, you know, put

out a little energy now and you may feel, feel better later on if in terms of resolving something.

DAVID: Like I said, I've been trying to keep away from the people here.

GEORGE: Why?

DAVID: So they can have a chance to look back over the last few years and see if what I've been teaching them is true.

GEORGE: Well --

DAVID: You know, I know where I'm coming from. I know where I've come from. I know what my foundation is. And you know, we've tried to offer in every respect two different ways to show our, our genuineness. You know, we, we sent, we sent people out. You know, and every time the things seem to be communicative in a proper and fair manner, all of a sudden, you know, these generals or whatever have been doing all these haranguements (sic). And it just doesn't, just doesn't make the people feel that trustworthy in regards to the position that you all are coming from.

And so they have two options. They, they trust in God. And they would love to trust in God and the nation God's blessed, but it just seems like the nation is losing its credibility.

GEORGE: Yeah, but what --

DAVID: And --

GEORGE: -- what's the alternative? I mean this is the only country we have. It's the only system we have.

DAVID: Well, in the light of, in the light of the seals which, you know, John Cox and people don't want to hear about. So I guess I should be quiet about that.

GEORGE: That's probably, that's probably best at this point. Because it's, it's, you know, you're going to go over stuff that's been gone over before and hasn't, hasn't led to anything positive. And if -- what we need to do now about is think about positive things. And, and no one, no one is here -- your beliefs and the beliefs of those people in there are not going to change once you come out. That's, that's going to remain constant.

DAVID: Well --

GEORGE: All you're, all you're doing now is, is facing up to what, what the legal system requires.

And that's why --

DAVID: Well --

GEORGE: -- that's why probably talking to the lawyer is the next logical step toward, toward resolving that part of the problem. You got -- you know, we're not, we're not interested in -- it's not

that we're not interested. But we don't have the -we're not in the jurisdiction of the, of the religious 2 beliefs. We're in the jurisdiction of dealing in the 3 real world. DAVID: Like I told them, I said my religious 5 beliefs is a political matter. And it is a real world. 6 7 And that's --GEORGE: Well, well, how do you address that 8 then? You got to, you got to get in the only system 9 you're in. There is --10 DAVID: Well --11 GEORGE: -- no other way to do that. 12 DAVID: That's, that's again like I say your 13 statements are many and broad and diversified. But my 14 statement stays consistent. I've been told to wait. 15 And I'm waiting. And don't think that there's not a 16 day that doesn't pass by that I wouldn't like to crawl 17 out of this bed, and sometimes a good night's sleep in 18 general seems pretty tempting, you know. 19 I've been a good citizen in this nation for 20 33 years. You can check my record. You can check the 21 record of just about everybody that's come out of here. 22 And this stuff about methamphetamines. You 23 all guys, you all really are sick. Absolutely sick. 24 You know, all my life I have been against drugs, pot, 25

dope. It's just vulgar. Of any insult that you all

could have insulted me with that -- if, if you could have said anything that could have gotten my gills you 2 could have -- that associating me to unreal carnal 3 drugs, stimulants. I tell you what. And you know, 5 he, he gets people out of cults and all that kind of stuff. He's supposed to be pretty sharp. And we 7 locked horns with him and some of his, you know, some 8 of his students, top students. 9 And it's kind of like a baseball game, you 10 know? finished, to be finished as God declared to the prophets, then you know, why they just get so upset 3 when I just go one after the other through the prophetic writings and just clearly lay out this 4 message that God has ordained for men in the latter 5 days to receive to bring all these religions into 6 7 I mean there's only --GEORGE: Who, who are you talking about 8 9 getting upset? DAVID: Oh, the, the leaders of the churches. 10 The reason why they get upset, George, is because if 11 12 I'm teaching these seven seals very thoroughly, that means that I am Christ as the prophecy teaches. 13 And like I've told them over and over again, 14 I said, I say brothers, the problem we have here is not 15 me showing you the seals. The problem is, is by you 16 being shown the seals the keys of your institutions 17 belong to me. I mean you tell the world that you've 18 built this church for Christ. You tell the world that 19 you're taking these tides and offerings for Christ. 20 And right now the way it is is that you can't afford to 21 give up your position. Because once you give these 22 institutions over to me, I'm supposed to deliver the 23 goods, right? I'm supposed to teach them for right 24

You hear that, George? 9 GEORGE: Yeah, I hear it. 10 DAVID: Rah, rah (mimicking noises). 11 GEORGE: Well, that's, that's the stuff that 12 it -- that's the stuff that we got to deal with though 13 is the --14 DAVID: Yeah --15 GEORGE: -- the real world part of the --16 DAVID: When I come out, you all probably 17 going to put me in jail and put me in a jail that's 18 going to have a speaker. And you're all going to still 19 keep playing this stuff, aren't you? 20 GEORGE: You, you know better than that. 21 I wonder. 22 DAVID: GEORGE: You know better than that. 23 I have never really seen the United DAVID: 24 States of America ever act like this. You know, we're 25 American citizens. We got good records. You know, the

ATF saying that we fired on them. I mean I know, let's deal with it on the outside in the judicial system. 2 GEORGE: That's the only, that's the only 3 system we can deal with, Dave. 4 DAVID: And until, and until, and until you 5 get your hands on us, we're in prison here. And we got 6 to be punished. Do you all do this in the federal 7 prisons to the prisoners every day? 8 GEORGE: No. 9 DAVID: Rah, rah, rah (mimicking noises). 10 GEORGE: Pretty nasty. 11 The other, the other night this thing DAVID: 12 was on and I was dreaming. And I was dreaming that I 13 was sitting in church. And the preacher was up there, 14 and he was asking for money. And he had this big old 15 horn in his hand. And he said I'm going to keep doing 16 this until this plate is filled to the top. And he kept going rah, rah (mimicking noises). And I was 18 trying to rebuke him. But I, I -- no one could hear 19 what I was saying. 20 That was a frustrating dream, George. 21 then I woke up, and of course it was here outside the, 22 the front of the building here so. 23 GEORGE: Well, David, you know what, you know 24 what we're trying to just move things along peacefully. 25

And that's, that's the reason for that.

Well --DAVID: 1 GEORGE: And, and you're smart enough to know 2 that. 3 I'm wondering anymore whether I'm DAVID: 4 smart or not. 5 GEORGE: Oh, come on. 6 (Sighing.) Oh, man. Well, George, 7 DAVID: when's that battery coming? 8 GEORGE: Okay, the battery, the battery has 9 been authorized. I don't know exactly. I'd probably 10 need to call back to tell you exactly how we're going 11 to get that in and when to get it in. 12 DAVID: Well, when is the lawyer going to 13 give us a call? 14 Okay, David, would --GEORGE: 15 DAVID: Could you at least turn this monkey 16 machine off while, when the lawyer calls? Can that be 17 18 arranged? Yeah, I think that, that we can work GEORGE: 19 If, if I -- for instance if I, we can turn the 20 noise down while we're talking or turn it off while 21 we're talking, would, would you get some people out for 22 us? It's kind of a --23 DAVID: George, where it stands right now is 24 if anybody wants to leave they're more than -- even 25 these two guys that came in. Steve has been giving

them -- do you know what they did? These guys came 2 here to save our souls. You know how fanatics are, 3 right? GEORGE: I'm learning. 4 5 They, they figured that we're that DAVID: 6 bad and everything that, that they, we needed somebody 7 that really was spirit filled. And so they risked their lives to come up here and save our souls. And 8 9 now they realize that we're, we're nothing like what people said we were. And they're learning these seals. 11 And these guys are just -- well, you should talk --12 have you talked to them yet? They think they talked to them last 13 GEORGE: night. But David the -- you know that they're waiting 14 15 for, for you to say it's okay. DAVID: I've told them it's okay. 16 17 GEORGE: Well, it's, it's going to be more 18 than you saying it's okay. It's you telling them to leave. That, that --19 20 DAVID: Look. I can't do that. GEORGE: -- that has to be done for their 21 22 own, for their own good. 23 DAVID: Hey, we were, we were sending them 24 out. 25 GEORGE: You've got to take the responsibility and the leadership to say this is in

your own good. You need to go. Because that's the only way we're --2 DAVID: Look, George, you do not understand. 3 My position is not what you think it is. Okay? Look 4 at the gospels. of I don't know, weakness or something go up and down 2 my back. 3 GEORGE: Um-hum. DAVID: You ever felt that way before? 5 GEORGE: Um-hum. DAVID: I mean just really like, you know, 6 7 every time you move it kind of feels warm. 8 GEORGE: Well, you may have an infection or 9 fever. DAVID: And -- I don't think I got a fever. 10 11 I don't -- it's cool in here anyway. But it's, it's, I don't know, it's half pleasant and half, half --12 forgotten words here. Annoying. 13 14 GEORGE: Uncomfortable. 15 DAVID: You know. I think, I think George --John Cox told me I, I shouldn't have jumped up too, so 16 quick in the beginning. Because every time I did I 17 started bleeding again. You know, that's -- ever been 18 19 shot with a bullet before, George? 20 GEORGE: I got hit with a ricochet once. 21 DAVID: Really? Vietnam? GEORGE: No. Talking to somebody on the 22 23 phone just like this in a bank. 24 DAVID: Really? 25 GEORGE: Yeah. DAVID: Did it go in you?
