2 DAVID: ...the children do bear a name and
3 they're identified in a specific way because they are
4 very young and they are very, very super-intelligent,
5 and they are not like normal children and any --

6 JOHN: That's a shame, you know.

7 DAVID: No, wait a minute. That is not a
8 shame. That is a praise.

9 JOHN: Yeah, but a kid should be allowed to
10 be a kid, David.

11 DAVID: No, no, no, wait a minute. Wait a
12 minute. Wait a minute. Let's don't be in the
13 negative. Let's don't dishonor our own wisdom by
14 saying that. We're saying that anyone who's ever met
15 these children have praised these children up and down
16 because they've never seen such light in the eyes and
17 such intelligence. You have videos there yourselves.
18 Look at these children. Look at their overall. They
19 wave at you. They smile. They're happy. They've got
20 a different light. They're from a different
21 perspective of being. So social workers have come here
22 and they ask me about my children, you know. I cannot
23 tell them everything, but I went down there when the
24 questions and I went to the social worker's office and
25 I took little Mayanah. I mean, excuse me, I took
little Star, you know, and I took Cyrus and I took

1 little Bobbie, you know. And they said, "Now, David,
2 we hear that you, you spank your children," you know.
3 "How do you discipline your children?" I go, "Well, we
4 discipline our children in truth." They went, "No,
5 what I mean is -- well, let me ask you this question.
6 When do you believe discipline should be given to
7 children?" I looked them in the eye and I said, "Upon
8 conception." "Pardon me?" I said, upon conception."

9 JOHN: When you spank them to make them start
10 breathing, right?

11 DAVID: No, no, no. Conception, when they're
12 first conceived. I said, "Look, the problem that
13 you're facing every day is that the children are only a
14 product."

15 JOHN: How do you discipline a kid on
16 conception?

17 DAVID: Well --

18 JOHN: You slug the mother after you
19 inseminate her or what?

20 DAVID: Okay, John, stop being a social
21 worker.

22 JOHN: Give me three answers and
23 (indiscernible)

24 DAVID: Let me -- you really want an answer?

25 JOHN: Yeah.

DAVID: First of all, in the law of God

1 maturity is one of the features of submitting oneself
2 to the wisdom of the law of God. You know, hey, come
3 on. Remember your dad whupped your butt first because
4 you were not prone to do right? He stopped whupping
5 you when you did right, didn't he? It feels good to do
6 right. There's a reward in wisdom. Okay. So what
7 happens is is that I explained that genetically that
8 God is ordained in the generic structure of the mind.
9 The whole inner structure of habit, practice is
10 incorporated into the chromosome. That's your genetic
11 information, biological formulation, physical and
12 mental prospects of the being to be conceived. Now,
13 when a parent is not submissive to principle, then what
14 happens is that lack of submissiveness, that lack of
15 law within oneself is transmitted by the chromosome and
16 seed and formulates to the first thing created in the
17 womb. That's the mind.

18 JOHN: Do you yell at the sperm before it
19 goes in or what?

20 DAVID: Come on, John. The fear of God is
21 the beginning of wisdom. And so that's why people that
22 do not have a true knowledge of God fulfill the
23 prophecy of Isaiah where it says, "And that day
24 children shall behave themselves proudly against the
25 ancient and the base against the honorable." No
respect, in other words, for the prophecy. It shows a

1 time when men will be ruled by women, strictly by the
2 basis sensuality of the daughter --

3 JOHN: Yeah. Are you married?

4 DAVID: Am I married?

5 JOHN: Yeah.

6 DAVID: I'm married to the whole world.

7 JOHN: The day has come, buddy. You know,
8 women control about 70 percent of the money in the
9 world.

10 DAVID: Well --

11 JOHN: You know. I mean -- and you just --
12 you know, you're talking about getting whacked by your
13 father. You know, try missing taking the trash out or
14 mowing the lawn.

15 DAVID: Yeah. It was kind of like that new
16 commercial, that telephone, "Call home."

17 JOHN: Um-hum.

18 DAVID: You heard that one?

19 JOHN: No.

20 DAVID: It's a new telephone where it says,
21 "Call home," and it dials your home. Then it says,
22 "Call office," and it dials your office. You know, you
23 program it. It's voice activated.

24 JOHN: Um-hum.

25 DAVID: It says you might get so used to it
you just might think everything should work that way

1 | and so you -- it shows the guy. You know, he gets on
2 | the radio and he like goes into his house and his wife
3 | says, "Hello, dear. Good evening," and he goes, "Cook
4 | dinner," you know, "Clean house," and she goes, "Pardon
5 | me?" You know, she gets offended because, you know,
6 | she's not this machine, right? You just can't tell her
7 | what to do. And it does it. So, anyway --

8 | JOHN: You've got women police officers.
9 | You've got them in Congress.

10 | DAVID: Definitely.

11 | JOHN: Women ministers, women priests, you
12 | know, in the Episcopal faith.

13 | DAVID: They have the capability. They're
14 | part of an --

15 | JOHN: Sure they do.

16 | DAVID: -- equilibrium.

17 | JOHN: Sure. You've got women fighter pilots
18 | now, I think, and so I'd say that, you know, what
19 | you're saying is absolutely true.

20 | DAVID: But it has to be a mind knowing the
21 | will of God, both masculine and feminine. Now, nobody
22 | knows the will of God in the seven seals until it's
23 | revealed to them. Do you agree with me on that point?

24 | JOHN: There's even some women cult leaders.

25 | DAVID: Uh-huh.

 JOHN: You know.

1 DAVID: So when it comes to the prophecies --

2 JOHN: Um-hum.

3 DAVID: -- I and the children -- have given
4 me for signs and wonders from the Lord of hosts who
5 hideth his face from Israel. It's a sign and it's a
6 wonder from the Lord of hosts. When Isaiah states that
7 God says, "Doth said the Lord to him who man despised,
8 to whom the nation abhorred, to my servant of rulers,
9 the words that I've put in my mouth that I might plant
10 the heavens to lay the foundations of the earth and say
11 unto Zion thou art my people. Remember, my doctrine is
12 not my own.

13 JOHN: Do you guys talk in tongues?

14 DAVID: Tongues?

15 JOHN: Yeah.

16 DAVID: Well, you'll find in the book of Acts
17 that when the apostolic power came -- God's not
18 interested in jibber-jabber or other confusion. God
19 permitted those people to speak in the national
20 languages of all the Jews to Mt. Mesopotamia and the
21 four corners of the earth. Speaking in tongues is not
22 what today people try to counterfeit as speaking in
23 tongues.

24 JOHN: I was just wondering.

25 DAVID: That if you were speaking in German
or Hebrew and all of a sudden it was necessary for me

1 | to communicate to you the seals, then I would probably
2 | speak to you in those languages, not (indiscernible
3 | jabbering). No, that's --

4 | JOHN: Better make it French. I don't
5 | understand the other ones. Yeah.

6 | DAVID: I mean, that's like saying I can say
7 | something you can't figure it out.

8 | JOHN: Yeah.

9 | DAVID: And it's from God. Oh, yeah, whoop-
10 | e-do, big deal.

11 | JOHN: Go back to the Wizard of Oz, right?

12 | DAVID: Yeah, pull the curtain back.

13 | JOHN: Yeah.

14 | DAVID: So, so the lady asked me -- I said,
15 | "Upon conception." I said, "If you are not matured,"
16 | -- God says in his law that he will visit in iniquities
17 | of the fathers to the children. In other words, what
18 | you don't know and what you don't fear and what you
19 | don't understand is not going to be transmitted to your
20 | offspring. And you're going to end up spanking your
21 | kid 99 percent of the time because of what you made it
22 | to be. I said, "That's not true discipline. Get your
23 | own house in order. Get your own mind set with God."

24 | JOHN: Did you ever read Ibsen's Ghosts?

25 | DAVID: No. What's that?

 JOHN: It's a play. The sins of the fathers

1 are visited on the son. If you haven't read it, it's
2 irrelevant. Go ahead.

3 DAVID: Well, anyway. But see -- so they
4 will like say well, that's amazing. I go, "Yeah." And
5 so what happens is then the first child came. One of
6 the first things I, I emphasized -- this is my son
7 Cyrus -- is to the students that came. I said no. My
8 little son was a year-and-a-half, right, and I would
9 tell him, I'd say, "Cyrus, lay down." He would lay
10 down. "Cyrus, you can get up now," and he'd get up.
11 People usually just like freak out because he always
12 obeyed me and he always has. All of my children obey
13 me and they obey their parents, unlike the rest of the
14 kids. So my attorney, the one I had in '88 who met
15 Cyrus and Star -- here we are. We had dinner together,
16 right? You with me? John?

17 JOHN: Yes.

18 DAVID: You there?

19 JOHN: Yes.

20 DAVID: Okay. Did you hear what I said?

21 JOHN: Yes.

22 DAVID: Okay.

23 JOHN: About Cyrus.

24 DAVID: Yeah. Well, here these kids are
25 climbing all over him. Sit down, sit, sit, get, sit,
sit, in a minute, you know, sit down. You know how

1 people are with their kids. You probably experienced
2 it yourself. You have to reach over and conk them on
3 the head, right?

4 JOHN: No, uh-uh.

5 DAVID: Okay. Well, that's good.

6 JOHN: I never really hit my kids, you know.

7 DAVID: Never needed to?

8 JOHN: No. Oh, I needed to, yeah. You know,
9 restraint.

10 DAVID: Okay. Well, so what happens is he
11 says, "David," he says, "How do you do it?" I go,
12 "Well, I would explain it to you, but you don't want a
13 Bible study." He goes, "No, I don't want a Bible
14 study." Okay, well, it's a mystery then. But, anyway,
15 I went to Hawaii and I had my two-year-old. Cyrus was
16 two at that time. And we just joined this -- finished
17 a church service and I had him in my left arm, you
18 know, just, you know, between my arm there. He was
19 kind of like up and down, just kind of, you know,
20 between my arm and I was standing outside the church.
21 And he'd just turned two and this minister came up and
22 he had a tape recorder inside of his jacket and he
23 wanted to tape some questions and answers without me
24 knowing it. Of course, I knew it.

25 JOHN: Why would he do that?

DAVID: Well, because people try to catch me

1 in my talk. They try to, they try to ask me direct and
2 indirect questions and try to see if I stammer and
3 stutter and sputter around. So he came and he says, he
4 said, "So, you think you're the son of God? Is that
5 correct?" And I said, "Well, actually the scripture
6 says all those that believe God's word are the sons of
7 God." I said, you know, "Christ --

8 JOHN: Good move.

9 DAVID: Well -- and he goes --

10 JOHN: You'd make a heck of a politician, you
11 know that?

12 DAVID: Well, it's just a fact.

13 JOHN: Yeah, but it's grey. I mean, it's --
14 you know, the way you talk it just can move either way.

15 DAVID: Well, no. The point of it is is
16 this.

17 JOHN: You don't affirm or you don't deny.

18 DAVID: Well, no.

19 JOHN: That's a very intelligent way to
20 answer.

21 DAVID: The point is is that if Christ is
22 true, Christ told the Pharisees, if God called them God
23 until the word of God came and the law cannot be
24 broken, why go you about -- because I said I'm the son
25 of God, taken from Psalms 82, Psalms 83? The scripture
says God stands in the congregation of God. God said I

1 | say you're gods and all of you are sons of the most
2 | high. He expects them to listen. It's not robbery to
3 | be equalled with God if you believe God and obey his
4 | word, like father to son. So to those that believe to
5 | them gave you power to become the sons of God and
6 | fellow heirs. That's just the way it is. So the thing
7 | of it is the guy was trying to hit me on this and I
8 | said well -- I just simply quoted him what's clearly
9 | told in the New Testament. So he says, "Well, but you
10 | believe that you're like the son of God, are you, or a
11 | great prophet, right?" And I go, "Well, if I'm a
12 | prophet, then I have to have a prophecy. If I have to
13 | have a prophecy, then it has to be in perfect harmony
14 | with what all the other prophets said because Paul says
15 | that the prophecies are subject to the prophets. God
16 | is not the author of confusion, and if I'm a prophet,
17 | then I can only have one spirit which is the spirit of
18 | prophecy which is of God, and so there's no prophet
19 | that's a prophet of his own mind that can only
20 | prophesize if they are spoken to by God. And if God
21 | has a book with seven seals that only the lamb can
22 | reveal, then truly the testimony of Jesus Christ is the
23 | spirit of prophecy and truly the mystery of God must be
24 | (indiscernible) serve the prophets."

25 | JOHN: It's a theological riddle, isn't it?

 DAVID: Well, it's a statement of fact that

1 | always goes around by the Old Testament, the whole, the
2 | whole summation of all that's been written beforehand
3 | for our learning. And he goes, he goes -- the guy
4 | goes, "Well, what if I said I was a prophet?" And I
5 | looked at him and he goes, "Well, I'm a prophet. I
6 | think we're all prophets. What do you think about
7 | that?" And I said, "Well," and about that time my own
8 | two-year-old, Cyrus, he leaned forward, and this is a
9 | little baby, just turned two, he leaned forward towards
10 | this minister and says, "No, you're not. No, you're
11 | not." And the guy's eyes got real big and he kind of
12 | looked back at this baby, you know, and people were
13 | standing around and they started laughing. This all
14 | got on the tape, you know. And I said, "Well, out of
15 | the mouth of babes exactly as God has ordained his
16 | strength," and this guy's just like shocked at the
17 | aggressiveness of my little son. Okay? And people
18 | thought it was really funny, but it really was not
19 | funny. And so he just looks at me and says, "Oh, and
20 | that will be real good on the tape, won't it?" and he
21 | goes -- just walked off and just shook his head. Of
22 | course, you know, there's a lot of stories. I could
23 | tell you a lot of stories --

24 | JOHN: What's that got to do with the price
25 | of beans?

 DAVID: Well, if you learned the seven seals

1 | then babes would be free because the kingdom of God
2 | would be revealed and the truth will be ratified and
3 | babes would be free, the way God originally made it.
4 | That would be cheap enough, wouldn't it?

5 | JOHN: I reckon.

6 | DAVID: Well, John, like I said, I appreciate
7 | you for bearing with me, you know. If you read the
8 | (indiscernible) apostles they all sound like fools,
9 | don't they?

10 | JOHN: Well, I think you should read them
11 | with an open mind, you know, try to look at things
12 | rationally.

13 | DAVID: Well, there's nothing more rational
14 | --

15 | JOHN: That's all, that's all I'm asking you
16 | to do is look at this situation rationally.

17 | DAVID: Oh, definitely rationally. I mean,
18 | if I, if I wasn't -- if I had not --

19 | JOHN: Ask your, ask your two-year-old, you
20 | know. You know, what does he think?

21 | DAVID: He's not two anymore.

22 | JOHN: Well, how old is he?

23 | DAVID: Right now he's like eight.

24 | JOHN: Get his opinion, you know.

25 | DAVID: Maybe I should let you talk to him.

 JOHN: Maybe you should, you know. Is that

1 | Cyrus?

2 | DAVID: Yeah.

3 | JOHN: Do you know who Cyrus McCormick was?

4 | DAVID: I've heard of the name. But anyway,
5 | John, take these things to heart and read Revelation 4
6 | and 5 and remember the everlasting gospel. You know,
7 | the gospel of Noah is not everlasting. The gospel of
8 | Moses is not everlasting. Even the gospel of 2,000
9 | years ago is not everlasting. But the lasting --
10 | everlasting, gospel is found in Revelation 14. You
11 | know what that gospel is? The gospel is fear God and
12 | give glory to him for the hour of his judgment is come.
13 | Worship him that made heaven and earth (indiscernible)
14 | the earth, the things (indiscernible) because when you
15 | worship that God who sits on the throne you will know
16 | that he gave his word to the lamb. And that's why the
17 | everlasting gospel; says and another angel followed
18 | saying Babylon has fallen, is fallen. No confusion up
19 | hither. There is no diversity of tongues. There's no
20 | opinions. Where I come from there's strictly seven
21 | seals.

22 | JOHN: Yeah, but do you always tell the
23 | truth?

24 | DAVID: And the thing of it is --

25 | JOHN: David, do you always tell the truth?

 DAVID: I always tell the truth. Have I ever

1 | lied?

2 | JOHN: Well --

3 | DAVID: I'll come out immediately.

4 | JOHN: I wasn't here, but I -- somebody said
5 | if they gave you a radio spot you said you'd come out.

6 | DAVID: Yeah, that's true.

7 | JOHN: That wasn't when I was here, but I
8 | remember that.

9 | DAVID: That is true.

10 | JOHN: Matter of fact, I was home and I said,
11 | "Oh, good, they're going to peacefully resolve that
12 | thing out in Waco," and then it didn't happen.

13 | DAVID: And then what happened was that --

14 | JOHN: They said --

15 | DAVID: -- I was told to wait right
16 | afterwards, but now --

17 | JOHN: You mean God made a liar out of you?

18 | DAVID: I guess that's what happened. I
19 | guess that's why all the prophets in the Bible were
20 | liars because their prophecies have not all been
21 | totally fulfilled. I mean, Christ says I'm coming
22 | soon, remember?

23 | JOHN: Well, how can, how can we trust you
24 | then, you know?

25 | DAVID: Well, basically I guess it has to be
something based upon God sitting on the throne.

1 JOHN: That's a great dodge, you know.

2 DAVID: Well, okay, I have to bear the
3 penalty then. I have to, I have to sit here --

4 JOHN: That's a great dodge.

5 DAVID: -- every day with you out there
6 telling the whole world that I'm a liar.

7 JOHN: I haven't told anybody. I haven't
8 told anybody you're a liar. I just asked to clarify
9 the point.

10 DAVID: Well, you know what happened for the
11 first hundred years in Jerusalem?

12 JOHN: In other words, you cannot -- you
13 can't, you can't say because you can't be truthful
14 because God won't let you be truthful.

15 DAVID: John?

16 JOHN: What?

17 DAVID: Read Revelation 4 and 5.

18 JOHN: Yeah?

19 DAVID: And you be truthful.

20 JOHN: Yes. But I mean -- you know, I was
21 just trying to establish credibility here, you know.
22 In other words, if you say you're coming out and
23 suddenly God says don't go out there, then you can't be
24 truthful.

25 DAVID: Then he made my -- he made me eat my
words.

1 JOHN: Um-hum. I'd rather eat a pizza.

2 DAVID: All I can say we have to sometimes
3 bear many things. But let me tell you another story
4 about a man that they called a liar.

5

6 JOHN: Um-hum.

7 DAVID: It's found right there in Matthew,
8 Mark, Luke and John. Christ says if I bear witness of
9 myself, my witness is not true, but there is one who
10 bears witness of me and I know that his witness is true
11 because I came from him and I'll return to him. My
12 doctrine is not my own, but I was received of my
13 father. Well, over the next couple of chapters Christ
14 says I am the light of the world. He that followeth me
15 shall not walk in darkness. And the Pharisee says he
16 (indiscernible) witness is not true and Christ says
17 well, though I bear witness of myself --
18 (indiscernible), didn't they? He says my witness is
19 true because I seek not my own glory and not my own
20 will but the will of him that sent me for I know his
21 truth. And so the scripture says on that day God will
22 visit them with thunder, with fire, devouring tempest,
23 they that watch for iniquity and those who make a man
24 an offender for a word and those who scorn him that
25 repoveth (indiscernible). So, you see, what happened
was is we called up, we called up the Sheriff's

1 Department. We did. Things had gotten out of hand.
2 Men and women were concerned because of actions that
3 they saw were not civil. And we called up and we said,
4 911, "Call them off." I'm talking about the raid.

5 JOHN: Oh, the raid. Oh, I thought you were
6 talking about something else.

7 DAVID: Yeah. We said, "Call them off." And
8 Sheriff Lynch got in touch immediately and we got in
9 touch with a guy and he was an ATF agent and what
10 happened was is that we began to talk and I had gone
11 upstairs and I'd gotten shot through the wall.

12 JOHN: Don't you hate that when that happens?

13 DAVID: Well, what happens is is that --
14 well, like the scholars say, they -- they say in the
15 book of Thomas and the Dead Sea scrolls, one of the
16 unique prophecies is is that this messiah is wounded in
17 a battle.

18 JOHN: I got a --

19 DAVID: -- in the side.

20 JOHN: I got a friend --

21 DAVID: We're not saying this is David,
22 though, but it is kind of strange.

23 JOHN: I got a friend that got shot in the
24 face that way.

25 DAVID: Well, that's a little more different,
isn't it?

1 JOHN: Well, no. They were doing a gambling
2 raid and they shot him through the wall and he caught
3 the bullet in his mouth. Isn't that weird? It knocked
4 the teeth out of one side of his face.

5 DAVID: Did it kill him?

6 JOHN: No, uh-uh. He said he put his tongue
7 in there and it felt like his whole cheek was gone, but
8 it's just a little scar there now.

9 DAVID: Well, thank God. And so what happens
10 is is that, as I said before, you know, you boys are
11 saying that you all called us first to make
12 negotiations and that's just not true. And we had, we
13 had one, two, three, four -- well, in the beginning,
14 like I say, you know, things -- as things developed, we
15 had some here that we found -- two people were dead in
16 their, in their beds that had been hit through the
17 wall. It was still morning. Some people sleep in, you
18 know. And one young man was -- had climbed up on the
19 top of the tower. He was outside and he heard
20 helicopters and he climbed up and stuck his head
21 through the tower. That's that -- the big water tower.

22 JOHN: Couldn't see helicopters from the
23 ground?

24 DAVID: Well, no. He was outside. See, he
25 was working in that tower. We was, we was getting it
ready to, to paint the inside of it to hold water.

1 JOHN: Um-hum.

2 DAVID: Because, you know, you have to scrape
3 the rust and you have to prepare the metal for the
4 special kind of paint that holds water.

5 JOHN: Rusto.

6 DAVID: Yeah.

7 JOHN: Yeah.

8 DAVID: But he was in there and then when he
9 heard everything going outside he climbed, he climbed
10 out and look out the top and they shot him in the head,
11 the helicopter.

12 JOHN: Well, let me, let me ask you something
13 while we're talking about this. You know, I heard, and
14 I just heard that maybe a child was killed in there.

15 DAVID: Well, that's what was stated earlier,
16 early in the beginning, and they stated who it was and,
17 like I said, I was laying in the floor when I was
18 talking but, of course, that's not what happened.

19 JOHN: Oh. There wasn't a child killed in
20 there?

21 DAVID: No.

22 JOHN: Oh.

23 DAVID: And so that was early in the
24 beginning, but what happened was when --

25 JOHN: I'm glad to hear that.

DAVID: See, you are and I was. Anyway, the

1 | next thing was, as I told Jim, I said, "Look, we've got
2 | kids in here and we want to send some kids out." He
3 | says, "I know you're a good man." Anyway, again they
4 | stated that they're the ones that initiated that and so
5 | if we really, if we really wanted to add up who has
6 | misrepresented and who has told stories --

7 | JOHN: Well, that's going to come out when
8 | this thing's resolved, you know.

9 | DAVID: Exactly and that's what we're so
10 | confident in. And that's what -- you know, like I say,
11 | you know, we were happy after -- all the time we kept
12 | asking for legal counsel, they kept saying, "Come out."
13 | We said, "Wait a minute," you know, and so a lot of
14 | these things have been, have been resolved and
15 | everything. Everything is satisfactory, you know, and
16 | even like -- they kept saying, "Well, Wayne's your,
17 | Wayne's your attorney." Wayne says, "Look, I cannot
18 | give legal counsel on the federal level. I myself need
19 | an attorney," and finally they allowed him to come in
20 | and like 99 percent of all difficulties are removed.
21 | It was -- you know, we appreciated it, but it took over
22 | a month to get this. And we were told -- we called up
23 | and we said, "Look, you got some wounded here. You
24 | know, we want to cease fire. Come and get your wounded
25 | out. We're concerned about these people. They've been
 | shot." You know, we initiated all that, John.

1 | JOHN: Well, I'm glad --

2 DAVID: There were some guys --

3 JOHN: See, I had heard -- I'm glad you're
4 being so objective because, you know, I heard that
5 initially that you had lost a two-year-old that was in
6 your arms.

7 | DAVID: No, no, no, no. That was never said.

8 JOHN: Oh, okay.

9 DAVID: Never was that said. That's not on
10 tape or nothing. You'll never find it nowhere.

11 JOHN: Good, because that got -- you know,
12 this guy's not going to be a very reasonable person if
13 that's occurred.

14 DAVID: Well, here are some things, though,
15 that make a lot of people kind of upset. You know,
16 after -

17 JOHN: Well, I think that --

18 DAVID: -- after the ATF took their wounded
19 and, you know, we heard that, you know, some of them
20 were dead, took them out, then all of a sudden
21 everything changed. They did not send doctors in here
22 like they said they would and they wouldn't even take
23 our dead out. They wouldn't take them out.

24 JOHN: Do you want to send them out, your
25 dead?

DAVID: We had to bury them. Do you think

1 we'd have them in here in the building?

2 JOHN: Well, I don't know.

3 DAVID: It's been a month.

4 JOHN: Yeah.

5 DAVID: We couldn't find, we couldn't find --
6 we was -- after awhile we found that the -- you know,
7 that Pete Gent wasn't around, so someone says, "Well,
8 where is he?"

9 JOHN: He was in the water tower, wasn't he?

10 DAVID: Well, what happened was that finally
11 we -- one of the guys went out the back, went into the
12 water tower and climbed up. The terrace, you know, has
13 several levels in there, the scaffolding that was built
14 for, you know -- because you got, you know, like that
15 thing's what, 60 feet high? And there he was on the
16 top level. He had -- you know, straight through his
17 head, you know. And he was, he was already smelling
18 and everything. So we said well, you know, look, and
19 then all of a sudden what happened was is that where
20 the others had been, had been buried, you know, and
21 all, you know, that rain came and it started filling up
22 with water and stuff and it's just a mess. And this is
23 the stuff -- this stuff can be very offensive to
24 people. No respect for our dead. What, are we dogs?
25 I mean, you know --

JOHN: Well, did you ever address that, you

1 | know, with people saying hey, we got dead people in
2 | here. We need to get them out or get them buried or
3 | --

4 | DAVID: Well, yeah. They kept saying, "Come
5 | out."

6 | JOHN: Yeah.

7 | DAVID: You know, "Come out with them," you
8 | know.

9 | JOHN: Well, I guess you should have.

10 | DAVID: And so what happened was -- but then
11 | -- but that -- it was no safe position during that time
12 | at all. We were already sending the children out.
13 | What are we doing to do? Send the children out with
14 | dead people? I mean, you know, with these things --
15 | you know, you're asking us to be reasonable and on the
16 | other hand not understanding our background or our
17 | knowledge of what this overall picture is. You know,
18 | you're the negotiators. You know, you have to forebear
19 | with our insanity before you can see where we're coming
20 | from to analyze and to deal with this. But the purpose
21 | is this, you know --

22 | JOHN: Well, I don't want to analyze you. I
23 | just want to help you get out of this situation.

24 | DAVID: Yeah. Well, so the things was was
25 | that -- so finally we -- you know, we found Pete and we
said, look, we have somebody. We're going to want to

1 bury him. We don't want to bury him where we buried,
2 you know, the others because, you know, a fellow with
3 water. And so the thing of it is is so we buried him
4 out here in the front and then your agents have been
5 out here and I've had to deal with this because there's
6 been some guys that, that have been -- I'm talking
7 about they are angry and I keep telling them, "Look,
8 remember the cross. Remember the humiliation.
9 Remember the dead know everything. The resurrection is
10 the hope." But you, you -- they think -- I'm not
11 saying you. I'm saying that they're out here and they
12 have crushed all over Pete Gent's grave purposely with
13 their tanks. They have probably squashed him so --
14 here the grave was marked with flowers and everything
15 and they just pompously over and over drive right over
16 his grave. Now, what kind of action is that?

17 JOHN: Well, you know, those people probably
18 feel some frustration, too.

19 DAVID: Okay. So that's the --

20 JOHN: I mean, I'm not taking their side.
21 I'm not taking your side.

22 DAVID: Wait a minute. Wait a minute now.
23 You just made a good point, a very good point. You're
24 telling us to come on out. We want your safety and you
25 just made a good point. So, in other words, they're
running over a young man they never knew, a good young

1 | man, a guy that would never hurt anybody, a guy that
2 | was not in any way armed, a kid. He's just a kid.

3 | JOHN: Sure.

4 | DAVID: And the way they want to get back at
5 | us --

6 | JOHN: Well, I don't know that that's
7 | purposeful.

8 | DAVID: Well, now that's -- so maybe these
9 | guys -- well, what we've been trying to tell you all,
10 | but now his grave is over, just squished all to pieces.

11 | JOHN: Oooh.

12 | DAVID: You know, and you keep running over
13 | it with those tanks. I mean, you know, maybe there's a
14 | God in heaven and maybe God will show the same respect
15 | to those who violated this. But they would not take
16 | his body out. You know, they would --

17 | JOHN: Well, have you requested that, you
18 | know?

19 | DAVID: Ever since Day 1.

20 | JOHN: That they pick Pete up?

21 | DAVID: Ever since Day 1. Now they're not
22 | going to be able to. He's probably just going to be
23 | liquid.

24 | JOHN: Did you ask the negotiators about
25 | that?

 DAVID: Huh?

1 JOHN: Did you ask the negotiators about
2 getting Pete out of there?

3 DAVID: Well, we've been telling them that
4 his grave's being desecrated and ran over and ran over,
5 and they go, "Well, you come out." I mean, this is
6 not, this is not, this is not American human reasoning.
7 This is not a sober, sane -- people, people -- this
8 implies that people want us to be punished and that's
9 all they've got on their mind. Punish those -- they
10 say we're ATF murderers. You know, I'm really ready
11 and willing to stand --

12 JOHN: Well, nobody's heard your, nobody's
13 heard your side of it, you know, and this is not the
14 arena for that, you know.

15 DAVID: Well, I agree and, like I say, you
16 know, it all comes down to -- well, like I say, I'm
17 waiting. I mean, I am wanting to get out there and I'm
18 wanting to state my cause and I'm willing to take any
19 and everything the judiciary system wants to put my way
20 because I know who the final judge is, you know. I
21 mean, I'm tired of this place. I've been here for 43
22 days, you know, but I'm subjugated. I mean, I'm
23 writing this final letter here that's for me but, I
24 mean, it's just like if -- I realize that if they don't
25 listen to what God purposely dictates to me to be able
to have written by those who share what vision or

1 | inspiration says, and they don't even care to imply the
2 | scriptures which are right out of the Bible which are
3 | obvious in detail, they're not going to listen to me,
4 | But still, nonetheless, I still have my say.

5 | JOHN: Well, maybe God will tell you to get
6 | off the dime here pretty soon, you know.

7 | DAVID: You remember that Viet Nam movie, I'm
8 | So Short? How short are you?

9 | JOHN: Right. You can sit on the edge of a
10 | dime.

11 | DAVID: I can parachute off of a dime.

12 | JOHN: We had all kinds of sayings like that.

13 | DAVID: Yeah, but see, another thing is that
14 | like, you know, we present these things to you and you
15 | guys act like you don't care.

16 | JOHN: I wouldn't be here if I didn't care.

17 | DAVID: No, no, no, wait a minute. Care --
18 | I'm talking about, you know --

19 | JOHN: I care about people.

20 | DAVID: -- four ATF agents lost their lives.

21 | JOHN: Um-hum, and some of your people did,
22 | too. I think that's horrendous.

23 | DAVID: More of us than yours.

24 | JOHN: I think it's --

25 | DAVID: You have far more wounded.

 JOHN: -- horrendous.

1 DAVID: But the thing of it is is that, as we
2 stated before, even Robert Gonzalez stated that he told
3 the people to avoid the raid. Now, that's on --

4 JOHN: Yeah, but that's -- you know, what has
5 occurred isn't going to change. Let's --

6 DAVID: Exactly.

7 JOHN: -- eliminate any further --

8 DAVID: Exactly.

9 JOHN: -- action like that.

10 DAVID: Exactly.

11 JOHN: We can do something about that. We
12 couldn't do anything about that, but we can do
13 something about the present.

14 DAVID: Exactly. And so, and so, you know,
15 the development --

16 JOHN: I hope God will tell you to get on the
17 stick and get this thing peacefully resolved as a
18 leader. You know, caring about people. That's what a
19 leader is about.

20 DAVID: Well, I definitely care about people.

21 JOHN: Taking care of people in general.

22 DAVID: I care about you and I care about all
23 of the negotiators and I care about whatever, you know,
24 your attitude is, but the thing of it is understand
25 that I am a person and I deserve just as much respect
 from you as I -- as you deserve from me. And I respect

1 | your job and everything and I would like to say, John,
2 | I sure wish that, that you could get me a pizza and
3 | send six gallons of milk in here. I mean -- or
4 | actually more than that now. The children haven't had
5 | any milk in awhile and I wish you would do these things
6 | for me while we're getting our act together. You know,
7 | I wish you would help us out. And you could say, well,
8 | Dave, I'd like to --

9 | JOHN: Yeah, but --

10 | DAVID: -- help you, but there's a man there
11 | saying no.

12 | JOHN: Those things are bullshit compared to
13 | the safety of you and those people in there. You know,
14 | pizza and milk --

15 | DAVID: Wait a minute. Wait a minute. Wait
16 | a minute. Are we going to end this conversation in you
17 | telling me that what I have to say is bullshit?

18 | JOHN: No. I said pizzas and milk, the
19 | items, are bullshit compared to the, the safety of you
20 | and those people in there, you know.

21 | DAVID: But that's what you're telling Steve
22 | that you're eating and everything.

23 | JOHN: Don't hang it on milk and -- well,
24 | yeah, I am, but don't hang it on, on milk and pizza.

25 | DAVID: Yeah, but the milk --

 JOHN: Let's think about bigger, in a bigger

1 arena.

2 DAVID: -- is important to the babies.

3 JOHN: Well, have them come out and get their
4 milk, you know, you know.

5 DAVID: Now, see there?

6 JOHN: I think the powers that be here, you
7 know, have really, you know, found that to be
8 unproductive, you know, sending in things. I could ask
9 --

10 DAVID: It's actually repulsive --

11 JOHN: I could ask for any of that stuff, you
12 know. It probably isn't going to happen.

13 DAVID: So we don't ask for it no more.

14 JOHN: Okay.

15 DAVID: But one day you'll have to answer to
16 those children, won't you, if their God in heaven does
17 to you and your children what you've done to them?

18 JOHN: It's just like the old -- uh-huh.

19 DAVID: I mean, it's just fair.

20 JOHN: Well, that's what it's about. Let's
21 be fair. And that's what the court system is about,
22 fairness.

23 DAVID: We're condemned and made guilty by
24 your system before we're even tried and then you're
25 telling us that because we're guilty and condemned --

JOHN: I didn't say a word. I didn't say

1 | anything of the sort.

2 | DAVID: -- and we're confined. I'm saying
3 | the system naturally takes the side of its own.

4 | JOHN: Not a word.

5 | DAVID: It naturally takes the side of its
6 | own. Instead of it protecting us as the citizenship,
7 | supporting it, it has turned against us and used its
8 | force and power to restrain and confine us.

9 | JOHN: Well, you've confined yourselves.

10 | DAVID: Absolutely not. I came out on the
11 | front porch. I came out.

12 | JOHN: Well, I mean now in this situation.

13 | DAVID: Now, because I have been done wrong
14 | and because -- now, it may have been an accident. I
15 | heard on the news report for the first couple of days
16 | that the agent said that when they approached the
17 | building that his gun went off by accident.

18 | JOHN: Whatever --

19 | DAVID: Let me be heard.

20 | JOHN: -- occurred, occurred and that's --

21 | DAVID: Because he didn't hit me directly.

22 | JOHN: -- that's not part of the resolution
23 | here.

24 | DAVID: I know. I know, but you see this is
25 | all part of it. You wish to detach it from it, but you
 | weren't on the receiving end of that bullet.

1 JOHN: No, I wasn't.

2 DAVID: You didn't go through that
3 experience. If they had told me all right, hold your
4 hands up. Come here. Let's talk about this -- I mean,
5 there was plenty of them -- I would have walked right
6 out to them. I was on the front porch. This could
7 have been avoided totally, but it went to show.

8 JOHN: Yeah, but here we are, right?

9 DAVID: Yeah, here we are and now you're
10 telling me to trust and then yet all the signs have
11 been -- look, don't -- I got in trouble in '88 because
12 a man dug up a person's grave and desecrated a grave.
13 I went to the law enforcement. I went down to the
14 Sheriff's Department. I said, look, George Roden is
15 digging up the cemetery out there. Do something. They
16 said I had to have evidence. What? I needed pictures
17 or something. I got the pictures. I took the pictures
18 back. They said, "Well, there's no pictures of bones
19 here. We got to have evidence." I said, "Look, it's a
20 dug up casket right here in the church. I mean, come
21 on." Okay. I went back to get more evidence. As I
22 went out I was told by Sheriff Dickerson very clearly,
23 "Boys, be careful. There's some dangerous customers
24 out there." Well, what does that mean? That means he
25 knows something we don't know. So we armed ourselves.
We had a plan for diversion and when things didn't work

1 out right, here's eight guys, you know, with .22s,
2 shotguns and Luger .222s, you know. Here's just George
3 Roden by himself standing out in the middle of a road.
4 He fires first and here's eight guys --

5 JOHN: Ooh, unwise, wasn't it?

6 DAVID: Well, here's -- he didn't know.
7 Here's eight guys and there was, there was over 400 or
8 500 cartridges picked up. Now, come off of it.

9 JOHN: George was alone and he shot at you
10 guys? That was unwise, wasn't it?

11 DAVID: Well, he -- no, it wasn't, but the
12 thing was nobody --

13 JOHN: It wasn't unwise for him to shoot at
14 you?

15 DAVID: He wasn't -- look, he wasn't in the
16 road dead. No one shot a single shot at him and yet
17 everyone fired their guns because it was -- the purpose
18 of the guns was to fire into the ground to cause a
19 diversion. He thought he was dead a hundred times
20 over, but that wasn't the purpose. Our purpose was not
21 to harm him, but to, but to bring justice to a
22 situation where he had violated the corpse abuse. He
23 had to be dealt with. He was not in his right mind.
24 But, no, they come out there and "Come on, boys. Come
25 on, boys. You know, let's talk about this." Sure,
yeah, you know, we went and there's no one here yet.

1 | Everyone's here. We all stood around, all eight of us
2 | and the Sheriff's Department. I was glad to see them.
3 | As a matter of fact I sent a guy earlier. There was
4 | original nine of us. I sent a guy back earlier to call
5 | the Sheriff's Department to tell them we was on the
6 | property and everything and that, you know, to be
7 | ready. Okay.

8 | JOHN: You knew there was going to be
9 | trouble, huh?

10 | DAVID: Huh?

11 | JOHN: You knew there was going to be
12 | trouble?

13 | DAVID: No. Actually what happened was when
14 | the pictures were to be taken and the stuff like that,
15 | we wanted them to be able to have firsthand so that
16 | they could, you know, be able to -- because that was --
17 | you're supposed to arrest somebody when they do
18 | something like that. Okay. So what happened was --

19 | JOHN: Who owns the property?

20 | DAVID: -- that they came out and everything
21 | and they took our camera and then once they -- you
22 | know, we had -- they all had our guns and everything,
23 | you know. "Get on the -- ground." Man, it was, it was
24 | summertime. There was red ants everywhere. They bit
25 | us everywhere they could bite us.

 JOHN: Geez. I heard about those things.

1 DAVID: Yeah. They're terrible.

2 JOHN: Yeah.

3 DAVID: And then all of a sudden the
4 Sheriff's Department got real big and cussed and told
5 us they'd blow us -- heads off if we moved an inch, and
6 "This don't happen in America, they said. Well, we
7 found out what happened in America. They arrested
8 every one of us, put a \$50,000 bond apiece on us.

9 JOHN: Um, Jesse James.

10 DAVID: Put us in jail. Not a one of us ever
11 had a record in our life. I learned about justice,
12 about the lady down here in 1988. You know, she's
13 right on top of that building. She's got a balance in
14 her hand and she's blindfolded, John.

15 JOHN: Oh, I thought she was gonna fall off.
16 I thought you were talking about -- are you talking
17 about the, the justice. I thought you were talking
18 about some woman that was going to step off a building.

19 DAVID: I'm talking about over at the
20 courthouse.

21 JOHN: Oh.

22 DAVID: And \$85,000 later, yes, we were
23 acquitted and you know what, the jury -- we had a party
24 after that and the jury told us that the third day --
25 they didn't know why it lasted two weeks. The DA was
just doing everything he could to make a big name for

1 | himself, you know, the Waco Eight, they called us.

2 | JOHN: And Wacko Eight.

3 | DAVID: They made big stories in the -- and
4 | what stories they couldn't make out of it, they made up
5 | stories. A Current Affair took it. I'm talking about
6 | these -- hey, learn about the real world, John.

7 | JOHN: PR, you know, the media. Go for it.

8 | DAVID: The real world.

9 | JOHN: Yeah. Well, we still got this problem
10 | here, don't we?

11 | DAVID: Yep. We have it. You don't. We
12 | have it.

13 | JOHN: No. I'm sharing it with you here.

14 | DAVID: No, you're telling me --

15 | JOHN" I'm not, I'm not -- you know, I'm not
16 | getting any, I'm not getting any prettier.

17 | DAVID: You're telling me that it's all right
18 | for them guys to run over that grave because they might
19 | be a little --

20 | JOHN: Did I say that I said it was all
21 | right? Did I say that?

22 | DAVID: No. You just --

23 | JOHN: Okay. Don't put words --

24 | DAVID: -- implied it from their point of
25 | view.

 JOHN: Don't put words in my mouth.

1 DAVID: They feel, they feel animosity.

2 JOHN: No.

3 DAVID: But there's a lot of those ATF agents
4 that have turned against the ATF, you know, and, you
5 know, it's just like --

6 JOHN: Well, that would be -- that would
7 certainly be to your benefit, wouldn't it?

8 DAVID: Well, it's really not to our benefit
9 or disadvantage. It's just they realize that
10 sometimes, you know, they're asked to do things that
11 can be avoided. Sure, if the ATF should be used or any
12 group like that should be used in dealing with, with
13 people that are definitely, you know, beyond a shadow
14 of a doubt murderers, rapists, terrorists, people like
15 that, but not a people that's in question by somebody's
16 accusations.

17 JOHN: Um-hum. Well, it sure, it sure is a
18 problem. Don't forget, tomorrow at 10:00 your attorney
19 will be calling you. Today. Today.

20 DAVID: Right.

21 JOHN: Okay? That's 10:00 a.m. Are you
22 smoking?

23 DAVID: Yeah. I've got one of these nasty
24 things in my mouth.

25 JOHN: I thought so.

 DAVID: I hate them.

1 JOHN: Um-hum.

2 DAVID: I'm not even going to get into you
3 for the reasons because, like I say, you're not even at
4 the first seal yet.

5 JOHN: No.

6 DAVID: You know, in the scriptures it's like
7 a biology book.

8 JOHN: I didn't do that well in biology
9 either.

10 DAVID: Well --

11 JOHN: I'm too busy handling, you know,
12 situations and what I call the read world.

13 DAVID: You know, this is the real world for
14 me. Don't think it's not. It's real.

15 JOHN: Um-hum.

16 DAVID: We are really here.

17 JOHN: Well, you're -- you can say that
18 again. We sure are.

19 DAVID: And you're really there.

20 JOHN: You got it, yeah.

21 DAVID: And it was the real world 2,000 years
22 ago, too.

23 JOHN: Um-hum.

24 DAVID: But people just couldn't believe.

25 JOHN: Well, I sure hope we can get this
thing resolved peacefully.

1 DAVID: They said Christ did the -- by the
2 power of Beelzebub. You know who Beelzebub is, don't
3 you?

4 JOHN: The devil, Satan, Beelzebub. So, you
5 know, whatever happens, I hope it gets resolved
6 peacefully and that everybody is okay in there and you
7 can go on with your beliefs and they can go on with
8 their beliefs and their life and --

9 DAVID: Will you pay my attorney fees?

10 JOHN: Are you kidding?

11 DAVID: Come on, John.

12 JOHN: Hey, if -- what I could afford as an
13 attorney you wouldn't want, you know. Okay.

24 says, "Man, what do you think of this? I thought God

the nation."

1 JOHN: (Laughter) A lot of people didn't get
2 that one, though, I'll bet, you know.

3 DAVID: Did you hear about it, though?

4 JOHN: No, I didn't, but I heard that there
5 is supposed to be a book deal or something and it's
6 supposed to be \$2 million or something.

7 DAVID: No, no.

8 JOHN: I said, "Oh, that's great because it
9 will pay his attorney's fees, but I'm not -- if it's
10 true or not.

11 DAVID: Yeah. Then what happens when -- what
12 happened then, what happened then was they brought it
13 up in the, in the -- what do you call it every day, the
14 --

15 JOHN: The press conference?

16 DAVID: Press conference.

17 JOHN: I sleep through those. I don't know.

18 DAVID: And someone says, "Well, what about
19 this?" and the ATF agent says, "Well, I don't know
20 anything about it," he says, but he says, "I'm glad I
21 do." He says, he says, "There's accusations that, that
22 David Koresh is involved in racketeering." He says,
23 "Maybe we can get him on racketeering. We'll take care
24 of that real quick."

25 JOHN: I don't know anything about that. You
got to get out there and put some of that stuff to

1 | rest, you know. I don't watch that stuff.

2 | DAVID: I'm just doing like --

3 | JOHN: I'm inspecting my eyelids. I'm
4 | inspecting my eyelids when that stuff is on.

5 | DAVID: Huh?

6 | JOHN: I'm inspecting my eyelids when that
7 | stuff is on.

8 | DAVID: Well, John, I'm -- we both better get
9 | some -- well, you'll probably get some. I won't.

10 | JOHN: Sleep, right?

11 | DAVID: Well, you hear what's on now.

12 | Telephones --

13 | JOHN: Oh, yeah.

14 | DAVID: The telephone out here is off the
15 | hook.

16 | JOHN: Uh-huh. I'll see if I can get that.
17 | You can hang that phone up, you know.

18 | DAVID: Not that phone out there.

19 | JOHN: Yeah, but you can get that stopped.

20 | DAVID: Only God can.

21 | JOHN: Well, then --

22 | DAVID: Why don't you pray to God --

23 | JOHN: Check in with him. Check in with --

24 | DAVID: -- the God of the seven seals? Say
25 | father in heaven, father of all flesh, why don't you
 | tell David to come on out?

1 JOHN: And lots of people have been doing
2 that, I think, you know.

3 DAVID: Pray to God --

4 JOHN: I heard on the news the other day that
5 some churches have been saying gee, I hope they come
6 out of there so there's a peaceful resolution and
7 evidently God doesn't care about those people because
8 he didn't listen to them, hasn't had any affect. But
9 that's the way it goes. That's the way the old cookie
10 crumbles, right?

11 DAVID: Yeah. That's what the scriptures
12 say, too.

13 JOHN: The fortune cookie cracks.

14 DAVID: Anyway, good talking with you, John,
15 and thanks for bearing with me and, like I say --

16 JOHN: Okay.

17 DAVID: -- forget about your future. Worry
18 about the present. Check out that Revelation 4 and 5
19 and 6 and ask yourself an honest question, do I
20 understand these things?

21 JOHN: Okay. And can we work this situation
22 out, you know, for you and those kids and everybody
23 else.

24 DAVID: They're one, both are the same. You
25 can't separate us from those seals.

 JOHN: Good. Let's take a package deal and

1 get this thing resolved.

2 DAVID: Okay.

3 JOHN: Okay?

4 DAVID: Get some scholars. Send that book in
5 about Koreshians or whatever.

6 JOHN: Get some sleep.

7 DAVID: You know and put some of them, put
8 some of them wise theologians on the telephone and
9 shake these people's faith. Bring in some questions.
10 The man answers. Maybe we're wrong. Maybe I'm being
11 led by a power that maybe is bigger than me, but not
12 bigger than you.

13 JOHN: Well, let's get this resolved first.
14 Okay?

15 DAVID: Well, that's one and the same.

16 JOHN: No. You know --

17 DAVID: One and the same because, like I say,
18 I mean, you know, our destination is basically within
19 your wisdom and within your mercy, you know. You've
20 got these big tanks out here. You keep aiming these
21 big tanks at us. What can we do about it?

22 JOHN: Hey, I'm not aiming those tanks, you
23 know. I got out of the service a long time ago.

24 DAVID: Okay.

25 JOHN: You know?

DAVID: But, anyway, you know, we can't, we

1 | can't do nothing about --

2 | JOHN: Shoot. I'd be delighted, I'd be
3 | delighted if you come out here with a freaking posy and
4 | stick it right in one of those gun barrels, you know.
5 | Send those, send those macho guys home, you know. Send
6 | them home.

7 | DAVID: Yeah.

8 | JOHN: Okay?

9 | DAVID: Okey-doke.

10 | JOHN: All right.

11 | DAVID: -- Shalom.

12 | JOHN: Uh-huh.

13 | DAVID: Bye.

14 | JOHN: Bye.

15 | * * * * *

16 | STEVE: Hello?

17 | RICK: Hello, Steve?

18 | STEVE: Yeah.

19 | RICK: This is Rick.

20 | STEVE: Rick, how's it going?

21 | RICK: All right. Good morning. How are
22 | you?

23 | STEVE: Oh, I'm extremely tired.

24 | RICK: Why?

25 | STEVE: Well, David and I both last night
stayed up until I think it was 5:30 this morning.

1 RICK: Holy cow.

2 STEVE: Yeah. He was talking with John-4
3 until that time.

4 RICK: Uh-huh. So you all were really
5 solving the world's problems, huh?

6 STEVE: I fell asleep, so somewhere around --
7 I think I turned in about 5:00, passed out. I woke up
8 again and looked at my watch and I thought oh, I got to
9 get to bed.

10 RICK: Yeah. Is, is David still asleep?

11 STEVE: I would imagine. It's pretty quiet.
12 He must have turned in maybe -- I was told just a
13 minute or two ago he turned in about a half-hour after
14 I did.

15 RICK: Really? Well, is he going to be ready
16 for his 10:00 --

17 STEVE: Is he going to be --

18 RICK: -- call?

19 STEVE: For his 10:00 call?

20 RICK: Yeah. Dick DeGuerin's going to be
21 calling at 10:00. Remember?

22 STEVE: Oh, man, I wonder. I'll, of course,
23 remind him.

24 RICK: Yeah. You'll need to do that because
25 Mr. DeGuerin drove all the way up here. He's going --
he'll likely be irritated at us if he can't get

1 | through.

2 | STEVE: Now, how was it that you guys worked
3 | it out that DeGuerin was coming and not Zimmerman?

4 | RICK: I don't know if Zimmerman joined him
5 | or not. I just know that DeGuerin did come.

6 | STEVE: Okay.

7 | RICK: Somebody just nodded their head in the
8 | door that, that Zimmerman's in town, too, so I'm
9 | assuming that he'll be around, as well.

10 | STEVE: He -- I think that Zimmerman did a
11 | lot in that he answered a lot of questions generally
12 | speaking for a lot of the people so, I mean, between
13 | the two of them what one didn't come up with, the other
14 | did.

15 | RICK: Oh, really?

16 | STEVE: Yeah. It was somewhat helpful.

17 | RICK: Yeah. Well, you know what? Since I
18 | don't know when DeGuerin calls in, that's a question
19 | that you can ask him because I think they're kind of
20 | working in tandem together and he may very well be here
21 | and I just don't know.

22 | STEVE: Right. So, Rick, how long are you on
23 | till?

24 | RICK: I'll be here all day.

25 | STEVE: You will? Until what, like 6:00 or
something?

1 RICK: Yeah, probably late afternoon.

2 STEVE: All right.

3 RICK: I'm pretty much here all day.

4 STEVE: You've not -- have you ever spoken
5 with David before?

6 RICK: No, I've never spoken to him.

7 STEVE: I didn't think so.

8 RICK: I was hoping to do that sometime, but
9 --

10 STEVE: Yes. He's -- you know, as soon as I
11 find out, I'll see if I can't get him on the phone.

12 RICK: Yeah. Maybe he could take a nap this
13 afternoon after we do our business this morning.

14 STEVE: Right. And I'd -- well, I didn't
15 realize, I mean seriously, last night. He was talking
16 and I didn't realize how late it got.

17 RICK: You must be -- he must have been
18 really absorbing what you all were talking about.

19 STEVE: Well, I was sitting there. I didn't
20 think it was going to be too long of a conversation, so
21 I sat down and waited for a little bit and after awhile
22 I went and sat in a little more comfortable of a chair
23 and before I knew it I must have been gone for about
24 two hours or more.

25 RICK: Oh, you did nod out sitting in the
chair?

1 STEVE: In and out, yeah, but I never had
2 really paid much attention to the time.

3 RICK: So now you have a stiff neck?

4 STEVE: Yeah, I do. I actually do. But
5 anyway, let's see. What time do you have there? It
6 must be getting close to 9:00 then?

7 RICK: Yeah. It's getting close to your, to
8 your daily time. But, yeah, if you could try to get
9 with David so at --

10 STEVE: Right.

11 RICK: -- so that we -- because David should
12 know, right? Didn't you tell him yesterday?

13 STEVE: Yeah, I did. I did.

14 RICK: Okay. I think --

15 STEVE: All right. What I'll do is -- so
16 he's going to call himself about 10:00 and --

17 RICK: Well, we'll do the standard thing
18 since we have to patch him through.

19 STEVE: Oh, see, what he's done before, both
20 things have happened. He's already just showed up here
21 even.

22 RICK: Really?

23 STEVE: Which is -- it's better that he calls
24 before --

25 RICK: Right.

 STEVE: -- so we know for sure just what he's

1 | doing or not doing.

2 | RICK: Absolutely. Well, my -- the plan that
3 | I've been told and I'm confident that this is what's
4 | going to happen is that we'll do our normal call in to
5 | you to advise you he's on the other line and then we'll
6 | do our, do our little patch through --

7 | STEVE: Okay.

8 | RICK: -- to David since he's --

9 | STEVE: Right.

10 | RICK: -- since he's specifically asking to
11 | talk to David. And then once David's on the line,
12 | we'll do our, do our little thing and then we'll back
13 | out and let them talk privately.

14 | STEVE: All right.

15 | RICK: And then, like I said, I -- in the
16 | meantime I'll pass it along up to the front office that
17 | you were asking about Zimmerman's status, too --

18 | STEVE: Okay.

19 | RICK: -- so that they can get an answer on
20 | that.

21 | STEVE: Yeah. Between the two of the guys
22 | last time they did -- it was helpful for not only
23 | myself, but for a number of people here.

24 | RICK: I can understand that.

25 | STEVE: Yeah.

 RICK: I can understand that.

1 STEVE: Okay. I tell you what, I'll wait for
2 that call --

3 RICK: Okay.

4 STEVE: -- and we'll pick up from there then.

5 RICK: All right. So you're going to like
6 hang by the phone at 10:00?

7 STEVE: Yeah.

8 RICK: Okay.

9 STEVE: Okay. I'll be talking to you then.

10 RICK: Okay, buddy.

11 STEVE: Okay, bye.

12 RICK: Bye-bye.

13 * * * * *

14 RICK: Hello?

15 STEVE: Hello, Rick?

16 RICK: Yeah.

17 STEVE: Yeah. What's the news then with
18 DeGuerin and Zimmerman?

19 RICK: Well, Byron went down to wait for
20 DeGuerin to arrive at the front of where we are.

21 STEVE: Oh, I see. Okay.

22 RICK: As soon as he arrives he's going to
23 call up to me here --

24 STEVE: All right.

25 RICK: -- so we can put him through.

 STEVE: Okay. I'll just wait for the call

1 then.

2 RICK: Were you able to get David aroused?

3 STEVE: Yeah. I just -- he was sleeping,
4 too, because he turned in at 5:30 or later.

5 RICK: Holy cow.

6 STEVE: Yeah. He was -- he did stay up, he
7 said, until that time.

8 RICK: Okay. Well, good. So what I'll do is
9 I'll give you a ring back.

10 STEVE: Okay. Sounds good.

11 RICK: Okay?

12 STEVE: Thanks.

13 RICK: Okay, buddy.

14 STEVE: Bye.

15 RICK: Bye.

16 * * * * *

17 RICK: Hello?

18 STEVE: Hello, Rick?

19 RICK: Yeah, Steve.

20 STEVE: Yeah. I was just -- I just went up
21 and talked to David and he reminded me, said, "Steve,
22 don't you know that today is the Sabbath?" You know, I
23 mean, with this -- with the Passover it goes seven
24 days. The first night of the -- is a Sabbath and the
25 last one is.

RICK: Um-hum.

1 STEVE: And, to tell you the truth, I was
2 actually thinking that it was going to be tonight at
3 eve until tomorrow at eve and then he just reminded me,
4 "No, you're not counting correctly." So with DeGuerin
5 let him know if he comes, comes out. I mean, we can't
6 be talking business and anything like that.

7 RICK: Until when?

8 STEVE: Until the sun goes down.

9 RICK: Today, you mean?

10 STEVE: Yeah.

11 RICK: Until sunset?

12 STEVE: Right.

13 RICK: So Passover ends today at sunset?

14 STEVE: Exactly.

15 RICK: Yeah. And, you know, it probably
16 would be best, as a suggestion, is that David tell
17 DeGuerin himself so that DeGuerin's clear that it's
18 not, you know, us.

19 STEVE: Right. Well, just so you know it
20 but, you know, if he calls or anything, you know, or
21 whatever he -- I don't even -- wherever he's at.

22 RICK: Well, he's in town and what he is --

23 STEVE: Oh, he is in town for sure?

24 RICK: Yeah. He -- yeah. He's -- what he is
25 is he's on his way over here.

 STEVE: Okay. Is Zimmerman in town then,

1 too, then you said?

2 RICK: See, I don't know. We were going to
3 wait and ask DeGuerin when he came --

4 STEVE: I see.

5 RICK: -- because they usually travel
6 together.

7 STEVE: Right.

8 RICK: And all we know is that DeGuerin was
9 going to show up here at 10:00. He's late. And we
10 were going to put the call through for him to talk to
11 David.

12 STEVE: Right. Okay.

13 RICK: See, because we -- believe it or not,
14 we try to stay out of that process.

15 STEVE: No. I know you do. I know you do.

16 RICK: You know, legally we -- we're
17 constrained by that and that's kind of between him and
18 David the way Zimmerman's between you and, you and he.

19 STEVE: Right.

20 RICK: And --

21 STEVE: Well, when it comes to just, you
22 know, working out times --

23 RICK: Right, exactly, those kinds of things,
24 logistical things --

25 STEVE: Right.

RICK: -- we, you know, we can be involved

1 in, but anything of substance we have to be careful to
2 let him have access and --

3 STEVE: Correct. Okay.

4 RICK: -- you know, as far as any messages
5 kind of thing.

6 STEVE: Well, I'll just wait. If you can,
7 though, you know, let him know or remind him that -- or
8 he's already familiar with when we have the daily which
9 is twice a day.

10 RICK: Right.

11 STEVE: He is -- usually he gets a Bible
12 study.

13 RICK: Right.

14 STEVE: And --

15 RICK: Right. Well, what I'll do then -- why
16 don't, why don't we do this then? When he gets here
17 I'll tell him that before he makes his call --

18 STEVE: Okay. Great.

19 RICK: -- so that he's prepared for that --

20 STEVE: I appreciate that. Good. That will
21 help an awful lot.

22 RICK: -- prepared for that discussion.

23 STEVE: That will help a lot.

24 RICK: And that way you'll -- that way there
25 won't be any surprises for him. Okay?

STEVE: Yes. Okay. Thanks a lot, Rick.

1 RICK: Okay, Steve.

2 STEVE: Okay. Bye.

3 RICK: Bye-bye.

4 * * * * *

5 UNIDENTIFIED MALE: Hello? Hello?

6 UNIDENTIFIED FEMALE: Yes. Is this Mr.
7 Treadmont (phonetic sp.)?

8 UNIDENTIFIED MALE: No. I think you've got
9 the wrong number.

10 UNIDENTIFIED FEMALE: This is not the Ronald
11 Treadmont residence?

12 UNIDENTIFIED MALE: No, ma'am.

13 UNIDENTIFIED FEMALE: Okay. Thank you.

14 UNIDENTIFIED MALE: Um-hum, bye.

15 * * * * *

16 UNIDENTIFIED MALE: Hello?

17 JOHN: Hello?

18 STEVE: Hello, John?

19 JOHN: Yeah. Hi, Steve.

20 STEVE: Hi. What's happening there?

21 JOHN: Oh, not much. We're just sitting
22 around. What's happening there?

23 STEVE: Well, believe it or not, I was
24 totally sleeping.

25 JOHN: Oh, yeah?

STEVE: Then I was woken up here and asked if

1 I wanted to come and talk to you.

2 JOHN: Who asked you to talk to me?

3 STEVE: David. He just said he -- someone
4 just came and said that David was curious as to if John
5 had any questions or any response to last night's
6 conversation.

7 JOHN: Tell him no.

8 STEVE: Okay.

9 JOHN: Is he aware that the attorney's going
10 to call in tomorrow?

11 STEVE: Yeah. I made it real clear. Finally
12 I got -- I went back up there and he was -- I knocked
13 at the door again and he was -- I went in there and
14 just said, you know, they're going to call again
15 tomorrow at about 10:00 or something.

16 JOHN: Yes.

17 STEVE: He says okay.

18 JOHN: Is that right, 10:00?

19 STEVE: Yeah.

20 JOHN: Yeah. Okay.

21 STEVE: Yeah. So --

22 JOHN: So what's new?

23 STEVE: What's new? I'm just kind of worn
24 out. I've been going to bed a little -- I didn't
25 realize that I was sitting there listening last night
for awhile. I went and sat in a -- in one of these

1 Lazy Boys and before I knew it I went to sleep. I
2 didn't even -- it's like I shook my head and I didn't
3 realize that hours went by, you know. I looked at my
4 watch. It was 5:00 in the morning. I -- what?

5 JOHN: Yeah. Those Lazy Boys will get you.

6 STEVE: Oh, I couldn't believe it and then I
7 asked him when I saw him this morning, "Well, how late
8 did you go anyway?" He says, "5:30."

9 JOHN: Um-hum.

10 STEVE: You must have been worn out yourself?

11 JOHN: Yeah. We were just batting the
12 breeze, you know.

13 STEVE: Right. Well, I doubt it was batting
14 the breeze, you know, from his perspective, but -- I
15 mean, hum, it's really -- you know, it's -- we're at
16 such a length apart it seems between you -- yourself
17 and where we're at. I mean, what he's opening up to
18 you is, you know, to him is sincerely serious and --

19 JOHN: Um-hum. Well, this whole thing is
20 serious.

21 STEVE: Yeah, I know, but I'm talking -- from
22 your perspective and, you know, it's a human drama
23 being played out as usual, you know, as thousands of
24 times before. But long before that there have been men
25 that have -- that are psychologists, that are doctors,
that have walked away shaking their head amazed at the

1 | information. But at the same time it seems like the
2 | Bible's right when it says like in Thessalonians II in
3 | the last days there's going to be a lot of people that
4 | perish because of one reason, they had no love for
5 | truth. Every generation it's going to be that way.
6 | Finally the judgment day comes and -- I mean, salvation
7 | is a simple, easy thing. In every generation there was
8 | a present truth for that time. But, you know, we're at
9 | such odds it seems in understanding each other. I
10 | mean, we understand where you're coming from plainly
11 | and clearly as human beings ourselves but, you know, to
12 | try to help you understand, I mean, we're just some
13 | little bizarre little nutty cult out in the middle of
14 | nowhere that got tromped on, apparently some kind of
15 | reasons why we're to be checked over by a warrant or
16 | something and from that point of time it's all of a
17 | sudden, you know, and now there's something that's got
18 | to be done and --

19 | JOHN: Well, my understanding it was a
20 | warrant for David and a search warrant.

21 | STEVE: Yeah. I understand that myself, but
22 | at the same time, you know, like what we were saying
23 | last night. They could have picked him up a hundred
24 | places or they could have honestly even sent anybody to
25 | the door.

 JOHN: Well, that didn't happen, so we have

1 | to deal with the realities --

2 | STEVE: No, I know. Yeah, but --

3 | JOHN: -- unfortunately.

4 | STEVE: Yeah, but unfortunately we, knowing
5 | the prophecies, he was -- even before that undercover
6 | agent, Gonzalez, left, he started getting into those
7 | prophecies like Nahum and so forth and -- started
8 | opening them up to everybody including Gonzalez. And
9 | we believe it's going to happen and it has. It's in
10 | the process.

11 | JOHN: So that's inevitable, right?

12 | STEVE: Well, see, but the thing of it, God's
13 | always allowed himself an out. Like in the days of
14 | Jonah, for instance, you know, you have a little book
15 | in the Bible called Jonah and Jonah ultimately is
16 | swallowed by a great fish. Wait until you find out
17 | when -- what that's really about. The Bible breaks
18 | down in minute detail the very -- the being, the animal
19 | that swallowed Jonah. It's not some big sperm whale as
20 | a lot of Ph.Ds try to say and explain away.

21 | JOHN: Well, a sperm whale's throat's only
22 | about like an inch across.

23 | STEVE: Exactly. I mean, this is what some
24 | of the --

25 | JOHN: It's physically impossible.

 STEVE: Yeah, exactly, just like you said,

1 | it's foolishness. That's the point. But, anyway --

2 | JOHN: Maybe they got the wrong fish.

3 | STEVE: Maybe they do. Anyway, really what
4 | it's talking about -- like Jonah, he was disappointed
5 | because finally when he did want to do it God's way, he
6 | went and told the mightiest city of the time, the
7 | capital of our greatest empire, Assyria -- Assyria,
8 | that to repent. They were heathen. He was a Jew. He
9 | was no -- any special person. He didn't think they
10 | would ever listen to him. If anything they would scoff
11 | and maybe throw him in their jail system. But finally
12 | the man after that harrowing and terrifying experience
13 | went to do what he was called to do in the first place
14 | and when he warned them to repent, they did. Amazing,
15 | but they did. And he ends up, as you read this story,
16 | he's quite disappointed because God didn't bring down
17 | fire, out of heaven and destroy them. It's like he was
18 | -- and his word was not exonerated but, of course, God
19 | always gives a warning ahead of time that man might
20 | hear and evaluate and then come to the right
21 | conclusions. So, I mean, of course, what David was
22 | sharing -- I fell asleep, but I can imagine he must
23 | have some things that were very clearly based from that
24 | book and so we're having -- I guess there's no end of
25 | difficulty. It amazes me no matter who we talk to that
 | there is no interest, just like there hasn't -- wasn't

1 5,000 years ago in the days of Noah.

2 JOHN: Well, you know, if what you say is a
3 fact, nothing's going to alter that, right, Steve,
4 what's set in place relative to the Bible, right?

5 STEVE: Pardon? Say that again. I didn't
6 get that.

7 JOHN: If what you say is true and correct,
8 what is set in place as the Bible states is going to
9 occur regardless of the other energies at work, right?

10 STEVE: But, see, the point being every
11 generation -- I mean, and all time -- God wants us to
12 know things ahead of time. That's why we sent -- he
13 did, that second letter that talks about the hand all
14 the way through and thy hand is lifted up. They will
15 not see, but they shall see. They're going to see when
16 it's too late like in the days of Noah. They could not
17 catch in the mind's eye, by the spirit, by an
18 understanding ahead of time that there was a God that
19 talked to one man only, Noah. He gave him a message.
20 No one could buy it in that day. They -- those men
21 were smart. If you ever read the Bible, if you have
22 any kind of a belief in it, if you possibly do, those
23 men lived -- the oldest men that ever lived. It's hard
24 for people in this generation to believe, but
25 Methuselah died at 969 years of age. Adam was 930.
Jarrett was 962. I mean, you start looking at some of

1 | these numbers. They didn't decrease in age until after
2 | the flood when vegetation was gone and destroyed by the
3 | flood. That's when man -- his longevity came way down
4 | to the time of Abraham who died at 175. It dropped to
5 | Joseph at 110. Pretty soon you get down to the days of
6 | David, 70 years of age, and basically that's where it
7 | been, up and down since. But man, as God says and
8 | shows in the scriptures, he does enough evil in that
9 | short amount of time that there doesn't need to be a
10 | thousand year period. That's why man almost destroyed
11 | himself in the days before the flood. They wouldn't --
12 | the flood was just a way --

13 | JOHN: Steve, that's inevitable, right, what
14 | will be will be -- the scriptures.

15 | STEVE: You and I are intelligent beings God
16 | deals with on a level like, like it says in Isaiah 118,
17 | Come let us reason together sayeth your Lord, your God.
18 | So in reasoning together, I mean, ultimately all of the
19 | prophets --

20 | JOHN: Let's talk about that reasoning. What
21 | would you have us do in this situation?

22 | STEVE: Well, there's not -- as individuals,
23 | all of you, you know, there's been about 20 of you or
24 | better that we have spoken with and, of course, the
25 | most -- which one would expect in this generation.
There's really in the world very few people that really

1 are honest listeners and really deal with the issues
2 that they must face which is death. Death comes to
3 everybody, all living things on this planet. And this
4 is why Solomon --

5 JOHN: Well, what would you have us do to
6 resolve this?

7 STEVE: To resolve this?

8 JOHN: What would you have us do? Yeah.

9 STEVE: There's not a whole lot I guess you
10 can do.

11 JOHN: You want us to forget the whole thing
12 and go home?

13 STEVE: Oh, no, no. Positively you cannot.
14 I believe in the same system you do. I do. And I
15 believe that we've got to come out. I believe that
16 we've got to go through this system. I believe that
17 the issues -- it has to be. There's no getting around
18 it. I mean, as far as I believe in God I believe it
19 has to be. But the element has only been -- the only
20 difficulty that's been the stumbling block for you
21 people has been the time element. At the same time
22 it's because we believe that God's about ready to pour
23 out his judgments upon an ignorant world who a good
24 share of actually claim to know this God. We do -- I
25 do not claim to know God. I've never met him. I've --
I don't know Jesus Christ. I know that never was his

1 name. His name was Zeus Christos, the anointed Zeus.
2 I know that all the world blasphemes his name. Like it
3 says in Revelation 13, all the world wondered after the
4 beast, worshipped the dragon, which is Satan, even
5 though -- everybody's got feelings. They all got a
6 feeling that they're right and -- but let's look at the
7 facts, you know. There's got to be some source that if
8 there's a creator, if we're actually related to that
9 creator, he left with -- that's all insanity. I mean,
10 we live and breathe for Jesus Christ.

11 JOHN: Well, I think we have earthly
12 responsibilities, I mean, you have to live up to, you
13 know, and I think, you know, if you believe in the
14 Bible and what's there is inevitable, you conduct your
15 life accordingly and hopefully you're on the right side
16 of the game plan when it comes down but, you know, that
17 does -- that shouldn't cause you to sit on your hands.

18 STEVE: Well, no. Definitely I agree with
19 you, John. You're -- in fact, you've said it very
20 well. I mean, no question you've got -- I mean, you
21 see and hear. I think you're perceptions are great.
22 Just like myself. I mean, I see it the way basically
23 you said it, but yet at the same time you see that
24 there's something that has to be followed through on,
25 that -- and I agree with you. And I do also agree that
there's difficulty from your perspective that we

1 haven't moved out already and I totally agree with
2 that, especially if I was sitting in your position. I
3 would find it extremely odd and unusual dealing with
4 people like ourselves and I know there would be a
5 frustration on my part walking in your shoes, being in
6 that place. But at the same time, I mean, studying so
7 many religions as I have and trying to walk in other
8 people's shoes and look at it through many
9 perspectives, I don't find it difficult to understand
10 others and how they see things. The way they see it
11 should be -- and immediately. But at the same time,
12 you know, there's something I've got to see and hear
13 over quite a period of time, that if given the
14 opportunity I believe I can develop something very
15 plain and clear, that either there's a God and he has
16 left this source, and it's a very reasonable source,
17 and he's going to fulfill his very every word like it
18 states so clearly in Act 3, verse 20 and 21, or it's
19 all just nonsense. It's just a crutch, as many
20 Atheists have said and Agnostics. But see, of course,
21 our reaction to you people is that it is -- it's more
22 than just a crutch. It's a reality. Nations like in
23 Daniel 2, Daniel 7 -- these are chapters that deal in
24 nations rising and falling before the fact. It deals
25 in showing that Babylon never was until Assyria made
Babylon. It's because on the one night alone God with

1 his powerful hands struck dead 185,000 of the Assyrians
2 which were taunting Hezekiah and those Judians that
3 were, of course, inside the city of Jerusalem. And in
4 the morning they're dead, 185,000. How do you explain
5 that? You know, and it's like historians, Agnostics,
6 secular historians, have tried to explain this blip in
7 history where all this army could have had -- what
8 could have happened when all of a sudden this powerful
9 empire all of a sudden out of nowhere up and starts
10 disintegrating and disappearing immediately.

11 JOHN: It could have been bad potato salad.

12 STEVE: Could have been. And how -- what
13 kind of a -- they've tried to say it was a plague.
14 They've tried to say many things. But how do you get
15 185 -- that's one lot of -- even in modern warfare
16 185,000 is a lot of people to die in the night. But,
17 anyway, you know, I mean, of course, we're having a
18 difficult time trying to be understood and I know that
19 you're using every type of psychology and reasoning to,
20 to get us into the system now or yesterday and --

21 JOHN: Well, you know, I work for the
22 American taxpayer. I mean, that's why --

23 STEVE: And I know you do.

24 JOHN: And, you know, you know, that's a
25 consideration that I have to be aware of. You know,
it's their money that we're spending here and, you

1 know, that's something that's always in the background.
2 You know, I respect your beliefs and all that, but I --
3 all I request is that you deal with the realities of
4 the situation.

5 STEVE: But what if the realities really are
6 that the God that he claims --

7 JOHN: Well, then nothing's going to change.

8 STEVE: -- showed him about Waco --

9 JOHN: Nothing's going to change.

10 STEVE: No. What about Waco being shaken and
11 about the dam breaking?

12 JOHN: Well, then nothing's going to change,
13 you know. You can stand on your head or, you know, do
14 whatever you want. Nothing's going to change if it's a
15 divine plan. You know, if you come out of there right
16 now, it's not going to change or if you come out of
17 there tomorrow afternoon nothing's going to change. I
18 think you've got the two entwined to where, you know,
19 you've become ineffective in the real world.

20 STEVE: Well, see, that's the difference of
21 our views. To me the real world is the, is the word.
22 This is why Christ set up Abel and Cain. The first
23 difference between two human beings, twins -- oh, not
24 twins, but two brothers -- was between Cain and Abel.
25 One did the will of God even though it went against his
own feelings, his own desires. I mean, it's funny how

1 | Cain did not want to take the innocent life of a little
2 | lamb, but at the same time took the life of his
3 | brother. But it says throughout the scriptures even in
4 | Paul's day, which is in the book of Hebrews, he states
5 | how Abel is not dead. Abel sleeps. You know, they
6 | talk about death as a sleep which makes sense, a
7 | euphemism that you and I can understand and, of course,
8 | those that have the truth within their mind, you can't
9 | kill the truth. The truth can't die. It's eternal.
10 | God says that man has become like one of us knowing
11 | good and evil. Well, God himself before he could be
12 | the righteous holy God he is would have to know
13 | something about evil and that it does not work. It
14 | does not work. So mankind has been given a
15 | probationary period. There's a timetable.
16 | Everything's been seen and explained ahead of time.
17 | But those that want to understand life and death will
18 | search by wisdom those issues, and to understand where
19 | they are in time, what the answers are for things, and
20 | that's what we've done. So in this generation again
21 | all the prophets and the apostles speak and they all
22 | seem very clearly to harmonize in a very clear picture
23 | from the final days. And God is going to use a way and
24 | means whereby he gets the attention of mankind, even
25 | though somewhat bizarre. But the question is is it
opened up to the place where we can see the answers and

1 | do they make sense? Hello?

2 | JOHN: Yeah. Go ahead, Steve.

3 | STEVE: Okay. I don't blame you for clicking

4 | --

5 | JOHN: I'm still hung up in reality.

6 | STEVE: Okay.

7 | JOHN: You know? It's an awful place to be
8 | stuck in, isn't it?

9 | STEVE: Well, I'm sure that you're probably
10 | talking what are we going to do with this nut and here
11 | we go again like that --

12 | JOHN: No. We're going to help this nut.
13 | We're going to help this nut. That's what we're going
14 | to do with this nut, you know. Like Dave said last
15 | night, we're -- the world thinks we're a bunch of nuts
16 | in here and I said well, at the present time you're
17 | probably pretty correct, you know. No one's heard your
18 | side of it, you know, and they think you're a bunch of
19 | barricaded crazies.

20 | STEVE: Yeah.

21 | JOHN: I mean, I guess the longer you stay
22 | there, the more that image is enhanced.

23 | STEVE: I guess it's probably true. I mean,
24 | I -- that -- I'm just thinking of mankind, humanity,
25 | and all the warnings. Man, there's so many warnings.
They all fall --

1 JOHN: We're all --

2 STEVE: It falls on deaf ears.

3 JOHN: We're all part of that.

4 STEVE: Yeah, you're part of that. You
5 really don't have an interest in knowing for yourself
6 as a, as a human being and you've got a family even.

7 JOHN: Yeah. What if the -- you know, you
8 know, I come down here to try to help resolve this
9 thing and then you come --

10 STEVE: And what if it boomerangs and --

11 JOHN: And I become a Davidian and I go in
12 there with my pajamas and toothbrush. You know, that
13 doesn't resolve the situation.

14 STEVE: No, you're right.

15 JOHN: I want to help you.

16 STEVE: I'm really happy. I mean, the one
17 thing that is in your favor, at least you've been a
18 courteous listener. You really have been. And if we
19 are nuts or whatever else, one thing -- or what if
20 we're right?

21 JOHN: We can help nuts too, though, you
22 know?

23 STEVE: Yeah. Well, that's good on your
24 part. Seriously, it goes a long way. It goes a very
25 long way. There's no question about it. I mean, the
very simply principles of whatever Christianity are

1 | definitely found in Matthew 25, verses 31 to 46.

2 | There's only two sides to the issue, those that have
3 | helped their fellow man in the name of Christ and those
4 | that have, that have not.

5 | JOHN: See, that --

6 | STEVE: Christ says if you've done it unto at
7 | least one of these, you've done it unto me. So, I
8 | mean, I appreciate from your perspective and your
9 | attempt and so forth to do it and continue to do the
10 | right thing from your perception. I see it as great.
11 | At the same time, of course, the only reason I was ever
12 | out in this dumpy place as far as human standards are
13 | is to learn a truth. I wanted -- I've always been a
14 | person that have been -- has been pursuing truth. Long
15 | before I met David I was in Hawaii, in Honolulu. I sat
16 | there and looked at people that got caught up in the
17 | Hare Krishnas and the Moonies and the Children of God.

18 | JOHN: Yeah. I wanted to ask you -- I'm glad
19 | you mentioned that. Did you do the whole thing with
20 | the robes and the hair thing?

21 | STEVE: Oh, no, no.

22 | JOHN: Okay.

23 | STEVE: What I would do is things like this.
24 | You know, I mean, first of all I'm going to parties
25 | with Pat Boone and Clint Eastwood and Robert Lansing.
Who else? What's this guy --

1 JOHN: One of the Beach Boys?

2 STEVE: No. I've never met any of those.

3 JOHN: They got into some of this.

4 STEVE: But I met like Peter Lawford. I
5 spent time with him, quite a few of those kind of guys.
6 That was right around '71 and --

7 JOHN: So you didn't hit people up at the
8 airport?

9 STEVE: I never got into the Hare Krishna
10 thing.

11 JOHN: Okay.

12 STEVE: I'm not -- I never had stuck on a
13 robe. I'm talking about a -- I was a partier. I was a
14 guy -- at that time I was not into any religion. I
15 wasn't into anything. I was into good times. I was
16 into knowing a guy that introduced me to so many well
17 known people. I would go to the parties, but after
18 awhile it got to be the same old thing and finally
19 that's when I said I ran into this guy who was planning
20 on being a quarterback and he gave it up all for
21 Eastern philosophy, and that's what more or less
22 started me wondering and looking and comparing. But
23 ultimately I got back with this source called the
24 Bible. I started comparing all the sources, the
25 Buddhist Sutras, the Bhagavad Gita, the Hindus,
Uponashod Savatas (phonetic) you know, all these

1 different so-called holy books.

2 JOHN: Well, the Bible certainly is a
3 powerful work. You know, Madeline Murray O'Hara?

4 STEVE: Oh, I remember her well.

5 JOHN: Her son, you know.

6 STEVE: Right.

7 JOHN: She had raised him to be an Atheist
8 and he started looking into the Bible and he is not an
9 Atheist anymore.

10 STEVE: Correct.

11 JOHN: Even with that strong mother trying to
12 implant those ideas. The Bible defeated that
13 mentality.

14 STEVE: Um-hum.

15 JOHN: So there's no doubt about it. It's
16 still a best seller.

17 STEVE: Well, it is. I mean, it's the only
18 book that really puts up the strongest challenges in
19 the world, like in Isaiah 41. I mean, not to -- you
20 know, it's just to say that this prophet says by the
21 name of God that if you can't show human beings a
22 future, thereby preparing them for the judgment God is
23 going to bring upon mankind in whatever generation, you
24 are nothing and anyone that chooses to use an
25 abomination, this is what it says in chapter 41, so our
challenge is that challenge to the world. There are

1 people sitting in these pews like they're all over the
2 place every Sunday morning for an hour or two hours,
3 going through the yo-yo experience, stand up, sit down,
4 stand up, sit down. Then they go home and live their
5 life. Well, that's not the way Christianity was 2,000
6 years ago in the first place. But in the process, you
7 know, if a man can't prepare an individual clearly to
8 know the answer of their being and where they're going,
9 what God is planning on doing and to be in line with
10 his will, it's all foolishness, especially collecting
11 money off of a human being for something that is to
12 prepare that human being to have a greater, a more
13 quality life, that -- I mean, it's all vanity anyway.
14 I mean, we might as well just, you know, do the best we
15 can as human beings working together to find
16 fulfillment in the here and now. So, I mean, I'd be
17 totally with you, but I'm not. I'm not. I'm a person
18 that -- I'm gambling. I'm gambling and I'm gambling by
19 saying I'm putting all my cards, coins in one place.
20 I'm gambling that this is true and right because I have
21 not had anybody come close to refuting it. I believe
22 in this source because this source consistently deals
23 in the future which becomes the present which becomes
24 the past. So the Bible to me is a whole book of
25 prophesy, even the ceremonial laws, the Ten
Commandments, are seen as prophetic statements and they

1 | can actually be, as the parables and proverbs of
2 | Christ, can be shown how they finally tie into the last
3 | book of the Bible which reveals Christ as somebody.
4 | So, I mean, that's where I am at and in this process,
5 | of course, February 28th happened. It is itself a
6 | reality. I know we're going to come out in God's time.
7 | That could be yet tonight in the middle of the night.
8 | It could be tomorrow. But at the same time, I mean,
9 | I'm waiting on the same God that showed David the very
10 | things I could not controvert from day 1 when I was
11 | living in Honolulu in '86. So, you know, I mean, no
12 | matter what happens for me, it's a day by day decision
13 | and I'll continue to talk to you people and if there's
14 | some new evidences or someone has something that could
15 | change my mind or opinion, you know, that's always a
16 | possibility. But, I mean, after six and a half years
17 | of looking and searching, looking again, talking to men
18 | all over the world, men and women of different rank and
19 | position, I'm at where I'm at. Just because I've seen
20 | men that have talents beyond myself that have quicker,
21 | sharper minds, greater vocabularies, greater memories,
22 | sit down totally mute when David started opening up
23 | material from the Bible and they didn't even have
24 | questions because the material he was -- material was
25 | so beyond their conceptions and thoughts of what they
thought might one day be shown of this so-called God

1 | that the Bible speaks of. I mean, when he's got into
2 | the science, the physics and so forth, which he has
3 | really not on the phone with you people and I've always
4 | kind of wished and wondered why he hasn't because it's
5 | a mind blower. Those are things that you people know
6 | yourself --

7 | JOHN: I'm glad he didn't because this
8 | situation is enough for me right here.

9 | STEVE: I mean, but it's mind boggling,
10 | seriously, John. The question is where is a ninth
11 | grade dropout getting the information that I know for a
12 | fact scientists themselves do not have and it's very
13 | clearly, very logical. It's very believable. It
14 | really is. And there's no question given the time and
15 | the materials, the equipment, one could prove or
16 | disprove whether these -- before they, of course,
17 | they're only a hypothesis. They're theories. But one
18 | can see the probability of those things working as he
19 | shows them. I mean, it's amazing to see when he gets
20 | into light and he starts breaking down matter,
21 | antimatter, the realms of music to sound, how it fits
22 | -- I mean, the whole thing is phenomenal, especially
23 | how this new Jerusalem, the city that has a definite
24 | dimension to it, one day is going to move from a place
25 | out of Orion down to this planet Earth. How does it
 | get here? How is it moved? And he'll get right into

1 | the physics of it, how it moves and so forth. I'm
2 | looking at -- the first time I met him I'm going well,
3 | excuse me, what school did you go to? Was it Oxford,
4 | Harvard, where? He said, well, I dropped out of school
5 | when I was a --

6 | JOHN: I know --

7 | STEVE: -- a freshman.

8 | JOHN: I know a vice president of a company
9 | like that.

10 | STEVE: Really.

11 | JOHN: He dropped out about the sixth grade,
12 | but he read everything he could, you know.

13 | STEVE: Well, David, see, he's not, he's not
14 | a good reader. That's one thing he --

15 | JOHN: Well, he memorized the Bible. I think
16 | that's why he's not a good reader.

17 | STEVE: He really didn't memorize the Bible.
18 | It was like bingo, I --

19 | JOHN: He memorized a couple of chapters, I
20 | think.

21 | STEVE: He just -- he's always had -- I
22 | talked to Perry Jones, you know, the guy that was
23 | killed. Perry was 64, but I got to talk to him
24 | frequently for six and a half years and he told me in
25 | '81 when he came he was just a -- like a stupid kid
that stuttered. He could never make himself

1 | understood. He was never plain. Nobody -- everybody
2 | just took him as off the wall. Seriously. Catherine
3 | Madison who is in jail there where, you know, on that
4 | side, she's in jail. You people can ask her questions
5 | about this human being and she'll tell you the same
6 | thing as she told me, as Perry told me about the person
7 | when he first came. And he was basically that way
8 | until '84 or '85 and bingo overnight, overnight the guy
9 | has no end of knowledge, no end of information,
10 | understanding. He can speak. He can make himself
11 | understood. Why? What happened? What took place?
12 | What very unusual thing happened? Like I think you and
13 | I were kidding there, you know, a couple nights back,
14 | we've got a cure for dyslexia and so forth and those
15 | that have it. Send them over to Jerusalem. But, you
16 | know, I mean, it's a strange phenomena.

17 | JOHN: To Mount Zion.

18 | STEVE: I mean, if you ask his own mother, if
19 | you talk to his own mother, he was a dope. The guy
20 | knew nothing. He couldn't explain anything. He had a
21 | hard time communicating and bingo, all of a sudden
22 | overnight -- she can't --

23 | JOHN: I think he figured out the system, you
24 | know.

25 | STEVE: Is that what you think happened?

 JOHN: Yeah.

1 STEVE: Well, it's beyond me. I haven't
2 heard a real good explanation by any -- I've got -- I
3 had, I had a relative that just died. He was -- in
4 fact, just about a month or so -- a month ago? It's
5 probably a month-and-a-half, two months ago. He was a
6 psychiatrist in southern California. His wife, who he
7 divorced -- they got a divorce about a year or so ago.
8 She was a psychologist.

9 JOHN: Weird.

10 STEVE: Isn't that something?

11 JOHN: Interesting.

12 STEVE: Yeah. And David got to meet the both
13 of them. And I'll never forget my distant uncle
14 because he's not an immediate uncle, the psychiatrist,
15 saying to him, "David, I have three questions for you.
16 Number one," and then he goes through this question and
17 I'm just sitting there observing all this. Yeah. I'm
18 observing the pride of the man, because of his degrees,
19 thinking he's going to figure out and analyze David.
20 So I'm sitting back and viewing all of this and David
21 starts out with an answer to his question and, oh, by
22 the time he is near the end, the second question and
23 the third question that he so-called had are about gone
24 and the look on his face was -- is quite amazing. It's
25 just like myself taking the information David gave me
when I went to London and dealt with so many ministers

1 | that came to put me away verbally and with their
2 | understanding and it didn't happen. All of a sudden
3 | I'm hitting them with more questions and their faces
4 | are red. They're embarrassed. I said, "Good question.
5 | Let's look at the answer," and when they start seeing
6 | chapters and not opinions and theories, what do you do
7 | with that? When you've got also -- there were 40 other
8 | people present and they're all looking at the Bible at
9 | the same time and then they're looking at the -- those
10 | that are asking the questions, they see plainly that
11 | these guys are trying to nail me to the wall, the
12 | spirits that they showed, how they asked the question.

13 | JOHN: Why do people want to do that?
14 | Because they feel insecure or what?

15 | STEVE: I think it's because ahead of time
16 | they think that -- well, they want to show how smart
17 | they really are. You know, these are people with
18 | degrees.

19 | JOHN: Yeah, but the way -- their beliefs,
20 | you know, and then that's a personal property, you
21 | know.

22 | STEVE: Well, not according to Christ.
23 | That's where you're dead -- all you people in this
24 | world that figure or have any knowledge about
25 | Christianity, that's bogus because once knowing Christ
 | you're -- as it says in Acts 2, 3, 4, 5, as Christ said

1 | in John 1 all the way through to the last chapter, in
2 | knowing Christ we're supposed to take every talent we
3 | have to use, to share it with everybody living on this
4 | planet.

5 | JOHN: You can't, you can't share much from
6 | in there, Steve.

7 | STEVE: But do you understand, though, John?
8 | I mean, you totally understand what I'm saying.
9 | Otherwise, you're not a Christian. You're a pseudo-
10 | Christian claiming that you have some kind of a belief
11 | in your heart, in your mind, but that's where it dies.
12 | It dies with you, so it's not something that really
13 | works. It's not, it's not according to the plan of the
14 | living Christ of 2,000 years ago. So this is what I've
15 | been trying to say to those people that have talked to
16 | me saying that's a personal thing. It is if you're a
17 | -- are some kind of a Hindu which has thousands of
18 | denominations and sects within it and you can believe
19 | basically anything you want and still be called a
20 | Hindu.

21 | JOHN: Um-hum.

22 | STEVE: So, but that -- true Christianity as
23 | laid out in the book according to Matthew all the way
24 | through to Jude is not that way at all. But, anyway,
25 | you know, I guess, you know, you're -- you, of course,
 | can make up your own mind but, you know, especially if

1 | it's based upon right information.

2 | JOHN: Yeah. I'll tell you what I'll do.
3 | I'll -- I just finished a novel I was reading. I'll
4 | break out my Gideons when I get off.

5 | STEVE: Sounds good. John, I'm going to tell
6 | the -- I really -- I mean, you'll never know how much
7 | -- I mean, I do like you. I like your character, your
8 | personality. You've been extremely courteous. I mean,
9 | there's been some that have tried other ways of
10 | communication and, and I do appreciate all of them. I
11 | mean, what else can a man do to get another man
12 | following something they believe in, which I do myself,
13 | but it's not the first cause. It's not the first
14 | principle.

15 | JOHN: Well, I think we both believe in a
16 | peaceful resolution.

17 | STEVE: Oh, yes, most -- yes. Never get that
18 | wrong. You know, when the question comes up all the
19 | time about are we going to commit a suicide or will
20 | there be a mass suicide, that has never come --

21 | JOHN: Well, you know what? The problem is,
22 | you know, the Jim Jones and all that kind of stuff, you
23 | know.

24 | STEVE: No, I know. I agree.

25 | JOHN: That's the kind of publicity that
these things get.

1 STEVE: This is true, but --
2 (End of tape 222.)

2 STEVE: The Jim Jones thing, I must admit,
3 when I first met David because of his information I
4 wasn't readily and quickly able to put it away to show
5 that it was faulty or false. One night, I'll never
6 forget, dropping off -- in fact, you've got the one
7 woman incarcerated now -- well, not you necessarily,
8 but Margaret Larson. I would pick her up in my car,
9 she'd get -- she -- I never knew her before -- she came
10 to the same church I was to hear this Marc Breault talk
11 what information that neither one of us got to hear
12 about, and in the process I realized she was an older
13 woman who didn't have a vehicle, so I'd pick her up and
14 take her to hear Marc Breault. And Marc started
15 opening up things that I never learned in all my years
16 of studying theology. And in the process she herself
17 was very -- it was a mind opener. And I'll never
18 forget one night dropping her off and a number of other
19 individuals as I'm driving home to see Judy because
20 Judy was not along, and when I got home Judy was always
21 curious as to what's going on, what do we study, what
22 are we learning? I started -- it was like on my way
23 home a blackness and darkness hit me, John, like you
24 wouldn't believe. I'm going like -- in honesty, I'm
25 driving home. I'm going like this, God -- I dropped
everybody off. I'm going, God, geez, what am I doing?

1 | What if this is another Jim Jones cult and I'm getting
2 | involved in it and I'm pulling innocent people into it?
3 | Then on the other hand I'm going like this, but what if
4 | it's the truth and the Bible has shown through the ages
5 | how God has brought truth and how it's got to stand on
6 | its own merits, and I remembered many of the, the
7 | examples of who brought the truth, how they brought the
8 | truth. I'm going oh, God, what a quandary I find
9 | myself in. It's like being between a hard place and a
10 | rock. I mean, it -- I'll tell you the truth, John. It
11 | was terrifying.

12 | JOHN: I would say we're in a quandary here,
13 | Steve.

14 | STEVE: We are. We are, John. But, I mean,
15 | let me tell you this is what I faced at that time and
16 | I'll tell you what, I mean, I knew that clearly the
17 | only thing I could do at that moment was just get a
18 | good night's rest, wake up refreshed in the morning,
19 | sit down, back up, go over all the information, go
20 | right back to the source that had given me more answers
21 | than any in the Bible, and that's what I did. And over
22 | six months I started to -- when he went back to -- or
23 | when I finally met David and he was in California, this
24 | is when I had the big phone bill. I tried to nail him
25 | down day after day and there was many people like that
to meet and know him, psychologists, ministers, that

1 | came to me with their arguments. So I would lay those
2 | arguments on my phone time and try to nail him down.
3 | It never happened. So ultimately I made a move to
4 | understand and to learn more, but that's why I'm at
5 | where I'm at. That's why these people are at where
6 | they're at now. And this is why it's not an easy thing
7 | to move them away from information that they have seen
8 | and learned and understand now because truly the
9 | principles, the statements -- throughout the Bible it
10 | says fear God, give him glory, for the hour of his
11 | judgment is come, is a reality to us, the judgment
12 | being the truth. We're to judge as man, as men, the
13 | truth that God lays out for this time and if we reject
14 | that truth, one day that truth will destroy us, just
15 | like in the days of Noah. That's why Christ made it
16 | such an important subject matter. The judgments of God
17 | were brought upon a people that -- that beautiful sunny
18 | day -- the world is doing what they wanted to do --
19 | they believe in their gods. They believed in
20 | themselves and all of a sudden an abrupt end comes to
21 | it all.

22 | JOHN: Steve --

23 | STEVE: And then in the final days that's
24 | what we believe is going to happen, John.

25 | JOHN: Are you going to become a teacher?

 STEVE: I am a teacher.

1 JOHN: Well, I know, but I mean you can't be
2 very effective in there.

3 STEVE: But I can be. Do you know why?

4 JOHN: No.

5 STEVE: Because if you gave me the time
6 myself, I would show you a couple of books that show
7 you that this is going to get out contrary to what I
8 choose -- I can walk away. Say you guys gave me
9 immunity or amnesty or whatever else you want to call
10 it and I worked something out with you and I went back
11 to Hawaii, if I threw my hands up, if I quit this thing
12 and said it doesn't work, it's not so, it's nonsense,
13 thank you for the immunity -- I'll tell you the truth,
14 I still -- with me or without me, I truly believe
15 certain things are going to take place. They're going
16 to happen no matter what.

17 JOHN: Yeah. See, nobody's, nobody's asking
18 you to give up anything you believe in --

19 STEVE: No, no, I know that.

20 JOHN: -- or challenging your beliefs.

21 STEVE: No, but part of this is me being in
22 here right now and not leaving as of yet. Part of that
23 is. And I believe that David or myself can show you
24 that clearly, but not unless you really wanted to hear
25 it.

 JOHN: You can't show me from in there.

1 STEVE: But I could. I could say grab your
2 book. I'll have a book right here. Take a little
3 time. Listen very carefully.

4 JOHN: Yeah, but you know, I didn't, I didn't
5 come down here for Bible studies.

6 STEVE: I know you didn't, but then see,
7 that's again, that's where the chasm is between
8 yourself and me, the chasm of a lack of understanding
9 why we haven't come out already, but I know that you
10 would -- by the time I'm done, you would see and
11 understand clearly why I haven't come out yet.

12 JOHN: Yeah, but that's not --

13 STEVE: Bob Ricks would understand and he can
14 make all the, the funny statements. I mean, I -- as a
15 person he's done a halfway decent job. I must admit
16 there's some things that he has said that whatever his
17 purpose, I can't -- I'm not going to judge him because
18 maybe from his perspective he'll do what he can to get
19 us out and into the system he believes, so I'm not
20 going to judge him that way. In fact, he has made some
21 statements that I think are very decent of him, I mean,
22 for us being in here. I can't answer for myself and --
23 but the one thing I know he does not understand is the
24 very things I'm opening up and saying to you, that God
25 will give that opportunity at the right time and place.
And certain things are taking place right now in this

1 | country, in the world. Men, world-wide, mankind is
2 | extremely ignorant. They're going through their
3 | rituals. Their -- all their theories of religion.
4 | God's going to do something that's going to get
5 | thinking people to stop and ask questions. What is
6 | going on?

7 | JOHN: Well, let me ask you a question.

8 | STEVE: Sure.

9 | JOHN: What do you think is going to happen
10 | tomorrow when the attorney calls in, you know, and stay
11 | away from the legal aspects of it, but what's your idea
12 | on that?

13 | STEVE: Well, you know, I don't -- well,
14 | tonight, for instance, it doesn't -- to me it doesn't
15 | matter that I tell you what happens or doesn't, you
16 | know, in conversation with them and us.

17 | JOHN: Well, I just want your opinion.

18 | STEVE: Yeah. Well, my opinion is he's going
19 | to be a disappointed man --

20 | JOHN: Uh-huh.

21 | STEVE: -- because he is, of course -- like
22 | tonight he's searching and trying to grab hold of a
23 | time frame and I keep on telling him --

24 | JOHN: See, the rest of the world's on -- is
25 | on the clock, you know.

 STEVE: I know they are. I know they are.

1 JOHN: And that's -- that causes a lot of
2 frustration I think, you know.

3 STEVE: Do you think I don't understand or
4 see that plainly? If I have any kind of --

5 JOHN: What did you use to do, Steve?

6 STEVE: Pardon?

7 JOHN: What did you used to do for a living?

8 STEVE: What did I used to do for a living?

9 | JOHN: Yeah.

10 STEVE: What -- at what period of time?

11 JOHN: You know, when you got out of school.

12 STEVE: Okay. Well, let's go back to high
13 school.

14 JOHN: Did you have a particular occupational
15 specialty?

16 STEVE: Well, I was one of these guys that,
17 that myself was never -- I was -- I'm a -- number one,
18 I've never believed in astrology even though finally I
19 find that astrology is a counterpart to something that
20 God really has called the massaroth (Phonetic) -- which
21 are twelve --

22 JOHN: Yeah, but Steve --

23 STEVE: No, no let me get into it. Let me
24 get into --

25 JOHN: Yeah, but were you a banker or --

STEVE: No. I wasn't going to go back too

1 far. I was just going to say this, that in astrology
2 you would say my sign is Libra and if you know anything
3 about Libras, they're very indecisive. It's like
4 you're --

5 JOHN: Yeah.

6 STEVE: So in high school --

7 JOHN: Yeah, but were you a banker or car
8 salesman or what?

9 STEVE: No. In fact, when I -- I worked many
10 jobs in high school. Then when I became -- when I was
11 18 years of age I graduated. I have a brother-in-law
12 who's dad owned a pipeline company, a lot of heavy
13 equipment. I'm talking about --

14 JOHN: Oh, so you worked construction stuff?

15 STEVE: For about two, three years, yeah.

16 JOHN: The reason I bring it up is because,
17 you know, I'm talking about the world living on the
18 clock and that's attorneys and that's us and everybody
19 else.

20 STEVE: Oh, I know.

21 JOHN: You know, and we just ask for you to
22 have the consideration to deal with us in that arena.

23 STEVE: And I agree with you, but I -- I'm
24 asking you to take a look at a god that's bigger than
25 the world's system, the world's time table. God's also
got a time table. This is why it says when there's

1 | time no longer, as in Revelation 10:6. Now, that's a
2 | statement --

3 | JOHN: Do me a favor, Steve.

4 | STEVE: That's a statement you don't believe
5 | in but I do, John.

6 | JOHN: Do me a favor.

7 | STEVE: Go ahead.

8 | JOHN: We're not here to challenge my
9 | beliefs. We're here to try to resolve a situation.

10 | STEVE: No. I'm trying -- no, and I'm trying
11 | to resolve -- I'm trying to help you and Rick and
12 | whoever else --

13 | JOHN: Yeah.

14 | STEVE: -- that's going to speak in my behalf
15 | daily.

16 | JOHN: Okay. I'll speak theology and you
17 | think reality. Okay?

18 | STEVE: Okay.

19 | JOHN: And --

20 | STEVE: And my reality is theology. That's
21 | where the problem is.

22 | JOHN: Well, see if you can't get it into a
23 | time frame, all right, and then give me a call? Okay?

24 | STEVE: Are you saying that, that you want to
25 | get off the phone now?

 JOHN: Yeah.

1 STEVE: Okay.
2 JOHN: Okay?
3 STEVE: No problem.
4 JOHN: All right.
5 STEVE: If you want, you call me the next
6 time.
7 JOHN: Okay, Steve.
8 STEVE: Okay.
9 JOHN: All right.
10 STEVE: John?
11 JOHN: Um-hum.
12 STEVE: Hey, take care.
13 JOHN: All right.
14 STEVE: Okay. Bye.
15 JOHN: Bye-bye.
16 (End of conversation.)
17 (Incomplete call -- telephone recorded
18 message, "We're sorry, your call cannot be completed as
19 dialed.)
20 (Dial tone and dialing of number.)
21 (Ringing of telephone.)
22 UNIDENTIFIED BACKGROUND VOICES: "What about
23 you? She said it was a good place.
24 RICK: Yeah, she did -- she said it was -- as
25 a matter of fact I have a menu right out there, if you
want to look at it.

1 (Telephone continues to ring.)
2 UNIDENTIFIED FEMALE: Hello?
3 RICK: Good morning.
4 UNIDENTIFIED FEMALE: Steve will ring you
5 right back. Okay?
6 RICK: Okay.
7 UNIDENTIFIED FEMALE: Thank you.
8 RICK: Thank you.
9 (End of conversation.)
10 (Ringing of telephone.)
11 MARGUERITA: Hello?
12 RICK: Hello. Who's this?
13 MARGUERITA: This is Marguerita.
14 RICK: Hi, Marguerita. How are you?
15 MARGUERITA: Fine, thank you.
16 RICK: This is Rick. Is Steve around there?
17 MARGUERITA: I have to look for him.
18 RICK: Okay.
19 MARGUERITA: Can I ask him -- you want to
20 hold or --
21 RICK: Yeah.
22 MARGUERITA: -- ask him to call you back?
23 RICK: No. I'll just hold on.
24 MARGUERITA: Okay. Just a minute.
25 RICK: Thanks.
STEVE: Hello?

1 RICK: Hello, Steve?
2 STEVE: Yeah.
3 RICK: Hi. This is Rick.
4 STEVE: Rick, good to talk to you.
5 RICK: How are you?
6 STEVE: Not too bad. How's yourself?
7 RICK: Just wonderful.
8 STEVE: Okay.
9 RICK: Couldn't be much better. Mr. DeGuerin
10 sent up a message that we're supposed to coordinate
11 picking up some legal papers with you.
12 STEVE: Right, and we're -- see, the problem
13 has been we, we wanted to type them up so they were
14 easier reading for him --
15 RICK: Uh-huh.
16 STEVE: -- and we've had a problem because we
17 have one typewriter that runs off of batteries and,
18 come to find out, there's no ribbons for it.
19 RICK: Oh, no.
20 STEVE: We have another one that's electric
21 that, of course, we have no electricity so we're trying
22 to hook -- do something with it. There is a manual so
23 we're having -- we were wondering about maybe getting a
24 typewriter in from you people. We gave -- we sent out
25 \$1,000. I don't know if the FBI themselves got it or
if it was sent down with one of the children, but it

1 was to go to you people and to use it as, you know, if
2 there would be needs like for a phone cord, whatever.

3 RICK: I'm not aware of that.

4 STEVE: Yeah. That's -- I'm not sure what
5 happened, but that's what, you know, the instructions
6 were when it was Mark Jones that went out. I believe
7 it was him that \$1,000 was tucked in his pocket. It
8 was -- he was told to give it to the FBI.

9 RICK: Um-hum. I know that, I know that
10 there was word of someone with money coming out,
11 \$1,000.

12 STEVE: Yeah.

13 RICK: It was taken for safe keeping, I
14 believe, but I don't know where it is right now.

15 STEVE: Okay.

16 RICK: I just don't have that knowledge.
17 Somebody does, but I don't.

18 STEVE: It was to be put into your hands,
19 your agency, where, you know, if there things like this
20 that come up it's not a problem like with needing a
21 typewriter to -- you know, it's finally -- you know, I
22 don't know what the attorney's told you, but it's
23 finally come to where, you know, he's had revelations
24 where now the picture's finally coming together as to
25 what's happening, when and all that.

RICK: Oh, good news.

1 STEVE: So -- yeah, and this has a lot to do
2 with it, typing out these seven seals. See, he's never
3 -- he's not a writer. He's not -- since I met him he's
4 never that whole time written anything.

5 RICK: Yeah. Well, you know, that one that
6 Judy sent out was, was relatively easy to read.

7 STEVE: Okay. Well, if you had no problem
8 with that, I mean, it just takes -- you know, it takes
9 a lot longer to handwrite something, of course.

10 RICK: Yeah. The, the one, the one that Judy
11 sent was very clear.

12 STEVE: Okay.

13 RICK: I had no trouble reading it and --

14 STEVE: Well, he wants -- you know, he wants
15 these others in manuscript form so I guess what we'll
16 try to do is somehow or other -- we've got -- now maybe
17 what we could do is we do have a typewriter. I could
18 give you the name of it and all that sort of thing and
19 if we could get ribbons for it.

20 RICK: Well, you know another alternative, do
21 you have any way to make an audio tape? You could just
22 -- he could just speak it in and then we could handle
23 it from there.

24 STEVE: Well, apparently -- I guess it's been
25 worked out where he's going to be sending some kind of
documents or something. I don't know what, but it's

1 | got to be legal, so -- for the attorney I guess to
2 | continue on as his attorney. They left -- you know,
3 | the contracts and so forth.

4 | RICK: Right. Right. I know those were
5 | coming out.

6 | STEVE: Yeah. That's what I'm speaking of.

7 | RICK: Yeah. According to Mr. DeGuerin it
8 | was some legal papers. That's what we were
9 | anticipating.

10 | STEVE: Well, that's what it is.

11 | RICK: The other stuff you all were going to
12 | be working on.

13 | STEVE: Exactly.

14 | RICK: And so it's almost like there's two
15 | separate sets of documents coming out.

16 | STEVE: Yeah.

17 | RICK: Okay.

18 | STEVE: Right. But this here, you know, even
19 | to do it really legally, I guess, we told him we had a
20 | typewriter and all of a sudden we're having problems so
21 | -- but that's --

22 | RICK: Are you saying that the forms he
23 | wanted you to sign you want to type?

24 | STEVE: Well, he had them already typed out
25 | himself --

 RICK: Right.

1 STEVE: -- so I don't know. It's just a
2 little more sloppy having it handwritten I guess for
3 that kind of a thing to retain him and so forth and
4 we're just going to try to put it in the same format he
5 had it in.

6 RICK: Okay. I'm, I'm confused because, see,
7 he -- we've not really talked --

8 STEVE: Well, see, he -- oh, okay. I guess
9 of the details anyway.

10 RICK: Yeah. I don't really know. I don't
11 imagine here really knows. I'm not sure that anybody
12 knows the details because --

13 STEVE: Right.

14 RICK: -- that's the attorney/client thing.

15 STEVE: It's just -- yeah. Well, you know,
16 it's just that, you know, in retaining an attorney, of
17 course, you've got to finally sign something at some
18 point in time.

19 RICK: Right, and that was our -- our
20 understanding was that those were the documents he
21 provided for your signature.

22 STEVE: Right, exactly. And we just wanted
23 to make some changes so, of course, see, we were
24 expecting that he was going to get in here one last
25 time, that he would take care of that, but obviously he
not being in here we're going to have to try to do that

1 --

2 RICK: Did you tell him that you needed to
3 make changes to it?

4 STEVE: Yeah, we did tell him that and he
5 says, "Well, then you do that and," -- we told him we
6 had a typewriter, though, and he says, "Put it in the
7 envelope and seal it and send it on today."

8 RICK: Right.

9 STEVE: And he told us, of course, what to do
10 --

11 RICK: Right.

12 STEVE: -- for that aspect.

13 RICK: And so you're saying that you can't
14 make the changes because you want to type them and you
15 can't get the typewriter to work?

16 STEVE: Well, I would imagine, I would
17 imagine we could, Rick, but it just wouldn't be, you
18 know, as professional. It wouldn't probably be, you
19 know, the kind of thing that you normally stick on
20 file, I guess, but --

21 RICK: Yeah. See, because I know that Mr.
22 DeGuerin was waiting on it.

23 STEVE: Yeah. Okay.

24 RICK: That's why we were calling. I don't
25 -- to be honest with you, I'm not sure that it matters
--

1 STEVE: Okay.

2 RICK: -- whether or not it's, you know,
3 neatly written versus typed.

4 STEVE: Right. Well, see, even myself, I'm
5 not even done with the -- my -- well, like Wayne Martin
6 and myself both are working on, you know, also some
7 documents here that are for like Zimmerman and he's
8 going to have somebody retained and I'm still not happy
9 with what was offered to me, so I still need to really
10 look it over and, you know, of course, they want it
11 done yesterday.

12 RICK: Yeah. Sure.

13 STEVE: And I just want to make sure I'm not
14 getting myself stuck in something I can't afford or I'm
15 going to get myself in no end of trouble later.

16 RICK: Right. I, I understand what you're
17 saying.

18 STEVE: I mean, you know, one does not want
19 to sign -- I mean, it's one thing going through this
20 system, it's another thing to sign your life away for
21 decades to come.

22 RICK: Yeah. I guess our only concern was
23 that -- I know you have your dailies at 3:00.

24 STEVE: Yeah.

25 RICK: And at Mr. DeGuerin's request we had
the Bradley kind of --

1 STEVE: What time do you have there, Rick? I
2 don't even have my watch on.

3 RICK: It's 2:00, a little after 2:00.

4 STEVE: I didn't --

5 RICK: 2:05. And at Mr. DeGuerin's request,
6 you know -- because basically he just comes out and
7 says okay, we have ³- I have legal papers that I need,
8 attorney/client.

9 STEVE: Yes, he's right.

10 RICK: And so can you have a Bradley standing
11 by because in an hour we're going to pick them up and
12 we said okay, fine, so we've kind of had the guy
13 standing by and, and that's -- and that was why I'm
14 trying to mentally work this out --

15 STEVE: Right.

16 RICK: -- logistically because --

17 STEVE: Right.

18 | RICK: -- this is kind of a --

19 STEVE: I was thinking, too, like you said, I
20 think what we'll be doing is later on we, you know,
21 like -- well, in the next day or so I was going to send
22 out, see, some videos, but I guess they're not so
23 important now of like the condition of David and those
24 that were wounded and --

25 RICK: Okay, fine.

STEVE: -- of some of the other people in

1 | here but, of course, I never got that, that battery
2 | pack of mine, the one I originally owned. It's good
3 | for six hours.

4 | RICK: It's my understanding we went ahead
5 | and sent that back --

6 | STEVE: No, it never came back.

7 | RICK: -- we fired it up and sent it back.

8 | STEVE: No, you never sent it back. No, I, I
9 | even sent out the, the charging unit that goes to that
10 | battery, the whole thing where you just plug it in the
11 | wall and --

12 | RICK: I remember, I remember you sending it
13 | out. I had thought it went back.

14 | STEVE: No. A small one that they bought and
15 | sent to me came back, but it was not the original one
16 | with the camera.

17 | RICK: Um-hum. Okay. Well, we had sent in a
18 | roughly fresh battery it seems to me when that last
19 | video. Did you already use that one up?

20 | STEVE: Yeah. You know, that thing only
21 | lasted ten minutes? See, it's -- in fact, that, that
22 | was the problem the first time. I don't know why but
23 | it lasted about like -- the first time it lasted like
24 | 20 minutes. The second time it lasted about ten and
25 | that's the only one that was sent back. But I sent out
-- that was one that you guys bought, sent in. I had

1 | my own two besides that. There's actually two here,
2 | but one did not fit the camera so I had Graham -- I
3 | says, "Can you stick some wires to the contact points
4 | of the camera," and I just had to stationary the thing
5 | to the tripod when I was taking some of those pictures.

6 | RICK: Um-hum. I see.

7 | STEVE: See? So I mean and then that thing
8 | went, of course, dead. None of those small ones seem
9 | to be -- you know, they're supposed to be good for one
10 | hour, but --

11 | RICK: Right.

12 | STEVE: -- they're rarely making it to even a
13 | half-hour and I'm not even going back and reviewing,
14 | you know, what I'm taking. So, you know, I just don't
15 | want to use up any juice.

16 | RICK: So what -- so I'm clear, so what do we
17 | have trying to take place now?

18 | STEVE: You have at least -- you've got two
19 | of those right now, the original one that slides. It's
20 | a little bitty unit that's good for an hour and then
21 | there's a heavier thing that's like about six inches
22 | high, about four wide, about maybe another four inches
23 | wide or six inches wide.

24 | RICK: Right.

25 | STEVE: And it's kind of heavy, but it's got
a strap that goes over it that you wear around your

1 waist and you plug it into the camera. Usually it's
2 good for at least four hours. It's supposed to be good
3 up to six, but I've never seen that happen yet. It
4 seems like those batteries are well under what they
5 claim to be.

6 RICK: Well, what I'll do is I'll check on --

7 STEVE: Okay.

8 RICK: -- I'll check on that battery thing
9 because, like I said, I -- my memory may not be real
10 good.

11 STEVE: And let me try to get back to you.
12 I'm still trying to get thing quickly written out, get
13 this contract and so forth and --

14 RICK: Well, where do we stand on that
15 because Mr. DeGuerin is going to want an answer from us
16 and make sure that we're not, we're not dropping the
17 ball.

18 STEVE: Tell him I'm going to call him --
19 yeah. Tell him I'm calling you right back.

20 RICK: Okay.

21 STEVE: I'm going to call you right back and
22 I'm going to see -- actually the truth is I thought it
23 was done already and the person that was supposed to do
24 it -- I don't know how the mixup happened, but I went
25 to get it --

RICK: Okay.

1 STEVE: -- even before the phone call and
2 they hadn't even started. They got caught up in --

3 RICK: Well, just so I know what to tell
4 those folks --

5 STEVE: Just tell them --

6 RICK: -- about the Bradleys and everything.
7 Are we talking about doing this before 3:00?

8 STEVE: See, and tell them we're not going to
9 have all the contracts done, so I mean we're going to
10 just have to give to them what we've got here.

11 RICK: Right. That would be fine.

12 STEVE: Okay.

13 RICK: At least get -- that way --

14 STEVE: Right.

15 RICK: That way Mr. DeGuerin can be working
16 on something and he won't --

17 STEVE: Right. See, there was a few
18 questions that we needed to have answered before we
19 could even get to this place, so it was helpful, you
20 know, to be talking with him today.

21 RICK: Sure. Sure.

22 STEVE: But now that I know more of what I
23 need to do now I can start working on it and finishing
24 it up.

25 RICK: Okay. So let me be clear then.
You're going to give us a call back so that we can get

1 | this --

2 | STEVE: Right.

3 | RICK: -- done before your dailies at 3:00?

4 | STEVE: Exactly. Exactly.

5 | RICK: Okay. And when are you going to be
6 | calling back so I can be back here by the phone?

7 | STEVE: As soon as -- it will be before the
8 | daily, of course.

9 | RICK: Well, are we going to be able to do
10 | this transfer before the dailies?

11 | STEVE: I'm going to sure try. That's why
12 | as soon as I get off the phone -- I mean, I'm running
13 | around here like a chicken with my head cut off.

14 | RICK: All right. Well, give me a holler
15 | back so I don't get in trouble with DeGuerin, all right
16 | --

17 | STEVE: Right.

18 | RICK: -- because he may think that we're
19 | stalling this thing.

20 | STEVE: Right. I understand.

21 | RICK: Okay?

22 | STEVE: Rick, were you the one I talked to
23 | originally from Austin or something like that?

24 | RICK: No. That's a different Rick. I'm --

25 | STEVE: Oh, okay.

 RICK: I'm a different -- but I don't like

1 | being called Rick 2.

2 | STEVE: Oh, no, no. That's fine. That's
3 | fine because, you know, I only talked to the other Rick
4 | I believe once anyway, so --

5 | RICK: Okay, no I'm not, no I'm not the same
6 | Rick.

7 | STEVE: Apparently he's not in the picture
8 | anymore, huh?

9 | RICK: Oh, he's still around, but --

10 | STEVE: Oh, he is?

11 | RICK: -- but we -- he's got other duties.

12 | STEVE: Okay.

13 | RICK: But --

14 | STEVE: Let me get right back to you, Rick.

15 | RICK: Okay.

16 | STEVE: Okay. Thanks. Bye.

17 | RICK: Okay. Bye-bye.

18 | (End of telephone conversation.)

19 | (No telephone ringing prior to this
20 | conversation.)

21 | UNIDENTIFIED VOICE: (Indiscernible) me down
22 | at the T and I'll do it. We'll work it out together.

23 | STEVE: Let's go sit out there together at the T
24 | then.

25 | RICK: It's down that --

 STEVE: Then I'll come back here and get it.

1 RICK: Come on down the road and we'll do it.

2 STEVE: Oh, Rick, I tell you what, I -- no,
3 actually, you know, finally I really feel good about
4 things moving, you know. I do. And --

5 RICK: Well, that's the problem. From this
6 end they don't think they're moving any and these
7 attorneys --

8 STEVE: Well, no. You know, I'm starting to
9 see a picture formed at least, you know, in the last
10 days. It's like I know it's coming because of those
11 first two letters that went out. And then now the
12 attorneys are back and he's -- I just saw the
13 seriousness of what he wants on his part through the,
14 you know, the attorneys and the sums and all that kind
15 of business. That's what's really being, you know,
16 finally worked out and --

17 RICK: Yeah. I'll tell you, Steve, though,
18 I'm having a problem here because I'm --

19 STEVE: They're working on you, aren't they?
20 I know they want it yesterday and --

21 RICK: The attorneys are, the attorneys are
22 really concerned about what the heck's going on here.

23 STEVE: Yeah. Well, we got some archaic
24 problems here. I mean, you know, it looks like we're
25 trying to -- we've got a guy working on this typewriter
as it's being handwritten --

1 RICK: Right.

2 STEVE: -- so if it ends up having to be
3 handwritten, I'm just going to have to, you know.

4 RICK: Well, what do you want me to tell
5 them?

6 STEVE: Well, what should we tell him.

7 RICK: 'Cause they're waiting, because
8 they're waiting. I mean, I got to -- you know, I'll
9 deliver a message for you, but --

10 STEVE: What's the longest they can wait for
11 us? I mean, do they have to be gone now? Can't they
12 wait just an hour or two yet?

13 RICK: Well, I can, I can tell them --

14 STEVE: Hang on one second. One second. Oh,
15 brother. Okay. Here's the daily and no one can even
16 be typing or writing now in the first place.

17 RICK: Well, if you tell --

18 STEVE: It's like the Sabbath.

19 RICK: If you tell me a time, then I will go
20 tell them.

21 STEVE: Okay. Let's go for 5:00.

22 RICK: That you'll have a package out at
23 5:00?

24 STEVE: Yes. Yes.

25 RICK: Okay. And it's going to be the
contract papers?

1 STEVE: Right.

2 RICK: All right. And you'll have it out at
3 5:00? I can tell them that you --

4 STEVE: Yes. It's going to happen. I don't
5 care if they scribble it out with their -- whatever.

6 RICK: Okay. So I can tell them that they,
7 they definitely need to stay until 5:00?

8 STEVE: Right.

9 RICK: And not to leave?

10 STEVE: Right.

11 RICK: Okay.

12 STEVE: Thanks, Rick.

13 RICK: When do you -- when are you -- I know
14 you got to go. When are you going to call us back then
15 because --

16 STEVE: I'm going to call you as soon as I
17 can.

18 RICK: Well --

19 STEVE: Well, you know, somewhere between
20 4:00 and 5:00 just to keep you paced.

21 RICK: Okay. Do -- yeah. Do that for me.

22 STEVE: Okay.

23 RICK: And we will tell them that they need
24 to stay until 5:00. I don't know if they can stay
25 later or not.

STEVE: Okay. Yeah. Do that. I appreciate

1 | that.

2 | RICK: Okay. All right. I'll --

3 | STEVE: There's a lot -- what time are you
4 | going to be around until?

5 | RICK: I'll be around a little while longer
6 | this afternoon.

7 | STEVE: You are, but you're not going to be
8 | like until 6:00 or anything yourself or --

9 | RICK: Well, could be.

10 | STEVE: I wanted to talk to you for a little
11 | while.

12 | RICK: I'd be happy to talk with you.

13 | STEVE: Well, I -- oh, there's so much that I
14 | got to do and a lot of it's to do with this contract
15 | business and, I mean, I've got to do a whole lot of
16 | writing right now myself.

17 | RICK: Yeah. Well, like I said, come on out
18 | and we'll sit down under a tree --

19 | STEVE: Well, that's what I'm trying to do.
20 | I'm trying to get to the place so I can.

21 | RICK: Yeah. I'll buy --

22 | STEVE: Okay.

23 | RICK: I'll buy the first coke.

24 | STEVE: I'm getting thirsty.

25 | RICK: I am, too.

 STEVE: Okay.

1 RICK: All right now.
2 STEVE: Okay. I'll be -- Rick.
3 RICK: Let me -- wait a minute now.
4 STEVE: Okay.
5 RICK: Before you hang up let me be clear
6 what message to give them, that you're going to be
7 calling back between 4:00 and 5:00 --
8 STEVE: Yeah.
9 RICK: -- and you'll have the papers for them
10 at 5:00?
11 STEVE: 5:00, got it.
12 RICK: Okay. I will tell them that.
13 STEVE: Okay. Thanks.
14 RICK: Okay.
15 STEVE: Okay. Bye.
16 RICK: Bye.
17 (End of telephone conversation.)
18 (Telephone ringing.)
19 DWAYNE: Hello?
20 STEVE: Hello.
21 DWAYNE: Steve?
22 STEVE: Yes.
23 DWAYNE: This is Dwayne.
24 STEVE: Dwayne. Yeah, I finally -- this has
25 been a nightmare getting this whole thing done finally.
They're finally done and we had to get him to sign it

1 and couldn't get the guy awake for any reason.

2 DWAYNE: Has he finally signed it?

3 STEVE: Yeah. He finally signed it so we're
4 ready to go.

5 DWAYNE: All right. Is there still daylight
6 outside?

7 STEVE: Yeah.

8 DWAYNE: Okay. So you're ready to send out
9 the package of the contracts and stuff for the
10 attorneys?

11 STEVE: Right.

12 DWAYNE: Okay. Is it one package?

13 STEVE: Yeah, just one.

14 DWAYNE: Okay.

15 STEVE: It will be addressed to Dick because
16 I'm working on that contract. You know, I was trying
17 to help him out, get him taken care of, and I never
18 really got to finish the one I was to work on.

19 DWAYNE: Okay. So it will be only the one
20 for Dick DeGuerin?

21 STEVE: Yeah, just for Dick.

22 DWAYNE: Was there a similar package you were
23 going to give to Jack Zimmerman?

24 STEVE: Yes. And I probably will make it
25 easy. I'll just -- well, I don't know.

DWAYNE: Well, we can do this one of two

1 | ways.

2 | STEVE: Yeah.

3 | DWAYNE: We can -- if it's still daylight
4 | outside -- I'm in the building here and haven't
5 | noticed. We can pick up the package for Dick and get
6 | yours in the morning or wait and pick up both packages
7 | in the morning.

8 | STEVE: Yeah, I think that -- I'm going to
9 | have to sort of look at it. I really -- you know, I
10 | haven't spent the time that I really should have and I
11 | guess I'm going to have to really be careful about the
12 | wording. I'm a little concerned about it.

13 | DWAYNE: Well, why don't we just -- you know,
14 | if --

15 | STEVE: I mean, it's like signing your life
16 | away. You know what I mean? I could be in debt and
17 | hock up to my neck for --

18 | DWAYNE: Yeah.

19 | STEVE: -- fifty years.

20 | DWAYNE: Any concerns or things we could help
21 | you with?

22 | STEVE: So far I guess not. You know, it's
23 | hard because, you know, being like in this situation,
24 | you know, I mean, it's -- really it's the financial
25 | aspect that's the most difficult, you know, making sure
 | that I don't get stuck with something that I can't

1 | handle later.

2 | DWAYNE: Well, you know, maybe some of here
3 | could let you sign a signature loan. We could help you
4 | with that.

5 | STEVE: Well, I'm glad, you know, that you
6 | have mentioned that at least but, you know, I'll look
7 | over the thing real good. I'll send it out and
8 | hopefully, you know, it will be okay to him. I'm going
9 | to make a few changes just to make sure I can handle,
10 | you know, the agreement.

11 | DWAYNE: Yeah. Okay. You're going to make
12 | some changes and initial them?

13 | STEVE: Yeah, for mine, yeah.

14 | DWAYNE: And, of course, that -- and you
15 | don't know whether that would be acceptable?

16 | STEVE: I don't, no. I'm not certain. I
17 | think probably it would be from what I've picked up
18 | already.

19 | DWAYNE: Did David make some changes on
20 | DeGuerin's copy?

21 | STEVE: Yeah. Yeah, he did.

22 | DWAYNE: So Dick will have to look at those
23 | and see if --

24 | STEVE: Yeah, and he was aware of that. I
25 | guess when he got on the phone with him apparently he
 | told him that, but when I was talking with him -- Jack

1 | Zimmerman could hear I think or through Dick DeGuerin,
2 | but I told him I need to look at mine a little more
3 | closely and there's -- I was concerned about a few
4 | different things that were still in there. And he told
5 | me just go ahead and mark it up, initial it and then
6 | send it in.

7 | DWAYNE: Okay. Let me make a suggestion to
8 | you.

9 | STEVE: Okay.

10 | DWAYNE: You know, rather than -- you know,
11 | because you know the logistics of moving things in and
12 | out of the compound are pretty difficult, particularly
13 | as it gets to -- toward dusk and the guys out there get
14 | concerned.

15 | STEVE: Yeah.

16 | DWAYNE: If you want to take time and review
17 | yours and get it ready, my suggestion is you wait -- we
18 | wait until both of them are ready and we can do it, you
19 | know, 8:00 or 9:00 tomorrow morning or 10:00.

20 | STEVE: Are they still there or did they
21 | leave?

22 | DWAYNE: Well, they're still here, but they
23 | just called in and wanted to know what the status was
24 | because I think they're getting ready to leave. Now,
25 | you -- I didn't -- I don't know the content of what you
 | talked to them. If they were going to leave Waco

WAYNE: So I said, "Let me call in and see

~~---~~"

STEVE: See, what the problem with it, I've
~~---~~g on -- what happened, they've had no end of
~~---~~re. They wanted to get one of the
~~---~~or part of the agreement. There's at least
~~---~~to his alone.

WAYNE: Yeah.

STEVE: And to redo any of that, number one,
~~---~~ he had -- he wasn't feeling too good
~~---~~arently he never slept last night and then
~~---~~onking out and he -- I'd ask him a question
~~---~~all asleep right on me while I'm sitting
~~---~~'m going this can't be real.

WAYNE: Yeah.

STEVE: And --

WAYNE: Unfortunately it is.

STEVE: Yeah, exactly.

WAYNE: Let me suggest this, Steve. Let me
~~---~~ack and say I just talked with you, that --

STEVE: Okay.

WAYNE: -- David's is ready to go --

STEVE: Right.

WAYNE: --but yours is not and see what both
~~---~~and Zimmerman's plans were.

STEVE: Okay. Yeah, that's --

1 DWAYNE: And I'll get back to you and tell
2 you either way because I kind of --

3 STEVE: Super.

4 DWAYNE: -- got the impression that they --
5 they said, you know, they were planning on, you know,
6 getting these packages and then leaving tonight to go
7 back to Houston.

8 STEVE: Right.

9 DWAYNE: If only David's is ready and yours
10 isn't, I don't know how they'll want to handle that.

11 STEVE: Otherwise what I'll do is I'll just
12 spend the day and the night working on it and make sure
13 that if they want to take off in the morning -- if they
14 would stay overnight, I would work on it and make sure
15 that it would be ready in the morning.

16 DWAYNE: Okay. At what -- what time would
17 you -- see, what I'm going to do, I'll call Jack back
18 and say here's what Steve said. The package for Mr.
19 DeGuerin is ready to come out.

20 STEVE: Right.

21 DWAYNE: However, the package for you is not.

22 STEVE: Right.

23 DWAYNE: But you anticipate the one
24 presumably will be ready at about such and such a time
25 and tell them that and say what do you want to do and
see --

1 STEVE: Sounds good.

2 DWAYNE: And if they want to wait obviously
3 that's good for you. If they have some other plans,
4 I'll call you back and say here's what they're saying.

5 STEVE: Okay.

6 DWAYNE: Okay.

7 STEVE: Thanks. Dwayne, that's great.

8 DWAYNE: But I want to make sure I've got it
9 clear, that David's is ready to come out.

10 STEVE: Yeah, it is.

11 DWAYNE: Yours is not, but you --

12 STEVE: Exactly.

13 DWAYNE: Okay. Now, if you work on this, do
14 you have any idea about -- you know, can I give them a
15 time, what time it will be ready tomorrow?

16 STEVE: Well, the daily is between 9:00 and
17 10:00 so it has to be the hour before or the hour
18 after. I'd prefer that it be ready at like say 10:05,
19 10:10, somewhere in there.

20 DWAYNE: Well, okay. I mean, whatever time
21 you're saying. I'm just concerned --

22 STEVE: Yeah. Okay. If they can handle it,
23 I'd like -- say, quarter-after-ten would be the best.

24 DWAYNE: Okay. I was just making it -- you
25 know, if they could pick it up like at 8:00 in the
morning and get on the road rather than what -- because

1 | I know you --
2 | STEVE: Right. Well --
3 | DWAYNE: -- I assume you won't be working on
4 | it during the daily, so if it's ready at, you know --
5 | STEVE: Well, I guess I could sit up through
6 | another night. I was -- it's just that I'll be -- I
7 | was up until 5:00 and they got me up like 6:30, so I
8 | had an hour-and-a-half last night.
9 | DWAYNE: Yeah. I understand. But, you know,
10 | that's a decision you make. It's between you and your
11 | attorney.
12 | STEVE: Right. Okay.
13 | DWAYNE: I mean, I'm not trying to push you
14 | either way.
15 | STEVE: Right. Well, just tell them the
16 | circumstances and I'll wait --
17 | DWAYNE: I'll ask him is 10:15 okay?
18 | STEVE: Okay. All right.
19 | DWAYNE: Get his answer and we'll call you
20 | back in 10 or 15 minutes. How's that?
21 | STEVE: Sounds good.
22 | DWAYNE: Okay.
23 | STEVE: Thanks, Dwayne.
24 | DWAYNE: Bye.
25 | STEVE: Okay. Bye.
 | (End of telephone conversation.)

1 (Telephone ringing.)

2 STEVE: Hello?

3 DWAYNE: Hello, Steve. This is Dwayne.

4 STEVE: Yeah, Dwayne. So what do you have?

5 DWAYNE: A couple of things. I talked to
6 Zimmerman. At first as we were getting ready to set up
7 to have the Bradleys move forward, our people said they
8 saw two people, a man and a woman, outside in the
9 courtyard and they see them moving around, gathering
10 water bottles.

11 STEVE: A man and a woman?

12 DWAYNE: Yes. That's what they're seeing
13 right now. So obviously we can't move forward to pick
14 up this package while you have people out there.

15 STEVE: Hold on. Let me go check.

16 DWAYNE: Okay.

17 STEVE: Oh, brother, I hate these kinds of
18 things.

19 DWAYNE: Yeah. Please get them back inside.

20 STEVE: Yeah, I am. I am.

21 DWAYNE: I'll hold, okay?

22 STEVE: Okay. Thanks. Hang on.

23 DWAYNE: All right. (Pause) Yes, Steve?

24 STEVE: Yeah. I just checked. There's no
25 one out there.

DWAYNE: Okay. You sure?

1 STEVE: But they were out there?

2 DWAYNE: Yes.

3 STEVE: Because they're not out -- no one's
4 out there now.

5 DWAYNE: Yeah. I was in talking to -- you
6 know, to the team who's going to move forward to pick
7 this up. They're ready to go and then some of our
8 observers are saying we see a man and a woman out there
9 picking up -- consolidating water jugs.

10 STEVE: Okay. Yeah. I just checked. No
11 one's out there. I'll make sure. I'll --

12 DWAYNE: Well, we're getting conflicting
13 information. Let's do this.

14 STEVE: Okay.

15 DWAYNE: Would you go around because I do
16 remember in listening to past conversations that Greg
17 Jones --

18 STEVE: Yeah.

19 DWAYNE: -- or someone tends to wander out
20 there.

21 STEVE: Yeah, that is true. That has
22 happened.

23 DWAYNE: Let me tell you what happened with,
24 with the attorneys.

25 STEVE: Yeah. Okay.

DWAYNE: Zimmerman needs to leave tonight.

1 STEVE: He does? Okay.

2 DWAYNE: DeGuerin can stay here.

3 STEVE: Okay.

4 DWAYNE: So, you know, we prefer to get both
5 of them out. It was our understanding you were just
6 supposed to sign them. Now, you want to make some
7 changes.

8 STEVE: Right.

9 DWAYNE: And you wouldn't have time to do
10 that within the next 20 minutes?

11 STEVE: No.

12 DWAYNE: All right.

13 STEVE: Because, you know, I'll tell you, it
14 is a long, lengthy thing. It really is. There's like
15 four or five parts to it.

16 DWAYNE: Yeah. Okay.

17 STEVE: And it -- man, I tell you what, you
18 know, I just don't want to make any mistakes --

19 DWAYNE: Well, we would be ready, we would be
20 ready to move forward to pick up the package of David's
21 --

22 STEVE: Okay.

23 DWAYNE: -- once we can get things settled on
24 these people being outside or not. Let me ask you to
25 go check with your people again. I'll --

STEVE: I'll make sure. I'll make for sure,

1 | for a fact.

2 | DWAYNE: Okay. And I'll get off the phone

3 | and go check with our observers and see if we can find

4 | out exactly where they were --

5 | STEVE: Okay. Good.

6 | DWAYNE: -- because until we can get it

7 | resolved --

8 | STEVE: Right. Okay.

9 | DWAYNE -- you know, it will -- this whole

10 | thing will be delayed and if it -- once it gets past

11 | 7:00 --

12 | STEVE: Right. Okay. Do it quickly and I'll

13 | do the same and call me right back because it won't

14 | take me any time at all.

15 | DWAYNE: Okay.

16 | STEVE: Okay. I'll just wait to hear from

17 | you.

18 | DWAYNE: All right.

19 | STEVE: Okay. Bye.

20 | DWAYNE: Bye.

21 | (End of telephone conversation.)

22 | (Telephone ringing.)

23 | STEVE: Hello?

24 | DWAYNE: Steve?

25 | STEVE: Yeah.

 DWAYNE: Dwayne. Okay. I've --

1 STEVE: Everything's clear here for sure.

2 DWAYNE: Yeah. They said they saw the people
3 go back inside.

4 STEVE: Oh, they did. Okay.

5 DWAYNE: Okay. We can talk about the people
6 outside later if we can because if you recall that was
7 the topic of the one previous conversation I had with
8 David. It caused everybody a great deal of concern.
9 And you wanted to know how old I was, right?

10 STEVE: I wanted to know how old you were?

11 DWAYNE: Yeah. You don't remember that?

12 STEVE: I don't.

13 DWAYNE: Well, okay. Okay. We're ready for
14 you to, to send somebody out with that -- with the
15 package for DeGuerin. Now, who will be, who will be
16 bringing that out?

17 STEVE: Okay. Greg Sommers because it's
18 usually him or I, but he's ready.

19 DWAYNE: Okay. We'll be -- great. He's
20 ready to go now?

21 STEVE: Yeah.

22 DWAYNE: All right. Let me get, get the
23 directions very clear.

24 STEVE: Okay.

25 DWAYNE: First of all, again the agreement
that -- you know, when he goes out and he comes back in

1 | he doesn't pick up anything else and bring it back in
2 | the compound. Okay?

3 | STEVE: Right.

4 | DWAYNE: You agree to that?

5 | STEVE: Most certainly.

6 | DWAYNE: Thank you. All right. What we're
7 | going to do is come out, you know, of the door and head
8 | to his left, you know, where the fence is.

9 | STEVE: Okay.

10 | DWAYNE: And go to the -- as he comes out, to
11 | his left down the road until he comes to the edge of
12 | the wire.

13 | STEVE: Go up -- okay. Go down, go to the
14 | edge of the fence, towards the wires, yeah.

15 | DWAYNE: Yeah. Now, he comes out to the
16 | left.

17 | STEVE: To the left, right.

18 | DWAYNE: And just lay it down on the road
19 | right near the edge of the fence there.

20 | STEVE: Okay.

21 | DWAYNE: Just short of -- there's a boat, a
22 | raft, out there?

23 | STEVE: A boat, yeah.

24 | DWAYNE: Yeah. Just -- you know, I think the
25 | wire is between the house and the boat, so just where
 | that wire --

1 STEVE: The raft is between the house and the
2 boat?

3 DWAYNE: No. Don't go outside the wire.
4 Just walk up to the wire, put it down right there.

5 STEVE: Right. No, on the inside of the
6 wire, on the road, right.

7 DWAYNE: Yeah. Okay?

8 STEVE: Right about in the area where the
9 boat is, though, and put it on what, the edge of the
10 road right there?

11 DWAYNE: Yeah. Just put it on the road.

12 STEVE: Okay.

13 DWAYNE: Don't go beyond the wire, though,
14 okay?

15 STEVE: Oh, no, no problem.

16 DWAYNE: Why don't you do this? Why don't
17 you send him out and you and I can just stay on the
18 line.

19 STEVE: Okay. That's fine.

20 STEVE TO GREG: Are you ready to take it out
21 there, Greg? Okay. Can you get it? Just run up
22 there. I know they got it.

23 STEVE: Okay. He's going to get it right now
24 first.

25 DWAYNE: Yeah, okay. I'd prefer to do it
this way. You and I stay on the line just --

1 STEVE: Right. No problem.

2 DWAYNE: -- so people don't get all upset and
3 start pointing fingers at each other.

4 STEVE: Right.

5 DWAYNE: And if you'll tell me when he comes
6 down? If you, if you say he's ready to go out --

7 STEVE: I'll let you know.

8 DWAYNE: And I'll just lean out and tell them
9 to be expecting him. And he'll go out and put it there
10 and then as he comes back in, then the Bradley will
11 move forward and pick it up.

12 STEVE: Okay. So, Dwayne, how long have you
13 been here in Waco?

14 DWAYNE: I've been here quite a long time.

15 STEVE: You have, huh?

16 DWAYNE: I've just been sitting back and
17 listening.

18 STEVE: You have, huh?

19 DWAYNE: Yeah.

20 STEVE: You poor guy.

21 DWAYNE: No. It's been --

22 STEVE: Interesting, huh?

23 DWAYNE: Well, all of us have a job to do.

24 STEVE: Right. So what part of the country
25 are you from?

DWAYNE: Oh, I live now in Denver.

1 STEVE: Oh, you do?

2 DWAYNE: That's where I live. It's not where
3 I'm from.

4 STEVE: I've got a lot of friends in that
5 area. What is it, Loveland also, I think?

6 DWAYNE: Yeah. Loveland is a little north of
7 Denver.

8 STEVE: Right. Boulder, Loveland. I had a
9 friend that has a place in Estes Park. In fact, he's
10 the guy that invented the Water Pik.

11 DWAYNE: Is that right?

12 STEVE: Yeah. He also is the guy that
13 started out -- I think it's called Viadent Toothpaste.

14 DWAYNE: Uh-huh.

15 STEVE: That's his product also.

16 DWAYNE: If he did I'm sure he's got a nice
17 house in Estes Park.

18 STEVE: He has a very nice house, but the
19 only problem with him, he's got tunnel vision. He only
20 can -- he has eight percent, I think, peripheral vision
21 --

22 DWAYNE: Uh-huh.

23 STEVE: -- which is terrible.

24 DWAYNE: Oh, so he's got literal tunnel
25 vision?

STEVE: Yeah, literal. Not even as a joke.

1 The guy, you know, he can't -- he's usually got to hang
2 onto someone and very nice guy, but he can't see too
3 much.

4 DWAYNE: That's too bad. Yeah, because
5 usually you describe people who have kind of figurative
6 tunnel vision.

7 STEVE: Right. That's true.

8 DWAYNE: In fact, it's probably been some of
9 -- one of the underlying topics in many of the
10 conversations you've had with some of our people.

11 STEVE: Well, at least you have a sense of
12 humor.

13 DWAYNE: You got to have it, don't you?

14 STEVE: That's right. That's right.

15 DWAYNE: That's one of the healthiest things
16 one can have.

17 STEVE: So, Denver, how long -- do you like
18 it there then?

19 DWAYNE: Yes. It's a nice place to live.

20 STEVE: I bet. I'm not too crazy about the
21 cold, but I have -- I've spend -- have you ever gone up
22 to Mt. Evans?

23 DWAYNE: Yes.

24 STEVE: You have?

25 DWAYNE: A couple of times, yeah.

STEVE: I actually was --

1 DWAYNE: Before we get too social here, we're
2 waiting to hear -- we have about a 20 -- well, actually
3 only about 10 minutes left.

4 STEVE: Okay. I'm waiting for him to come
5 down. That's why. I don't know --

6 DWAYNE: Yeah. He's going to get lost out
7 there.

8 STEVE: Apparently, I don't know what's going
9 on.

10 DWAYNE: Yeah. Do you want to go check on it
11 because --

12 STEVE: Just a second. Let me do that. Just
13 hold on.

14 DWAYNE: All right.

15 STEVE TO UNIDENTIFIED PERSON(S): Tell you
16 what, check to see what happened to Greg now -- Eugene?
17 Judy (indiscernible), oh, yeah, oh she's down here.
18 What is going on now? I'm -- I'm never -- I don't want
19 to do that (indiscernible) happen again like that. It
20 was to take one hour, it's eight hours later, it
21 doesn't make sense. (Indiscernible)

22 (Long pause.)

23 STEVE: Okay. Dwayne?

24 DWAYNE: Yes.

25 STEVE: Yeah. He's ready.

 DWAYNE: He's at the door with you right now?

1 STEVE: Yes. He's right here and right next
2 to me.

3 DWAYNE: Okay. And you're sure he knows
4 exactly what to do?

5 STEVE: Yes.

6 DWAYNE: Walk out to the left and put it down
7 there.

8 STEVE: Walk out to the left, put it on the
9 edge of the road right before the fence, right in the
10 area of the boat.

11 DWAYNE: Yeah. Inside the fence. The boat
12 is, the boat is outside the fence.

13 STEVE: Yeah. No, no. I don't know -- even
14 know how -- where your guards get out in the first
15 place.

16 DWAYNE: Okay. Go ahead and send him out.

17 STEVE: Okay.

18 DWAYNE: You stay on the line.

19 STEVE: Okay.

20 STEVE TO GREG: Go ahead, Greg. Just leave
21 the door open and I'll stay on the line.

22 BACKGROUND CONVERSATION: Hey, Greg, it's wet
23 out there. Let's put it in a plastic bag.

24 STEVE TO GREG: No. It's not raining.

25 DWAYNE: Okay. Don't --

STEVE: They want to put it in a plastic bag.

1 DWAYNE: No. Don't do anything like that.

2 STEVE TO GREG No. Don't -- it's not. It's
3 okay. Don't worry about it. No. It's okay. Leave it
4 -- no, forget it.

5 DWAYNE: Steve?

6 STEVE: That's my wife.

7 DWAYNE: I know.

8 STEVE: You know how that goes.

9 DWAYNE: I take it --

10 STEVE: No. We don't need to be that --

11 DWAYNE: When too many cooks get in here and
12 start stirring the pot --

13 STEVE: I understand. I understand.

14 DWAYNE: -- things get changed. Is he
15 outside now?

16 STEVE: Yeah, he is.

17 DWAYNE: All right. He's walking down there.
18 He's outside. Okay. Okay. Yeah. See, that's what
19 causes all sorts of consternation when, you know, those
20 of here that are talking to you, the negotiators, say
21 all right, let's do it this way.

22 STEVE: Right. Here, talk to Judy one
23 minute. I just want to keep an eye just to make sure
24 he's doing it right --

25 DWAYNE: Okay. You do that.

 STEVE: -- because I've done it so many times

1 | myself. Hang on.
2 | DWAYNE: Okay. Are you going to put Judy on?
3 | JUDY: Hello?
4 | DWAYNE: Hello, Judy.
5 | JUDY: How are you doing?
6 | DWAYNE: I'm doing fine. My name is Dwayne.
7 | JUDY: Who this? Dawayne?
8 | DWAYNE: Yes. Well, not Dawayne, just
9 | Dwayne.
10 | JUDY: Dwayne?
11 | DWAYNE: Yeah.
12 | JUDY: Oh.
13 | DWAYNE: How's your, how's your finger?
14 | JUDY: Oh, it's pretty good.
15 | DWAYNE: Oh, that's not what I've been
16 | hearing.
17 | JUDY: Who told you it wasn't good?
18 | DWAYNE: Well, someone did in previous
19 | conversations, that, that it --
20 | JUDY: Well, I mean, it's broke all over the
21 | place and it's out of joint, but, you know.
22 | DWAYNE: It's not getting worse?
23 | JUDY: Oh, no, it's not getting worse. It's
24 | getting better.
25 | DWAYNE: It is getting better?
 JUDY: But it's -- you know, it's going to be

1 | a funny finger.

2 | DWAYNE: Yeah. We've heard -- you had heard
3 | that actually there were bone fragments that --

4 | JUDY: Yeah, probably.

5 | DWAYNE: Probably? Meaning that you were
6 | picking them out yourself trying to get them out of
7 | there?

8 | JUDY: Oh. Somebody told you that?

9 | DWAYNE: Yep.

10 | JUDY: I picked out one or two, yeah. That's
11 | good, pick them out.

12 | DWAYNE: You make it sound like such a minor
13 | thing.

14 | JUDY: Well, what are we going to do about
15 | it, huh?

16 | DWAYNE: Well, one thing you can do is get
17 | some, some medical attention.

18 | JUDY: Oh, yeah.

19 | DWAYNE: Is it still infected or --

20 | JUDY: I'd rather wait on God than worry
21 | about my finger, you know, trust in God.

22 | DWAYNE: But isn't one of the basic things
23 | that he helps those that help themselves?

24 | STEVE: Hello?

25 | DWAYNE: Steve?

 STEVE: Yes.

1 DWAYNE: Okay. You've got --
2 STEVE: Okay. Yeah. Everything is -- yeah.
3 And the Bradley's sitting a number of feet away, so I
4 guess they're ready to pick it up.
5 DWAYNE: Okay. Is Greg back in the house?
6 STEVE: Yeah. He's right back in here.
7 DWAYNE: Okay. Sounds like everything's done
8 then.
9 STEVE: Yeah. Everything's ready.
10 DWAYNE: Okay. I tell you what then. Let
11 me, let me go call Mr. DeGuerin back --
12 STEVE: Okay.
13 DWAYNE: -- and what, what I think we'll set
14 up is this, that -- Zimmerman had to leave today.
15 STEVE: Okay.
16 DWAYNE: So we'll pick up the package for
17 DeGuerin.
18 STEVE: All right.
19 DWAYNE: He was supposed to leave, he said,
20 at around 10:00 tomorrow morning.
21 STEVE: Oh, he has to leave about 10:00?
22 DWAYNE: But he was willing -- yeah. He
23 said, I can -- when I said that yours would be ready
24 tomorrow morning, he said, "Well, I can pick it up,"
25 and then I said, "Well." He said, "It would be after
the dailys at about 10:00." He said, "Well, geez, I

1 | was supposed to leave here." It may be better for him
2 | if you could get it out --

3 | STEVE: By 9:00 maybe.

4 | DWAYNE: Yeah, just before the daily. That
5 | would give him time to get here, pick it up --

6 | STEVE: Exactly. Okay.

7 | DWAYNE: -- and then get to his business.

8 | STEVE: Well, let's do that then.

9 | DWAYNE: All right. So you'd like me to tell
10 | him that it would be available at --

11 | STEVE: Right.

12 | DWAYNE: -- what time? 9:00?

13 | STEVE: 9:00.

14 | DWAYNE: Okay. That will give you time to
15 | get it delivered out like this and --

16 | STEVE: Right.

17 | DWAYNE: -- and back for your Bible study

19 | STEVE: Make it about five to 9:00 because,
20 | you know, I don't want to --

21 | DWAYNE: Let's give us -- give us some
22 | leeway. We'll say 8:45.

23 | STEVE: Okay. Sounds good.

24 | DWAYNE: Okay? So you'll be ready to send
25 | somebody out with it at 8:45 exactly as we planned?

 STEVE: Correct.

1 DWAYNE: All right. Let me call him back.

2 STEVE: Okay.

3 DWAYNE: Tell him that and I'll give you a
4 call back and see if there's any change and we'll
5 confirm it.

6 STEVE: Okay. I'll wait to hear from you.

7 DWAYNE: Okay.

8 STEVE: Bye.

9 DWAYNE: Bye.

10 (End of telephone conversation.)

11 (No telephone ringing prior to this
12 conversation.)

13 STEVE: Dwayne?

14 DWAYNE: Yes.

15 STEVE: Okay.

16 DWAYNE: Listen. I think we're about to get
17 that package. I talked to DeGuerin. He's on his way
18 here.

19 STEVE: Okay.

20 DWAYNE: He wanted to confirm what, what was
21 in the package. We know we have the tape from Pablo
22 Cohen. Is that correct?

23 STEVE: No. In fact, there's no tape in the
24 package whatsoever.

25 DWAYNE: I thought Pablo Cohen was supposed
to put a tape in there.

1 STEVE: We never got -- remember, we were
2 waiting on -- in fact, I don't know if it was Zimmerman
3 or DeGuerin. Somebody was going to check, from what I
4 understand, about that battery pack I had that I never
5 got back that was good for four to six hours, and then
6 there was another one. The one that was sent in here
7 the last time was only good for like ten minutes.

8 DWAYNE: Okay. So in this package that you
9 just sent out there's no tape? What is in the package
10 then?

11 STEVE: No. It's the contract that he had
12 and it was the letter that DeGuerin had requested
13 originally that David put in there to him or something
14 of that nature. All it is is paper, you know -- yeah.

15 DWAYNE: Which letters are we talking about?

16 STEVE: I'm not even sure because they handed
17 me -- that sent out the package and he said that he had
18 in there the contracts that he wanted and I guess some
19 letter that he sent to him or something of that nature.
20 I don't know if it's a personal, private letter to him
21 or what.

22 DWAYNE: Okay.

23 STEVE: But I -- he didn't allow me -- I
24 didn't even read it.

25 DWAYNE: Okay. Is David available?

 STEVE: No, he's not. In fact, that's what

1 | took so long was trying to get him even to wake up long
2 | enough to even sign his own contract and then he stuck
3 | whatever it was for a moment there. They went up there
4 | and he stuck it in the --

5 | DWAYNE: So David's asleep now?

6 | STEVE: Yeah.

7 | DWAYNE: I thought he was working on his --
8 | on the manuscript about the seven seals.

9 | STEVE: He was. That's what the difficulty
10 | was. And then finally when I went in there he had
11 | passed out already because he, he stayed up the entire
12 | night. I went to bed like at 5:00 in the morning. I
13 | didn't know. I thought he went to bed at the same
14 | time, but he had never -- he never did. He went right
15 | on through the morning hours.

16 | DWAYNE: Okay. So what you're saying is
17 | you're not sure what's in the package?

18 | STEVE: No. In fact, he said -- I know it
19 | was -- he said it was -- something about a letter to
20 | DeGuerin.

21 | DWAYNE: Okay.

22 | STEVE: And I don't know if it's between them
23 | two working out about the check -- the trust or
24 | something to do with the children. I'm not sure.

25 | DWAYNE: Yeah.

 STEVE: But, you know, it's him and --

1 DWAYNE: Okay. But you're sure that --

20 STEVE: Yeah. I guess I better get a little
21 more into it here so I can have it ready for the
22 morning.

23 DWAYNE: Yeah. What we confirmed is that
24 Zimmerman has authorized DeGuerin to pick up your
25 package.

STEVE: Okay. That's good.

1 DWAYNE: And I told DeGuerin that we had
2 agreed that it would be, you know, ready to be laid out
3 there at 8:45 a.m.

4 STEVE: Okay.

5 DWAYNE: Because by the time we pick it up in
6 the Bradley and get it back and get it all the way here
7 it's going to be at least a half an hour.

8 STEVE: I hope he's not too unhappy about the
9 differences of the amounts. I just -- man, I don't see
10 myself ever being into the kind of money there. Anyway
11 --

12 DWAYNE: Yeah. You know, that's -- you know,
13 I hope that doesn't happen, that if -- if you make too
14 many changes he may not be --

15 STEVE: Well, yeah. I mean, I'm trying --
16 that's what I mean. I'm just trying to be real
17 careful.

18 DWAYNE: Yeah. And I don't know how soon he
19 will get that. I don't know when DeGuerin is going to
20 see him again.

21 STEVE: Okay. I would imagine, being that
22 he's in -- the both of them are in Houston --

23 DWAYNE: How are you, how are you working on
24 this now? Isn't it dark out there?

25 STEVE: Yeah, it is. That's why it's
extremely difficult, so what I'm doing is -- at least

1 | we've got some bright lights around there. I'm going
2 | to be sitting near a window I suppose and just trying
3 | to do the best I can.

4 | DWAYNE: Oh. So you'll be using our lights?

5 | STEVE: Exactly.

6 | DWAYNE: Well, I'm glad we're able to help
7 | you.

8 | STEVE: Well -- great.

9 | DWAYNE: Did you see -- did you think about
10 | perhaps having Martin go over the --

11 | STEVE: Yeah. He's -- I don't know why, but
12 | he doesn't seem to be extremely helpful to me.

13 | DWAYNE: Oh, yeah? The guys are telling me
14 | that Wayne went to Harvard.

15 | STEVE: He did. His strength, though, he's
16 | more of a researcher than he is, I think, a -- I, I
17 | don't know. You know, I've never seen him in a
18 | courtroom situation. I've never -- I've not even spent
19 | that much time with him.

20 | DWAYNE: Well, all I can say from my
21 | perspective, Steve, is that both the guys, Jack
22 | Zimmerman and Dick DeGuerin, seem to be sincerely
23 | interested in just --

24 | STEVE: Right.

25 | DWAYNE: -- getting this thing handled in the
most professional way.

1 STEVE: That's -- you know, I detect that,
2 too, and you know, I mean that does seem good and it's
3 all right. You know, it's just getting some of these
4 things worked out where one doesn't end up paying for
5 the rest of their life.

6 DWAYNE: Yeah, I know. That can be tough.

7 STEVE: So --

8 DWAYNE: You don't even have any assets, I
9 guess, to pledge as collateral.

10 STEVE: No. That's true. Whatever -- I
11 mean, I've not been in this for making money and I have
12 made none and --

13 DWAYNE: But didn't you, didn't you -- I
14 think, as I recall, you and Judy were actually in
15 pretty good shape when you were back in Hawaii.

16 STEVE: Oh, yeah. I mean, there was so much
17 that was going our way, but at the same time she always
18 knew that I was always pursuing religion and once I
19 started looking it over and studying -- it took awhile
20 before she actually looked it over, but I told her not
21 to ever rely on me, of course, that she had her own
22 mind she had to make up and -- but we came to a -- I
23 mean, we always had so much in common anyway. I mean,
24 our likes and dislikes, so she always -- when I first
25 met her, in fact, she's the one that brought up
religion to me.

1 DWAYNE: Oh, yeah?

2 STEVE: Um-hum. But, yeah, it's -- you know,
3 some of these kind of sums are -- man, they're out of
4 my league and just per chance making money off of one
5 thing or another. I mean, it's not a sure thing. In
6 David's, of course, position it's a different story.
7 But, anyway, I guess I better get on this thing and get
8 it finished so there's something to send out in the
9 morning.

10 DWAYNE: Okay. So you understand you'll be
11 -- you know, I'll pass on to Byron that --

12 STEVE: Okay.

13 DWAYNE: -- that the package will be ready
14 and --

15 STEVE: Right.

16 DWAYNE: -- Dick DeGuerin was quite pleased
17 that we had moved the time up from 10:00 to 8:45
18 because it really -- because he had to leave here no
19 later than about 10:00 and --

20 STEVE: Oh, he did? Okay. Yeah. That's
21 good.

22 DWAYNE: -- if he gets it -- you know, if we
23 pick it up at 8:45 it will be at least a half-an-hour
24 to 45 minutes before it gets here and then --

25 STEVE: Right.

 DWAYNE: -- it's, you know, it's then 9:30 so

1 | that will give him just enough -- now, you know, one
2 | thing, you know, he asked us to -- or we need to know
3 | is, is it simply going to be your -- the contract in
4 | there just signed or any other papers or messages in

6 | STEVE: The one -- Judy's got one that's
7 | almost identical. In fact, it is. It's identical
8 | except for the sums are not as high for hers as mine.

9 | DWAYNE: Okay. For Zimmerman?

10 | STEVE: No. Hers is for Levine.

11 | DWAYNE: Oh, you're going to put his in
12 | there?

13 | STEVE: Yeah, because remember they're
14 | partners.

15 | DWAYNE: Oh, okay. So Zimmerman knows?

16 | STEVE: Yeah, Zimmerman and Levine is the law
17 | firm.

18 | DWAYNE: It will be just those two contracts?

19 | STEVE: Exactly.

20 | DWAYNE: Okay.

21 | STEVE: Exactly.

22 | DWAYNE: Okay.

23 | STEVE: Hers is almost -- I guess what I'm
24 | going to do with mine is -- I kind of had it worked out
25 | with him, but then the guy, he came back like a couple
 | days later with -- holy smokers. The sums were not the

1 | same. They were a lot more. So, I mean, it kind of
2 | took me back.

3 | DWAYNE: I wonder if it's kind of like market
4 | interest rates. You know, sometimes you have to get
5 | the deal when you can or they keep going up.

6 | STEVE: Possibly. I think the more they
7 | thought about it and the sensationalism it involved and
8 | all the rest. I don't know. I'm sure that made a lot
9 | of difference. But -- so who do you have there with
10 | you tonight, Dwayne?

11 | DWAYNE: Oh, Deck says hello.

12 | STEVE: Deck says hello.

13 | DWAYNE: Rick says hello.

14 | STEVE: Oh, wow. Rick is still there?

15 | DWAYNE: Yeah. We have a Rick 1 and a Rick 2
16 | now.

17 | STEVE: Oh, that's right. So Rick -- the one
18 | Rick that is there, is he the one from Austin?

19 | DWAYNE: Yeah, that's him.

20 | STEVE: Oh, yeah.

21 | DWAYNE: Okay. He seemed to think that you
22 | didn't think he was a real person.

23 | STEVE: Say what?

24 | DWAYNE: Because he said tell Steve that even
25 | -- because he met your attorney this afternoon.

 STEVE: Oh, he did? Okay.

1 DWAYNE: And he said that, you know,
2 Zimmerman could vouch that Rick surely is, you know, is
3 a true person.

4 STEVE: No. I never had a problem. You
5 know, in fact, Rick -- he seemed to be a very decent,
6 nice individual.

7 DWAYNE: Well, I'm not so sure. And, of
8 course, John 5 is here.

9 STEVE: Okay. Well, you -- at least I've met
10 all these guys, I guess. So that's why I was asking
11 how long they've had you involved in this.

12 DWAYNE: Well, I've been here for quite a
13 time, but I've been sitting back and listening.

14 STEVE: I see.

15 DWAYNE: Sometimes I find out that you
16 understand a great deal more when you listen. That's
17 what my dad used to tell me when I was growing up. He
18 said, "Dwayne, if you're talking you ain't learning."

19 STEVE: That's well -- he couldn't say it any
20 better.

21 DWAYNE: Yeah.

22 STEVE: That's called wisdom, two ears and
23 one mouth. But, anyway -- okay. I'm going to get on
24 this and we'll have it ready in the morning then.

25 DWAYNE: Okay.

 STEVE: So what I'll probably do -- will I

1 | need to maybe give a call just to make sure or --

2 | DWAYNE: Yes. You know, if there's any way
3 | you can get it done earlier, I'm sure it would be
4 | better for DeGuerin, so --

5 | STEVE: Oh, all right.

6 | DWAYNE: You don't have to wait until 8:45.

7 | STEVE: Right.

8 | DWAYNE: You can call in -- you know, we
9 | prefer to do it in the daylight.

10 | STEVE: Yeah.

11 | DWAYNE: So, you know, soon after daylight if
12 | it's ready, you could just call in and we'll start
13 | making -- because it always takes us, you know, some
14 | time to make sure that the team is ready and the guys
15 | are --

16 | STEVE: That's what I wondered.

17 | DWAYNE: -- out there and not, you know, on
18 | the shift or something. Do you have any questions for
19 | us?

20 | STEVE: Not that I can think of right now.
21 | Yes. It seems like, you know, a lot of things were --
22 | you know, in talking with them, quite a few things were
23 | answered and we're actually ourselves getting more
24 | direction as to what's taking place now and more
25 | understanding of this book and more settled into -- I
 | mean, you know, that's what we really needed right

1 along and, you know, everybody is now looking at the
2 final stages of leaving and all the rest.

3 DWAYNE: Well, what's the progress on that?

4 STEVE: Well, you know, I mean, we're talking
5 about it like constantly now and, and we're starting to
6 see our place more in relation to the Bible which we've
7 always believed in.

8 DWAYNE: So you're talking about coming out
9 voluntarily now?

10 STEVE: Oh, we always have. You know, yeah,
11 but now it's more -- you know, I mean, we see more.
12 See, I mean after coming from such distances and such
13 an investment of time and gaining an understanding like
14 we have, it was like there was a little -- something
15 left that was just missing still in pulling together
16 the whole picture by these prophets, so that more or
17 less is happening in the last few days.

18 DWAYNE: That is happening with David?

19 STEVE: Yeah, exactly. Ever since those
20 letters. You know, that first letter that we sent into
21 you people Friday and then the second one Saturday he's
22 had a lot more and to open up how the picture fits
23 together.

24 DWAYNE: Yeah. Well, there's also a letter
25 that he sent to his attorney. Are you aware of the
contents of that one?

1 STEVE: Not -- well, I'm not sure.

2 DWAYNE: But did he tell you what he was
3 saying?

4 STEVE: See, I know that -- I'm not sure
5 because he told me he was even going to write another
6 letter to you people and I don't know if -- what came
7 of that or if he still -- in fact, I was waiting for
8 him to wake up and find out what he was doing because
9 last night or yesterday, I think it was, he was -- he
10 had written a letter and then he decided -- I think, if
11 I remember right, he decided to do a tape and he was
12 going to have me call you up last night and have you
13 pick the tape up which would have been for you.

14 DWAYNE: Um-hum.

15 STEVE: I mean, plural. And then at the last
16 he says, "I don't think they will really listen to it.
17 I don't think they're interested." I says, "Are you
18 sure?" And he says to me, "I think I'll forget it,"
19 and so he ended up -- he didn't do anything with it, so
20 I didn't know, you know, today when he was talking with
21 DeGuerin just what he was doing exactly and I decided
22 to kind of leave him be.

23 DWAYNE: So he hasn't told you? He did not
24 dictate a tape for us, but he authorized DeGuerin to
25 show us or to give us a copy of the letter he wrote to

--

1 STEVE: To DeGuerin maybe.

2 DWAYNE: -- DeGuerin which --

3 STEVE: Okay. Okay.

4 DWAYNE: -- seems to set some sort of time
5 frame here. I just wondered if he shared that --

6 STEVE: Okay. I think I do know what you're
7 talking about because he did mention something. So do
8 you have a copy of -- I think I know what you mean.

9 DWAYNE: Yeah, we have a copy. I don't have
10 it here with me, but I know DeGuerin allowed us to make
11 a copy.

12 STEVE: Yeah. Okay. That's what I was
13 talking to -- I was talking to Rick earlier and --
14 because I had -- he had told me a little bit about it,
15 but I wasn't sure just, you know, what --

16 DWAYNE: I guess I'm asking you is -- what's
17 your understanding of what, what David said in that and
18 with the time frame?

19 STEVE: That about, that about blew me away
20 when I first heard about it myself because it seemed
21 like -- to be the strongest yet as to, you know, coming
22 out and now it's like I can see where he's going, what
23 he's doing. And if you had a copy -- I mean, I wish --
24 if you did, if it's the thing that I think it is, well,
25 then it does deal with a time frame of getting these
seven seals on paper.

1 DWAYNE: Yeah. Well, we do have a copy of
2 that. I --

3 STEVE: Oh, you do? Good.

4 DWAYNE: Well, not me personally.

5 STEVE: Right.

6 DWAYNE: It's the royal "we" just like you're
7 saying you guys plural. I know we were allowed to make
8 a copy of that. I just don't have it here in front of
9 me --

10 STEVE: Right. Okay.

11 DWAYNE: -- and I just wanted to know what
12 your understanding was of --

13 STEVE: Yeah. To me that -- now he's got a,
14 you know, a date in his mind and that that's why he
15 didn't even want to be bothered by DeGuerin at first
16 because it was shown to him apparently to start getting
17 these things written out. He doesn't want to -- once
18 -- see, that's the whole thing. Once he knows what's
19 going on, what's to do, then, you know, he gets -- he
20 does it.

21 DWAYNE: So you're saying he's indicated that
22 he has received some sort of guidance --

23 STEVE: Right, he has.

24 DWAYNE: Did he tell you what the date is
25 that he has in his mind?

 STEVE: No, but I know that he's already

1 | working and doing the very things that he said. You
2 | know, it's not -- that's why he got actually worn out.
3 | I talked to him up until like 5:00 this morning and I
4 | --

5 | DWAYNE: Well, is there some reason why he
6 | wouldn't want to tell you the date?

7 | STEVE: Well, I don't know if he has the
8 | exact date, but I know that it's to be on the
9 | completion of whatever he's working on which seems to
10 | be the showing of the seven seals on paper.

11 | DWAYNE: Yeah.

12 | STEVE: And if you have -- if you didn't have
13 | a copy of that yet or whatever, I think he made some
14 | comments about that, but about how -- I mean, and it's
15 | -- he's talking about all the way through about, you
16 | know, coming out. The whole thing, that letter from
17 | what he showed me and what I saw of it was --

18 | DWAYNE: Oh, so you did see some of the
19 | letter?

20 | STEVE: Well, see, I don't know if he added
21 | -- that's the whole thing. When he got on the phone I
22 | walked away and I don't know if it's just -- see, what
23 | I had, what he gave to me, and the portion I did see
24 | was that he talked about having these seals written
25 | out, sent in and upon doing that, he's walking out.

 DWAYNE: Uh-huh.

1 STEVE: That's what he said.

2 DWAYNE: Okay. He's walking out. What does
3 that -- can I imply that you would walk out with him
4 also?

5 STEVE: Oh, most -- no question about it.

6 DWAYNE: I presume everybody else in the
7 compound --

8 STEVE: Oh, yeah, yeah, for sure. No
9 question.

10 DWAYNE: Yeah. Any reason --

11 STEVE: See, this is what they've been
12 waiting for. It's like -- well, why -- you know, one
13 has sacrificed to a degree their life up to this point
14 of time. We see -- like I was talking to John 4 last
15 night and trying to help him understand one's
16 perspective. But -- and then this morning, like I had
17 spent some time with David and I knew that he was going
18 to be working on something 'here. He kept on bringing
19 -- raising a lot of deep questions in regards to
20 prophets, how they've worked, about Christianity at
21 large, the prophecies relative to the workings of
22 religion in this day, the so-called ministers'
23 shepherds that all the prophets speak about, what
24 they're going to be like in the final days. He raised
25 questions that went deep beyond those surface things I
mentioned and --

1 DWAYNE: Well, look , Steve -- I know you
2 want to get to your paper, but I've got two, two
3 questions I'd like to ask you.

4 STEVE: Okay.

5 DWAYNE: Or actually two things to go over,
6 one a question and one I'd like to go over. Since --
7 you're indicating that things seem to be progressing --

8 STEVE: Um-hum.

9 DWAYNE: -- and that David is -- has at least
10 a time frame in his mind that he's indicated to you. I
11 really want to impress upon you the importance of these
12 rules we have. You know, that -- for example, when the
13 two people were outside this afternoon right when we
14 were trying to pick up the package, those sorts of
15 things, you know, could really screw up something in
16 the final hours and I really want to impress upon you
17 the importance that if -- that no one is to leave the
18 compound unless you call us and say look, somebody
19 would like to come out and do this because, you know,
20 you have the --

21 STEVE: Well, no one has. No one has left
22 the compound.

23 DWAYNE: Well, someone was out right when we
24 were trying to get this --

25 STEVE: Well, see, that's in the perimeter of
the building itself. You know, I mean, that is part of

1 -- there's walls around where they were in.

2 DWAYNE: Yeah, but you're talking about the
3 little courtyard there where they --

4 STEVE: Exactly.

5 DWAYNE: -- climb out a window?

6 STEVE: Exactly.

7 DWAYNE: But that's -- we can't have that.

8 STEVE: Well, there's nothing we can do about
9 that because --

10 DWAYNE: Well --

11 STEVE: -- we've been doing that since Day 1.

12 DWAYNE: Steve, do you remember the first
13 time David heard my voice? It was late one night when
14 somebody was outside and both of you deny anybody was
15 outside and I had to take --

16 STEVE: Did that end up being (Inaudible)
17 Jones or something like that?

18 DWAYNE: I don't know who it was outside.

19 STEVE: Because to this day, to this day I
20 asked everybody. I went from room to room. I went all
21 over this place and everyone denied that they were
22 outside.

23 DWAYNE: Okay. But, see, what applies --

24 STEVE: If you did -- if you saw -- if that
25 -- such a thing happened, there's no way for me --
unless, you know, unless someone did not tell me the

1 truth.

2 DWAYNE: Well, okay. Now we're getting to
3 it. If you recall what I said to David when he -- his
4 voice was rising was either the people in there are not
5 being straight with you or you're not aware of what
6 your people are doing or, or you're lying to us. Now,
7 I can accept that if you're saying that you wouldn't
8 lie to us, then what that certainly implies is that
9 people you're asking, if you are saying were you
10 outside and you've asked everyone, somebody is then
11 lying to you and that's -- I just -- I'm telling you
12 that because I don't want anything to screw something
13 up.

14 STEVE: Well, I must admit I thought that it
15 was just like this business with thinking that there
16 was some kind of a face or a target in the window and,
17 I mean, I went up there and checked it out myself. I
18 mean, there was never anything there at all.

19 DWAYNE: Yeah.

20 STEVE: So -- and in the past there's been
21 those kind of questions also and there was nothing,
22 nothing that really materialized, nothing tangible that
23 was there.

24 DWAYNE: Well, I think what got David kind of
25 screwed in the ceiling is when I made it clear to him
that I wasn't asking if anybody was outside, I was

1 | telling him there's no doubt somebody's out there, just
2 | as --

3 | STEVE: Well, he probably believed these
4 | people that said that, you know, they hadn't been or
5 | weren't.

6 | DWAYNE: Well, then I think the harsh reality
7 | is setting in that some of your people may be deceiving
8 | you.

9 | STEVE: Well, see, there's no way -- like he,
10 | he never goes running around all over the place and,
11 | you know, he never has ever done anything like that,
12 | especially in his condition, the way he's been from,
13 | you know, the beginning.

14 | DWAYNE: Yeah.

15 | STEVE: So -- and what I've always --

16 | DWAYNE: The concern is just about loss of
17 | control and somebody in there doing something --

18 | STEVE: Well, I must admit I've been quite
19 | mad and annoyed like in the case with the person that
20 | went out on the roof without me knowing about it.

21 | DWAYNE: Greg Jones?

22 | STEVE: Yeah.

23 | DWAYNE: Yeah.

24 | STEVE: In fact, even in the beginning when I
25 | was talking with Jim Kavanaugh one night -- I don't
remember if it was the first, second night. It was one

1 of those two nights and we never even got a complaint
2 from you people but, anyway, I was already mad because,
3 I mean, not -- well, who was ever crawling around on
4 the roof and all that, here it was him and everybody
5 here felt like giving him a kick in the butt.

6 DWAYNE: Yeah.

7 STEVE: So --

8 DWAYNE: I can sympathize with your feeling
9 because, as you know, if somebody's outside there and
10 we take action, somebody could get hurt.

11 STEVE: Exactly.

12 DWAYNE: We don't want that. I mean, we
13 would prefer to see everything calm and quiet in there
14 and that's all that we've been trying to do, so I just
15 urge you to do whatever you and perhaps David can to,
16 to get the attention --

17 STEVE: Well, I have, you know, right from
18 the beginning. I get very annoyed when I don't know
19 immediately what's taking place.

20 DWAYNE: Yeah. And little things can do it.
21 Just like as you were getting ready to send the package
22 out, I don't know if Judy or someone else wanted to
23 wrap it in plastic or something like that.

24 STEVE: Right.

25 DWAYNE: You know, when there's movement
between you and us, it has to be clearly and accurately

1 choreographed. We want to know exactly what you're
2 doing and we're going to tell you exactly what we're
3 going to do so there are no mistakes that may interfere
4 with, with this whole procedure. Okay?

5 STEVE: Yeah.

6 DWAYNE: So you'll do what you can to keep
7 people out there because, you know, I've been asked to
8 emphasize to you, particularly if things are --

9 STEVE: Well, you've got to admit after so
10 much time it's not been bad at all. I mean, overall I
11 think we've done pretty well. We've shown you --

12 DWAYNE: Well, I think you --

13 STEVE: -- our good faith and good will.

14 DWAYNE: You seem to be saying that, but, but
15 unfortunately it appears that some of the other people
16 inside are not abiding by your agreements with us. Do
17 you see what I mean?

18 STEVE: Well, if you counted them up, what
19 there might be, if even possible at all, I don't think
20 that you'd even have enough to even -- you know, like
21 on one hand.

22 DWAYNE: Well, I would agree with that. It
23 hasn't been, you know, continuous, but that's the --
24 the concern is that one --

25 STEVE: No. I myself -- no. I agree with
you. I like to know what's going on myself and it's a

1 | very irritating thing to -- like even in the beginning
2 | days. In the beginning days it was really a hard
3 | thing. I don't know if you were around in those first
4 | four or five days, but I would be getting calls. We
5 | would be calling and saying we -- I was -- it was
6 | reported to my by our people that they saw people
7 | crawling around in the fields and I don't know what
8 | all. And Jim Kavanaugh and I can't remember if it was
9 | Gary said that's not true. There's no one out there.
10 | We can assure you. It's positive. They're not there.
11 | And then on the other hand they said they now and then
12 | would see something and we assured them. And so in the
13 | first few, four or five days or whatever it seemed that
14 | there was those kind of problems and as time went on it
15 | seemed to be alleviated. The only thing that has
16 | changed is the encroachment of your people closer,
17 | closer, closer and doing things that are more, of
18 | course, irritating and apparently trying to intimidate
19 | and so, you know, on one hand you -- you're telling me
20 | things as you are. On the other hand you've got guys
21 | that don't be -- that don't -- aren't seemingly under
22 | your control when it comes to operating the Bradleys,
23 | flipping the finger, those kind of things. You know,
24 | it does make you wonder. But the thing about the
25 | courtyard and so forth, you know --

DWAYNE: So you're talking about the

1 | courtyard right there in the middle?

2 | STEVE: Yeah, right in the middle there.

3 | DWAYNE: Yeah. Well, it's important for you
4 | to understand that that's outside the building. I
5 | recognize it's surrounded on three sides.

6 | STEVE: Well, if you would like, and I'm
7 | telling you this as a fact, if you would like, we've
8 | got plywood and we could easily block that off so you
9 | see nothing unless you want to fly over the top and
10 | take pictures.

11 | DWAYNE: Well, I'm not -- no, that wouldn't
12 | suffice. I'm not saying don't block it off so we can't
13 | see it.

14 | STEVE: So what I'm telling you --

15 | DWAYNE: You need to tell your people don't
16 | go outside the compound because --

17 | STEVE: That's not -- we're saying that
18 | that's not outside the compound. That area was meant
19 | to be -- in fact, long before that incident that was an
20 | area where people have gone to privately be in -- get
21 | in some sun. There have always been people that have
22 | believed in having rainwater versus, you know, water
23 | pumped out of the ground. So at the same time I can't
24 | agree to that, nor will I be, nor will he, and if you
25 | want to take measures, all I can tell you is you're
going to have to do what you have to do.

1 DWAYNE: Well, I want you to understand that
2 because --

3 STEVE: But I will agree on one thing. If --
4 you know, if there's going to be a pickup or anything
5 going on like that, I understand what you're saying and
6 I do go along with safety, but if there's someone out
7 there that I'm aware of and -- that's collecting water
8 or something of that nature, or have hung out shirts or
9 whatever, you know, that's something different, but if
10 there are people like yours on the outside coming to
11 pick something up, I can understand that.

12 DWAYNE: Well, you need to realize that the,
13 the people out there on that perimeter, that's there
14 bailiwick and they're concerned about personal safety
15 and control there. And, you know, what they have said
16 is that if people are coming out, they may take action.
17 If there's anything there that --

18 STEVE: They can if they want. You know,
19 they can.

20 DWAYNE: Yeah. Well, I know they can. I
21 mean, sure we can. What I'm trying to do is work it
22 out so that it doesn't happen because those --

23 STEVE: You got to remember --

24 DWAYNE: -- those things happening, I think,
25 could only -- can only serve to exacerbate this whole
incident.

1 STEVE: Well then, you know, keep the -- have
2 those guys keep that in mind as they keep on
3 encroaching and maybe provoking. I -- have them not
4 provoke or do anything of that nature because, on the
5 other hand, like I -- like has been proven to you
6 people over and over again, if anything you've seen
7 smiles out windows, waving and no one's ever even held
8 any kind of an arm in the window or -- not even as much
9 as a broom handle, and that's been that way from Day 1.

10 DWAYNE: Well --

11 STEVE: We've never done anything to even
12 show that we're provoking or anything of that nature,
13 never have, and if anything we've told you how much we
14 like you people and we want to have you see our good
15 side.

16 DWAYNE: I'll have to. I'll have to disagree
17 with your statement. We have seen people in the
18 windows with what appear to be weapons.

19 STEVE: That has never been. That is a fact.
20 It never has been.

21 DWAYNE: It won't do us any good here to
22 argue about that.

23 STEVE: Well, I'm going to tell you I
24 remember in the -- some days back someone called in and
25 kept on asking about some place and spot and I went up
there and checked myself three, four times. It was

1 total nonsense, total, complete nonsense. In fact,
2 that that very spot was a woman's place who, who never
3 -- there is no way. There's no way and that was the
4 only complaint I ever had.

5 DWAYNE: But you said many times there are 90
6 people and it's a very large building and you can't
7 keep track of what's going on.

8 STEVE: That is true, but at the same time I
9 went back and forth and had someone -- others even
10 checked, others.

11 DWAYNE: Which is -- you've also acknowledged
12 to me that you checked with everyone. Like, for
13 example, just recently, this afternoon --

14 STEVE: That would have been the first time,
15 Dwayne, and I'm not, you know, I'm not saying that it
16 couldn't happen like in the case with Jones being on
17 the roof. That, that did surprise me.

18 DWAYNE: Yeah.

19 STEVE: So at the same time, you know --
20 overall, though, I mean, especially on the incident or
21 two that was brought up and you called in on the phone
22 and so forth and checked and rechecked again.

23 DWAYNE: Well see, from my perspective, Steve
24 --

25 STEVE: In fact, I already knew that was not
-- pardon?

1 DWIGHT: From my perspective, you know, when
2 we call and say there's someone outside the compound,
3 it's, it's a fact that we see someone out there.

4 STEVE: But you acknowledge, though, honest.
5 There's a couple guys -- a couple times you've called
6 and if you go back you'll notice that there weren't and
7 they even acknowledged that being so, that they thought
8 that a possibility was. Now, this last time I don't
9 know because, oh, from what you say, if you really --
10 if you had someone, I do wonder because of the Jones
11 thing. That's why, you know, I'm not quick now to say
12 anything about that because I do know for a fact he was
13 out there that one day. I don't know how many days ago
14 it was.

15 DWAYNE: Did the guy step out just to get a
16 cigarette or something like that?

17 STEVE: No. In fact, I -- he -- you know, I
18 asked him about that and, and he was the one that was
19 out there, and he said that there is no way in the
20 world. No one smokes here in the first place.

21 DWAYNE: Well, what was his reason for being
22 out on the roof? I mean, why would he do something
23 like that?

24 STEVE: He's that kind of a person, even long
25 before this incident happened. He'll like -- for
instance, if we're having a study or get together,

1 | he'll go walk outside or, you know, he's always been
2 | like that. I don't know. He's a unique individual.

3 | DWAYNE: Well, that's one adjective you could
4 | apply to him. I guess my concern is that someone like
5 | him or somebody else could do something now in what I
6 | see as the eleventh hour here when things seem to be
7 | getting together.

8 | STEVE: No, and I'm aware of that. That's
9 | why, that's why it's not happened since and that's why
10 | I got all over him myself and says don't ever -- don't
11 | do that again.

12 | DWAYNE: Is there any possibility that any
13 | people are coming outside with weapons?

14 | STEVE: Is there what now?

15 | DWAYNE: Is it possible that these people are
16 | coming outside with weapons?

17 | STEVE: Never. Dwayne, never.

18 | DWAYNE: What have you done with your
19 | weapons?

20 | STEVE: I'm not going to get into that
21 | because in the first place I try to stay -- believe it
22 | or not, I choose, and it might be hard for you to
23 | believe, but to be ignorant of some things here as I
24 | have when I came from California some time ago. Hello?

25 | DWAYNE: Yeah, I'm still here.

 STEVE: Okay. Did you get that?

1 DWAYNE: Yeah.

2 STEVE: Okay.

3 DWAYNE: Well, you know, I want to address a
4 couple of issues with you because, you know, I see
5 things or at least I, like everybody else, am hopeful
6 that this thing is moving to a conclusion and I just --
7 I had to pass this on. Now, what you've told me is
8 that you will not tell the people not to go out in the
9 courtyard and what I'm saying is that the people on the
10 perimeter are saying they consider that outside and
11 they may take action. We're kind of at an impasse
12 here.

13 STEVE: Okay. Well, then that's what I was
14 telling you. I'd be -- it would be nothing for us to
15 put up some plywood and that would take care of that
16 problem.

17 DWAYNE: Well, that --

18 STEVE: Or we could even put a roof over it
19 or whatever.

20 DWAYNE: No, no. That -- I think that would
21 be interpreted as a very negative thing.

22 STEVE: Okay. Then let's -- I think it would
23 be advisable, I would say, to drop the whole thing
24 because we've been there --

25 DWAYNE: Well, we can't drop it.

STEVE: -- we've been there every day, by the

1 way, and the only way you would ever see that is if you
2 fly over or if you come into that -- if you ever come
3 that close, and there are problems, big major problems.

4 DWAYNE: Did you say that no one inside the
5 compound smokes?

6 STEVE: Not that I'm aware of. I've never
7 seen anybody. If they are, it's news to me.

8 DWAYNE: Well, because when John was talking
9 to David the other night and David said he was smoking.

10 STEVE: Oh, I -- well, yeah, you know, he
11 does. I don't. I've never -- that's not something I
12 do.

13 DWAYNE: But you told me nobody in the
14 compound smoked.

15 STEVE: I guess I was thinking about the rest
16 of the people here.

17 DWAYNE: So David is not a major player?

18 STEVE: No. Well, no. He started doing that
19 a couple of years -- I guess I just didn't think about
20 him. I was thinking overall about some of these other
21 people here. I thought you were talking about some of
22 those that like -- I don't know. I was thinking about
23 the guy on the roof and that type of thing.

24 DWAYNE: Uh-huh. Kind of a --

25 STEVE: Dwayne, what are you getting at?

DWAYNE: Well, what I'm trying to say is if

1 | people come outside -- I want to get -- I'm trying to
2 | get some sort of an agreement for you to take some
3 | responsibility for that because I don't want anything
4 | to happen now --

5 | STEVE: Responsibility for what?

6 | DWAYNE: For people coming outside. I mean,
7 | see, you know, we're -- our job is obviously to talk to
8 | you and help work things out here. The people out
9 | there, it's their job to keep that perimeter under
10 | control and I cannot agree to ignore that or agree to
11 | say yes, go ahead and put up plywood. That's totally
12 | unacceptable and I --

13 | STEVE: Okay. Then we will continue as has
14 | been and the -- in the manner we have and as has been
15 | in the last month-and-a-half.

16 | DWAYNE: It's been a month-and-a-half?

17 | STEVE: Probably or pretty close to it.

18 | DWAYNE: Yeah, 46 days I think.

19 | STEVE: Is that what it's been? I don't even
20 | know. It seems in some days -- ways like it's been
21 | yesterday and others like a year.

22 | DWAYNE: Why did you ask --

23 | STEVE: I'm totally -- I'll tell you. I
24 | don't know if you can tell, but I am totally shot. I
25 | mean, after getting an hour, hour-and-a-half, and here
I've got to do this contract still.

1 DWAYNE: Yeah, I know you're working on that.

2 STEVE: And even though --

3 DWAYNE: Do you have guys going out to, to
4 catch the rainwater?

5 STEVE: Pardon?

6 DWAYNE: I mean, do you have guys going out
7 to catch rainwater?

8 STEVE: Oh yeah. Like every -- you know that
9 yourselves. That's nothing new. You fly over with
10 choppers and the airplanes. I've even been out there
11 waving at you guys, you know, so it's nothing new.

12 DWAYNE: Yeah, but why not get the water from
13 the holding tanks that comes from the well??

14 STEVE: One does.

15 DWAYNE: Some people just prefer the
16 rainwater?

17 STEVE: Exactly. You know, some like to
18 actually wash their clothes and everything else in it.

19 DWAYNE: Yeah, okay. Which one do you drink,
20 the well water or the rainwater?

21 STEVE: Isn't this funny the way you guys
22 want to get into -- I really don't care, to be honest
23 with you, if you really do know or don't.

24 DWAYNE: You don't care to be honest with me?
25 Is that what you said?

 STEVE: No. Oh, god.

1 DWAYNE: That's what you just said. Was that
2 a, was that a Freudian slip, Steve?

3 STEVE: I -- who knows? I'm so tired. You
4 guys can take what you want. It doesn't really matter
5 to me. You'll see my old kisser soon anyway.

6 DWAYNE: Well, I hope so. One last question.
7 After David got -- kind of screwed himself into the
8 ceiling when we had the same conversation about people
9 being outside you came back on the phone --

10 STEVE: He screwed himself in the ceiling?
11 I've never -- now, what does that mean? Where are you
12 from, Dwayne?

13 DWAYNE: Right now I live in Denver. I'm
14 from Louisiana.

15 STEVE: Okay.

16 DWAYNE: He --

17 STEVE: It must be a southern --

18 DWAYNE: This is a southern --

19 STEVE: -- colloquial.

20 DWAYNE: He seemed to get very agitated when
21 we were talking about this same topic, the people who
22 were outside. Now --

23 STEVE: As I recall, you hung up on him. Am
24 I right?

25 DWAYNE: Well, yeah, because he got very
angry and he started yelling at me. I will, I will not

1 | yell at anyone and I will not allow anyone to yell at
2 | me. I don't think that's necessary.

3 | STEVE: Well, there's other things that
4 | aren't necessary either and that's being as the world
5 | says --

6 | DWAYNE: The world says?

7 | STEVE: Yeah. We're talking about every day
8 | common occurrences of provocation with using words and
9 | so forth, insults and so forth. It's -- to me it's all
10 | and the same. The same thing, whether you raised your
11 | voice or whether you --

12 | DWAYNE: Have I used any words that have
13 | insulted you?

14 | STEVE: -- whether you're immature enough to
15 | hang up for whatever you consider. I mean, it's a
16 | disagreement.

17 | DWAYNE: Oh, was that your reason for asking
18 | about my age? Do you consider I was immature when I
19 | hung up? Is that what you're --

20 | STEVE: No, that's not the reason. I usually
21 | like to, as yourself, try to understand something about
22 | the person you're speaking with.

23 | DWAYNE: Well, I certainly would like to do
24 | that, but then I'll tell you exactly where I'm coming
25 | from. Each of us, I believe, every day, all the time,
 | is responsible for our own behavior. I will not yell

1 | or raise my voice at anyone and, quite frankly, I will
2 | not accept that from anyone. I don't talk to anybody
3 | like that. So when David was beginning to yell at me,
4 | I simply decided that I was not going to talk with him.

5 | STEVE: The way you -- Dwayne, he would only
6 | talk like that is if you threatened in a veiled manner
7 | or outward manner or if you're using intimidation or
8 | whatever you're using --

9 | DWAYNE: We were discussing --

10 | STEVE: -- or if you, like your men did,
11 | threw the distraction grenades at myself, when it was
12 | you people initiating this line being brought into the
13 | building, of course, that we might communicate. Now,
14 | now, that is something to get angry about, having
15 | immature individuals out of a sandbox in a tin can like
16 | they are doing such a thing as they did. I mean, if
17 | you want --

18 | DWAYNE: As I understand, you --

19 | STEVE: If you want, let's go -- let's review
20 | back the last number of weeks --

21 | DWAYNE: Well --

22 | STEVE: -- to pick up the different insults.

23 | DWAYNE: I'll come back to this, Steve. I'll
24 | take total responsibility, I always do, for my behavior
25 | and my actions, what I say and what I do. I think
that's a fundamental truism that we're all responsible

1 | for our own --

2 | STEVE: I believe, for instance, like Henry
3 | was the one that had told one of our guys first -- I
4 | had spoken with him a number of times. Then finally
5 | Henry spoke with -- I can't remember who.

6 | DWAYNE: That was one of my best phrases,
7 | Steve. It went just right by you there, you know. I
8 | had hoped --

9 | STEVE: Who's laughing in the background
10 | there?

11 | DWAYNE: Well, that's -- obviously it's --
12 | because I think it's an important phrase. I'm trying
13 | to make a point here and I think it -- maybe you are
14 | tired, that it zipped right by you because usually --

15 | STEVE: Yeah, it did zip right by me. I'm
16 | about ready to --

17 | DWAYNE: Yeah.

18 | STEVE: And here I've got a contract. Can
19 | you imagine that?

20 | DWAYNE: Yeah, I know. I think we're back to
21 | that. Remember we said it's more important to listen?
22 | I think you're tired enough that you're not listening.
23 | So, I tell you what, let me let you go.

24 | STEVE: I'm worn -- hey, I'm serious. I am
25 | totally worn out.

 DWAYNE: Let me let you go and then maybe we

1 | can have a more productive talk tomorrow.

2 | STEVE: That sounds more like it.

3 | DWAYNE: Okay. I'll leave you with this.

4 | I'll take responsibility for my behavior and my
5 | actions. I will not raise my voice. I never have.
6 | And I will expect the same in return. Is that
7 | unreasonable?

8 | STEVE: I've always tried to do that, but the
9 | difference being is you have a rotation there that
10 | leaves a change of three people in a day and it's
11 | usually me that you talk to whether it's in the middle
12 | of the night, in the daytime, in the morning.

13 | DWAYNE: How is it that --

14 | STEVE: Isn't that true?

15 | DWAYNE: -- that burden has fallen upon your
16 | shoulders?

17 | STEVE: No. It's just that you've got to
18 | keep that in mind. Otherwise, let's --

19 | DWAYNE: Well, I do. I recognize that,
20 | Steve. We know we've talked to you 95 percent of the
21 | time. That's why I asked how is it that burden has
22 | fallen upon your shoulders? How did that --

23 | STEVE: That would be -- it would seem
24 | because the majority apparently do not want to
25 | communicate with you.

 DWAYNE: Well. But it seems like that should

1 | be -- the burden that you're carrying now should be
2 | handled by David.

3 | STEVE: Here we go again with the
4 | psychologies.

5 | DWAYNE: That's just a simple --

6 | STEVE: I'll tell you what. The next time
7 | he's on the phone you can tell him that.

8 | DWAYNE: Well, I will if he -- if he'll agree
9 | not to yell at me. Think he'd do that?

10 | STEVE: It depends upon what you have to say
11 | to him, what you choose to -- how you might want to --

12 | DWAYNE: Well, we've talked before --

13 | STEVE: -- threaten or tell him or try to
14 | enforce your will upon him.

15 | DWAYNE: I can't -- no one can force their
16 | will upon anybody.

17 | STEVE: See, the difference is he wants to
18 | see you make it. You've got a -- you've going to be
19 | involved in this process of man's law. He's saying
20 | something to you that you can't imagine in your wildest
21 | dreams about you sitting in a judgment of an almighty
22 | God.

23 | DWAYNE: Well, that's --

24 | STEVE: He's -- and so forth and give --

25 | DWAYNE: Yeah, but see, that's not what he
was saying when he got so angry. He wasn't saying

1 | that. He actually started threatening me.

2 | STEVE: There is still certain rights that we
3 | as human beings have and because someone came to murder
4 | me and others in this building, Dwayne, doesn't mean
5 | that all of a sudden me, because I'm choosing to come
6 | out and assist them and still have freedoms taken from
7 | me and go through a process that should never be.

8 | DWAYNE: We all have rights.

9 | STEVE: I know, but --

10 | DWAYNE: And we all have obligations.

11 | STEVE: -- you seem to forget that.

12 | DWAYNE: Yeah.

13 | STEVE: At the same time I still am a human
14 | being and I still -- like in regards to what you've
15 | been saying, there's been many intimidating things that
16 | you people have said and done. There are many threats
17 | that you have made. You encroach more and more and
18 | keep on doing more things and that hasn't helped in
19 | regards to these people coming out. If anything, it's
20 | hindered. Like the sounds and all the rest, if you
21 | think that's causing people to want to come out sooner,
22 | it has the opposite effect on these people. It's like
23 | they want to dig in all the more. It's like, you know,
24 | you're doing that in behalf of God's power to
25 | strengthen these people's faith.

 DWAYNE: But you recognize you guys agreed to

1 | come out way back on March the 2nd and backed off of
2 | that?

3 | STEVE: There's one person that did speak,
4 | didn't they, and that was David in regards to that?

5 | DWAYNE: Yeah.

6 | STEVE: And I was ready and everyone else was
7 | ready. But you've also got to remember there were some
8 | lies that were given to us in those first two or three
9 | days. It was stated about three Bradleys being on the
10 | perimeter, not on the property. I was on the phone
11 | working that out with Jim Kavanaugh. I remember Gary
12 | coming on a few times and David wanted to continue
13 | conversation with Jim Kavanaugh, and at the same time
14 | people right away were in that garage out there already
15 | moving around private property right from Day 1.

16 | DWAYNE: Excuse me. Do you think it will
17 | help us to go over things that happened six weeks ago?

18 | STEVE: It's all part of the same, all part
19 | of the same incidences that are all wrapped --

20 | DWAYNE: Yeah.

21 | STEVE: -- up in the same situation.

22 | DWAYNE: Well, but it's --

23 | STEVE: How are you going to divide any of
24 | these things that you've already done of which trust is
25 | to be based upon?

 DWAYNE: Well, let me, let me address that.

1 Do you realize that it -- and correct me if your
2 understanding is different, that when ATF came in they
3 had an arrest warrant for Vernon Howell and a search
4 warrant for the compound.

5 STEVE: No one here ever knew that.

6 DWAYNE: Well, let me, let me put this to
7 you, that -- had they -- you know, had gunfire not
8 erupted -- now, I'll phrase it in the passive way --
9 that they would have come in. Vernon would have been
10 arrested. They would have searched the compound and
11 nobody else would have been touched.

12 STEVE: That's correct. I believe that.

13 DWAYNE: And if, as I've heard you say ,
14 before, there are no illegal weapons there and the only
15 weapons there were legal weapons, do you recognize that
16 six or seven weeks ago the only person who would have
17 been arrested would have been Vernon Howell? He would
18 have been arraigned and he would --

19 STEVE: Exactly. Exactly.

20 DWAYNE: -- probably be out on bail now.

21 STEVE: Positively.

22 DWAYNE: So do you recognize that you're in
23 there right now, and I've heard you now for a number of
24 weeks say that you never fired a weapon, you never did
25 this.

STEVE: That's correct.

1 DWAYNE: If that is true --

2 STEVE: Which it is.

3 DWAYNE: -- then you have no reason not to
4 come out and say Zimmerman, let's you and I get into
5 the court system and show that you did nothing wrong.
6 Do you recognize that you kind of put yourself in a
7 situation? If what you're telling us and have been for
8 the last seven weeks is true, my question to you is
9 why?

10 STEVE: And as I told you, not you but all
11 these other negotiators from Day 1, I came here with a
12 purpose before February 28 was brought upon us, not by
13 choice but against our freedoms. And irregardless of
14 what man is doing and not doing and the system and its
15 corruption, wherever it might be or lie, at the same
16 time I came here for a higher reason, a reason beyond
17 the scope of mankind. And I choose to know what the
18 will of God is by the book called the Bible and I, and
19 I choose to do that. And because that incident
20 happened, and it's extremely unfortunate that it did,
21 especially for myself and I -- and these people here.

22 DWAYNE: How about for the agents and the
23 other people who were killed?

24 STEVE: Yeah It's too bad that they chose --
25 especially -- I don't know if you heard, but I heard
some information through a certain news sources that

1 | they were advised not to do that and they did it
2 | anyway.

3 | DWAYNE: Well, I think, as you know, when you
4 | get the media involved that often what they're saying
5 | is not -- has not been correct.

6 | STEVE: To tell you the truth, I got to know
7 | Robert Gonzalez somewhat. I mean, one never really
8 | knows one in that short of a period of time, but at the
9 | same time I was there that morning that David made some
10 | statements to him and when he went out, I would have
11 | thought, him being a human being, seeing the people
12 | here, the children, the women, the men and everything
13 | else that something like that would have never been
14 | pursued. I mean, it's a mind blower that such a thing
15 | was approached like it was with men running to the door
16 | grunting and screaming and then firing.

17 | DWAYNE: Hang on, Steve. Let me ask you a
18 | simple question. You've heard of this through the
19 | media. Has the media in your opinion been accurate in
20 | their presentation of this matter?

21 | STEVE: I haven't -- you know, what I've
22 | heard -- I haven't heard much.

23 | DWAYNE: That's a set up question because I
24 | know you and David have both been very angry because
25 | you believe the media has distorted a lot of things
that you've said and done. I guess that's what I'm

1 pointing out to you.

2 STEVE: I don't -- it depends upon, you know,
3 what aspect -- what you're talking about, statements
4 we've made on the phone to you people or what you've
5 given to them by Bob Ricks or Schwein or whoever else.

6 DWAYNE: But there have been
7 misrepresentations and distortions.

8 STEVE: Oh, you know yourself Ricks purposely
9 goes out of his way to do that.

10 DWAYNE: No. I'm not -- I mean by the media.

11 STEVE: Pardon?

12 DWAYNE: I mean by the media.

13 STEVE: Oh, the media will always do that.
14 You know --

15 DWAYNE: Right.

16 STEVE: -- sensationalism sells stories. You
17 and I know that. But at the same time, you know, I'm
18 hoping that -- more than anybody -- we all here hope
19 that there was a video taken from the moment that the
20 trucks and so forth approached the property and -- by
21 the choppers. I hope that there was a -- I mean, that
22 will exonerate everybody here. I mean, I heard where
23 the first shots came from. I didn't see, but I heard.

24 DWAYNE: Okay. I guess that -- those issues
25 have to be resolved in the only method we have which is
through the American justice system which I think --

1 STEVE: And I disagree and I said that, but
2 at the same time we are coming out to face it. We're
3 going to do it. It's got to be.

4 DWAYNE: Which is the best justice system in
5 the world.

6 STEVE: Yeah. And, of course, you know, the
7 whole thing still comes down to I first put -- I put
8 God first over all things and so that's where the
9 problem lie -- has lain in regards to the time element.

10 DWAYNE: Okay.

11 STEVE: So, anyhow.

12 DWAYNE: Well, I'm glad we got that resolved.

13 STEVE: Well, did we? Good. I'm glad.

14 DWAYNE: But I think we've been over this
15 same ground before.

16 STEVE: You know we have.

17 DWAYNE: Let me just leave you with this
18 thought then because I've thought about it many times
19 in the weeks I've been sitting here listening to you
20 talk to everyone else. Each of us is responsible every
21 day for our own behavior. I've seen people attempt to
22 give other people responsibility for their behavior.
23 You know, young kids will do it. You know, he made me
24 do it, somebody made me do that, or even adults --

25 STEVE: No one -- yes. No one made me --

 DWAYNE: -- you made me angry, rather than

1 take responsibility for one's own feelings and
2 emotions. Therefore -- I guess I said I'm leaving it
3 with you, you know. As I said, I'll take
4 responsibility for every word I say to you and David
5 and every action I do. I'm simply suggesting you
6 consider whether or not you are taking responsibility
7 for your behavior or perhaps trying to give David
8 responsibility for yours. You see what I mean?

9 STEVE: No, I really don't. I don't really
10 see what you're saying at all.

11 DWAYNE: Well, maybe we can -- maybe just let
12 that thought ferment, that each of us are responsible
13 for our --

14 STEVE: That's probably what it will do is
15 ferment.

16 DWAYNE: Yeah. Will it turn into beer or
17 what?

18 STEVE: Who's laughing back there.

19 DWAYNE: That's John 5.

20 STEVE: Okay.

21 DWAYNE: You know it. I've been
22 straightforward with you. What other people are
23 listening to your side of the conversation?

24 STEVE: Right now?

25 DWAYNE Yeah.

STEVE: No one is tonight. I'm looking

1 around. In fact, no one is at all. In fact it's extra
2 quiet here.

3 DWAYNE: Typically who's there with you?

4 STEVE: Usually there will be -- it depends
5 upon how the conversation's going, I suppose, or what's
6 been happening through the day, but sometimes there can
7 be anywhere up to three, four, five, six people, and
8 last night when I was talking with John 4 there were
9 two individuals here. I didn't know it because I was
10 sitting in the dark. I didn't even know they were here
11 until I got up to leave and --

12 DWAYNE: But they can't hear our side of the
13 conversation. They can listen to your side?

14 STEVE: No, no. I don't have a speaker
15 phone.

16 DWAYNE: Yeah. I mean, do they listen to
17 your side of the conversation?

18 STEVE: Well, that's all they can. We don't
19 -- you know, the speaker phones we had actually worked
20 off electricity off of, you know, out of a socket.

21 DWAYNE: Um-hum.

22 STEVE: And I think we might have two, three
23 phones that might -- I don't know if they have speaker
24 ability or not. I think they may, but I think it's all
25 the same thing.

DWAYNE: Yeah.

1 STEVE: Those are the phones we tried to use
2 originally even with the electricity and they're always
3 being bumped and all that, so we finally just dispensed
4 with it.

5 DWAYNE: Okay. I'm 45, by the way.

6 STEVE: Oh, you are?

7 DWAYNE: Yeah. You deny -- you say you don't
8 remember asking that, but that's the first thing you
9 came back -- because I understand you 're --

10 STEVE: No. I don't -- I wouldn't doubt it,
11 you know, I mean --

12 DWAYNE: So you were born in '44, so you're
13 about 47 now?

14 STEVE: No, I'm not. I was not born in '44.

15 DWAYNE: You were not born in 1944?

16 STEVE: Where did that ever come from?

17 DWAYNE: I don't know.

18 STEVE: I heard that and I -- in '48.

19 DWAYNE: Maybe it's erroneous information
20 we're getting from the media.

21 STEVE: Hey, I --

22 DWAYNE: You were born in '48?

23 STEVE: I was born in '49.

24 DWAYNE: Well, you're younger than I am.

25 STEVE: Well, sure I am.

 DWAYNE: So now you --

1 STEVE: I'm just a young -- I'm only -- In
2 fact, I'm actually -- I think from my last look I think
3 I'm 21 or 22, somewhere in there.

4 DWAYNE: What's it -- you were born in --

5 STEVE: '49.

6 DWAYNE: When in '49?

7 STEVE: October.

8 DWAYNE: 10/14?

9 STEVE: 10/16.

10 DWAYNE: 10/16/49. Well, you're younger than
11 I am.

12 STEVE: I most certainly am.

13 DWAYNE: And you're implying that I was
14 immature and hung up on someone.

15 STEVE: Well, I couldn't -- Dwayne, I'd never
16 talked to you before and I didn't know who was on the
17 other end, but I was quite shocked when all of a sudden
18 -- I thought David hung up on you, to be honest with
19 you. I didn't know and I says to him well -- I was
20 going to ask him well, what happened? Why did you --
21 what was he saying that -- I was going to ask him why
22 -- what he was saying that he did that to you, and then
23 he says no, you hung up on him. So I says wow, well --

24 DWAYNE: But I want you to know --

25 STEVE: He's getting to be like John Cox.

 DWAYNE: -- as I will, that, you know, that

1 | there's kind of a rule I go by in my relationships with
2 | people, that I am -- try to speak --

3 | STEVE: Well, you don't have to apologize or
4 | --

5 | DWAYNE: There's nothing for me to apologize.
6 | It's just that -- it's just a statement. See, I did
7 | not -- that's -- I'm not apologizing because I didn't
8 | do anything wrong.

9 | STEVE: I know you're not.

10 | DWAYNE: You know, I didn't raise my voice.
11 | I felt he was yelling at me.

12 | STEVE: Don't let me get your goat or
13 | anything.

14 | DWAYNE: I don't have a goat.

15 | STEVE: Well, are you sure?

16 | DWAYNE: No.

17 | STEVE: What do you have now?

18 | DWAYNE: I don't even have a puppy dog.
