I was neglected, and abused in home environment from 5 to 13 years of age violating 1 thru 7, 9 thru 18, and 20 thru 45, of Our Children's Bill of Rights.

I was neglected, and abused in State Hospital, home environment, Juvenile Center, and Children's Home from 13 to 17 years of age violating 1 thru 7, 10 thru 12, 14 thru 18, 21 thru 29, and 31 thru 45 of Our Children's Bill of Rights.

I have since had a stressful Active Military experience.

I have had no consideration from society, because I was forced to bottle my experiences, and feelings to survive.

I have lived through, "Hell On Earth", damned by God Theory from the beginning in this world. I have 2 brothers who were deprived from Our Children's Bill of Rights, and victims of suicide at 29 years of age in 1977, and at 25 years of age in 1980. I have bordered life, and death numerous times myself. I have experienced consort, civil, common law, and plural marriage divorce in an effort to replace my chosen child, and replacements for my unfortunate brothers, I have been buried out of my family of the past, and my family of the future into Our Children's Bill of Rights.

Enclosed for Washington Field Office (WFO) is two copies of USSS Memo, 10/18/84.

On 11/1/84, Special Agent (SA) [redacted], USSS, Louisville Office, was contacted concerning [redacted]. SA [redacted] advises that [redacted] is well known to USSS, Louisville and that a file is currently in an open status for information up dating purpose.

[redacted] suffers from mental and emotional problems which have been documented through local hospitals. He maintains constant contact with USSS, Louisville, telephoning the office approximately four times per day. [redacted] has no record of violence and has never been known to cause harm to another.

[redacted] was interviewed at his home address, [redacted], Louisville, by SA [redacted] within the last two weeks. SA [redacted] states that [redacted] is incoherent most of the time and is incapable of participating in a logical conversation.
