On the above date, ROBERT SCHREIBER, 2911 Arizona Ave., N.W., Washington, D.C. (WDC), telephone 362-5119, telephonically advised that he had been the desk clerk at the HOWARD JOHNSON'S MOTOR LODGE, 2601 Virginia Ave., N.W., WDC, for the past few months. SCHREIBER stated that on April 27th or 28th, subject MC CORD came to the desk at HOWARD JOHNSON'S and asked for a room for "about ten days". When SCHREIBER told him they had no vacancies, subject said that it was imperative that he have a room and produced two one hundred dollar bills as a deposit. Subject was then given a room.

SCHREIBER stated that subject never stayed in the room, but another individual, identity unknown, was always going to and from the room. This unknown individual also picked up the mail for MC CORD at the desk. SCHREIBER stated that there were an unusual amount of long distance phone calls made from subject's room, and the bill for the room was always paid in advance in one hundred dollar bills.

SCHREIBER stated that he is no longer employed at HOWARD JOHNSON'S, but may be reached at his home address.

[REDACTED] advised SA ALBERT N. NENCIONI this date that he is acquainted with FRANK FIORINI, who was one of the subjects of above case.

[REDACTED] FIORINI that he had been a member of the Norfolk, Virginia, Police Department around 1949-1950. He said FIORINI also owned a beer joint at one time called the Cafe Society, but this is now out of business. He also said he believes FIORINI handled call girls during the time he owned the cafe. He also said he believes that FIORINI belonged to the Civil Air Patrol around 1950-1952, and is sure that he had a pilots license. He understood that FIORINI was involved in one of the Cuban invasions but not the Bay of Pigs invasion. [REDACTED] stated that he believed that one time FIORINI was in the Merchant Marine. He could furnish no additional information at this time but would recontact SA NENCIONI when he obtains further information.
