On 6/23/72 Mr. GLENN J. SEDAM, ^{GENERAL} Counsel for Committee For RE-ELECTION OF THE PRESIDENT, ~~residence~~ Committee Headquarters, 1701 Pennsylvania Avenue N.W., WDC, furnished the following information

During late Fall or early Winter 1971, JAMES MC CORD learned t SEDAM was looking for somone to do part time yard work at his (SED residence. MC.CORD told SEDAM he had just the man for him, one of MC CORD's students at Montgomery Junior College.

SEDAM said he hired one JUAN RUIZ, allegedly a Chilean national and a former member of some police ~~depart~~ department in Chile.

RUIZ apparently worked approximately three weekends in March and April 1972 at Mr. SEDAM's residence until \$40.00 in wages had been accumulated. According to Mr. SEDAM, RUIZ was residing with a family in McLean, Virginia. SEDAM made the check payable to DON R. HEATH at RUIZ' instructions ostensibly to enable HEATH to cash the check for RUIZ. The date of check was made was 4/15/72 and RUIZ never worked after that time because he was then employed full time by MC CORD and previously on a part-time basis.

While so-employed, RUIZ according to Mr. SEDAM entered into frequent conversations and asked many questions relating to recent bussing decisions and other political topics of current interest.

Mr. SEDAM voluntarily furnished the above information because of MC CORD's involvement in this case.

Copy of check attached. RUIZ, W/M Latin appearance about 5'7" 150-170lbs, black hair, heavy accent, about 28 yrs old.
