JACK M. BOUMAN SIX HUNDRED LAKE MARTHA ROAD, NORTHEAST, WINTERHAVEN, FLA., WAS REINTERVIEWED ON JUNE TWENTYFIVE INSTANT. BOUMAN FURNISHED CORRESPONDENCE FROM HOWARD HUNT DATED DECEMBER SEVENTYONE MENTIONING A DESIRE TO MEET WITH BOUMAN. BOUMAN ADVISED KNOWS JAMES MC CORD CASUALLY IN CONNECTION WITH HIS CAREER WITH CIA. HE AND MC CORD WERE BOTH ASSIGNED OFFICE OF SECURITY, MC LEAN VA. NO CONTACT WITH MC CORD SINCE NINETEEN SIXTYSIX. BOUMAN STATED MC CORD WAS ADMINISTRATIVE OFFICIAL AND NOT A TECHNICIAN; HOWEVER, HAD SUPERVISED A TECHNICAL SECTION OF CIA. BOUMAN ADVISED HAS KNOWN HUNT SINCE NINETEEN FIFTYTHREE WHEN ASSIGNED TO A PROJECT WITH HIM, HAS DEVELOPED PROFESSIONAL AND PERSONAL RELATIONSHIP AND HOLDS HUNT IN HIGH REGARD. SINCE LEAVING CIA, NINETEEN SIXTYNINE, HAS EXCHANGED CHRISTMAS CARDS. IN DECEMBER

NINETEEN SEVENTYONE RECEIVED NOTE FROM HUNT ON WHITE HOUSE NOTE PAPER STATING HUNT WOULD LIKE TO SEE HIM AFTER CHRISTMAS. HUNT INDICATED JOB POSSIBILITY. ONE DAY LATER RECEIVED LETTER IN ENVELOPE BEARING RETURN ADDRESS OF " ROBERT R. MULLEN AND COMPANY, SEVENTEEN HUNDRED PENNSYLVANIA AVENUE, WASHINGTON, D. C. ". NOTE THEREIN WAS ON MULLEN AND COMPANY NOTE PAPER AND HAD NAME "HOWARD HUNT" PRINTED THEREON. THE NOTE WAS ATTACHED TO JOB PERSPECTUS OF THOMAS C. AMATO, THREE EIGHT ZERO NORTHPOINT COURT, SATELLITE BEACH, FLA. NOTE READ AS FOLLOWS: "JACK, WONDER IF YOU KNOW THIS FELLOW? OR SOMEONE WITH HIS (DEVELOPED SKILLS)? HANG ON TO THIS SO WE CAN DISCUSS WHEN I CALL YOU NEXT WEEK. BEST. (SIGNED) HOWARD". BOUMAN ADVISED AT THAT TIME HE HAD NEVER HEARD OF AMATO. BOUMAN STATED THAT AFTER SECOND NOTE HE WAS CALLED BY HUNT WHO ADVISED HE WAS ASSEMBLING A "CAPABILITY" IN THE SECURITY FIELD AND INDICATED AS ASSOCIATION WITH REPUBLICAN PARTY. HUNT MENTIONED HIS OFFICE IN WHITEHOUSE BUT DID NOT DESCRIBE POSITION. HUNT STATED ROBERT R. MULLEN AND COMPANY WAS A PUBLIC RELATIONS FIRM WITH WHOM HE WAS ASSOCIATED. BOUMAN ADVISED ROBERT R. MULLEN AND COMPANY UNKNOWN TO HIM. AMATO WAS DISCUSSED BRIEFLY DURING THIS CALL AND HUNT REQUESTED BOUMAN TO CONTACT AMATO TO SEE IF HE WOULD

BE INTERESTED IN WORKING FOR SECURITY GROUP HE WAS FORMING.

HUNT DESCRIBED OPERATION AS LEGITIMATE WHEN BOUMAN TOLD HIM THIS WHOLE THING SOUNDED MYSTERIOUS. HUNT INDICATED PROMOTION OF SECURITY STANDARDS OF REPUBLICAN PARTY. BOUMAN ADVISED HE FELT THIS SECURITY PROGRAM CONSISTED OF PREVENTION OF POLITICAL ESPIONAGE EMPLOYEE SCREENING AND FILES SECURITY. BOUMAN FURTHER ADVISED THAT HE FELT HUNT WANTED TO DEVELOPE INFORMANTS, AND THAT HUNT'S VAGUENESS ON THIS MATTER CAUSED HIM TO SPECULATE. A SUBSEQUENT TELEPHONE CALL FROM HUNT SET UP MEETING AT ROOM SIX ZERO FOUR PLAYBOY PLAZA HOTEL FIVE FOUR FOUR FIVE COLLINS AT FOUR THIRTY PM TWELVE TWENTYEIGHT SEVENTYONE AT MIAMI. THIS CORRESPONDED WITH BOUMAN'S VISIT TO HIS DOCTOR IN MIAMI.

BOUMAN STATED GEORGE LEONARD, ON HIS NOTE WRITTEN IN DAY TIMER NOTEBOOK IS UNKNOWN TO HIM AND HE DOES NOT BELIEVE GEORGE LEONARD AND HOWARD HUNT ARE THE SAME PERSON.

BOUMAN ADVISED ENTERING PALYBOY PLAZA HOTEL AND TAKING ELEVATOR BANK ON RIGHT OF ENTRY. HE EXITED ON THE SIXTH FLOOR. HE TURNED TO THE LEFT, WALKED TO THE END OF THE HALL AND ENTERED A SUITE ON RIGHT SIDE OF ALCOVE. HUNT WAS PRESENT WITH AN INDIVIDUAL DESCRIBED WHITE MALE, THIRTYEIGHT TO FORTYTWO YEARS OLD, FIVE FEET EIGHT

TO FIVE FEET TEN INCHES, ONE SIX ZERO POUNDS, BLACK HAIR, RECEEDING. HE WAS WELL DRESSED, HAD THE APPEARANCE OF AN ATTORNEY. HE WAS INTRODUCED TO BOUMAN BY A FIRST NAME HE CANNOT RECALL.

BOUMAN DID NOT QUESTION THE MANS PRESENCE AS HE WAS OBVIOUSLY WITH HUNT. HUNT AND BOUMAN DISCUSSED A NEED FOR SECURITY PROGRAM FOR REPUBLICAN PARTY. HUNT GAVE ACCOUNT OF REPUBLICAN PARTY SECURITY AND STATED AIMS AS OUTLINED ON PREVIOUS TELEPHONE CALL. BOUMAN DID NOT FEEL AT ANY TIME HUNT'S PROPOSAL WAS OTHER THAN LEGITIMATE. HUNT ASKED BOUMAN IF HE MINDED WORKING FOR REPUBLICAN PARTY AND HE ADVISED HE HAD NO POLITICAL PREFERENCE. OTHER THAN BEING A CONSULTANT HUNT WAS VAGUE AS TO THE JOBS' RESPONSIBILITIES

HUNT ADVISED EXPENSES WOULD BE PAID AND A SALARY LEFT OPEN.

AMATO WAS AGAIN MENTIONED AS CRISS AMATO. BOUMAN REQUESTED HUNT CONTACT SOMEONE ELSE CONCERNING AMATO. BOUMAN TOLD HUNT HE HAD TO CONTACT HIS DOCTOR AND WIFE BEFORE COMMITMENT TO WORK FOR HUNT. AGREEMENT WAS MADE TO RECONTACT AT A LATER DATE. THE THIRD MAN NEVER ENTERED THE CONVERSATION.

SUBSEQUENT TELEPHONE CONTACT MADE BY HUNT TO BOUMAN'S RESIDENCE. BOUMAN ADVISED HE INTENDED TO TRAVEL TO WASHINGTON D.C. ON PERSONAL BUSINESS IN THE NEAR FUTURE, AND HUNT TOLD HIM HE WOULD PAY HIS EXPENSES IF HE WOULD COME UP IN JANUARY.

BOUMAN MADE OWN ARRANGEMENTS TO TRAVEL TO WASHINGTON D. C. AND TO STAY AT HAY DASH ADAMS HOTEL.

UPON ARRIVING WASHINGTON D. C. BOUMAN CONDUCTED PERSONAL BUSINESS AND CALLED HUNT THROUGH WHITE HOUSE SWITCHBOARD. HUNT AND MAN WITH HIM IN MIAMI CAME TO THE HAY DASH ADAMS HOTEL AND MET WITH BOUMAN. REHASH OF MIAMI DISCUSSION ENSUED. HUNT STILL VAGUE AS TO POSITION OFFERED BOUMAN AND NEEDED COMMITMENT FROM BOUMAN BEFORE DISCUSSING JOB FURTHER. BOUMAN ADVISED HE CONTINUED TO FEEL HUNT IN LEGITIMATE SECURITY OPERATION.

BOUMAN NOTICED THAT THE THIRD MAN HAD INITIALED CUFFLINKS WHICH DID NOT CORRESPOND TO FIRST NAME GIVEN HIM BY HUNT. HE AGAIN DID NOT ENTER CONVERSATION. AMATO AGAIN MENTIONED TO BOUMAN, BOUMAN REQUESTED TO PERSONALLY CONTACT AMATO. BOUMAN AGREED.

BOUMAN ADVISED HE WOULD CONTACT HUNT LATER CONCERNING POSITION OFFERED. BOUMAN RECEIVED PAYMENT OF FOUR HUNDRED DOLLARS CASH FOR HIS EXPENSES, MONIES PLACED IN PLAIN ENVELOPE IN MAIL SLOT AT

HOTEL. BOUMAN ADVISED THAT A SHORT TIME AFTER RETURNING FROM WASHINGTON D.C. HE CALLED AMATO AND MADE ARRANGEMENTS TO SEE HIM AT HIS HOME.

HE TRAVELED BY AUTOMOBILE TO SATALLITE BEACH WITH A NEIGHBOR WHO HE DESCRIBED AS CONSIDERABLY OLDER THAN HE AND TOTALLY UNAWARE OF THE PURPOSE OF THE VISIT. BOUMAN REQUESTED INDIVIDUAL NOT BE INVOLVED DUE TO SEVERE HEART CONDITION. AMATO ADVISED HE WAS INTERESTED

IN JOB IF IT DID NOT INVOLVE TRAVEL. BOUMAN CALLED HUNT AND ADVISED THAT HUNT COULD CALL AMATO AND SET UP MEETING. BOUMAN LATER RECEIVED CALL FROM HUNT STATING AMATO HAD NOT SHOWN UP FOR MEETING AND HAD TELEPHONICALLY ADVISED HE WAS NOT INTERESTED IN WORKING HAVING JUST PURCHASED A BOAT. ONE ONE ELEVEN SEVENTYTWO BOUMAN SENT HUNT A LETTER ADVISING HE COULD NOT ACCEPT OFFER. ONE ONE FOURTEEN SEVENTYTWO, HUNT SENT LETTER TO BOUMAN EXPRESSING REGRETS THAT BOUMAN COULD NOT ACCEPT POSITION AND MENTIONED QUOTE GEORGE AND I UNQUOTE APPRECIATE THE TROUBLE YOU WENT TO ON OUR ACCOUNT.. BOUMAN FURNISHED COPY OF HIS LETTER AND THE ORIGINAL LETTER FROM HUNT. BOUMAN ADVISED NAMES AND ALL ALIAS' OF ALL SUBJECTS UNKNOWN TO HIM EXCEPT THAT OF MC CORD.

LINDA GERSTON stated that she took special notice of this individual; first because he appeared to be of latin descent and she is also of latin descent and second, she missed a luncheon appointment with a man of latin descent whom she had never met and she thought this individual might be the person whom she was supposed to meet.

LINDA GERSTON described the individual as a caucasien, male, 5 feet 5 inches to 5 feet 6 inches, slight build, mustache, black hair graying, late thirties or early forties, and wearing a dark suit.

Mr. HUNT advised that he is employed on a part-time basis at the White House.

Mr. HUNT advised that he is a member of the Lakewood Country Club and he does possess an account at the First National Bank of Washington and his account number is identical to the one mentioned by Mr. PAUL. Mr. HUNT stated that he did not feel he would make any other statement to SAs PAUL and STUKEY until he had consulted with legal counsel.

Mr. BENNETT stated that Mr. HUNT's duties include preparation of news releases and pamphlets, producing radio and television announcements concerning the hiring of the handicapped, and arranging for radio and television personalities to make appearances on radio and television to promote the hiring of the handicapped.

Mr. BENNETT noted that Mr. HUNT receives \$125.00 a day per diem from the Robert R. Mullen and Company for the handling of this account. Mr. BENNETT explained that Mr. HUNT is on a per diem basis with the company rather than a salary basis because a portion of his time is devoted to his position as a Consultant at the White House and he receives \$100.00 a day per diem for this consulting position. Mr. BENNETT stated that a review of the records of the Robert R. Mullen and Company revealed that EVERETTE HOWARD HUNT has been employed by the firm since May 1, 1970. Mr. BENNETT noted that Mr. HUNT was with the firm prior to his purchase of the company from Mr. MULLEN in 1970.

Mr. BENNETT stated that he was approached by Mr. ROBERT R. MULLEN approximately four years ago concerning the purchase of the Robert R. Mullen and Company. Mr. MULLEN expressed

a desire to retire from the company. Mr. BENNETT stated that at that time he was employed as an Executive in the Public Relations Department of the J. C. Penny and Company, but was dissatisfied with his duties with that company. Mr. BENNETT stated that when he approached J. C. Penny officials concerning the possibility that he might leave the company, he did not receive a favorable response. Mr. BENNETT said that he did not feel that he could leave the J. C. Penny and Company under those circumstances, as an unfavorable recommendation from J. C. Penny officials would be detrimental to a further career in the Public Relations field. Mr. BENNETT stated that through his contact, he was able to receive a presidential appointment as the Congressional Liaison Officer with the Department of Transportation. Mr. BENNETT explained that his primary purpose in seeking this position was to leave the J. C. Penny and Company gracefully and further it would permit him to establish new contacts in the Washington, D.C. (WDC), area. Mr. BENNETT said that he served as the Congressional Liaison Officer with the Department of Transportation for approximately two years. BENNETT stated that he was again approached by Mr. ROBERT R. MULLEN concerning the purchase of the Robert R. Mullen and Company and that he resigned his position with the Department of Transportation in order to purchase the Robert R. Mullen and Company.

Mr. BENNETT stated that Mr. MULLEN arranged a luncheon meeting approximately two years ago to discuss the details of the purchase of the company. Mr. BENNETT said that he was surprised when DOUGLAS CADDY and EVERETTE HOWARD HUNT appeared at the meeting with Mr. MULLEN. Mr. MULLEN explained that DOUGLAS CADDY and EVERETTE HOWARD HUNT had expressed a desire to purchase a portion of the stock of the Robert R. Mullen and Company and he, Mr. MULLEN, felt that they should all get together and discuss this issue. Mr. BENNETT said that he did discuss this matter with DOUGLAS CADDY and EVERETTE HOWARD HUNT, but no conclusion was reached at this luncheon meeting.

Mr. BENNETT explained that one of the principal accounts of the Robert R. Mullen and Company is the General Foods Corpora-

tion, whose headquarters are located in White Plains, New York. BENNETT stated that the General Foods Corporation maintains an office and assigns an employee to the Robert R. Mullen and Company to maintain liaison between the Robert R. Mullen and Company and the General Foods Corporation Headquarters in White Plains, New York. BENNETT stated that DOUGLAS CADDY was at that time an employee of the General Foods Corporation and was assigned to the Robert M. Mullen and Company as the Liaison Officer.

BENNETT stated that subsequent to this meeting with MULLEN, CADDY and HUNT, he exercised his original option for the exclusive purchase of the Robert R. Mullen and Company and completed the negotiations for the purchase of the company with Mr. MULLEN.

Mr. BENNETT stated that during this period of negotiations for the purchase of the company, both the Robert R. Mullen and Company and the General Foods Corporation found DOUGLAS CADDY's performance to be unacceptable and Mr. CADDY was released from his position by the General Foods Corporation. BENNETT stated that through a contact, Mr. MULLEN arranged for DOUGLAS CADDY to obtain a position as an attorney with the law firm Gall, Lane, Powell and Kilcullen, Suite 707, 1250 Connecticut Avenue, N.W., WDC. Mr. BENNETT noted that DOUGLAS CADDY had left the Robert R. Mullen and Company before he assumed the duties as President of the company.

Mr. BENNETT stated that he knows that Mr. HUNT has maintained a personal relationship with Mr. CADDY as Mr. CADDY has called the Robert R. Mullen and Company offices on several occasions requesting to speak to Mr. HUNT.

Mr. BENNETT stated that he last saw EVERETTE HOWARD HUNT on June 19, 1972, and Mr. HUNT made no reference to the burglary of the Democratic National Headquarters on June 17, 1972.

Mr. BENNETT stated that he read in the news articles concerning Mr. HUNT in "The Washington Post" on the morning of

12 June 20, 1972, and he subsequently received a long distance
