On 6/26/72, SA JOHN E. DENTON and J. CARLTON BURELL had scheduled interviews at the Committee to Re-elect the President, 1701 Pennsylvania Avenue, N.W. Upon arriving at the committee, the agents were informed by ROBERT C. ODLE, Personnel Coordinator for the committee, that from this point on all interviews conducted at the Committee to Re-elect the President must be conducted in the presence of an attorney from the Council for the Committee to Re-elect the President.

On 6/26/73, Security Coordinator, Mr. ROBERT HOUSTON, and the Council for the Committee to Re-elect the President, Mr. GLENN SEDAM were interviewed in the presence of H. DONALD KISTLER, an attorney with the firm of Jackson, Gray, and Lasky, located at 1828 L Street, N.W., WDC.

The purpose of this memo is to inform Special Agents of the WFO that this policy is now in effect that interviews should be coordinated through ROBERT C. ODLE of the Personnel Office for the Committee to Re-elect the President.

Mr. ODLE advised that this policy has been set due to the fact that the Democratic National Party is presently in the process of filing a law suit against the Republican Committee and that the presence of attorneys during interviews is simply a precautionary measure in order that the Republicans might protect their interest in regard to this pending law suit.

MR. ROBERT L. HOUSTON, Security Coordinator for The Committee to Re-Elect the President, 1701 Pennsylvania Avenue, N. W., furnished the following information:

Mr. HOUSTON advised that Mr. JAMES MC CORD was previously the security supervisor for the above Committee and had set up the security system for the Committee.

Mr. MC CORD had various articles of electronics gear such as radios with speakers and receivers. With the electronic equipment there was microphones which looked like chapstick containers and these and other radio equipment were to be used by the security force at the Republican National Committee Meeting Convention in Miami. The devices would be used on the floor of the Convention to maintain security.

Mr. HOUSTON pointed out articles Mr. MC CORD had used for instructional purposes when teaching the Committee Staff about security of the offices. This equipment consisted of alarm systems, with remote control and instruction as to where "bugs" might be placed, such as behind electrical outlets. There was also a partially filled box of pen-type tear gas dispensers ("Sheriff-50" brand).

The Committee's offices were monitored by a closed circuit television system and door "buzzers" have been installed as well as an alarm system which was presently in the process of being installed.

Mr. HOUSTON pointed out a base radio unit which netted with the equipment that Mr. MC CORD carried. The base radio was installed and the unit for the roof to be used in transmitting. The only time Mr. HOUSTON knew of that the equipment (radio) had been operated was to test it when it had been installed.

Mr. MICHAEL G. ALEXANDER, Deputy United States Marshal, temporarily assigned, Washington, D. C., United States Marshal Service, voluntarily appeared at the Federal Bureau of Investigation (FBI), Washington Field Office (WFO), at which time PAUL P. MAGALLANES and JOHN W. MINDERMAN identified themselves as Special Agents of the FBI. Mr. ALEXANDER was advised that the nature of the interview concerned his relationship, if any, with JAMES MC CORD. Mr. ALEXANDER furnished the following information:

Mr. ALEXANDER viewed the following six black and white photographs: FRANCIS XAVIER DOLAN, SR.; VIRGILIO R. GONZALEZ; BERNARD BARKER; JAMES W. MC CORD; EUGENIO R. MARTINEZ; and FRANK STURGIS.

Mr. ALEXANDER could not identify any of the above photographs as being identical with JAMES MC CORD. Mr. ALEXANDER stated, however, that an individual who identified himself as Mr. JAMES MC CORD had telephoned him on about three occasions, approximately December, 1971, and February and March, 1972, in order to ascertain whether Mr. ALEXANDER was interested in employment with the firm Mc Cord Associates, Rockville, Maryland.

Mr. ALEXANDER advised he had, prior to retiring from the United States Army, submitted resumes with the Department of Army for purposes of employment after he retired from service. He stated the Army has a project, Project Referral, which attempts to place retired Army personnel in positions relating to security and to law enforcement.

Mr. ALEXANDER stated that MC CORD, in his telephone conversations, had attempted to persuade Mr. ALEXANDER to join his firm and said that the position would be in the security field. When Mr. ALEXANDER attempted to pinpoint Mr. MC CORD as to specific duties of the position, MC CORD stated he would rather talk to him in person at his Rockville Office and would

not discuss the security position over the telephone. Upon learning that Mr. ALEXANDER would probably find employment with the United States Marshal Service in Baltimore, Maryland, Mr. MC CORD stated that he would pay Mr. ALEXANDER more money than the United States Marshal Service offered Mr. ALEXANDER. Mr. ALEXANDER, however, stated that he had no desire to commute from Baltimore to Washington, D. C. on a daily basis. At this point Mr. MC CORD stated that there was a possibility that Mr. ALEXANDER could obtain employment in Baltimore, Maryland in a position which would relate to railroad security. Mr. MC CORD indicated, however, that he would need to personally talk with Mr. ALEXANDER at his Rockville office of employment. Mr. ALEXANDER stated that he had subsequently made an appointment to discuss employment with Mr. MC CORD but that he never kept the appointment, inasmuch as the United States Marshal Service hired him prior to the date of the appointment.

Mr. ALEXANDER stated that Mr. MC CORD had said that he had employed other men for his firm through the Army project referred to above. Mr. MC CORD also indicated that he had contacts at the Pentagon, Arlington, Virginia and that he received all of the names of the military retirees in the Washington, D. C. area.

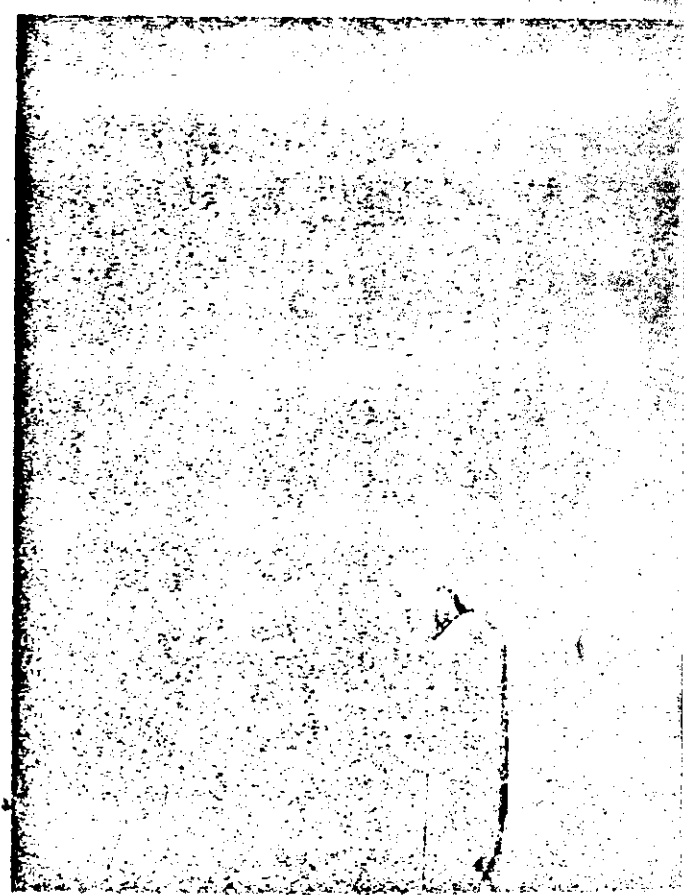

(WDC), by SAs DONALD E. STUKEY, II, and DANIEL C. MAHAN, who identified themselves as Special Agents of the FBI.

Mr. LIDDY advised SAs STUKEY and MAHAN that KENNETH WELLS PARKINSON, Attorney at Law, who is associated with the Law Firm of Jackson, Gray and Laskey, 1828 L Street, N.W., WDC, would be present at this interview as this is the policy of the Committee to Re-Elect the President because a civil suit is pending against the Committee.

SA MAHAN advised Mr. LIDDY that the FBI is conducting an investigation related to the burglary on June 17, 1972, of the Democratic National Committee Headquarters (DNCH) located in the Watergate Office Building, 2650 Virginia Avenue, N.W., WDC. SA MAHAN noted that five men were arrested on the premises of the offices of the DNCH by the Metropolitan Police Department (MPD), WDC.

SA MAHAN advised Mr. LIDDY that Mr. LIDDY's name and telephone number were found in the notebooks of a Mr. BARKER and a Mr. MARTINEZ, who were two of the five men arrested in the offices of the DNCH on June 17, 1972.

Mr. LIDDY stated that because he was being accused of being involved with these men who were arrested in a criminal act, he would make no further statement until he had secured advice of counsel.

SA MAHAN stated that he did not say that Mr. LIDDY was accused of being "involved" with these men.

LEWIS RUSSELL was interviewed by Special Agents of the FBI who identified themselves as agents of the FBI and advised RUSSELL of the nature of the interview. He supplied the following information:

He does not recall ever receiving a phone call on April 25, 1972 from McCord Associates to the phone number 234-9746 which is the pay telephone located in the hall of the rooming house where he resides. He advised that he does know JAMES MCCORD of McCord Associates and that he is employed by JAMES MCCORD. He stated that the phone call could have been taken by any of the tenants living in the rooming house formerly owned by Mrs. KATHERINE M. ROBINSON, who died around February, 1972. The house is now owned by her niece and the rooming house houses several Spanish speaking persons as well as Iranians.

He first met JAMES MCCORD in January or February of 1972 at Scholls Restaurant in Washington, D.C. at which time MCCORD asked him to work for him as an investigator for the National Committee to Re-Elect the President. He stated that MCCORD said that he was recommended to him by someone, whose name he did not disclose. RUSSELL advised that this is probably correct as he has done investigative work in and around Washington, D.C. for some time. He said his first job was to do a background check on a female, name "JANE" (Last Name Unknown) who was in the employ of the National Committee to Re-Elect the President. He said for that job he received \$40.00 paid by check in advance by MCCORD. His next job was a background check on a male "Hippie" who was a messenger for The National Committee to Re-Elect the President and for this job he received \$25.00. He advised he was also asked to check out a magazine by the title of "The Sociables", and a woman by the name of RITA GERIN. He gave written reports to MCCORD on all the above cases.

On June 1, 1972, MCCORD put him on retainer of \$710.00 per month to continue until the Presidential Election was over with the purpose of investigating JACK ANDERSON to determine the source of ANDERSON'S information. He furnished MCCORD with one report on ANDERSON for which he received \$75.00. He stated that he worked this case solely during the month of June but that now that the "Democratic Committee Bugging Incident Occured", he does not know if he will still be employed by MCCORD. He advised that he also worked for MCCORD as a Security Guard at 1701 Pennsylvania Avenue, Northwest, Washington, D.C., 2nd Floor, for about two weeks prior to being put on retainer by MCCORD. He said that it was his understanding he was employed by The National Committee to Re-Elect the President and was hired by JAMES MCCORD. His checks were drawn on the Maryland National Bank on the account of Mr. and Mrs. JAMES MCCORD or McCord Associates. He couldn't remember which.

He said that he saw JAMES and Mrs. MCCORD last night at their home, but that they did not discuss the break in of the Democratic National Headquarters nor did MCCORD give him any information as to RUSSELLS current employment status with The National Committee to Re-Elect the President. As far as the ANDERSON investigation was concerned RUSSELL stated that he was never told what person or persons in The National Committee to Re-Elect the President was interested or requested the ANDERSON investigation.

RUSSELL advised that his background concerning investigative work started in 1937 when he was a Special Agent for the Federal Bureau of Investigation.
