CURT C. CLINKSCALES III, National Director of the National Alliance of Senior Citizens, 2525 Wilson Boulevard, Arlington, VA (528-4380) was contacted and advised that he first became acquainted with SPITZ CHANNELL when both of them were affiliated with the National Conservative Political Action Committee. He never developed a liking for CHANNELL because he considered CHANNELL to be an unethical person. CHANNELL would make promises to potential contributors that he could not possibly keep.

CLINKSCALES went on to state that he has not had any dealings with CHANNELL during the past 4 years but heard that during the summer of 1986 CHANNELL purchased the Western Goals Foundation (WGF). This foundation had been established by the now deceased U.S. Congressman LARRY McDONALD. A LINDA GUELL was the former head of WGF but quit this job shortly after CHANNELL took over. She is now a staff member of the U.S. Senate Judiciary Committee.
