On July 22, 1987, [REDACTED] Ahavat Torah Congregation, 6816 East Cactus Road, Scottsdale, Arizona, advised that during the middle of June, 1987, anti-semitic slogans were found painted on the outside [REDACTED] which included Nazi insignias and slogans. Approximately one week later, a number of bottles were broken in the synagogue parking lot. Eggs have also been thrown hitting the exterior of the synagogue and a toy hand grenade was found in the synagogue mailbox. An unidentified male individual has also made numerous telephone calls to the synagogue [REDACTED]. During these telephone calls, the unidentified male has made a number of anti-semitic slurs, [REDACTED].

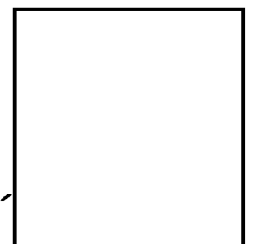

On 12/14/87, [redacted] provided the enclosed report in addition to the following information: (S)(u)

On November 28, 1987, Temple Shalom, located at the intersection of Alpha and Hillcrest, Dallas, received extensive damage from window breaking and graffiti. Graffiti included "Gas the Jews", "6 million more", "88" (referring to eighth letter in alphabet "H" for "Heil Hitler") and various swastika symbols. On December 11, 1987, two white males dressed in black leather apparel were observed outside the entrance to Temple Shalom prior to a service. After the service began, loud commotion was heard in the synagogue. Upon checking out the disturbance, broken windows and more graffiti was observed. (S)(u)

Due to the location of the Temple in Dallas (upper-middle class area), the type of graffiti, and the timing of the disturbances, it is speculated by Jewish officials [redacted] that the SKINHEADS are responsible. [redacted] advised that both temples in Oklahoma City were recently vandalized and there has been a recent surge in recruitment attempts in the high schools. This follows the recent SKINHEAD violence in Chicago celebrating the November 9th anniversary of Germany's "Crystal Nacht" and the subsequent (S)(u)

Although it appears there is no national network or organizational structure for the SKINHEADS (each gang being autonomous both inter-city and intra-city), the recent concurrent activities in Chicago, Oklahoma City, and Dallas indicate possible national connections. On the second altercation at Temple Shalom, a small adhesive sticker was left amongst the graffiti which said "NSWAP, PO BOX 1133, PACIFIC PALISADES, CA. 90272". [REDACTED] indicated these letters stand for: NATIONAL (S) SOCIALIST WHITE AMERICAN'S PARTY, [REDACTED]

This information is being provided to the Bureau and receiving offices which were specifically noted in enclosed ADL report, as way of background for possible future altercations. White American Resistance (WAR) which has also used the names of White American Political Association (WAPA) and White Aryan Resistance, espouses the principles of white supremacy. WAR is principally in operation

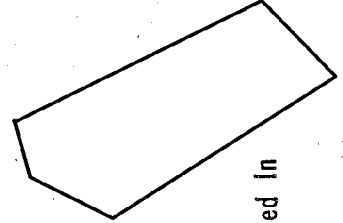

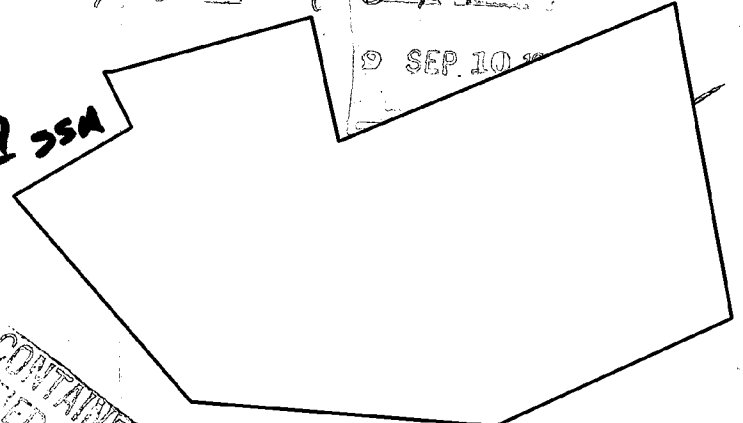

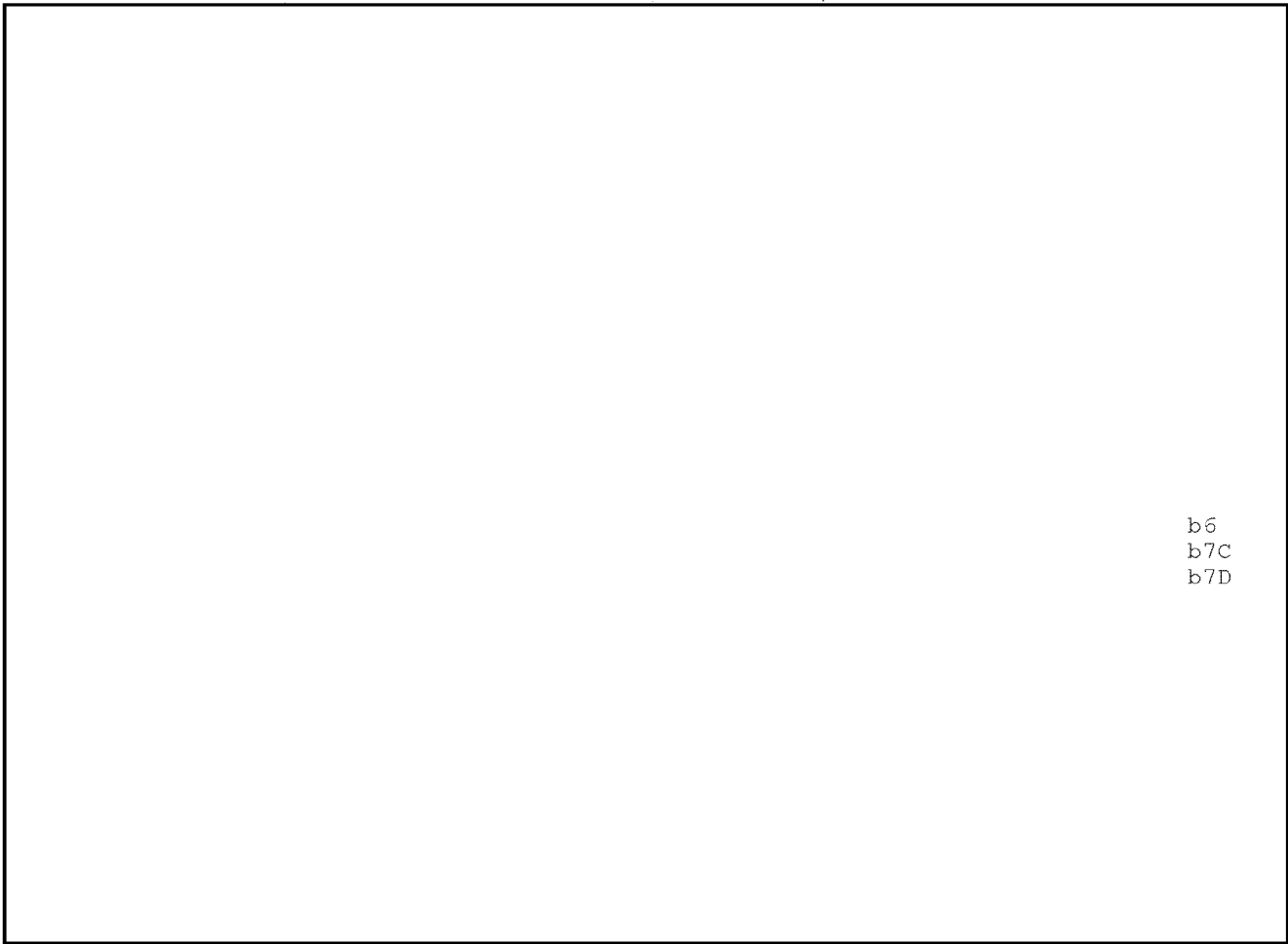

San Diego has observed very little distinction between WAR and AYM/WSU in San Diego County. [REDACTED]

[REDACTED] AYM/WSU does have a separate newsletter which, on most occasions, has expressed more violent rhetoric than the WAR newspaper. It appears that AYM/WSU is attempting to establish chapters throughout the United States through the use of a computerized bulletin board operated out of San Diego County and newsletters.

San Diego has no separate investigation regarding AYM/WSU and has included all investigation regarding that organization, [REDACTED] in the investigation of WAR. San Diego has received no information indicating that the goals and objectives of AYM/WSU are different or distinct from those of WAR, and, in fact, the objectives of the two organizations appear to be consistent with each other, and the primary purpose of AYM/WSU may be that of recruitment of young people.

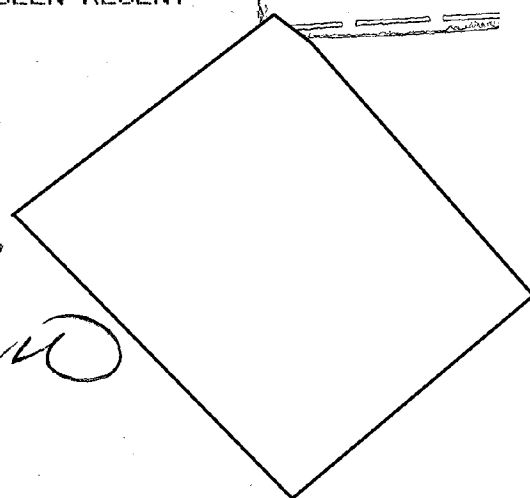

# Bay Area 'skinheads' join Klan ceremony in Modesto

MODESTO — A small group of "skinheads" from the Bay Area gathered in an alfalfa field on the outskirts of town Saturday night to join in a Ku Klux Klan cross-lighting ceremony.

Sheriff's officials said it was the first time they had seen skinhead teen-agers from the Bay Area at a Klan ceremony in Modesto. Thirteen youths showed up representing clubs from Palo Alto, Turlock and Hollister.

At least four of the teen-agers, who wore knee-length boots and suspenders and had shaved heads, were initiated into the Klan late Saturday.

"First, I was a white-power sympathizer, then I got into throwing literature, now I'm ready for a bigger organization," said Mike, 19, a South Bay skinhead who planned to join the Klan. "I've believed in white power since I was 13. I was sick of being bashed. In my town, you either knew how to run or knew how to fight."

While a group of about 20 local Klansmen gathered for a chicken dinner — of only white meat — the skinheads prepared for their first ceremony.

Some nailed planks into a 20-foot cross, then

wrapped gasoline-soaked burlap bags around the structure, which was sunk into the ground. Others made the torches that later were carried in a circle and thrown at the base of the cross for the lighting.

"We're here to show our solidarity," said Dave Mazzella, 19, of Mountain View. He has been recruiting South Bay teen-agers into the white supremacist movement.

The cross-burning, held behind the house of klansman Bill Albers, was by invitation only. Stanislaus County sheriff's deputies observed the activities from across an irrigation canal.

"They talk a lot about overthrowing the U.S. government and declaring war on Zionists," said a sheriff's deputy who has followed Albers' Klan gatherings for several years. "It's a lot of rhetoric, but we have to listen to what they are saying and keep an eye on them."

In San Jose last summer, a 54-year-old black woman said she had been held and threatened by four teen-age skinheads. A 19-year-old man has been arrested and charged with attempted robbery and false imprisonment, but others allegedly involved in the incident could not be identified. Two teen-agers at Saturday's Klan rally said they were involved in the assault. They refused to give their names.

The AYM mainly recruits high school and college students on campuses throughout the country and publishes a newsletter similar to the WAR newsletter, although it is much more violent in nature. [REDACTED]

This appears to be the newest form of recruitment for WAR, inasmuch as the Skinheads are usually quite susceptible to the white supremacist rhetoric and are easily provoked into violent acts. Criminal acts committed by the Skinheads to date have mostly been assaults on minorities or vandalism of synagogues and Jewish-owned businesses. It is speculated that WAR is actively supporting the Skinhead movement in order to recruit Skinheads into the WAR organization and the white supremacist movement. This support will ultimately expand the membership of WAR and provide a young, volatile group capable of perpetrating criminal acts.

During the past several months the activities of WAR, as well as the other white supremacist groups, have been severely curtailed. It is believed that this is due primarily to the recent trial of several leaders of the white supremacist movement which was held in Fort Smith, Arkansas. In the months immediately preceding and during the trial, the main goal of these groups was to raise funds for the defense of their leaders and to recruit new members into the movement. Members were warned not to commit acts of violence or do anything which would reflect negatively on the movement, as this could possibly affect the outcome of the Fort Smith trial.

On April 7, 1988, all defendants in the Fort Smith trial were acquitted. Now that the white supremacist movement has received what could be viewed as a "shot in the arm" by this victory, it is believed that WAR and other like-minded groups will flourish. Acts which may have been held in initial planning stages may begin to become overt. Since it is believed that WAR has been in a "holding pattern" for the past few months and that now the group will begin to grow in membership and will be more likely to commit violent acts, the Domestic Terrorism Unit believes that the actions of this terrorist group meet the requirements set forth in the Attorney General Guidelines on DS/T investigations. It is therefore recommended that this investigation be renewed for another 180-day period.

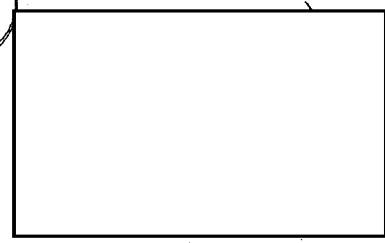

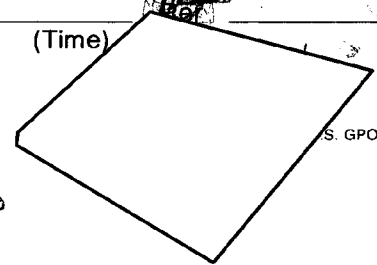

Predicate offenses, as established in the enclosed LHM, are Title 18, Section 2385, Conspiracy-Advocating the Overthrow of Government; Title 18, Section 241, Conspiracy Against Rights of Citizens.

REQUEST OF BUREAU

FBIHQ is requested to direct a copy of the enclosed LHM to the Department of Justice with the request that another six (6) months authorization to investigate WAR be granted and Los Angeles be designated office of origin.

The geographical dimensions of WAR are certainly not restricted to southern California and have no doubt expanded due to WAR's persistent effort in recruiting Skinheads. The Skinhead movement, which has grown in size and intensity, has gained the increased interest [redacted] provided direction to the group.

There has been notable involvement between those affiliated with WAR and Skinhead factions. In the Los Angeles Division, such notable associations are:

In July, 1987, investigation by Los Angeles FBI agents and Los Angeles Police Department (LAPD) detectives covering the Arvan World Congress in Hayden Lake, Idaho, determined that [redacted]

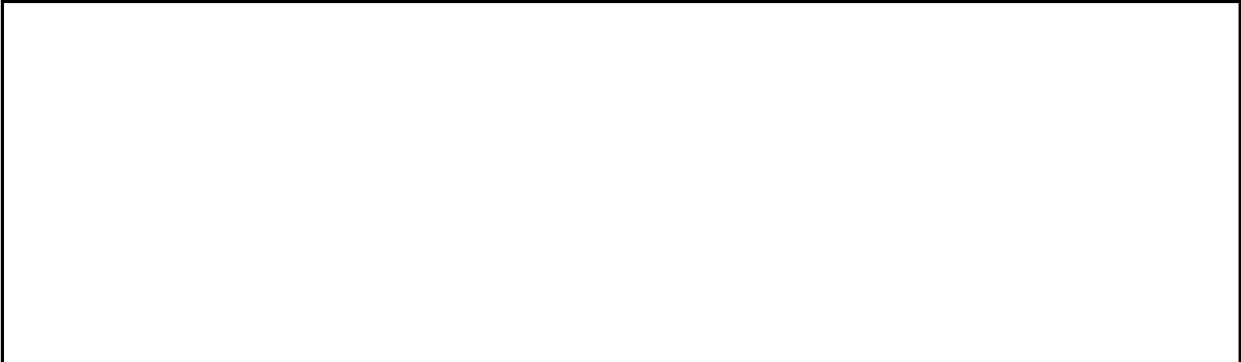

On October 7, 1987, a seemingly minor burglary attempt started local law enforcement on an investigation that eventually provided insight into a particularly violent faction of Skinheads in the Los Angeles area and this helped solidify already growing suspicions of established white supremacist organizations entanglements with Skinheads.

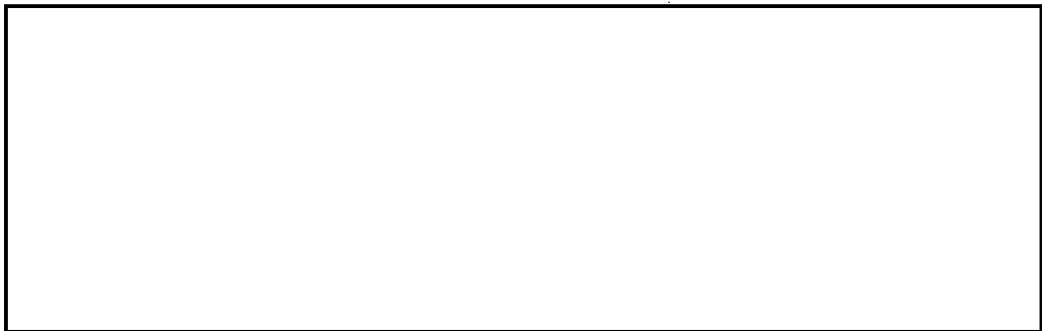

The above associations depicts the obvious correlation between WAR and the Skinhead movement. Most disturbing however, is the more frequent acts of violence noted with Skinhead activities. Skinhead factions in the Los Angeles area have displayed a violent and criminal demeanor which is evidenced by the continuing racially motivated crimes and confrontations which are a common characteristic of the Skinhead groups. The most recent are:

- In Ventura, California, a Skinhead stabbed a black high school student twice in the back after a fight.
- Three Skinheads were arrested and later convicted, in Laguna Beach, California, after attacking two homosexuals.
- Several Skinheads were arrested and later convicted in connection with a stabbing attack on individuals at a party in Camarillo, California.

In a most recent development, it has been learned that in April of 1988, a Skinhead conference is scheduled at the Arvan Compound. This conference has allegedly [redacted] [redacted] Aryan Nations), and can only be interpreted as an attempt by the Aryan Nations to cuddle the Skinheads under the umbrella of white supremacy. In all probability, this could well mark the emergence of the Skinhead movement into a concerted effort with those white supremacists having organization.

The Skinheads, who are undisciplined and prone to violence, have no doubt rejuvenated racist sentiments throughout the United States. Although a common cohesiveness has not emerged. WAR [redacted]

[redacted] This involvement combined, by efforts of the Aryan Nations Church, will likely create a cohesive and disciplined Skinhead movement, a reality that cannot be ignored.

Whatever the rationale, it is clear that those committed few whose lives revolve around the ideals of white racism, are interested not only in advancing the rhetoric but also in funding the future with young recruits. The examination provided herein tends to show, in Southern California at least, that major white supremacist figures [redacted]

[redacted] have begun to use the Skinhead phenomenon much like a minor league system, drafting committed and violent young men into the larger cause. [redacted]

[redacted] Skinheads offer a track record of racism and violence at an early age, [redacted]. Additionally, it can be theorized that [redacted] Skinhead were to be conducted, it would reveal an inadequate personality type easily lured to loyalty by a charismatic figure [redacted]

In the Los Angeles Division, it has become evident that if the key Skinheads that have come to the attention of law enforcement over the past year had to be defined organizationally, most would be readily [redacted]. Indeed, many of those mentioned in this report (and shown to be [redacted] begun to refer to themselves as "WARSKINS".

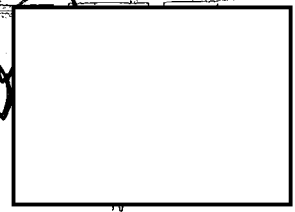

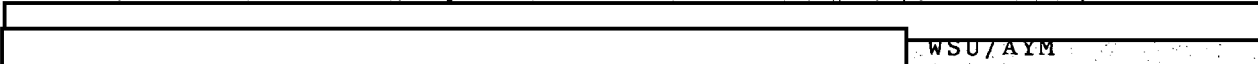

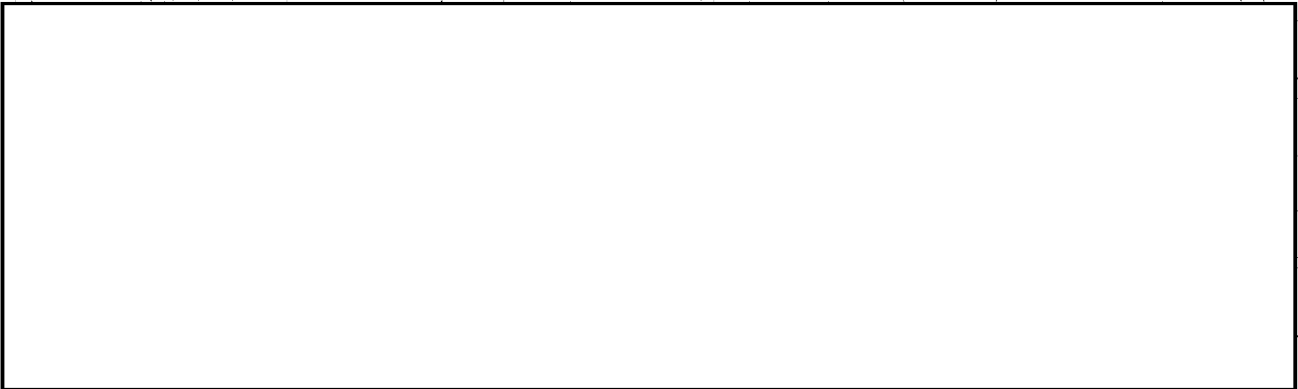

Current recruitment efforts by WAR and WSU/AYM do appear to be directed towards younger people.

Skinheads are a relatively new sub-group within the white supremacy movement, and are generally characterized as white males, usually under 25 years of age, with their hair cut very short or shaved completely, and noted to be particularly violent prone. Most Skinhead activity to date has been observed in the Los Angeles area, however, Skinheads are now active in San Diego as well.

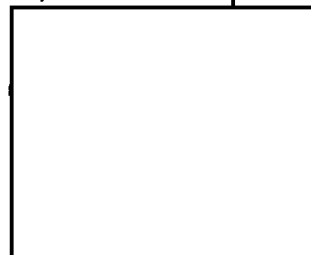
